1. Financial Impact of COVID-19 on Public Higher Education Institutions

- Financial models and projections remain tentative because enrollment numbers are hard to pin down; will have firm numbers in a few weeks.
- Each IHE has implemented cost-saving measures to balance operating budgets, seeking to close deficits ranging from \$2-4 million (SCSU), \$9 million (CofC), \$45-60 million (Clemson), \$125 million (UofSC).
- Fall sports: Mid-Eastern Athletic Conference (SCSU) has cancelled all fall sports; ACC, SEC undecided.
 - Clemson projects \$40 million in lost athletic revenue; Carolina about \$48 million.
 - NCAA guidelines require extensive and frequent testing of athletes, as a significant cost.
- If the semester can be taught fully on-campus, through face-to-face instruction, we believe all institutions will weather the crisis through cost-cutting and tapping into available reserves.
 - If wholly online all but MUSC would need additional state or federal support to meet obligations.
 - Online only with no students on campus would mean significant decreases in revenue from housing and other auxiliary revenues.
- A few IHEs project flat or slightly higher enrollment; others project declines ranging from 4% to 15%.
- Each IHE has frozen or plans to freeze tuition for the 2020-2021 academic year.

2. Higher Education Emergency Relief Fund (HEERF) Update with breakdown of funds received by HBCUs

- CARES Act spending (mostly as of 6/30/2020). All IHEs received funds from Higher Education Emergency Relief Fund (HEERF). 50% of these dollars had to go directly to students.
 - Most IHEs have dispersed emergency grants to students and used most of allotted funds for institutional expenses (including refunding student fees in spring).
- HBCUs and other Minority Serving Institutions (MSI) received additional funds. The table below **does not include** the \$2.4 million Gov. McMaster recommended for SC HBCUs from GEER, which is currently in court.
