Proviso 89.136 of the FY2010-11 General Appropriations Act State Agency Restructuring Study Committee

(GP: State Agency Restructuring Study Committee) There is created a State Agency Restructuring Study Committee. The committee shall be co-chaired by the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee. Its membership shall consist of an additional ten members of the General Assembly appointed as follows: two members appointed by the President Pro Tempore of the Senate; one member of the Senate Finance Committee appointed by the Chairman of the Senate Finance Committee; one member appointed by the Senate Majority Leader; one member appointed by the Senate Minority Leader; two members appointed by the Speaker of the House of Representatives; one member of the House Ways and Means Committee appointed by the Chairman of the House Ways and Means Committee; one member appointed by the House Majority Leader; and one member appointed by the House Minority Leader.

The committee shall review and recommend ways to further streamline government to realize maximum effectiveness and efficiency.

The committee shall not be limited in scope, but at a minimum it shall review

- 1) Education;
- 2) Health and Social Services;
- 3) Natural Resources and Environmental Services;
- 4) Cultural;
- 5) Regulatory;
- 6) Transportation.

This review, including an estimate of cost savings must be submitted to the Chairman of the Senate Finance Committee and the Chairman of the House of Representatives Ways and Means Committee by December 10, 2010.
