Section I.

Executive Summary

The Commission was created to coordinate all activities involving the prosecution of criminal cases in this State. The increase of criminal cases in both the General Sessions and Family Courts challenge the agency in fulfilling its statutory obligations. The Commission is governed by Sections 1-7-910 through 1-7-1000 of the South Carolina Code of Laws. The Commission is composed of the Chairmen of the Senate and House Judiciary Committees or their legislative designees, the Chief of the SC Law Enforcement Division, the Director of the Department of Public Safety, a director of a Judicial Circuit Pre-Trial Intervention Program (PTI), a Judicial Circuit Victim-Witness Assistance Advocate, and five Judicial Circuit Solicitors appointed by the Governor.

1. Mission Statement:

The SC Commission on Prosecution Coordination (SCCPC) coordinates all administrative functions of the offices of the Solicitors and affiliate services to include submission of the budgets, developing and providing both legal education and training programs, and serving as a clearinghouse and distribution source for publications involving Solicitors and affiliate services, provide blank indictments, and assists the Solicitors in establishing and maintaining a pretrial intervention program in each judicial circuit.

2. Major Achievements from FY 2007/08

The Commission's major achievements from the past year are listed below.

- Two (4) DUI training seminars which provided continuing legal education (CLE) credits for prosecutors, continuing law enforcement (CLEE) credits for officers, and Judicial Continuing Legal Education (JCLE) for judges

- Two (2) victim/witness assistance advocates training programs
- One (1) Child Abuse Prosecution training program

- One (1) Child Abuse Prosecution publication
- Approximately 55 child sexual abuse cases were reviewed by the agency resulting in either consultations or criminal prosecutions

6. Employees (all unclassified)

The Commission has a total of forty-two (42) full-time employees and one (1) part-time employee. There are sixteen (16) Judicial Circuit Solicitors who are elected by the public. Each Office of the Solicitor has sixteen (16) Administrative Assistants who are unclassified employees. In the Columbia Office there is employed (1) Executive Director; one (1) Deputy Director; one (1) Administrative Assistant to the Commission; one (1) State PTI Coordinator; one (1) Information Technology/Accountability Coordinator; one (1) Child Abuse Attorney; one (1) Education Coordinator; one (1) State Victim/Witness Assistance Coordinator (vacant); and, one (1) Traffic Safety Resource Prosecutor (federal); and, one (1) full-time TSRP Support Personnel (federal) who are all unclassified.

7. Regulatory Environment:

Section 1-7-990 of the SC Code of Laws provides that the Commission on Prosecution Coordination may promulgate those regulations necessary to assist it in performing its required duties. The Commission has adopted training certification standards for personnel within the local Pretrial Intervention programs and the Victim/Witness Assistance Advocates programs.



The South Carolina Court Administration is the State's repository of criminal records for both General Sessions Court and Family Court. Court Administration's year-end reports best describe the activities of the Office of Solicitor as it relates to adult and juvenile prosecutions. In the area of adult criminal prosecution for the fiscal year 2006-2007, the Solicitors of this State disposed of 124,171 General Sessions criminal warrants. In the area of juvenile criminal prosecution for fiscal year 2006-2007, the Solicitors of this State disposed of 16,405 Family Court petitions. South Carolina Court Administration's goal of the disposition of criminal cases within 180 days of the date of arrest is a significant factor in all prosecutorial decisions. Currently, 80% of all Family Court petitions are being disposed of within 365 days or less and 80% of all General Sessions warrants are being disposed of within 180 days or less.

State Office of Pretrial Intervention	Within the Commission is the State Office of Pretrial Intervention whose responsibility is to assist the Solicitor in each judicial circuit in establishing and maintaining a pretrial intervention program. The State Pretrial Intervention Coordinator and such staff which are necessary to assist in the implementation of the provisions of SC Code Sections 17-22-10 through 17-22-170 are within this office.	To enter approximately 11,300 statewide applications per year and the associated accepted/rejected information on each participant, run generation reports weekly, and provide statistical information to the Office of Solicitor upon request.	The State Office of Pretrial Intervention provides statewide training to all pretrial intervention personnel for compliance with the continuing educational requirements promulgated by the Commission. The State Office also provides new hire and software training so as to provide statewide uniformity free of charge. ** See Chart #1
Child Abuse Prosecution Unit	Within the Commission is the Child Abuse Prosecution Unit composed of an experienced attorney who prosecutes cases statewide involving traumatized child victims in rural districts/regions where resources are limited. This increasing backlog is attributable to many factors including mandatory minimum sentences, 2 strikes/3 strikes statutory provisions, the implementation of Constitutional guarantees for victims, as well as increasing scientific and technological advancements in criminology. Without proper recurring funding of the Offices of Solicitor and other criminal and juvenile justice agencies, the backlog will continue to increase and cases will become more state as they await their dispositional dates. Section III: Category 1: SENIOR LEADERSHIP, GOVERNANCE, AND SOCIAL RESPONSIBILITY:

The Commission is composed of the Chairmen of the Senate and House Judiciary Committees or their legislative designees, the Chief of the SC Law Enforcement Division, the Director of the Department of Public Safety, a director of a Judicial Circuit Pretrial Intervention Program, a Judicial Circuit Victim-Witness Assistance Advocate, and five Judicial Circuit Solicitors appointed by the Governor. The Commission was created to coordinate all activities involving the prosecution of criminal cases in this State.

There is created a permanent Executive Committee of the South Carolina Commission on Prosecution Coordination which is composed of the five Judicial Circuit Solicitors appointed by the Governor pursuant to SC Code Section 1-7-920(6) whose duties shall include the development and implementation of policies for a SCCPC Personnel Plan which shall include: establishment of policies and procedures for the employment and separation of employees; establishment of guidelines for the effective management and supervision of employees; and review staff requirements and needs of the Commission and Solicitors.

The sixteen (16) Judicial Circuit Solicitors represent the various judicial circuits as established by law. There is one solicitor for each judicial circuit, to be elected by the qualified electors of the circuit, who holds his office for the term of four years. A solicitor must be licensed to practice law by the South Carolina Bar at the time of his election and throughout his term. The Solicitors of this State are full-time employees of the State of South Carolina. The Solicitors are officers of the Executive Department of this State. On behalf of the State, the Circuit Solicitor's office prosecutes trial-level criminal cases and handles juvenile matters. The Solicitor attends the courts of General Sessions for their respective circuits. Preparation of the dockets for General Sessions Court is exclusively vested in the circuit solicitor and the solicitors determine the order in which the cases on the docket are called for trial. Their legal authorization is established in the Constitution of South Carolina, Article V, Section 20, and the Code of Laws of South Carolina, Title 1, Section 1-7-310 (1977), establishes the position of Circuit Solicitor.

Category 2: STRATEGIC PLANNING

The SCCPC meets on a regular basis to address the coordination of all activities involving the prosecution of criminal cases in this State. The Commission serves to coordinate all administrative functions of the offices of the solicitor and any affiliate services operating in conjunction with the Solicitor's office. The Commission promulgates those regulations necessary to assist it in performing its required duties.

The Executive Committee of the SCCPC meets on a regular basis to develop and implement a personnel plan and to address any specific personnel request that relate to hiring, separation and related matters regarding its employees.

The Judicial Circuit Solicitors serve as the Agency Head for any Commission employee working directly under his supervision.

On behalf of the State, the Solicitor coordinates the prosecution of trial-level criminal cases and handles juvenile matters in the Judicial Circuit. State appropriations are provided to the Office of Solicitor for these specific purposes.

Proviso 33.3 of the General Appropriations Act provides that the amount appropriated and authorized in this section for Judicial Circuits (16) State Support may, upon approval of the Commission, be used to fund necessary administrative and personnel costs of the Commission and other expenditures approved by the Commission, not to exceed 5% of the appropriation, and the balance thereafter remaining shall be apportioned among the circuits on a per capita basis and based upon the official census of 1990. Payment shall be made as soon after the beginning of the first and third quarter as practical.

Category 3: CUSTOMER AND MARKET FOCUS

The Commission serves the Offices of the sixteen (16) Judicial Circuit Solicitors and any affiliate services operating in conjunction with the Solicitors' offices. Currently, those affiliate services are as follows: Pretrial Intervention programs, Victim/Witness Assistance programs, Investigator programs; Drug Treatment Courts, and Juvenile Arbitration programs.

Category 4: MEASUREMENT, ANALYSIS AND KNOWLEDGE MANAGEMENT

The primary clientele served by this agency are the sixteen (16) Judicial Circuit Solicitors, the deputy solicitors and assistant solicitors throughout the State, the Judicial Circuit Victim/Witness Assistance Advocates and their programs, the Pretrial Intervention programs representing the forty-six (46) counties of this state, and those Solicitors-based investigators.

The Commission is providing statistical data in five (6) areas: Information Technology/Accountability Coordinator, Child Abuse Prosecution, State Office of Pretrial Intervention, State Victim/Witness Assistance Coordinator, Education Coordinator, and Traffic Safety Resource Prosecution.

1. Information Technology/Accountability Coordinator: The SC Commission on Prosecution Coordination recognizes South Carolina's need for the collection of data regarding criminal and juvenile data. The information is being gleaned statewide and the information is being collected on various programs within the Office of Solicitor. Statistical and financial information is outlined in state law and reports are required 60 days following the close of the fiscal year. Quarterly and annual reports are required for the Criminal Domestic Violence Prosecution (Proviso 46.9) and DUI Prosecution (Proviso 46.10). The quarterly reports for these programs as well as the case tracking documents are maintained by the ITAC. Victim/Witness Assistance annual reports for SOVA are distributed, collected, and forwarded to the appropriate representatives by the ITAC and/or Administrative Assistant to the Commission. Drug Treatment Court Program information is maintained by the ITAC as well as the contact information for the Education, Intervention, and Support Services within the Office of the Solicitor (Alcohol Education Program, Expungements, Drug Treatment Court Program, Juvenile Arbitration, Pretrial Intervention, and Worthless Check Units). This year the Commission actively worked with committee members to develop, distribute, and collect information on the Prosecutor and Defender Public Service Incentive Program. This

program provides funding for assistant solicitors who have three years of employment with in the Office of the Solicitor, and have acquired outstanding student loans for attending law school. The ITAC maintains the reports for Prosecutor and Defender Public Service Incentive Program which are due to the General Assembly by September 1 of each year. The Commission's website is maintain by the ITAC.

2. Child Abuse Prosecution Unit: Within the Commission is the Child Abuse Prosecution Unit composed of an experienced attorney who prosecutes cases involving traumatized child victims in rural districts/regions where resources are limited. A Child Victim/Witness Assistance Advocate (part-time) assists the Child Abuse Attorney Specialist by performing certain duties.

The jury trial of State v. Williams Ricky Welch in Sumter County has served as a precedent setting case. It is the first trial in South Carolina to prosecute an offender pursuant to SC Code Section 16-3-655(A)(2) of Jessie's Law, which allows evidence of a prior conviction to be admitted as an element of proof in a criminal sexual conduct – first degree case. The precedent established through this case should aid in the successful utilization of the new statute across the state.

During the time period of July 1, 2007 – June 30, 2008, the Child Abuse Prosecution Unit continued to conduct meetings with victims in additional cases which are currently in the process of being evaluated and scheduled for trial. Further, court hearings as part of the pre-trial or post-trial judicial process have accounted for additional appearances in 5 cases, with direct services provided to 7 primary victims and 8 secondary victims.

Category 5: WORKFORCE FOCUS

The Commission encourages and develops legal education programs and training programs for solicitors and their affiliate services, organizes and provides seminars to help increase the effectiveness and efficiency of the prosecution of criminal cases in this State, and acts as a clearinghouse and distribution source for publications involving the solicitors and their affiliate services and provides legal updates on matters of law affecting the prosecution of cases in this State.

The Commission surveys the various Solicitors’ offices and affiliate services to ascertain the need for future various training components as well as the skill level. Each Agency Head is responsible for the submission of an annual employee performance evaluation. These evaluations are utilized to determine the criteria for future training programs throughout the various affiliate services.

Category 6: PROCESS MANAGEMENT

The Commission provides blank indictments for the Judicial Circuit Solicitors. Currently, the Commission is in the final phases of providing an electronic process for developing General Sessions Court indictments and Family Court petitions in a prosecutorial-based case management system. The prosecutorial-based case management system will also allow the sharing of criminal and juvenile justice information among the various Solicitors’ offices. In addition, the Commission is constructing a website to improve the communication of information relating to the various Solicitors’ offices and their affiliate services.

Category 7: RESULTS

The South Carolina Commission on Prosecution Coordination’s primary purpose is the coordination of activities involving the prosecution of criminal cases in this State. The South Carolina Court Administration is the State’s repository of criminal records for both General Sessions Court and Family Court. Court Administration’s year-end reports best describe the activities of the Office of Solicitor as it relates to adult and juvenile prosecutions. In the area of adult criminal prosecution, please consider the following: In FY 2006-2007, the Solicitors of this State disposed of 124,171 in General Sessions Court. During FY 2005-06, they disposed of 132,732. In the area of juvenile criminal prosecution, please consider the following: In FY 2006-2007, the Solicitors of this State disposed of 16,405 Family Court petitions. During FY 2005-06, they disposed of 19,195.

South Carolina Court Administration’s goal of the disposition of criminal cases within 180 days from the date of arrest is a significant factor in all prosecutorial decisions as

well as Family Court petitions are being disposed of within 365 days or less. The number of General Sessions Court and Family Court cases handled by the sixteen (16) Judicial Circuit Solicitors has dropped during FY 2006/07 due passage of certain Without proper funding of the Offices of Solicitor and other criminal and juvenile justice agencies, the backlog will continue to increase and cases will become more stale as they await their dispositional dates.
