13	Fifteen plus years ago, I worked with other advocates to obtain \$1 million a year for SLED to establish a special victims unit. At the last minute, a provision was added to allow SLED to refer cases to law enforcement. The then director told the committee that if someone was to be abused in an upstate county, he did not want to delay the investigation by sending a SLED agent to the site. Since then, SLED refers nearly all allegations to either local law enforcement or DSS. In one case, a client was picked up in the morning and taken to a DDSN workshop, where she was left in the bus all day in 90 degree heat (outside temp). I have the SLED intake report. NO AGENCY FILED A REPORT and neglect was "unsubstantiated." When we subpoenaed SLED records, they responded claiming to have no record of the incidents. That is the second time that has happened to my clients. Look at the incident reports from Pee Dee Center of abuse where there were video recordings of the assaults and failure to report. Why does it take a month or more to arrest these folks. How many have been convicted? Look at recent reports from Coastal Center and Whitten. In 2019, I received an anonymous letter reporting a client at Coastal being put in a choke hold- on video with witnesses. It took more than 6 months to arrest the abuser and he still has not gone to trial. This is too typical. In another case, the group home resident with the mental capacity of a pre-school child was placed in a home with a registered sex offender and was raped at least twice. I would be happy to share those records. When he was found with 2d degree burns to both wrists and his shirt adhered to the scabbed arms, SLED did not investigate. The reports I see more often than not to not even show contact with the family. Family members have no idea what is going on in these homes and facilities. Incident reports often list the administrator of the facility as the guardian/parent. I would like to speak personally with committee members about my experiences.
