





Excretion

#### LNPs

Feces, urine, saliva, sweat, maternal milk, unexplored in semen mRNA naked and in EVs in human maternal milk

Spike in EVs in keratinocytes 3 months post injection

Penetration of vaccine products

#### Why should we be concerned now? Isn't the "pandemic" over?

#### **Mandates: Private industry, education**

- ✓ Masks, shots, lockdowns, lockouts, etc... or even fired, even if not state mandate: Why?
  - ✓ Dept of Labor Reqts for doing business, executive support of Democrat policies, contracts
  - ✓ Healthcare due to Medicare and HHS funding

#### **DHEC Disinformation**

DHEC failed at its basic task, <u>accurate guidance</u>, with no commitment to fix (FOAI and following meeting findings):

- □Unable to provide transparency on the validity of data used for hospitalizations and deaths published on the DHEC website.
- □Unable to provide adequate evidence re: universal masking in South Carolina's K-12 schools; inadequate risk vs benefit analysis of this policy for school-age children.
- □ Unable to provide safety and AE data re recommendation of universal pediatric VAX or COVID-19 VAX of SC children.
- □ Did not evaluate and act on the nearly 9,000 COVID-19 VAX AEs for South Carolina reported to VAERS, or US data, or any other country data, nor did it have accurate data on AEs
- □ Has not investigated possible job, financial, psychological, education effects: not their job


Healthcare system corruption: protocols that kill but are profitable, protocols that limit our freedom

#### **Follow the Money**

#### **FOIA Revealed:**

- \$13 billion in funding to "influencers" to promote the mRNA injections:
  - For example: including an \$11M contract with a for-profit OB/GYN NGO that oversees tens of thousands of obstetricians and gynecologists on two continents
  - Requires the return of funding if medical organizations do not adhere to the "safe and effective" message presented to them by HHS.

#### The Legal Framework for YmRNA and Future "Countermeasures"

## What the Laws Built

- Set up huge public and private **funding** streams for military-led biological/chemical/neurological weapons research, development and deployment programs, sold to Congress and public as public health emergency programs.
- Shield government funders, developers, regulators from CBRN WMD/terrorism criminal prosecution by classifying weapons as scheduled toxins, communicable pathogens, etc., and R&D on those weapons as defensive/protective
- Eliminate informed consent in PHE contexts by reclassifying potential carriers
  of disease (each human) as presumptive national security threat.
- Shield products/weapons from product liability. No safety/efficacy standards.
- Shield **contractors, manufacturers, distributors and 'vaccinators**' from civil and criminal liability for their harmful/lethal actions.

- ✓ Will WHO Treaty Supersede Federal or State Laws?



#### **Lessons Learned**

We can not trust what the US Government says


The States (SOUTH CAROLINA) and the citizens must step up!

- ✓ Transparent Status Report of DHEC and Executive Branch Root Cause Analysis?
- ✓ Establish State Disease Management System- and use it (TOP Priority)
  - ✓ RHIO (A Politics-free State Effectiveness and Adverse Effects Database and Management Structure)
  - ✓ Autopsy criteria and workflow
  - ✓ DHEC responsibility to <u>critically review</u> all NIH work products (eg FDA, CDC)
  - ✓ DHEC Quality examination of vaccines and RXs regardless of FDA approval status (end product quality)
  - ✓ Pharmaceutical supply chains (to the arm or mouth) should be audited for quality (process quality)
  - ✓ Independent of Federal agencies

#### **DHEC Corrective Actions**


- ✓ Correct web site and circulars to reflect scientific findings
- ✓ Stop psi-mRNA technology products from being used in SC (food, pharmas; human, animal, agricultural products grown in state)
- ✓ Improve informed consent process

- ✓ Include new Public Health process in DHEC restructure (next slides)

- ✓ Blood donations screened for psi-mRNA biproducts (eg modSpike)
  - √ "Long-covid" symptoms as in UK
  - ✓ Blood test screens for spike, LPN (both whole and fragments)
- ✓ There is no "KEEP IT SIMPLE" when it comes to healthcare
  and pharma: key policy makers, and key staff, must be
  educated. (ROOT CAUSE!)
  - ✓ Surgeon General responsibility? (eg Florida solution)

- ✓ State-wide or even regional mandates should be illegal
  - ✓ Executive order by governor, immediate approval by legislature, brief period, no extension without revote of legislature
- ✓ Pharmas should be "off-campus" only
- ✓ Pharma off state media (TV, radio, etc)?
- ✓ Transparency in financial dealings from pharma, healthcare orgs, health NPOs
  - ✓ Legislature and executive branch (eg retainers, legal fees, etc) to legislative and executive branch,
  - ✓ Revolving door slammed shut


- ✓ DBDC (federal digital money) is not money under SC law to prevent coercion
- ✓ Federal mandates from administrators or presidential executive orders should be reviewed by AG to determine if constitutional
  - ✓ Citizens, businesses should not impose AG-deemed unconstitutional orders on employees or customers
  - ✓ AG budget should be funded for these reviews

- ✓ All goods and services exempt from liability should not be permitted in SC. This includes pharmas.
- ✓ Support and/or bring suits against individuals and organizations for
  - ✓ Malfeasance, dereliction of duty, etc
  - ✓ Workman's comp paid by the employer or organization requiring the shot, plus medical costs
  - ✓ Medical costs, personal injury, etc for improper informed consent

# Restore the healthcare provider's relationship with the patient

- ✓ Healthcare providers- doctors, etc- should be able to express their medical opinions without fear of retribution, either from the administration or from other staff
- ✓ Healthcare providers should not be disciplined for discussing with patients care alternatives outside a mandated protocol. The healthcare provider/patient relationship must be respected.

#### **CORRECTIVE ACTION: EDUCATION**



#### **CORRECTIVE ACTION: EDUCATION**

- ✓ Teaching "Scientific Method"
- ✓ Teaching biology of SARS-CoV-2 as an example: effectiveness and AEs- teaching how to evaluate medications and treatment methodologies as a life skill
- ✓ Teaching "critical thinking"
- ✓ Education Department mandate: Education is the Responsibility (and privilege) of Parents; so is Health
- ✓ <u>All ages</u>: we are exposed because technology has made it easy to avoid the responsibility of critical thinking AND technology controls everything now. "Keep it simple" will end our society

#### A Final Thought on Education

I have been involved in education since the 1960s, not counting my own education. I served on a school board in the 1980s for 10 years. I have written articles on education. The changes we are attempting to make trace their origins two generations back- to the 1960s. If we commit to change now, will it be a two generation journey?
