
## Funding for a YMCA Type Facility - \$2.0 Million

The American Academy of Pediatrics urges parents and caregivers to provide multiple layers of protection to keep children and teens safe around water. This includes swimming lessons. Colleton County currently has no public swimming facility to provide swimming lessons and drowning is the single leading cause of injury death for children ages 1 to 4, and it's one of the top causes of death for teens. In Colleton County, children often have more access to rivers, lakes, and the ocean at Edisto Beach, all of which pose a drowning risk. Unfortunately, within just the last few weeks Colleton County lost another child to a drowning in the Edisto River.

Colleton County currently has Capital Projects Sales Tax funding for a new gymnasium and activity rooms in the amount of \$2,953,575 and for a swimming pool in the amount of \$2,029,690. With the increased cost of construction, we currently have a funding gap of roughly 2 million dollars to complete a YMCA-type facility in Walterboro. The County would like to use this requested funding (\$2 Million), in conjunction with the \$4,983,265 approved by the Capital Projects Sales Tax Referendum, to construct a stand-alone facility. This YMCA-type facility would include a swimming pool, gymnasium, activity rooms, a fitness center with machines for all fitness levels, and an outdoor picnic area and would be located in an area accessible to everyone in the community.
