


Successful Employment Outcomes


Rehabilitated clients will pay back \$4.18 through taxes for every dollar spent on their services.

New Performance Measures for VR

- 1. Percentage employed 2nd quarter after exit
- 2. Percentage employed 4th quarter after exit
- 3. Median earnings of those employed 2nd quarter after exit
- 4. Percentage in education/training program attaining recognized postsecondary credential or secondary school diploma/equivalent



New Performance Measures for VR

- 5. Percentage in education/training program achieving measurable skills gains
- 6. Effectiveness in serving employers
 - Percentage of repeat employers using services
 - Percentage of all SC employers using services



Requires state VR agencies to expend at least **15 percent** of their federal allotments for Pre-Employment Transition Services for Students with Disabilities:

- Job exploration counseling
- Work based learning experiences
- Counseling on opportunities for transition or post-secondary educational programs
- Workplace readiness training
- Instruction in self-advocacy

Purchase of up to 1,000 computers (statewide)

- Current computers unsupported by Microsoft after January 2020
- Will no longer receive security updates that help protect from viruses and other malicious software endangering personal information of clients and staff



NEW:

Deferred Maintenance, Capital Projects, Ordinary Repair and Maintenance

- Would allow VR to establish fund with State Treasurer to deposit funds appropriated for deferred maintenance and capital projects
- More than 900,000 square feet of facilities
- Would be interest-bearing and allow flexibility of carry-forward (for same purpose)



NEW:

Licensing Requirements for Disability Examiners

- Seeking waiver for certain state licensing requirements for physicians employed by Disability Determination Services for evaluation of medical evidence for disability benefits claims.
- These physicians do not perform examinations or have any contact with claimants.



AMEND:

93.19 DOA: Sale of Surplus Real Property

- VR seeks deletion of the reference to its sale of property in Clinton
- The agency has met the requirements by utilizing net proceeds of the sale for capital projects or deferred maintenance, which has been completed and reported as directed.



DELETE:

117.130 GP: Equestrian Center Therapy Program

- Proviso required VR to transfer \$500,000 to Lander University for operation of its equestrian center and to create a pilot program for equine-assisted psychotherapy for military members.
- VR has met the requirements of the proviso by completing the transfer.
