# **SENATE BILL 1258**

S. 1258 -- Finance Committee: A BILL TO AMEND CHAPTER 43, TITLE 11 OF THE 1976 CODE, RELATING TO THE SOUTH CAROLINA TRANSPORTATION INFRASTRUCTURE BANK, TO PROVIDE FOR THE DISTRIBUTION BY THE DEPARTMENT OF TRANSPORTATION AND THE SOUTH CAROLINA TRANSPORTATION INFRASTRUCTURE BANK OF CERTAIN FEES AND FINES COLLECTED BY THE DEPARTMENT OF MOTOR VEHICLES TRANSFERRED TO THE STATE HIGHWAY FUND; TO AMEND SECTIONS 12-37-2740(D), 38-73-470, 56-1-170(B)(3), 56-1-200, 56-1-286(K)(1), 56-1-390(2), 56-1-400(A), 56-1-460(A)(1)(e)(iii), 56-1-550, 56-1-740(B)(3), 56-1-746(D)(3), 56-1-2080, 56-3-355, 56-3-1335, 56-5-750(G)(3), 56-5-2951(B)(1), 56-5-2951(H)(3), 56-9-330, 56-10-240(C), 56-10-245, 56-10-552, 56-19-420(C), AND 56-19-520(A)(4), ALL OF THE 1976 CODE, ALL RELATING TO FEES OR FINES COLLECTED BY THE DEPARTMENT OF MOTOR VEHICLES, TO PROVIDE THAT ALL OR A PORTION OF THE FEES SHALL BE CREDITED TO THE STATE HIGHWAY FUND, AND TO PROVIDE FOR THE DISTRIBUTION OF THOSE FUNDS BY THE DEPARTMENT OF TRANSPORTATION AND THE SOUTH CAROLINA TRANSPORTATION INFRASTRUCTURE BANK; TO AMEND SECTION 12-36-2647 OF THE 1976 CODE, AS ENACTED IN ACT 98 OF 2013 AND RELATED TO SOURCES OF REVENUE USED FOR HIGHWAY CONSTRUCTION AND MAINTENANCE, TO PROVIDE THAT THE REVENUES OF SALES, USE, AND CASUAL EXCISE TAXES DERIVED PURSUANT TO SECTIONS 12-36-2620(1) AND 12-36-2640(1) ON THE SALE, USE, OR TITLING OF A MOTOR VEHICLE MUST BE CREDITED TO THE STATE HIGHWAY FUND, AND TO PROVIDE FOR THE DISTRIBUTION OF THOSE FUNDS OF TRANSPORTATION AND THE SOUTH CAROLINA DEPARTMENT TRANSPORTATION INFRASTRUCTURE BANK.

Summary of Bill:

Transfers Motor Vehicle Sales Tax revenues and DMV Fees and Fines revenues to the SCDOT. An equivalent amount of non-tax source revenues are transfered from the SCDOT to the SIB for bridge and interstate projects identified by the SCDOT. An estimated \$950 M to eliminate structurally-deficient and load-restricted bridges, and \$2 B for Interstate Widenings and Improvements. See attached for bill and amendment summaries.

Estimated Revenue Impact:

As amended, this bill would reduce fees and fines revenue from the DMV by an estimated \$84,200,000. General Fund sales and use tax revenue and the State Non-Federal Aid Highway Fund will each be reduced by an estimated \$65,680,000. All funds will be distributed to the SCDOT's State Highway Fund, for an estimated total of \$215,560,000 in FY 16-17.

# S. 1258 Summary

Directs all revenue collected from the sales tax on motor vehicles - excluding the 20% portion designated for the EIA - to be credited to the SCDOT State Highway Fund

- RFA Estimate: \$131,360,000
- SCDOT must transfer amount required to finance bridge and road projects identified by SCDOT to the State Infrastructure Bank (SIB)

- SCDOT is directed to allocate any funds not needed to finance SIB projects to the state-funded resurfacing program and develop a needs-based methodology to distribute the revenue so that each county is guaranteed funding.

# **S.1258 Amendment Summary**

- Amendment adds new sections to include language from the House passed, amended version of H.3579 (now in conference), and a provision to capture all fee and fine revenue retained by the DMV for operations an increase from \$71.75 M/year (senate version) to \$84.2 M/year
- This represents an additional \$12.45 M/year or \$136 M in additional SIB bonds

### Commission

- All Highway Commissioners are appointed by the Governor, 7 district and 1 state-wide
- Keeps the qualifications for Commissioners removed in senate version
- Requires that "other demographic factors such as residence in rural or urban areas" be considered
- Advice and consent of General Assembly (roll call language removed)
- Commissioners serve four year terms, no more than two consecutive terms, and may not serve more than 12 years, regardless of when the term is/was served (retroactive)

### Secretary

- Commission appoints a Secretary of Transportation with Advice/Consent of *General Assembly (roll call language removed)*

### Joint Transportation Review Committee

Repeals the JTRC code sections and eliminates the Committee

### **Effective Dates and Current Commissioners**

- Sections 1-4 take effect on July 1, 2016
- Members serving on the Commission on June 30, 2016 shall continue to serve until their current term expires, and until their successor is appointed and confirmed
- Vacancies are filled by appointment of the Governor, and serve until the end of that unexpired term
- Any eligible commissioner may be reappointed by Governor on or after June 30, 2016

### **SIB Project Review by Commission**

- Before any loan or financial assistance can be provided by the SIB, the board must submit the decision to the DOT Commission for approval, rejection, or a request for additional information from the SIB Board
- Does not relate to any payment or contractual obligations that the DOT has to the bank that are pledged to any bonds issued by the bank

### \$25 M SIB Project Threshold

SIB cannot provide financial assistance for any project below \$25 M

# 1258 Funding Summary

- Fee and Fine revenues collected by the DMV and used for agency operations are transferred to the SCDOT/State Highway Fund \$84.2 M
- All Motor Vehicle Sales tax revenues (excluding the EIA portion) are transferred to the SCDOT/State Highway Fund - \$131.3 M
- SCDOT to use funds for resurfacing program, implemented with a needs-based distribution methodology, including consideration on a county-by-county basis, to ensure that each county in the state is guaranteed funding for resurfacing
- SCDOT shall identify road and bridge projects to be financed through the SIB, and transfer non-tax revenue in amounts equal to the finance requirements of the selected projects

/ SECTION \_\_\_\_. A. SECTIONS 57-1-310 THROUGH SECTION 57-1-340 OF THE 1976 CODE, ALL AS LAST AMENDED BY ACT 114 OF 2007, ARE FURTHER AMENDED TO READ:

"SECTION 57-1-310. (A) THE CONGRESSIONAL DISTRICTS OF THIS STATE ARE CONSTITUTED AND CREATED DEPARTMENT OF

TRANSPORTATION DISTRICTS OF THE STATE, DESIGNATED BY NUMBERS CORRESPONDING TO NUMBERS OF THE RESPECTIVE CONGRESSIONAL DISTRICTS. THE COMMISSION OF THE DEPARTMENT OF TRANSPORTATION SHALL BE COMPOSED OF ONE MEMBER FROM EACH TRANSPORTATION DISTRICT ELECTED BY THE DELEGATIONS OF THE CONGRESSIONAL DISTRICT AND ONE MEMBER APPOINTED BY THE GOVERNOR FROM THE STATE AT LARGE, ALL APPOINTED BY THE GOVERNOR, UPON THE ADVICE AND CONSENT OF THE GENERAL ASSEMBLY. - (C) AN INSTITUTION OF HIGHER LEARNING CHARTERED BEFORE 1962; OR
- (2) A BACKGROUND OF AT LEAST FIVE YEARS IN ANY COMBINATION OF THE FOLLOWING FIELDS OF EXPERTISE:
  - (A) TRANSPORTATION;
  - (B) CONSTRUCTION;
  - (C) FINANCE;
  - (D) LAW;
  - (E) ENVIRONMENTAL ISSUES;

SECTION 57-1-320. (A) A COUNTY THAT IS DIVIDED AMONG TWO OR MORE DEPARTMENT OF TRANSPORTATION DISTRICTS, FOR PURPOSES OF ELECTING A COMMISSION MEMBER, IS DEEMED TO BE CONSIDERED IN THE DISTRICT WHICH CONTAINS THE LARGEST NUMBER OF RESIDENTS FROM THAT COUNTY.

(B) No A COUNTY WITHIN A DEPARTMENT OF TRANSPORTATION DISTRICT SHALL MAY NOT HAVE A RESIDENT COMMISSION MEMBER FOR MORE THAN ONE CONSECUTIVE TERM TWELVE CONSECUTIVE YEARS

AND IN NO EVENT SHALL ANY TWO PERSONS FROM THE SAME COUNTY SERVE AS A COMMISSION MEMBER SIMULTANEOUSLY EXCEPT AS PROVIDED HEREINAFTER.

SECTION 57-1-325. LEGISLATORS RESIDING IN THE CONGRESSIONAL DISTRICT SHALL MEET UPON WRITTEN CALL OF A MAJORITY OF THE MEMBERS OF THE DELEGATION OF EACH DISTRICT AT A TIME AND PLACE TO BE DESIGNATED IN THE CALL FOR THE PURPOSE OF ELECTING A COMMISSIONER TO REPRESENT THE DISTRICT. A MAJORITY PRESENT, EITHER IN PERSON OR BY WRITTEN PROXY, OF THE DELEGATION FROM A GIVEN CONGRESSIONAL DISTRICT CONSTITUTES A QUORUM FOR THE PURPOSE OF ELECTING A DISTRICT COMMISSIONER. NO PERSON MAY BE ELECTED COMMISSIONER WHO FAILS TO RECEIVE A MAJORITY VOTE OF THE MEMBERS OF THE DELEGATION.

THE DELEGATION MUST BE ORGANIZED BY THE ELECTION OF A CHAIRMAN AND A SECRETARY, AND THE DELEGATIONS OF EACH CONGRESSIONAL DISTRICT SHALL ADOPT SUCH RULES AS THEY CONSIDER PROPER TO GOVERN THE ELECTION. ANY ABSENTEE MAY VOTE BY WRITTEN PROXY. WHEN THE ELECTION IS COMPLETED, THE CHAIRMAN AND THE SECRETARY OF THE DELEGATION SHALL IMMEDIATELY TRANSMIT THE NAME OF THE PERSON ELECTED TO THE SECRETARY OF STATE WHO SHALL ISSUE TO THE PERSON, AFTER HE HAS TAKEN THE USUAL OATH OF OFFICE, A CERTIFICATE OF ELECTION AS COMMISSIONER. THE GOVERNOR SHALL THEN ISSUE A COMMISSION TO THE PERSON, AND PENDING THE ISSUANCE OF THE COMMISSION, THE CERTIFICATE OF ELECTION IS SUFFICIENT WARRANT TO THE PERSON TO PERFORM ALL OF THE DUTIES AND FUNCTIONS OF HIS OFFICE AS COMMISSIONER. EACH COMMISSIONER SHALL SERVE UNTIL HIS SUCCESSOR IS ELECTED AND QUALIFIED.

SECTION 57-1-330. (A) FOR THE PURPOSES OF ELECTING A COMMISSION MEMBER, A LEGISLATOR SHALL VOTE ONLY IN THE

CONGRESSIONAL DISTRICT IN WHICH HE RESIDES. ALL COMMISSION MEMBERS ARE ELECTED TO A TERM OF OFFICE OF FOUR YEARS WHICH EXPIRES ON FEBRUARY FIFTEENTH OF THE APPROPRIATE YEAR. HOWEVER, A COMMISSION MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE TERMS, AND MAY NOT SERVE MORE THAN TWELVE YEARS, REGARDLESS OF WHEN THE TERM WAS SERVED. COMMISSIONERS SHALL CONTINUE TO SERVE UNTIL THEIR SUCCESSORS ARE **PROVIDED** APPOINTED AND QUALIFY CONFIRMED, COMMISSIONER MAY ONLY MAY SERVE IN A HOLD-OVER CAPACITY FOR A PERIOD NOT TO EXCEED SIX MONTHS. ANY VACANCY OCCURRING IN THE OFFICE OF COMMISSIONER SHALL BE FILLED BY ELECTION OR APPOINTMENT IN THE MANNER PROVIDED IN THIS ARTICLE FOR THE UNEXPIRED TERM ONLY. EXCEPT FOR THE AT-LARGE MEMBER, NO A PERSON IS NOT ELIGIBLE TO SERVE AS A COMMISSION MEMBER WHO IS NOT A RESIDENT OF THAT DISTRICT AT THE TIME OF HIS APPOINTMENT. FAILURE BY AN ELECTED SUCH COMMISSION MEMBER TO MAINTAIN RESIDENCY IN THE DISTRICT FOR WHICH HE IS ELECTED APPOINTED SHALL RESULT IN THE FORFEITURE OF HIS OFFICE.

- (B) THE AT-LARGE COMMISSION MEMBER SHALL SERVE AT THE PLEASURE OF THE GOVERNOR. THE AT-LARGE COMMISSION MEMBER MAY BE APPOINTED FROM ANY COUNTY IN THE STATE UNLESS ANOTHER COMMISSION MEMBER IS SERVING FROM THAT COUNTY. FAILURE BY THE AT-LARGE COMMISSION MEMBER TO MAINTAIN RESIDENCE IN THE STATE SHALL RESULT IN A FORFEITURE OF HIS OFFICE.
- (C) ALL ELECTED COMMISSION MEMBERS MAY BE REMOVED FROM OFFICE AS PROVIDED IN SECTION 1-3-240(C)(1).

SECTION 57-1-340. EACH COMMISSION MEMBER, WITHIN THIRTY DAYS AFTER HIS ELECTION OR APPOINTMENT, AND BEFORE ENTERING UPON THE DISCHARGE OF THE DUTIES OF HIS OFFICE, SHALL TAKE, SUBSCRIBE, AND FILE WITH THE SECRETARY OF STATE THE OATH OF OFFICE PRESCRIBED BY THE CONSTITUTION OF THE STATE."

B. SECTION 57-1-410 OF THE 1976 CODE, AS LAST AMENDED BY ACT 114 OF 2007, IS FURTHER AMENDED TO READ:

"SECTION 57-1-410. THE GOVERNOR COMMISSION SHALL APPOINT, WITH THE ADVICE AND CONSENT OF THE SENATE GENERAL ASSEMBLY, A SECRETARY OF TRANSPORTATION WHO SHALL SERVE AT THE PLEASURE OF THE GOVERNOR COMMISSION. A PERSON APPOINTED TO THIS POSITION SHALL POSSESS PRACTICAL AND SUCCESSFUL BUSINESS AND EXECUTIVE ABILITY AND BE KNOWLEDGEABLE IN THE FIELD OF TRANSPORTATION. THE SECRETARY OF TRANSPORTATION SHALL RECEIVE SUCH COMPENSATION AS MAY BE ESTABLISHED UNDER THE PROVISIONS OF SECTION 8-11-160 AND FOR WHICH FUNDS HAVE BEEN AUTHORIZED IN THE GENERAL APPROPRIATIONS ACT."

C. This SECTION takes effect July 1, 2016, except that the members of the Commission of the Department of Transportation serving on June 30, 2016, shall continue to serve until their current term expires, and until their successor is appointed and confirmed. If a vacancy occurs in the seat of a member serving on June 30, 2016, before the member's term otherwise expires, the vacancy must be filled in the manner specified in Chapter 1, Title 57 of the 1976 Code, as amended by this act, and the member filling the vacancy shall serve until the term expires. The members serving on June 30, 2016, if otherwise eligible, may be reappointed pursuant to Section 57-1-310, as amended by this act.

SECTION \_\_\_. A. SECTION 57-1-360 OF THE 1976 CODE, AS ADDED BY ACT 114 OF 2007, IS AMENDED TO READ:

- "SECTION 57-1-360. (A) THE COMMISSION MUST APPOINT A STATE AUDITOR SHALL EMPLOY AN INDIVIDUAL TO SERVE AS THE CHIEF INTERNAL AUDITOR OF THE DEPARTMENT, AND OTHER PROFESSIONAL, ADMINISTRATIVE, TECHNICAL, AND CLERICAL PERSONNEL AS THE COMMISSION STATE AUDITOR DETERMINES TO BE NECESSARY IN THE PROPER DISCHARGE OF THE COMMISSION'S DUTIES AND RESPONSIBILITIES PROVIDED BY LAW. THE COMMISSION STATE AUDITOR ALSO MUST PROVIDE PROFESSIONAL, ADMINISTRATIVE, TECHNICAL, AND CLERICAL PERSONNEL, AS THE COMMISSION STATE AUDITOR DETERMINES TO BE NECESSARY, FOR THE CHIEF INTERNAL AUDITOR TO PROPERLY DISCHARGE HIS DUTIES AND RESPONSIBILITIES AUTHORIZED BY THE COMMISSION STATE AUDITOR OR PROVIDED BY LAW. EXCEPT AS OTHERWISE PROVIDED, ANY EMPLOYEES HIRED PURSUANT TO THIS SECTION SHALL SERVE AT THE PLEASURE OF THE COMMISSION STATE AUDITOR.
- (B)(1) THE CHIEF INTERNAL AUDITOR SHALL SERVE FOR A TERM OF FOUR YEARS AND MAY BE REMOVED BY THE COMMISSION ONLY FOR MALFEASANCE, MISFEASANCE, INCOMPETENCY, ABSENTEEISM, CONFLICTS OF INTEREST, MISCONDUCT, PERSISTENT NEGLECT OF DUTY IN OFFICE, OR INCAPACITY. THE CHIEF INTERNAL AUDITOR MUST BE A CERTIFIED PUBLIC ACCOUNTANT AND POSSESS ANY OTHER EXPERIENCE THE COMMISSION STATE AUDITOR MAY REQUIRE. THE CHIEF INTERNAL AUDITOR MUST ESTABLISH, IMPLEMENT, AND MAINTAIN THE EXCLUSIVE INTERNAL AUDIT FUNCTION OF ALL DEPARTMENTAL ACTIVITIES. THE COMMISSION STATE AUDITOR SHALL SET THE SALARY FOR THE CHIEF INTERNAL AUDITOR AS ALLOWED BY STATUTE OR APPLICABLE LAW.
- (2) THE AUDITS PERFORMED BY THE CHIEF INTERNAL AUDITOR MUST COMPLY WITH RECOGNIZED GOVERNMENTAL AUDITING STANDARDS. THE DEPARTMENT AND ANY ENTITY CONTRACTING WITH THE DEPARTMENT MUST FULLY COOPERATE WITH THE CHIEF INTERNAL AUDITOR IN THE DISCHARGE OF HIS DUTIES AND RESPONSIBILITIES AND MUST TIMELY PRODUCE ALL BOOKS, PAPERS, CORRESPONDENCE,

MEMORANDA, AND OTHER RECORDS CONSIDERED NECESSARY IN CONNECTION WITH AN INTERNAL AUDIT. ALL FINAL AUDIT REPORTS MUST BE SUBMITTED TO THE COMMISSION AND THE CHAIRMAN OF THE SENATE TRANSPORTATION COMMITTEE, THE CHAIRMAN OF THE SENATE FINANCE COMMITTEE, THE CHAIRMAN OF THE HOUSE OF REPRESENTATIVES EDUCATION AND PUBLIC WORKS COMMITTEE, AND THE CHAIRMAN OF THE HOUSE OF REPRESENTATIVES WAYS AND MEANS COMMITTEE BEFORE BEING MADE PUBLIC.

- (3) THE COMMISSION STATE AUDITOR IS VESTED WITH THE EXCLUSIVE MANAGEMENT AND CONTROL OF THE CHIEF INTERNAL AUDITOR.
- (C) THE DEPARTMENT, AT ITS OWN EXPENSE, MUST PROVIDE APPROPRIATE OFFICE SPACE WITHIN ITS HEADQUARTERS, BUILDING, AND FACILITY SERVICE, INCLUDING JANITORIAL, UTILITY AND TELEPHONE SERVICES, COMPUTER AND TECHNOLOGY SERVICES, AND RELATED SUPPLIES, FOR THE CHIEF INTERNAL AUDITOR AND HIS SUPPORT STAFF."
- B. (A) THE CHIEF INTERNAL AUDITOR OF THE DEPARTMENT OF TRANSPORTATION AND ALL ASSOCIATED SUPPORT STAFF, AND ALL AUTHORIZED APPROPRIATIONS ASSOCIATED WITH THE CHIEF INTERNAL AUDITOR AND ASSOCIATED SUPPORT STAFF ARE TRANSFERRED TO AND BECOME PART OF THE STATE AUDITOR'S OFFICE, STATE FISCAL ACCOUNTABILITY AUTHORITY. THE CHIEF INTERNAL AUDITOR OF THE DEPARTMENT OF TRANSPORTATION AND ALL ASSOCIATED SUPPORT STAFF, WHETHER CLASSIFIED OR UNCLASSIFIED PERSONNEL, EMPLOYED BY THE DEPARTMENT OF TRANSPORTATION ON THE EFFECTIVE DATE OF THIS ACT, EITHER BY CONTRACT OR BY EMPLOYMENT AT WILL, SHALL BECOME EMPLOYEES OF THE STATE AUDITOR'S OFFICE, STATE FISCAL ACCOUNTABILITY AUTHORITY, WITH THE SAME COMPENSATION, CLASSIFICATION, AND GRADE LEVEL, AS APPLICABLE.

(B) THE CHIEF INTERNAL AUDITOR OF THE DEPARTMENT OF TRANSPORTATION ON JUNE 30, 2016, SHALL CONTINUE TO SERVE UNTIL THE STATE AUDITOR EMPLOYS A SUCCESSOR. NOTHING IN THIS SECTION SHALL PREVENT THE STATE AUDITOR FROM RETAINING THE CHIEF INTERNAL AUDITOR OF THE DEPARTMENT OF TRANSPORTATION AS OF JUNE 30, 2016, PURSUANT TO THE PROVISIONS OF THIS SECTION.

SECTION \_\_\_\_. SECTION 57-1-490 OF THE 1976 CODE, AS AMENDED BY ACT 114 OF 2007, IS FURTHER AMENDED TO READ:

"SECTION 57-1-490. (A) THE DEPARTMENT SHALL BE AUDITED BY A CERTIFIED PUBLIC ACCOUNTANT OR FIRM OF CERTIFIED PUBLIC ACCOUNTANTS ONCE EACH YEAR TO BE DESIGNATED BY THE STATE AUDITOR. THE DESIGNATED ACCOUNTANT OR FIRM OF ACCOUNTANTS SHALL ISSUE AUDITED FINANCIAL STATEMENTS IN ACCORDANCE WITH GENERALLY ACCEPTED ACCOUNTING PRINCIPLES, AND SUCH FINANCIAL STATEMENTS SHALL MUST BE MADE AVAILABLE ANNUALLY BY OCTOBER FIFTEENTH TO THE GENERAL ASSEMBLY. THE COSTS AND EXPENSES OF THE AUDIT MUST BE PAID BY THE DEPARTMENT OUT OF ITS FUNDS.

(B) THE MATERIALS MANAGEMENT OFFICE OF THE DEPARTMENT OF ADMINISTRATION STATE FISCAL ACCOUNTABILITY AUTHORITY ANNUALLY MUST AUDIT THE DEPARTMENT'S INTERNAL PROCUREMENT OPERATION TO ENSURE THAT THE DEPARTMENT HAS ACTED PROPERLY WITH REGARD TO THE DEPARTMENT'S EXEMPTIONS CONTAINED IN SECTION 11-35-710. THE CHAIRMEN OF THE HOUSE OF REPRESENTATIVES WAYS AND MEANS AND EDUCATION AND PUBLIC WORKS COMMITTEES. THE COSTS AND EXPENSES OF THE AUDIT MUST BE PAID BY THE DEPARTMENT OUT OF ITS FUNDS.

- (C) THE LEGISLATIVE AUDIT COUNCIL SHALL CONTRACT FOR AN INDEPENDENT PERFORMANCE AND COMPLIANCE AUDIT OF THE DEPARTMENT'S FINANCE AND ADMINISTRATION DIVISION, MASS TRANSIT DIVISION, AND CONSTRUCTION ENGINEERING AND PLANNING DIVISION. THIS AUDIT MUST BE COMPLETED BY JANUARY 15, 2010. THE LEGISLATIVE AUDIT COUNCIL MAY CONTRACT FOR FOLLOW-UP AUDITS OR CONDUCT FOLLOW-UP AUDITS AS NEEDED BASED UPON THE AUDIT'S INITIAL FINDINGS. THE COSTS OF THESE AUDITS, INCLUDING RELATED ADMINISTRATIVE AND MANAGEMENT EXPENSES OF THE LEGISLATIVE AUDIT COUNCIL, ARE AN OPERATING EXPENSE OF THE DEPARTMENT. THE DEPARTMENT SHALL PAY DIRECTLY TO THE LEGISLATIVE AUDIT COUNCIL THE COST OF THE AUDITS.
- (D) COPIES OF EVERY AUDIT CONDUCTED PURSUANT TO THIS SECTION MUST BE MADE AVAILABLE TO THE DEPARTMENT OF TRANSPORTATION COMMISSION, THE DEPARTMENT OF TRANSPORTATION CHIEF INTERNAL AUDITOR STATE AUDITOR, THE GOVERNOR, THE CHAIRMEN OF THE SENATE FINANCE AND TRANSPORTATION COMMITTEES, AND THE CHAIRMEN OF THE HOUSE OF REPRESENTATIVES WAYS AND MEANS AND EDUCATION AND PUBLIC WORKS COMMITTEES."

SECTION \_\_\_\_. ARTICLE 7, CHAPTER 1, TITLE 57 OF THE 1976 CODE IS REPEALED.

SECTION \_\_\_\_. SECTION 11-43-150 OF THE 1976 CODE IS AMENDED BY ADDING AN APPROPRIATELY LETTERED SUBSECTION AT THE END TO READ:

"() BEFORE PROVIDING A LOAN OR OTHER FINANCIAL ASSISTANCE TO A QUALIFIED BORROWER ON A QUALIFIED PROJECT, THE BOARD OF DIRECTORS MUST SUBMIT THE DECISION TO THE DEPARTMENT OF TRANSPORTATION COMMISSION FOR ITS CONSIDERATION. THE DEPARTMENT OF TRANSPORTATION COMMISSION CAN APPROVE OR REJECT THE BOARD OF DIRECTORS DECISIONS OR REQUEST ADDITIONAL INFORMATION FROM THE BOARD OF DIRECTORS. THIS REQUIREMENT DOES NOT APPLY TO DECISIONS BY THE BOARD THAT RELATE TO ANY PAYMENT OR CONTRACTUAL OBLIGATIONS THAT THE DEPARTMENT OF TRANSPORTATION HAS TO THE BANK THAT ARE PLEDGED TO ANY BONDS ISSUED BY THE BANK."

In order to minimize continued cost escalation, the agency administration recommends that the projects initiated within the ACT 98 Interstate Widening Program from 2013 be completed and advanced as soon as they are ready to move into the construction or design-build phase. For example, the I-85 Phase 3 in Cherokee will be poised and ready to advance in 2018 and the I-26/20/126 Interchange project is forecasted to be ready to advance to construction (in-phases) beginning in 2019.

**Fiscal Impact Summary** 

This bill would reduce fees and fines revenue from the Department of Motor Vehicles by an estimated \$71,750,000 to be distributed to the Department of Transportation's State Highway Fund. General Fund sales and use tax revenue and the State Non-Federal Aid Highway Fund will be reduced by an estimated \$65,680,000 to be distributed to the Department of Transportation's State Highway Fund. Other Funds of the Department of Transportation will increase by a total of \$203,110,000 in FY 2016-17. There will be no impact to Federal Funds from this bill.

# **Explanation of Fiscal Impact**

# **State Expenditure**

The Department of Transportation. The Department indicates that this bill would have no expenditure impact to the General Fund, Federal Funds, or Other Funds.

### State Revenue

This bill amends Sections 56-19-520(A)(4), 56-19-420(C), 56-1-550, 56-1-200, 56-1-170(B)(3), 56-1-740(B)(3), 56-5-750(G)(3), 56-1-460(A)(1)(e)(iii), 56-1-286(K)(1), 56-5-2951(B)(1), 56-5-2951(H)(3), 56-1-746(D)(3), 56-1-2080, 56-1-400(A), 56-1-390(2), 56-3-355, 56-3-1335, 12-37-2740(D), and 56-9-330 of the South Carolina Code so that the revenue generated from various operating fees and fines collected by the Department of Motor Vehicles be reallocated to the State Highway Fund of the Department of Transportation. Based upon a preliminary analysis of data from the Department of Motor Vehicles, revenues generated relating to these operating fees and fines were \$37,766,607 in FY 2014-15. This portion of the bill would reduce the

Department of Motor Vehicles fees and fines revenue by an estimated \$38,750,000 and generate a corresponding \$38,750,000 revenue increase to the State Highway Fund in FY 2016-17.

This bill also amends Sections 56-10-240(C), 56-10-245, 38-73-470, and 56-10-552 of the South Carolina Code so that the revenue generated from uninsured motorist fees and fines collected by the Department of Motor Vehicles be reallocated to the State Highway Fund of the Department of Transportation. Based upon a preliminary analysis of data from the Department of Motor Vehicles, revenues generated relating to the uninsured motorist fees and fines were \$31,286,016 in FY 2014-15. This portion of the bill would reduce the Department of Motor Vehicles fees and fines revenue by an estimated \$33,000,000 and generate a corresponding \$33,000,000 revenue increase to the State Highway Fund in FY 2016-17.

Currently, Act 98 of 2013 allows fifty percent of the revenues derived from the sale of motor vehicles pursuant to Sections 12-36-2620(1) and 12-36-2640(1) to be redirected from the state public school building fund and credited to the State Non-Federal Aid Highway Fund. This transfer only affects the four percent component of the sales and use tax credited to the General Fund and does not affect EIA Fund revenue collections. According to the Department of Revenue, this transfer amounted to a reduction in General Fund sales and use tax revenue of \$60,947,394 and a concomitant increase in State Highway Fund revenue in FY 2014-15.

This section would amend Section 12-36-2647 to credit the remaining fifty percent of the revenues derived from the sale of motor vehicles pursuant to Sections 12-36-2620(1) and 12-36-2640(1) to the State Highway Fund. Again, this transfer only affects the four percent component of the sales and use tax and does not affect the one percent for EIA. Based upon the latest data on motor vehicle sales, the Board of Economic Advisors' maximum sales and use tax cap model suggests motor vehicle sales and use tax revenue of an estimated \$164,200,000 in FY 2016-17.

Under current law, \$65,680,000 is expected to be transferred to the Department of Transportation for the State Non-Federal Aid Highway Fund, \$65,680,000 is expected for deposit to the General Fund, and \$32,840,000 is to be credited to the Education Improvement Act Fund. Pursuant to this bill, the General Fund allocation of \$65,680,000 would be transferred to the State Highway Fund in addition to the current allocation of \$65,680,000 for a total of \$131,360,000. The Department of Transportation shall transfer an amount equal to the revenue credited to the State Highway Fund pursuant to 12-36-2647(A), or \$131,360,000, to the South Carolina Transportation Infrastructure Bank. The first \$50,000,000 transferred to the bank shall be used to finance bridge replacement, rehabilitation projects, and expansion and improvements on existing roads in the State Highway System. Any funds in excess of \$50,000,000 transferred to the bank shall be used to finance expansion and improvements to existing mainline interstates.

This bill takes effect July 1, 2016.
