My role as a judge is to preside over an orderly court, advise jurors so that they understand and are comfortable with the process, encourage lawyers, and listen to the positions of the parties and their witnesses. I believe I maintain a good working relationship with court personnel. I am considerate of the pressures on practicing lawyers, the demands of their clients, and the affects of my decisions on all parties: plaintiffs, the State, defendants and victims.
