1. Why do you want to serve as a Circuit Court judge?

I believe in public service at the highest level. Serving as a Circuit Court judge would allow me to increase my service to my state by supporting and advancing the trust, dignity, and respect of the judiciary.

2. Do you plan to serve your full term if elected?

Yes.

3. Do you have any plans to return to private practice one day?

4. Have you met the Constitutional requirements for this position regarding age, residence, and years of practice?

5. What is your philosophy regarding *ex parte* communications? Are there circumstances under which you could envision *ex parte* communications being tolerated?

I follow the law, and I will require parties appearing before me to do the same. *Ex parte* communications are illegal and I will not initiate, permit, or consider *ex parte* communications. Even though exceptions exist for administrative matters, scheduling, and emergencies *ex parte* communications are not a best practice. As such, my philosophy on *ex parte* communications is that all parties should be involved in any and all communication regarding any matter before me for consideration.

6. If you disclosed something that had the appearance of bias, but you believed it would not actually prejudice your impartiality, what deference would you give a party that requested your recusal? Would you grant such a motion?

I would give great deference to a party that requested my recusal if they believed something I disclosed gave the appearance of bias because upholding the integrity, independence, and public confidence of the judiciary is of the utmost importance. I would address recusal motions on a case-by-case basis to fully unpack the potential bias by seeking to understand the party's basis for the motion. I would more likely than not grant the recusal motion if the party articulates the appearance of bias if I cannot clearly articulate how and why I can maintain my impartiality to the moving party's satisfaction.

7. How would you handle the appearance of impropriety because of the financial or social involvement of your spouse or a close relative?

I would confront the matter directly by requesting an ethics opinion from the State Ethics Commission. Additionally, I would request that my spouse or close relative cease and desist the activity in question.

8. What standards would you set for yourself regarding the acceptance of gifts or social hospitality?

I would not accept gifts or social hospitality.

9. How would you handle a situation in which you became aware of misconduct or appearance of infirmity of a lawyer or of a fellow judge?

I would confront the accused with the allegation in a private and

professional manner. If at any point I gain knowledge of a violation, I would report the violation to the appropriate authority.
