That being said, it should also be said that your email was the first notice I have had about this case as I was not served with any summons or any other paper giving me notice that I was a party to a lawsuit.

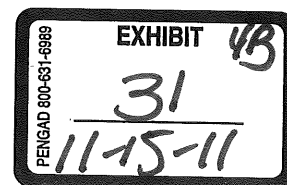
I ask that Anthony, my law clerk, verify this.
