It is not only the skill to recognize legal questions but the ability to define the issue and to craft an answer in a succinct way to be understandable and useable. I believe my skills of communication with the judges on the court have been refined and made me a better judge as well. Without the skill to reasonably and effectively express your analysis of an issue any academic or professional ability is muted and dulled. The experience of working with my law clerks and other judges on the court to prepare opinions and see them evolve and develop thru research, discussion and oral argument has likewise educated me in an intellectual and maturing way. It has matured me to accept fair comment and improvement to my writings. What "we" produce in our court opinions must be done well with word and reason. I believe the work, the effort and the experience has made me a better judge and qualified me for continued service on the Court of Appeals.
