H. 3929 -- Reps. Hiott, Pitts, Kirby, Forrest, Yow, Sandifer, Atkinson, Hayes, Hixon and V.S. Lowe, Ott, Pitts and White: A BILL TO AMEND SECTION 49-6-30, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO MEMBERSHIP ON THE SOUTH CAROLINA AQUATIC PLANT MANAGEMENT COUNCIL, SO AS TO ALTER THE COMPOSITION OF THE COUNCIL; AND TO AMEND SECTION 49-6-40, RELATING TO THE AQUATIC PLANT MANAGEMENT PLAN, SO AS TO REQUIRE THE PLAN TO BALANCE AQUATIC PLANT MANAGEMENT WITH THE PRESERVATION OF FISH AND WILDLIFE HABITATS.
