### **S\*1114 (Rat #0562, Act #0469 of 1990) General Bill, By Senate Banking and Insurance**

A Bill to amend Section 38-75-310, Code of Laws of South Carolina, 1976, relating to the definitions pertaining to windstorm and hail insurance; Section 38-75-320, relating to the purpose of the windstorm and hail insurance provisions; and Section 38-75-330, relating to the creation and members of the Windstorm and Hail Underwriting Association, so as to change the references to windstorm to wind and to define the Wind and Hail Underwriting Association and its membership exemptions.-amended title
