### **H\*3053 (Rat #0525, Act #0443 of 1990) General Bill, By Kirsh and T.T. Mappus**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 56-5-3885 so as to make it unlawful for a person to operate a motor vehicle in this State which has affixed to it an obscene bumper sticker and to provide penalties for violation.
