### **H\*3711 (Rat #0158, Act #0095 of 1991) General Bill, By House Agriculture, Natural Resources and Environmental Affairs**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 20 to Title 50 so as to provide for the Recreational Fisheries Conservation and Management Act of 1991.
