**Summary:** Criminal justice organizations exempt from tort liability

AN ACT TO AMEND SECTION 40-71-10, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO MEMBERS OF CERTAIN PROFESSIONAL SOCIETIES WHO ARE EXEMPT FROM TORT LIABILITY, SO AS TO REVISE THE DEFINITION OF PROFESSIONAL SOCIETY TO INCLUDE THE SOUTH CAROLINA LAW ENFORCEMENT ACCREDITATION COUNCIL. - ratified title
