### ***Similar (H 4396)***

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 38-71-135 so as to require all individual and group health insurance and health maintenance organization policies to provide payment for hospitalization of a mother and her child, if at the discretion of the attending physician it is medically necessary, for a period not to exceed the second postpartum day, not including the day of delivery, after a vaginal delivery, or the third post-operative day, not including the day of surgery, after a Caesarian Section, and to provide for exceptions.-amended title
