AN ACT TO AMEND CHAPTER 45 OF TITLE 46, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE NUISANCE SUITS PERTAINING TO AGRICULTURAL OPERATIONS, SO AS TO PROVIDE THAT WITH CERTAIN EXCEPTIONS LOCAL COUNTY ORDINANCES IN CONFLICT WITH STATE LAW OR REGULATIONS GOVERNING OR REGULATING AN AGRICULTURAL FACILITY OR OPERATION ARE NULL AND VOID, TO DEFINE OR FURTHER DEFINE SPECIFIC TERMS, TO PERMIT A COUNTY TO DETERMINE WHETHER AN AGRICULTURAL USE IS A PERMITTED USE UNDER THE COUNTY'S LAND USE AND ZONING AUTHORITY, TO FURTHER PROVIDE FOR THE MANNER IN WHICH SETBACK DISTANCES FOR AGRICULTURE ANIMAL FACILITIES ARE DETERMINED, AND TO PROVIDE THAT THESE PROVISIONS DO NOT APPLY TO ANY LICENSE OR PERMIT APPLICATION FOR WHICH THE DEPARTMENT OF HEALTH AND ENVIRONMENTAL CONTROL HAS MADE A DECISION PRIOR TO THE EFFECTIVE DATE OF THESE PROVISIONS. - ratified title
