**S\*0158 (Rat #0532, Act #0425 of 1982) General Bill, By D.S. Rushing, Leventis and M.B. Williams**

***Similar (H 2365)***

A Bill to amend Section 12-3-145, as amended, Code of Laws of South Carolina, 1976, relating to the procedures required to obtain certificates of exemption status from the South Carolina Tax Commission for property to be exempt from ad valorem taxation, so as to provide that libraries, churches, parsonages and burying grounds shall only be required to file an initial application requesting that their property be exempt from such taxation, to provide exceptions, and to extend the deadline for filing such applications to December 31, 1982, for certain tax years.-at
