A Bill to amend Section 50-11-610, Code of Laws of South Carolina, 1976, relating to seasons for the hunting of game in Game Zone No. 4, so as to allow the hunting of rabbits with dogs, but without firearms, from February sixteenth until Thanksgiving Day, except in game management area hunt units.-amended title
