H 3091 General Bill, By Talley, Mahaffey and Cotty

Summary: Driving without or cancelled, suspended or revoked license

A BILL TO AMEND SECTION 56-1-440, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO PENALTIES FOR DRIVING A MOTOR VEHICLE WITHOUT A DRIVER'S LICENSE, SO AS TO INCREASE THE FINE FOR A FIRST OFFENSE; TO AMEND SECTION 56-1-460, RELATING TO PENALTIES FOR DRIVING A MOTOR VEHICLE WITH A CANCELLED, SUSPENDED, OR REVOKED DRIVER'S LICENSE, SO AS TO INCREASE THE FINE FOR A FIRST AND SECOND OFFENSE: TO AMEND SECTION 56-1-720, RELATING TO THE POINT SYSTEM ESTABLISHED FOR THE EVALUATION OF THE OPERATING RECORD OF A LICENSED DRIVER TO DETERMINE WHETHER THE DRIVER IS QUALIFIED TO RETAIN A DRIVER'S LICENSE, SO AS TO REVISE THE OFFENSE OF DRIVING TOO FAST FOR CONDITIONS OR SPEEDING BY CREATING ADDITIONAL VIOLATIONS AND POINTS RELATING TO THIS OFFENSE: TO AMEND SECTION 56-5-750, RELATING TO THE OFFENSE OF FAILURE TO STOP A MOTOR VEHICLE WHEN SIGNALED BY A LAW ENFORCEMENT VEHICLE, SO AS TO INCREASE THE PENALTIES FOR THIS OFFENSE; TO AMEND SECTION 56-5-1520, RELATING TO THE MAXIMUM SPEED LIMITS ALLOWED ON THE STATE'S HIGHWAYS, SO AS TO INCREASE THE PENALTIES FOR VIOLATING THE SPEED LIMITS ESTABLISHED BY THIS SECTION; TO AMEND SECTION 56-5-1535, RELATING TO SPEEDING IN HIGHWAY WORK ZONES, SO AS TO REVISE THE PENALTIES FOR A VIOLATION OF THIS OFFENSE, AND TO REVISE THE CONTENTS OF THE SIGN THAT IS POSTED AT THE BEGINNING OF AN ACTIVE HIGHWAY WORK ZONE THAT INDICATES THE PENALTIES FOR VIOLATING A PROVISION CONTAINED IN THIS SECTION; AND TO AMEND SECTION 56-5-2920, RELATING TO THE OFFENSE OF RECKLESS DRIVING, SO AS TO INCREASE THE PENALTIES FOR A VIOLATION OF THIS OFFENSE.
