A BILL TO AMEND SECTION 50-11-940, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE DESIGNATION OF CERTAIN PROPERTY OF THE BELLE W. BARUCH FOUNDATION AS A BIRD AND GAME SANCTUARY, SO AS TO PERMIT EDUCATIONAL AND RESEARCH ACTIVITIES TO BE UNDERTAKEN IN SUCH SANCTUARY NOT ONLY BY THE UNIVERSITY OF SOUTH CAROLINA AND CLEMSON UNIVERSITY BUT ALSO BY ANY OTHER FULLY ACCREDITED, NOT-FOR-PROFIT PUBLIC OR PRIVATE COLLEGE OR UNIVERSITY HEADQUARTERED IN THIS STATE OR UNDERTAKEN UNDER THE SUPERVISIONS OF SUCH COLLEGE OR UNIVERSITY, AND TO PROVIDE THAT NOTHING CONTAINED IN SECTION 50-11-940 SHALL BE CONSTRUED TO BE IN CONFLICT WITH THE PROVISIONS OR INTENT OF THE LAST WILL AND TESTAMENT OF BELLE W. BARUCH WHICH LAST WILL AND TESTAMENT SHALL CONTROL WITH RESPECT TO THE PROVISIONS OF SECTION 50-11-940.-AMENDED TITLE
