### **S\*0340 (Rat #0033, Act #0012 of 2003) General Bill, By Senate Finance**

**Summary:** Retirement Systems Claims Procedures Act

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING CHAPTER 21 TO TITLE 9 ENACTING THE SOUTH CAROLINA RETIREMENT SYSTEMS CLAIMS PROCEDURES ACT SO AS TO PROVIDE THE REMEDIES AVAILABLE IN A DISPUTE OR CONTROVERSY BETWEEN THE SOUTH CAROLINA RETIREMENT SYSTEMS AND A MEMBER OR DESIGNATED BENEFICIARY OF A MEMBER OF ANY OF THE RETIREMENT SYSTEMS ESTABLISHED IN TITLE 9; TO AMEND SECTION 9-11-25, AS AMENDED, RELATING TO DEFINITIONS OF "POLICE OFFICER" FOR PURPOSES OF THE SOUTH CAROLINA POLICE OFFICERS RETIREMENT SYSTEM, SO AS TO INCLUDE WITHIN THE DEFINITION AN EMPLOYEE AFTER JANUARY 1, 2000, OF THE SOUTH CAROLINA DEPARTMENT OF MENTAL HEALTH HIRED AS A PEACE OFFICER, AND TO AMEND SECTION 24-1-280, AS AMENDED, RELATING TO THE STATUS AS A PEACE OFFICER OF EMPLOYEES OF THE SOUTH CAROLINA DEPARTMENT OF CORRECTIONS AND SOUTH CAROLINA DEPARTMENT OF JUVENILE JUSTICE WHO ARE HIRED TO PERFORM DUTIES RELATING TO CUSTODY, CONTROL, TRANSPORTATION, AND RECAPTURE, SO AS TO INCLUDE IN THAT STATUS AN EMPLOYEE OF THE SOUTH CAROLINA DEPARTMENT OF MENTAL HEALTH HIRED TO PERFORM SIMILAR DUTIES. - ratified title
