A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 56-1-221 so as to provide for a Medical Advisory Board to advise the Department of Highways and Public Transportation on the mental and physical fitness of persons to be licensed to operate motor vehicles and on the medical criteria and vision standards relating to the licensing of drivers.-amended title
