H*3826 (Rat #0166, Act #0092 of 1999) General Bill, By Battle

Summary: Cigarettes, illegal packages of unlawful; penalties for selling, Crimes and Offenses, Agriculture, Tobacco

A BILL TO AMEND CHAPTER 17, TITLE 16, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO OFFENSES AGAINST PUBLIC POLICY, BY ADDING SECTION 16-17-505, SO AS TO PROVIDE FOR THE OFFENSE OF SELLING, HOLDING FOR SALE, OR DISTRIBUTING A PACKAGE OF CIGARETTES THAT VIOLATES FEDERAL LAW IN REGARD TO LABELS, PACKAGING, OR OTHER REQUIREMENTS, TO PROVIDE THAT LAW ENFORCEMENT MAY SEIZE, DESTROY OR SELL TO THE MANUFACTURER, FOR EXPORT ONLY, THE ILLEGAL PACKAGE, AND TO PROVIDE PENALTIES FOR VIOLATIONS.-AMENDED TITLE
