A Bill to amend Act 275 of 1985, as amended, relating to the tax levy for the Greenville County School District, so as to set the annual millage limitation for the school district at eighty-four mills and to provide exceptions and the manner or method of action for a higher millage and procedure for adjustment of the millage and for conducting a referendum for a higher millage and to provide for the terms of school trustees.-amended title
