A Bill to revise the charges for environmental permits, licenses, and certificates required by the Department of Health and Environmental Control under the Pollution Control Act, the Safe Drinking Water Act, the Hazardous Waste Management Act, the Oil and Gas Act, the Atomic Energy and Radiation Control Act, and Department regulations.-amended title
