### S\*0394 (Rat #0150, Act #0091 of 2001) General Bill, By Senate Judiciary

**Summary:** Guardians ad litem, court-appointed in custody cases, disclosure requirements; Courts, Minors, Domestic Relations

A BILL TO AMEND CHAPTER 4, TITLE 20, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE PROTECTION FROM DOMESTIC ABUSE ACT BY ADDING SECTION 20-4-160 SO AS TO PROVIDE FOR THE ESTABLISHMENT OF THE DOMESTIC VIOLENCE FUND ADMINISTERED BY THE DEPARTMENT OF SOCIAL SERVICES AND WHOSE REVENUES MUST BE USED SOLELY TO AWARD GRANTS TO CERTAIN DOMESTIC VIOLENCE CENTERS AND PROGRAMS IN THE STATE, TO PROVIDE THAT THE FUND MUST RECEIVE ITS REVENUE FROM A PORTION OF MARRIAGE LICENSE FEES AND DONATIONS, CONTRIBUTIONS, BEQUESTS, OR OTHER GIFTS MADE TO THE FUND, TO PROVIDE THAT CONTRIBUTIONS TO THE FUND MUST NOT BE USED TO SUPPLANT EXISTING FUNDS APPROPRIATED TO THE DEPARTMENT FOR DOMESTIC VIOLENCE PROGRAMS AND GRANTS, TO PROVIDE THAT MONIES IN THE FUND MAY BE CARRIED FORWARD FROM ONE FISCAL YEAR TO THE NEXT FISCAL YEAR, AND TO PROVIDE THAT INTEREST EARNED ON MONIES IN THE FUND MUST BE RETAINED BY THE FUND; AND TO AMEND CHAPTER 1, TITLE 20, RELATING TO MARRIAGE BY ADDING SECTION 20-1-375 SO AS TO IMPOSE AN ADDITIONAL TWENTY DOLLAR FEE UPON THE MARRIAGE LICENSE FEE AND TO PROVIDE THAT THE ADDITIONAL FEE MUST BE REMITTED TO THE STATE TREASURER AND CREDITED TO THE DOMESTIC VIOLENCE FUND.-AMENDED TITLE
