A Bill to amend Section 12-27-400, Code of Laws of South Carolina, 1976, relating to distribution and use of certain gasoline tax revenue so as to increase from twenty-five to fifty percent the amount of a county's apportionment of "C" construction funds which may be expended for certain purposes, to add other authorized purposes, and to delete language which limits the above provisions to particular counties.-amended title
