AN ACT TO AMEND SECTION 16-3-1400, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO DEFINITIONS FOR PURPOSES OF THE ARTICLE ON THE VICTIM ASSISTANCE PROGRAM, SO AS TO PROVIDE THAT THE TERM "VICTIM SERVICE PROVIDER" DOES NOT INCLUDE A MUNICIPAL COURT JUDGE, MAGISTRATES COURT JUDGE, CIRCUIT COURT JUDGE, SPECIAL CIRCUIT COURT JUDGE, OR FAMILY COURT JUDGE. - ratified title
