A Bill to amend Section 44-7-320, as amended, Code of Laws of South Carolina, 1976, relating to the denial, suspension, and revocation of a certificate of need and penalties, so as to provide for action to be taken against a person or facility for failing to allow a team advocacy inspection by the Protection and Advocacy System for the Handicapped, Inc.-amended title
