A Bill to amend the Code of Laws of South Carolina, 1976, by adding Title 29, Chapter 4, so as to enact the South Carolina Reverse Mortgage Act which defines "reverse mortgage", provides rules for governing these mortgages, exempts reverse mortgages from certain provisions of other mortgage transactions, and requires that certain information concerning reverse mortgages is available to loan applicants.
