### **H\*4619 (Rat #0594, Act #0449 of 1994) General Bill, By T.E. Huff, Sharpe, R. Smith, C.H. Stone, Wilkins and Young-Brickell**

A Bill to amend Section 62-7-302, as amended, Code of Laws of South Carolina, 1976, relating to a trustee's standard of care, so as to further provide for the duties of a trustee with respect to acquiring or retaining a contract of insurance upon the life of the trustor or upon the lives of the trustor and his spouse, children, or parents, and by adding Section 62-1-109 so as to clarify the duties or obligations of an attorney for a person serving as fiduciary.-amended title
