### **H\*4686 (Rat #0381, Act #0315 of 1998) General Bill, By E.C. Stoddard**

A BILL TO AMEND SECTION 7-7-360, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO VOTING PRECINCTS IN LAURENS COUNTY, SO AS TO CHANGE THE NAME OF WOODVILLE PRECINCT TO GREENPOND PRECINCT, DESIGNATE A MAP NUMBER ON WHICH THE LINES OF THESE PRECINCTS ARE DELINEATED, AND DIRECT THE DIVISION OF RESEARCH AND STATISTICAL SERVICES OF THE STATE BUDGET AND CONTROL BOARD TO CHANGE THE BOUNDARIES OF TWO PRECINCTS IN LAURENS COUNTY.-AMENDED TITLE
