**H\*4804 (Rat #0538, Act #0435 of 1998) General Bill, By Jennings**

A BILL TO AMEND SECTION 16-3-1040, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THREATENING THE LIFE, PERSON, OR FAMILY OF A PUBLIC OFFICIAL, TEACHER OR PRINCIPAL, SO AS TO MAKE IT UNLAWFUL TO THREATEN THE LIFE, PERSON, OR FAMILY OF ANY PUBLIC EMPLOYEE, AND REVISE THE PENALTIES FOR VIOLATION; TO AMEND CHAPTER 7 OF TITLE 5, RELATING TO MUNICIPAL CORPORATIONS, BY ADDING SECTION 5-7-12 SO AS TO PROVIDE FOR DESIGNATION AND ASSIGNMENT OF A SCHOOL RESOURCE OFFICER FOR LAW ENFORCEMENT PURPOSES IN CONNECTION WITH A SCHOOL OR SCHOOL SYSTEM; TO AMEND ARTICLE 4, CHAPTER 63, TITLE 59, RELATING TO REPORTING OF SCHOOL CRIMES, BY ADDING SECTION 59-63-335 SO AS TO PROVIDE FOR LIABILITY OF A SCHOOL ADMINISTRATOR AND DISTRICT FOR ATTORNEY'S FEES AND COSTS ASSOCIATED WITH ENFORCEMENT OF SCHOOL CRIME REPORTING REQUIREMENTS; TO AMEND SECTION 59-63-360, RELATING TO THE ATTORNEY GENERAL'S MONITORING OF SCHOOL CRIME REPORTS, SO AS TO ALLOW HIM OR HIS DESIGNEE TO REPRESENT THE SCHOOL DISTRICT WHEN A CRIMINAL CASE IS APPEALED; TO AMEND SECTION 59-63-370, RELATING TO A STUDENT'S CONVICTION OR DELINQUENCY ADJUDICATION FOR CERTAIN CRIMES, SO AS TO INCLUDE CERTAIN DRUG ACTIVITIES AND WEAPONS OFFENSES AND TO DEFINE "WEAPON"; AND TO AMEND SECTION 20-7-8505, RELATING TO JUVENILE RECORDS, SO AS TO PROVIDE FOR DISCLOSURE OF RECORDS TO A SCHOOL BY THE DEPARTMENTS OF JUVENILE JUSTICE, CORRECTIONS, AND PROBATION, PARDON, AND PAROLE SERVICES AND TO INCLUDE SCHOOL CRIMES.-AMENDED TITLE
