A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 59-101-290 SO AS TO REQUIRE PUBLIC INSTITUTIONS OF HIGHER LEARNING TO NOTIFY INCOMING STUDENTS OR THEIR PARENTS OF THE RISK OF CONTRACTING MENINGOCOCCAL DISEASE AND HEPATITIS B IF LIVING IN ON-CAMPUS STUDENT HOUSING AND TO REQUIRE THESE INSTITUTIONS TO RECOMMEND VACCINATION AGAINST THESE DISEASES IN THE INSTITUTION'S HEALTH AND MEDICAL INFORMATION PROVIDED TO STUDENTS AND PARENTS; AND TO PROVIDE THAT PRIVATE INSTITUTIONS OF HIGHER LEARNING MAY ELECT TO BE GOVERNED BY THIS ACT AND MAY REMOVE ITSELF FROM SUCH GOVERNANCE AT ANY TIME.-amended title
