Summary: Boiler Safety Act

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING CHAPTER 14 TO TITLE 41 SO AS TO ENACT THE "BOILER SAFETY ACT" TO PROVIDE THAT THE DEPARTMENT OF LABOR, LICENSING AND REGULATION SHALL PROMULGATE REGULATIONS FOR THE SAFE INSTALLATION AND INSPECTION OF BOILERS IN THIS STATE, INCLUDING REQUIRING NATIONAL BOILER REGISTRATION AND CONFORMITY WITH NATIONAL INSTALLATION STANDARDS AND TO REQUIRE INSPECTION OF EXISTING BOILERS; TO EXEMPT CERTAIN BOILERS FROM REGULATION UNDER THIS CHAPTER; TO IDENTIFY STANDARDS FOR WORKING PRESSURE OF A BOILER; TO AUTHORIZE THE APPOINTMENT OF A CHIEF BOILER ADMINISTRATOR FOR THE PURPOSE OF ENFORCING THE LAWS OF THIS STATE REGULATING THE USE OF BOILERS; TO PROVIDE FOR THE CERTIFICATION AND REGULATION OF SPECIAL BOILER INSPECTORS; TO PROVIDE BOILER INSPECTION TIMEFRAMES, CRITERIA, AND REPORTING REQUIREMENTS; AND TO PROVIDE CIVIL PENALTIES; AND TO AMEND SECTION 40-11-410, RELATING TO CONTRACTOR LICENSE CLASSIFICATIONS AND SUBCLASSIFICATIONS, INCLUDING BOILER INSTALLATION SUBCLASSIFICATION REQUIREMENTS, SO AS TO AUTHORIZE CREDENTIALS FROM THE NATIONAL BOARD OF BOILER AND PRESSURE VESSEL INSPECTORS AS SUFFICIENT FOR LICENSURE UNDER THIS SUBCLASSIFICATION. - ratified title
