**Summary:** Workers' Compensation Second Injury Fund, manner of funding through equitable assessments revised; disabled employee

A BILL TO AMEND SECTION 42-7-310, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE ESTABLISHMENT, PURPOSE, ADMINISTRATION, FUNDING, AND STAFF OF THE SECOND INJURY FUND UNDER THE SOUTH CAROLINA WORKERS' COMPENSATION LAW, SO AS TO PROVIDE THAT THE SECOND INJURY FUND SHALL MAKE PAYMENTS IN ACCORDANCE WITH THE PROVISIONS CONTAINED IN SECTION 42-9-410 WHICH RELATE TO REIMBURSEMENTS FROM THE FUND FOR AN EMPLOYEE WHO BECOMES TOTALLY AND PERMANENTLY DISABLED IN A SUBSEQUENT INJURY, TO REVISE THE MANNER OF FUNDING THE SECOND INJURY FUND THROUGH EQUITABLE ASSESSMENTS UPON ALL INSURANCE CARRIERS, SELF-INSURERS, AND THE STATE ACCIDENT FUND, AND TO PROVIDE A DEFINITION FOR THE TERM "NORMALIZED PREMIUM".-AMENDED TITLE
