A BILL TO AMEND TITLE 44, CODE OF LAWS OF SOUTH CAROLINA, 1976 RELATING TO HEALTH, BY ADDING CHAPTER 76, SO AS TO ENACT THE "SOUTH CAROLINA AUTOMATED EXTERNAL DEFIBRILLATOR ACT" WHICH REQUIRES PERSONS OR ENTITIES THAT ACQUIRE AN AUTOMATED EXTERNAL DEFIBRILLATOR TO COMPLY WITH CERTAIN TRAINING, TESTING, AND USE PROCEDURES AND TO PROVIDE IMMUNITY FROM CIVIL LIABILITY WHEN IN COMPLIANCE.-AMENDED TITLE
