### **S\*0784 (Rat #0623, Act #0503 of 1980) General Bill, By Senate Education**

#### **Similar (S 0714, H 3259)**

A Bill to amend Sections 59-53-1850, 59-53-1860, and 59-53-1870, Code of Laws of South Carolina, 1976, relating to vocational training funds, so as to provide that such funds shall not be disbursed for use by high schools and joint vocational school which do not conduct programs of vocational agriculture on a twelve month basis per year; to prescribe programs of instruction during the interim academic years; and to provide that the State Board of Education shall adopt standards for vocational programs in agricultural education and provide for the review of local vocational agricultural education programs.-at
