**Summary:** Worker's compensation insurance

AN ACT TO AMEND SECTION 38-73-500, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO RANDOM DRUG AND ALCOHOL TESTING PROCEDURES CONCERNING MERIT RATING FOR WORKERS' COMPENSATION INSURANCE, SO AS TO PROVIDE THAT A SINGLE SAMPLE MAY BE USED FOR THE FIRST AND SECOND TESTS IF A SECOND TEST IS ADMINISTERED. - ratified title
