Summary: Pharmacy Board, permit issuance by; Pharmacists, licensure, examination requirements; prescription drugs A BILL TO AMEND SECTION 40-43-60, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO,
