Installation of Governor on the first Wednesday following the second Tuesday in January after his election (Const., Art. IV, Sec. 4; 1976 Code, Sec. 1-3-110). Vacancy—to be filled until next general election by officials in the following order: Lieutenant Governor, President *Pro Tempore* of the Senate, Speaker of the House (Const., Art. IV, Secs. 6, 7, 11; 1976 Code, Sec. 1-3-130).
