Reporting Requirement

The Students Health and Fitness Act of 2005, S.C. Code <u>\$59-10-10(C)</u>, requires each South Carolina district to report on the amount of time allotted to students for physical education instruction and physical activity as referenced in the excerpt below.

During each year of implementation of the reduced student to physical education teacher ratio, each district shall report to the State Department of Education by June fifteenth, the number of minutes of physical education instruction and the minutes of additional physical activity students receive daily with a total for the week. The report must be listed by elementary school and by individual class and grade level. The State Department of Education shall provide a summary of this information to the General Assembly by December first of each year of implementation.

Students Health and Fitness Act of 2005 Requirements

The Students Health and Fitness Act of 2005, S.C. Code <u>§59-10-10</u>, mandates that students in grades kindergarten through five receive at least one hundred and fifty minutes per week of physical education and physical activity. Of those one hundred and fifty minutes per week, at least sixty minutes are to be allotted to physical education as referenced in the excerpts below.

<u>§59-10-10(A)</u>: The goal of this article is to provide every elementary student with the equivalent of thirty minutes of physical activity daily. Beginning in the 2006–07 school year, students in kindergarten through fifth grade must be provided a minimum of one hundred fifty minutes a week of physical education and physical activity. In 2006–07, a minimum of sixty minutes a week must be provided in physical education, and as Section 59-10-20 is phased in, the minimum time for physical education must be increased to ninety minutes a week.

<u>§59-10-370:</u> Each phase of implementation of the Students Health and Fitness Act is contingent upon the appropriation of adequate funding as documented by the fiscal impact statement provided by the Revenue and Fiscal Affairs, formerly the State Budget Office of the State Budget and Control Board. There is no mandatory financial obligation to school districts if state funding is not appropriated for each phase of implementation

In addition, Proviso 1.28 of the 2016-17 Appropriations Act grants districts flexibility in use of funds.

Survey Administration

The South Carolina Department of Education (SCDE) notified all district instructional leaders and elementary school health and fitness coordinators about the mandatory Students Health and Fitness Act Annual Compliance Survey via memorandum on May 15, 2017 (Appendix A), as well as follow-up electronic and phone communications. The Students Health and Fitness Act Annual Compliance Survey required all school physical activity directors to provide the number of minutes allotted to their students per week for both physical education and physical activity (Appendix B).

School Survey Participation

Seventy-three percent (n=470) of South Carolina public schools with students in any or all grades K–5 responded to the Students Health and Fitness Act Annual Compliance Survey. Conversely, twenty-seven percent (n=170) of South Carolina public schools with students in any or all grades K–5 did not respond to the Students Health and Fitness Act Annual Compliance Survey (Appendix C).

The results reported below were analyzed based on data collected from self-reported physical activity director surveys (Appendices A and B).

Physical Education and Physical Activity Minutes

Of the 470 schools responding, fifty-two percent (n=247) reported providing at least one hundred fifty minutes per week of physical education and physical activity during the 2016–17 school year. Each of these schools had a minimum of sixty minutes of physical education per week and a minimum of ninety minutes of physical activity outside of physical education.

Conversely, of the 470 schools responding, forty-seven percent did not report meeting either the sixty minutes of physical education per week or the one hundred fifty minutes of physical activity per week.

This information will be shared with each district's identified district physical education contact. Each district should complete and return the survey and spreadsheet no later than 5:00 p.m. on June 15, 2017, to Mike Lally.
