Introduction

Per Act 241 of 2016 the General Assembly directed that a report be submitted detailing obsolete laws or laws that are no longer applicable. Further, a report must be included that identifies the cost of compliance with federal education statutes and regulations.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. The General Assembly directs the State Superintendent of Education, the Executive Director of the Education Oversight Committee, the Chairman of the House Education and Public Works Committee, and the chairman of the Senate Education Committee to each appoint one representative to a committee to be chaired by the appointee of the State Superintendent of Education to review Title 59 of the South Carolina Code of Laws and report to the General Assembly all statutes that are obsolete or no longer applicable. In addition, the report must identify all the federal education statutes and regulations with which the state of South Carolina is required to comply. The committee, with the assistance of the Revenue and Fiscal Affairs Office, must include in the report the total cost to the State of South Carolina to comply with the identified federal education statutes and regulations. This report must be submitted by December 31, 2016, and updated at least every five years thereafter.

The committee members were:

Emily Heatwole – Appointee of the State Superintendent of Education

Melanie Barton – Executive Director of the Education Oversight Committee

Jay W. Ragley – Appointee of the Chairman of the Senate Education Committee

Sandy Smith – Appointee of the Chairman of the House Education and Public Works Committee

The Committee met during Fall 2016 and offered opportunities for public testimony both at the meeting and in writing.

Attached is the summary review of each chapter of Title 59, as well as an excerpt from the Agency Accountability Report outlining the cost of compliance with federal laws and regulations, with a link to the full report below. The agency will continue to update on costs associated with ESSA once the agency plan has been submitted and accepted by the US Department of Education.
