RE: First Steps 4K Report Pursuant to Proviso 1.56

Proviso 1.56 of the General Appropriations Act for FY22 specifies that:

No later than April first, the Department of Education and the Office of First Steps shall report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee on the expenditure of these funds to include the following information: the amount of money used and specific steps and measures taken to enhance the quality of the 4K program and the amount of money used for professional development as well as the types of professional development offered and the number of participants. The Office of First Steps is directed to determine if the provision of extended programs in private centers improves the ability of parents to enter the workforce or to pursue postsecondary training or industry credentials.

Pursuant to the terms of the proviso, I am writing to provide an update on First Steps 4K implementation of Proviso 1.56 to date. Thus far South Carolina First Steps 4K has spent or encumbered \$1.14M total quality enhancement funding during FY22. We are deeply grateful for the General Assembly's commitment to 4K quality and pleased to provide the attached table, detailing First Steps' spending on Quality Enhancement efforts within South Carolina.

We are committed to raising quality in our classrooms through teacher excellence. LearnERS is an individualized teacher growth and development system. Along with completion of specific training and assessment requirements established by First Steps 4K, teachers work closely with their First Steps 4K Coach to set professional development goals and document their attainment throughout the school year.

You will note that First Steps has also extended its multi-year commitment to *Conscious Discipline*, a leader in classroom management that provides a transformational, whole-school solution for social-emotional learning, discipline, and self-regulation skills. Additional expenditures have refurbished aged classroom materials, supplied consumables, provided literacy and math-based curriculum materials, and provided for staff and teacher professional development.

We are particularly proud to disclose that 74% of parents whose children are in extended day or extended year First Steps 4K classrooms report being able to work or attend school full time because of their child's enrollment in First Steps 4K.

We are also grateful for the General Assembly's enabling of extended 4K service models, which our private providers have enthusiastically embraced. The chart below reflects the current options that our 267 classrooms in 240 centers/schools have elected to provide students for the 2021-2022 term. 83.3% of our sites have chosen an option that extends the traditional school year.
