OPERATION OF STATE GOVERNMENT

SECTION 1 - H630 - DEPARTMENT OF EDUCATION

1.1. (SDE: Appropriation Transfer Prohibition) The amounts appropriated herein for aid to subdivisions, allocations to school districts, or special line items shall not be transferred and must be expended in accordance with the intent of the appropriation, except that the department may transfer funds that are deducted and retained from a school district's transportation allocation to reimburse the department for the cost of unauthorized mileage. This transfer must be agreed upon by both the school district and the department. Those funds may be transferred into the department's school bus transportation operating account.

12 1.2. (SDE: DHEC - Comprehensive Health Assessment) All school districts shall participate, to the fullest extent possible, in the
 13 Medicaid program by seeking appropriate reimbursement for services and administration of health and social services.
 14 Reimbursements to the school districts shall not be used to supplant funds currently being spent on health and social services.

15 **1.3.** (SDE: EFA Formula/Base Student Cost Inflation Factor) To the extent possible within available funds, it is the intent of the 16 General Assembly to provide for one hundred percent of full implementation of the Education Finance Act to include an inflation 17 factor projected by the Revenue and Fiscal Affairs Office to match inflation wages of public school employees in the Southeast. The

18 base student cost for the current fiscal year has been determined to be $\frac{2,220}{2,350}$. For the current fiscal year, the total pupil count

19 is projected to be $\frac{714,394}{723,953}$. The average per pupil funding is projected to be $\frac{55,536}{5,827}$ state, $\frac{51,245}{1,245}$ federal, and

20 $\frac{5,371}{5,542}$ local. This is an average total funding level of $\frac{12,092}{5,371}$ excluding revenues of local bond issues. For the 21 current fiscal year the South Carolina Public Charter School District and any institution of higher education sponsoring a public

22 charter school shall receive and distribute state EFA funds to the charter school as determined by one hundred percent of the current

23 year's base student cost, as funded by the General Assembly multiplied by the weighted students pupils enrolled in the charter school,

24 which must be subject to adjustment for student attendance.

The Revenue and Fiscal Affairs Office, must post in a prominent place on their website for each school district projections, including the per pupil state, federal and local revenues, excluding revenues of local bond

issues, for the current fiscal year. Also, as soon as practicable, upon determining the exact numbers regarding pupil count and funding, the Revenue and Fiscal Affairs Office, shall also post on their website the one hundred thirty-five day average daily membership for each school district and per pupil state, federal and local revenues, excluding revenues of local bond issues, based on the most recent audited financial statement as reported annually pursuant to Section 59-17-100. The Department of Education and the Education Oversight Committee shall provide in a prominent place on their internet websites a link to the information posted by the Revenue and Fiscal Affairs Office, including the projected numbers and the exact numbers.

35 Students served in licensed residential treatment facilities (RTFs) for children and adolescents as defined under Section 36 44-7-130 of the 1976 Code shall receive a weighting of 2.10.

adjustments by June 30, 2016 2017. The department must provide districts with technical assistance with regard to student count changes in PowerSchool.

1.4. (SDE: EFA - Formula) The amount appropriated in Part IA, Section 1 for "Education Finance Act" shall be the maximum 3 4 paid under the provisions of Act 163 of 1977 (the South Carolina Education Finance Act of 1977) to the aggregate of all recipients. 5 The South Carolina Education Department shall develop formulas to determine the state and required local funding as stipulated in 6 the South Carolina Education Finance Act of 1977. Such formulas shall require the approval of the State Board of Education and 7 the State Fiscal Accountability Authority. After computing the EFA allocations for all districts, the department shall determine 8 whether any districts' minimum required local revenue exceeds the districts' total EFA Foundation Program. When such instance is found, the department shall adjust the index of taxpaying ability to reflect a local effort equal to the cost of the districts' EFA 9 Foundation Program. The districts' weighted pupil units are to be included in determination of the funds needed for implementation 10 11 of the Education Finance Act statewide. 12 In the event that the formulas as devised by the Department of Education and approved by the State Board of Education and the State Fiscal Accountability Authority should provide for distribution to the various school districts totaling more than the amount 13 appropriated for such purposes, subject to the provisions of this proviso, the Department of Education shall reduce each school district 14 15 entitlement by an equal amount per weighted pupil so as to bring the total disbursements into conformity with the total funds appropriated for this purpose. If a reduction is required in the state's contribution, the required local funding shall be reduced by the 16 proportionate share of local funds per weighted pupil unit. The Department of Education shall continually monitor the distribution 17 of funds under the provisions of the Education Finance Act and shall make periodic adjustments to disbursements to ensure the 18 aggregate of such disbursements do not exceed the appropriated funds. 19 Local districts shall not be mandated or required to inflate the base number in their respective salary schedules by any percentage 20 21 greater than the percentage by which the appropriated base student cost exceeds the appropriated base student cost of the prior fiscal 22 year. 23 **1.5.** (SDE: Employer Contributions/Allocations) It is the intent of the General Assembly that the appropriation contained herein for "Public School Employee Benefits" shall not be utilized to provide employer contributions for any portion of a school district 24 25 employee's salary that is federally funded.

State funds allocated for school district employer contributions must be allocated by the formula and must be used first by each district to cover the cost of fringe benefits for personnel required by the Defined Program, food service personnel and other personnel required by law. Once a district has expended all state allocated funds for fringe benefits, the district may utilize food service revenues to fund a proportionate share of fringe benefits costs for food service personnel.

The Department of Juvenile Justice and the Department of Corrections' school districts must be allocated funds under the fringe benefits program in accordance with criteria established for all school districts.

32 **1.6.** (SDE: Employer Contributions/Obligations) In order to finalize each school district's allocations of Employer Contributions

33 funds for retiree insurance from the prior fiscal year, the Department of Education is authorized to adjust a school district's allocation

in the current fiscal year accordingly to reflect actual payroll and payments to the Retirement System from the prior fiscal year. In

35 the event the Department of Education is notified that an educational subdivision has failed to remit proper payments to cover

1 Employee Fringe Benefit obligations, the Department of Education is directed to withhold the educational subdivision's state funds

2 until such obligations are met.

1.7. (SDE: Governor's School for Science & Math) Any unexpended balance on June thirtieth of the prior fiscal year of funds appropriated to or generated by the Governor's School for Science and Mathematics may be carried forward and expended in the current fiscal year pursuant to the direction of the board of trustees of the school.

6 **1.8.** (SDE: Educational Responsibility/Foster Care) The responsibility for providing a free and appropriate public education 7 program for all children including disabled students is vested in the public school district wherein a child of lawful school age resides 8 in a foster home, group home, orphanage, or a state operated health care facility including a facility for treatment of mental illness 9 or chemical dependence and habilitation centers for persons with intellectual disabilities or persons with related conditions located within the jurisdiction of the school district or alternative residences. The districts concerned may agree upon acceptable local cost 10 11 reimbursement. If no agreement is reached, districts providing education shall receive from the district where the child last resided 12 before placement in a facility an additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. If a child from out of state is residing 13 in a facility owned and/or operated by a for profit entity, the district providing educational services shall be reimbursed by the for 14 profit entity the local district's local support per weighted pupil above the statewide average base student cost multiplied by the 15 appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. This also applies to John de la Howe 16 School who also has the authority to seek reimbursement in any situation that the school district has participation in the placement 17 of the student. John de la Howe School shall be reimbursed the local district's local support per weighted pupil above the statewide 18 average base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance 19 Act. Participation will be evidenced by a written agreement from the IEP team or 504 team, written referral, or the school district 20 initiating the placement process. School districts providing the education shall notify the nonresident district in writing within forty-21 five calendar days that a student from the nonresident district is receiving education services pursuant to the provisions of the proviso. 22 23 The notice shall also contain the student's name, date of birth, and disabling condition if available. If appropriate financial arrangements cannot be effected between institutions of the state, including independent school districts under the authority of the 24 Department of Disabilities and Special Needs, and school districts, institutions receiving educational appropriations shall pay the 25 26 local base student cost multiplied by the appropriate pupil weighting. Children residing in institutions of state agencies shall be educated with nondisabled children in the public school districts if appropriate to their educational needs. Such institutions shall 27 28 determine, on an individual basis, which children residing in the institution might be eligible to receive appropriate educational 29 services in a public school setting. Once these children are identified, the institution shall convene an IEP meeting with officials of 30 the public school district in which the institution is located. If it is determined by the committee that the least restrictive environment 31 in which to implement the child's IEP is a public school setting, then the school district in which the institution is located must provide the educational services. However, that school district may enter into contractual agreements with any other school district 32 having schools located within a forty-five mile radius of the institution. The cost for educating such children shall be allocated in 33 34 the following manner: the school district where the child last resided before being placed in an institution shall pay to the school 35 district providing the educational services an amount equivalent to the statewide average of the local base student cost multiplied by 36 the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act; the school district providing the

1 educational services shall be able to count the child for all funding sources, both state and federal. The institution and school district,

2 through contractual agreements, will address the special education and related services to be provided to students. Should the school district wherein the institution is located determine that the child cannot be appropriately served in a public school setting, then the

4 institution may request a due process hearing pursuant to the procedures provided for in the Individuals with Disabilities Education

Institution may request a due process nearing pursuant to the procedures provided for in the individuals with Disabilitie
 Act.

The agreed upon acceptable local cost reimbursement or the additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to out-of-district students, shall be paid within sixty days of billing, provided the billing district has provided a copy of the invoice to both the Superintendent and the finance office of the district being invoiced. Should the district not pay within sixty days, the billing district can seek relief from the Department of Education. The department shall withhold EFA funding equal to the billing from the district refusing to pay and submit the funding (equal to the invoice) to the billing school district.

The agency placing a child in any situation that requires changing school districts, must work with the schools to assure that all 12 required school records, including confidential records, are transferred from the sending to the receiving school within three working 13 days. School records to be transferred should include grade transcripts, state birth certificate, certificate of immunization, social 14 security card, attendance records, discipline records, IEP's, psychological reports (or notation in the school records that a 15 psychological report on the child is available at the school district office) and any other records necessary for the appropriate 16 placement of the child in the new school. School districts must release all records upon presentation of a court order or appropriate 17 permission for confidential release. If evaluation or placement is pending, the receiving school district is responsible to secure 18 information and to complete the placement. The receiving school will maintain appropriate confidentiality of all records received 19 20 on a child.

1.9. (SDE: Instruction in Juvenile Detention Centers) It shall be the responsibility of the school district where a local juvenile detention center is located to provide adequate teaching staff and to ensure compliance with the educational requirements of this State. Students housed in local juvenile detention centers are to be included in the average daily membership count of students for that district and reimbursement by the Department of Education made accordingly.

25 **1.10.** (SDE: Revenue Authorization) The State Department of Education is hereby authorized to collect, expend, and carry 26 forward revenues in the following areas to offset the cost of providing such services: the sale of publications, manuals and forms, 27 the sale of Apple Tags, royalties, contributions, donations, foundation funds, special grants and contracts, brochures, photo copies, 28 listings and labels, Directory of South Carolina Schools, student health record cards, items to be recycled, and high school diplomas 29 and certificates; the collection of out-of-state and in-state investigation fees, registration fees for non-SDE employees, recurring facility inspection fees, teacher certification fees; the handling of audio-visual film; the provision of contract computer services to 30 31 school districts and other state agencies, joint broadcast service to school districts, and education-related statistics through agreement with the National Center for Education Statistics; the lease or sale of programs of television, audio or microcomputer software; the 32 lease or sale of virtual courses to other states; the collection of damage fees for instructional materials and the sale of unusable 33 34 instructional materials; sale of fuel; use and repair of transportation equipment; fees for Medicaid reimbursable transportation; the receipt of insurance and warranty payments on Department of Education equipment and the sale of used school buses and support 35 equipment. The Department of Education is authorized to collect revenue for deposit into the State General Fund for testing material 36

1 purchases and test rescoring fees. The Department of Education is authorized to expend revenue collected for lost and damaged

2 instructional materials and the sale of unusable instructional materials for the purpose of contracting for the purchase and maintenance

of a statewide textbook inventory management system, provided that schools' newly-adopted instructional materials needs are met
 first.

1.11. (SDE: School District Bank Accounts) Each school district in this State, upon the approval of the district's governing body, may maintain its own bank account for the purpose of making disbursement of school district funds as necessary to conduct school district business and each county treasurer is hereby authorized to transfer such amount as needed, upon receipt of a written order certified by the district governing body or their designee. Such order shall contain a statement that such amount is for immediate disbursement for the payment of correct and legal obligation of the school district.

10 1.12. (SDE: School Lunch Program Aid) The amount appropriated herein for School Lunch Program Aid shall be divided among 11 the District and/or County Boards of Education of the State upon the basis of the number of schools participating in the School Lunch 12 Program in each district during the prior school year. The travel expenses of the District and/or County School Lunch Supervisor 13 shall be paid from this appropriation at the prevailing rate of mileage allowed by the State. These funds may be used as an aid in 14 improving the School Lunch Program. These funds may not be used to supplement the salaries of school lunch supervisors. In the 15 absence of a County Board of Education in multi-district counties, the funds will be divided among the school districts of the county 16 on the basis of the number of schools participating in the School Lunch Program in each district during the prior school year.

17 1.13. (SDE: Travel/Outside of Continental U.S.) School District allocations from General Funds, lottery, and EIA funds shall 18 not be used for travel outside of the continental United States. The International Baccalaureate Program shall be exempt from this 19 restriction.

1.14. (SDE: Year End Closeout) The State Department of Education is authorized to expend federal and earmarked funds (not including state or EIA funds) in the current fiscal year for expenditures incurred in the prior year; however, state funds appropriated in Part IA, Section 1, X, Aid to School Districts, for the Children's Case Resolution System or private placements for services provided to children with disabilities may be used for those expenditures in prior fiscal years. The department is also authorized to use appropriated funds to pay for textbooks shipped in the fourth quarter of the prior fiscal year.

1.15. (SDE: Transportation Collaboration) The Department of Education School Bus Maintenance Shops shall be permitted, on
 a cost reimbursable-plus basis, to deliver transportation maintenance and services to vehicles owned or operated by public agencies
 in South Carolina.

School buses operated by school districts, other governmental agencies or head start agencies for the purpose of transporting students for school or school related activities shall not be subject to state motor fuel taxes. Further, that school districts, other governmental agencies or head start agencies may purchase this fuel, on a cost reimbursable-plus basis, from the Department of Education School Bus Maintenance Shops.

1.16. (SDE: School Bus Insurance) The Department of Education shall maintain comprehensive and collision insurance or self insure state-owned buses. In no event shall the department charge local school districts for damages to the buses which are commonly
 covered by insurance.

1.17. (SDE: Teacher Data Collection) Of the non-program funds appropriated to the Department of Education, it and the
 Commission on Higher Education shall share data about the teaching profession in South Carolina. The data sharing should ensure

(1) a systematic report on teacher supply and demand information and (2) data to determine classes being taught by public school 1 2 teachers out of field of their preparation. The data collection should include but not be limited to: classes/subjects taught, number of students taught, percentage of teacher education graduates from South Carolina colleges/universities who go into teaching, 3 4 percentage of teacher education graduates who teach in public schools in South Carolina, percentage of new teachers who leave the 5 South Carolina teaching profession in the first three years of public school teaching due to unsuccessful evaluations, percentage of 6 new teachers who leave the profession in the first three years of public school teaching in South Carolina who have successful 7 evaluations, turnover rate of teachers and certification areas with highest vacancies. All database items should be set up so that it can be disaggregated by ethnicity, gender, geographic location, etc. 8 1.18. (SDE: School Building Aid) Of the funds appropriated in Part IA for School Building Aid, \$500,000 shall be allocated on 9 a K-12 per pupil basis to Multi-District Area Vocational Schools. 10

11 **1.19.** (SDE: School Bus Driver CDL) From funds provided in Part IA, Section 1, VII.B., local school districts shall request a 12 criminal record history from the South Carolina Law Enforcement Division for past conviction of any crime before the initial 13 employment of a school bus driver or school bus aide. The Department of Education and the school districts shall be treated as a 14 charitable organization for purposes of the fee charged for the criminal records search.

15 1.20. (SDE: School Bus Purchase) Any procurement of school buses with funds appropriated in this act or any other appropriation bill must meet specifications developed by the School Bus Specification Committee as established by the State 16 Superintendent of Education. The School Bus Specifications Committee shall allow for input from all school bus chassis and body 17 manufacturers. However, if it is safe, more economical, and in the public interest, the department may use the school bus 18 specifications of another state in the procurement of school buses. If the department uses the specifications of another state, the 19 department must submit a report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means 20 Committee detailing the methodology by which the alternative specifications were determined to be safe, more economical, and in 21 the public interest, when compared to the specifications set forth by the School Bus Specifications Committee. 22

1.21. (SDE: Buses, Parts, and/or Fuel) Funds appropriated for other operating in program VII.B. - Bus Shops and funds appropriated in VII.C. - Buses may be used to purchase buses, fuel, parts, or other school bus related items. All funds appropriated for bus fuel, parts/supplies, maintenance, and bus purchases may be carried forward from the prior fiscal year and expended in the current fiscal year to support bus transportation services.

1.22. (SDE: Mitford Transportation Costs) Transportation costs for the transporting of students from the Mitford area of Fairfield
 County to schools in the Great Falls area of Chester County is not the responsibility of and shall not be borne by the Chester County
 School District. These transportation costs shall continue to be the responsibility of the State Department of Education.

30 **1.23.** (SDE: Status Offenders/John de la Howe) The funds appropriated for the Status Offender Program shall be distributed to 31 John de la Howe School to expand residential programs to include court ordered status offenders. Components of such a program 32 shall include collaboration between the home school district and the residential school and treatment or related services to the families 33 of students in placement.

1.24. (SDE: Governor's School Leave Policy) The South Carolina Governor's School for the Arts and Humanities and the South
 Carolina Governor's School for Science and Mathematics are authorized to promulgate administrative policy governing annual and

sick leave relative to faculty and staff with the approval of their respective board of directors. This policy shall address their
 respective school calendars in order to comply with the instructional needs of students attending both special schools.

1.25. (SDE: School Facilities Management System) School Districts may use capital improvement bond funds, lapsed funds or
 any other unexpended appropriated funds or revenues to access the Department of Education's School Facilities Management System
 database.

6 1.26. (SDE: School Board Meetings) Of the funds appropriated through the Department of Education for technology related
7 expenses, school districts that have a website shall place a notice of a regularly scheduled school board meeting twenty-four hours
8 in advance of such meeting. The notice shall include the date, time, and agenda for the board meeting. The school district shall
9 place the minutes of the board meeting on their website within ten days of the next regularly scheduled board meeting.

10 **1.27.** (SDE: Proviso Allocations) In the event an official General Fund revenue shortfall is declared by the Board of Economic 11 Advisors, the Department of Education may reduce any allocation in Section 1 specifically designated by proviso in accordance with 12 the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office, except the additional EFA 13 allocation to the South Carolina Public Charter School District. The reduction may not be greater than the total percentage of 14 reduction of the Section 1 appropriation. Should the department hold back funds in excess of the total percentage reduction those 15 funds must be allocated per the proviso. No allocation for teacher salaries shall be reduced as a result of this proviso.

1.28. (SDE: School Districts and Special Schools Flexibility) All school districts and special schools of this State may transfer 16 and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery Act funds, 17 and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, to ensure 18 19 the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated specifically for state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance of effort 20 requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for Career and 21 Technology Education, nor required for debt service or bonded indebtedness. All school districts and special schools of this State 22 23 may suspend professional staffing ratios and expenditure regulations and guidelines at the sub-function and service area level, except 24 for four-year old programs and programs serving students with disabilities who have Individualized Education Programs.

In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per pupil expenditures must be utilized within the In\$ite categories of instruction, instructional support, and <u>only transportation, food</u> *service, and safety within* non-instruction pupil services. No portion of the seventy-five percent may be used for <u>facilities</u>, business services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional support, and *transportation, food service, and safety within* non-instruction pupil services for the current school year ending June

thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures.

1 School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year.

2 Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 3 allocation due to them for each categorical program.

4 Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school

5 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken.

6 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State

7 Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of

8 the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education

9 and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting,

10 and the certification must be conspicuously posted on the internet website maintained by the school district.

For the current fiscal year, Section 59-21-1030 is suspended. Formative assessments for grades one, two, and nine, the foreign language program assessment, and the physical education assessment must be suspended. School districts and the Department of

13 Education are granted permission to purchase the most economical type of bus fuel.

For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school districts based on weighted pupil units.

16 School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, 17 from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made 18 available for public viewing and downloading. The register must include for each expenditure:

(i) the transaction amount;

(ii) the name of the payee; and

(iii) a statement providing a detailed description of the expenditure.

The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must not include any information that can be used to identify an individual employee. The register must be accompanied by a complete explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at

least once a month.

Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the

29 thirtieth day after the first date that any portion of the balance due as shown on the statement is paid.

30 The Comptroller General must establish and maintain a website to contain the information required by this section from a school

31 district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate

32 between the school districts and search for the information they are seeking.

33 School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller

34 General in a manner and at a time determined by the Comptroller General to be included on the internet website.

The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 30, the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of Education to exercise its authority to grant waivers under Regulation 43-261.

1.29. (SDE: Medical Examination and Security Reimbursement/Expenditures) From funds authorized in Part IA, Section 1,
 VII.B. Other Operating Expenses, the Department of Education may directly pay, or reimburse employees, for the cost of a medical
 examination as required in Part 391, Subpart E of the Federal Motor Carrier Safety Regulations, for employees that are required to
 operate a state vehicle transporting hazardous materials and that are required to undergo a national security background check because
 of the required Hazmat endorsement to their CDL.

9 1.30. (SDE: Budget Reduction) In compensating for any reduction in funding, local districts must give priority to preserving
 10 classroom teachers and operations. Funding reductions should first be applied to administrative and non-classroom expenses before
 11 classroom expenses are affected.

12 **1.31.** (SDE: Governor's School for the Arts and Humanities Carry Forward) Any unexpended balance on June thirtieth of the 13 prior fiscal year of funds appropriated to or generated by the Governor's School for the Arts and Humanities may be carried forward 14 and expended in the current fiscal year pursuant to the discretion of the Board of Trustees of the School.

1.32. (SDE: Governor's Schools' Fees) The South Carolina Governor's School for the Arts and Humanities and the South Carolina Governor's School for Science and Mathematics are authorized to charge, collect, expend, and carry forward student fees as approved by their respective Board of Directors. The purpose and amount of any such fees will be to maintain program quality in both academics and residential support. No student will be denied admittance or participation due to financial inability to pay. The respective Board of Directors shall promulgate administrative policy governing the collection of all student fees. Both schools shall conspicuously publish a fee schedule on their respective websites.

1.33. (SDE: School District Furlough) Should there be a midyear reduction in state funding to the districts, school districts may institute employee furlough programs for district-level and school-level professional staff. Before any of these employees may be furloughed, the chairman of the governing body of the school district must certify that all fund flexibility provided by the General Assembly has been utilized by the district and that the furlough is necessary to avoid a year-end deficit and a reduction in force. The certification must include a detailed report by the superintendent of the specific action taken by the district to avoid a year-end deficit. The certification and report must be in writing and delivered to the State Superintendent of Education and a copy must be forwarded to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

28 The local school district board of trustees may implement a furlough of personnel once certification to the State Superintendent documents all funding flexibility has been exhausted and continued year-end deficits exist. Local school boards of trustees shall 29 have the authority to authorize furloughs of these employees in the manner in which it sees fit. However, instructional personnel 30 31 may be furloughed for up to five non-instructional days if not prohibited by an applicable employment contract with the district and provided district administrators are furloughed for twice the number of days. District administrators may only be furloughed on non-32 instructional days and may not be furloughed for a period exceeding ten days. District administrators shall be defined by the 33 34 Department of Education using the Professional Certified Staff (PCS) System. For individuals not coded in PCS, the determination shall be made based upon whether the individual performs the functions outlined in position codes identified by the department as 35

administration. Educators who would have received a year's experience credit had a furlough not been implemented, shall not have 1 2 their experience credit negatively impacted because of a furlough implementation. During any furlough, affected employees shall be entitled to participate in the same benefits as otherwise available to them except 3 4 for receiving their salaries. As to those benefits that require employer and employee contributions, including, but not limited to, contributions to the South Carolina Retirement System or the optional retirement program, the district will be responsible for making 5 both employer and employee contributions if coverage would otherwise be interrupted; and as to those benefits which require only 6 7 employee contributions, the employee remains solely responsible for making those contributions. Placement of an employee on furlough under this provision does not constitute a grievance or appeal under any employee grievance procedure. The district may 8 allocate the employee's reduction in pay over the balance of the fiscal year for payroll purposes regardless of the pay period within 9 which the furlough occurs. 10 Each local school district must prominently post on the district's internet website and make available for public viewing and 11 downloading the most recent version of the school district's policy manual and administrative rule manual. 12 This proviso shall not abrogate the terms of any contract between any school district and its employees. 13 1.34. (SDE: School Lunch/Attendance Supervisors) For those counties in which an entity other than the school district 14 administers the school lunch supervisor and/or attendance supervisor programs, the school districts in that county shall transfer to 15 the entity the amount available in the previous fiscal year for administration of the school lunch supervisor and/or attendance 16 supervisor programs. Each district shall transfer a pro rata share of the total cost based upon the percentage of state EFA funds 17 distributed to the districts within the county. 18 1.35. (SDE: SCGSAH Certified Teacher Designation) Because of the unique nature of the South Carolina Governor's School 19 for the Arts and Humanities, the Charleston School of the Arts, and the Greenville County Fine Arts Center, the schools are authorized 20 to employ at its discretion noncertified classroom teachers teaching in the literary, visual and performing arts subject areas who are 21 otherwise considered to be appropriately qualified in a ratio of up to one hundred percent of the entire teacher staff. 22 23 **1.36.** (SDE: No Discrimination Requirement) State funds must not be appropriated to a school that discriminates against or participates with or is a member of an association with policies that discriminate or afford different treatment of students based on 24 25 race or national origin. 26 1.37. (SDE: Medicaid Cash Match Accounting) The department is granted authority to transfer funds between budget lines and object codes to identify, reconcile, reimburse, and remit funds required for Medicaid cash match to the Department of Health and 27 Human Services. 28 1.38. (SDE: Student Report Card-GPA) For each high school student, school districts shall be required to print the student's 29 individual cumulative grade point average for grades nine through twelve on the student's report card. 30 1.39. (SDE: Lost & Damaged Textbook Instructional Materials Fees) Fees for lost and damaged textbooks instructional 31 materials for the prior school year are due no later than December first of the current school year when invoiced by the Department 32 of Education. The department may withhold textbooks instructional materials funding from schools that have not paid their fees by 33 34 the payment deadline. 1.40. (SDE: Education Finance Act Reserve Fund) There is created in the State Treasury a fund separate and distinct from the 35 General Fund of the State and all other funds entitled the Education Finance Act Reserve Fund. All unexpended general funds 36

1 appropriated to the Department of Education for the Education Finance Act in the current fiscal year shall be transferred to the 2 Education Finance Act Reserve Fund. In the event that the amount appropriated for the Education Finance Act is insufficient to fully fund the base student cost as established by this act, revenues from the Education Finance Act Reserve Fund may be used to 3 4 supplement the funds appropriated. The General Assembly may make direct appropriations to this fund. All unexpended funds in 5 the Education Finance Act Reserve Fund and any interest accrued by the fund must remain in the fund and may be carried forward 6 into the current fiscal year. 7 **1.41.** (SDE: Prohibit Advertising on School Buses) The Department of Education and local school districts are prohibited from selling space for or the placement of advertisements on the outside or inside of state-owned school buses. 8 1.42. (SDE: Residential Treatment Facilities Student Enrollment and Funding) Each South Carolina resident of lawful school 9 age residing in licensed residential treatment facilities (RTFs) for children and adolescents as defined under identified on the State 10 Oualified Providers list and meets the requirements of Section 44-7-130 of the 1976 Code, ("students") shall be entitled to receive 11 educational services from the school district in which the RTF is located ("facility school district"). The responsibility for providing 12 appropriate educational programs and services for these students, both with and without disabilities, who are referred, authorized, or 13 placed by the State is vested in the facility school districts. For purposes of this proviso, an authorization must be pursuant to a 14 physician's determination of medical necessity. If clinically appropriate, the facility school district, the RTF, and the parent or 15 guardian of a student referred or placed in a RTF may consider the appropriateness of providing the student's education program 16 virtually through enrollment in either the facility district's virtual program, the South Carolina virtual school program provided 17 through the Department of Education (Virtual SC), or a virtual charter school authorized by the South Carolina Public Charter School 18 District, or a virtual charter school authorized by an approved institute of higher education. This decision should be made jointly 19 with the best interest of the student and what is clinically indicated being considered. 20 A facility school district must provide the necessary educational programs and services directly to the student at the RTF's facility. 21 provided that the RTF facility provides and maintains comparable adequate space for the educational programs and services 22 23 consistent with all federal and state least restrictive environment requirements. Adequate space shall include appropriate electrical support and Internet accessibility. Unless the parent or legal guardian of the student seeks to continue the student's enrollment in 24

the resident school district under a medical homebound instruction program and the district approves, if appropriate, then, under 25 these circumstances, the facility school district shall enroll the student and assume full legal and financial responsibility for the 26 educational services including enrolling the student, approving the student's entry into a medical homebound instructional program, 27 28 if appropriate, and receiving and expending funds, unless the resident school district undertakes to carry out its educational responsibilities for the student directly. Alternatively, a facility school district may choose to provide the necessary educational 29 programs and services by contracting with the RTF provided that the RTF agrees to provide educational services to the student at the 30 31 RTF's facility. Under these circumstances, the facility school district must enroll the student and pay the RTF for the educational services provided. If the facility school district determines the educational program being offered by the RTF does not meet the 32

33 educational standards outlines in the contract, the facility district shall be justified in terminating the contract.

The facility school districts are entitled to receive the base student cost multiplied by the Education Finance Act pupil weighting for Homebound pupils of 2.10, as set forth in Section 59-20-40 of the 1976 Code and any eligible categorical and federal funds. These funds may be retained by the facility school districts for the purpose of providing the educational programs and services

directly to students referred or placed by the State or the facility school districts may use these funds to reimburse RTFs for the 1 2 educational programs and services provided directly by the RTFs. A facility school district is entitled to reimbursement from a resident school district for the difference between (1) the reasonable costs expended for the educational services provided directly 3 4 by the facility school district or the amount paid to the RTF and (2) the aggregate amount of federal and state funding received by 5 the facility school district for that student. However, the reimbursement rate may not exceed \$45 per student per day. Facility school districts providing the educational services shall notify the resident district in writing within forty-five calendar days that a student 6 7 from the resident district is receiving educational services pursuant to the provisions of the proviso. Reimbursements shall be paid 8 within sixty days of billing, provided the facility district has provided a copy of the invoice to both the District Superintendent and the finance office of the resident district being invoiced. Should the facility school district be unable to reach agreement with the 9 resident school district regarding reasonable costs differences, the facility school district shall notify the Department of Education's 10 Office of General Counsel. The Department of Education shall facilitate a resolution of the dispute between the facility school 11 district and the resident school district within forty-five days of the notice of dispute. If the issue of reasonable cost differences 12 should remain unresolved, a facility school district shall have the right to file a complaint in a Circuit Court. Should a resident school 13 district fail to distribute the entitled funding to the facility school district by the one hundred thirty-five day count, the Department 14 15 of Education is authorized to withhold the equivalent amount of EFA funds and transfer those funds to the facility school district. RTF facilities on the State Qualified Provider List not located within the boundaries of the state shall be reimbursed at a rate that 16 may not exceed \$45 per student per day for education services and school districts shall be eligible to receive a base student cost 17 weighted funding of 2.10 provided that the student remains enrolled in the school district. Facilities providing the educational 18 services shall notify the resident district in writing within forty-five calendar days that a student from the resident district is receiving 19 educational services pursuant to the provisions of the proviso. Reimbursements shall be paid within sixty days of billing, provided 20 the qualified facility has provided a copy of the invoice to both the District Superintendent and the finance office of the resident 21 district being invoiced. Should the facility be unable to reach agreement with the resident school district regarding reasonable costs 22 23 differences, the provider shall notify the Department of Education's Office of General Counsel. The Department of Education shall 24 facilitate a resolution of the dispute between the facility and the resident school district within forty-five days of the notice of dispute. 25 If the issue of reasonable cost differences should remain unresolved, a facility shall have the right to file a complaint in a Circuit 26 Court. Additionally, qualified RTF providers' general education curriculum must be aligned to the South Carolina academic standards in the core content areas. All students with disabilities who are eligible for special education and related services under 27 the Individuals with Disabilities Education Act (IDEA), as amended, and the State Board of Education (SBE) regulations, as 28 amended, shall receive special education and related services in the least restrictive environment by appropriately certified 29 personnel. Students in a qualified RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned 30 through their educational efforts. The resident school district and the RTF should develop a memorandum of understanding to 31 outline the responsibilities of the RTF in providing the educational services and responsibilities, if any, of the resident school district 32 while the student is housed in the RTF. 33

If a child from out of state is placed in a RTF by an out-of-state school district or agency, the child's home state remains responsible for the educational services. The facility school district may choose to provide the educational program to the child and, upon choosing to do so, shall contract with the appropriate entity for payment of educational serviced provided to the child. Out-of-state

students provided educational services by a facility school district shall not be eligible for funding through the Education Finance
 Act.

If a child is placed in a RTF by the child's parent or guardian and is not referred, authorized, or placed by the State, the facility 3 school district may choose to provide the educational program to the child, and upon doing so, must negotiate with the resident 4 5 school district for services through medical homebound procedures. A facility school district is responsible for compliance with all 6 child find requirements under Section 504 of the Rehabilitation Act of 1973 and Individuals with Disabilities Act of 2004 (IDEA). 7 All students enrolled in the facility school districts shall have access to the facility school districts' general education curriculum, 8 which will be tied to the South Carolina academic standards in the core content areas. All students with disabilities who are eligible 9 for special education and related services under the Individuals with IDEA, as amended, and the State Board of Education (SBE) regulations, as amended, shall receive special education and related services in the least restrictive environment by appropriately 10

11 certified personnel. Students in an RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned

12 through their educational efforts.

With respect to students enrolled in the facility school districts, for accountability purposes, the assessment and accountability measures for students residing in RTFs shall be attributed to a specific school only if the child physically attends the school. The performance of students residing in a RTF who receive their educational program on site at the RTF must be reflected on a separate line on the facility school district's report card and must not be included in the overall performance ratings of the facility school district. The Department of Education shall examine the feasibility of issuing report cards for RTFs. For the current fiscal year, a facility school district shall not have the district's state accreditation rating negatively impacted by deficiencies related to the delivery of an educational program at a RTF.

RTFs shall notify the facility school district as soon as practical, and before admission to the RTF if practical, of a student's admission to the RTF. RTFs, the facility school districts and the Department of Education shall use their best efforts to secure and/or exchange information, including documents and records necessary to provide appropriate educational services and/or related services as necessary to assist the facility school district in determining the resident school district. The Department of Education, in collaboration with state placing agencies, RTFs, facility school districts, and resident school districts, shall implement a system to follow the release of students from a RTF and re-enrollment in public, private, or special schools to ensure these students, when appropriate, are not recorded as dropouts.

1.43. (SDE: Special Schools Flexibility) For the current fiscal year, the special schools are authorized to transfer funds among
 funding categories, including capital funds.

1.44. (SDE: High School Driver Education) For the current fiscal year, the requirement for high schools to provide a course in
 driver education is suspended however, high schools may continue to offer driver education courses if they choose to do so.

1.45. (SDE: Carry Forward Authorization) For the current fiscal year, the Department of Education is authorized to carry forward
 and expend any General Fund balances for school bus transportation.

1.46. (SDE: Administrative Costs Report Posting) School districts must report the amount of funds spent on administrative costs, as defined by In\$ight in the prior fiscal year and post the report on the districts website. School districts shall provide an electronic copy of this report to the Department of Education in conjunction with the financial audit report required by Section 59-17-100, of the 1976 Code. If a district fails to meet these requirements they must be notified in writing by the department that the

authorized to reduce the district's base student cost by one percent until such time as the requirement is met. Once in compliance, any funds withheld will be returned to the district. **1.47.** (SDE: Governor's Schools Residency Requirement) Of the funds appropriated, the Governor's School for the Arts and the Humanities and the Governor's School for Science and Mathematics are to ensure that a parent(s) or guardian(s) of a student attending either the Governor's School for the Arts and the Humanities or the Governor's School for Science and Mathematics must prove that they are a legal resident of the state of South Carolina at the time of application and must remain so throughout time of attendance. The Governor's School for the Arts and the Humanities and Governor's School for Science and Mathematics may not admit students whose parent(s) or guardian(s) are not legal residents of South Carolina. **1.48.** (SDE: Holocaust Funds) Funds appropriated to the Department of Education for the SC Council on Holocaust shall not be used for any other purpose nor transferred to any other program. In addition, in the event the department is required to implement a budget reduction, SC Council on Holocaust funds may not be reduced. **1.49.** (SDE: Governor's School for Science and Mathematics must be used to bring the schools up to full capacity, to the extent possible. Each school must report electronically to the Chairman of the Senate Finance Committee and the Chairman of the Humanities have been utilized and how many additional students have

18 1.50. (SDE: Student Health and Fitness) Funds appropriated for Student Health and Fitness shall be allocated to school districts to increase the number of physical education teachers to the extent possible and to provide licensed nurses for elementary public schools. Twenty-seven percent of the funds shall be allocated to the districts based on average daily membership of grades K-5 from the preceding year for physical education teachers. The remaining funds will be made available through a grant program for school nurses and shall be distributed to the school districts on a per school basis. Schools that provide instruction in grades K-5 are eligible to apply for the school nurse grant program *funds*.

1.51. (SDE: Impute Index Value) For the current fiscal year and for the purposes of calculating the index of taxpaying ability the Department of Revenue shall impute an index value for owner-occupied residential property qualifying for the special four percent assessment ratio by adding the second preceding taxable year total school district reimbursements for Tier 1, 2, and Tier 3(A) and not to include the supplement distribution. The Department of Revenue shall not include sales ratio data in its calculation of the index of taxpaying ability. The methodology for the calculations for the remaining classes of property shall remain as required pursuant to the EFA and other applicable provisions of law.

30 **1.52.** (SDE: EFA State Share) A school district that does not recognize a State share of the EFA financial requirement shall be
 31 supplemented with an amount equal to seventy percent of the school district with the least State financial requirement.

1.53. (SDE: Health Education) Each school district is required to ensure that all comprehensive health education, reproductive
 health education, and family life education conducted within the district, whether by school district employees or a private entity,
 must utilize curriculum that complies with the provisions contained in Chapter 32, Title 59. *Each district shall publish on its website*

35 *the title and publisher of all health education materials it has approved, adopted, and used in the classroom.* Any person may

36 complain in a signed, notarized writing to the chairman of the governing board of a school district that matter not in compliance with

the requirements of Chapter 32, Title 59 is being taught in the district. Upon receiving a notarized complaint, the chairman of the 1 2 governing board must ensure that the complaint is immediately investigated and, if the complaint is determined to be founded, that immediate action is taken to correct the violation. If corrective action is not taken within 60 days of such a determination, or if no 3 4 investigation is made within 60 days of the chairman's receipt of the notarized statement, then the complainant may within 60 calendar day, give written notice to the department. The notice must include the original notarized complaint. If, upon investigation, 5 6 the department determines that the district has not taken appropriate immediate action to correct a violation, then the Department of Education is noncompliant with mandated health education, the department shall withhold one percent of the district's funds 7 allocated in Part IA, Section 1, X - Student Health and Fitness Act until the department determines the district is in compliance. If 8 the department determines that a district is non-compliant with mandated health education or if the district fails to publish the title 9 and publisher of materials on its website, then the Department of Education shall withhold one percent of the district's funds 10 allocated in Part IA, Section 1, X - Student Health and Fitness Act until the department determines the district is in compliance. 11 1.54. (SDE: Bus Lease/Purchase) The Department of Education is permitted to purchase or lease school buses in order to 12 continue replacement of the state's school bus fleet. 13 1.55. (SDE: Felton Lab Allocation) Of the funds distributed pursuant to the Education Finance Act, the Felton-Laboratory 14 15 School at South Carolina State University shall receive each year, seventy percent of the funds it would have received for that year under the Education Finance Act and under aid to school districts-fringe benefits, as if it were a special school district. The calculation 16 of the amount of funds which the Felton-Laboratory School is entitled to receive each year shall be made by the Department of 17 18 Education. **1.56.** (SDE: Lee County Bus Shop) From the funds appropriated in program VII.B. Bus Shops, in the current fiscal year, the 19 department must fund the Lee County School District Bus Shop and the Kershaw County School District Bus Shop at the same level 20 21 as they were funded in the previous fiscal year. **1.57.** (SDE: School Enrollment Policy) For the current fiscal year, any school district with an open enrollment policy for all 22 23 schools or certain schools which had previously accepted certain students residing outside of the district to an academic magnet 24 school in the district must continue to accept these students and their siblings for enrollment at the academic magnet school under 25 the same terms and conditions these students were previously permitted to attend the school. **1.58.** (SDE: District Funding Flexibility) For the current fiscal year, districts must utilize funding flexibility provided herein to 26 ensure that district approved safety precautions are in place at every school. 27 **1.59.** (SDE: Transportation Maintenance Facilities) For the current fiscal year, a school district wishing to include school bus 28 29 maintenance in a contract with a private vendor may enter into an agreement with the Department of Education whereby the department releases the school district to include school bus maintenance in the private vendor contract. 30 31 1.60. (SDE: School District Activity Bus Advertisements) School Districts may sell commercial advertising space on the outside or inside of district owned activity buses. However, as defined and determined by the local school board, a school district may not 32 sell such commercial advertising if the advertisement promotes a political candidate, ideology, or cause, a product that could be 33 34 harmful to children, or a product that appeals to the prurient interest. Revenue generated from the sale of commercial advertising space shall be retained by the school district. 35

1.61. (SDE: School District Property) The requirements of Section 59-19-250 of the 1976 Code, as amended, which requires the consent of a governing board of a county in order for school trustees to sell or lease school property whenever they deem it expedient to do so are suspended for the current fiscal year.

1.62. (SDE: Full-Day 4K) For the current school year, eligible Eligible students residing in a school district with a poverty index 4 5 of seventy percent or greater may participate that met the poverty level for participation in the prior school year are eligible to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and private 6 7 providers will be reimbursed for instructional costs at a rate of $\frac{4.218}{4.323}$ per student enrolled. Eligible students enrolling during 8 the school year or withdrawing during the school year shall be funded on a pro rata basis determined by the length of their enrollment. Private providers transporting eligible children to and from school shall also be eligible for a reimbursement of \$550 per eligible 9 child transported. All providers who are reimbursed are required to retain records as required by their fiscal agent. New providers 10 participating for the first time in the current fiscal year and enrolling between one and six eligible children shall be eligible to receive 11 up to \$1,000 per child in materials and equipment funding, with providers enrolling seven or more such children eligible for funding 12 not to exceed \$10,000. Providers receiving equipment funding are expected to participate in the program and provide high-quality, 13 center-based programs as defined herein for a minimum of three years. Failure to participate for three years will require the provider 14 to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of First Steps to 15 School Readiness. Funding to providers is contingent upon receipt of data as requested by the Department of Education and the 16 17 Office of First Steps. Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 18

the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 19 fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 20 public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 21 program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 22 23 Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day four-year-24 25 old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and maintenance of data on the state funded programs provided through private providers. The Education Oversight Committee shall use this data and 26 all other collected and maintained data necessary to conduct a research based review of the program's implementation and assessment 27 28 of student success in the early elementary grades.

1.63. (SDE: Summer Reading Camps) For the current fiscal year, funds appropriated for summer reading camps must be 29 30 allocated as follows: (1) up to twenty percent to the Department of Education to provide bus transportation for students attending 31 the camps; (2) \$700,000 allocated to the department to provide grants to support community partnerships whereby community organizations would collaborate shall partner with local school districts to provide enrichment activities as part of after school 32 programs or summer reading camps that utilize volunteers, mentors or tutors to provide instructional support to struggling readers in 33 34 elementary schools that have a poverty index of fifty forty percent or greater based on the poverty index utilized the prior fiscal year that was student eligibility for the free or reduced price lunch program and Medicaid. All mentors and tutors that are a part of these 35 after school programs or summer reading camps must have passed a SLED criminal background check. Participant to volunteer or 36

teacher ratio must conform to that of the school district in which the program is located. The Education Oversight Committee will 1 2 document and evaluate the partnerships and the impact of the partnerships on student academic success and make recommendations on the characteristics of effective partnerships and on methods of duplicating effective partnerships throughout the state; and (3) the 3 4 remainder on a per pupil allocation to each school district based on the number of students who substantially failed to demonstrate 5 third-grade reading proficiency as indicated on the prior year's state assessment as defined by Section 59-155-120 (10) of the 1976 6 Code. Summer reading camps must be at least six weeks in duration with a minimum of four days of instruction per week and four 7 hours of instruction per day, or the equivalent minimum hours of instruction in the summer. School transportation shall be provided. 8 The camps must be taught by compensated teachers who have at least an add-on literacy endorsement or who have documented and demonstrated substantial success in helping students comprehend grade-level texts. The Department of Education shall assist districts 9 that cannot find qualified teachers to work in the summer camps. Districts may also choose to contract for the services of qualified 10 instructors or collaborate with one or more districts to provide a summer reading camp. Schools and school districts are encouraged 11 to partner with county or school libraries, institutions of higher learning, community organizations, faith-based institutions, 12 businesses, pediatric and family practice medical personnel, and other groups to provide volunteers, mentors, tutors, space, or other 13 support to assist with the provision of the summer reading camps. In the current school year, any student in third grade who 14 substantially fails to demonstrate third-grade reading proficiency by the end of the school year must be offered the opportunity to 15 attend a summer reading camp at no cost to the parent or guardian. The purpose of the reading camp is to provide students who are 16 significantly below third-grade reading proficiency with the opportunity to receive quality, intensive instructional services and 17 support. A district may also include in the summer reading camps students who are not exhibiting reading proficiency at any grade 18 and may charge fees for these students to attend the summer reading camps based on a sliding scale pursuant to Section 59-19-90, 19 except where a child is found to be reading below grade level in the first, second or third grade. A parent or guardian of a student 20 who does not substantially demonstrate proficiency in comprehending texts appropriate for his grade level must make the final 21 22 decision regarding the student's participation in the summer reading camp.

1.64. (SDE: Interscholastic Athletic Association Dues) A public school district supported by state funds shall not use any funds or permit any school within the district to use any funds to join, affiliate with, pay dues or fees to, or in any way financially support any interscholastic athletic association, body, or entity unless the constitution, rules, or policies of the association, body, or entity contain the following:

(1) a range of sanctions that may be applied to a student, coach, team, or program and that takes into account factors such as
 the seriousness, frequency, and other relevant factors when there is a violation of the constitution, bylaws, rules, or other governing
 provisions of the association, body, or entity;

(2) (a) guarantees that private or charter schools are afforded the same rights and privileges that are enjoyed by all other
members of the association, body, or entity. A private or charter school may not be expelled from or have its membership
unreasonably withheld by the association, body, or entity or restricted in its ability to participate in interscholastic athletics including,
but not limited to, state playoffs or championships based solely on its status as a private school or charter school. The association,
body, or entity shall set reasonable standards for private or charter school admission. A private or charter school denied membership
must be provided, in writing within five business days, the reason or reasons for rejection of its application for membership;

1 (b) guarantees that a South Carolina home school athletic team that is a member of a home school athletic association 2 may not be denied access to preseason and regular season interscholastic athletics including, but not limited to, jamborees and 3 invitational tournaments, based solely on its status as a home school athletic team; other rules or policies of the association, body, or 4 entity would apply;

5 (3) (a) an appeals process in which appeals of the association, body, or entity are made to a disinterested third-body appellate 6 panel which consists of seven members who serve four year terms, with one person appointed by the delegation of each congressional 7 district;

8 (b) a member of the panel serves until his successor is appointed and qualifies. A vacancy on the panel is filled in the 9 manner of the original appointment;

10 (c) members of the appellate panel do not concurrently serve as officers of the association, body, or entity and may not 11 have served as a member of the executive committee within the last three years. Principals and superintendents are able to appeal a 12 ruling of the association, body, or entity to the panel. The appellate panel also must provide the final ruling in any appeal brought 13 against a decision of the association, body, or entity;

14 (4) a procedure in place for emergency appeals to be held and decided upon in an expedited manner if the normal appellate 15 process would prohibit the participation of a student, team, program, or school in an athletic event, to include practices;

16 (5) provisions, implemented within one year after the effective date of this section, that require the composition of the executive 17 committee of the association, body, or entity be geographically representative of this State.

In the event an association, body, or entity fails to include one of the items listed in this proviso, public school districts and schools must end their affiliation with the association, body, or entity prior to the beginning of the upcoming school year and are prohibited from paying dues or fees to the association, body, or entity.

1.65. (SDE: Governor's Schools Informational Access to Students) For the current fiscal year, school districts must permit both 21 the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics to collaborate with 22 23 individual schools and their staff to share information with students and families about the educational opportunities offered at the respective Governor's Schools, through avenues including school visits, informational presentations, and posters. By June 30, 2015 24 25 of the current fiscal year, the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics must report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee the 26 27 results of these Informational Access efforts. Further, the two Governor's Schools will work with districts, the Department of 28 Education and School Report Card administrators, to ensure that SAT scores of current Governor's Schools' students are included 29 in the School Report Card of those students' resident schools and districts.

30 1.66. (SDE: Reading/*Literacy* Coaches) (A) Funds appropriated for Reading/*Literacy* Coaches must be allocated to school
 31 districts by the Department of Education as follows:

32 (1) for each elementary school in which twenty percent or more of the students scored Not Met <u>below proficient</u> on the reading 33 and research test in the most recent year for which such data are available, the school district shall be eligible to receive the lesser of 34 either up to \$62,730 or the actual cost of salary and benefits for a full-time reading/<u>literacy</u> coach; and

35 (2) for each elementary school in which fewer than twenty percent of the students scored <u>Not Met *below proficient*</u> on the 36 reading and research test during the same period, the school district shall be eligible to receive the lesser of either up to \$31,365 or

fifty percent of the actual cost of salary and benefits for a full-time reading/literacy coach. A school district must provide local 1 2 support for state funds provided under this paragraph. School districts may use existing local funds currently used for reading assistance as the local support. 3 4 (B) By accepting these funds, a school district warrants that they will not be used to supplant existing school district expenditures, 5 except for districts that either are currently, or in the prior fiscal year, were paying for reading/literacy coaches with local funds. A district may, however, assign a reading/literacy coach to a primary school rather than to the elementary school to improve the early 6 7 literacy skills of young children. 8 (C) Funds appropriated for Reading/Literacy Coaches are intended to be used to provide elementary schools with reading/literacy coaches, who shall serve as job-embedded, stable resources for professional development throughout schools in order to generate 9 improvement in reading and literacy instruction and student achievement who shall serve according to the provisions in Chapter 155 10 of Title 59. Reading coaches shall support and provide initial and ongoing professional development to teachers based on an analysis 11 of student assessment and the provision of differentiated instruction and intensive intervention. The reading coach shall: 12 (1) model effective instructional strategies for teachers by working weekly with students in whole, and small groups, or 13 individually; 14 15 (2) facilitate study groups; (3) train teachers in data analysis and using data to differentiated instruction; 16 (4) coaching and mentoring colleagues; 17 (5) work with teachers to ensure that research-based reading programs are implemented with fidelity; 18 (6) work with all teachers (including content area and elective areas) at the school they serve, and help prioritize time for those 19 teachers, activities, and roles that will have the greatest impact on student achievement, namely coaching and mentoring in the 20 21 classrooms; 22 (7) help lead and support reading leadership teams; and-23 (8) The reading coach must not be assigned a regular classroom teaching assignment, must not serve an as administrator, must not perform administrative functions that deter from the flow of improving reading instruction and reading performance of students, 24 25 and must not devote a significant portion of his or her time to administering or coordinating assessments. 26 (D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve as an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute 27 28 they must withhold that districts remaining balance of funds allocated pursuant to this proviso. (DE) No later than February 1, 2016, the The Department of Education must publish guidelines that define the minimum 29 qualifications for a reading/literacy coach for Fiscal Year 2015-16. These guidelines must deem any licensed/certified teacher 30 qualified if, at a minimum, he or she: 31 (1) holds a bachelor's degree or higher and an add-on endorsement for literacy coach or literacy specialist, or 32 (2) holds a bachelor's degree or higher and is actively pursuing the literacy coach or literacy specialist endorsement; or 33 34 (3) holds a master's degree or higher in reading or a closely-related field. Within these guidelines, the Department of Education must also establish a process for Fiscal Year 2015-16 through which an 35 elementary school may be permitted to use some or all of the allocation granted under subsection (A) in order to obtain in-school 36

reading coaching services from a department approved consultant or vendor, assist districts in identifying a reading/literacy coach 1

2 in the event that the school is not successful in identifying and directly employing a qualified candidate. The provisions of subsection

(A), including the local support requirements, shall also apply to any allocations made pursuant to this paragraph. 3

4 (E F) The Department of Education must develop procedures for monitoring the use of funds appropriated for Reading Coaches 5 reading/literacy coaches to ensure they are applied to their intended uses and are not redirected for other purposes. The Department 6 of Education may receive up to \$100,000 of the funds appropriated for Reading Coaches reading/literacy coaches in order to

7 implement this program, provided that this allocation does not exceed the department's actual costs.

8 (F G) Prior to the close of the current fiscal year, any remaining <u>unspent or unallocated</u> funds for Reading Coaches, reading/literacy coaches but no more than \$5,000,000, shall be distributed by the Department of Education among the school districts 9 containing elementary or primary schools that were eligible for and which elected to receive funding under subsection (A)(1) of this 10 proviso; these funds shall be distributed in proportion to these districts' relative shares of students who scored Not Met on the research 11 and reading test in the most recent year for which such data are available used to fund Summer Reading Camps. Funds distributed 12 under this subsection must be used exclusively to support reading related professional development opportunities for teachers that 13 lead to the literacy add-on endorsement. 14

15 (GH) The Department of Education shall require:

(1) any school district receiving funding under subsection (A) to identify the name and qualifications of the supported 16 reading/literacy coach; as well as the school in which the coach is assigned along with the rationale for how the school selection was 17 18 made: and 19

(2) any school district receiving funding under subsection (F G) to account for the specific amounts and uses of such funds.

(H) With the data reported by the school districts, the department shall report by January fifteenth of the current fiscal year on 20 the hiring of and assignment of reading/ literacy coaches by school and on the expenditure of professional development funds for 21 opportunities for teachers to earn the literacy endorsement. The department shall also report the amount of funds that will be carried 22 23 forward used for Summer Reading Camps.

(IJ) Funds appropriated for Reading Coaches reading/literacy coaches shall be retained and carried forward to be used for the 24 same purpose but may not be flexed. 25

26 (JK) For Fiscal Year 2015-16 2016-17, if increased funding for reading/literacy coaches is not sufficient to provide additional reading/literacy coaches at each elementary school then the funding must be targeted to the areas of greatest need based on the 27 28 number of students substantially failing to demonstrate reading proficiency as indicated on the prior year's state assessment.

29 1.67. (SDE: Charter School Transition Funds) For Fiscal Year 2015-16, charter schools sponsored by a local school district must receive transition funds from the local district or statewide transition funds available in an amount equal to any reduction in 30 funds received by the school due to the changes in the Education Finance Act formula. In order to receive funds from the statewide 31

32 transition funds, the charter school must report the amount of funds required to the department through the authorizing district. The

department shall allocate the transition funds to the district which then shall allocate the funds to the school. If the amount of 33

transition funds for the charter schools exceeds transition funds available, then funds will be reduced pro rata for all parties. 34

1.68. (SDE: Sports Participation) Any school receiving state funds shall be required to allow a military dependent student who 35 has transferred from their resident school district to another school district to participate in a sport that was not offered in the resident 36

school district. Should a school fail to comply with this provision, the Department of Education shall withhold one percent of their
 total state allocation.

3 **1.69.** (SDE: Graduation Rates) For the current fiscal year, if a high school has a graduation rate below sixty percent, using appropriated funds a local school district board of trustees must provide a report detailing a plan to increase the graduation rate in accordance with the provisions of the Education Accountability Act to the State Board of Education.

6 1.70. (SDE: South Carolina Community Block Grants for Education Pilot Program) There is created the South Carolina
 7 Community Block Grants for Education Pilot Program. The purpose of this matching grants program is to encourage and sustain
 8 partnerships between a community and its local public school district or school for the implementation of innovative, state-of-the-art
 9 education initiatives and models to improve student learning. The initiatives and models funded by the grant must be well designed,
 10 based on strong evidence of effectiveness, and have a history of improved student performance.

The General Assembly finds that the success offered by these initiatives and programs is assured best when vigorous community support is integral to their development and implementation. It is the intent of this proviso to encourage public school and district communities and their entrepreneurial public educators to undertake state-of-the-art initiatives to improve student learning and to share the results of these efforts with the state's public education community.

15 As used in this proviso:

(1) "Community" is defined as a group of parents, educators, and individuals from business, faith groups, elected officials,
 nonprofit organizations and others who support the public school district or school in its efforts to provide an outstanding education
 for each child. As applied to the schools impacted within a district or an individual school, "community" includes the school faculty
 and the School Improvement Council as established in Section 59-20-60 of the 1976 Code;

20 (2) "Poverty" is defined as the percent of students eligible in the prior year for the free and reduced price lunch program and 21 or Medicaid; and

(3) "Achievement" is as established by the Education Oversight Committee for the report card ratings developed pursuant to
 Section 59-18-900 of the 1976 Code.

The Executive Director of the Education Oversight Committee is directed to appoint an independent grants committee to develop the process for awarding the grants including the application procedure, selection process, and matching grant formula. The grants committee will be comprised of seven members, three members selected from the education community and four members from the business community. The chairman of the committee will be selected by the committee members at the first meeting of the grants committee. The grants committee will review and select the recipients of the Community Block Grants for Education.

29 The criteria for awarding the grants must include, but are not limited to:

30 (1) the establishment and continuation of a robust community advisory committee to leverage funding, expertise, and other 31 resources to assist the district or school throughout the implementation of the initiatives funded through the Block Grant Program;

(2) a demonstrated ability to meet the match throughout the granting period;

(3) a demonstrated ability to implement the initiative or model as set forth in the application; and

34 (4) an explanation of the manner in which the initiative supports the district's or school's strategic plan required by Section
 35 59-18-1310 of the 1976 Code.

36 In addition, the district or school, with input from the community advisory committee, must include:

(1) a comprehensive plan to examine delivery implementation and measure impact of the model;

(2) a report on implementation problems and successes and impact of the innovation or model; and

(3) evidence of support for the project from the school district administration when an individual school applies for a grant.

The match required from a grant recipient is based on the poverty of the district or school. No matching amount will exceed more than seventy percent of the grant request or be less than ten percent of the request. The required match may be met by funds or by in-kind donations, such as technology, to be further defined by the grants committee. Public school districts and schools that have high poverty and low achievement will receive priority for grants when their applications are judged to meet the criteria established

8 for the grant program.

9 However, no grant may exceed \$250,000 annually unless the grants committee finds that exceptional circumstances warrant 10 exceeding this amount.

11 The Education Oversight Committee will review the grantee reports and examine the implementation of the initiatives and models

12 to understand the delivery of services and any contextual factors. The Oversight Committee will then highlight the accomplishments

13 and common challenges of the initiatives and models funded by the Community Block Grant for Education Pilot Program to share

14 the lessons learned with the state's public education community.

For the current fiscal year, funds allocated to the Community Block Grant for Education Pilot Program must be used to provide or expand high-quality early childhood programs for a targeted population of at-risk four-year-olds. High-quality is defined as meeting

the minimum program requirements of the Child Early Reading Development and Education Program and providing measurable high-quality child-teacher interactions, curricula and instruction. Priority will be given to applications that involve public-private

high-quality child-teacher interactions, curricula and instruction. Priority will be given to applications that involve public-private partnerships between school districts, schools, Head Start, and private child care providers who collaborate to: (1) provide high-

quality programs to four-year-olds to maximize the return on investment; (2) assist in making the transition to kindergarten; (3)

20 quarty programs to four-year-olds to maximize the return on investment, (2) assist in making the transition to kindergarten, (3) 21 improve the early literacy, *social and emotional*, and numeracy readiness of children; and (4) engage families in improving their

children's readiness.

1.71. (SDE: Board of Education Funds) For the current fiscal year, the Department of Education is authorized to carry forward
 funds appropriated in Part IA, Section 1, II. Board of Education. The State Board of Education is permitted to utilize these funds for
 innovative educational opportunities and projects. The Board of Education shall develop guidelines and publish them on the board's
 website.

1.72. (SDE: Proceeds from Sale of Bus Shop & Boat) For the current fiscal year the Department of Education is authorized to
 retain any funds received from the sale of any bus shop and the sale of the state- owned boat and expend those funds for transportation
 purposes.

30 **1.73.** (SDE: Transition Funds to Districts) Funds appropriated in Part IA, Section 1, X. Aid to School Districts, A. Aid to School

31 Districts, EFA Transition Payments, are to be distributed to school districts eligible to receive transition funds. The funds will be

32 disbursed in an amount equal to the net aggregate decrease in funding realized by a district as a result of changes to the EFA funding

33 formula.

34 (A) Districts eligible for transition payments in the prior fiscal year are eligible to receive one-half of the transition payment
 35 received in Fiscal Year 2014-15, subject to the limitations of item (B) of this section.

(B) School districts are not eligible to receive transition funds for the portion of a net funding decrease resulting from a decrease
 in district ADM from the prior to the current fiscal year.

3 (C) If the amount of transition payments for all school districts exceeds the availability of funds appropriated for this purpose,
 4 each entity receiving funds shall have their allocation reduced pro rata.

5 1.74. (SDE: First Steps 4K Technology) During the current fiscal year, South Carolina Office of First Steps to School Readiness is authorized to expend up to \$75,000 from the four-year-old kindergarten carry forward funds to purchase electronic devices for the 6 7 administration of early literacy and language development required school readiness assessments to children enrolled in the full-day 4K program in private centers in the current fiscal year. The State Office of First Steps may purchase one device, which would be 8 the property of the Office of First Steps, for every ten centers serving children in the program. The regional coordinators who provide 9 support to the centers shall coordinate the usage of the devices among the centers. First Steps shall provide a report documenting its 10 technology and materials expenditures to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and 11 Means Committee no later than January 15, 2016 2017. 12 1.75. (SDE: Teacher Salary Schedule Structure) The Department of Education shall convene stakeholders to include: Palmetto 13 State Teachers Association, South Carolina School Business Officials, South Carolina Association of School Administrators, South 14 Carolina School Boards Association, South Carolina Education Association, and the Education Oversight Committee to examine 15 and make recommendations regarding changes to the statewide minimum state teacher salary schedule to include extending the steps 16 on the state teacher salary schedule; an examination of the beginning teacher salary; and an examination of each district's salary 17 schedule structure. The department shall also include information from each of the districts who are, or were, the original trial and 18 plaintiff school districts in the Abbeville law suit regarding salary needs in those districts. Recommendations shall be provided to 19 the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by November 15, 2015. 20 1.76. (SDE: Teacher Certification Exemption) For the current fiscal year, a teacher certified at the secondary level may teach 21 such courses in grades seven through twelve without having the add on certification for middle-level education. Districts must report 22 23 to the Department of Education and the Center for Educator Recruitment Retention and Advancement on the teachers and courses 24 that utilize this exemption. 25 **1.77.** (SDE: Digital Instructional Materials) The Department of Education shall create an instructional materials list composed of those items (print and/or digital) that have received State Board of Education approval through the normal adoption process. The 26

27 department shall continue to work with the publishers of instructional materials to ensure that districts who wish to receive both the 28 digital version and class sets of textbooks may be awarded that option. Funds appropriated for the purchase of textbooks and other 29 instructional materials may be used for reimbursing school districts to offset the costs of refurbishing science kits on the state-adopted textbook inventory, purchasing new kits from the central textbook depository, or a combination of refurbishment and purchase. The 30 31 refurbishing cost of kits may not exceed the cost of the state-adopted refurbishing kits plus a reasonable amount for shipping and handling. Costs for staff development, personnel costs, equipment, or other costs associated with refurbishing kits on state inventory 32 are not allowable costs. Funds provided for Instructional Materials may be carried forward from the prior fiscal year into the current 33 34 fiscal year to be expended for the same purposes by the department, school districts, and special schools. These funds are not subject to flexibility. Digital Instructional Materials shall include the digital equivalent of materials and devices. 35

22	1.88. (SDE: Technology Technical Assistance) Funds appropriated to the Department of Education for Technology Technical

29	1.90. (SDE-Highly Qualified Teachers) For the current fiscal year teacher certification requirements for highly qualified
30	educators aligned to No Child Left Behind shall be suspended. The department shall report to the General Assembly by February 1
31	on the updated Federal requirements under the Every Student Succeeds Act.
32	1.91. (SDE: Teacher Salaries Increase) For Fiscal Year 2016-17, the Department of Education is directed to increase the
33	statewide salary schedule by two percent. A local school district board of trustees must provide all certified teachers paid on the

However, transfers are authorized from allocations to school districts or special line items with projected year-end excess 1 2 appropriations above requirements, to allocations to school districts or special line items with projected deficits in appropriations. 1A.2. (SDE-EIA: African-American History) Funds provided for the development of the African-American History curricula 3 4 may be carried forward into the current fiscal year. Funds that are currently a salary line item will be reallocated for the development of instructional materials and programs and the implementation of professional learning opportunities that promote African 5 American history and culture. For Fiscal Year 2014-15 2016-17 not less than seventy percent of the funds carried forwarded must 6 7 be expended for the development of additional instructional materials by nonprofit organizations selected through a competitive bids 8 grant process by the Department of Education. Priority must be given to organizations that have already produced materials that are currently being used by schools and outreach programs that reflect African American culture and history and that support literacy 9 10 efforts. 11 **1A.3.** (SDE-EIA: Teacher Evaluations, Implementation/Education Oversight) The Department of Education is directed to 12 oversee the evaluation of teachers at the School for the Deaf and the Blind, the John de la Howe School and the Department of 13 Juvenile Justice under the ADEPT model. 1A.4. (SDE-EIA: Teacher Salaries/State Agencies) Each state agency which does not contain a school district but has 14 instructional personnel shall receive an allocation from the line item "Alloc. EIA - Teacher/Other Pay" in Part IA, Section 1, VIII.E. 15 appropriation as recommended by the Education Oversight Committee and funded by the General Assembly for teacher salaries 16 based on the following formula: Each state agency shall receive such funds as are necessary to adjust the pay of all instructional 17 personnel to the appropriate salary provided by the salary schedules of the school district in which the agency is located. Instructional 18 personnel may include all positions which would be eligible for EIA supplements in a public school district, and may at the discretion 19 of the state agency, be defined to cover curriculum development specialists, educational testing psychologists, psychological and 20 guidance counselors, and principals. The twelve-month agricultural teachers located at Clemson University are to be included in this 21 allocation of funds for base salary increases. The South Carolina Governor's School for the Arts and Humanities and the South 22 23 Carolina Governor's School for Science and Mathematics are authorized to increase the salaries of instructional personnel by an 24 amount equal to the percentage increase given by the School District in which they are both located. 25 The funds appropriated herein in the line item "Alloc. EIA Teacher/Other Pay" must be distributed to the agencies by the Executive Budget Office. Teacher salary increases recommended by the Education Oversight Committee and funded in this Act shall be 26 incorporated into each agency's EIA appropriation contained in Section 1, VIII.E. 27 1A.5. (SDE-EIA: Work-Based Learning) Of the funds appropriated in Part IA, Section 1, VIII.A.1. for the Work-Based Learning 28 Program, \$75,000 shall be used by the State Department of Education to provide for regional professional development in contextual 29 methodology techniques and integration of curriculum, and professional development in career guidance for teachers and guidance 30 31 counselors and training mentors. Pilot-site delivery of contextual methodology training in mathematics will be supported by technology and hands-on lab activities. In addition, \$500,000 shall be allocated for Regional Career Specialists. Each Regional 32 Career Specialist shall (1) be housed within the regional centers/WIA geographic areas, (2) provide career development activities 33 34 throughout all schools within the region, (3) be under the program supervision of the Office of Career and Technology Education, State Department of Education, and (4) adhere to an accountability and evaluation plan created by the Office of Career and 35 Technology Education, State Department of Education. The Office of Career and Technology Education, State Department of 36

1 Education, shall provide a report, in February of the current fiscal year to the Senate Finance Committee and the House Ways and

2 Means Committee on accomplishments of the Career Counseling Specialists. Of the funds appropriated in the prior fiscal year,

3 unexpended funds may be carried forward to the current fiscal year and expended for the same purposes.

4 1A.6. (SDE-EIA: CHE/Teacher Recruitment) Of the funds appropriated in Part IA, Section 1, VIII.E. for the Teacher 5 Recruitment Program, the South Carolina Commission on Higher Education shall distribute a total of ninety-two percent to the Center 6 for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) for a state teacher recruitment program, of which 7 at least seventy-eight percent must be used for the Teaching Fellows Program specifically to provide scholarships for future teachers, 8 and of which twenty-two percent must be used for other aspects of the state teacher recruitment program, including the Teacher Cadet Program and \$166,302 which must be used for specific programs to recruit minority teachers: and shall distribute eight percent 9 to South Carolina State University to be used only for the operation of a minority teacher recruitment program and therefore shall 10 not be used for the operation of their established general education programs. Working with districts with an absolute rating of At-11 Risk or Below Average, CERRA will provide shared initiatives to recruit and retain teachers to schools in these districts. CERRA 12 will report annually by October first to the Education Oversight Committee and the Department of Education on the success of the 13 recruitment and retention efforts in these schools. The South Carolina Commission on Higher Education shall ensure that all funds 14 are used to promote teacher recruitment on a statewide basis, shall ensure the continued coordination of efforts among the three 15 teacher recruitment projects, shall review the use of funds and shall have prior program and budget approval. The South Carolina 16 State University program, in consultation with the Commission on Higher Education, shall extend beyond the geographic area it 17 currently serves. Annually, the Commission on Higher Education shall evaluate the effectiveness of each of the teacher recruitment 18 projects and shall report its findings and its program and budget recommendations to the House and Senate Education Committees, 19 the State Board of Education and the Education Oversight Committee by October first annually, in a format agreed upon by the 20 Education Oversight Committee and the Department of Education. 21 22 With the funds appropriated CERRA shall also appoint and maintain the South Carolina Teacher Loan Advisory Committee. The 23 Committee shall be composed of one member representing each of the following: (1) Commission on Higher Education; (2) State 24 Board of Education; (3) Education Oversight Committee; (4) Center for Educator Recruitment, Retention, and Advancement; (5)

Board of Education, (3) Education Oversignt Committee, (4) Center for Educator Recruitment, Retention, and Advancement; (5)
 South Carolina Student Loan Corporation; (6) South Carolina Association of Student Financial Aid Administrators; (7) a local school

district human resources officer; (8) a public higher education institution with an approved teacher education program; and (9) a

27 private higher education institution with an approved teacher education program. The members of the committee representing the

28 public and private higher education institutions shall rotate among those intuitions and shall serve a two-year term on the committee.

29 The committee must be staffed by CERRA, and shall meet at least twice annually. The committee's responsibilities are limited to:

30 (1) establishing goals for the Teacher Loan Program; (2) facilitating communication among the cooperating agencies; (3) advocating

31 for program participants; and (4) recommending policies and procedures necessary to promote and maintain the program.

1A.7. (SDE-EIA: Disbursements/Other Entities) Notwithstanding the provisions of Sections 2-7-66 and 11-3-50, South
 Carolina Code of Laws, it is the intent of the General Assembly that funds appropriated in Part IA, Section 1, VIII.E. Other State

34 Agencies and Entities shall be disbursed on a quarterly basis by the Department of Revenue directly to the state agencies and entities

35 referenced except for the Teacher Loan Program, Centers of Excellence, the Education Oversight Committee and School Technology,

36 which shall receive their full appropriation at the start of the fiscal year from available revenue. The Comptroller General's Office

is authorized to make necessary appropriation reductions in Part IA, Section 1, VIII.E. to prevent duplicate appropriations. If the 1 2 Education Improvement Act appropriations in the agency and entity respective sections of the General Appropriations Act at the start of the fiscal year do not agree with the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities, the "other 3 4 funds" appropriations in the respective agency and entity sections of the General Appropriations Act will be adjusted by the 5 Comptroller General's Office to conform to the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities. Further, the Department of Revenue is directed to provide the full appropriation of the funding appropriated in Part IA, Section 1, 6 7 VIII.C.2. Teacher Supplies to the Department of Education at the start of the fiscal year from available revenue. The Department of Revenue is also directed to provide the first quarter appropriation of the funding appropriated in Part IA, Section 1, VIII.G. Charter 8 School District to the Department of Education at the start of the fiscal year from available revenue. 9 **1A.8.** (SDE-EIA: Arts in Education) Funds appropriated in Part IA, Section 1, VIII.A.1. Arts Curricula shall be used to support 10 innovative practices in arts education curriculum, instruction, and assessment in the visual and performing arts including dance, 11 12 music, theatre, and visual arts which incorporates strengths from the Arts in Education sites. They shall also be used to support the advancement of the implementation of the visual and performing arts academic standards. These funds shall be distributed to schools 13 and school districts under a competitive grants program; however, up to thirty-three percent of the total amount of the grant fund 14 shall be made available as "Aid to Other Agencies" to facilitate the funding of professional development arts institutes that have been 15 approved by the State Department of Education for South Carolina arts teachers, appropriate classroom teachers, and administrators. 16 Arts Curricular Grants funds may be retained and carried forward into the current fiscal year to be expended in accordance with the 17 proposed award. 18 1A.9. (SDE-EIA: Teacher Supplies) All certified and non-certified public school teachers identified in PCS, certified special 19 school classroom teachers, certified media specialists, and certified guidance counselors, and career specialists who are employed 20 by a school district, or a charter school, or lead teachers employed in a publically funded full day 4K classroom approved by the 21 South Carolina First Steps to School Readiness, as of November thirtieth of the current fiscal year, based on the public decision of 22 23 the school board may receive reimbursement of up to two hundred seventy-five dollars each school year to offset expenses incurred 24 by them for teaching supplies and materials. Funds shall be disbursed by the department to School districts by July fifteenth based 25 on the last reconciled Professional Certified Staff (PCS) listing from the previous year. With remaining funds for this program, any deviation in the PCS and actual teacher count will be reconciled by December thirty-first or as soon as practicable thereafter. Based 26 27 on the public decision of the school district these funds shall be disbursed to each teacher via check in a manner separate and distinct 28 from their payroll check on the first day teachers, by contract, are required to be in attendance at school for the current contract year. 29 Upon request of the teacher, a school district must give the teacher the option of being reimbursed by a debit card. This reimbursement shall not be considered by the state as taxable income. Special schools include the Governor's School for Science 30 31 and Math, the Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe School, School

32 for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice, and Palmetto Unified School District. Funds distributed to

33 school districts or allocated to schools must not supplant existing supply money paid to teachers from other sources. If a school 34 district requires receipts for tax purposes the receipts may not be required before December thirty-first. Districts that do not wish to

require receipts may have teachers retain the receipts and certify for the district they have received the allocation for purchase of

teaching supplies and/or materials and that they have purchased or will purchase supplies and/or materials during the fiscal year for

the amount of the allocation. Districts shall not have an audit exception related to non-retention of receipts in any instances where a 1 2 similar instrument is utilized. Any district requiring receipts must notify any teacher from whom receipts have not been submitted between November twenty-fifth and December sixth that receipts must be submitted to the district. Districts may not add any 3 4 additional requirement not listed herein related to this reimbursement. Any classroom teacher, including a classroom teacher at a South Carolina private school, that is not eligible for the reimbursement 5 allowed by this provision, may claim a refundable income tax credit on the teacher's 2015 2016 tax return, provided that the return 6 7 or any amended return claiming the credit is filed prior to the end of the fiscal year. The credit is equal to two hundred seventy-five 8 dollars, or the amount the teacher expends on teacher supplies and materials, whichever is less. If any expenditures eligible for a credit are made after December thirty-first, the teacher may include the expenditures on his initial return or may file an amended 9 2015 2016 return claiming the credit, so long as the return or amended return is filed in this fiscal year. The Department of Revenue 10 may require whatever proof it deems necessary to implement the credit provided by this part of this provision. Any person receiving 11 the reimbursement provided by this proviso is ineligible to take the income tax credit allowed by this proviso. 12 1A.10. (SDE-EIA: Teacher of the Year Awards) Of the funds provided herein for Teacher of the Year Awards, each district 13 Teacher of the Year shall receive an award of \$1,000. In addition, the State Teacher of the Year shall receive an award of \$25,000, 14 and each of the four Honor Roll Teachers of the Year will receive an award of \$10,000. To be eligible, districts must participate in 15 the State Teacher of the Year Program sponsored by the State Department of Education. These awards shall not be subject to South 16 17 Carolina income taxes. 1A.11. (SDE-EIA: EOC) The Education Oversight Committee may collect, retain and expend revenue from conference 18 registration and fees; charges for materials supplied to local school districts or other entities not otherwise mandated to be provided 19 by state law; and from other activities or functions sponsored by the committee including public awareness campaign activities. Any 20 unexpended revenue from these sources may be carried forward into the current fiscal year and expended for the same purposes. 21 **1A.12.** (SDE-EIA: Technical Assistance) In order to best meet the needs of underperforming schools, funds appropriated for 22 23 technical assistance must be used to provide intensive support to schools and districts with an absolute rating of below average or at-24 risk on the most recent annual school report card or with the lowest percentages of students meeting state standards on state assessments on the most recent state assessments or with the lowest high school graduation rates must be allocated according to the 25 26 severity of not meeting report card criteria. The department will create a system of tiers of technical assistance for low-performing schools and districts that will receive technical assistance. The tiers will be determined by factors that include, but are not limited 27 to, length of time performance of the school or district has been at-risk/below average, annual achievement ratings, annual growth 28 29 ratings, school or district accreditation, and/or financial risk status. The tiers of technical assistance may include a per student allocation, placement of a principal mentor, transformation coach, instructional leader, replacement of the principal, reconstitution 30 of a school, and declaration of a state of emergency. Low-performing schools and districts shall be placed within the tiered technical 31 assistance framework not later than December 15. 32 Schools receiving an absolute rating of below average or at risk Low-performing schools shall receive a diagnostic review through 33 34 the department. In addition, newly identified low-performing schools and districts must be reviewed by an External Review Team in the year of designation, and every third year thereafter. These reports shall be made available on the Department of Education's 35 website; any information pertaining to personnel matters or containing personally identifiable information shall be exempted. Based 36

1 upon the recommendations in the review(s), low-performing schools and districts must develop and submit to the Department of 2 Education an updated school renewal or district strategic plan outlining goals for improvements. The amended plans must address specific strategies designed to increase student achievement and must include measures to evaluate the success of implementation 3 4 of the plan. Of the technical assistance funds allocated to below average or at-risk schools each allocation must address specific 5 strategies designed to increase student achievement and must include measures to evaluate success. The school renewal plan may include expenditures for recruitment incentives for faculty and staff, performance incentives for faculty and staff, assistance with 6 7 curriculum and test score analysis, professional development activities based on curriculum and test score analysis that may include 8 daily stipends if delivered on days outside of required contract days. School expenditures of technical assistance shall be monitored 9 by the Department of Education. 10 With the funds appropriated to the Department of Education, and any experts placed in the school or district for technical assistance services, the department will assist low-performing schools and districts with an absolute rating of below average or at-risk in 11 designing and implementing technical assistance school renewal the strategies and measurement identified in the amended plans and 12 in brokering for technical assistance personnel as needed and as stipulated in the plan. In addition, the department must monitor 13 student academic achievement and progress on implementation the expenditure of technical assistance funds in schools receiving 14 15 these funds and report their findings to the General Assembly and the Education Oversight Committee by January first of each fiscal year as the General Assembly may direct Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means 16 Committee, the Chairman of the Senate Education Committee, the Chairman of the House Education and Public Works Committee, 17 the local legislative delegation, and the Governor in the fall following the school or district designation as low-performing. If the 18 Education Oversight Committee or the department requests information from schools or school districts regarding the expenditure 19 of technical assistance funds pursuant to evaluations, the school or school district must provide the evaluation information necessary 20 to determine effective use. If the school or school district does not provide the evaluation information necessary to determine 21 effective use, the principal of the school or the district superintendent may be subject to receiving a public reprimand by the State 22 23 Board of Education if it is determined that those individuals are responsible for the failure to provide the required information. 24 No more than five percent of the total amount appropriated for technical assistance services to schools with an absolute rating of 25 below average or at risk may be retained and expended Funds must be used by the department for implementation and delivery of technical assistance services. Using previous report card data and monitoring reports on the status of implementation of the school 26 renewal plan, the department shall identify priority schools. Up to \$6,000,000 of the total funds Funds appropriated for technical 27 28 assistance shall be used by the department to work with those schools identified as *low-performing and to support* priority schools 29 under the tiered system. These funds shall not be transferred to any other funding category by the school district without prior 30 approval of the State Superintendent of Education and funds are not subject to agency flexibility provisions. The department will create a system of levels of technical assistance for schools that will receive technical assistance funds. The 31 levels will be determined by the severity of not meeting report card criteria. The levels of technical assistance may include a per 32 student allocation, placement of a principal mentor, replacement of the principal, and/or reconstitution of a school. 33 34 Reconstitution means the redesign or reorganization of the school, which includes may include the declaration that all positions in the school are considered vacant. Certified staff currently employed in priority schools must undergo a formal an evaluation in the 35

36 spring following the school's identification as a priority school and must meet determined goals to be rehired and continue their

employment at that school. Student achievement will be considered as a significant factor when determining whether to rehire 1 2 existing staff. Educators who were employed at a school that is being reconstituted prior to the effective date of this proviso July 2009 and to whom the employment and dismissal laws apply will not lose their rights in the reconstitution. If they are not rehired or 3 4 are not assigned to another school in the school district they have the opportunity for a hearing. However, employment and dismissal 5 laws shall not apply to educators who are employed in the district and assigned to the priority schools after the effective date of this 6 proviso July 1, 2009, in the event of a reconstitution of the school in which the educator is employed. Those rights are only suspended in the event of a reconstitution of the entire school staff. Additionally, the rights and requirements of the employment and dismissal 7 8 laws do not apply to educators who are currently on July 1, 2009 were on an induction or annual contract, that subsequently are were offered continuing contract status after the effective date of this proviso, and are employed at a school that is subject to reconstitution 9 10 under this proviso. The reconstitution of a school could take place if the school has been identified as a priority school that has failed to improve 11 satisfactorily. The decision to reconstitute a school shall be made by the State Superintendent of Education in consultation with the 12 principal and/or principal mentor, the school board of trustees, and the district superintendent. The decision to reconstitute a school 13 shall be made by April first, at which time notice shall be given to all employees of the school. The department, in consultation with 14 15 the principal and district superintendent, shall develop a staffing plan, recruitment and performance bonuses, and a budget for each reconstituted school. 16 The State Superintendent of Education may declare a state of emergency in a district if the accreditation status is probation or 17 denied, if a majority of the schools fail to show improvement, if the district is classified as being in "high risk" status financially, or 18 for financial mismanagement resulting in a deficit. The State Superintendent of Education may declare a state of emergency in a 19 school if the accreditation status is probation or denied, or if the school fails to show improvement. Upon declaration of a state of 20 emergency, the Superintendent may take over management of the school or district. Management of the school or district may 21 include direct management, consolidation with another district, charter management, public/private management, or contracting 22 with an educational management organization or another school district. 23 Upon approval of the school renewal plans by the department and the State Board of Education, a newly identified school or a 24 currently identified school with an absolute rating of below average or at-risk on the report card will receive a base amount and a per 25 pupil allocation based on the previous year's average daily membership as determined by the annual budget appropriation. No more 26 than fifteen percent of funds not expended in the prior fiscal year may be carried forward and expended in the current fiscal year for 27 28 strategies outlined in the school's renewal plan. Schools must use technical assistance funds to augment or increase, not to replace or supplant local or state revenues that would have been used if the technical assistance funds had not been available. Schools must 29 30 use technical assistance funds only to supplement, and to the extent practical, increase the level of funds available from other revenue 31 sources. 1A.13. (SDE-EIA: Proviso Allocations) In the event an official EIA revenue shortfall is declared by the Board of Economic 32 Advisors, the Department of Education may reduce any allocation in Section 1A specifically designated by proviso in accordance 33 34 with the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office. No allocation for teacher

35 salaries shall be reduced as a result of this proviso.

1A.14. (SDE-EIA: School Districts and Special Schools Flexibility) All school districts and special schools of this State may 1 2 transfer and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery Act funds, and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, 3 4 to ensure the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated 5 specifically for state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance 6 of effort requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for 7 Career and Technology Education, nor required for debt service or bonded indebtedness. All school districts and special schools of this State may suspend professional staffing ratios and expenditure regulations and guidelines at the sub-function and service area 8 level, except for four-year old programs and programs serving students with disabilities who have Individualized Education 9 10 Programs. In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per 11 pupil expenditures must be utilized within the Insite categories of instruction, instructional support, and only transportation, food 12 service, and safety within non-instruction pupil services. No portion of the seventy-five percent may be used for facilities, business 13 services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall 14 report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional 15 support, and only transportation, food service, and safety within non-instruction pupil services for the current school year ending 16 June thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures. 17 "In\$ite" means the financial analysis model for education programs utilized by the Department of Education. 18 School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low 19 enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and 20 21 memberships, reducing transportation costs for extracurricular and academic competitions, restructuring administrative staffing, and 22 expanding virtual instruction. 23 School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year. 24 Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 25 allocation due to them for each categorical program. 26 Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school 27 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken. 28 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State 29

Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education 30

31 and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting,

and the certification must be conspicuously posted on the internet website maintained by the school district. 32

For the current fiscal year, Section 59-21-1030 is suspended. Formative assessments for grades one, two, and nine, the foreign 33 language program assessment, and the physical education assessment must be suspended. School districts and the Department of

34

35 Education are granted permission to purchase the most economical type of bus fuel.

1 For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school

2 districts based on weighted pupil units.

School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars,
 from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made
 available for public viewing and downloading. The register must include for each expenditure:

(i) the transaction amount;

(ii) the name of the payee; and

(iii) a statement providing a detailed description of the expenditure.

9 The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must 10 not include any information that can be used to identify an individual employee. The register must be accompanied by a complete 11 explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at 12 least once a month.

Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the thirtieth day after the first date that any portion of the balance due as shown on the statement is paid.

The Comptroller General must establish and maintain a website to contain the information required by this section from a school district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate

19 between the school districts and search for the information they are seeking.

20 School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller 21 General in a manner and at a time determined by the Comptroller General to be included on the internet website.

The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 30, the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of Education to exercise its authority to grant waivers under Regulation 43-261.

1A.15. (SDE-EIA: Teacher Salary Supplement) The department is directed to carry forward prior year unobligated teacher salary supplement and related employer contribution funds into the current fiscal year to be used for the same purpose. Any unexpended funds in teacher salary supplement may be used to fund shortfalls in the associated employer contribution funding in the current fiscal year.

1A.16. (SDE-EIA: Dropout Prevention and High Schools That Work Programs) The Department of Education must report annually by December first, to the Governor, the Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means Committee, the Chairman of the Senate Education Committee, and the Chairman of the House Education and Public Works Committee on the effectiveness of dropout prevention programs funded by the Education and Economic Development Act and on

33 the High Schools that Work Programs' progress and effectiveness in providing a better prepared workforce and student success in

34 post-secondary education. The department, school districts, and special schools may carry forward unexpended funds from the prior

35 fiscal year into the current fiscal that were allocated for High Schools That Work.

1A.17. (SDE-EIA: Assessment) The department is authorized to carry forward into the current fiscal year, prior year state 1 2 assessment funds for the same purpose. Reimbursements shall resume in the current fiscal year for PSAT pre-ACT or 10th grade 3 Aspire. 4 1A.18. (SDE-EIA: Report Card Information) The percentage each school district expended on classroom instruction as defined 5 by the Department of Education's In\$ite classification for "Instruction" must be printed on the Annual School and District Report 6 Card. 7 **1A.19.** (SDE-EIA: Core Curriculum Materials) The funds appropriated in Part IA, Section 1, VIII.A.3 for instructional materials 8 for core curriculum shall be expended consistent with the requirements of Section 59-31-600 of the 1976 Code requiring the development of higher order thinking skills and critical thinking which should be integrated throughout the core curriculum 9 instructional materials. Furthermore, the evaluation criteria used to select instructional materials with funds appropriated in Part IA, 10 Section 1, VIII.A.3 shall include a weight of up to ten percent of the overall criteria to the development of higher order thinking skills 11 12 and critical thinking. **1A.20.** (SDE-EIA: Certified Staff Technology Proficiency) To ensure the effective and efficient use of the funding provided by 13 the General Assembly in Part IA, Section 1 VIII.D. for school technology in the classroom and internet access, the State Department 14 of Education shall approve district technology plans that specifically address and incorporate certified staff technology competency 15 standards and local school districts must require certified staff to demonstrate proficiency in these standards as part of each certified 16 staff's Professional Development plan. The Department of Education's professional development tracking, prescriptive and 17 electronic portfolio system for certified staff is the preferred method for demonstrating technology proficiency as this system is 18 District adopted technology proficiency standards and plans should be, at minimum, aligned to the International Society for 19 Technology in Education (ISTE) teacher standards. Evidence that districts are meeting the requirement is a prerequisite to 20 expenditure of a district's technology funds. 21 1A.21. (SDE-EIA: Accountability Program Implementation) To support implementation of the accountability program, the 22 23 Education Oversight Committee may carry forward unexpended Education Accountability Act funds authorized specifically for the administration of the Education Oversight Committee. For the current fiscal year the Education Oversight Committee may carry 24 25 forward prior year EIA South Carolina Community Block Grants for Education Pilot Program funds not awarded by the grant 26 committee. These funds must be used for an independent common evaluation of each awarded grant to ensure high quality programs 27 that maximize a return on the state's investment. 1A.22. (SDE-EIA: 4K Targeting) EIA funds allocated for the provision of four-year-old kindergarten shall be utilized for the 28 provision of services to age-eligible children qualifying for free or reduced-price lunch or Medicaid. Children with developmental 29 delays documented through state approved screening assessments or children with medically documented disabilities who do not 30 31 already qualify for special need services should also be considered for enrollment. In the event that more students seek to enroll than available space permits, districts shall prioritize students (at the time of acceptance) on the basis of family income expressed as a 32 percentage of the federal poverty guidelines, with the lowest family incomes given the highest enrollment priority. 33

34 **1A.23.** (SDE-EIA: Reading) Of the funds appropriated for reading/literacy, the Department of Education, schools, and districts 35 shall ensure that resources are utilized to improve student achievement in reading/literacy. To focus on the importance of early 36 reading and writing skills and to ensure that all students acquire reading/literacy skills by the end of grade three, fifty percent of the

appropriation shall be directed toward acquisition of reading proficiency to include, but not be limited to, strategies in phonemic 1 2 awareness, phonics, fluency, vocabulary, and comprehension. Forty percent of the appropriation shall be directed toward classroom instruction and intervention to focus on struggling readers and writers in grades four through eight. Ten percent of the appropriation 3 4 should be directed toward acceleration to provide additional opportunities for deepening and refinement of literacy skills. 5 Fifty percent of the funds shall be allocated to school districts based on the number of weighted pupil units in each school district in proportion to the statewide weighted pupil units using the one hundred thirty-five day count of the prior school year. Fifty percent 6 7 of the funds shall be allocated to the Department of Education to provide districts with research-based strategies and professional 8 development and to work directly with schools and districts to assist with implementation of research-based strategies. When 9 providing professional development the department and school districts must use the most cost effective method and when able utilize ETV to provide such services throughout the state. The department shall provide for an evaluation to review first year 10 implementation activities and to establish measurements for monitoring impact on student achievement. 11 12 1A.24. (SDE-EIA: Students at Risk of School Failure) For the current fiscal year, EIA funds appropriated for students at academic risk of school failure, which include funds for Act 135 Academic Assistance, summer school, reduce class size, alternative schools, 13 parent support and family literacy, must be allocated to school districts based two factors: (1) the poverty index of the district as 14 15 documented on the most recent district report card, which measures student eligibility for the free or reduced price lunch program and Medicaid as determined for the poverty add on weight in Proviso 1.3; and (2) the number of students not in poverty or eligible 16 for Medicaid but who fail to meet state standards on state standards based assessments in either reading or mathematics weighted 17 pupil units identified in the prior fiscal year as in need of academic assistance. At least eighty-five percent of the funds allocated for 18 students classified as at academic risk must be spent on instruction and instructional support for these students who generated the 19 funds. Instructional support may include family literacy and parenting programs to students at-risk for school failure and their 20 families. Students at academic risk are defined as students who are at risk of not graduating from high school because they failed 21 either the English language arts or mathematics portion of the High School Assessment Program on first attempt and who score not 22 23 met on grades three through eight in reading and mathematics state assessments. Public charter schools, the Palmetto Unified School 24 District, and the Department of Juvenile Justice must also receive a proportionate per pupil allocation based on the number of students 25 at academic risk of school failure served. **1A.25.** (SDE-EIA: Professional Development) Of the funds appropriated for professional development, up to \$500,000 may be 26 expended for gifted and talented teacher endorsement and certification activities. The balance of EIA funds appropriated for 27 28 professional development must be allocated to districts based on the number of weighted pupil units in each school district in 29 proportion to the statewide weighted pupil units using the one hundred thirty-five day count of the prior school year. The funds must be expended on professional development for certificated instructional and instructional leadership personnel in grades kindergarten 30 31 through twelve across all content areas, including teaching in and through the arts. No more than twenty-five percent of the funds appropriated for professional development may be retained by the Department of Education for the administration and provision of 32

other professional development services which must be targeted to districts who are or were the original trial and plaintiff school 33

34 districts in the Abbeville law suit to increase the capacity of educators and leaders in those districts. The Department of Education

must provide professional development on assessing student mastery of the content standards through classroom, formative and end-35 36

of-year assessments. The Department of Education also must post on the agency's website the South Carolina Professional

Development Standards and provide training through telecommunication methods to school leadership on the professional 1 2 development standards. The department is authorized to carry forward and expend professional development funds for the same 3 purpose. 4 **1A.26.** (SDE-EIA: Assessments-Gifted & Talented, Advanced Placement, & International Baccalaureate Exams) Of the funds 5 appropriated and/or authorized for assessment, up to $\frac{44,600,000}{55,400,000}$ shall be used for assessments to determine eligibility of students for gifted and talented programs and for the cost of Advanced Placement and International Baccalaureate exams. 6 7 1A.27. (SDE-EIA: Adult Education) A minimum of thirty percent of the funds appropriated for adult education must be allocated 8 to school districts to serve adult education students between the ages of seventeen and twenty-one who are enrolled in programs leading to a state high school diploma, state high school equivalency diploma (GED), or career readiness certificate (WorkKeys). 9 The remaining funds will be allocated to districts based on a formula which includes factors such as target populations without a 10 high school credential, program enrollment the previous school year, number of students making an educational gain the previous 11 school year, and performance factors such as number of high school credentials and career readiness certificates awarded the previous 12 school year. Overall levels of state funding must meet the federal requirement of state maintenance of effort. Each school district 13 must collect information from both the student and the school including why the student has enrolled in Adult Education and whether 14 15 or not the student is pursuing a GED or Diploma. The school district must then provide a quarterly report to the Department of Education and must include the unique student identifier. The department, in turn, will provide summary information to the House 16 Ways and Means Committee, the House Education and Public Works Committee, the Senate Finance Committee and the Senate 17 Education Committee on the information. Up to a maximum of \$300,000, of funds may be used to establish an initiative by which 18 qualifying adult education students may qualify for a free high school equivalency test. The Department of Education shall establish 19 guidelines for the free high school equivalency testing initiative. 20 1A.28. (SDE-EIA: Clemson Agriculture Education Teachers) The funds appropriated in Part IA, Section VIII.E. for Clemson 21 Agriculture Education Teachers must be transferred to Clemson University PSA to fund summer employment of agriculture teachers 22 23 and to cover state-mandated salary increases on that portion of the agriculture teachers' salaries attributable to summer employment. 24 If sufficient funds remain, Clemson University PSA may utilize such funds for a Regional Coordinator. 1A.29. (SDE-EIA: Incentive for National Board Certification After June 30, 2010) Public school classroom teachers to include 25 teachers employed at the special schools or classroom teachers who work with classroom teachers to include teachers employed at 26 27 the special schools who are certified by the State Board of Education and who complete the application process on or after July 1, 28 2010 shall be paid a \$5,000 salary supplement in the year of achieving certification. The special schools include the Governor's School for Science and Math, Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe 29 School, School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice and Palmetto Unified School District 1. The 30 31 \$5,000 salary supplement shall be added to the annual pay of the teacher, not to exceed ten years of the national certificate. However, the \$5,000 supplement shall be adjusted on a pro rata basis for the teacher's FTE and paid to the teacher in accordance with the 32 district's payroll procedure. The Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) shall 33 34 administer whereby teachers who are United States citizens or permanent resident aliens apply to the National Board for Professional Teaching Standards for certification on or after July 1, 2010. Should the program not be suspended, up to nine hundred applications 35 shall be processed annually. Of the funds appropriated in Part IA, Section 1, VIII.C.2. for National Board Certification, the 36

1 Department of Education shall transfer to the Center for Educator Recruitment, Retention, and Advancement (CERRA-South

Carolina) the funds necessary for the administration of teachers applying to the National Board for Professional Teaching Standards
 for certification.

4 **1A.30.** (SDE-EIA: Full-Day 4K) For the current school year, eligible *Eligible* students residing in a school district with a poverty 5 index of seventy percent or greater may participate that met the poverty level for participation in the prior school year are eligible to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and 6 7 private providers will be reimbursed for instructional costs at a rate of $\frac{4.218}{34.323}$ per student enrolled. Eligible students enrolling 8 during the school year or withdrawing during the school year shall be funded on a pro rata basis determined by the length of their enrollment. Private providers transporting eligible children to and from school shall also be eligible for a reimbursement of \$550 9 per eligible child transported. All providers who are reimbursed are required to retain records as required by their fiscal agent. New 10 providers participating for the first time in the current fiscal year and enrolling between one and six eligible children shall be eligible 11 to receive up to \$1,000 per child in materials and equipment funding, with providers enrolling seven or more such children eligible 12 for funding not to exceed \$10,000. Providers receiving equipment funding are expected to participate in the program and provide 13 high-quality, center-based programs as defined herein for a minimum of three years. Failure to participate for three years will require 14 the provider to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of 15 First Steps to School Readiness. Funding to providers is contingent upon receipt of data as requested by the Department of Education 16 17 and the Office of First Steps. Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 18

the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 19 fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 20 public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 21 program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 22 23 Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day four-year-24 old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and maintenance of 25 data on the state funded programs provided through private providers. The Education Oversight Committee shall use this data and 26 27 all other collected and maintained data necessary to conduct a research based review of the program's implementation and assessment 28 of student success in the early elementary grades.

1A.31. (SDE-EIA: Aid to Districts) Funds appropriated in Part IA, Section 1, VIII.A.1. Aid to Districts shall be dispersed to school districts based on the number of weighted pupil units.

31 1A.32. (SDE-EIA: Centers of Excellence) Of the funds appropriated for Centers of Excellence, \$350,000 must be allocated to the 32 Francis Marion University Center of Excellence to Prepare Teachers of Children of Poverty to expand statewide training for 33 individuals who teach children of poverty through weekend college, nontraditional or alternative learning opportunities.

1A.33. (SDE-EIA: IDEA Maintenance of Effort) Prior to the dispersal of funds appropriated in Section VIII.A.1. Aid to Districts according to Proviso 1A.31 for the current fiscal year, the department shall direct funds appropriated in Section VIII.A.1. Aid To

36 Districts to school districts and special schools for supplemental support of programs and services for students with disabilities, to

meet the estimated maintenance of effort for IDEA or to resolve pending litigation concerning the IDEA maintenance of effort. 1 2 Funds provided for the maintenance of effort for IDEA these purposes may not be transferred to any other purpose and therefore are not subject to flexibility. The department shall distribute these funds using the current fiscal year one hundred thirty-five day Average 3 Daily Membership or as directed in any litigation settlement agreement. For continued compliance with the federal maintenance of 4 efforts requirements of the IDEA, funding for children with disabilities must, to the extent practicable, be held harmless to budget 5 6 cuts or reductions to the extent those funds are required to meet federal maintenance of effort requirements under the IDEA. In the 7 event cuts to funds that are needed to maintain fiscal effort are necessary, when administering such cuts, the department must not 8 reduce funding to support children with disabilities who qualify for services under the IDEA in a manner that is disproportionate to the level of overall reduction to state programs in general. By December 1, 2015 2016, the department must submit an estimate of 9 the IDEA MOE requirement to the General Assembly and the Governor. For the current fiscal year, the department may carry 10 forward IDEA Maintenance of Effort funds from the prior fiscal year and expend them in the same manner. 11 1A.34. (SDE-EIA: Career Cluster Industry Partnerships) From the funds appropriated to the Department of Education, \$800,000 12 must be provided as direct grants to the private sector statewide trade association or educational foundation providing nationally 13 certified programs in career and technology education representing the automotive, construction, engineering, healthcare, mechanical 14 15 contracting/construction, and hospitality tourism career clusters. Organizations applying for a grant must do so by July first 31st and the Department of Education must award a minimum of one grant of at least \$150,000 in at least four of these specified career clusters 16 to be used exclusively for career and technology education. The recipient industry organization must conduct end-of-course exams 17 graded by a national industry organization and must include in their grant request how the money will be spent in direct support of 18 students to further industry-specific career technology education; a description and history of their program nationally and within 19 South Carolina; estimates of future employment growth in their industry; and the national scope of their program. By August first 20 of the following year, the organization must submit to the department a report detailing how the grant increased industry/employer 21 awareness; the number of increased schools using the industry-based curriculum and partnered with the industry organization; the 22 23 increased number of students in the program; and an overview and analysis of the organization's statewide student competition. The 24 grant must be used for career awareness programs for that industry cluster; statewide student competitions leading to national 25 competitions; teacher development and training; post-secondary scholarships in industry-specific degree programs; student recruitment into that career cluster programs; programs to educate middle and high school Career or Guidance Counselors about the 26 27 industry; service to disadvantaged youth; and administering business/employer awareness and partnerships which help lead to 28 experience-based, career-oriented experiences including internships, apprenticeships, mentoring, co-op education and service learning. The Office of Career and Technology Education of the department will develop goals with each career cluster on the 29 30 number of new schools using the industry-based curriculum and partnered with that career cluster organization. These funds may 31 not be used to supplant or replace, in whole or in part, other existing resources/assets sourced outside the present grant being used to provide the same services or programs. Organizations may carry-over grants for up to three years when a large project is identified 32 in the grant application to be used at a future date; otherwise excess funds must be returned to the state. Organizations awarded must 33 34 submit a semi-annual programmatic and financial report on the last day of December in addition to the final report due August first that has been audited by a third party accounting firm. 35

1A.35. (SDE-EIA: Partnerships/Other Agencies & Entities) For the current fiscal year, agencies and other entities receiving funds 1 2 appropriated in Part IA, Section 1, VIII.E. will continue to report annually to the Education Oversight Committee (EOC). Any entity receiving funds that must flow through a state agency will receive those funds through the EOC. The EOC will make funding 3 4 recommendations to the Governor and General Assembly as part of the agency's annual budget request. 5 1A.36. (SDE-EIA: ETV Teacher Training/Support) Of the funds appropriated in Part IA, Section 1, VIII.E. South Carolina Educational Television must provide training and technical support on the educational resources available to teachers and school 6 7 districts. 1A.37. (SDE-EIA: Career and Technology Education Consumables) A maximum of twenty-five percent of the funds appropriated 8 for Modernize Vocational Equipment, Career and Technology Education may be utilized to purchase textbooks, instructional 9 materials and other consumables used in classroom instruction. The department may carry forward unexpended Modernize 10 Vocational Equipment and Tech Prep funds to be used for the same purpose. 11 1A.38. (SDE-EIA: Teacher Salaries/SE Average) The projected Southeastern average teacher salary shall be the average of the 12 average teachers' salaries of the southeastern states as projected by the Revenue and Fiscal Affairs Office. For the current school 13 year the Southeastern average teacher salary is projected to be \$49,796 \$51,495. The General Assembly remains desirous of raising 14 the average teacher salary in South Carolina through incremental increases over the next few years so as to make such equivalent to 15 the national average teacher salary. 16 The statewide minimum teacher salary schedule used in Fiscal Year 2012-13 will continue to be used in Fiscal Year 2015-16 2016-17 18 17 and be increased by 2%. Additionally, for the current fiscal year, a local school district board of trustees must increase the salary compensation for all 19 eligible certified teachers employed by the district by no less than one year of experience credit using the district salary schedule 20 utilized the prior fiscal year as the basis for providing the step. Application of this provision must be applied uniformly for all eligible 21 certified teachers. 22 23 Funds appropriated in Part IA, Section 1, VIII.C.2. for Teacher Salaries must be used to increase salaries of those teachers eligible pursuant to Section 59-20-50(b), to include classroom teachers, librarians, guidance counselors, psychologists, social workers, 24 25 occupational and physical therapists, school nurses, orientation/mobility instructors, and audiologists in the school districts of the 26 state. 27 For purposes of this provision teachers shall be defined by the Department of Education using the Professional Certified Staff 28 (PCS) System. 29 1A.39. (SDE-EIA: PowerSchool Dropout Recovery Data) With the funds appropriated to the Department of Education for PowerSchool and data collection, the department will begin in the current fiscal year to collect data from schools and school districts 30 on the number of students who had previously dropped out of school and who reenrolled in a public school or adult education to 31 pursue a high school diploma. The Education Oversight Committee working with the Department of Education will determine how 32 to calculate a dropout recovery rate that will be reflected on the annual school and district report cards. 33 34 1A.40. (SDE-EIA: Assisting, Developing and Evaluating Professional Teaching - ADEPT) With funds appropriated in the current

fiscal year, the Department of Education, school districts, the Department of Juvenile Justice and special schools of the state may

36 continue implementation of the ADEPT program. Governing boards of public institutions of higher education may provide by policy

or regulation for a tuition waiver for the tuition for one three-hour course at that institution for those public school teachers who serve 1 2 as supervisors for full-time students completing education degree requirements. Unexpended funds appropriated for this purpose may be carried forward from the prior fiscal year into the current fiscal year and expended for the same purposes. 3 4 1A.41. (SDE-EIA: Assessment Preparation) From the funds appropriated in Part IA for Assessment Preparation, the Department 5 of Education shall institute a plan reviewing the strengths and weaknesses of students on national assessments such as, but not limited 6 to, the SAT, ACT, WorkKeys, GED, Advanced Placement exams, and International Baccalaureate exams. The department shall use 7 reports that analyze student strengths and weaknesses to provide guidance to local school districts. 8 **1A.42.** (SDE-EIA: National Board Certification Incentive) Public school classroom teachers to include teachers employed at the 9 special schools or classroom teachers who work with classroom teachers to include teachers employed at the special schools who are certified by the State Board of Education and who have been certified by the National Board for Professional Teaching Standards or 10 11 completed the application process prior to July 1, 2010 shall be paid a \$7,500 salary supplement beginning July first in the year 12 following the year of achieving certification, beginning with 2009 applicants. The special schools include the Governor's School for Science and Math, Governor's School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe School, 13 School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice and Palmetto Unified School District 1. The \$7,500 14 salary supplement shall be added to the annual pay of the teacher for the length of the national certificate. However, the \$7,500 15 supplement shall be adjusted on a pro rata basis for the teacher's FTE and paid to the teacher in accordance with the district's payroll 16 procedure. The Center for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) shall administer the 17 programs whereby teachers who are United States citizens or permanent resident aliens, and who applied to the National Board for 18 Professional Teaching Standards for certification prior to July 1, 2010, may receive a loan equal to the amount of the application fee. 19 Teachers who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010 shall have 20 one-half of the loan principal amount and interest forgiven when the required portfolio is submitted to the national board. Teachers 21 who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010 who attain certification 22 23 within three years of receiving the loan will have the full loan principal amount and interest forgiven. Teachers who previously submitted a portfolio to the National Board for Professional Teaching Standards for certification under previous appropriation acts, 24 25 shall receive reimbursement of their certification fee as prescribed under the provisions of the previous appropriation act. Funds collected from educators who are in default of the National Board loan shall be retained and carried forward by the department. The 26 27 department may retain up to ten percent of the funds collected to offset the administrative costs of loan collection. All other funds 28 shall be retained by the department and used for National Board loan purposes. Of the funds appropriated in Part IA, Section 1, 29 VIII.C.2. for National Board Certification, the Department of Education shall transfer to the Center for Educator Recruitment, 30 Retention, and Advancement (CERRA-South Carolina) the funds necessary for the administration of the loan program for teachers 31 who applied to the National Board for Professional Teaching Standards for certification prior to July 1, 2010. In addition, teachers who have applied prior to July 1, 2010 and are certified by the National Board for Professional Teaching Standards shall enter a 32 recertification cycle for their South Carolina certificate consistent with the recertification cycle for national board certification. 33 34 National board certified teachers who have been certified by the National Board for Professional Teaching Standards or completed 35 the application process prior to July 1, 2010 moving to this State who hold a valid standard certificate from their sending state are

exempted from initial certification requirements and are eligible for a professional teaching certificate and continuing contract status. 1

2 Their recertification cycle will be consistent with national board certification.

Provided, further, that in calculating the compensation for teacher specialists, the Department of Education shall include state and 3

4 local compensation as defined in Section 59-18-1530 to include local supplements except local supplements for National Board

5 certification. Teacher specialists remain eligible for state supplement for National Board certification.

The incentives and implementation shall be developed in consultation with the State Department of 16 Education and the Education Oversight Committee, and shall provide incentive options for eligible individuals at all stages of their 17 careers, including high-school and college or university students interested in entering the teaching profession and including 18 individuals entering the field through an alternative certification pathway to include, but not limited to. PACE, ABCTE. Teach for 19 American and CATE Work-Based Certification. 20 21 At a minimum, the incentives shall include: (1) South Carolina Teachers Loan forgiveness at a rate of one year for every two years of service as a teacher in an eligible 22 district, unless otherwise eligible for a greater forgiveness rate under the guidelines of the South Carolina Teachers Loan Program. 23 24 (2) Development of a program for forgiveness of undergraduate student loans, not to exceed \$5,000 per year, for up to 7 years, for teachers participating in this incentive that achieve certification through an alternative pathway or who have a loan from an 25 26 institution other than the South Carolina Student Loan Corporation or program other than the South Carolina Teachers Loan 27 Program. (3) Development of a forgivable loan program for individuals pursuing graduate coursework in furtherance of a teaching 28 29 career, including enrollment in graduate-level coursework necessary to seek additional credentialing or certification relevant to the participant's teaching practice, or individuals seeking an alternative pathway to certification as a teacher. 30 (4) Support for the establishment and maintenance of a teaching mentorship program, including salary supplements for 31 teaching mentors not to exceed \$2,500 per year. 32 (5) Other technical support and recruiting incentives as developed by CERRA in conjunction with the Department of Education 33 34 and the Education Oversight Committee consistent with the objectives of this section. (D) In addition to eligibility and application requirements, CERRA shall develop a process for recovering an amount equal to 35 the incentives given to individual participants who fail to comply with the obligations associated with a relevant incentive in which 36

they participate including, but not limited to, failure to complete a prescribed course of study, failure to obtain a relevant certification 1 2 or licensure upon completion of a course of study, or failure to provide instructional services in an eligible district for a prescribed 3 period of time. 4 (D E) CERRA shall report by January 15, 2016 July 31 of the current fiscal year to the Governor, President pro Tempore of the 5 Senate, and Speaker of the House on the incentives developed pursuant to item (C) of this section and make recommendations for 6 attracting and retaining high quality teachers in rural and underserved districts. The report shall contain at a minimum eligibility 7 requirements and application processes for districts and individuals, descriptions of and proposed budgets for each incentive program 8 and an analysis of the number and demographics of individuals potentially eligible for each. $(\underline{E} \underline{F})$ Funds appropriated or transferred for use in the Rural Teacher Recruiting Incentive may be carried forward from prior 9 fiscal years and used for the same purpose. 10 1A.65. (SDE-EIA: Project Read) Of the funds appropriated in Section 1A. VIII.A.3. for Reading, \$500,000 must be used for 11 12 teacher in-service training and professional development related to Project Read. The department may set accountability guidelines to ensure that funds are spent in accordance with the proviso. 13 1A.66. (SDE-EIA: Reading/Literacy Coaches) (A) Funds appropriated for Reading/Literacy Coaches must be allocated to school 14 districts by the Department of Education as follows: 15 (1) for each elementary school in which twenty percent or more of the students scored Not Met below proficient on the reading 16 and research test in the most recent year for which such data are available, the school district shall be eligible to receive the lesser of 17 either up to \$62,730 or the actual cost of salary and benefits for a full-time reading/literacy coach; and 18 (2) for each elementary school in which fewer than twenty percent of the students scored Not Met below proficient on the 19 reading and research test during the same period, the school district shall be eligible to receive the lesser of either up to \$31,365 or 20 fifty percent of the actual cost of salary and benefits for a full-time reading/literacy coach. A school district must provide local 21 support for state funds provided under this paragraph. School districts may use existing local funds currently used for reading 22 23 assistance as the local support. 24 (B) By accepting these funds, a school district warrants that they will not be used to supplant existing school district expenditures, 25 except for districts that either are currently, or in the prior fiscal year, were paying for reading/literacy coaches with local funds. A district may, however, assign a reading/literacy coach to a primary school rather than to the elementary school to improve the early 26 literacy skills of young children. 27 28 (C) Funds appropriated for Reading/Literacy Coaches are intended to be used to provide elementary schools with reading/literacy coaches, who shall serve as job-embedded, stable resources for professional development throughout schools in order to generate 29 improvement in reading and literacy instruction and student achievement who shall serve according to the provisions in Chapter 155 30 of Title 59. Reading coaches shall support and provide initial and ongoing professional development to teachers based on an analysis 31 of student assessment and the provision of differentiated instruction and intensive intervention. The reading coach shall: 32 (1) model effective instructional strategies for teachers by working weekly with students in whole, and small groups, or 33 individually: 34 35 (2) facilitate study groups; (3) train teachers in data analysis and using data to differentiated instruction; 36

(4) coaching and mentoring colleagues; 1 2 (5) work with teachers to ensure that research-based reading programs are implemented with fidelity; (6) work with all teachers (including content area and elective areas) at the school they serve, and help prioritize time for those 3 4 teachers, activities, and roles that will have the greatest impact on student achievement, namely coaching and mentoring in the 5 classrooms; 6 (7) help lead and support reading leadership teams; and. (8) The reading coach must not be assigned a regular classroom teaching assignment, must not serve an as administrator, must 7 8 not perform administrative functions that deter from the flow of improving reading instruction and reading performance of students, and must not devote a significant portion of his or her time to administering or coordinating assessments. 9 (D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve 10 as an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute 11 they must withhold that districts remaining balance of funds allocated pursuant to this proviso. 12 (DE) No later than February 1, 2016, the The Department of Education must publish guidelines that define the minimum 13 qualifications for a reading/literacy coach for Fiscal Year 2015-16. These guidelines must deem any licensed/certified teacher 14 15 qualified if, at a minimum, he or she: (1) holds a bachelor's degree or higher and an add-on endorsement for literacy coach or literacy specialist₇; or 16 (2) holds a bachelor's degree or higher and is actively pursuing the literacy coach or literacy specialist endorsement; or 17 (3) holds a master's degree or higher in reading or a closely-related field. 18 Within these guidelines, the Department of Education must also establish a process for Fiscal Year 2015-16 through which an 19 elementary school may be permitted to use some or all of the allocation granted under subsection (A) in order to obtain in-school 20 21 reading coaching services from a department-approved consultant or vendor, assist districts in identifying a reading/literacy coach 22 in the event that the school is not successful in identifying and directly employing a qualified candidate. 1 (1) any school district receiving funding under subsection (A) to identify the name and qualifications of the supported 2 reading/*literacy* coach; as well as the school in which the coach is assigned along with the rationale for how the school selection was 3 made; and

(2) any school district receiving funding under subsection ($\mathbf{F} \mathbf{G}$) to account for the specific amounts and uses of such funds.

5 (H<u>I</u>) With the data reported by the school districts, the department shall report by January fifteenth of the current fiscal year on 6 the hiring of and assignment of reading/<u>literacy</u> coaches by school and on the expenditure of professional development funds for 7 opportunities for teachers to earn the literacy endorsement. The department shall also report the amount of funds that will be earried 8 forward <u>used for Summer Reading Camps</u>.

9 (1.*J*) Funds appropriated for Reading Coaches <u>reading/literacy coaches</u> shall be retained and carried forward to be used for the 10 same purpose but may not be flexed.

11 $(J \underline{K})$ For Fiscal Year 2015-16 2016-17, if increased funding for reading/*literacy* coaches is not sufficient to provide additional 12 reading/*literacy* coaches at each elementary school then the funding must be targeted to the areas of greatest need based on the 13 number of students substantially failing to demonstrate reading proficiency as indicated on the prior year's state assessment.

1A.67. (SDE-EIA: Digital Instructional Materials) The Department of Education shall create an instructional materials list 14 15 composed of those items (print and/or digital) that have received State Board of Education approval through the normal adoption process. The department shall continue to work with the publishers of instructional materials to ensure that districts who wish to 16 receive both the digital version and class sets of textbooks may be awarded that option. Funds appropriated for the purchase of 17 textbooks and other instructional materials may be used for reimbursing school districts to offset the costs of refurbishing science 18 kits on the state-adopted textbook inventory, purchasing new kits from the central textbook depository, or a combination of 19 refurbishment and purchase. The refurbishing cost of kits may not exceed the cost of the state-adopted refurbishing kits plus a 20 reasonable amount for shipping and handling. Costs for staff development, personnel costs, equipment, or other costs associated 21 with refurbishing kits on state inventory are not allowable costs. Funds provided for Instructional Materials may be carried forward 22 23 from the prior fiscal year into the current fiscal year to be expended for the same purposes by the department, school districts, and 24 special schools. These funds are not subject to flexibility. Digital Instructional Materials shall include the digital equivalent of 25 materials and devices.

26 **1A.68.** (SDE-EIA: 4K Early Literacy Competencies Assessments) Of the funds carried forward from the full-day 4K program from the previous fiscal year, the Department of Education is authorized to expend up to \$800,000 on assessments and professional 27 development to analyze the early literacy competencies of children in publicly funded prekindergarten. The department, in 28 consultation with the Office of First Steps, will select up to three formative shall manage the administration of assessments that 29 analyze the early literacy and language development of children in publicly funded prekindergarten as done in the prior fiscal year. 30 Each school district and private provider participating in a publicly funded prekindergarten program will administer one of the 31 formative assessments selected by the department to each child eligible for and enrolled in a publicly funded prekindergarten program 32 during the first forty-five days of the school year and during the last forty-five days of the school year. Accommodations that do not 33 34 invalidate the results of these assessments must be provided in the manner set forth by the student's Individualized Education Program or 504 Accommodations Plan. School districts and private providers will be allocated \$15 per child assessed to cover the 35 cost of the formative assessment. School districts and private providers are required to report electronically the results of each 36

1 individual assessment to the department using a form that must include the unique student identifier and any other information

2 prescribed by the department. In turn, the <u>The</u> department will provide the assessment data to the Education Oversight Committee.

3 The results of the assessment and the developmental intervention strategies recommended or services needed to address the child's

identified needs must also be provided, in writing, to the parent or guardian. The assessment may not be used to deny a student to
 admission to prekindergarten.

6 Furthermore, \$2,000,000 of the funds appropriated for half-day programs for four-year-olds and funds carried forward from 7 assessment must be expended by the Department of Education to administer the Developmental Reading Assessment® 2nd Edition 8 PLUS to implement the progress monitoring system required by the Read to Succeed Act of 2014 and to evaluate the early literacy and language competencies of each child entering kindergarten in the public schools. The assessment of kindergarten students must 9 be administered at a minimum of once during the first forty-five days of the school year and once during the last forty-five days of 10 the school year with the results collected by the department. The results of the assessments and the developmental intervention 11 strategies recommended or services needed to address each child's identified needs must also be provided, in writing, to the parent 12 or guardian. The assessment may not be used to deny a student admission to kindergarten. Accommodations that do not invalidate 13

the results of these assessments must be provided in the manner set forth by the student's Individualized Education Program or 504

15 <u>Accommodations Plan.</u> Districts are given the option of designating up to two days of the one hundred eighty day school calendar 16 to administer the assessment to kindergarten students. The department will also provide the results of the assessment of kindergarten 17 students to the Education Oversight Committee. With available funds, the department will also provide or secure training for 18 appropriate educators in how to administer the assessment. In addition the department may pilot in kindergarten classes one or more 19 comprehensive readiness assessments that address the other domains in numeracy, approaches to learning, social and emotional

20 development, and physical well-being in the current school year.

21 1A.69. (SDE-EIA: Teacher Supply Study) With funds appropriated to the Center for Educator Recruitment, Retention, and Advancement (CERRA), in concert with the Commission on Higher Education, the Department of Education, and the Education 22 23 Oversight Committee, CERRA shall initiate and conduct a study to identify and project the number of additional teachers needed 24 annually in public school classrooms for grades K5 through 12, for school years beginning 2017 through 2027. The purpose of the 25 study shall be to: (1) provide specific data and projections on the number of teachers expected to be needed as compared to the number available, by Subject Areas Taught as indicated in CERRA's annual Supply and Demand Report, and with a focus on critical 26 need subject areas; (2) determine whether, individually and collectively, teaching programs at applicable institutions of higher 27 28 learning in South Carolina have the capacity and infrastructure to fulfill projected needs in item (1); and (3) provide data for general 29 use in estimating the fiscal impact of any new or revised programs being considered to incent more talented individuals to enter 30 teacher training programs and more highly qualified teachers to remain in the profession for longer periods of time.

31 1A.70. (SDE-EIA: Statewide Assessment Procurement) With the funds appropriated and carried forward for assessment, the
 32 Department of Education, in consultation with the State Board of Education and the Education Oversight Committee pursuant to

33 Section 59-18-320 of the 1976 Code, is directed to issue a procurement for a statewide assessment to students in grades 3 through 8

34 in English/language arts and mathematics that meet the requirements of the Education Accountability Act as amended by Act 200 of

35 2014. The assessment must be a rigorous, achievement assessment that measures student mastery of the SC College- and Career-

1	Ready Standards, that provides timely reporting of results to educators, parents, and students, and that measures each student's
2	progress toward college and career readiness.
3	In addition, the Department of Education, in consultation with the State Board of Education and the Education Oversight
4	Committee pursuant to Section 59-18-320, is directed to issue a procurement for a statewide assessment of students in grade 11 that
5	meets the requirements of the Education Accountability Act as amended by Act 155 of 2014. The procured assessments are to be
6	administered in school year 2015-16.
7	1A.71. (SDE-EIA: CDEPP Unexpended Funds) For Fiscal Year 2015-16 2016-17, the Office of First Steps to School Readiness
8	is directed <u>permitted</u> to retain the first \$2,000,000 <u>\$1,000,000</u> of any unexpended CDEPP funds from <u>of</u> the prior fiscal year and
9	expend these funds to enhance the quality of the full-day 4K program in private centers and provide professional development
10	opportunities.
11	By August 1, the Office of First Steps is directed to allocate any <i>additional</i> unexpended CDEPP funds from the prior fiscal year
12	and any CDEPP funds carried forward from prior fiscal years that were transferred to the restricted account for the purposes following
13	purpose: Education Oversight Committee - \$1,000,000 for the South Carolina Community Block Grants for Education Pilot
14	<u>Program.</u>
15	1. Department of Education - \$4,250,000 for full-day 4K; and
16	2. Education Oversight Committee - \$2,000,000 for the South Carolina Community Block Grants for Education Pilot Program.
17	If carry forward funds are less than the amounts appropriated, funding for the items listed herein shall be reduced on a pro rata
18	basis.
19	If any funds are remaining, they shall be transferred to the Department of Education to be expended only on full day 4K.
20	If by August 1, school districts eligible to receive full-day 4K funding opt to not participate in the program, the Department of
21	Education is authorized to utilize unexpended funds to increase participation on a per pupil basis for districts eligible for
22	participation who have a documented waiting list. The per pupil allocation and classroom grant must conform with the appropriated
23	amount contained in this Act. Funds may also be used to provide professional development and quality evaluations of programs.
24	No later than April 1, 2016 2017, the Office of First Steps must report to the Chairman of the Senate Finance Committee and the

31	experienced educators with demonstrated effectiveness in instructional leadership. Support shall include professional development,
32	standards and learning support, instructional support, data analysis and leadership development resources to ensure that educators
33	are equipped with the tools to provide students with high quality, personalized learning that supports the Profile of the South Carolina
34	Graduate. The department shall report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and
35	Means Committee on how these funds were expended.

1 14.73. (SDE-EIA: Industry Certifications/Credentials) The funds appropriated for Industry Certifications/Credentials must be 2 allocated to school districts based upon the number of national industry exams administered in the prior schoolyear. The department 3 will identify the national industry exams that will be funded based upon the job availability in the state. School districts may carry 4 forward funds from the prior fiscal year into the current fiscal year and expend the funds for the cost of national industry exams. 5 The department shall work with the Department of Commerce, the Department of Employment and Workforce, state and local 6 chambers of commerce and economic development offices and the Tech Board to ensure that students are aware of the industry 7 required credentials for current job availability in the state organized by region. 8 1A.74. (SDE-EIA: Career and Technical Equipment Funding) Funds appropriated for Modernize Career and Technical Equipment will be distributed to school districts and multi-district career centers based on the prior year actual student enrollment 9 10 for career and technology education courses, with no district or multi-district career center receiving less than \$50,000. Funds may be expended for the purchase of career and technical equipment, the up fitting of facilities and the purchase of consumables. Each 11 12 district must include in the district plan submitted to the Office of Career and Technology Education information on other career 13 and technical equipment available. The district must include, at a minimum, equipment located at the career center and at the 14 technical college, information on the alignment of equipment to current industry jobs and needs in the state as recommended by 15 career and technical program advisory committees. District plans must include charter schools within the school district offering at least one career and technical education completer program. School districts and career centers may carry forward unexpended 16 17 funds to be used for the same intended purposes to up fit career and technical facilities and replace career and technical program 18 consumables. 19 14.75. (SDE-EIA: Digital Learning) Of the funds appropriated to the Education Oversight Committee for Partnerships for 20 Innovation, \$1,600,000 will be authorized to be utilized to enter into one-vear memoranda of agreements with public and private 21 entities to pilot computer science initiatives in schools and school districts. The initiatives must focus on improving the digital 22 literacy skills of students and teachers, expanding opportunities for students to learn coding, or providing computer science 23 curriculum. To this end, at least \$1,300,000 must be authorized for schools or school districts that have poverty indices of eighty 24 percent or greater based on the poverty index utilized the prior fiscal year that was student eligibility for the free or reduced price 25 lunch program and Medicaid, or are a trial or plaintiff district in the Abbeville equity lawsuit. (SDE-EIA: South Carolina IT Academy) Of the funds appropriated for the South Carolina IT Academy, the Department of Education shall procure an IT Academy for public schools statewide in the coming school year. The IT Academy must offer 29 certification opportunities for educators to receive Teacher Certification Exams and for students to receive certifications in an office 30 31 suite of products in the middle grades and programming credentials in high school. The procurement shall include official 32 curriculum. e-learning. E-books. exams. software and lesson plans. 33 1A.77. (SDE-EIA: Family Connection South Carolina) Funds appropriated in Part IA. Section 1. VIII.E. Partnerships, for Family 34 Connection South Carolina (H63), shall be transferred in quarterly installments from the Department of Education to Family 35 Connection South Carolina. Funds shall be used to provide support to families of children with disabilities. Support shall include, 36 home visits, transition assistance, education assistance, parent support and parent training. The department shall establish

3	1A.78. (SDE-EIA: Low Achieving Schools) Of the funds appropriated to the Education Oversight Committee for Partnerships for

5	communities.
6	1A.79. (SDE-EIA: Teacher Salaries Increase) For Fiscal Year 2016-17, the Department of Education is directed to increase the
7	statewide salary schedule by two percent. A local school district board of trustees must provide all certified teachers paid on the
8	teacher salary schedule a two percent salary increase. Districts are to provide this increase using the district salary schedule utilized
9	the prior fiscal year as its base. School districts shall utilize the additional funds made available from the Teacher Salary Supplement
10	appropriation to provide one percent of the required two percent increase.
11	Additionally, for the current fiscal year, a local school district board of trustees must increase the salary compensation for all
12	eligible certified teachers employed by the district by an amount equal to a step on the salary schedule for any teacher entering the
13	<u>23rd year if the district's salary schedule does not go beyond 22 years.</u> Application of this provision must be applied uniformly for
14	all eligible certified teachers. If a school district believes it will be unable to provide the required additional step without incurring

16	For purposes of this provision teachers shall be defined by the Department of Education using the Professional Certified Staff
17	(PCS) System.
18	1A.80. (SDE-EIA: College Readiness Assessments) For the current fiscal year, with the funds appropriated for assessment, the
19	Department of Education is directed to manage the administration of the same college readiness assessment that was administered
20	in the prior fiscal year to students in grade 11. The assessment, or an alternate college readiness measure approved by the
21	department as set forth by the student's Individualized Education Program, must be administered to all students in grade 11. For
22	the purposes of administering the assessment, "eleventh grade students" is defined as students in the third year of high school after
23	their initial enrollment in the ninth grade. Valid accommodations must be provided according to the student's IEP/504 plan. If a
24	student also chooses to use the results of the college readiness assessment for post-secondary admission or placement, the student,
25	his parent, or his guardian must indicate that choice in compliance with the testing vendor's deadline to ensure that the student may

27	1A.81. (SDE-EIA: EOC Military-Connected Children) Of the funds allocated for Partnerships for Innovation, the Education
28	Oversight Committee is directed to expend \$100,000 to initiate in at least two school districts with high military density, a pilot
29	program that will provide training, services, resources and research to teachers, counselors, mental health professionals, school
30	nurses, service providers and military parents. The objective of the pilot is to increase the level of educational quality and support
31	for military-connected children. The training and services must be provided by a non-profit entity that is an NBCC-Approved
32	Continuing Education Provider and is an authorized provider by the international Association for Continuing Education and
33	Training (IACET). Pursuant to its responsibilities under Act 289 of 2014, the Education Oversight Committee will report on the
34	expenditure of these funds and post-training evaluations in its annual report on the educational performance of military-connected

1	1A.82. (SDE-EIA: STEM Labs) Of the funds appropriated for customized STEM labs, the Education Oversight Committee shall
2	work with the Department of Education, Office of Standards and Learning to solicit interested middle schools from the Abbeville
3	trial and plaintiff districts to participate in implementing a STEM based curriculum. The pilot sites will receive a customized 6th -
4	8 th grade STEM curriculum designed to address the needs of local industry. The curriculum provided will be aligned to state
5	standards and certified by ACT WorkKeys and will include hands-on, problem based student labs. The curriculum will also be
6	certified by ACT WorkKeys. Teachers in the pilot sites will receive ongoing, year-long professional development on cross curricular
7	STEM implementation that will be aligned to state standards as well and the district strategic plan.
8	1A.83. (SDE-EIA: Baby Net Financial Audit Reimbursement) For Fiscal Year 2016-17, of the funds appropriated or carried
9	forward, First Steps to School Readiness is directed to reimburse the Department of Education up to \$50,000 for the costs of the
10	financial audit of Baby Net.

1 Funds appropriated to the Department of Education for the K-12 Technology Initiative shall be distributed to the public school 2 districts of the state, the special schools of the state and the South Carolina Public Charter School District, per pupil, based on the 3 previous year's one hundred thirty-five day average daily membership, according to the below calculations: (1) For a school district 4 with a poverty index of less than 75: \$35 per ADM: (2) For a school district with a poverty index of at least 75 but no more than 85: 5 \$50 per ADM; or (3) For a school district with a poverty index of greater than 85 or a special school with no defined poverty index: 6 \$70 per ADM. Poverty will be defined as determined for the poverty add on weight in Proviso 1.3 of this Act. 7 The Department of Education may adjust the per-ADM rates for each of the three classes defined above in order to conform to 8 actual levels of student attendance and available appropriations, provided that the per-ADM rate for each class is adjusted by the 9 same percentage. Funds distributed to a school district through the K-12 Technology Initiative may only be used for the following purposes: (1) To 10 11 improve external connections to schools, with a goal of reaching at least 100 kilobits per second, per student in each school by 2017: (2) To improve internal connections within schools, with a goal of reaching at least 1 megabit per second, per student in each school 12 13 by 2017; or (3) To develop or expand one-to-one computing initiatives. 14 A school district that has achieved each of the above goals may submit a plan to the K-12 Technology Initiative Committee for 15 permission to expend its allocation on other technology-related uses; such permission shall not be unreasonably withheld and the K-12 Technology Committee must permit districts to appeal any process should a district not receive approval and must provide 16 technical assistance to districts in developing plans should the district request such. 17 Funds appropriated for the K-12 Technology Initiative may not be used to supplant existing school district expenditures on 18 technology. By June 30, 2017, each school district that receives funding through the K-12 Technology Initiative during Fiscal Year 19 20 2016-17 must provide the K-12 Technology Initiative Committee with an itemized report on the amounts and uses of these funds, using a form developed by the Education Oversight Committee. In this report, a school district must provide information on its 21 efforts to obtain reimbursements through the "E-Rate" Schools and Libraries Program administered by the Universal Service 22 23 Administrative Company. Within its available resources, the K-12 Technology Initiative Committee shall support school districts' 24 efforts to obtain these reimbursements. 25 Funds appropriated to the Department of Education for Reading Partners shall be allocated to Reading Partners and must be used to increase the number of reading interventions for students in low performing schools in grades K-5. The Office of Early 26 Learning and Literacy shall specify planning criteria to be submitted by Reading Partners no later than July 15, 2016. Planning 27 criteria shall include, but is not limited to, pre and post assessment data, parental and family literacy engagement, summer learning 28 29 support and building school level capacity for intervention. The department shall report to the Governor, the Chairman of the Senate 30 Finance Committee, the Chairman of the Senate Education Committee, the Chairman of the House Ways and Means Committee and 31 the Chairman of the House Education Committee by June 15, 2017 on the impact of the program. 32 Funds appropriated to the Department of Education for Mobile Device Access and Management shall be disbursed to school 33 districts to procure high-speed mobile internet service for students that lack such internet service at home and are participating in a 34 course of study that requires such access, as demonstrated by the school district. Districts requesting funding shall make application 35 to the South Carolina K-12 Technology Committee in a form approved by the committee and the Department of Education detailing, at a minimum, the proposed uses of such mobile internet service, the number of students eligible for the service, the process used to 36

1	determine student eligibility, and the process by which the devices will be secured and use-restricted to prevent breach or misuse.
2	The Committee may approve requests in whole or in-part as funds are available.
3	The Department of Administration, Division of Technology may disapprove applications if the district's mobile device
4	management plans are insufficient to properly secure mobile internet devices issued to students. The Division of Technology may
5	<u>offer mobile device management services to applicant districts in lieu of a district-specific plan.</u>
6	The funds appropriated above for South Carolina State University shall be utilized by the Interim Board of Trustees for
7	administrative functions of the interim board and for any other purpose deemed necessary by the interim board.
8	The funds appropriated to the State Board for Technical and Comprehensive Education for Workforce Scholarships and Grants
9	shall be used to provide grants up to \$2,000 per student per term for the cost of attendance for credit and/or non-credit programs
10	with a completion period of one year or less in the areas of Healthcare, Advanced Manufacturing, Information Technology, and/or
11	Transportation/Logistics. By March 15th of the academic year provided, the State Board for Technical and Comprehensive
12	Education shall provide a report to the Chairman of House Ways and Means Committee and the Chairman of the Senate Finance
13	Committee containing a list of programs, amount of funding spent per program, number of students that received grants, and the
14	grant amount per student.
15	Of the funds appropriated above for Maintenance-Critical Care and Replacement-1 to 1 Match, the institutions shall use the
16	amount appropriated only for critical repair and related maintenance and/or other critical equipment and systems repair and
17	maintenance that are necessary for the safe and efficient operation of an institution's physical plant in its support of the institution's
18	educational purpose.
19	Funds must not be used for new construction and may only be utilized by an institution to the extent the funds are matched by the
20	institution for necessary repair and maintenance projects generally.
21	Matching funds exclude supplemental, capital reserve, lottery, or non-recurring state funds appropriated to an institution either
22	in the current fiscal year or from a prior fiscal year for repair and maintenance or deferred maintenance projects.
23	Prior to the utilization of these funds, institutions must certify to the Commission on Higher Education, in a manner it prescribes,
24	the extent to which they have met this requirement, including the sources of funds utilized to meet this requirement.
25	Not later than one hundred twenty days after the close of the fiscal year, the Commission on Higher Education shall report to the
26	Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee regarding the utilization
27	of this provision.
28	Funds not expended in the prior fiscal year may be carried forward into the current fiscal year and utilized for the same purpose,
29	subject to the matching requirement.
30	On or before December 31, 2016, the Department of Education, in cooperation with the Commission on Higher Education, shall
31	provide a report to the Governor, the Chairman of the Senate Education Committee, the Chairman of the House Education and
32	Public Works Committee, the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and Means
33	Committee regarding the costs and opportunities of the change to the State's Uniform Grading Policy from a 7-point scale to a 10-
34	point scale. The report shall include, but not necessarily be limited to, the projected impact, if any, that the change may have on the
35	State's merit based scholarship programs, recommendations on how to fund the projected impact, if any, to the State's merit based
36	scholarship programs, and suggested alternatives to mitigate the projected impact, if any, to the State's merit based scholarship

Alternatives, if any, may include potential changes to the State's merit based scholarship criteria including GPA or 1 2 testing requirements. 3 4 SECTION 5 - H710 - WIL LOU GRAY OPPORTUNITY SCHOOL 5 6 5.1. (WLG: Truants) The Opportunity School will incorporate into its program services for students, ages fifteen and over, who 7 are deemed truant; and will cooperate with the Department of Juvenile Justice, the Family Courts, and School districts to encourage the removal of truant students to the Opportunity School when such students can be served appropriately by the Opportunity School's 8 9 program. 5.2. (WLG: GED Test) Students attending school at the Wil Lou Gray Opportunity School that are sixteen years of age and are 10 unable to remain enrolled due to the necessity of immediate employment or enrollment in post-secondary education may be eligible 11 to take the General Education Development (GED) Test. 12 5.3. (WLG: Deferred Salaries Carry Forward) Wil Lou Gray is authorized to carry forward into the current fiscal year the amount 13 of the deferred salaries and employer contributions earned in the prior fiscal year for non-twelve month employees. These deferred 14 15 funds are not to be included or part of any other authorized carry forward amount. 5.4. (WLG: Improved Forestry Practices) The Trustees of the Wil Lou Gray Opportunity School may carry out improved forestry 16 practices on the timber holdings of the school property and apply the revenues derived from them and any other revenue source on 17 the property for the further improvement and development of the school forest and other school purposes. 18 5.5. (WLG: Educational Program Initiatives) Wil Lou Gray Opportunity School is authorized to utilize funds received from the 19 Department of Education for vocational equipment on educational program initiatives. 20 5.6. (WLG: Lease Revenue) Wil Lou Gray Opportunity School is authorized to retain revenues derived from the lease of school 21 properties titled to or utilized by the school and may use revenues retained for general school operations, including, but not limited 22 23 to, maintenance of such properties. Unexpended funds may be carried forward into the current fiscal year and used for the same 24 purposes. 25 5.7. (WLG: USDA Federal Grants) All revenues generated from USDA federal grants may be retained and expended by the school in accordance with Federal regulations for the purpose of covering actual expenses in the cafeteria/food service operations of 26 27 the school. 28 5.8. (WLG: By-Products Revenue Carry Forward) The Wil Lou Gray Opportunity School is authorized to sell goods that are by-products of the school's programs and operations, charge user fees and fees for services to the general public, individuals, 29 organizations, agencies and school districts, and such revenue may be retained and carried forward into the current fiscal year and 30 expended for the purpose of covering expenses of the school's programs and operations. 31 5.9. (WLG: Capacity) For Fiscal Year 2015-16, funds appropriated to Wil Lou Gray Opportunity School must be used to bring 32 the school up to full capacity, to the extent possible, and the school must report electronically to the Chairman of the Senate Finance 33 Committee and the Chairman of the House Ways and Means Committee by December first, on how the funds have been utilized and 34 how many additional students have been served. 35

SECTION 6 - H750 - SCHOOL FOR THE DEAF AND THE BLIND

6.1. (SDB: Student Activity Fee) The School for the Deaf and the Blind is authorized to charge to the parents of students at the
 school a student activity fee, differentiated according to the income of the family. The required student activity fee shall not exceed
 \$40.00. Such revenue may be retained and carried forward into the current fiscal year and expended for the purpose of covering
 expenses for student activities.

6.2. (SDB: Weighted Student Cost) The School for the Deaf and the Blind shall receive through the Education Finance Act the
 average State share of the required weighted cost for each student enrolled in the School.

6.3. (SDB: Admissions) Deaf, blind, multi-disabled and other disabled students identified by the Board of Commissioners as 9 target groups for admission to the South Carolina School for the Deaf and the Blind may be admitted by the School either through 10 direct application by parents or on referral from the local school district. The Board of Commissioners shall define the appropriate 11 admissions criteria including mental capacity, degree of disability, functioning level, age, and other factors deemed necessary by the 12 board. All placement hearings for admission to the South Carolina School for the Deaf and the Blind shall be organized by the 13 School. The South Carolina School for the Deaf and the Blind shall obtain information from the local school district concerning the 14 needs of the student and shall prepare an Individualized Education Plan for each student admitted. All parents applying for admission 15 of their children must sign a statement certifying that they feel the South Carolina School for the Deaf and the Blind is the most 16 appropriate placement which constitutes the least restrictive environment for the individual student, based upon needs identified in 17 the placement meeting and the Individualized Education Plan. The decision concerning placement and least restrictive environment 18 shall be reviewed annually at the IEP Conference. 19 6.4. (SDB: Adult Vocational Program Fees) The School for the Deaf and the Blind is authorized to charge appropriate tuition, 20 room and board, and other fees to students accepted into the Adult Vocational Program. Such fees will be determined by the School 21 Board of Commissioners, and such revenue shall be retained and carried forward into the current fiscal year and expended by the 22

23 School for the purpose of covering expenses in the Adult Vocational Program.

6.5. (SDB: Mobility Instructor Service Fee) The School for the Deaf and the Blind is authorized to charge a fee for the services of a mobility instructor to provide service on a contractual basis to various school districts in the state, and such revenue shall be retained and carried forward into the current fiscal year and expended by the School for the purpose of covering expenses in the Blind School.

6.6. (SDB: Cafeteria Revenues) All revenues generated from cafeteria operations may be retained and expended by the institution
 for the purpose of covering actual expenses in cafeteria operations.

6.7. (SDB: School Buses) The school buses of the South Carolina School for the Deaf and the Blind are authorized to travel at
 the posted speed limit.

6.8. (SDB: USDA Federal Grants) All revenues generated from USDA federal grants may be retained and expended by the
 SCSDB in accordance with Federal regulations for the purpose of covering actual expenses in the cafeteria/food service operations
 of the school.

6.9. (SDB: By-Products Revenue Carry Forward) The School for the Deaf and the Blind is authorized to sell goods that are byproducts of the school's programs and operations, charge user fees and fees for services to the general public: individuals,

organizations, agencies and school districts, and such revenue may be retained and carried forward into the current fiscal year and expended for the purpose of covering expenses of the school's programs and operations. **6.10.** (SDB: Deferred Salaries Carry Forward) South Carolina School for the Deaf and the Blind is authorized to carry forward in the current fiscal year the amount of the deferred salaries and employer contributions earned in the prior fiscal year for non-twelve month employees. These deferred funds are not to be included or part of any other authorized carry forward amount. 6.11. (SDB: Sale of Property) After receiving approval from the Department of Administration or State Fiscal Accountability Authority for the sale of property, the school may retain revenues associated with the sale of property titled to or utilized by the school. These funds shall be expended on capital improvements approved by the Joint Bond Review Committee and the State Fiscal Accountability Authority. For the current fiscal year, the school is authorized to use the retained revenue from the sale of donated property for educational and other operating purposes. 6.12. (SDB: USC-Upstate Visual Impairment Master of Education Program) Of the funds appropriated to the South Carolina School for the Deaf and the Blind, \$50,000 shall be used to fund the Master of Education Program In Visual Impairment at the University of South Carolina - Upstate. 6.13. (SDB: Capacity) For Fiscal Year 2015-16, funds appropriated to the School for the Deaf and the Blind must be used to bring the school up to full capacity, to the extent possible, and the school must report electronically to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by December first, on how the funds have been utilized and how many additional students have been served. 6.14. (SDB: Educational Program Initiatives) The School for the Deaf and Blind is authorized to utilize funds received from the Department of Education for vocational equipment on educational program initiatives. 6.15. (SDB: School Leave Policy) The School for the Deaf and Blind is authorized to promulgate administrative policy governing annual and sick leave relative to faculty and staff with the approval of the School's board of directors. This policy shall address the school calendar in order to comply with the instructional needs of students attending the school. **6.16.** (SDB: Buildings) For the current fiscal year; the South Carolina School for the Deaf and Blind will be subject to the same requirements as a local education agency for the purposes of building renovation and construction. 6.17. (SDB: Early Childhood Center) The School for the Deaf and the Blind shall be authorized to redirect and transfer the \$500,000 appropriated for the Thackston Hall Roof Replacement in Act 91 of 2015 by proviso 118.14(B)(5)(a) to the Early Childhood Center Construction project.

7.1. (JDLHS: Status Offender Carry Forward) Unexpended status offender funds distributed to John de la Howe School from the
 Department of Education may be carried forward and used for the same purpose.

7.2. (JDLHS: Campus Private Residence Leases) John de la Howe School is authorized to lease, to its employees, private
 residences on the agency's campus. Funds generated may be retained and used for general operating purposes including, but not
 limited to, maintenance of the residences.

SECTION 7 - L120 - JOHN DE LA HOWE SCHOOL

1	7.3. (JDLHS: Deferred Salaries Carried Forward) John de la Howe School is authorized to carry forward into the current fiscal
2	year the amount of deferred salaries and employer contributions earned in the prior fiscal year for non-twelve month employees.
3	These deferred funds are not to be included or part of any other authorized carry forward amount.
4	7.4. (JDLHS: Capacity) For Fiscal Year 2015-16, funds appropriated to John de la Howe School must be used to complete
5	deferred maintenance on the residential cottages and to bring the school up to full capacity, to the extent possible. The school must
6	not utilize the funds to hire new employees until the school has completed deferred maintenance on a cottage and requires the new
7	employee due to a projected increase in students. Any increases in staff must be reported to the Chairman of the House Ways and
8	Means Committee and the Chairman of the Senate Finance Committee thirty days prior to the hire. Further, the school must report
9	electronically to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by
10	December first, on how the funds have been utilized and how many additional students have been served.
11	7.5. (JDLH: Educational, Therapeutic Progress, and Other Financial Information) For the current fiscal year, the John de la Howe
12	School shall provide information and data to the Education Oversight Committee, the Office of the Inspector General, and the
13	Department of Education on a quarterly basis, as required, to document the following for all programs and services offered by the
14	school:
15	(1) student enrollment counts and data that document what educational and therapeutic needs and interventions each student
16	at the school received in the prior and current school years;
17	(a) student counts shall be broken out to detail students on campus during the day and the number of overnight students
18	requiring and receiving 24/7 supervision;
19	(b) using this data a cost per student calculation shall be reported with the calculation excluding capital costs and the
20	assumption day students are revenue neutral unless documentation is provided to the contrary;
21	(2) dates of enrollment and withdrawal of each student; included with this data shall be a calculation showing the average

26	(5) the number of staff employed that provide direct and indirect services to students;
27	(6) other financial expenses of the school; and
28	(7) any other data as identified by the committee.
29	To protect the identity of each student, unique student identifiers and not personally identifiable information must be provided.
30	The Education Oversight Committee, the Office of the Inspector General, and the Department of Education shall prescribe the
31	reporting measures to be followed by the school and shall report to the Governor, to the Senate Finance Committee, and to the House
32	Ways and Means Committee by January 15, 2016, on recommendations for improving services to students.
33	7.6. (JDLH: Transition) In accordance with the purposes of the will of Dr. John de la Howe, by September 30 of the current
34	fiscal year, the Board of Trustees of John de la Howe is directed to work with an advisory group comprised of one person each
35	designated by the Director of the Department of Social Services, the Director of the Department of Mental Health, the Director of
36	the Department of Juvenile Justice, the State Superintendent of Education, the Director of the Department of Alcohol and Other

1 Drug Abuse Services, the Chair of the Joint Citizens and Legislative Committee on Children, a Representative appointed by the 2 Speaker of the House, and a Senator appointed by the President Pro Tempore of the Senate to recommend an educational, vocational, 3 and life skills training program at the John de la Howe School for older youth who are at risk and who are aging out of the foster 4 care or the juvenile justice supervisory programs of the Department of Social Services or the Department of Juvenile Justice. The 5 program will utilize the funds appropriated to John de la Howe School for the costs of the program that will include school drop-out 6 recovery to complete a high school degree, a GED program, vocational and employment training, and an aftercare program for 7 transition of the youth to independent living and employment. Clemson University will collaborate with the advisory group regarding 8 the development of a vocational farming component for the program. In consultation with the advisory group and as set forth herein, by November 30. the John de la Howe Board of Trustees will 9 procure a contract with a child-service provider to operate the program. The child-service provider must be a nationally accredited 10 11 (AdvancED) educational organization experienced in both child protection and juvenile justice programs and must be able to 12 demonstrate a history of success in the operation of educational and vocational residential training programs for vouth. The 13 Department of Administration and the Executive Budget Office will assist John de la Howe as needed in the transition. 14 With funds appropriated and with technical assistance from Clemson University, the Department of Administration and the 15 Executive Budget Office, the John de la Howe School Board of Trustees will continue to provide wilderness camp programs to students in the current fiscal year: and identify initiatives to provide agricultural education opportunities on campus for students. 16 17 John de la Howe will work with the Department of Social Services and the Department of Juvenile Justice to provide for the safe transition of the existing residents from John de la Howe School into such placements, programs and services as determined 18 19 appropriate based on an assessment of their individual needs. 20 In the development of the program and in the qualifications and selection of the child-service provider, considerations by the John 21 de la Howe Board of Trustees in consultation with the advisory group will include the following: 22 (1) the overlap of needs of children who crossover for services between the Department of Social Services and the Department 23 of Juvenile Justice: 24 (2) educational, school drop-out recovery, GED, vocational programs, life skills training programs, career and employment 25 opportunities, and independent living programs for these older youth clients that can be provided using the John de la Howe School 26 facilities, resources, and funding to assist these youth who are at risk and aging out of state services to prepare for success as adults: (3) aftercare programs that will follow these vouths into the community and help them to become established in viable 27 employment and living situations that encourage a future free of homelessness, unemployment, poverty, alcohol and other substance 28 29 *abuse. criminal behavior. and dependence on public assistance:* 30 (4) provide the existing child clients at John de la Howe School with a proper, safe transition to family reunification or other 31 appropriate placements and services: (5) provide consideration of current John de la Howe School employees, where appropriate, for employment pursuant to the 32 33 new provider contract for program services: and. 34 (6) how the existing funds and vouth vocational training programs can be applied to provide repairs and maintenance to the 35 John de la Howe School buildings and grounds.

SECTION 7 - L120 - JOHN DE LA HOWE SCHOOL

The John de la Howe Board of Trustees, with technical assistance from the Department of Education will provide procurement 1 2 for the contract, fiscal administration of the funds, contract accountability, compliance, and reporting and will submit reports by June 30th of the current fiscal year to the House Ways and Means Committee, the Senate Finance Committee, and the Joint Citizens 3 and Legislative Committee on Children to inform the Committees regarding the status and progress of programs, operations, client 4 data, facilities, and budget information. The John de la Howe Board of Trustees, in consultation with the advisory group will make 5 recommendations to the Governor and General Assembly regarding the future role of the John De La Howe School. 6 7 8 **SECTION 8 - H670 - EDUCATIONAL TELEVISION COMMISSION** 9 8.1. (ETV: Grants/Contributions Carry Forward) The Educational Television Commission shall be permitted to carry forward 10 any funds derived from grant awards or designated contributions and any state funds necessary to match such funds, provided that 11 these funds be expended for the programs which they were originally designated. 12 8.2. (ETV: Spectrum Auction) During the current fiscal year, if If the Educational Television Commission opts to enter the 13 Federal Communications Commission TV Spectrum Auction and subsequently receives any proceeds from the auction Federal 14 15 Communication Commission TV Auction, the commission is authorized to receive and retain the proceeds for the development of a capital reserve declining balance fund. Up to \$40,000,000 of the proceeds shall be used to fund several critical capital needs at ETV, 16 including an expected broadcast industry standards change. Proceeds shall also be deployed for existing equipment repair, 17 maintenance and replacement needs and operational costs. Any proceeds received above \$40,000,000 must be placed into a 18 segregated account and shall require General Assembly approval prior to the expenditure of these funds. Unexpended funds shall be 19 carried forward from the prior fiscal year into the current fiscal year and used for the same purpose. The Subject to the FCC 20 requirements for a specified quiet period, the commission shall report to the Governor, the Chairman of the Senate Finance 21 22 Committee and the Chairman of the House Ways and Means Committee on the intent to enter the auction; dates of the auction; 23 potential revenue estimates; and actual received revenue. 24 8.3. (ETV: Antenna and Tower Placement) All leases for antenna and tower operations within institutions of higher learning campuses must conform to master plans for such property, as determined solely by the institution of higher learning. 25 26 8.4. (ETV: Wireless Communications Tower) The Educational Television Commission is directed to coordinate tower and antenna operations within South Carolina state government. The commission shall (1) approve all leases regarding antenna 27 placement on state-owned towers and buildings, (2) coordinate all new tower construction on state-owned property, (3) promote 28 and market excess capacity on the State's wireless communications infrastructure, (4) generate revenue by leasing, licensing, or 29 selling excess capacity on the State's wireless communications infrastructure, and (5) construct new communications assets on 30 appropriate state-owned property for the purpose of generating revenue pursuant to this proviso. The commission shall retain and 31 expend such funds for agency operations. The commission shall be authorized to carry forward unexpended funds from the prior 32 fiscal year into the current fiscal year. The commission shall annually report to the Chairmen of the Senate Finance and House 33 34 Ways and Means Committees by October first of each year all revenue collected and disbursed.

(CHE: Contract for Services Program Fees) The amounts appropriated in this section for "Southern Regional Education 3 4 Board Contract Programs" and "Southern Regional Education Board Dues" are to be used by the commission to pay to the Southern 5 Regional Education Board the required contract fees for South Carolina students enrolled under the Contract for Services program of the Southern Regional Education Board, in specific degree programs in specified institutions and the Southern Regional Education 6 7 Board membership dues. The funds appropriated may not be reduced to cover any budget reductions or be transferred for other 8 purposes. **11.2.** (CHE: African-American Loan Program) Of the funds appropriated to the Commission on Higher Education for the 9 African-American Loan Program, 73.7 percent shall be distributed to South Carolina State University and 26.3 percent shall be 10 distributed to Benedict College, and must be used for a loan program with the major focus of attracting African-American males to 11 the teaching profession. The Commission of Higher Education shall act as the monitoring and reporting agency for the African-12

American Loan Program. Of the funds allocated according to this proviso, no more than ten percent shall be used for administrative purposes.

15 **11.3.** (CHE: GEAR-UP) Funds appropriated for GEAR-UP shall be used for state grants programs to reach disadvantaged 16 middle school students to improve their preparation for college. Eligible South Carolina public schools and public institutions of 17 higher education shall cooperate with the Commission on Higher Education in the provision of services under the Gaining Early 18 Awareness and Readiness for Undergraduate Programs (GEAR-UP) grant.

19 **11.4.** (CHE: EPSCoR Committee Representation) With the intent that the four-year teaching institutions receive a portion of 20 EPSCoR funding, the State EPSCoR Committee shall have an executive committee consisting of one representative from each of the 21 research institutions and one representative from the four-year teaching university sector.

11.5. (CHE: SREB Funds Exempt From Budget Cut) In the calculation of any across the board cut mandated by the Executive Budget Office or General Assembly, the amount which the Commission on Higher Education is appropriated for Southern Regional Education Board (SREB) Professional Scholarship Programs and Fees, Dues and Assessments shall be excluded from the Commission on Higher Education's base budget. Funds appropriated for SREB programs may be carried forward into the current fiscal year and expended for the same purpose by the Commission on Higher Education.

11.6. (CHE: Performance Improvement Pool Allocation) Of the funds appropriated to the Commission on Higher Education
 under Section II. Other Agencies & Entities: Special Items: Performance Funding, eighty percent will be allocated to the EPSCoR
 program under the Commission on Higher Education to improve South Carolina's research capabilities and twenty percent will be
 allocated to support the management education programs of the School of Business at South Carolina State University.

31 **11.7.** (CHE: Troop-to-Teachers) Members of the Armed Forces either active-duty, retired, or separated who are admitted to and 32 enrolled in the South Carolina Troop-to-Teachers Alternative Route to Certification program are entitled to pay in-state rates at 33 participating state institutions for requisite program work.

34 **11.8.** (CHE: Need-Based Grants for Foster Youth) For the current academic year, youth in the custody of the Department of 35 Social Services and attending a higher education institution in South Carolina are eligible for additional need-based grants funding 36 of up to \$2,000 above the \$2,500 maximum. Foster youth must apply for these funds no later than May first, of the preceding year.

SECTION 11 - H030 - COMMISSION ON HIGHER EDUCATION

All other grants, both state and federal, for which these foster youth are eligible must be applied first to the cost of attendance prior 1 2 to using the additional need-based grant funding. If the cost of attendance for a foster youth is met with other grants and scholarships, then no additional need-based grant may be used. The Department of Social Services, in cooperation with the Commission on Higher 3 4 Education will track the numbers of recipients of this additional need-based grant to determine its effectiveness in encouraging more 5 foster youth to pursue a secondary education. No more than \$100,000 may be expended from currently appropriated need-based 6 grants funding for this additional assistance. 7 **11.9.** (CHE: Tuition Age) For the current fiscal year, the age limitation for those children of certain war veterans who may be admitted to any state-supported college, university, or post high school technical education institution free of tuition is suspended for 8 eligible children that successfully appeal the Division of Veterans Affairs on the grounds of a serious extenuating health condition. 9 11.10. (CHE: LIFE and Palmetto Fellows Enhancement Stipends) In the current fiscal year before fall awards are made, to 10 continue eligibility for LIFE and Palmetto Fellows Enhancement Stipends, students shall certify and the institutions shall verify that 11 the student is meeting all requirements as stipulated by the policies established by the institution and the academic department to be 12 enrolled as a declared major in an eligible program and is making academic progress toward completion of the student's declared 13 eligible major. These determinations are subject to the verification and audit of the Commission on Higher Education. Institutions 14 shall return funds determined to have been awarded to ineligible students. 15 11.11. (CHE: SmartState) The Commission on Higher Education is prohibited from expending any source of funds on the 16 marketing of the SmartState Program. 17 **11.12.** (CHE: College Transition Need-Based Grants) Of the currently appropriated need-based grants funding, no more than 18 \$179,178 \$350,000 shall be used to provide need-based grants to South Carolina resident students enrolled at a public institution of 19 higher education in an established college transition program that serves students with intellectual disabilities. The Commission on 20 Higher Education shall allocate the available funds to eligible institutions on the basis of student need and enrollment in the 21 established college transition programs. All other grants and gift aid for which these students are eligible must be applied first to the 22 23 cost of attendance prior to using the need-based grant funding. If the cost of attendance for an eligible student is met with all other grants and gift aid, the need-based grant shall not be used. The participating institutions, in cooperation with the Commission on 24 25 Higher Education, shall track the number of grant recipients and other information determined necessary to evaluate the effectiveness

of these grants in assisting students with intellectual disabilities in college transition programs. 26

11.13. (CHE: Scholarship Awards) A student may receive a Palmetto Fellows or LIFE scholarship award during the summer, in 27 28 addition to fall and spring semesters of an academic year, provided continued eligibility requirements are met as of the end of the 29 spring semester. Students must enroll full-time, which for purposes of the summer award will require enrollment in at least twelve hours over the course of the summer. The summer is defined as the period between the end of the spring term and prior to the 30 31 opening of the fall term. The total summer award per student may not exceed half of the allowable academic year award up to the cost of attendance and must be reimbursed if less than twelve hours for academic credit are not attempted by the student during 32 summer sessions. If awarded in the summer, a student's total award during his or her enrollment may not exceed the amount that 33 34 would otherwise be provided under current semester limits applied for the scholarship awards. The Commission on Higher Education

35 may provide additional guidelines necessary to ensure uniform implementation.

SECTION 11 - H030 - COMMISSION ON HIGHER EDUCATION

11.14. (CHE: Other Funded FTE Revenue) Each institution When institutions of higher learning when requesting request 1 2 additional other funded full-time equivalent positions, shall ensure to the Executive Budget Office shall inform the Commission on Higher Education, or its successor entity, that of its decision regarding the request and whether or not sufficient revenues exist to 3 4 fund the salary and fringe benefits for the positions. In addition, the institution shall also ensure that in the calculation of the revenue 5 required for the positions, future pay increases and future health insurance adjustments as may be mandated by the General Assembly 6 are taken into consideration. 7 11.15. (CHE: Abatements) By October November first of each year, state supported institutions of higher learning must submit 8 to the Commission on Higher Education, or its successor entity, the *total* number of out-of-state *undergraduate* students during the prior fiscal year that received abatement of rates pursuant to Section 59-112-70 of the 1976 Code as well as the total dollar amount 9 of the abatements received. The report must include the geo origin of the student, class of the student, comprehensive listing of all 10 financial awards received by the student, number of semesters the student has received the abated rate, as well as the athletic status 11 of the student. The report must also include the calculation method used to determine the abatement amount awarded to students as 12 well as the number of students that received educational fee waivers pursuant to Section 59-101-620. 13 11.16. (CHE: Outstanding Institutional Debt) By November first, institutions of higher learning must submit to the Chairman of 14 15 the Senate Finance Committee, the Chairman of the House Ways and Means Committee, and the Commission on Higher Education, or its successor entity, data on all outstanding institutional debt for their respective institution. Data shall include, but not be limited 16 to, the amount of the initial debt, year in which the debt was incurred, the year in which the debt will be satisfied, the repayment 17 schedule, and the purpose for which the debt was incurred. 18 11.17. (CHE: Transferability) No later than May 2, 2016, the Commission on Higher Education's Council of Presidents, or the 19 council's designees, in consultation with the State Board for Technical and Comprehensive Education, or its designees, shall make 20 a recommendation(s) to the Chairman of the Senate Education Committee and the Chairman of the House Education and Public 21 Works Committee concerning policy options for the state to consider with regards to the development of a more seamless transition 22 23 for students with Associate Degrees from public two-year institutions of higher learning wishing to transfer to public research 24 institutions and four-year colleges and universities. Recommendations must consider both the costs and opportunities of the option(s) 25 presented including, but not limited to, impacts on institutional core requirements and accreditation standards. Nothing herein shall 26 be construed as superseding any agreements, memorandums of understanding, or letters of intent that are in effect in the current fiscal year between or on behalf of one or more public institutions of higher learning in this state with another public institution or 27 28 institutions of higher learning in this state regarding the transferability of students between institutions as described herein. 11.18. (CHE: Technical College Study) (A) The Commission on Higher Education shall examine the viability of a program that 29 30 allows a student who graduated from a high school in this state or who attained the state educational equivalency of a high school diploma to attend a state technical college without paying tuition and fees at the institution for a specified period. When conducting 31 32 the examination, the commission shall identify and consider: (1) The anticipated number of students who will participate in the program; 33 34 (2) The anticipated annual cost of the program and federal, state and other sources of funding that could be used to pay the 35 costs of the program;

(3) Current capacity available at state technical colleges to enroll additional students;

(4) The ability of the program to increase the state's pool of skilled workers and meet projected workforce demands; 1 2 (5) The impact of the program to increase educational attainment in the state; (6) The regions of the state the program would likely significantly increase educational attainment and workforce readiness; 3 (7) Potential eligibility criteria for students participating in the program; and 4 (8) The possibility of requiring students to first use financial aid available to the students, including federal funding provided 5 to low-income students for the purpose of paying for post-secondary education. 6 7 (B) The commission shall propose criteria for the program. 8 (C) The commission shall submit a report that summarizes the findings to the General Assembly no later than January 31, 2016. The report may include recommendations for legislation. 9 11.19. (CHE: College and University Out of State Veteran Tuition Differential Reimbursement Fund) Of the funds appropriated 10 to and/or authorized for the Commission on Higher Education for the Out of State Veteran Tuition Reimbursement, the Office of 11 State Treasurer is directed to establish a fund, separate and distinct from the general fund and all other funds, entitled the College 12 and University Out of State Veteran Tuition Differential Reimbursement Fund. Any funds appropriated and/or authorized in the 13 current fiscal year for this purpose must be deposited into the fund and interest accrued by the fund must remain in the fund. 14 15 The purpose of the fund is to reimburse public institutions of higher learning, as defined in Section 59-103-5 of the 1976 Code, for revenue loss resulting from the provisions of Section 59-112-50(C). By March 1, 2016 each year, a public institution of higher 16 learning seeking a reimbursement from this fund must submit an application to the Commission on Higher Education to receive a 17 reimbursement from the fund. The total reimbursement to a public institution may not exceed the difference between the amounts 18 the institution would have charged but for Section 59-112-50(C), and the amounts the institution actually charged. The Commission 19 on Higher Education may require any proof it determines necessary to verify the veracity of the application. 20 By June 15, 2016 each year, the Commission on Higher Education must distribute the funds to those institutions that have applied 21 pursuant to this provision. In the event that the total requested and verified reimbursements exceed the amount in the fund, the 22 23 distribution to each public institution shall be reduced pro rata based on the institution's amount of verified reimbursements compared 24 to the total amount of verified reimbursements of all institutions. 25 26 SECTION 14 - H120 - CLEMSON UNIVERSITY - EDUCATIONAL & GENERAL 27 28 14.1. (CU: Electrical Infrastructure) Clemson University is directed to enter into negotiations with an appropriate entity or an 29 electric cooperative to determine the feasibility for the purchase and operation of the main campus electrical infrastructure and 30 maintenance associated with said infrastructure. A report shall be submitted to the Chairman of the Senate Finance Committee and 31 the Chairman of the House Ways and Means Committee by December 1, 2015 on the results of the negotiations. 32

SECTION 19 - H240 - SOUTH CAROLINA STATE UNIVERSITY

19.1. (SCSU: Blue Ribbon Commission Loan Funds) (A) Pursuant to Proviso 19.2, Part IB, of Act 286 of 2014, South Carolina 9 State University was approved for a loan to be disbursed through a series of scheduled installments. Any funds not disbursed to the 10 university pursuant to the schedule during Fiscal Year 2014-15 2015-16 shall be carried forward to Fiscal Year 2015-16 2016-17. 11 In Fiscal Year 2015-16 2016-17, the State Treasurer, upon certification of the Executive Budget Office, shall disburse up to 12 \$8,500,000 \$3,000,000 to the university pursuant to the provisions contained in this proviso. The loan amount consists of (1) funds 13 carried forward pursuant to this proviso and (2) the \$4,000,000 \$2,000,000 approved for Fiscal Year 2015-16 2016-17 by the Joint 14 15 Bond Review Committee pursuant to Paragraph 19.2, Part IB, of Act 286 of 2014. Any funds approved pursuant Paragraph 19.2, Part IB, of Act 286 of 2014 that remain undisbursed at the end of Fiscal Year 2015-16 2016-17 shall be carried forward. The loan 16 must be at an interest rate established by the State Treasurer pursuant to Section 11-9-250 of the 1976 Code. 17

- (B) To compel disbursements in Fiscal Year 2016-17, the Executive Budget Office must certify that:
- (1) for the initial scheduled quarterly installment, <u>which to the extent practicable shall occur on or before August 30.</u>
 2016, the Board of Trustees of the university, based on reasonable enrollment and other realistic budgetary assumptions, has adopted
 a balanced budget, whereby operating expenditures do not exceed operating revenue and that the university is not projected by the
 Executive Budget Office, based upon a cash flow analysis, to fall out of balance for the quarter; and
- (2) for each remaining quarterly installment, the Executive Budget Office, certifies that the university's budget for the
 fiscal year in which the loan is made remains in balance based on a cash flow analysis at the time of the installment payment and that
 the university is not projected, by the Executive Budget Office, based on a cash flow analysis, to fall out of balance during the quarter.
- (C) If the provisions contained in item (B) are not met, then installment payments scheduled but not yet made must be suspended until the Executive Budget Office certifies that the university has taken necessary corrective action to meet the provisions of this proviso.
- 29 (D) Pursuant to Title 11, Chapter 7, the State Auditor shall audit, or cause to be audited, the university's finances. In addition,
 30 upon a request of the university's interim Board of Trustees, the State Auditor shall audit, or cause to be audited the university's
- 31 *internal controls. A separate report of findings and recommendations arising from the financial audit and the internal control audit,*
- 32 if one is conducted, shall be submitted to the Chairman of the Senate Finance Committee, the Chairman of the House Ways and
- 33 Means Committee, and the Executive Budget Office, by March 1, 2017.
- 34 (E) \$1,000,000 of the loan funds disbursed to South Carolina State University pursuant to Proviso 19.2, Part IB, of Act 286 of
- 35 2014, including any associated interest, shall be forgiven provided the University has met the following benchmarks:

11	president. During the fiscal year, should the Interim Board of Trustees conduct a search to hire a president, the Interim Board shall
12	submit a progress report on the status of the search to the Chairman of the Senate Finance Committee and the Chairman of the
13	House Ways and Means Committee within 90 days of the search's start, or August 2, 2016, whichever is later, with subsequent status
14	updates to follow at least every 90 days during the fiscal year if an active search remains in effect.
15	19.3. (SCSU: State Fiscal Accountability Authority Loan Funds) The annual payment to the State of South Carolina to retire
16	the debt incurred by the university pursuant to the April 30, 2014 loan from the Budget and Control Board, succeeded in interest by
17	the State Fiscal Accountability Authority, shall be \$355,036. The installment payment required pursuant to this proviso shall be due
18	on or before June 30, 2017. The provisions contained in this proviso shall not be implemented if a permanent loan repayment

33	student funding disparity that exists between each of these campuses. The university shall determine the appropriate enrollment
34	measure to guide the distribution of these additional, recurring state appropriations. The allocation of state funds shall be reported
35	to the Commission on Higher Education, the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and
36	Means Committee

36 Means Committee.

SECTION 23 - H510 - MEDICAL UNIVERSITY OF SOUTH CAROLINA

23.1. (MUSC: Rural Dentist Program) The Rural Dentist Program, in coordination with the Department of Health and 3 4 Environmental Control's Public Health Dentistry Program, is established at the Medical University of South Carolina. The funds 5 appropriated to the Medical University of South Carolina for the Rural Dentist Program shall be administered by the South Carolina Area Health Education Consortium physician recruitment office. The costs associated with administering this program are to be paid 6 7 from the funds appropriated to the Rural Dentist Program and shall not exceed four percent of the appropriation. The Medical 8 University of South Carolina is responsible for the fiscal management of funds to ensure that state policies and guidelines are adhered to. MUSC shall be permitted to carry forward unspent general funds appropriated to the Rural Dentist program provided that these 9 funds be expended for the program for which they were originally designated. A board is created to manage and allocate these funds 10 to insure the location of licensed dentists in rural areas of South Carolina and on the faculty of the College of Dental Medicine at 11 MUSC. The board will be composed of the following: the Dean, or his designee, of the MUSC College of Dental Medicine; three 12 members from the South Carolina Dental Education Foundation Board who represent rural areas; and the President, or his designee, 13 of the South Carolina Dental Association. The Director of DHEC's Office of Primary Care; the Director or his designee of the 14 15 Department of Health and Human Services; and the Executive Director of the South Carolina Dental Association shall serve as ex officio members without vote. This board shall serve without compensation. 16

23.2. (MUSC: Telemedicine) From the funds appropriated to the Medical University of South Carolina for the MUSC Hospital 17 Authority, the Authority is directed to continue the development of it's the South Carolina Statewide Telemedicine network. The 18 South Carolina Telehealth Alliance shall submit a proposal to the MUSC Hospital Authority shall to determine which hospitals are 19 best suited for a Telemedicine partnership. The MUSC Hospital Authority shall provide bi-annual reports to the Chairman of the 20 Senate Finance Committee and the Chairman of the House Ways and Means Committee detailing the distribution of funds. 21

23.3. (MUSC: Rural Access Plan) The MUSC Hospital Authority, in conjunction with the Department of Health and Human 22 23 Services, shall study how to partner with existing rural hospitals to ensure that these regions maintain access to medical care. 24

SECTION 25 - H590 - STATE BOARD FOR TECHNICAL AND COMPREHENSIVE EDUCATION

27 25.1. (TEC: Training of New & Expanding Industry) (A) Notwithstanding the amounts appropriated in this section for readySC it is the intent of the General Assembly that the State Board for Technical and Comprehensive Education expend the funds necessary 28 29 to provide direct training for new and expanding business or industry.

(B) In the event projected expenditures are above the appropriation, the appropriation in this section for readySC may be 30 31 appropriately adjusted, if and only if, the Executive Budget Office determines that the projected expenditures are directly related to:

- (1) an existing technology training program where the demand for the program exceeds the program's capacity and the 32 additional funds are to be utilized to meet the demand; or 33 34

35 (C) The adjustment may occur only upon approval by the Executive Budget Office. Upon the Executive Budget Office's approval of the adjustment, the Director of the Executive Budget Office must certify, in writing, that the adjustment is directly related to either 36

(TEC: Training of New & Expanding Industry Carry Forward) In addition to the funds appropriated in this section, any of 13 the funds appropriated under this section for the prior fiscal year which are not expended during that fiscal year may be carried 14 forward and expended for direct training of new and expanding industry in the current fiscal year. 15 25.3. (TEC: Training of New & Expanding Industry - Payments of Prior Year Expenditures) The State Board for Technical and 16 Comprehensive Education may reimburse business and industry for prior year training costs billed to the agency after fiscal year 17 closing with the concurrence of the Comptroller General. 18 25.4. (TEC: MSSC) The funds appropriated to the State Board for Technical and Comprehensive Education for the 19 Manufacturing Skills Standards Council Initiative may not be used for consulting associated with the Initiative. 20 25.5. (TEC: Critical Statewide Workforce Needs) Of the funds appropriated in this act to the State Board for Technical and 21 Comprehensive Education for E&G STEM Programs: Critical Needs Workforce Development Initiative, the State Board must 22 23 allocate the funds between the colleges based on a methodology designed to best meet the state's workforce needs and demands. 24 This methodology should be created by the State Board in consultation with the Department of Commerce and the Department of 25 Employment and Workforce and should identify the areas with the most critical need. For this purpose, critical need shall be defined 26 as unmet employment demand in areas or fields of Science, Technology, Engineering, Mathematics, and Manufacturing. The Revenue and Fiscal Affairs Office shall provide the department with any information required by the department in order to implement this proviso in accordance with state law and regulations.

(H) The department shall may pilot an all-inclusive health intervention program for wrap-around care to vulnerable mental

33.22. (DHHS: Medicaid Healthcare Initiatives Outcomes) Prior to February fifteenth of the current fiscal year, the Director of

(DHHS: Rural Health Initiative) From the funds appropriated to the Department of Health and Human Services for the 22 23 Rural Health Initiative, the department shall partner with the following state agencies, institutions, and other key stakeholders to 24 implement these components of a Rural Health Initiative to better meet the needs of medically underserved communities throughout the state. The department may leverage any and all available federal funds to implement this initiative. 25 (A) The Department of Health and Human Services shall take appropriate action to facilitate the following provisions: 26 (1) Rural Healthcare and Education - The USC School of Medicine shall consult with the South Carolina Office of Rural 27 Health in preparing a proposal for a Center of Excellence to support and develop rural medical education and delivery infrastructure 28 29 with a statewide focus through clinical practice, training and research as well as collaboration with other state agencies and institutions. These individuals will provide direct patient care in a home environment. The per visit rate may vary based on the discipline providing the care and the geographical location of services rendered. Management may pay exempt or nonexempt employees as defined by the Fair Labor Standards Act only when they are needed to work. Individuals employed in this category may exceed twelve months, but are not eligible for State benefits except for the option of contributing to the State Retirement System.

34.21. (DHEC: Allocation of Indirect Cost and Recoveries) The department shall continue to deposit in the general fund all indirect cost recoveries derived from state general funds participating in the calculation of the approved indirect cost rate. Further administration cost funded with other funds used in the indirect cost calculation may, based on their percentage, be retained by the agency to support the remaining administrative costs of the agency.

(DHEC: Radiological Health Monetary Penalties) In the course of regulating health care facilities/services, the Bureau of Radiological Health (BRH) assesses civil monetary penalties against nonconforming providers. BRH shall retain up to the first 16 \$30,000 of civil monetary penalties collected each fiscal year and these funds shall be utilized solely to carry out and enforce the 17 provisions of regulations applicable to that Bureau. These funds shall be separately accounted for in the department's fiscal records. 18 34.27. 38.7. (DSS: Fee Schedule) The Department of Social Services shall be allowed to charge fees and accept donations, grants, and bequests for social services provided under their direct responsibility on the basis of a fee schedule. 38.8. (DSS: Food Stamp Fraud) The state portion of funds recouped from the collection of recipient claims in the TANF and
 Food Stamp programs shall be retained by the department. A portion of these funds shall be distributed to local county offices for

38.9. (DSS: TANF - Immunizations Certificates) The department shall require all TANF applicants and/or recipients to provide
 proof of age appropriate immunizations for children. If such immunizations have not been administered, the department shall assist

The department shall require a match 10 from all grant recipients.

- 38.14. (DSS: Family Foster Care Payments) The Department of Social Services shall furnish as Family Foster Care payments for
 individual foster children under their sponsorship *and under kinship care*:
- 13 ages 0 5 $\frac{3383}{2404}$ per month
- 14 ages 6 12 \$458 <u>\$469</u> per month
- 15 ages $13 + \frac{$518 \\ \$535}$ per month

These specified amounts are for the basic needs of the foster children <u>to include kinship care assistance</u>. Basic needs within this proviso are identified as food (at home and away), clothing, housing, transportation, education and other costs as defined in the U.S. Department of Agriculture study of "Annual Cost of Raising a Child to Age Eighteen". Further, each agency shall identify and justify, as another line item, all material and/or services, in excess of those basic needs listed above, which were a direct result of a professional agency evaluation of clientele need. Legitimate medical care in excess of Medicaid reimbursement or such care not recognized by Medicaid may be considered as special needs if approved by the sponsoring/responsible agency and shall be reimbursed by the sponsoring agency in the same manner of reimbursing other special needs of foster children.

23 **38.15.** (DSS: Penalty Assessment) The Department of Social Services may impose monetary penalties against a person, facility, or other entity for violation of statutes or regulations pertaining to programs, other than foster home licensing, that the department 24 25 regulates. Penalties collected must be remitted to the State Treasurer for deposit into the State General Fund. The department shall promulgate regulations for each program in which penalties may be imposed. The regulations must include guidance on the decision 26 to assess a penalty, the effect of failure to pay a penalty in a timely manner, and a schedule of penalty ranges that takes into account 27 severity and frequency of violations. These regulations must provide for notice of the penalty and the right to a contested case 28 hearing before a designee of or panel appointed by the director of the department. The authority to assess monetary penalties shall be in addition to other statutory provisions authorizing the department to 33 34 seek injunctive relief or to deny, revoke, suspend, or otherwise restrict or limit a license or other types of operating or practice registrations, approvals, or certificates. 35

38.16. (DSS: Child Support Enforcement Automated System Carry Forward) The department shall be authorized to retain and carry forward any unexpended funds appropriated for the Child Support Enforcement automated system and related penalties.

38.17. (DSS: Child Support Enforcement System) From the funds appropriated in Part IA, Section 38(F), the Department of 3 4 Social Services shall prepare a detailed report on the status of the Child Support Enforcement System. The report shall include, but 5 not be limited to, actions currently being undertaken to become compliant with federal government requirements; the cost required to meet minimum federal guidelines; total funds spent so far on the system; the amount of fines assessed by the federal government 6 7 associated with noncompliance; how much has been spent to satisfy actions taken by the state judicial system; and how much has 8 been spent related to actions taken by any other entity which may have altered the amount required for meeting minimum federal guidelines. The report shall be submitted to the General Assembly by August thirty-first of the current fiscal year. 9 38.18. (DSS: Child Care Voucher) State funds allocated to the Department of Social Services and used for child care vouchers 10

11 must be used to enroll eligible recipients within provider settings exceeding the state's minimum child care licensing standards. The 12 department may waive this requirement on a case by case basis.

13 38.19. (DSS: Meals in Emergency Operations) The cost of meals may be provided to state employees who are not permitted to 14 leave their stations and are required to work during actual emergencies, emergency situation exercises, and when the Governor 15 declares a state of emergency.

38.20. (DSS: Day Care Facilities Supervision Ratios) For the current fiscal year, staff-child ratios contained in Regulations
 114-504(B), 114-504(C), 114-524(B), and 114-524(C) shall remain at the June 24, 2008 levels.

38.21. (DSS: Foster Care Goals) To comply with the requirements of 42 U.S.C. Section 671(a)(14) and 45 C.F.R. Section 1356.21(n), it shall be the goal of the state that the maximum number of Title IV-E funded children who will remain in foster care for more than twenty-four months will not exceed a total of 2,617 during the fiscal year. The Department of Social Services shall develop appropriate plans for timely permanency and use appropriate data benchmarks and targets that will achieve this goal.

38.22. (DSS: Comprehensive Teen Pregnancy Prevention Funding) (A) From the monies appropriated for the Continuation of Teen Pregnancy Prevention, the department must award the dollars allocated to a nonprofit 501(c)(3) entity to provide abstinence first, age appropriate comprehensive approach to health and sexuality education with a goal of preventing adolescent pregnancy throughout South Carolina.

26 (B) Contracts must be awarded utilizing a competitive approach in accordance with the South Carolina Procurement Code.

(C) The monies appropriated must be paid over a twelve month basis for services rendered. Unexpended funds shall be carried
 forward for the purpose of fulfilling the department's contractual agreement.

(D) The programs implemented by the entity awarded a contract pursuant to this proviso may not violate any portion of the South
 Carolina Comprehensive Health Education Act when implemented in a school setting. An entity that violates any portion of the
 South Carolina Comprehensive Health Education Act must reimburse the State for all funds disbursed.

32 **38.23.** (DSS: SNAP Coupons) The Department of Social Services shall continue the "Healthy Bucks" program established to 33 provide coupons that allow Supplemental Nutrition Assistance Program (SNAP) recipients to obtain additional fresh fruits and 34 vegetables when purchasing fresh produce at grocery stores or farmers markets with SNAP benefits through their EBT cards. Each 35 coupon shall allow the beneficiary to double the amount of produce purchased, up to ten dollars per month. The agency shall utilize 36 all funds received in the prior and current fiscal years from the U.S. Department of Agriculture as a bonus for reducing the error rate

in processing SNAP applications to fund the program. The agency shall work to identify and utilize funds as matching dollars for 1 2 the continued success of the "Healthy Bucks" program and shall report semi-annually to the General Assembly on the status of the program. The report shall include, at a minimum, the number of recipients, counties served, and cumulative expenditure data for the 3 4 program. 5 **38.24.** (DSS: Local Internal Child Fatality Review Committees) For Fiscal Year 2015-16 2016-17, the Director of the Department of Social Services shall create and fund Local Internal Child Fatality Review Committees (local internal committees) pursuant to 6 7 the authority granted in Sections 43-1-60(3), 43-1-80, and 63-7-910(E) of the 1976 Code to allow for the rapid and expeditious 8 review of reported child fatalities which come within the investigative authority of the department that are reported to the Department of Social Services on suspicion of abandonment, child abuse, neglect or harm as defined in Section 63-7-20. This review process 9 will enable the department to respond to the safety needs of any surviving siblings and will lead to improvement in the department's 10 efforts to prevent child fatalities caused by abandonment, child abuse, neglect or harm. Each local internal committee shall be 11 composed of a board-certified child abuse pediatrician, an agent from the State Law Enforcement Division, and representatives from 12 a local law enforcement officer, a representative from the local coroner's office, and representatives from the Department of Social 13 Services, public health, the solicitor's office and, as necessary, healthcare workers, mental health providers, educators, and the 14 15 Children's Advocacy Centers. The internal committee may invite other service provider organizations as deemed necessary. The department is authorized to provide reasonable compensation for board-certified child abuse pediatricians serving on a Local Child 16 Fatality Review Committee an internal committee. Local Internal committees shall have access to information and records 17 maintained by a provider of medical care regarding a child whose death is being reviewed by the local internal committee, including 18 information on prenatal care; all information and records maintained by any state, county, or local government agency, including, 19 but not limited to, birth certificates, law enforcement investigation data, county coroner or medical examiner investigation data, 20 parole and probation information and records, and information and records of health agencies that provided services to the child or 21 family: and unfounded reports of abuse or neglect made strictly confidential and whose disclosure is otherwise prohibited by statute. 22 23 Further, local committees shall have the same authority as the State Child Fatality Advisory Committee to obtain information as set 24 forth in Section 63-11-1970. The meetings, information obtained by, reports prepared by, and testimony statements made before the 25 local internal committees are confidential and protected from disclosure pursuant to the Freedom of Information Act, criminal and 26 civil proceedings, and subpoenas to the same extent as the State Child Fatality Advisory Committee as set forth in Sections 63-11-1980 and 63-11-1990 63-7-940 and 63-7-1990. 27 38.25. (DSS: Tuition Reimbursement/Student Loan Repayment) The Department of Social Services is allowed to spend state, 28 29 federal, and other sources of revenue to provide tuition reimbursement and/or student loan repayment to aid in retaining caseworkers and critical needs department jobs based on objective guidelines established by the State Director of the Department of Social 30 31 Services. 32 The department may also provide paid educational leave for any employees in an FTE position to attend class while enrolled in programs that are related to the agency's mission. All such leave is at the agency head's discretion. 33 The department may enter into an agreement with staff employed in critical need departments to repay them for their outstanding 34 student loans and/or reimburse tuition expenses. The employee must be employed in a critical needs area, which would be identified 35 at the agency head's discretion, be in a covered FTE, and not have any disciplinary actions. Participants in this program must agree 36

to remain at the department for a period of five years. The department may pay these employees up to \$7,500 each year over a five-1 2 year period in accordance with a program developed by the department. Payments will be made directly to the employee at the end of each year of employment. Payments cannot exceed the balance of the student loan or the cost of tuition. 3 4 38.26. (DSS: Federally Certified Child Support Enforcement System Project) In order to expedite the completion and certification of the Automated Child Support Enforcement System required by the Social Security Act (42 U.S.C. § 654a), the Department of 5 Social Services is authorized to adopt, to the fullest extent possible, the system and operating procedures of the Delaware Transfer 6 System. To the extent the Transfer System operating processes deviate from, or are incompatible with, current South Carolina 7 practice, the department is authorized to determine the most effective and efficient practice to comply with federal requirements. 8 The department shall work with Clerks of Court to identify the changes involved in the implementation of the Transfer System which 9 may impact their current operating practices with regards to performance of required child support functions in order to facilitate 10 the integration of those practices into the Transfer System. Pursuant to the Social Security Act and S.C. Code Section 63-17-610, 11 Clerks of Court shall utilize the federally certifiable child support system and the state disbursement unit developed by the department 12 to perform required child support functions. 13 38.27. (PRT: Tourism and Promotion) The funds appropriated in this act for Regional Promotions shall be distributed equally to the eleven Regional Tourism groups, except that the Grandstrand Tourism Region's funds shall be divided, with \$50,000 distributed to the Myrtle Beach Chamber of Commerce, \$115,000 distributed to the Georgetown Chamber of Commerce, \$30,000 distributed to the City of Georgetown, and \$30,000 distributed to the Williamsburg Chamber of Commerce for tourism related activities. IA, Section 57, are exempt from mid-year across-the-board reductions.

The department is authorized to receive, expend, retain, and carry forward these funds which shall be used for the same purpose. 9 57.19. The department is authorized to receive, expend, retain, and carry forward these funds which shall be used by the 11 department. 12 57.20. (AG: Securities Fee Revenue) After the provisions of Section 35-1-702(b) of the 1976 Code have been satisfied, and upon notification to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee that such provisions have been satisfied, the next \$20,500,000 of Securities Fee revenues collected during the current fiscal year by the Office of the Attorney General shall be remitted to the General Fund of the State. 4 counsel appointed in noncapital cases pursuant to Section 17-3-50 (Conflict Fund). Of the funds generated from the fees imposed 5 under Sections 14-1-206(C)(4), 14-1-207(C)(6) and 14-1-208(C)(6) and the application fee provided in Section 17-3-30(B), on a

5 under Sections 14-1-206(C)(4), 14-1-207(C)(6) and 14-1-208(C)(6) and the application fee provided in Section 17-3-30(B), on a 6 monthly basis, fifty percent must be deposited into the Death Penalty Trial Fund, fifteen percent must be deposited into the Conflict

Fund, and the remaining funds each month must be apportioned among the counties' public defender offices pursuant to Section 17-

12 Defense. Reimbursement in excess of the hourly rate and limit set forth in Section 17-3-50 is authorized only if the court certifies,

13 in a written order with specific findings of fact, prior to the fees being incurred, that reimbursement in excess of the rates or limit is

14 necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is

appropriate because the services to be provided are reasonable and necessary. If prior approval by written order of the court is not

16 obtained, no additional fees shall be paid under any circumstances.

Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the 17 representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant 18 and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed 19 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the 20 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the 21 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. Payments shall 22 23 be made from funds appropriated for this purpose from the Commission of Indigent Defense. If prior approval by written order of 24 the court is not obtained, no additional expenses shall be paid under any circumstances.

Indigent defense vouchers authorized in this provision must be reviewed and paid pursuant to procedures and policies established by the Commission on Indigent Defense. The commission shall provide a copy of the established procedures and policies to the Senate Finance Committee and the House Ways and Means Committee.

61.2. (INDEF: State Employee Compensation Prohibited) Except as otherwise provided in Section 117.5, no money

 guardians ad litem or attorneys nor shall such funds be used in payment to any state agency for providing such services by their

61.3. Any attorney appointed shall be compensated at a rate not to exceed forty dollars per hour for time expended out of court and sixty dollars per hour for time expended in court, or on the basis of a set (flat) fee. The method of payment and amount of set (flat) fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed three thousand five hundred dollars in any single felony case or one thousand dollars in any single misdemeanor case.

Reimbursement in excess of the hourly rate and limit set forth herein is authorized only if the court certifies, in a written order with specific findings of fact, prior to the fees being incurred, that reimbursement in excess of the rates or limit is necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is appropriate because

the services to be provided are reasonable and necessary. If prior approval by written order of the court is not obtained, no additional

the services to be provided are reasonable and necessary. If prior approval by written order of the court is not obtained, no ad

35 fees shall be paid under any circumstances.

Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the 1 2 representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed 3 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the 4 5 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the 6 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. Payments shall 7 be made from funds appropriated for this purpose from the Commission of Indigent Defense. If prior approval by written order of 8 the court is not obtained, no additional expenses shall be paid under any circumstances. Indigent defense vouchers authorized in this provision must be reviewed and paid pursuant to procedures and policies established 9 by the Commission on Indigent Defense. The commission shall provide a copy of the established procedures and policies to the 10 Senate Finance Committee and the House Ways and Means Committee. 11 12 A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" may be used by the Commission on Indigent Defense to retain, on a contractual basis, the services of attorneys qualified to handle civil and criminal court appointments, 13 to be reimbursed in accordance with applicable provisos and statutes. 14 15 61.5. (INDEF: Carry Forward) To offset budget reductions, the Commission on Indigent Defense may carry forward and utilize any unencumbered balances available in the Appellate Conflict Fund and the SC Appellate Court Rule 608 Appointment Fund at the 16 end of the prior fiscal year. 17 **61.6.** (INDEF: Public Defender Fee) Every person placed on probation on or after July 1, 2003, who was represented by a public 18 defender or appointed counsel, shall be assessed a fee of five hundred dollars. The revenue generated from this fee must be collected 19 by the clerk of court and sent on a monthly basis to the Commission on Indigent Defense. However, if a defendant fails to pay this 20 fee, this failure alone is not sufficient basis for incarceration for a probation violation. The clerk of court or other appropriate official shall collect the application fee imposed by this section and remit the proceeds to the Commission on Indigent Defense on a monthly basis. In matters concerning juveniles, the parents 5 or legal guardians of said juvenile, shall be advised in writing of this requirement at the earliest stage of the proceedings against said 6 7 juvenile. 8 (D) Nothing contained above shall restrict or hinder a court from appointing counsel in any emergency proceedings or where existing statutes do not provide sufficient time for an individual to complete the application process. 9 (E) The appointment of counsel, as herein before provided, creates a claim against the assets and estate of the person who is 10 provided counsel or the parents or legal guardians of a juvenile in an amount equal to the costs of representation as determined by a 11 voucher submitted by the appointed counsel and approved by the court, less that amount that the person pays to the appointed counsel. 12 (F) Such claim shall be filed in the office of the clerk of court in the county where the person is assigned counsel, but the filing 13 of a claim shall not constitute a lien against real or personal property of the person unless, in the discretion of the court, part or all of 14 such claim is reduced to judgment by appropriate order of the court, after serving the person with at least thirty days' notice that 15 judgment will be entered. When a claim is reduced to judgment, it shall have the same effect as judgments, except as modified by 16 this provision. 17 61.8. (INDEF: Exemption for Pass Through Funding) The funds distributed by the Commission on Indigent Defense to the 18 Legal Services Corporation in accordance with Section 14-1-204 of the 1976 Code shall not be considered part of the commission's 19 budget for purposes of calculating budget reductions. 20 61.9. (INDEF: Reporting Requirement) Circuit Public Defenders shall provide, in a manner and form as the agency head 21 requires, information and data concerning caseloads, dispositions, and other information as required by the agency head or General 22 Assembly. The agency shall withhold payments and transfers to Circuit Public Defenders who are not in compliance with the agency 23 24 reporting requirements. 25 61.10. (INDEF: Donation Carry Forward) The Commission on Indigent Defense may accept donations for the publication of 26 "The South Carolina Juvenile Collateral Consequences Checklist." All revenue derived from donations received at the Commission on Indigent Defense shall be retained, carried forward and expended according to agreement reached between the donor, or donors, 27

and the Commission on Indigent Defense.

61.11. (INDEF: Capital Case Contract Attorneys) Funds appropriated from the Death Penalty Trial Fund may be used by the commission to retain, on a contractual basis, the service of attorneys qualified to provide representation in capital proceedings to include: capital trials, post-conviction relief actions, re-sentencing, appeals or any other capital litigation proceeding.

The commission shall establish all policies, procedures and contract provisions as it deems appropriate for the implementation of the system, including but not limited to the selection and compensation of contract awardees.

61.12. (INDEF: Optional Courts and Indigent Representation) If a municipality has or elects to have an optional municipal court
 system, it must provide adequate funds for representation of indigents. No public defender shall be appointed in any such court

unless the municipality and the office of the circuit public defender have reached an agreement for indigent representation and no
 funds allocated to the commission shall be used to provide compensation for appointed counsel in municipal courts.

3 61.13. (INDEF: Indigent Verification) The Commission on Indigent Defense is directed to review the Affidavit for Indigency

62.1. (SLED: Special Account Carry Forward) Funds awarded to the State Law Enforcement Division by either court order or from donations or contributions shall be deposited in a special account with the State Treasurer, and shall be carried forward from year to year, and withdrawn from the Treasurer as needed to fulfill the purposes and conditions of the said order, donations or contributions, if specified, and if not specified, as may be directed by the Chief of the State Law Enforcement Division. Funds expended from the special account must be annually reported by October first to the Senate Finance Committee and the Ways and Means Committee.

62.2. (SLED: Computer/Communications Center Carry Forward) Revenue generated from the operation of the division's
 criminal justice computer/communications center and not expended during the prior fiscal year may be carried forward and expended
 for the same purpose during the current fiscal year.

62.3. (SLED: Agents Operations Carry Forward) Any unexpended balance on June thirtieth, of the prior fiscal year, in Part IA,
 subsection 62 of the section "Agents Operations" may be carried forward and expended for the same purpose in the current fiscal
 year.

62.4. (SLED: Match for Federal Grants Carry Forward) State appropriations to SLED that are required to provide match for federal grant programs in the prior fiscal year may be carried forward into the current fiscal year and expended for the same purpose as originally appropriated.

62.5. (SLED: Clothing Allowance) The State Law Enforcement Division is hereby authorized to provide agents and criminalists
 with an annual clothing allowance (on a pro rata basis) not to exceed \$600 per agent/criminalist for required clothing used in the line
 of duty.

62.6. (SLED: Witness Fee) The State Law Enforcement Division is hereby authorized to charge a witness fee of \$130.00 per
 hour up to \$1,000 per day for each employee testifying in civil matters which do not involve the State as a part in interest. This fee
 shall be charged in addition to any court prescribed payment due as compensation or reimbursement for judicial appearances and
 deposited into a designated revenue account.

62.7. (SLED: Commissioned Officers' Physicals) The department is authorized to pay for the cost of physical examinations for
 department personnel who are required to receive such physical examinations prior to receiving a law enforcement commission.

62.8. (SLED: Meals in Emergency Operations) The State Law Enforcement Division may provide meals to employees of SLED
 who are not permitted to leave assigned duty stations and are required to work during deployment, emergency simulation exercises
 and when the Governor declares a state of emergency.

62.9. (SLED: Hazardous Materials Security Detail) The State Law Enforcement Division (SLED) is authorized to be reimbursed for security related law enforcement services provided to entities authorized to transport sensitive materials within the borders of South Carolina. SLED shall determine all costs associated with security details and is authorized to coordinate the collection, retention, and distribution to any assisting agency. SLED and each assisting agency shall expend any funds associated with minimizing risks related to the transportation of these hazardous materials for the implementation of homeland security initiatives.

62.10. (SLED: Sex Offender Registry Fee) Each Sheriff is authorized to charge and collect an annual amount of one hundred fifty dollars from each sex offender required to register by law. If such sex offender has been declared indigent by the Sheriff of the county in which the offender must register and provides proof of the declaration at the time of registration, the fee will automatically be waived. If an offender is not declared indigent and fails to pay the fee, he is officially declared unregistered. This fee shall be divided between the Sheriffs and the State Law Enforcement Division with one hundred dollars of the fee retained by the Sheriffs and the remaining fifty dollars remitted by the Sheriffs to SLED on a quarterly basis. These funds must be used to support the Statewide Sex Offender Pagietry

15 Statewide Sex Offender Registry.

62.11. (SLED: Private Detective Fees Criminal History Checks) The State Law Enforcement Division is authorized to charge private detective companies, individual private detectives, private security companies, armed security guards, and proprietary security companies a fee of twenty-five dollars to process state criminal history checks and fifty dollars for federal fingerprint based criminal history checks. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement Division.

62.12. (SLED: CWP Instructors Certification) The State Law Enforcement Division is authorized to charge one hundred dollars
 for the issuance of a Certified Concealable Weapons Permit Instructor certificate, and one hundred dollars every three years for each
 renewal. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement Division.

62.13. (SLED: Expungement Requests) The State Law Enforcement Division is authorized to collect a twenty-five dollar expungement fee for each request to expunge criminal records. These funds shall be used to offset the operational and research expenses associated with processing these expungement requests. SLED is authorized to collect, retain, expend, and carry forward these funds. Persons found not guilty by a court of competent jurisdiction or where charges have been dismissed or nolle prossed shall be excluded from the fee requirement.

62.14. (SLED: Retention of Funds Reimbursed by State or Federal Agencies) The State Law Enforcement Division is authorized to
 collect, expend, retain, and carry forward all funds received from other state or federal agencies in the current fiscal year as
 reimbursement of expenditures incurred in the current or prior fiscal year.

62.15. (SLED: Monies Associated with Illegal Gaming Devices) The State Law Enforcement Division is authorized to retain,
 expend, and carry forward all monies associated with illegal gaming devices seized by the division, once orders of destruction and
 awarding of these monies have been received from a court of competent jurisdiction.

62.16. (SLED: Private Detective/Security Fee) The license and registration fees set by the State Law Enforcement Division for
 private detective businesses, private security businesses, including employees of these businesses, and companies which provide

1 private security on their own premises must not exceed those fees set by regulation as of January 1, 2011, unless otherwise approved

2 by the General Assembly. From the funds collected from these fees, the State Law Enforcement Division must transfer \$480,000 to

3 the Department of Public Safety which shall be used for the purpose of providing security in the Capitol Complex area.

62.17. (SLED: Criminal Record Search Fees) The State Law Enforcement Division is authorized to charge and collect a fee of eight dollars for a criminal record search for local park and recreation volunteers through a commission, municipality, county, or the South Carolina Department of Parks, Recreation, and Tourism. Any organization that is authorized to receive the reduced fee must not charge the volunteer, mentor, member, or employee more than the eight dollars or any additional fee that is not required by the State Law Enforcement Division. All criminal record searches conducted under this provision must be for a volunteer, mentor, member or employee performing in an official capacity of the organization and must not be resold.

62.18. (SLED: Compensatory Payment) In the event a State of Emergency is declared by the Governor, exempt employees of the
 State Law Enforcement Division may be paid for actual hours worked in lieu of accruing compensatory time, at the discretion of the
 Chief, and providing funds are available.

62.19. (SLED: Meth Lab Clean Up Carry Forward) Any unexpended balance on June thirtieth of the prior fiscal year, in the
 special line "Meth Lab Clean Up" may be carried forward and expended for the same purpose <u>agency law enforcement operations</u>
 in the current fiscal year.

62.20. (SLED: CWP Renewal and Replacement) A concealed weapons permit may not be suspended by a state official, agent, or employee supported by state funds if the permit holder has initiated a renewal or replacement application and the processing and issuance of a renewal or replacement permit is delayed for administrative reasons. A concealed weapons permit remains valid during the pendency of the renewal or replacement process so long as the application for replacement renewal is submitted prior to the expiration of the permit.

62.21. (SLED: Drug Lab Electronic Mandatory Reporting System) Of the funds appropriated for Meth Lab Clean Up, the State
 Law Enforcement Division is authorized to expend such funds for the development and implementation of a statewide electronic
 mandatory reporting system for municipal, county and state governmental entities to report information, as directed by the State Law
 Enforcement Division, pertaining to the discovery or seizure of methamphetamine laboratories and dumpsites.

62.22. (SLED: Mandatory Meth Lab Reporting) If a municipal, county, or state governmental entity locates, finds, or seizes a
 methamphetamine laboratory or dumpsite within the State, the governmental entity shall report the incident within three business
 days to the State Law Enforcement Division.

The State Law Enforcement Division shall determine the reporting mechanism and is authorized to request, receive, catalogue, classify, and maintain all information it determines necessary pertaining to the laboratory or dumpsite including, but not limited to, the location, the type of manufacturing method used, and suspect information. The State Law Enforcement Division shall maintain

information related to these governmental reports on its website, which must be made available to the public, and is authorized to use funds appropriated for Meth Lab Clean Up towards the prudent maintenance of information reported.

A governmental entity that fails to report information to the State Law Enforcement Division pursuant to this proviso is ineligible to receive public safety grants that are funded through the South Carolina Public Safety Coordinating Council pursuant to Section

35 23-6-520(2) of the 1976 Code.

SECTION 62 - D100 - STATE LAW ENFORCEMENT DIVISION

62.23. (SLED: First Responder PTSD Treatment) From the funds provided for First Responder PTSD Treatment, the State Law 1 2 Enforcement Division shall distribute 50% percent to the South Carolina Law Enforcement Assistance Program to reimburse law enforcement officers who incur mental injury as a result of a critical incident during the scope of employment for actual out-of-3 pocket expenses not covered through worker's compensation claims and/or other insurance and can also be utilized to provide 4 services through the South Carolina Law Enforcement Assistance Program. The State Law Enforcement Division shall distribute 5 50% percent to the South Carolina State Firefighters Association for the South Carolina Firefighter Assistance Support Team to 6 reimburse firefighters and emergency medical technicians who incur mental injury as a result of a critical incident during the scope 7 of employment for actual out-of-pocket expenses not covered through worker's compensation claims and/or other insurance and can 8 also be utilized to provide services through the South Carolina Firefighter Assistance Support Team. The State Law Enforcement 9 Division shall promulgate any administrative regulations necessary to carry out the provisions of this section. 10 62.24. (SLED: Concealed Weapons Permit Report) SLED shall publish on its website, the total number of concealed weapons 11 permits revoked pursuant to Section 23-31-215(J) in the prior calendar year. SLED shall include the total number of concealed 12 weapons permits revoked pursuant to each subsection of Section 23-31-215(J). The data shall not include the name of the concealed 13 weapons permit holder whose permit was revoked. 14 15 16 SECTION 63 - K050 - DEPARTMENT OF PUBLIC SAFETY 17 **63.1.** (DPS: Special Events Traffic Control) The highway patrol must not charge any fee associated with special events for 18 maintaining traffic control and ensuring safety on South Carolina public roads and highways unless approved by the General 19 Assembly. Nothing shall prohibit the Treasury of the State from accepting voluntary payment of fees from private or public entities 20 to defray the actual expenses incurred for services provided by the Department of Public Safety. 21 63.2. (DPS: Retention of Private Detective Fees) The Department of Public Safety is hereby authorized to receive, expend, 22 23 retain, and carry forward all funds transmitted from SLED related to fees charged and collected by SLED from license and registration 24 fees for private detective businesses, private security businesses, including employees of these businesses, and companies which 25 provide private security on their own premises. The funds transferred are to be used in the Bureau of Protective Services Program to provide security for state agencies and the Capitol Complex. 26 63.3. (DPS: Motor Carrier Advisory Committee) From the funds appropriated and/or authorized to the Department of Public 27 Safety and the Department of Motor Vehicles, the departments are directed to jointly establish a Motor Carrier Advisory Committee 28 to solicit input from the Trucking Industry and other interested parties in developing policies and procedures for the regulation of 29 this industry. The members of the advisory committee shall serve without compensation. 30 31 **63.4.** (DPS: Sale of Real Property) At such time as any portion of the Laurens Road property in Greenville is declared to be surplus by the agency or agencies which occupy said portion, and after receiving approval from the Department of Administration 32 or State Fiscal Accountability Authority, for the sale of the property, the Department of Public Safety, the Department of 33 34 Transportation, and the Department of Motor Vehicles are authorized to receive, retain, expend, and carry forward funds derived from the sale of the real property in which each agency holds an interest or title. No portion of the property may be declared as 35

surplus by one agency if another agency is occupying said property. The Department of Public Safety is directed to use these funds 36

to defray the operating expenses of the Highway Patrol and the Department of Transportation and the Department of Motor Vehicles 1 2 are directed to use their portion of these funds for department operating expenses. **63.5.** (DPS: CMV Driver Rest Areas) A joint working group is to be established between the Department of Transportation, 3 4 Department of Public Safety, State Transport Police and the South Carolina Trucking Association to review and evaluate where 5 critical rest areas may be made available for commercial motor vehicle drivers to park and obtain their federally mandated required 6 rest. 7 63.6. (DPS: SC Law Enforcement Officers Hall of Fame Scholarships) The Department of Public Safety is hereby authorized 8 to accept donations from the public in order to provide scholarships to the children of law enforcement officers killed in the line of duty. The South Carolina Law Enforcement Officers Hall of Fame Advisory Committee is authorized to set the criteria for awarding 9 such scholarships. All revenue received for this purpose shall be used to provide scholarships and shall be retained, carried forward, 10 and expended for the same purpose. 11 63.7. (DPS: Hours of Service Rest Requirements) Of the funds directed to the Department of Public Safety, the department shall 12 expend the necessary funds to establish a policy to allow drivers of commercial motor vehicles engaged in intrastate commerce to 13 use time waiting in their trucks while on the job to satisfy any hours of service thirty minute rest requirements. The policy shall then 14 be printed and distributed to the Senate Transportation Committee and the House of Representatives Education and Public Works 15 Committee. In addition, the policy shall be provided to any motor carrier who requests a copy. The department is further instructed 16 to allow the Motor Carrier Advisory Committee to review options that may facilitate adoption of allowable variances from state and 17 federal statutes, rules, and regulations, as well as specific relief for interstate border-zone operations. 18 63.8. (DPS: Body Cameras) The Department of Public Safety is authorized to retain and carry forward unexpended funds 19 associated with body cameras from the prior fiscal year into the current fiscal year and expend those funds for the same purpose. 20 21 22 SECTION 64 - N200 - LAW ENFORCEMENT TRAINING COUNCIL 23 24 64.1. (LETC: CJA-Federal, Other Flow Through Funds) In order to complete projects begun in a prior fiscal year, the Law 25 Enforcement Training Council, Criminal Justice Academy is authorized to expend federal and earmarked funds in the current fiscal year for expenditures incurred in the prior fiscal year. 26 64.2. (LETC: CJA-Retention of Emergency Expenditure Refunds) The Law Enforcement Training Council, Criminal Justice 27 Academy is authorized to collect, expend, retain, and carry forward all funds received from other state or federal agencies in the 28 current fiscal year as reimbursement of expenditures incurred in the current or prior fiscal year when personnel and equipment are 29 30 mobilized and expenses incurred due to an emergency. 31 32 **SECTION 65 - N040 - DEPARTMENT OF CORRECTIONS** 33 34 **65.1.** (CORR: Canteen Operations) Revenue derived wholly from the canteen operations within the Department of Corrections on behalf of the inmate population, may be retained and expended by the department for the continuation of the operation of said 35 canteens and the welfare of the inmate population or, at the discretion of the Director, used to supplement costs of operations. The 36

canteen operation is to be treated as an enterprise fund within the Department of Corrections and is not to be subsidized by state
 appropriated funds.

65.2. (CORR: E.H. Cooper Trust Fund) Any unclaimed funds remaining in any inmate account, after appropriate and necessary
 steps are taken to determine and contact a rightful owner of such funds, shall be deposited into the Inmate Welfare Fund.

65.3. (CORR: Instructional Salaries) The certified instructional personnel of the Department of Corrections shall receive a percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel throughout the State.

65.4. (CORR: Funding Through State Criminal Assistance Program) All funds received by the State from the United States
 Department of Justice, State Criminal Alien Assistance Program, for care and custody of illegal aliens housed in the state correctional
 facilities shall be retained by the South Carolina Department of Corrections to offset incurred expenses.

65.5. (CORR: Remedial Education Funding) A criminal offender committed to the custody of the Department of Corrections, who has been evaluated to function at less than an eighth grade educational level, or less than the equivalent of an eighth grade educational level, may be required by department officials to enroll and actively participate in academic education programs. Funds appropriated to the Department of Corrections for educational programs shall be prioritized to assure such remedial services are provided.

16 **65.6.** (CORR: Tire Retreading Program Restriction) The tire retreading program at the Lieber Correctional Institution shall be limited to the marketing and sale of retreads to state governmental entities.

65.7. (CORR: Social Security Administration Funding) All funds received by the South Carolina Department of Corrections from the Social Security Administration under Section 1611 (e)(1)(I) of the Social Security Act, which provides payment for information regarding incarcerated Social Security Insurance recipients, shall be retained by the South Carolina Department of Corrections and credited to a fund entitled "Special Social Security" for the care and custody of inmates housed in the state correctional facilities.

65.8. (CORR: Medical Expenses) The Department of Corrections shall be authorized to charge inmates a nominal fee for any
 medical treatment or consultation provided at the request of or initiated by the inmate. A nominal co-pay shall be charged for
 prescribed medications. Inmates shall not be charged for psychological or mental health visits.

65.9. (CORR: Prison Industry Funds) The Director of the Department of Corrections, at his discretion, is hereby authorized to utilize prison industry funds for projects or services benefiting the general welfare of the inmate population or to supplement costs of operations. These funds may be carried forward from the prior fiscal year into the current fiscal year to be used for the same purpose.

65.10. (CORR: Reimbursement for Expenditures) The Department of Corrections may retain for general operating purposes any
 reimbursement of funds for expenses incurred in a prior fiscal year.

65.11. (CORR: Sale of Real Property) Funds generated from the sale of real property owned by the Department of Corrections
 shall be retained by the department to offset renovation and maintenance capital expenditures.

65.12. (CORR: Funds From Vehicle Cleaning) Monies generated by inmates engaged in the cleaning and waxing of private vehicles, or any other adult work activity center, shall be placed in a special account and utilized for the welfare of the inmate population.

65.13. (CORR: Release of Inmates) The Director of the Department of Corrections and other persons having charge of prisoners 1 2 who are required to serve a period of six months or more, may release all such prisoners, including prisoners to whom Section 24-13-150(A) of the 1976 Code applies, on the first day of the month in which their sentences expire, and if the first day of the month 3 4 falls on a Saturday, Sunday, or a legal holiday, such prisoners may be released on the last weekday prior to the first of the month 5 which is not a holiday. 6 65.14. (CORR: Western Union Funding) All funds received by the South Carolina Department of Corrections from the Western 7 Union Ouick Collect Revenue Sharing Program or similar private sector entities, which provides payment for processing electronic transfers into the E.H. Cooper Trust Fund, shall be retained by the South Carolina Department of Corrections and credited to a fund 8 entitled "Inmate Welfare Fund" to be expended for the benefit of the inmate population. 9 65.15. (CORR: Monitoring Fees) The Department of Corrections is authorized to charge an inmate who participates in community 10 programs a reasonable fee for the cost of supplying electronic and telephonic monitoring. The fees charged may not exceed the 11 actual cost of the monitoring. 12 65.16. (CORR: Inmate Insurance Policies) The Department of Corrections may collect and record private health insurance 13 information from incarcerated individuals. The department may file against any private insurance policy covering an inmate to 14 recoup any health care expenditures covered by the policy. Health care will be provided in accordance with law and standards 15 regardless of whether or not an inmate is covered by insurance. 16 65.17. (CORR: Work Release Transportation Fee) The South Carolina Department of Corrections is authorized to charge a \$4.00 17 per day transportation fee to participants in the work release program only when such transportation is provided by the department. 18 Monies collected shall be credited to the South Carolina Department of Corrections, and utilized solely to fund transportation of 19 work release participants and vehicle replacement for the work release program. 20 65.18. (CORR: Special Assignment Pay Level 2 & 3 Facilities) Funds appropriated for special assignment pay at the Department 21 of Corrections are for the purpose of addressing vacancies and turnover of staff by providing a pay differential for certain employees 22 23 assigned to institutions with a Level II or Level III security designation. The funds are to be used for special assignment pay only and may not be transferred to any other program. If the employee leaves one of the qualifying job classes or leaves a Level II or 24 25 Level III institution for a non-Level II or non-Level III facility, they shall no longer be eligible for this special assignment pay. Only 26 employees in full-time equivalent positions are eligible for this special assignment pay.  Institutions to the hours of 8:00 a.m. to 10:30 a.m., Monday through Friday, excluding holidays.

By mutual agreement between the Department of Corrections and a local jail or detention center, the department may establish an alternate admissions schedule for receiving inmates at the Reception and Evaluation Center.

14 At the time of transfer of the inmate to the department, the county shall provide the sentencing order, and if available copies of

15 medical screening records, booking reports, and other documents to assist the department in its intake processing. Counties that have

16 not completed medical screenings at the time of transfer shall not be required to do so.

17 In the event there are inadequate beds within the Reception and Evaluation Center, the Department of Corrections may create a

- 18 "jail" within the Kirkland Correctional Institution using one or more of the available 192-bed housing units to accept newly sentenced
- 19 state inmates who are awaiting R & E processing. The department may operate such "jail," to the extent feasible, in accordance with 20 standards applicable to the local jails.

The department shall use the funds appropriated in this act for "Quota Elimination" to accomplish this initiative and to open a 96bed unit at the MacDougall Correctional Institution and the 192-bed housing units at Kirkland Correctional Institution. The funds may not be transferred to any other program or used for any other purpose.

65.20. (CORR: Public/Private Partnerships for Construction) Funds appropriated in Act 407 of 2006, item 23, shall be used to construct as many multi-purpose buildings at Department of Corrections institutions as possible. For such facilities at Lieber, McCormick, Leath, Perry, or Allendale Correctional Institution, at least \$150,000 in matching funds and/or construction materials or services must be donated before construction of the facility may begin. At other Department of Corrections locations, the Director may require that donated funds and/or materials or services equal one-half of the cost of construction, including design and engineering costs.

65.21. (CORR: Inmate Barbering Program) Inmate barbers in the Inmate Barbering Program at the Department of Corrections,
 shall not be subject to the licensing requirement of Section 40-7-30 of the 1976 Code.

65.22. (CORR: Executed Inmate Autopsy) For the current fiscal year, the autopsy requirements of Section 17-7-10 of the 1976
 Code are suspended when an inmate is executed by the Department of Corrections pursuant to a valid order of the Supreme Court of
 South Correling

34 South Carolina.

65.23. (CORR: Recoupment of Expenses Associated with Inmate Cremation) If the Department of Corrections incurs expenses
 for cremating and disposing of an unclaimed deceased inmate, the department may recoup all associated costs of cremation, including
 transportation, through the deceased inmate's E.H. Cooper account, providing funds are available.

4 65.24. (CORR: Credited Jail Time; DNA Sample Collection) Inmates committed to the Department of Corrections for sentences 5 greater than ninety days, but who have credit for jail time in excess of their sentence to incarceration are not required to be transported 6 to the Reception and Evaluation Center of the Department of Corrections. Cities and counties housing inmates who have credit for 7 jail time in excess of their sentence may, through written agreement with the Department of Corrections, transfer required commitment records to the department electronically or by other means. The Department of Corrections must establish reasonable 8 documentation requirements to facilitate the implementation of this cost savings measure. Employees of the Department of 9 Probation, Parole and Pardon Services assigned to the court or employees of the Department of Corrections, as applicable, shall 10 obtain DNA samples from the offenders who are required to submit DNA samples. This provision does not exempt the above 11 referenced inmates from the \$250 DNA fee as required by Section 23-3-670 of the 1976 Code. The \$250 fee shall be collected in 12 the same manner as other fines and fees and submitted to the State Treasurer for remittance to SLED. 13 65.25. (CORR: Cell Phone Interdiction) The Director of the Department of Corrections is granted the right to add a surcharge to 14 all inmate pay phone calls to offset the cost of equipment and operations of cell phone interdiction measures. The surcharge will be 15 added to the cost per call, collected by chosen telephone vendor and paid to the department on a monthly basis. The department is 16 authorized to retain the funds to pay, either directly or through the State lease program, for equipment required to enact cell phone 17

interdiction or retrieval. When the equipment has been paid in full, the surcharge amount will be reviewed and adjusted to cover the cost of ongoing operational expenses of the interdiction equipment. Any unexpended balance may be carried forward from the prior fiscal year into the current fiscal year and be used for the same purpose.

65.26. (CORR: Correctional Institution Maintenance and Construction) For maintenance and construction activities funded in the current fiscal year, the Department of Corrections may utilize inmate labor to perform any portion of the work on its own grounds and facilities. The provisions of Section 40-11-360(A)(9) of the 1976 Code shall apply to any such project, including new construction.

65.27. (CORR: Meals in Emergency Operations) The Department of Corrections may provide meals to public employees who
 are not permitted to leave their stations and are required to work during actual emergencies, emergency simulation exercises, or when
 the Governor declares a state of emergency.

65.28. (CORR: Prohibition on Funding Certain Surgery) (A) The Department of Corrections is prohibited from using state funds
 or state resources to provide a prisoner in the state prison system sexual reassignment surgery; however, if a person is taking hormonal
 therapy at the time the person is committed to the Department of Corrections, the department shall continue to provide this therapy
 to the person as long as medically necessary for the health of the person.

32 (B) As used in this provision:

(1) 'Hormonal therapy' means the use of hormones to stimulate the development or alteration of a person's sexual
 characteristics in order to alter the person's physical appearance so that the person appears more like the opposite gender;

(2) 'Sexual reassignment surgery' means a surgical procedure to alter a person's physical appearance so that the person
 appears more like the opposite gender.

66.1. (DPPP: Sale of Equipment) All revenue generated by the Department of Probation, Parole and Pardon Services from the sale of various equipment in excess of \$575, less the cost of disposition incurred by the Department of Administration, may be retained and carried forward into the current fiscal year and expended for the purpose of purchasing like items.

6 **66.2.** (DPPP: Interstate Compact Application Fee) The department may charge offenders an application fee set by the 7 department, not to exceed the department's actual costs, to offenders applying for transfers out of or into the state under the Interstate 8 Compact Act. The application fee shall be retained by the department to offset the cost of the Interstate Compact Act. All unexpended 9 funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.3. (DPPP: GED Learn and Earn Program) From the funds appropriated in Part IA, the department may enter into agreements with statewide colleges, technical colleges, and school districts for the purpose of providing GED and GED Prep education to offenders. Offenders of the department enrolled in the program must repay the department the cost of the course and materials within six months of obtaining their GED.

66.4. (DPPP: Sex Offender Monitoring Carry Forward) The Department of Probation, Parole and Pardon Services is authorized to carry forward any unexpended funds in the Sex Offender Monitoring program. These funds must be used for the sex offender monitoring program. For the purpose of calculating the amount of funds which may be carried forward by the department, Sex Offender Monitoring program funds carried forward by this provision shall be excluded from the calculation of the carry forward authorized by provision elsewhere in this act.

66.5. (DPPP: Offender Drug Testing Fee) The department may charge offenders a fee set by the department, not to exceed \$50, for the purpose of drug testing. If it is determined that the offender is indigent, this fee must be waived. The fee shall be retained by the department to offset the cost of drug testing. All unexpended funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.6. (DPPP: Public Service Employment Set-Up Fee) In addition to any other fee, the department may charge an adult offender
 placed under the jurisdiction of the department, who is ordered to public service employment by the court, a twenty-five dollar Public
 Service Employment set-up fee. The fee must be retained by the department and applied to the department's supervision process.
 The department shall submit a report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and

(DJJ: Children's Projects Revenue) Funds generated from the projects undertaken by children under the supervision of the Department of Juvenile Justice may be retained by the department and utilized for the benefit of those children. Such funds may be carried forward into the following fiscal year.

67.4. (DJJ: Instructional Salaries) The certified instructional personnel of the Department of Juvenile Justice shall receive a
 percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel
 throughout the State.

67.5. (DJJ: Reimbursements for Expenditures) The Department of Juvenile Justice may retain for general operating purposes
 any reimbursement of funds for expenses incurred in a prior fiscal year.

67.6. (DJJ: Juvenile Arbitration/Community Advocacy Program) The amount appropriated and authorized in this section for the Juvenile Arbitration Program shall be retained and expended by the Department of Juvenile Justice for the purpose of providing juvenile arbitration services through the sixteen Judicial Circuit Solicitors' offices in the state and used to fund necessary administrative and personnel costs for the programs.

The Department of Juvenile Justice shall contract with Solicitors to administer the Juvenile Arbitration Program and disburse up to \$60,000 per Judicial Circuit based on services rendered. The amount payable to Solicitors may vary based on consistent adherence to established statewide program guidelines to assess program performance.

The \$250,000 appropriated for the Community Advocacy Program in the first Judicial Circuit, will be used to fund necessary administrative and personnel costs for this status offender diversion program. The Department of Juvenile Justice shall monitor and provide support to this program.

19 All unexpended funds may be retained and carried forward from the prior fiscal year to be used for the same purposes.

67.7. (DJJ: Sale of Real Property) After receiving approval from the Department of Administration or State Fiscal Accountability
 Authority, for the sale of property, the department is authorized to retain revenues associated with the sale of department-owned real
 property and may expend these funds on capital improvements reviewed by the Joint Bond Review Committee and approved by the

23 State Fiscal Accountability Authority.

67.8. (DJJ: Sale of Timber) The Department of Juvenile Justice is hereby authorized to sell mature trees and other timber suitable for commercial purposes from lands owned by the department. Prior to such sales, the director shall consult with the State Forester to determine economic and environmental feasibility and to obtain approval for such sales. Funds derived from timber sales shall be retained and utilized for family support services after setting aside a reasonable amount, as determined by the State Forester, for reforestation of the lands from which the trees and timber are sold.

67.9. (DJJ: Drug Free Workplace) The critical mission of the Department of Juvenile Justice requires a safe and drug free work
 environment. In order to accomplish this, the department may conduct and pay for the cost of pre-employment drug testing and
 random employee drug testing. The department is authorized to expend funds in order to provide or procure these services.

67.10. (DJJ: Definition of Juveniles) The Department of Juvenile Justice is authorized to place juveniles in marine and wilderness programs or other community residence programs operated by nongovernmental entities. Juveniles receiving services in these community residence programs must either be referred to such a program by the Family Court as a condition of probation, released to such a program by the Board of Juvenile Parole, or voluntarily agree to be assigned and released to such a program by the Department of Juvenile Justice.

SECTION 67 - N120 - DEPARTMENT OF JUVENILE JUSTICE

67.11. (DJJ: Adult Education - GED) Juveniles committed to the Department of Juvenile Justice who have been enrolled in, but not yet completed, a GED educational program while at the department, at the discretion of the local school district, upon release from the department shall be allowed to enroll in either the juvenile's local school district's regular education program, in their appropriate grade placement, or allowed to enroll in that district's or county's adult education program. If enrolled in an adult education program, the juvenile's eligibility for taking the GED shall be based upon the regulations promulgated by the Department of Education for youth who are confined in, or under the custody of, the Department of Juvenile Justice.

7 67.12. (DJJ: Local District Effort) Upon commitment or confinement to a Department of Juvenile Justice facility, the school district in which that child resides shall pay an amount equivalent to the statewide average of the local base student cost (thirty 8 percent), multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to out-of-9 district students to the Department of Juvenile Justice for the time period in which the child is committed or confined to a department 10 facility. EFA funding for school districts is provided for a one hundred eighty day school year. The billing provided by the 11 12 department shall be calculated by dividing the local base student cost by two hundred twenty-five days to determine the daily rate. (DJJ: Early Release Authorization) In order to avoid unconstitutional levels of overcrowding and other unconstitutional 22 23 conditions from occurring in facilities operated by the department and in residential programs operated for the department, the number of children housed in residential placements (either committed to the custody of the Department of Juvenile Justice or who 24 25 are under the department's supervision) shall not exceed the number of beds available to the department to house them. 81.5. (LLR: Firefighter Mobilization Project) The department is directed to utilize \$165,000 of the funds derived under Section
 2 of Act 1377 of 1968, as amended by Act 60 of 2001 from the tax of thirty-five one-hundredths percent imposed annually on the
 gross premium receipts less premiums returned on canceled policy contracts and less dividends and returns of unabsorbed premium
 deposits of all fire insurance companies doing business in the State to fund the Firefighter Mobilization Project.

81.6. (LLR: Match for Federal Funds) State appropriations to the Department of Labor, Licensing, and Regulation that are required to provide match for federal grant programs in the prior fiscal year may be carried forward into the current fiscal year and expended for the same purpose as originally appropriated.

81.7. (LLR: Flexibility) In order to provide maximum flexibility in absorbing the general fund reductions to the OSHA and OSHA Voluntary Programs, the Department of Labor, Licensing, and Regulation shall be authorized to spend agency earmarked and restricted accounts to maintain these critical programs previously funded with general fund appropriations. Any increase in spending authorization for these purposes must receive the prior approval of the Executive Budget Office.

SECTION 81 - R360 - DEPARTMENT OF LABOR, LICENSING AND REGULATION

81.8. (LLR: Immigration Bill Funding Report) Prior to any funds carried forward from the prior fiscal year in Subfund 3135 1 2 being transferred to fund any other purpose, \$250,000 must be retained by the Department of Labor, Licensing, and Regulation to fund the department's responsibilities under the South Carolina Illegal Immigration Reform Act. The department shall compile an 3 4 accountability report outlining expenditures of the Immigration Bill funding to be issued to the President Pro Tempore of the Senate, 5 the Chairman of the Senate Finance Committee, the Chairman of the Senate Finance Natural Resources and Economic Development 6 Subcommittee, the Speaker of the House of Representatives, the Chairman of the House Ways and Means Committee, and the 7 Chairman of the House Ways and Means Transportation and Regulatory Subcommittee. Said report must be issued on the first 8 Tuesday of February in the current fiscal year. **81.9.** (LLR: Authorized Reimbursement) The Director of the Department of Labor, Licensing, and Regulation cannot authorize 9 reimbursement under Section 40-1-50(A) of the 1976 Code to members of any board listed in Section 40-1-40(B) for meetings held 10 at any location other than the offices of the department unless there has been a determination that the department is unable to provide 11 12 space for the meeting in a state-owned or leased facility in Richland or Lexington County. 81.10. (LLR: Illegal Immigration Hotline Assistance) Upon the request of the Commission on Minority Affairs, the Department 13 of Labor, Licensing, and Regulation shall provide assistance to establish and maintain a twenty-four hour toll free telephone number 14 and electronic website to receive, record, collect, and report allegations of violations of federal immigration laws or related provisions 15 of South Carolina law by any non-United States citizen or immigrant, and allegations of violations of any federal immigration laws 16 or related provisions in South Carolina law against any non-United States citizen or immigrant. 17 Such violations shall include, but are not limited to, E-Verify or other federal work authorization program violations, violations of 18 Chapter 83, Title 40 of the 1976 Code relating to immigration assistance services, or any regulations enacted governing the operation 19 of immigration assistance services, false or fraudulent statements made or documents filed in relation to an immigration matter, as 20 defined by Section 40-83-20, violation of human trafficking laws, as defined in Section 16-3-930, landlord tenant law violations, or 21 violations of any law pertaining to the provision or receipt of public assistance benefits or public services. 22 23 **81.11.** (LLR: Board of Pharmacy) The Board of Pharmacy must accept affidavits of practical experience from interns whose practical experience internships occurred in this State. The affidavit must provide that the supervising pharmacist and the site of 24 experience is licensed and in good standing with the board and that the internship falls within the criteria for internships set by the 25 26 board. The affidavit must be accompanied by a ten dollar fee to cover administrative costs associated with compliance with this 27 proviso.

81.12. (LLR: Office of State Fire Marshal - Clothing) The Department of Labor, Licensing, and Regulation is authorized to
 purchase and issue clothing to the non-administrative staff of the Office of the State Fire Marshal that are field personnel working in
 a regulatory aspect and/or certified to be a resident state fire marshal.

81.13. (LLR: Wind and Structural Engineering Research Lab) The Department of Labor, Licensing, and Regulation is directed to utilize \$40,000 of the funds appropriated to the department to contract with the Citadel to establish a research project to determine

33 the validity of wind and seismic residential building requirements for South Carolina, as prescribed in the 2015 International

34 Residential Code (IRC). A preliminary report on the findings must be submitted to the SC Building Codes Council by June 30, 2016.

(DMV: Activities Allowed on Special Restricted Driver's License) In the current fiscal year, employing funds authorized 10 or appropriated to the Department of Motor Vehicles pursuant to Section 82, Part IA of this act, the department must include 11 12 employment, school, church-related or sponsored activities, and parentally approved sports activities in the categories for which it may waive or modify restrictions in the special restricted driver's license for certain minors. The licensee must provide the 13 department a statement of the purpose of the waiver or modification of restrictions executed by the parents or legal guardian of the 14 15 licensee and documents executed by church representatives and/or representatives of the sports entity for which the waiver is being 16 requested. 82.10. (DEW: Consortium Contracts: Training-Development Sessions and Media Services) All earmarked funds collected for the 13 LMI - Training-Development Sessions; Media Services and Program Contracts through the Department of Employment and 14 Workforce may be retained by the agency to be used for the exclusive purpose of operating these programs. All funds not expended 15 in the prior fiscal year may be carried forward for use in the current fiscal year. 16 83.3. (DEW: Federal and Earmarked Prior Year Payments) The Department of Employment and Workforce shall be allowed to 17 pay federal and earmarked prior year obligations with current year funds. 18 83.4. (DEW: Transparency of Funding Appropriation) In order to promote accountability and transparency, the Department of 19 Employment and Workforce must provide and release to the public via the agency's website, a report of all aggregate amounts of 20 taxes, fees and payments that were charged, collected and paid by that state agency in the prior fiscal year. For the purpose of 21 efficiency and conservation of resources, this report shall be incorporated into the Trust Fund Report due by October first as required 22 23 by Section 41-33-45 of the 1976 Code. 84.6. (DOT: Meals in Emergency Operations) The Department of Transportation may provide meals to employees of the department who are not permitted to leave assigned duty stations and are required to work during deployment, emergency simulation exercises, and when the Governor declares a state of emergency.

84.7. (DOT: Rest Area Water Rates) For the current fiscal year, rest areas of the Department of Transportation shall be charged
 in-district water rates by providers of water and sewer services, unless the rate currently charged by the provider is less than in district rates.

10 **84.8.** (DOT: Shop Road Farmers Market Bypass Carry Forward) Unexpended funds appropriated for the Shop Road Farmers 11 Market Bypass may be carried forward into the current fiscal year and expended for the matching requirement for the widening and 12 expansion of Leesburg Road from Fairmont to Wildcat Road (Lower Richland roads-Phase I).

84.9. (DOT: Tree Removal) The Department of Transportation is prohibited from using funds authorized by this act for clear cutting, or other similar activities, in the median of Interstate 26 from approximately mile marker 170 to approximately mile marker 199 between Summerville and Interstate 95, except for the following mile marker locations: 170 to 171, 175 to 176, 182 to 183, 187 to 191, and 193 to 199.

84.10. (DOT: Hanahan Permit Application) With the funds authorized for the Department of Transportation, the department shall
 coordinate and facilitate negotiations between the City of Hanahan, the United States Army Corps of Engineers, CSX Railroad, and

19 other applicable entities for the necessary permit required to complete the Railroad Avenue Extension project in the City of Hanahan.

20 The department shall submit any and all necessary applications for the required permit on behalf of the applicable entities no later 21 than June 30, 2016.

22 **84.11.** (DOT: Bridge Replacement in McCormick County) Planning and construction on a new U.S. 378 bridge crossing Lake J.

Strom Thurmond must provide for and allow McCormick County to affix water lines to the new bridge just as the water lines are affixed to the existing bridge. McCormick County shall bear the cost of affixing the water lines to the new bridge.

84.12. (DOT: Project Priority List) From the funds appropriated to the department, the Department of Transportation Commission project priority lists, as required under Act 114 of 2007, shall be published in a conspicuous place on the department's website in a manner easily accessible to the public. The priority lists shall be accompanied by the associated engineering directives explaining the ranking process and methodology for applying the commission approved criteria.

29 **84.13.** (DOT: Sunset Suspended) The provisions of Section 6 of Act 114 of 2007 are suspended for the current fiscal year.

30 84.14. (DOT: CTC Road Program) The Department of Transportation shall distribute the \$70,499,995 appropriated for the

31 County Transportation Committee Road Program pursuant to Section 12-28-2740 of the 1976 Code. County Transportation

32 Committees shall utilize the funds distributed pursuant to this proviso solely for use on the state owned secondary road system for

33 paving, rehabilitation, resurfacing, and/or reconstruction, and bridge repair, replacement, or reconstruction. No funds from this

9	department must develop direct internet access from the department's home page to any document or claim form that may be used
10	by the public to seek reimbursement for vehicle damages caused by poor road conditions. The department must post a link to the
11	documents or claim forms on the department's home page in a prominent, easily viewed location.
12	84.18. (DOT: Pothole Busters) The Department of Transportation shall assemble in each transportation maintenance district
13	Pothole Suppression Teams whose primary responsibility shall be to identify and fill in potholes and perform associated minor
14	maintenance throughout the maintenance district. Each District Engineer must report quarterly to the Secretary of Transportation
15	on the progress of the Pothole Suppression Teams within his district. The report must contain information related to the number
16	and location of potholes filled and associated minor maintenance. The Secretary must make those reports available to the public on

The Hangar Fee Schedule shall be determined by the division and shall not exceed local average market rates. 3 4 Personnel from the agencies owning and/or operating aircraft will be responsible for ground movement of their aircraft. 5 87.5. 20	The study committee shall make a report of its findings and recommendations to the General Assembly during the 2017 legislative

25	92.1. (GOV: Governor's Office Budget) All other provisions of law notwithstanding, the Executive Control of State section and
26	Mansion and Grounds section shall be treated as a single budget section for the purpose of transfers and budget reconciliation.
27	92.2. (GOV: Mansion and Grounds Budget) The Governor's Office of Mansion and Grounds shall not exceed ten percent of its
28	quarterly allocation of funds so as to provide for agency operations on a uniform basis throughout the fiscal year.
29	92.3. (GOV: Mansion and Grounds Maintenance and Complex Facilities) Revenue collected from rental of Mansion Complex
30	facilities and grounds must be retained and expended by the Governor's Office, Mansion and Grounds to support its operations.
31	Unexpended funds shall be carried forward from the prior fiscal year into the current fiscal year and be utilized for the same purposes.
32	92.4. (GOV: Use of Funds Report) In order to ensure transparency and accountability, the Governor's Office of Executive
33	Control of State shall report quarterly to the Senate Finance Committee and House Ways and Means Committee on financial

93.1. (DOA: Development Disabilities Case Coordination System) Of the funds appropriated to the Department of Administration, Office of Executive Policy and Programs, \$50,000 must be used as state match for the Developmental Disabilities Council federal grant. These funds shall be excluded from the Department of Administration's base budget calculation of any across-the-board agency base reductions mandated by the Executive Budget Office or General Assembly.

93.2. (DOA: CCRS Evaluations & Placements) The amount appropriated in this section under Special Items Children's Case 10 Resolution System for Private Placement of Handicapped School-Age Children must be used for expenses incurred in the evaluation 11 of children referred to the CCRS to facilitate appropriate placement and to pay up to forty percent when placement is made in-state 12 and up to thirty percent when placement must be made out-of-state of the excess cost of private placement over and above one-per-13 pupil share of state and local funds generated by the Education Finance Act, and the one-per-pupil share of applicable federal funds; 14 15 provided it has been established that all other possible public placements are exhausted or inappropriate. The balance of funding responsibility necessary to provide the child with services must be determined by the Children's Case Resolution System (CCRS) 16 and apportioned among the appropriate public agencies on the basis of the reasons for the private placement. When the amount 17 appropriated in this section is exhausted, the funding responsibility must be apportioned according to the procedures of the CCRS. 18 93.3. (DOA: CCRS Significant Fiscal Impact) In accordance with Section 20-7-5240(e) of the 1976 Code, "significant fiscal 19 impact" in the current fiscal year shall be defined for each designated agency as the greater of (1) funds appropriated by the General 20 Assembly for the current fiscal year on cases referred to, decided or placed through the Children's Case Resolution System or (2) 21

that agency's assigned shares in the current fiscal year of five cases decided by the Children's Case Resolution System.

93.4. (DOA: Victim/Witness Program Formula Distribution) If funds in the South Carolina Victims' Compensation Fund exceed the amount required to operate the State Office of Victims Assistance and pay claims of crime victims the first \$650,000 of such excess must be used for Victim/Witness programs by distribution to Judicial Circuits based on a formula and criteria developed by the policy committee, and otherwise subject to requirements of Section 60.8.

93.5. (DOA: Physical Abuse Examinations) Of the funds appropriated in this section for Victims' Rights, up to \$120,000 may
 be expended for physical abuse examinations.

93.6. (DOA: Foster Care-Private Foster Care Reviews) The Department of Administration, Office of Executive Policy and Programs, Division of Foster Care is authorized to restructure its programs, including but not limited to, suspending reviews of children privately placed in private foster care and/or changing the location of reviews of children in public foster care, to maintain continuous operations within existing resources as dictated by recent budget reductions. These decisions must be based upon the availability of existing funds. This provision supersedes any previous statutory or regulatory mandate.

93.7. (DOA: Guardian Ad Litem Program) Both the program and the funds appropriated to the Department of Administration,
 Office of Executive Policy and Programs, Division of Children's Services, Guardian ad Litem Program must be administered

separately from other programs within the Division of Children's Services and must be expended for the exclusive use of the Guardian

2 ad Litem Program.

For the current fiscal year, the Department of Revenue is directed to reduce the rate of interest paid on eligible refunds by two 3 4 percentage points. The revenue resulting from this reduction must be used exclusively for operations of the Guardian ad Litem 5 program and be deposited in the State Treasury in a separate and distinct fund known as the "South Carolina Guardian ad Litem 6 Trust Fund." Unexpended revenues in this fund carry forward to succeeding fiscal years, and earnings in this fund must be credited 7 to it. The Guardian ad Litem program may carry forward the other funds authorized herein for its operations from the prior fiscal 8 year into the current fiscal year. **93.8.** (DOA: Continuum of Care Carry Forward) The Department of Administration, Office of Executive Policy and Programs, 9 Division of Continuum of Care may carry forward funds appropriated herein to continue services. 10 93.9. (DOA: Procuring Services) In order to maximize services for victims of crime, if the fulfilling of requirements pursuant 11 to Section 16-3-1410 of the 1976 Code, necessitates hiring any outside entities, the State Office of Victims' Assistance must follow 12 procedures established by the SC Consolidated Procurement Code. Any entity contracting with the agency will submit an annual 13 report by August first to the Governor's Office and to the Chairmen of the Senate Finance Committee and House Ways and Means 14 Committee detailing expenditures from the prior fiscal year in accordance with the State Office of Victims' Assistance. The 15

16 Governor's Office of Executive Policy and Programs is directed to transfer \$122,032 of the funds carried forward from the prior

- fiscal year in the Victims' Compensation Fund, and up to \$41,892 from general funds from Program III.C.1 to pay for any contracts
 or services procured.
- 93.10. (DOA: M.J. "Dolly" Cooper Veterans Cemetery Carry Forward) The Department of Administration, Office of Executive Policy and Programs, Veterans' Affairs Program may carry forward unexpended funds appropriated and/or authorized for the M.J. "Dolly" Cooper Veterans Cemetery from the prior fiscal year and shall use such funds for the same purpose. In addition, any unexpended funds in the Veterans' Affairs Program, including Special Line Items, shall be carried forward from the prior fiscal year into the current fiscal year and used for operation of the M.J. "Dolly" Cooper Veterans Cemetery. Funds carried forward in excess of the amount needed for the operation of the Cemetery may be used for other expenses of the Veterans' Affairs Program. Funds carried forward may not be transferred to any other Department of Administration programs.

93.11. (DOA: Crime Victims Ombudsman) For the current fiscal year, the State Office of Victims Assistance shall transfer
 \$85,000 to the Crime Victims Ombudsman's Office to be used for administrative and operational support.

93.12. (DOA: Veterans' Affairs Budget Reduction Exemption) Funds appropriated for the Department of Administration, Office
 of Executive Policy and Program, Veterans' Affairs Program shall be excluded from the Department of Administration's base budget
 in the calculation of any across-the-board agency base reductions mandated by the Executive Budget Office or General Assembly.

31 93.13. (DOA: Outside Legal Counsel) In the event circumstances necessitate that the Department of Administration, Office of

Executive Policy and Programs acquire the services of outside legal counsel, the Department of Administration must follow
 procedures established by the SC Consolidated Procurement Code.

93.14. (DOA: Carillon Tower) The Department of Administration, Office of Executive Policy and Programs, Veterans' Affairs
 Program shall use any carry forward funds authorized for the M.J. "Dolly" Cooper Veterans Cemetery to construct the Carillon
 Tower to house the sound system used to provide bell tower music for the cemetery.

93.15. (DOA: State House Operation & Maintenance Account) Funds appropriated to the Department of Administration - for 1 2 State House Maintenance & Operations & Renovations must be set aside in a separate account for the operation and maintenance of the State House. The department shall report annually to the State House Committee on the amount expended from this fund. 3 4 93.16. (DOA: Wireless Communications Tower) The Department of Administration is directed to coordinate tower and antenna 5 operations within South Carolina state government. The department shall (1) approve all leases regarding antenna placement on 6 state-owned towers and buildings, (2) coordinate all new tower construction on state-owned property, (3) promote and market excess 7 capacity on the State's wireless communications infrastructure, (4) generate revenue by leasing, licensing, or selling excess capacity on the State's wireless communications infrastructure, and (5) construct new communications assets on appropriate state-owned 8 property for the purpose of generating revenue pursuant to this proviso. All revenue from tower and antenna leases and contracts 9 after July 1, 2001 must be remitted to a separate fund established by the department and shall be transferred to the Educational 10 Television Commission which shall retain and expend such funds for agency operations. The commission shall be authorized to 11 carry forward unexpended funds from the prior fiscal year into the current fiscal year. Agencies owning tower and antenna assets 12 will be allowed to recover expenses associated with implementing this proviso from this fund. The department shall annually report 13 to the Chairmen of the Senate Finance and House Ways and Means Committees by October first of each year all revenue collected 14 15 and disbursed. This report shall also include a summary of each agency's overall revenues, whether retained by the agency or remitted to the separate fund. 16 93.17. (DOA: Compensation - Reporting of Supplemental Salaries) No supplement shall be paid to an agency's employee unless 17 the agency head or designated official of the employing agency, or in the case of supplements paid to college and university 18 presidents, their board of trustees, has approved the conditions and amount of salary supplement. Any compensation, excluding 19 travel reimbursement, from an affiliated public charity, foundation, clinical faculty practice plan, or other public source or any 20 supplement from a private source to the salary appropriated for a state employee and fixed by the State must be reported by the 21 employing agency to the Department of Administration. The report must include the employee's base salary, amount of the 22 23 supplement, source of the supplement, and any condition of the supplement. The employing agency must report this information on 24 or before August thirty-first of each year and must include the total amount and source of the salary supplement received by the 25 employee during the preceding fiscal year (July first through June thirtieth). The Department of Administration shall formulate

policies and procedures to ensure compliance with the reporting provisions of this proviso. Copies of the reports shall be made available to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee, upon request.

93.18. (DOA: Compensation Increase - Appropriated Funds Ratio) Appropriated funds may be used for compensation increases
 for classified and unclassified employees and agency heads only in the same ratio that the employee's base salary is paid from
 appropriated sources.

93.19. (DOA: Local Provider Health Insurance) The local health care providers of the Department of Disabilities and Special
 Needs shall be awarded funding increases as prescribed for state agencies to cover the employer's share for the cost of providing
 health and dental insurance to their employees.

35 93.20. (DOA: Military Service) Notwithstanding the provisions of Section 8-11-610 of the 1976 Code, a permanent full-time 36 state employee who serves on active duty as a result of an emergency or conflict declared by the President of the United States, and

1 performs such duty, may use up to forty-five days of accumulated annual leave and may use up to ninety days of accumulated sick

2 leave in a calendar year as if it were annual leave.

93.21. (DOA: Antenna and Tower Placement) All leases for antenna and tower operations within institutions of higher learning
 campuses must conform to master plans for such property, as determined solely by the institution of higher learning.

5 93.22. (DOA: First Responder Interoperability) The Department of Administration is directed to administer and coordinate First Responder Interoperability operations for the statewide Palmetto 800 radio system to better coordinate public safety disaster 6 7 responses and communications. First Responder Interoperability administration and coordination shall be funded as provided in this 8 act. The cost-proportional funds shall be utilized for radio user fees of state agencies and public safety first responders (Fire, EMS and Law Enforcement) that participate in the statewide Palmetto 800 radio system (Palmetto 800 participants). The Department of 9 Administration, in consultation with the State Law Enforcement Division, the Department of Public Safety, and the State Emergency 10 Management Division, and a representative of the South Carolina Sheriff's Association, shall set a baseline number of radios used 11 12 by each Palmetto 800 participant based on the technical aspects of the Palmetto 800 radio system and the jurisdictional requirements of the participant. If a Palmetto 800 participant reduces the baseline number of radios in use, the amount of funds allocated for the 13 participant's radio user fees shall be reduced in a proportional amount. The funds shall also be utilized to provide private county and 14 city radio systems with grant funds to be used for purchases of equipment that support interoperability with the statewide Palmetto 15 800 radio system and its users. Grant funds shall be allocated to private county and city radio systems based on the criteria used for 16 Palmetto 800 Participants and in amounts proportional to the amounts allocated to support the per-site radio user fees of Palmetto 17 800 participants. A matching share is required by a Palmetto 800 participant or by a private county or city radio system in order to 18 qualify for receipt of funds pursuant to this proviso. Each fiscal year the Department of Administration shall establish the level of 19 match required based upon funding provided by this act. These entities shall be required to furnish such documentation as may be 20 required by the department to verify that the matching funds requirement is met. Upon funding state agency and public safety first 21 responder user fees and private county and city equipment purchases, any remaining funds may be used to enhance and expand the 22 23 statewide Palmetto 800 radio system. All funds shall be held in a separate account established by the department for the purposes set forth herein. Any unexpended portion of these funds may be carried forward and used for the same purpose. In the calculation 24 25 of any across-the-board budget reduction mandated by the Executive Budget Office or General Assembly, the amount appropriated to the Department of Administration for First Responder Interoperability must be excluded from the department's base budget. 26 27 The Department of Administration shall provide a report on the status of the integration of the statewide Palmetto 800 radio system 28 which shall include, but not be limited to, a list of entities who are not integrated into the system as of the end of the immediately

29 preceding fiscal year and the reason why they are not integrated. The report shall be submitted by October first, of the current fiscal 30 year to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

93.23. (DOA: Sale of Surplus Real Property) Up to fifty percent of the proceeds, net of selling expenses, from the sale of surplus real properties shall be retained by the Department of Administration and used for the deferred maintenance of state-owned buildings. The remaining fifty percent of the net proceeds shall be returned to the agency that the property is owned by, under the control of, or assigned to and shall be used by that agency for nonrecurring purposes. This provision applies to all state agencies and departments except: institutions of higher learning; the Public Service Authority; the Ports Authority; the MUSC Hospital Authority; the Myrtle Beach Air Force Redevelopment Authority; the Department of Transportation; the Columbia State Farmers Market; the Department

of Agriculture's Columbia Metrology Lab building and property; the Charleston Naval Complex Redevelopment Authority; the 1 2 Department of Commerce's Division of Public Railways; the Midlands Technical College Enterprise Campus Authority; the Trident Technical College Enterprise Campus Authority; the Commissioners residence at the Department of Corrections and the Educational 3 4 Television Commission's Key Road property. 5 The Educational Television Commission shall be authorized to retain the net proceeds from the sale of its property on Key Road, and such proceeds may be used for the renovation of the ETV Telecommunications Center and other maintenance and operating 6 7 expenses. If it is determined that sufficient net proceeds are not to be derived from the sale of its property on Key Road to cover the 8 cost of all renovations of the Telecommunications Center, the property on Key Road shall not be sold. Any proposed sale hereunder shall, prior to said sale, be submitted to the Department of Administration for approval as being in compliance with the requirements 9 10 of this subsection. The Department of Corrections shall be authorized to retain the net proceeds from the sale of the residence provided for the 11 Commissioner of the Department of Corrections and use such proceeds for deferred maintenance needs at the Department of 12 Corrections. 13 The Forestry Commission shall be authorized to retain the net proceeds from the sale of surplus land for use in firefighting 14 operations and replacement of firefighting equipment. 15 The Department of Natural Resources shall be authorized to retain the net proceeds from the sale of existing offices originally 16 purchased with a federal grant or with restricted revenue from hunting and fishing license sales for the improvement, consolidation, 17 and/or establishment of regional offices and related facilities. 18 The Department of Vocational Rehabilitation shall be authorized to retain the net proceeds from the sale of 3.205 acres located at 19 22861 Highway 76 East in Clinton, South Carolina to be used for capital projects and deferred maintenance. 20 The Department of Agriculture, the Educational Television Commission, the Department of Corrections, the Department of 21 Natural Resources, the Forestry Commission, and the Department of Vocational Rehabilitation shall annually submit a report, within 22 23 sixty days after the close of the fiscal year, to the Senate Finance Committee and the House Ways and Means Committee on the 24 status of the sale of the identified property and a detailed accounting on the expenditure of funds resulting from such sale. 25 This provision is comprehensive and supersedes any conflicting provisions concerning disposition of state-owned real property 26 whether in permanent law, temporary law or by provision elsewhere in this act. Any unused portion of these funds may be carried forward into succeeding fiscal years and used for the same purposes. 27 93.24. (DOA: Compensation - Agency Head Salary) In the event of an agency head or technical college president vacancy, the 28 governing board of the agency or the Governor, or the appointing authority of a technical college president, must have the prior 29 favorable recommendation of the Agency Head Salary Commission to set, discuss, offer, or pay a salary for the agency head or 30 technical college president at a rate that exceeds the minimum of the range established by the Agency Head Salary Commission. No 31 agency head or technical college president shall be paid a salary higher than that recommended by the commission. Boards and 32 commissions, or the Governor if he is the appointing authority, of newly created agencies or technical colleges shall not offer or pay 33 a salary to a prospective agency head until a salary range has been established and the salary approved by the Agency Head Salary 34 Commission. The funding of the salaries of any agency head or technical college president should come from resources within the 35 agency. The Department of Administration shall contract every four years for a study of agency head and technical college president 36

1 compensation. The cost of the study must be shared by the participating agencies. The staff of the State Fiscal Accountability

2 Authority shall serve as the support staff to the Agency Head Salary Commission. Limited only by the maximum of the respective

3 salary range, the General Assembly authorizes the respective appointing authority for an agency head or technical college president

4 to provide salary increases for an agency head or technical college president not to exceed that recommended by the Agency Head

5 Salary Commission. No agency head or technical college president shall be paid less than the minimum of the pay range nor receive

6 an increase that would have the effect of raising the salary above the maximum of the pay range.

7 93.25. (DOA: Cyber Security) All state agencies must adopt and implement cyber security policies, guidelines and standards 8 developed by the Department of Administration. The department may conduct audits on state agencies except public institutions of higher learning, technical colleges, political subdivisions, and quasi-governmental bodies as necessary to monitor compliance with 9 established cyber security policies, guidelines and standards. Upon request, public institutions of higher learning, technical colleges, 10 political subdivisions, and quasi-governmental bodies shall submit sufficient evidence that their cyber security policies, guidelines 11 12 and standards meet or exceed those adopted and implemented by the department. In addition, while agencies retain the primary responsibility and accountability for ensuring responses to breach incidents comply with federal and state laws, the department shall 13 be informed of all agency cyber security breaches, and is authorized to oversee incident responses in a manner determined by the 14 department to be the most prudent. Upon request of the Department of Administration for information or data, all agencies must 15 fully cooperate with and furnish the department with all documents, reports, assessments, and any other data and documentary 16 information needed by the department to perform its mission and to exercise its functions, powers and duties. The Judicial and 17 Legislative Branches are specifically exempt from the requirements set forth herein. 18

93.26. (DOA: Holidays) When a legal holiday specified in Section 53-5-10 of the 1976 Code falls on Sunday, the following 19 Monday and when a holiday specified in that section falls on Saturday, the preceding Friday next preceding is deemed a public 20 holiday for all of the purposes. If either the following Monday or the preceding Friday is also a legal holiday, then the State Human 21 Resources Director will designate the day upon which the legal holiday will be observed by state employees. To insure that no more 22 23 than the legal holidays specified in Section 53-5-10 are observed in the calendar year, a New Year's Day that falls on Saturday must 24 be observed on the following Monday. All bills of exchange, checks, and promissory notes which would otherwise be presentable 25 for acceptance or payment on a Monday or Friday observed as a holiday pursuant to this section are deemed presentable for acceptance or payment on the secular or business day succeeding the holiday. 26

93.27. (DOA: Nuclear Advisory Council) The Office of Regulatory Staff shall reimburse the Department of Administration for
 travel expenses associated with the Governor's Nuclear Advisory Council from the SC Energy Office's radioactive waste funds.

29 93.28. (DOA: Classification and Compensation System Study) (A) The Department of Administration, Human Resources

30 Division shall enter into a contract to conduct an in-depth study of the state's classification and compensation system. For purposes

31 of the study, compensation shall include comprehensive employee benefits. The vendor must have experience with a state's

32 compensation system. The study shall include, but not be limited to:

- 33 (1) methods used to develop and determine position classifications;
- 34 (2) methods used to set pay grade minimum, midpoint, and maximum;
- 35 (3) appropriate market comparisons including, but not limited to, the private sector and local governments;
- 36 (4) methods to minimize salary disparities within an agency and within state government;

1	(5) methods of developing and sustaining a consistent long-term salary increase administrative policy for state government;
2	(6) recruitment and retention tools including, but not limited to, the impact of the Teacher and Employee Retirement
3	Incentive program;
4	(7) a process to address longevity pay deficits that currently exist;
5	(8) a state compensation philosophy statement;
6	(9) an analysis of merit-based compensation for employees and
7	(10) an analysis of unnecessary, underutilized, and duplicative positions in order to use that pay to increase salaries of existing
8	employees.
9	The study should also include interviews with agency heads and human resource staff from state agencies of various sizes. The
10	cost of the study shall not exceed \$300,000.
11	The findings of the study along with an implementation plan outlining the steps, sequences, and costs for implementing study
12	recommendations and findings shall be submitted by January 4, 2016 to the Classification and Compensation System Study
13	Committee as defined herein.
14	(B) There is created the Classification and Compensation System Study Committee which shall examine the findings and
15	recommendations submitted by the Department of Administration, Human Resources Division on the state's classification and
16	compensation system.
17	The committee shall be composed of eleven members, which shall be appointed as follows: two members appointed by the
18	Governor; two members appointed by the President Pro Temporary of the Senate; two members appointed by the Speaker of the
19	House of Representatives; two members appointed by the Chairman of the Senate Finance Committee; two members appointed by
20	the Chairman of the House Ways and Means Committee; and one member appointed by the SC State Employees Association. The
21	members shall elect a chairman at the first meeting of the committee.
22	No later than six months after the date from which a vendor contract has been signed, the committee shall prepare and deliver a
23	report and recommendation to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means
24	Committee.
25	Staff for the committee shall be provided by the Senate Finance Committee and the House Ways and Means Committee. Members
26	of the study committee shall serve without compensation for per diem, mileage, and subsistence.
27	93.29. (DOA: Office of Victim Assistance) For the current fiscal year, The State Office of Victim Assistance may enter into
28	memoranda of agreement with third-party victim service providers to secure emergency medical, transportation, or other crisis
29	stabilization services on a reimbursable basis. Such agreements shall not allow for more than eight percent of the total reimbursement
30	to cover a provider's administrative, marketing, and advocacy costs. Annually, and no later than October first of each year, the State
31	Office of Victim Assistance shall report to the Governor, the Chairman of Senate Finance Committee, and the Chairman of House
32	Ways and Means Committee on the performance of third-party providers and the use of funds authorized pursuant to this provision
33	in the prior fiscal year.
34	93.30. (DOA: Emerging Leaders Program) (A) With the funds appropriated to the Office of Human Resources, the Department
35	of Administration shall establish an Emerging Leaders Program (ELP) that is designed to identify and develop the next generation
36	of South Carolina state government's leaders by attracting and/or retaining imminent or recent graduates of relevant post-

baccalaureate programs to careers in public service. In order to cultivate effective and innovative leaders with demonstrated problem solving capabilities, the program shall be cohort-based and require participants to complete rotations in a variety of functional roles
 that focus on budgeting, policymaking, operations/service delivery, and other appropriate/elective fields. These rotations shall be
 augmented by and interspersed with classroom-based modules on organizational behavior, decision-making processes, principles of

15 (5) 'Identity theft resolution services' means products and services that attempt to mitigate the effects of identity fraud after 16 personally identifiable information has been fraudulently obtained by a third party, including, but not limited to, identity theft 17 insurance and other identity theft resolution services that are designed to resolve actual and potential identity theft and related matters.

18 (6) 'Person' shall mean an individual, corporation, firm, association, joint venture, partnership, limited liability corporation,

20 (7) - 'Personally identifiable information' means information that can be used to uniquely identify, contact, or locate a single
 21 person or can be used with other sources to uniquely identify a single individual, including, but not limited to, social security numbers,

(RSIC: Retirement Investment Commission Audit) For Fiscal Year 2015-16 2016-17, the provisions of Section 9-16-380 requiring the Inspector General to employ a private audit firm to perform the fiduciary audit on the Retirement System Investment 10 Commission as required by Section 9-16-380 of the 1976 Code shall be suspended. Any savings generated by not conducting the 11 audit shall be used to conduct audits required by Section 9-4-40 of the 1976 Code. 12 99.2. (RSIC: Semi-Annual Meetings) The Retirement System Investment Commission shall be required to appear before the 13 House Ways and Means Committee's, Legislative, Executive and Local Government Subcommittee on a semi-annual basis at the 14 15 request of the subcommittee. The purpose of the meeting shall include, but not be limited to, the review of quarterly investment

(ADJ: Meals in Emergency Operations Centers) The cost of meals, or the advanced purchase of food products to be stored 12 and prepared for meals, may be provided to state employees who are required to work at the State Emergency Operations Centers 13 during actual emergencies and emergency simulation exercises when they are not permitted to leave their stations. 14 15 100.7. (ADJ: Educational Seminar Revenue) All revenue earned from educational seminars shall be retained by the agency to be used for the printing of materials and other expenses related to conducting the seminars. (ADJ: Retention of Lease Property Revenue) The Adjutant General is authorized to lease all real property under the control 18 of SCMD. These funds may not be used for any other purpose. **100.13.** (ADJ: Emergency Commodities) The Emergency Management Division shall be allowed to rotate and replace water, 3 4 Meals Ready to Eat (MREs), and other essential emergency commodities housed in the state's Logistic Center through the provision 5 of said commodities to neighboring states, counties, municipalities and other state agencies, and shall be allowed to accept 6 compensation for said commodities not to exceed replacement costs. 3 **101.1.** (ELECT: County Boards of Voter Registration and Elections Compensation) The amounts appropriated in this section for 4 "County Boards of Voter Registration and Elections Commissioners Members," shall be disbursed annually to the County Treasurer 5 at the rate of \$1,500 \$2,500 for each member, not to exceed \$12,500 per county. The County Treasurer shall use these funds only 6 for the compensation of County Boards of Voter Registration and Elections Commissioners Members. Any funds not used for this 7 purpose shall be returned to the State Treasurer. These funds are exempted from mandated budget reductions. In addition, in the calculation of any across the board agency base reductions mandated by the Executive Budget Office or the General Assembly, the 8 amount of funds appropriated for compensation of County Boards of Voter Registration and Elections Commissioners Members shall 9 be excluded from the agency's base budget. 10 101.2. (ELECT: Elections Managers & Clerks Per Diem) Managers and clerks of state and county elections shall receive a per 11 diem of \$60.00; \$100.00 for working on election day and \$60.00 for training. Clerks shall receive \$60.00 for additional clerk 12 responsibilities on election day but managers shall not be paid for more than two days for any election and elerks for not more than 13 three days for any election. The commission may adjust the per diem of \$60.00 \$100.00 for the managers and clerks of the statewide 14 election to a higher level only to the extent that the appropriation for the statewide election is sufficient to bear the added cost of 15

increasing the per diem and the cost of the statewide election. Up to three additional managers per county may be appointed to assist county boards of voter registration and elections with the absentee/fail safe voting process prior to, on Election Day, and immediately following statewide elections. (ELECT: Sale of Lists Revenue Carry Forward) Any revenue generated from the sale of election lists may be retained and expended by the South Carolina Election Commission to reimburse the Department of Administration, for the printing of such lists and to pay expenses of postage and shipment of these lists to electors who purchase them. After such reimbursement has been made an amount, not to exceed \$400,000, shall be used for nonrecurring expenses in conjunction with extraordinary special election and legal costs and costs for upgrading the Statewide Voter Registration System. Any balance in the Sale of Lists Account on June thirtieth, of the prior fiscal year may be carried forward and expended for the same purposes during the current fiscal year.

101.5. (ELECT: Budget Reduction Exemption) Funds appropriated for recurring and nonrecurring general and primary election expenses are exempted from mandated across the board reductions. In addition, in the calculation of any across the board agency base reductions mandated by the Executive Budget Office or the General Assembly, the amount of funds appropriated for recurring and nonrecurring primary and general election expenses shall be excluded from the agency's base budget.

101.7. (ELECT: Training & Certification Program) All members and staff of County Boards of Voter Registration and Elections will receive a common curriculum to include core courses on the duties and responsibilities of county boards of voter registration and elections and electives to promote quality service and professional development. The State Election Commission shall make these courses available in various locations, including but not be limited to, the upstate, coastal, and midlands areas of the state. Up to \$35,000 of revenue generated by charging a fee to attend these courses may be retained and expended by the South Carolina Election Commission to help cover the cost of providing the training. Any balance in the training and certification account on June thirtieth, of the prior fiscal year may be carried forward and expended for the same purpose during the current fiscal year.

The State Election Commission is required to withhold the stipend of members who do not complete the training and certification 11 program as required in Section 7-5-10 of the 1976 Code. Additionally, funds will also be withheld if a board or commission member 12 completes the training and certification program, but fails to complete at least one training course per year. The board or commission 13 member and members of that county's legislative delegation will be notified of the withholding of the stipend and the requirements 14 needed to bring the member into compliance with the law. If a board or commission member cannot complete the program or 15 complete the required continuing education due to extenuating circumstances, the board or commission member must submit a 16 written request to the county legislative delegation for approval or funds will continue to be withheld as described in this proviso.  federal funds received through the Help America Vote Act (HAVA) shall be moved to a restricted account in order that the funds

 of the boundary between the states of South Carolina and North Carolina.

An affected party disagreeing with a county boundary certified by the Revenue and Fiscal Affairs Office may appeal the certification to the South Carolina Administrative Law Court, which is vested with jurisdiction to hear and decide the case subject to the provisions of Section 1-23-380 of the 1976 Code, except that the case must be heard 'de novo.' Additionally, for purposes of determining the timelines of an appeal, notice is deemed to have been provided on the date of the written notice to affected parties. An affected party has sixty calendar days from the date of a written notice sent to the affected party to file an appeal with the Administrative Law Court.

102.2. (RFAO: Election File Merge) In order to assist the County Registration and Election Commissions to ensure that registered 16 voters are assigned to proper election districts, the Revenue and Fiscal Affairs Office, in conjunction with the South Carolina Election 17 Commission, shall merge the voter registration file with the office's Geocoded Address List and the district boundaries of the 18 Congress, South Carolina Senate, South Carolina House of Representatives, county councils, and such other districts as the office 19 possesses official district boundary records in electronic format. The merged systems will allow the Revenue and Fiscal Affairs 20 Office to provide the respective county officials with a list of potential voters who are possibly assigned to the wrong election district. 21 File merger is required only for those districts in which elections are scheduled. Counties and municipalities shall release GIS to the 22 23 Revenue and Fiscal Affairs Office upon the office's written request. Written request must be sent to the chief administrative officer 24 of the county or municipality and advise the county or municipality that failure to comply within thirty days of request may result in 25 the withholding of ten percent of the county's or municipality's state aid. The Executive Director of the Revenue and Fiscal Affairs 26 Office may grant additional time for good cause and must waive release if the county or municipality does not possess GIS data. For counties and municipalities that possess GIS data but do not release it, the Executive Director of the Revenue and Fiscal Affairs 27 28 Office shall notify the State Treasurer of the failure to comply with this provision after the required notice. Notification shall result in the withholding of ten percent of subsequent payments of state aid to the entity until the GIS data is provided. Municipal and 29 county data acquired by the Revenue and Fiscal Affairs Office in the course of performing its responsibilities may be used for other 30 31 functions of the office as well as shared with other state agencies. For this provision GIS data includes, but is not limited to, road centerlines; orthophotography; parcel boundaries; address points; political boundaries; and administrative boundaries. 32 102.3. The purpose of the Warehouse is to ensure that the operation 9 of health and human services agencies may be enhanced by coordination and integration of client information. Client data is defined 10 as person-level data that is created, received, and/or maintained by state agencies and other entities required to report client 11 information to the Revenue and Fiscal Affairs Office under this provision. To integrate client information, client data from health 12 and human services state agencies will be linked to improve client outcome measures, enabling state agencies to analyze coordination 13 and continuity of care issues. The addition of these data will enhance existing agency systems by providing client data from other 14 state agency programs to assist in the provision of client services. Certain client information shall be delivered to the Revenue and 15 Fiscal Affairs Office in order to assist in the development and maintenance of this Warehouse. These agencies and departments shall collect and provide client data in formats and schedules to be specified by the Revenue and 1 2 Fiscal Affairs Office (Office). The Office shall establish a Memorandum of Agreement with each agency, department or division. These Memorandums of Agreement shall specify, but are not limited to, the confidentiality of client information, the conditions for 3 4 the release of data that may identify agencies, departments, divisions, programs and services, or clients, any restrictions on the release 5 of data so as to be compliant with state and federal statutes and regulations on confidentiality of data, conditions under which the 6 data may be used for research purposes, and any security measures to be taken to insure the confidentiality of client information. 7 To ensure accountability and the coordinated, efficient delivery of health and human services, the Office shall implement, in 8 consultation with state health and human services agencies and other entities as deemed necessary by the Office, an integrated data system that includes client data from all participating agencies. 9 In order to provide for inclusion of other entities into the South Carolina Health and Human Services Data Warehouse and other 10 research and analytic-oriented applications that will assist the state in the efficient and effective provision of services, the Office shall 11 have the authority to enter into agreements or transactions with any federal, state or municipal agency or other public institution or 12 with any private individual, partnership, firm, corporation, association or other entity to provide statistical, research and information 13 dissemination services including, but not limited to, program and outcomes evaluation, program monitoring/surveillance, projects to 14 determine the feasibility of data collection and/or analyses, information dissemination and research. The confidentiality of data 15 collected under these initiatives shall comply with applicable state and federal laws governing the privacy of data. The Office shall 16 have the power to promulgate regulations, policies and procedures, in consultation with the participating agencies, for the 17 development, protection and operation of the Data Warehouse, other research and analytic-oriented applications, and their underlying 18 19 processes. The Office shall develop internet-accessible secure analytic query tools (such as analytic cubes) using integrated client data from 20 the Warehouse. All agencies shall cooperate with the Office in the development of these analytic tools. It is the intent of this provision 21 that the analytic tools developed under this provision shall be made available to members of the South Carolina General Assembly 22 23 and their research staff members, state agencies, and researchers. To that end, the Office shall, in consultation with the participating 24 agencies, promulgate regulations addressing access to and use and release of information generated through use of the query tools. 25 All state agencies participating in the Warehouse shall utilize it and its associated software applications in the day-to-day operation

of their programs and for coordination, collaboration, program evaluation and outcomes analysis. 12 **113.1.** (AS-TREAS: Veterans' Affairs-Aid to Counties) In the allocation of the appropriation in Part IA, Section 113, as adjusted 13 for "Aid to County Veteran Offices," each county shall receive an effective annual amount equal to one hundred percent of the 14 amount allocated to it for the prior fiscal year plus an amount equivalent to base pay increases for state employees, less any 15 adjustments made for budget reductions. This allocation shall be distributed on a quarterly basis to the County Treasurer who will 16 handle and distribute these monies for the sole benefit and use of the County Veterans' Affairs Offices.

The amounts appropriated in Part IA, Section 113 for Clerks of Court, Probate Judges, Sheriffs, Register of Deeds, Coroners,

Auditors, and Treasurers shall be exempt from any across the board cut mandated by the Executive Budget Office or General Assembly. However, the governing body of a county may reduce the expenditures in the operation of the offices of these officials

(GP: State Institutions - Revenues & Income) The University of South Carolina, Clemson University, the Medical 21 University of South Carolina (including the Medical University Hospital), The Citadel, Winthrop University, South Carolina State 22 23 University, Francis Marion University, University of Charleston, Lander University, Coastal Carolina University, and the Wil Lou 24 Gray Opportunity School shall remit all revenues and income, collected at the respective institutions, to the State Treasurer according 25 to the terms of Section 117.1 of this act, but all such revenues or income so collected, except fees received as regular term tuition, 26 matriculation, and registration, shall be carried in a special continuing account by the State Treasurer, to the credit of the respective institutions, and may be requisitioned by said institutions, in the manner prescribed in Section 11-3-185 of the 1976 Code, and 27 expended to fulfill the purpose for which such fees or income were levied, but no part of such income shall be used for permanent 28 improvements without the express written approval of the State Fiscal Accountability Authority and the Joint Legislative Capital 29 Bond Review Committee; and it is further required that no such fee or income shall be charged in excess of the amount that is 30 31 necessary to supply the service, or fulfill the purpose for which such fee or income was charged.  subsistence expenses shall be sufficient to fully cover the total direct operating and capital expenses of providing such facilities and
 services over their expected useful life except those operating or capital expenses related to the removal of asbestos.

(2) Student activity fees may be fixed at such rates as the respective Boards shall deem reasonable and necessary.

117.12. (GP: Tech Educ. Colleges Student Activity Fees) Notwithstanding any other provisions of this act, funds at technical education colleges derived wholly from the activities of student organizations and from the operations of canteens and bookstores may be retained by the college and expended only in accord with policies established by the respective college's area commission and approved by the State Board for Technical and Comprehensive Education.

117.13. (GP: Discrimination Policy) It is the policy of the State of South Carolina to recruit, hire, train, and promote employees without discrimination because of race, color, sex, national origin, age, religion or physical disability. This policy is to apply to all levels and phases of personnel within state government, including but not limited to recruiting, hiring, compensation, benefits, promotions, transfers, layoffs, recalls from layoffs, and educational, social, or recreational programs. It is the policy of the State to take affirmative action to remove the disparate effects of past discrimination, if any, because of race, color, sex, national origin, age, religion or physical disability.

Each state agency shall submit to the State Human Affairs Commission employment and filled vacancy data by race and sex by October thirty-first, of each year.

In accordance with Section 1-13-110 of the 1976 Code, as amended, the Human Affairs Commission shall submit a report on the status of state agencies' Affirmative Action Plans and Programs to the General Assembly by February first each year. This report shall contain the total number of persons employed in each job group, by race and sex, at the end of the preceding reporting period,

36 a breakdown by race and sex of those hired or promoted from within the agency during the reporting period, and an indication of

whether affirmative action goals were achieved. For each job group referenced in the Human Affairs report, where the hiring of 1 2 personnel does not reflect the percentage goals established in the agency's affirmative action plan for the year in question, the state agency shall submit a detailed explanation to the Human Affairs Commission by February fifteenth, explaining why goals were not 3 4 achieved. 5 The Human Affairs Commission shall review the explanations and notify the Department of Administration of any agency not in 6 satisfactory compliance with meeting its stated goals. 7 The Department of Administration shall notify any agency not in compliance that their request for additional appropriations for 8 the current appropriation cycle, may not be processed until such time as the Department of Administration, after consultation with the Human Affairs Commission, is satisfied that the agency is making a good faith effort to comply with its affirmative action plan, 9 and that the compliance must be accomplished within a reasonable length of time to be determined by the mission and circumstances 10 of the agency. This requirement shall not affect additional appropriation requests for public assistance payments or aid to entities. 11 This section does not apply to those agencies that have been exempted from the reporting requirements of the Human Affairs 12 Commission. 13

14 **117.14.** (GP: Personal Service Reconciliation, FTEs) In order to provide the necessary control over the number of employees,
 the Executive Budget Office is hereby directed to maintain close supervision over the number of state employees, and to require
 specifically the following:

17 (1) That no state agency exceed the total authorized number of full-time equivalent positions and those funded from state 18 sources as provided in each section of this act except by majority vote of the State Fiscal Accountability Authority.

(2) That the Executive Budget Office shall maintain and make, as necessary, periodic adjustments thereto, an official record
 of the total number of authorized full-time equivalent positions by agency for state and total funding sources.

(a) That within thirty days of the passage of the Appropriation Act or by August first, whichever comes later, each agency 21 of the State must have established on the Executive Budget Office records all positions authorized in the Act. After that date, the 22 23 office shall delete any non-established positions immediately from the official record of authorized full-time equivalent positions. 24 No positions shall be established by the office in excess of the total number of authorized full-time equivalent positions. Each agency 25 may, upon notification to the Executive Budget Office, change the funding source of state FTE positions established on the Executive 26 Budget Office records as necessary to expend federal and other sources of personal service funds to conserve or stay within the state appropriated personal service funds. No agency shall change funding sources that will cause the agency to exceed the authorized 27 number of state or total full-time equivalent positions. Each agency may transfer FTE's between programs as needed to accomplish 28 29 the agency mission.

30 (b) That by September thirtieth, the office shall prepare a personal service analysis, by agency, which shows the number 31 of established positions for the fiscal year and the amount of funds required, by source of funds, to support the FTE's for the fiscal 32 year at a funding level of one hundred percent. The office shall then reconcile each agency's personal service detail with the agency's 33 personal service appropriation as contained in the Act adjusted for any pay increases and any other factors necessary to reflect the 34 agency's personal service funding level. The office shall provide a copy of each agency's personal service reconciliation to the 35 Senate Finance and House Ways and Means Committees.

1	(c) That any position which is shown by the reconciliation to be unfunded or significantly underfunded may be deleted at

5	(b) The state FTE shall be derived by multiplying the state percentage of budgeted funds for each position by the FTE for
6	that position.
7	(c) All institutions of higher education shall use a value of 0.75 FTE for each position determined to be full-time faculty
8	with a duration of nine months.
9	The FTE method of accounting shall be utilized for all authorized positions.
10	(4) That the number of positions authorized in this act shall be reduced in the following circumstances:
11	(a) Upon request by an agency.
12	(b) When anticipated federal funds are not made available.
13	(c) When the Executive Budget Office, through study or analysis, becomes aware of any unjustifiable excess of positions
14	in any state agency.
15	(5) That the Executive Budget Office shall annually reconcile personal service funds with full-time employee count. Unfunded
16	positions will be eliminated no later than January fifteenth of the current fiscal year unless specifically exempted elsewhere in this
17	act or by the Executive Budget Office. The Executive Budget Office must report the full-time employee count and unfunded position
18	status to the Senate Finance Committee and the Ways and Means Committee by February first of the current fiscal year.
19	(6) That no new permanent positions in state government shall be funded by appropriations in acts supplemental to this act but
20	temporary positions may be so funded.
21	(7) That the provisions of this section shall not apply to personnel exempt from the State Classification and Compensation
22	Plan under item I of Section 8-11-260 of the 1976 Code.
23	The Governor, in making his appropriation recommendations to the Ways and Means Committee, must provide that the level of
24	personal service appropriation recommended for each agency is at least ninety-seven percent of the funds required to meet one
25	hundred percent of the funds needed for the full-time equivalents positions recommended by the Governor (exclusive of new
26	positions).
27	117.15. (GP: Allowance for Residences & Compensation Restrictions) That salaries paid to officers and employees of the State,
28	including its several boards, commissions, and institutions shall be in full for all services rendered, and no perquisites of office or of
29	employment shall be allowed in addition thereto, but such perquisites, commodities, services or other benefits shall be charged for
30	at the prevailing local value and without the purpose or effect of increasing the compensation of said officer or employee. The charge
31	for these items may be payroll deducted at the discretion of the Comptroller General or the chief financial officer at each agency
32	maintaining its own payroll system. This shall not apply to the Governor's Mansion, nor to guards at any of the state's penal
33	institutions and nurses and attendants at the Department of Disabilities and Special Needs, and registered nurses providing clinical
33 34	care at the MUSC Medical Center, nor to the Superintendent and staff of John de la Howe School, nor to the cottage parents and staff
34 35	
	of Wil Lou Gray Opportunity School, nor to full-time or part-time staff who work after regular working hours in the SLED
36	Communications Center or Maintenance Area, nor to adult staff at the Governor's School for Science and Mathematics and the

1 Governor's School for Arts and Humanities who are required to stay on campus by the institution because of job requirements or

2 program participation. Any state institution of higher learning may provide complimentary membership privileges to employees

3 who work at their wellness centers. The presidents of those state institutions of higher learning authorized to provide on-campus

4 residential facilities for students may be permitted to occupy residences on the grounds of such institutions without charge.

5 Any state institution of higher learning may provide a housing allowance to the president in lieu of a residential facility, the amount 6 to be approved by the State Fiscal Accountability Authority.

7 That the following may be permitted to occupy residences owned by the respective departments without charge: the Farm Director, 8 Farm Managers, and Specialists employed at the Wateree River Correctional Institution; the South Carolina State Commission of Forestry fire tower operators, forestry aides, and caretaker at central headquarters; the Department of Natural Resources' Game 9 Management Personnel, Fish Hatchery Personnel, and Fort Johnson Superintendent; the Department of Parks, Recreation and 10 Tourism field personnel in the State Parks Division; Director of Wil Lou Gray Opportunity School; President of the School for the 11 Deaf and the Blind; houseparents for the Commission for the Blind; South Carolina Department of Health and Environmental Control 12 personnel at the State Park Health Facility and Camp Burnt Gin; Residence Life Coordinators at Lander University; Residence Life 13 Directors, temporary and transition employees, student interns, and emergency personnel at Winthrop University; Farm 14 Superintendent at Winthrop University; Residence Hall Directors at the College of Charleston; the Department of Disabilities and 15 Special Needs' physicians and other professionals at Whitten Center, Clemson University Off-Campus Agricultural Staff and 16 Housing Area Coordinators; and TriCounty Technical College's Bridge to Clemson Resident and Area Directors; and housing 17 maintenance night supervisors, residence life directors, temporary and transition employees, and emergency medical personnel 18 occupying residences owned by the University of South Carolina. Except in the case of elected officials, the fair market rental value 19 of any residence furnished to a state employee shall be reported by the state agency furnishing the residence to the Agency Head 20 Salary Commission, and the Department of Administration by October first of each fiscal year. 21

22 All salaries paid by departments and institutions shall be in accord with a uniform classification and compensation plan, approved 23 by the Department of Administration, applicable to all personnel of the State Government whose compensation is not specifically 24 fixed in this act. Such plan shall include all employees regardless of the source of funds from which payment for personal service is 25 drawn. The Department of Administration is authorized to approve temporary salary adjustments for classified and unclassified 26 employees who perform temporary duties which are limited by time and/or funds. When approved, a temporary salary adjustment shall not be added to an employee's base salary and shall end when the duties are completed and/or the funds expire. Academic 27 personnel of the institutions of higher learning and other individual or group of positions that cannot practically be covered by the 28 plan may be excluded therefrom but their compensations as approved by the Department of Administration shall, nevertheless, be 29 subject to review by the State Fiscal Accountability Authority. Salary appropriations for employees fixed in this act shall be in full 30 for all services rendered, and no supplements from other sources shall be permitted or approved by the State Fiscal Accountability 31 Authority. With the exception of travel and subsistence, legislative study committees shall not compensate any person who is 32 otherwise employed as a full-time state employee. Salaries of the heads of all agencies of the State Government shall be specifically 33 34 fixed in this act and no salary shall be paid any agency head whose salary is not so fixed. As long as there is no impact on appropriated funds, state agencies and institutions shall be allowed to spend public funds and/or other funds for designated employee award 35 programs which shall have written criteria approved by the agency governing board or commission. For purposes of this section, 36

monetary awards, if any, shall not be considered a part of an employee's base salary, a salary supplement, or a perquisite of 1

2 employment. The names of all employees receiving monetary awards and the amounts received shall be reported annually to the

Department of Administration. 3

4 In the case of lodging furnished by certain higher education institutions to employees, the prevailing local rate does not apply if 5 the institution meets the exceptions for inadequate rent described in the current Internal Revenue Code Section 119(d)(2). To meet 6 the exception, rental rates must equal the lesser of five percent of the appraised value of the qualified campus lodging, or the average 7 of the rentals paid by individuals (other than employees or students of the educational institution) during the calendar year for lodging 8 provided by the educational institution which is comparable to the qualified campus lodging provided to the employee, over the rent paid by the employee for the qualified campus lodging during the calendar year. The appraised value shall be determined as of the 9 close of the calendar year in which the taxable year begins, or, in the case of a rental period not greater than one year, at any time 10 during the calendar year in which the period begins. 11 117.16. (GP: Universities & Colleges - Allowance for Presidents) Presidents of the University of South Carolina, Clemson 12

University, the Medical University of South Carolina, The Citadel, Winthrop University, South Carolina State University, Francis 13 Marion University, University of Charleston, Coastal Carolina University and Lander University must not be paid a fixed allowance 14 for personal expenses incurred in connection with the performance of their official duties. Reimbursements may be made to the 15 presidents from funds available to their respective institutions for any personal expenses incurred provided that all requests for 16 reimbursement are supported by properly documented vouchers processed through the normal accounting procedures of the 17 18 institutions.

117.17. (GP: Replacement of Personal Property) The Department of Juvenile Justice, Department of Corrections, Department 19 of Probation, Parole and Pardon Services, Department of Mental Health, Department of Disabilities and Special Needs, Continuum 20 of Care, Department of Social Services and School for the Deaf and the Blind may replace the personal property of an employee 21 22 which has been damaged or destroyed by a client while in custody of the agency. The replacement of personal property may be 23 made only if the loss has resulted from actions by the employee deemed to be appropriate and in the line of duty by the agency head 24 and if the damaged or destroyed item is found by the agency head to be reasonable in value, and necessary for the employee to carry 25 out the functions and duties of his employment. Replacement of damaged or destroyed items shall not exceed \$250 per item, per 26 incident. Each agency must have guidelines to insure the reasonableness of the replacement payments.

117.18. (GP: Business Expense Reimbursement) Agency heads and deputy commissioners or deputy directors designated by 27 agency heads may receive reimbursements for business expenses incurred while performing their official duties, provided that 28 receipts are presented when seeking reimbursement and justification is submitted to document the time, place, and purpose of the 29 expense as well as the names of the individuals involved. The Department of Administration shall promulgate regulations governing 30 31 these expenses.

117.19. (GP: Per Diem) The per diem allowance of all boards, commissions and committees shall be at the rate of \$35 per day. 32 No full-time officer or employee of the State shall draw any per diem allowance for service on such boards, commissions or 33 34 committees.

117.20. (GP: Travel - Subsistence Expenses & Mileage) Travel and subsistence expenses, whether paid from state appropriated, 35 federal, local or other funds, shall be allowed in accordance with the following provisions: 36

(A) Unless otherwise provided in paragraphs B through H of this section, all employees of the State of South Carolina or any 1 2 agency thereof including employees and members of the governing bodies of each technical college while traveling on the business of the State shall, upon presentation of a paid receipt, be allowed reimbursement for actual expenses incurred for lodging, not to 3 4 exceed the current maximum lodging rates, excluding taxes, established by the U.S. General Services Administration. The lodging 5 reimbursement for employees of a school district must also conform to these rates when that employee's travel reimbursement is 6 paid by state funds that are transferred to the school district. Agencies may contract with lodging facilities to pay on behalf of an 7 employee. Failure to maintain proper control of direct payments for lodging may result in the revocation of the agency's authority 8 by the Comptroller General or the State Auditor. The employee shall also be reimbursed for the actual expenses incurred in the obtaining of meals except that such costs shall not exceed \$25 per day within the State of South Carolina. For travel outside of South 9 Carolina the maximum daily reimbursement for meals shall not exceed \$32. Agencies may contract with food or dining facilities to 10 pay for meals on behalf of employees in accordance with rules and regulations established by the Office of Comptroller General. It 11 12 shall be the responsibility of the agency head to monitor the charges for lodging which might be claimed by his employees in order to determine that such charges are following maximum lodging rates as established by the U.S. General Services Administration. 13 Any exceptions must have the written approval of the agency head, taking into consideration location, purpose of travel or other 14 extenuating circumstances. The provisions of this item shall not apply to Section 42-3-40 of the 1976 Code, and when pertaining to 15 institutions of higher learning, for travel paid with funds other than General Funds. 16 (B) That employees of the State, when traveling outside the United States, Canada, and Puerto Rico upon promotional business 17 for the State of South Carolina shall be entitled to actual expenses for both food and lodging. 18 (C) The Governor, Lieutenant Governor, Secretary of State, Comptroller General, Attorney General, State Treasurer, Adjutant 19

20 General, Superintendent of Education and the Commissioner of Agriculture shall be reimbursed actual expenses for subsistence.

(D) Non-legislative members of committees appointed pursuant to Acts and Resolutions of the General Assembly whose membership consists solely of members of the General Assembly or members of the General Assembly and other personnel who are not employees of the State of South Carolina shall be allowed subsistence expenses of \$35 per day while traveling on official business, unless otherwise designated by law. Members of such committees may opt to receive actual expenses incurred for lodging and actual expenses incurred in the obtaining of meals in lieu of the allowable subsistence expense.

(E) Members of the state boards, commissions, or committees whose duties are not full-time and who are paid on a per diem basis, shall be allowed reimbursement for actual expenses incurred at the rates provided in paragraph A and I of this section while away from their places of residence on official business of the State. One person accompanying a handicapped member of a state board, commission, or committee on official business of the State shall be allowed the same reimbursement for actual expenses incurred at the rates provided in paragraph A through I of this section.

(F) No subsistence reimbursement shall be allowed to a Justice of the Supreme Court or Judge of the Court of Appeals while traveling in the county of his official residence. When traveling on official business of said court within fifty miles outside the county of his official residence, a Supreme Court Justice and a Judge of the Court of Appeals shall be allowed subsistence expenses in the amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. When traveling on official business of said court fifty or more miles outside the county of his official residence, each Justice and Judge of the Court of Appeals shall be allowed subsistence expenses in the amount as provided in this act for members of the General Assembly plus such

1 mileage allowance for travel as is provided for other employees of the State. The Chief Justice, or such other person as the Chief

Justice designates, while attending the Conference of Chief Justices and one member of the Supreme Court while attending the
 National Convention of Appellate Court Judges, and three Circuit Judges while attending the National Convention of State Trial

4 Judges shall be allowed actual subsistence and travel expenses.

5 Upon approval of the Chief Justice, Supreme Court Justices, Judges of the Court of Appeals, Circuit Judges, and Family Court 6 Judges shall be reimbursed for actual expenses incurred for all other official business requiring out-of-state expenses at the rate 7 provided in paragraph A of this section.

(G) No subsistence reimbursements are allowed to a Circuit Judge, a Family Court Judge, or an Administrative Law Judge while holding court within the county in which he resides. While holding court or on other official business outside the county, within fifty miles of his residence, a Circuit Court Judge, Family Court Judge, or an Administrative Law Judge is entitled to a subsistence allowance in the amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. While holding court or on other official business at a location fifty miles or more from his residence, a Circuit Court, Family Court or Administrative Law Judge is entitled to a subsistence allowance in the amount as provided in this act for members of the General Assembly plus such mileage allowance for travel as is provided for other employees of the State.

(H) Any retired Justice, Circuit Court Judge or Family Court Judge or Master-in-Equity appointed by the Supreme Court to serve
 as a Special Circuit Judge, Family Court Judge, Appeals Court Judge, or Acting Associate Justice shall serve without pay but shall
 receive the same allowance for subsistence, expenses, and mileage as provided in Part I for Circuit Court Judges.

(I) No expense shall be allowed an employee either at his place of residence or at the official headquarters of the agency by 18 which he is employed except as provided in paragraph E, of this section. When an employee is assigned to work a particular territory 19 or district, and such territory or district and his official headquarters are in different localities or sections of the State, expenses may 20 be allowed for the necessary travel to his official headquarters. The members of the Workers' Compensation Commission may be 21 reimbursed at the regular mileage rate of one round trip each week from their respective homes to Columbia. No subsistence 22 23 reimbursement shall be allowed to a member of the Workers' Compensation Commission while traveling in the county of his official 24 residence. When traveling on official business of the commission outside the county of his official residence, a member of the 25 Workers' Compensation Commission shall be allowed subsistence expenses in the amount of \$35 per day. When traveling on official 26 business of the commission fifty or more miles outside the county of his official residence, each member shall be allowed a 27 subsistence allowance in the amount as provided in this act for members of the General Assembly. When out-of-state, members of 28 the Workers' Compensation Commission and the members of the Appellate Panel of the Department of Employment and Workforce 29 may claim the established amount of per diem, as stated in the General Appropriation Act, or actual expenses as deemed reasonable by the Comptroller General. The members of the Appellate Panel of the Department of Employment and Workforce may be 30 31 reimbursed at the regular mileage rate when the member is on official business fifty miles or more outside of Columbia. The members of the Appellate Panel of the Department of Employment and Workforce shall be allowed subsistence allowance in the amount as 32 provided in this act for members of the General Assembly when the member is on official business fifty miles or more outside of 33 34 Columbia.

35 (J) When an employee of the State shall use his or her personal automobile in traveling on necessary official business, a charge 36 to equal the standard business mileage rate as established by the Internal Revenue Service will be allowed for the use of such

1 automobile and the employee shall bear the expense of supplies and upkeep thereof. The standard business mileage rate used in this

2 calculation shall be the current rate established by the Internal Revenue Service. Whenever state provided motor pool vehicles are

3 reasonably available and their use is practical and an employee of the State shall request for his own benefit to use his or her personal

4 vehicle in traveling on necessary official business, a charge of four cents per mile less than the standard business mileage rate as

5 established by the Internal Revenue Service will be allocated for the use of such vehicle and the employee shall bear the expense of 6 supplies and upkeep thereof. The standard business mileage rate used in this calculation shall be the current rate established by the

7 Internal Revenue Service. When such travel is by a state-owned automobile, the State shall bear the expense of supplies and upkeep

8 thereof but no mileage will be allowed. Agencies and employees are directed to use state fueling facilities to the maximum extent

9 possible, when such use is cost beneficial to the State. When using commercial fueling facilities, operators of State-owned vehicles

are directed to use self-service pumps. In traveling on the business of the State, employees are required to use the most economical

11 mode of transportation, due consideration being given to urgency, schedules and like factors.

Mileage between an employee's home and his/her place of employment is not subject to reimbursement. However, when an employee leaves on a business trip directly from his/her home, and does not go by the employee's headquarters, the employee shall be eligible for reimbursement for actual mileage beginning at his/her residence.

15 (K) That a state agency may advance travel and subsistence expense monies to employees of that agency for the financing of 16 ordinary and necessary travel required in the conducting of the business of the agency. The Office of Comptroller General is directed 17 to develop and publish rules and regulations pertaining to the advancing of travel expenses and no state agency shall make such 18 advances except under the rules and regulations as published. All advances for travel and subsistence monies shall be repaid to the 19 agency within thirty days after the end of the trip or by July fifteenth, whichever comes first.

(L) That the state institutions of higher learning are authorized to reimburse reasonable relocation expenses for new employees
 when such reimbursements are considered by the agency head to be essential to successful recruitment of professionally competent
 staff members.

(M) The Office of Comptroller General is authorized to promulgate and publish rules and regulations governing travel and
 subsistence payments.

25 (N) No state funds may be used to purchase first class airline tickets.

26 117.21. (GP: Organizations Receiving State Appropriations Report) Each organization receiving a contribution in this act shall render to the state agency making the contribution by November first of the fiscal year in which funds are received, an accounting 27 of how the state funds will be spent, a copy of the adopted budget for the current year, and also a copy of the organization's most 28 recent operating financial statement. The funds appropriated in this act for contributions shall not be expended until the required 29 financial statements are filed with the appropriate state agency. No funds in this act shall be disbursed to organizations or purposes 30 which practice discrimination against persons by virtue of race, creed, color or national origin. The State Auditor shall review and 31 audit, if necessary, the financial structure and activities of each organization receiving contributions in this act and make a report to 32 the General Assembly of such review and/or audit, when requested to do so by the State Fiscal Accountability Authority. 33

34 **117.22.** (GP: State-Owned Aircraft - Flight Logs) Each agency having in its custody one or more aircraft shall maintain a 35 continuing log on all flights, which in order to promote accountability and transparency shall be open for public inspection and shall 36 also be posted online. Any and all aircraft owned or operated by agencies of the State Government shall be used only for official

1

2 Constitutional Officers, members of the General Assembly, members of state boards, commissions, and agencies and their invitees for official business only; no member of the General Assembly, no member of a state board, commission, or committee, and no state 3 4 official shall use any state-owned or operated aircraft unless the member or official files within twenty-four hours after the completion 5 of the flight with the agency that provided the flight a sworn statement certifying and describing the official nature of his trip; and 6 no member of the General Assembly, no member of a state board, commission or committee, and no state official shall be furnished 7 air transportation by a state agency unless such agency prepares and maintains in its files a sworn statement from the highest ranking 8 official of the agency or its designee certifying that the member's or state official's trip was in conjunction with the official business of the agency. Official business shall not include routine transportation to and from meetings of the General Assembly or committee 9 meetings for which mileage is authorized. Official business also does not include attending a press conference, bill signing, or 10 political function. 11 12 All logs shall be signed by the parties using the flight and the signatures shall be maintained as part of the permanent record of any agency. All passengers shall be listed on the flight log by their legal name; passengers flying with an appropriate official of 13 SLED or the Department of Commerce whose confidentiality must, in the opinion of SLED or the department, be protected shall be 14 listed in writing on the flight log as "Confidential Passenger SLED or the Department of Commerce (strike one)" and the appropriate 15 official of SLED or the department shall certify to the agency operating the aircraft the necessity for such confidentiality. The 16 Division of Aeronautics shall post its flight logs on its website within one working day of completion of trips. 17 Violation of the above provisions of this section is prima facie evidence of a violation of Section 8-13-700(A) of the 1976 Code 18 and shall subject a violating member of the General Assembly to the ethics procedure of his appropriate house and shall subject a 19 violating member of a state board, commission or committee, or a state official to the applicable ethics procedure relating to them as 20

business. The Division of Aeronautics and other agencies owning and operating aircraft may furnish transportation to the Governor,

21 provided by law. The above provisions do not apply to state-owned or operated aircraft when used by the Medical University of 22 South Carolina, nor to aircraft of the athletic department or the educational foundations of any state-supported institution of higher 23 education, nor to law enforcement officers when flying on state-owned aircraft in pursuit of fugitives, missing persons, or felons or

24 for investigation of gang, drug, or other violent crimes.

25 Aircraft owned by agencies of state government shall not be leased to individuals for their personal use.

117.23. (GP: Carry Forward) Each agency is authorized to carry forward unspent general fund appropriations from the prior fiscal year into the current fiscal year, up to a maximum of ten percent of its original general fund appropriations less any appropriation reductions for the current fiscal year. Agencies shall not withhold services in order to carry forward general funds.

This provision shall be suspended if necessary to avoid a fiscal year-end general fund deficit. For purposes of this proviso, the amount of the general fund deficit shall be determined after first applying the Capital Reserve Fund provisions in Section 11-11-

31 320(D) of the 1976 Code, and before any transfers from the General Reserve. The amount of general funds needed to avoid a year-

32 end deficit shall be reduced proportionately from each agency's carry forward amount.

Agencies which have separate general fund carry forward authority must exclude the amount carried forward by such separate authority from their base for purposes of calculating the ten percent carry forward authorized herein. Any funds that are carried

35 forward as a result of this provision are not considered part of the base of appropriations for any succeeding years.

117.24. (GP: TEFRA-Tax Equity and Fiscal Responsibility Act) It is the intent of the General Assembly that the State Medicaid 1 2 Plan be amended to provide benefits for disabled children as allowed by the Tax Equity and Fiscal Responsibility Act (TEFRA) option. State agencies, including but not limited to, the Department of Social Services - the Continuum of Care, the Department of 3 4 Health and Environmental Control, the Department of Mental Health, the Department of Disabilities and Special Needs, and the 5 Department of Health and Human Services shall collectively review and identify existing state appropriations within their respective 6 budgets that can be used as state match to serve these children. Such funds shall be used effective January 1, 1995 to implement 7 TEFRA option benefits. Agencies providing services under the provisions of this paragraph must not spend less in the current fiscal year than expended in the previous fiscal year. 8

9 117.25. (GP: Prison Industries) All agencies funded in this act, when procuring goods and services, shall first consider
 10 contracting for services or purchasing goods and services through the Department of Corrections' Prison Industries Program. The
 11 Department of Corrections shall furnish, upon request, to all agencies a catalogue of goods and services provided by Prison Industries.
 12 The department is hereby directed to develop and market a catalogue of Prison Industries products for nationwide circulation.

117.26. (GP: Travel Report) Annually on November first, the Comptroller General shall issue a report on travel expenditures 13 for the prior fiscal year which shall be distributed to the Senate Finance Committee, the House Ways and Means Committee, and the 14 Statehouse Press Room. The Comptroller General may use up to \$500 of general fund appropriations for the purpose of providing 15 copies to the media or the public upon request. The report must contain a listing for every agency receiving an appropriation in the 16 annual General Appropriations Act. The listing must show at a minimum the top ten percent of employees for whom travel expenses 17 and registration fees were paid within each agency, not to exceed twenty-five employees per agency. Agencies should include 18 position titles for each of the top twenty-five travelers for each agency. Expenditures must include state, federal and other sources 19 of funds. Expenditures for in-state and out-of-state registration fees (fees to attend conferences, teleconferences, workshops, or 20 seminars for training on a per person basis) must be shown as a separate subtotal within the grand total for the individual employees 21 and the agency as a whole. The list for each agency must be in rank order with the largest expenditure first and the name of the 22 23 employee must be shown with each amount. Agencies should include a brief summary of the type of travel the agency incurs. The Comptroller General may provide additional information as deemed appropriate. The Comptroller General shall provide no 24 25 exceptions to this report in that the information contained is not considered confidential or restricted for economic development 26 purposes. However, further disclosure of detailed information shall be restricted as provided for by law.

117.27. (GP: School Technology Initiative) From the funds appropriated/authorized for the K-12 technology initiative, the Department of Education, in consultation with the Department of Administration, the State Library, the Educational Television Commission, and a representative from the Education Oversight Committee, shall administer the K-12 technology initiative funds. These funds are intended to provide technology, encourage effective use of technology in K-12 public schools throughout the state, conduct cost/benefit analyses of the various technologies, and should, to the maximum extent possible, involve public-private sector collaborative efforts. Funds may also be used to establish pilot projects for new technologies with selected school districts as part of the evaluation process. K-12 technology initiative funds shall be retained and carried forward to be used for the same purpose.

34 **117.28.** (GP: State-Operated Day Care Facilities Fees) Any state agency receiving funding in this act and any higher education 35 institution, including four-year institutions, two-year institutions, and technical colleges, that operates an early childhood 36 development center or day care facility shall charge, at a minimum, fees that are comparable to those charged by private day care

1 facilities in the local community. The institution or agency shall not restrict enrollment in the center solely to the children of faculty,

2 staff, and students of the institution; nor shall fees be set at a lower level for faculty, staff, or students of the institution or agency.

3 **117.29.** (GP: Base Budget Analysis) Agencies' annual accountability reports for the prior fiscal year, as required in Section 1-1-

4 810, must be accessible to the Governor, Senate Finance Committee, House Ways and Means Committee, and to the public on or

5 before September fifteenth, for the purpose of a zero-base budget analysis and in order to ensure that the Agency Head Salary 6 Commission has the accountability reports for use in a timely manner. Accountability Report guidelines shall require agencies to

7 identify key program area descriptions and expenditures and link these to key financial and performance results measures. The

8 Executive Budget Office is directed to develop a process for training agency leaders on the annual agency accountability report and

9 its use in financial, organizational, and accountability improvement. Until performance-based funding is fully implemented and

10 reported annually, the state supported colleges, universities and technical schools shall report in accordance with Section 59-101-11 350.

12 **117.30.** (GP: Collection on Dishonored Payments) In lieu of any other provision of law, any state agency may collect a service 13 charge as provided in Section 34-11-70 to cover the costs associated with the processing and collection of dishonored instruments or 14 electronic payments where any amount is not paid by the drawee due to insufficient funds on deposit with the bank or the person 15 upon which it was drawn when presented, or the instrument has an incorrect or insufficient signature on it. Such funds shall be 16 retained and expended by the agency in accordance with this purpose and any unused amount shall carry forward to the following 17 fiscal year.

18 **117.31.** (GP: State DNA Database) Funds collected by the South Carolina Department of Corrections, the Department of 19 Probation, Parole and Pardon, and Department of Juvenile Justice to process DNA samples must be remitted to the State Law 20 Enforcement Division to offset the expenses incurred to operate the State DNA Database program. SLED may retain, expend, and 21 carry forward these funds. Any carry forward funds resulting from the DNA Database program must be used solely to operate the 22 DNA Database program.

23 117.32. (GP: Voluntary Separation Incentive Program) State agencies may implement, in consultation with the Department of 24 Administration, a program to realign resources to include provisions for a separation incentive payment for employees which may 25 include the employer portion of health and dental benefits not to exceed one year. Employees participating in such program shall 26 not be eligible to participate in the Teacher and Employee Retention Incentive (TERI) program. Employees participating in such program shall be considered to have voluntarily quit their employment without good cause and be subject to the provisions of Section 27 41-35-120(1) of the South Carolina Employment Security Law. Any program developed under this provision will involve voluntary 28 participation from employees and will be funded within existing appropriations. The program must be approved by the agency head 29 and the Director of the Human Resources Division based on ability to demonstrate recurring cost savings for realignment and/or 30 31 permanent downsizing. State agencies shall report the prior year's results to the Department of Administration by August fifteenth, of the current fiscal year. The Department of Administration, upon request, shall report to the Senate Finance Committee and the 32 House Ways and Means Committee on these results. 33

34 **117.33.** (GP: Alternative Commitment to Truancy) As part of its plan for an alternative school, a school district receiving funds 35 from the Department of Education for an alternative school shall identify available alternatives to commitment for children whose 36 truancy is approaching the level of being referred to family court. When proceeding under S.C. Code Section 59-65-50 to bring an

1 individual case before the family court, the school district must present this plan as well as the district's efforts with respect to the

individual child to the court. Each school district's plan under this proviso shall include possible assignment to alternative school
 for a non-attending child before petitioning the court.

4 **117.34.** (GP: Debt Collection Reports) Each state agency shall provide to the Chairmen of the Senate Finance and House of 5 Representatives Ways and Means Committees and the Inspector General a report detailing the amount of its outstanding debt and all 6 methods it has used to collect that debt. This report is due by the last day of February for the previous calendar year. For purposes 7 of this provision, outstanding debt means a sum remaining due and owed to a state agency by a nongovernmental entity for more 8 than sixty calendar days.

9 117.35. (GP: State-Funded Libraries - Web Filters) (A) A library receiving state funds, directly, indirectly, by grant, or otherwise, other than a library at an institution of higher learning, that has computers available for use by the public or students, or both, must equip these computers with software incorporating web-filtering technology designed to eliminate or reduce the ability of the computer to access sites displaying pornographic pictures or text. However, up to ten percent, and at least one, of the library's

13 computers must be unfiltered. Each library's governing officials shall determine the physical location of any unfiltered computer(s).

The library also must have a written policy providing sanctions against a person who instructs or demonstrates to another person how to bypass this web-filtering technology.

16 (B) State funds intended for a library not in compliance with subsection (A) must be reduced by fifty percent. Funds resulting 17 from this reduction must be distributed among other libraries that are in compliance with subsection (A).

18 **117.36.** (GP: Tobacco Settlement Funds Carry Forward) State agencies are hereby authorized to retain and carry forward any 19 unexpended Tobacco Settlement Agreement funds from the prior fiscal year into the current fiscal year and to expend such funds for 20 the same purpose.

117.37. (GP: Use Tax Exemption) For the current fiscal year there is exempt from the use tax imposed pursuant to Chapter 36, Title 12 of the 1976 Code the sales price of tangible personal property purchased for use in private primary and secondary schools, including kindergartens and early childhood education programs, which are exempt from income taxes pursuant to Section 501(c)(3) of the Internal Revenue Code. For the purposes of this item, the Internal Revenue Code means Internal Revenue Code as described

in Section 12-6-40 of the 1976 Code. This exemption applies for sales occurring after 1995. No refund is due any taxpayer of use tax paid on sales exempted by this paragraph.

117.38. (GP: Personal Property Tax Relief Fund) For the current fiscal year, Section 12-37-2735 of the 1976 Code is suspended. If the Personal Property Tax Exemption Sales Tax is imposed in a county and a sales tax rate of two percent of gross proceeds of sales is insufficient to offset the property tax not collected, sufficient amounts must be credited to the Trust Fund for Tax Relief established pursuant to Section 11-11-150 of the 1976 Code to provide the reimbursement to offset such a shortfall in the manner provided in Section 4-10-540(A) of the 1976 Code.

117.39. (GP: COG Annual Report) Each Council of Government shall submit a report to the Senate Finance Committee and the
 House Ways and Means Committee by December first each year describing how the funds which they received from the State in the
 prior fiscal year were expended.

35 117.40. (GP: Department of Administration, OEPP, Veterans Affairs) Of the funds appropriated for the Department of 36 Administration, Office of Executive Policy and Programs, Division of Veterans Affairs, the Director of the Division shall appoint an

additional claims representative within the Division of Veterans Affairs, who, in addition to being charged with the duty of assisting 1 2 all ex-servicemen, regardless of the wars in which their service may have been rendered, in filing, presenting, and prosecuting to final determination all claims which they have for money compensation, hospitalization, training, and insurance benefits under the 3 4 terms of federal legislation, shall also specialize in the specific needs and diseases associated with veterans of the Vietnam era. The 5 person appointed as a claims representative under this section must be versed in federal legislation relating to these matters and the 6 rules, regulations, and practice of the Veterans Administration as created by Congress and his appointment must be approved by the 7 Governor. Subject to the direction of the director, and in addition to other duties prescribed in this section, the claims representative appointed 8 pursuant to this section may represent the Division of Veterans Affairs on the South Carolina Agent Orange Advisory Council and 9 on the Hepatitis C Coalition established by the South Carolina Department of Health and Environmental Control, assist the Division 10 of Veterans Affairs in carrying out its duties in connection with the Agent Orange Information and Assistance program, represent 11 the director in connection with functions relating to Vietnam veterans, and perform other duties as may be assigned by the director. 12 117.41. (GP: South Carolina Recycling Initiative) To protect the public health and safety, protect and preserve the environment 13 of this State, and to recover resources which have the potential for usefulness in the most environmentally safe, economically feasible 14 and cost effective manner, state agencies shall purchase recycled steel unless the item cannot be acquired competitively at a 15 16 reasonable price. 117.42. (GP: Life and Palmetto Fellows Scholarships Waiver Exemption) Any provision in permanent law or in Part IB, 17 Section 117 of this act, except that which is specified for LIFE and Palmetto Fellows Scholarships, that would require general fund 18 appropriations other than what is specified in Part IA of this act is waived for the current fiscal year. 19 117.43. (GP: Sole Source Procurements) The State Fiscal Accountability Authority shall evaluate and determine whether the 20 written determinations, explanations, and basis for sole source procurements, pursuant to South Carolina Code Section 11-35-1560, 21 and emergency procurements, pursuant to South Carolina Code Section 11-35-1570, are legitimate and valid reasons for awarding 22 23 noncompetitive contracts. 24 117.44. (GP: DMV Data) The Department of Motor Vehicles shall provide access, in compliance with all state and federal 25 privacy protection statues, to the following data and reports without charge to the South Carolina Department of Transportation: 26 (1) all collision data and collision reports; 27

(2) registration information used for toll enforcement; and

(3) driver records of employees or prospective employees.

28

117.45. (GP: Parking Fees) State agencies shall not impose additional parking fees or increases in current fees for state 29 employees during the current fiscal year. This provision does not apply to any college or university. 30

117.46. (GP: Facility Rental Fee) The Governor's School for the Arts and Humanities, Governor's School for Science and 31 Mathematics, Wil Lou Gray Opportunity School, and John de la Howe School are authorized to charge, collect, expend and carry 32 forward fees charged for facility and equipment rental and registration. 33

34 117.47. (GP: Insurance Claims) Any insurance reimbursement to an agency may be used to offset expenses related to the claim. These funds may be retained, expended, and carried forward. 35

117.48. (GP: Organizational Charts) All agencies, departments and institutions of state government shall furnish to the Human Resources Division (1) a current personnel organizational chart annually no later than September first of the current fiscal year, or upon the request of the division and (2) notification of any change to the agency's organizational structure which impacts an employee's grievance rights within thirty days of such change. The organizational chart shall be in a form prescribed by the Human Resources Division showing all authorized positions, class title, class code, position number and indications as to whether such positions are filled or vacant. In addition, the organizational chart shall clearly identify those employees who are exempt from the State Employee Grievance Procedure Act.

8 **117.49.** (GP: Agencies Affected by Restructuring) Upon restructuring of state agencies by the General Assembly the Department of Administration is directed to work with affected State agencies in order to phase-in operations of restructured organizations during 9 the current fiscal year. Restructured organizations should be operating entirely under the revised structure no later than December 10 thirty-first, of the current fiscal year, unless otherwise directed by law. The department is further directed to work with the affected 11 agencies in order to identify and facilitate the transfer of any portion of their operations, including transfer of funds during the current 12 fiscal year, which is affected by the restructured organization adopted by the General Assembly, but which has not already been 13 accomplished herein. Until sufficient changes can be made to the State's accounting system and the appointment of appropriate 14 agency heads, the Comptroller General and the State Treasurer shall allow those agencies affected by restructuring to continue 15 processing documents within the account structure existing on June thirtieth, of the prior fiscal year. Restructured agencies shall 16 make all the necessary accounting adjustments to complete the transition to the new account structure as soon as possible, but no 17 later than December thirty-first, of the current fiscal year, unless otherwise directed by law. The Executive Budget Office is directed 18 to prepare the subsequent detail budget to conform Part IA and corresponding provisos in this act to any restructuring changes that 19 20 are ratified.

117.50. (GP: Agency Administrative Support Collaboration) It is the intent of the General Assembly that state agencies continue
 to actively pursue cost savings measures through collaborative efforts and where feasible may combine administrative support
 functions with other agencies in order to maximize efficiency and effectiveness.

24 117.51. (GP: Assessment Audit / Crime Victim Funds) If the State Auditor finds that any county treasurer, municipal treasurer, 25 county clerk of court, magistrate, or municipal court has not properly allocated revenue generated from court fines, fines, and 26 assessments to the crime victim funds or has not properly expended crime victim funds, pursuant to Sections 14-1-206(B)(D), 14-1-207(B)(D), 14-1-208(B)(D), and 14-1-211(B) of the 1976 Code, the State Auditor shall notify the State Office of Victim Assistance. 27 28 The State Office of Victim Assistance is authorized to conduct an audit which shall include both a programmatic review and financial 29 audit of any entity or nonprofit organization receiving victim assistance funding based on the referrals from the State Auditor or complaints of a specific nature received by the State Office of Victim Assistance to ensure that crime victim funds are expended in 30 31 accordance with the law. Guidelines for the expenditure of these funds shall be developed by the Victim Services Coordinating Council. The Victim Services Coordinating Council shall develop these guidelines to ensure any expenditure which meets the 32 parameters of Article 15, Chapter 3, Title 16 is an allowable expenditure. Any local entity or nonprofit organization that receives 33 34 funding from revenue generated from crime victim funds is required to submit their budget for the expenditure of these funds to the State Office of Victim Assistance within thirty days of the budget's approval by the governing body of the entity or nonprofit 35 organization. Failure to comply with this provision shall cause the State Office of Victim Assistance to initiate a programmatic 36

review and a financial audit of the entity's or nonprofit organization's expenditures of victim assistance funds. Additionally, the 1 2 State Office of Victim Assistance will place the name of the noncompliant entity or nonprofit organization on their website where it shall remain until such time as they are in compliance with the terms of this proviso. Any entity or nonprofit organization receiving 3 4 victim assistance funding must cooperate and provide expenditure/program data requested by the State Office of Victim Assistance. 5 If the State Office of Victim Assistance finds an error, the entity or nonprofit organization has ninety days to rectify the error. An 6 error constitutes an entity or nonprofit organization spending victim assistance funding on unauthorized items as determined by the State Office of Victims Assistance. If the entity or nonprofit organization fails to cooperate with the programmatic review and 7 8 financial audit or to rectify the error within ninety days, the State Office of Victim Assistance shall assess and collect a penalty in the amount of the unauthorized expenditure plus \$1,500 against the entity or nonprofit organization for improper expenditures. 9 This penalty plus \$1,500 must be paid within thirty days of the notification by the State Office of Victim Assistance to the entity 10 or nonprofit organization that they are in noncompliance with the provisions of this proviso. All penalties received by the State 11 Office of Victim Assistance shall be credited to the General Fund of the State. If the penalty is not received by the State Office of 12 Victim Assistance within thirty days of the notification, the political subdivision will deduct the amount of the penalty from the entity 13 or nonprofit organization's subsequent fiscal year appropriation. 14 15 117.52. (GP: H.L. Hunley Museum Location) The General Assembly approves the City of North Charleston as the permanent site of the H.L. Hunley Museum. This approval is contingent upon the negotiation and execution of necessary contracts between the 16 State of South Carolina and the City of North Charleston. The Hunley Commission is directed to expend funds from its account to 17 negotiate and execute contracts on behalf of the State of South Carolina. 18 117.53. (GP: Secure Juvenile Confinement) The Attorney General shall review the interpretation of the current policies of the 19 Department of Public Safety and the Department of Corrections regarding secure juvenile confinement that the departments indicate 20 may jeopardize federal grant funds. The departments may not implement any changes to the current policies regarding secure juvenile 21 confinement until the Attorney General considers the departments' interpretation of the federal Juvenile Justice and Delinquency 22 23 Prevention Act in regard to the secure holding of juveniles for more than six hours in adult detention facilities that also serve as fortyeight-hour juvenile holdover facilities. The Attorney General will determine if the departments' interpretation is fair and equitable 24 25 and how the local governments and the Department of Juvenile Justice would be impacted, to include any financial considerations. 26 117.54. (GP: ISCEDC Funding Transfer) The departments of Mental Health, Disabilities and Special Needs, and Juvenile Justice 27 are directed to transfer a total of \$1,199,456 in funds to the Department of Social Services for the support of the Interagency System 28 for Caring for Emotionally Disturbed Children. Funding transfers shall be in the following amounts: Department of Mental Health - \$595,000, Department of Disabilities and Special Needs - \$379,456, and Department of Juvenile Justice - \$225,000. The transfer 29 of funds shall be accomplished by September thirtieth of the current fiscal year. 30

31 117.55. (GP: Employee Bonuses) State agencies and institutions are allowed to spend state, federal, and other sources of revenue 32 to provide selected employees lump sum bonuses, not to exceed three thousand dollars per year, based on objective guidelines 33 established by the Department of Administration. Payment of these bonuses is not a part of the employee's base salary and is not 34 earnable compensation for purposes of employee and employer contributions to respective retirement systems. Employees earning 35 \$100,000 or more shall not be eligible to receive bonuses under this provision. The employing agency must report this information 36 on or before August thirty-first of each year and must include the total amount and source of the bonus received by the employee

1 during the preceding fiscal year (July first through June thirtieth). The Human Resources Division of the Department of

Administration shall formulate policies and procedures to ensure compliance with the reporting provisions of this proviso. Copies of the reports shall be made available to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and

4 Means Committee, upon request.

5 **117.56.** (GP: FEMA Flexibility) Any appropriation designated as the state share for a federally declared disaster may be carried 6 forward and used for the same purpose by the Emergency Management Division of the Adjutant General's Office in the event of 7 additional federally declared disasters. Unallocated funds from established state accounts may be used as the state share in any 8 federally declared disaster. These funds may also be used during a Governor's state of emergency to augment existing state 9 appropriations of the South Carolina Emergency Management Division (SCEMD). When these funds are used during a Governor's 8 state of emergency, the allocation of those funds following the event will be determined by the Governor based on the 9 recommendation of the Adjutant General and the Director of the South Carolina Emergency Management Division.

In the event there is a federally declared disaster and state match funds are unavailable, the State Fiscal Accountability Authority may borrow from any internal account or accounts necessary to maximize federal matching funds through the Emergency Management Division. Any such borrowing must be reported to the General Assembly within five days. Funds borrowed from accounts shall be replenished by the General Assembly as soon as practicable.

16 **117.57.** (GP: Respiratory Syncytial Virus Prescription Sales and Use Tax Exemption) The effective date of the exemption from 17 sales and use tax of prescription medicines used to prevent respiratory syncytial virus shall be January 1, 1999. No refund of sales 18 and use taxes may be claimed as a result of this provision.

19 117.58. (GP: Year-End Financial Statements - Penalties) Agencies, *institutions*, and other reporting entities required to submit 20 annual audited financial statements for inclusion in the State's Comprehensive Annual Financial Report must comply with the 21 submission dates stipulated in the State Auditor's Office audit contract *submit final audited financial statements to the Comptroller* 22 *General not later than October 1st for those with fiscal year-end June 30th. For institutions and reporting entities with fiscal year-23 ends other than June 30th, final audited financial statements must be submitted to the Comptroller General within 120 days of that 24 fiscal year-end.* If the audit was not contracted by the State Auditor's Office, the final audited financial statements are due not later 25 than October tenth for the prior fiscal year. Each agency that does not comply with the provisions of this proviso shall appear before

26 the Comptroller General, providing an explanation for the delay. <u>The Comptroller General shall provide a written report of each</u>

27 agency, institution, or other reporting entity not in compliance with this provision to the State Fiscal Accountability Authority by

28 <u>November 30th.</u>

29 117.59. (GP: Purchase Card Incentive Rebates) In addition to the Purchase Card Rebate deposited in the general fund, any 30 incentive rebate premium received by an agency from the Purchase Card Program may be retained and used by the agency to support 31 its operations.

117.60. (GP: Sex Offender Monitoring and Supervision) The funds appropriated to the Department of Probation, Parole and
 Pardon Services in Part IA, Section 66, Program II.A.2. for the Sex Offender Monitoring Program and to the Department of Juvenile
 Justice in Part IA, Section 67, Program III.A. Special Item: Sex Offender Monitoring are to be used and expended only for GPS

35 monitoring programs of the departments. In cases of limited funds, monitoring of "Jessie's Law" offenders shall take precedence

36 over all other GPS programs of the departments. Funds appropriated for this program may not be used for any other purpose or

1 transferred to any other program. Unexpended funds appropriated for Sex Offender Monitoring may be carried forward and used

2 for the same purpose. The departments are directed to submit a report to the General Assembly by January fifteenth each year 3 accounting for the expenditure of the funds including any carry-forward funding; the total costs and per-day costs for equipment,

4 supervision, and monitoring; the total number of staff assigned to the activity and the average agent caseloads; the amount of funds

5 collected from sex offenders for both intensive supervision and electronic monitoring; and the anticipated fiscal needs for the 6 upcoming fiscal year. The report shall also include, but not be limited to, data regarding the number of offenders sentenced to 7 electronic monitoring, including the number sentenced for life; the number of alert notifications received, investigated, and 8 prosecuted; and the number of offenders returned to prison as a result of electronic monitoring violations.

9 **117.61.** (GP: Viscosupplementation Therapies Sales and Use Tax Exemption) For the current fiscal year only, sales and use 10 taxes on viscosupplementation therapies shall be suspended. No refund or forgiveness of tax may be claimed as a result of this 11 provision.

12 117.62. (GP: CID & PCC Agency Head Salaries) All hiring salaries and salary increases for the agency heads of the Commission 13 on Indigent Defense and the Prosecution Coordination Commission shall be subject to all provisions related to agency heads covered 14 by the Agency Head Salary Commission.

15 **117.63.** (GP: Prosecutors and Defenders Public Service Incentive Program) The Office of Attorney General, the Prosecution 16 Coordination Commission, and the Commission on Indigent Defense, in consultation with the South Carolina Student Loan 17 Corporation and the Commission on Higher Education, shall develop and implement a Prosecutors and Defenders Public Service 18 Incentive Program for attorneys employed by the Office of Attorney General, the Prosecution Coordination Commission, the 19 Commission on Indigent Defense, a Circuit Solicitor's Office or a county Public Defender's Office.

After more than three years of continuous service as a full-time attorney with any of these entities, qualifying attorneys may be reimbursed up to \$1,000 for payments made in the prior calendar year on outstanding law school loans. Reimbursements for law school loan payments may be increased by up to \$1,000 for each additional year of continuous service; however, such reimbursements shall not exceed \$5,000 in any year. The amount of law school loan payment reimbursement in any calendar year shall not exceed the amount of principal and interest paid on the loan in the prior calendar year. Reimbursements under the program may continue until all outstanding law school loans are satisfied; however, such reimbursements shall not exceed \$40,000 per qualifying attorney. Reimbursements shall be adjusted if necessary so as not to exceed appropriations for the program.

The Prosecutors and Defenders Public Service Incentive Program must be administered by the South Carolina Student Loan Corporation, which shall pay for the cost of administration within the funds appropriated.

The Office of Attorney General, the Prosecution Coordination Commission, and the Commission on Indigent Defense shall each compile a report that includes, but is not limited to, the number of applicants and the impact of the program on attracting and retaining

31 attorneys. The Student Loan Corporation shall compile a report that includes, but is not limited to, the cost of administering the

32 program as well as the amount of reimbursements per agency or entity. Such reports shall be submitted to the Senate Finance

33 Committee and the House Ways and Means Committee by September first each fiscal year.

34 Unexpended program funds from the prior fiscal year may be carried forward into the current fiscal year to be used for the same 35 purpose.

117.64. (GP: Attorney Dues) Agencies and offices of the State of South Carolina that employ attorneys are authorized, if they 1 2 so decide, to use other appropriated funds, including General Fund carry forward funds, to pay the costs of mandatory dues owed to the South Carolina Bar Association. 3 4 117.65. (GP: Healthcare Employee Recruitment and Retention) The Department of Corrections, Department of Disabilities and 5 Special Needs, Department of Health and Environmental Control, Department of Health and Human Services, Department of 6 Juvenile Justice, Department of Mental Health, and Department of Vocational Rehabilitation, and Wil Lou Grav Opportunity School 7 are allowed to spend state, federal, and other sources of revenue to provide lump sum bonuses to aid in recruiting and retaining healthcare workers in critical needs healthcare jobs based on objective guidelines established by the Department of Administration. 8 The employee bonus amount shall be approved by the State Human Resources Director and shall not exceed \$10,000 per year. 9 Payment of these bonuses is not a part of the employee's base salary and is not earnable compensation for purposes of employee and 10 employer contributions to respective retirement systems. 11 These agencies may also provide paid educational leave for any employees in an FTE position to attend class while enrolled in 12 healthcare degree programs that are related to the agency's mission. All such leave is at the agency head's discretion. 13 These agencies may enter into an agreement with Psychiatrists, Psychologists, and Nurses employed in those positions to repay 14 them for their outstanding student loans associated with completion of a healthcare degree. The employee must be employed in a 15 critical needs area, which would be identified at the agency head's discretion. Critical needs areas could include rural areas, areas 16 with high turnover, or where the agency has experienced recruiting difficulties. Agencies may pay these employees up to twenty 17 percent or \$7,500, whichever is less, of their outstanding student loan each year over a five-year period. Payments will be made 18 directly to the employee at the end of each year of employment. The agency will be responsible for verifying the principle balance 19 of the employee's student loan prior to issuing payments. 20 Employees of these agencies working on a practicum or required clinical experience towards completion of a healthcare degree 21 22 may be allowed to complete these requirements at their state agency or another state agency at the discretion of the agency head. 23 This field placement at another state agency may be considered work time for participating employees. 24 These agencies are also authorized to allow tuition reimbursement from a maximum of ten credit hours per semester; allow probationary employees to participate in tuition programs; and provide tuition prepayment instead of tuition reimbursement for 25 employees willing to pursue a degree in a healthcare program. An agency may pay up to fifty percent of an employee's tuition 26 27 through tuition prepayment. The remaining tuition could be reimbursed to the employee after successful completion of the class.

117.66. (GP: Governor's Budget Certification) The annual Executive Budget proposed by the Governor must be certified by the
 Director of the Revenue and Fiscal Affairs Office or his designee in the same manner as the House Ways and Means and Senate
 Finance Committee versions of the budget bill are certified.

31 **117.67.** (GP: Sexually Violent Predator Program) After the Department of Mental Health obtains all necessary project approvals, 32 the Department of Corrections may utilize inmate labor to perform any portion of the construction of an addition to the Edisto Unit 33 at the Broad River Correctional Institution, which houses the Department of Mental Health's Sexually Violent Predator Treatment 34 Program, such addition to be used for additional treatment space and staff offices. For purposes of this project, the Department of 35 Corrections may exceed the \$350,000 limit on projects for which it may use inmate labor.

117.68. (GP: Voluntary Furlough) Agency heads may institute a voluntary employee furlough program of not more than ninety days per fiscal year. During this voluntary furlough, the state employees shall be entitled to participate in the same state benefits as otherwise available to them except for receiving their salaries. As to those benefits which require employer and employee contributions, the state agencies, institutions and departments will be responsible for making both employer and employee contributions if coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the employee remains solely responsible for making those contributions. In the event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply.

117.69. (GP: Governor's Security Detail) The State Law Enforcement Division, the Department of Public Safety, and the 8 Department of Natural Resources shall provide a security detail to the Governor in a manner agreed to by the State Law Enforcement 9 Division, the Department of Public Safety, the Department of Natural Resources, and the Office of Governor. Reimbursement to the 10 State Law Enforcement Division, the Department of Public Safety, and the Department of Natural Resources to offset the cost of the 11 security detail for the Governor shall be made in an amount agreed to by the State Law Enforcement Division, the Department of 12 Public Safety, the Department of Natural Resources, and the Office of Governor from funds appropriated to the Office of Governor 13 for this purpose. Law enforcement officers assigned to security detail for the Governor shall only perform services related to security 14 15 and shall not provide any unrelated service during the assignment.

16 **117.70.** (GP: Reduction in Force Antidiscrimination) In the event of a reduction in force implemented by a state agency or 17 institution, the state agency or institution must comply with Title VII of the Civil Rights Act of 1964 or any other applicable federal 18 or state antidiscrimination laws.

117.71. (GP: Reduction in Force/Agency Head Furlough) In the event a reduction in force is implemented by a state agency or 19 institution of higher learning, the agency head shall be required to take five days furlough in the current fiscal year. If more than one 20 reduction in force plan is implemented in a fiscal year, the mandatory agency head furlough is only required for the initial plan. The 21 22 agency head will retain all responsibilities and authority during the furlough. All monies saved from this furlough may be retained 23 by that agency and expended at the discretion of the agency head. During this furlough, the agency head shall be entitled to participate 24 in the same state benefits as otherwise available to them except for receiving their salaries. As to those benefits which require 25 employer and employee contributions, the state agency will be responsible for making both employer and employee contributions if 26 coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the agency head 27 remains solely responsible for making those contributions.

Placement of an agency head on furlough under this provision does not constitute a grievance or appeal under the State Employee Grievance Procedure Act. In the event the reduction for the state agency or institution of higher learning is due solely to the General Assembly transferring or deleting a program, this provision does not apply. Agencies may allocate the agency head's reduction in pay over the balance of the fiscal year for payroll purposes regardless of the pay period within which the furlough occurs. The Department of Administration shall promulgate guidelines and policies, as necessary, to implement the provisions of this proviso. State agencies shall report information regarding furloughs to the Department of Administration.

For purposes of this provision, agency head includes the president of a technical college as defined by Section 59-103-5 of the 1976 Code.

The agency head of the State Board for Technical and Comprehensive Education shall not be required to take this mandatory 1 2 furlough based solely on the implementation of a reduction in force plan by a technical college. An agency head shall not be required to take this mandatory furlough based solely on reductions in force implemented as a result 3 4 of federal budget cuts or reorganization to accomplish organizational efficiencies. 5 117.72. (GP: Printed Report Requirements) (A) For Fiscal Year 2015-16 2016-17, state supported institutions of higher learning shall not be required to submit printed reports mandated by Sections 2-47-40, 2-47-50, and 59-103-110 of the 1976 Code, and shall 6 7 instead only submit the documents electronically. 8 Submission of the plans or reports required by Sections 59-101-350, 59-103-30, 59-103-45(4), and 59-103-160(D) shall be waived for the current fiscal year, except institutions of higher learning must continue to report student pass rates on professional 9 examinations, and data elements otherwise required for the Commission on Higher Education Management Information System. 10 The commission, in consultation with institutions, shall take further action to reduce data reporting burdens as possible. 11 (B) For Fiscal Year 2015-16 2016-17, the Department of Agriculture shall not be required to submit printed reports mandated by 12 Section 46-49-10 of the 1976 Code. The department shall provide these reports electronically and shall use any monetary savings 13 for K5-12 agricultural education programs. 14 15 (C) For Fiscal Year 2015-16 2016-17, the Department of Health and Human Services shall not be required to provide printed copies of the Medicaid Annual Report required pursuant to Section 44-6-80 of the 1976 Code and shall instead only submit the 16 documents electronically. 17 (D) For Fiscal Year 2015-16 2016-17, the Department of Transportation shall not be required to submit printed reports or 18 publications mandated by Sections 1-11-58, 2-47-55, and 58-17-1450 of the 1976 Code. 19 The Department of Transportation may combine their Annual Report and Mass Transit Report into their Annual Accountability 20 21 Report. **117.73.** (GP: IMD Operations) All funds received by the Department of Education, the Department of Juvenile Justice, the 22 23 Department of Disabilities and Special Needs, the Department of Mental Health, the Department of Social Services, and the Department of Administration, Office of Executive Policy and Programs-Continuum of Care as State child placing agencies for the 24 25 Institution for Mental Diseases Transition Plan (IMD) of the discontinued behavioral health services in group homes and child caring institutions, as described in the Children's Behavioral Health Services Manual Section 2, dated 7/01/06, shall be applied only for out 26 of home placement in providers which operate Department of Social Services or Department of Health and Environmental Control 27 28 licensed institutional, residential, or treatment programs. An annual report by each state child placing agency shall be made on the expenditures of all IMD transition funds and shall be provided to the Chairman of the Senate Finance Committee, Chairman of the 29 House Ways and Means Committee, and the Governor no later than November first each year. The Department of Health and Human 30 31 Services shall review the numbers of out of home placements by type and by agency each year and make recommendations to the General Assembly. 32 **117.74.** (GP: Fines and Fees Report) In order to promote accountability and transparency, each state agency must provide and 33 34 release to the public via the agency's website, a report of all aggregate amounts of fines and fees that were charged and collected by

35 that state agency in the prior fiscal year. The report shall include, but not be limited to: (1) the code section, regulation, or proviso

that authorized the fines and fees to be charged, collected, or received; (2) the amount of the fine or fee; (3) the amount received by

source; (4) the purpose for which the funds were expended by the agency; (5) the amount of funds transferred to the general fund, if applicable, and the authority by which the transfer took place; and (6) the amount of funds transferred to another entity, if applicable, and the authority by which the transfer took place, as well as the name of the entity to which the funds were transferred. The report must be posted online by September first. Additionally, the report must be delivered to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by September first. Funds appropriated to and/or authorized for use by each state agency shall be used to accomplish this directive.

7 117.75. (GP: Mandatory Furlough) In a fiscal year in which the general funds appropriated for a state agency are less than the general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 8 implements a midyear across-the-board budget reduction, and agency heads institute a mandatory employee furlough program, in 9 determining which employees must participate in the program, agency heads should give consideration to furloughs for contract 10 employees, post-TERI employees, and TERI employees before other employees. During this mandatory furlough, the state 11 employees shall be entitled to participate in the same state benefits as otherwise available to them except for receiving their salaries. 12 As to those benefits which require employer and employee contributions, the state agencies, institutions, and departments will be 13 responsible for making both employer and employee contributions if coverage would otherwise be interrupted; and as to those 14 benefits which require only employee contributions, the employee remains solely responsible for making those contributions. In the 15 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 16 **117.76.** (GP: Reduction In Force) In a fiscal year in which the general funds appropriated for a state agency are less than the 17 general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 18 implements a midyear across-the-board budget reduction, and agency heads must make reductions in force, agency heads should 19 give consideration to reductions of contract employees, post-TERI employees, and TERI employees before other employees. In the 20 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 21 117.77. (GP: Cost Savings When Filling Vacancies Created by Retirements) During the current fiscal year, whenever classified 22 FTEs become vacant because of employee retirements, it is the intent of the General Assembly that state agencies should realize 23 personnel costs savings of at least twenty-five percent in the aggregate when managing these vacant positions. Prior to filling a 24 25 classified FTE which has become vacant because of a retirement, an agency must review and determine the appropriate salary for 26 the position as well as determine whether the agency can manage without filling the position or by delay in filling the position. Prior to filling the vacant FTE, agencies must follow all laws and regulations concerning posting and competitive solicitation and 27 28 consideration of applicants. No agency shall enter into any agreement with any employee that violates the terms of this proviso. 117.78. (GP: Information Technology for Health Care) From the funds appropriated and awarded to the South Carolina 29 Department of Health and Human Services for the Health Information Technology for Economic and Clinical Health Act of 2009, 30 31 the department shall advance the use of health information technology and health information exchange to improve quality and efficiency of health care and to decrease the costs of health care. In order to facilitate the qualification of Medicare and/or Medicaid 32 eligible providers and hospitals for incentive payments for meaningful health information technology (HIT) use, a health care 33

34 organization participating in the South Carolina Health Information Exchange (SCHIEx) or a Regional Health Information

35 Organization (RHIO) or a hospital system health information exchange (HIE) that participates in SCHIEx may release patient records

36 and medical information, including the results of any laboratory or other tests ordered or requested by an authorized health care

1 provider within the scope of his or her license or practice act, to another health information organization that requests the information

2 via a HIE for treatment purposes with or without express written consent or authorization from the patient. A health information

3 organization that receives or views this information from a patient's electronic health record or incorporates this information into the

4 health information organization's electronic medical record for the patient in providing treatment is considered an authorized person

5 for purposes of 42 C.F.R. 493.2 and the Clinical Laboratory Improvement Amendments.

6 **117.79.** (GP: Broadband Spectrum Lease) The General Assembly must approve any exercise of the Middle Band Segment 7 Channel recapture provisions contained in the Educational Broadband Service Spectrum Lease Agreements if the exercise of the 8 recapture provisions would result in a decrease in payments received by the State. The Educational Television Commission assumes management and administration of the lease and receives lease payments directly. The Educational Television Commission shall 9 retain and expend funds received pursuant to the lease for agency operations. The commission shall be authorized to carry forward 10 unexpended funds from the prior fiscal year into the current fiscal year. In the event of a default by the current lease holder, the 11 Educational Television Commission is authorized to use contingent funds up until such time as a new lease can be negotiated by the 12 State and the Educational Television Commission. 13

14 **117.80.** (GP: Reduction in Compensation) For the current fiscal year, no state agency or political subdivision of this state may 15 decrease the compensation of an employee, including dismissal, suspension, or demotion, solely because the employee gave sworn

16 testimony regarding alleged wrongdoing to a standing committee, subcommittee of a standing committee, or study committee of the

17 Senate or the House of Representatives. This proviso shall apply regardless of when the alleged wrongdoing occurred.

18 **117.81.** (GP: Deficit Monitoring) It is the responsibility of each state agency, department, and institution to operate within the 19 limits of its authorized appropriations. All agencies, departments, and institutions are to budget, allocate and manage its authorized 20 appropriations in a way to avoid an operating deficit for the fiscal year.

If at the end of each quarterly deficit monitoring review by the Executive Budget Office, it is determined by either the Executive Budget Office or a state agency, department, or institution that the likelihood of a deficit for the current fiscal year exists, the state agency shall notify the General Assembly within fifteen days of this determination and shall further request the Executive Budget Office to work with it to develop a plan to avoid the deficit. Within fifteen days of the deficit avoidance plan being completed, the Executive Budget Office shall either request the General Assembly to recognize the deficit if it determines the deficit avoidance plan will not be sufficient to avoid a deficit or notify the General Assembly of how the deficit will be avoided based on the deficit avoidance plan if the Executive Budget Office determines the plan will be sufficient to avoid a deficit.

Upon notification from the Executive Budget Office that an agency will run a deficit and requesting that it be recognized, the General Assembly, by joint resolution, may make a finding that the cause of, or likelihood of, a deficit is unavoidable due to factors which are outside the control of the state agency, department, or institution, and recognize the deficit. Any legislation to recognize

31 a deficit must be in a separate joint resolution enacted for the sole purpose of recognizing the deficit of a particular state agency,

32 department, or institution. A deficit may only be recognized by an affirmative vote of each branch of the General Assembly.

33 If the General Assembly recognizes the deficit, then the actual deficit at the close of the fiscal year must be reduced as necessary

34 from surplus revenues or surplus funds available at the close of the fiscal year in which the deficit occurs and from funds available

35 in the General Reserve Fund and the Capital Reserve Fund, as required by the Constitution of this State.

Once a deficit has been recognized by the General Assembly, the state agency, department, or institution shall limit travel and conference attendance to that which is deemed essential by the director of the agency, department, or institution. In addition, the General Assembly, when recognizing a deficit may direct that any pay increases and purchases of equipment and vehicles must be approved by the Executive Budget Office.

5 **117.82.** (GP: Commuting Costs) State government employees who use a permanently assigned agency or state-owned vehicle 6 to commute from their permanently assigned work location to and from the employee's home must reimburse the agency in which 7 they are employed for commuting use in accordance with IRS regulations based on guidance from the Office of Comptroller General 8 which must use the Cents per mile Rule, unless they are exempted from such reimbursement by applicable IRS regulations. These permanently assigned vehicles must be clearly marked as a state or agency vehicle through the use of permanent state-government 9 license plates and either state or agency seal decals unless the vehicle is used primarily in undercover operations. This requirement 10 does not apply to a vehicle used by an employee for the purpose of a special travel assignment, for active certified law enforcement 11 officers authorized to carry firearms, execute warrants, and make arrests, for Constitutional Officers, or for Department of 12 Transportation employees on call for emergency maintenance. 13 117.83. (GP: Bank Account Transparency and Accountability) Each state agency, except state institutions of higher learning, 14

which has composite reservoir bank accounts or any other accounts containing public funds which are not included in the Comptroller 15 General's South Carolina Enterprise Information System shall prepare a report for each account disclosing every transaction of the 16 account in the prior fiscal year. The report shall be submitted to the State Fiscal Accountability Authority by October first of each 17 fiscal year. The report shall include the name(s) and title(s) of each person authorized to sign checks or make withdrawals from each 18 account, the name and title of each person responsible for reconciling each account, the beginning and year-end balance of funds in 19 each account, and data related to both deposits and expenditures of each account. The report shall include, but not be limited to, the 20 date, amount, and source of each deposit transaction and the date, name of the payee, the transaction amount, and a description of 21 22 the goods or services purchased for each expenditure transaction. To facilitate review, the State Fiscal Accountability Authority 23 shall prescribe a common format for the report which agencies must use. In order to promote accountability and transparency, a link 24 to the report shall be posted on the Comptroller General's website as well as the agency's homepage.

When the State Auditor conducts or contracts for an audit of a state agency, accounts of the agency subject to this proviso must be included as part of the review.

If an agency determines that the release of the information required in this provision would be detrimental to the state or the 27 28 agency, the agency may petition the State Fiscal Accountability Authority to grant the agency an exemption from the reporting requirements for the detrimental portion. The meeting to determine whether an exemption should be granted shall be closed. 29 However, the exemption may only be granted upon a majority vote of the State Fiscal Accountability Authority in a public meeting. 30 31 **117.84.** (GP: Websites) All agencies, departments, and institutions of state government shall be responsible for providing on its Internet website a link to the Internet website of any agency, other than the individual agency, department, or institution, that posts 32 on its Internet website that agency, department, or institution's monthly state procurement card statements or monthly reports 33 34 containing all or substantially all the same information contained in the monthly state procurement card statements. The link must be to the specific webpage or section on the website of the agency where the state procurement card information for the state agency, 35 department, or institution can be found. The information posted may not contain the state procurement card number. Any 36

1 information that is expressly prohibited from public disclosure by federal or state law or regulation must be redacted from any posting

2 required by this section.

3 **117.85.** (GP: Regulations) For the current fiscal year, if a state agency proposes a regulation that levies or increases a fee, fine,

or that otherwise generates revenues, the title to the Joint Resolution which proposes the regulation must indicate that a fee, fine, or
 revenue source is being proposed.

6 **117.86.** (GP: Joint Children's Committee) For the current fiscal year, the Department of Revenue is directed to reduce the rate 7 of interest paid on eligible refunds by one percentage point. Of the revenue resulting from this reduction, \$300,000 shall be 8 transferred to the Senate for the Joint Citizens and Legislative Committee on Children to provide the report, research, and other operating expenses as directed in Section 63-1-50 of the 1976 Code. Funds transferred to the University of South Carolina for the 9 Joint Citizens and Legislative Committee on Children shall be maintained in a separate and distinct account. A detailed report of all 10 expenditures shall be made to the Executive Budget Office within thirty days of the close each fiscal quarter, and the Executive 11 Budget Office shall distribute this information to the Chairman of the Senate Finance Committee and the Chairman of the House 12 Ways and Means Committee. The remaining revenue resulting from this reduction shall be transferred to the Department of Juvenile 13 Justice to be used for mentoring or alternatives to incarceration programs. Unexpended funds authorized by this provision may be 14 retained and carried forward by the Senate or the Department of Juvenile Justice, respectively, and used for the same purposes. The 15 rate of reduction authorized in this provision shall be in addition to the reduction authorized in Proviso 93.7. 16

117.87. (GP: Civil Conspiracy Defense Costs) For the current fiscal year, for any claim that has not reached a judgment, if a 17 state or local government employee or former state or local government employee ("government employee") is personally sued for 18 civil conspiracy based in part upon a personnel or employment action or decision regarding an employee, the court must, prior to 19 trial, make a final determination whether the action or decision giving rise to the suit was made by the government employee within 20 the scope of their official duty. If the court finds that the government employee was acting outside the scope of the employee's 21 official duties, the government shall not thereafter expend any funds to pay or defend the claim. If the court finds the government 22 23 employee was acting within the scope of their official duties, the employee is immune from suit, liability, and damages with respect 24 to the civil conspiracy claim. The government may only expend funds to defend the claim if the determination is that the employee 25 was acting within the scope of their official duties. Nothing in this proviso prevents an insurance provider from defending and 26 paying, respectively, any claims that the provider has contractually agreed to defend and pay.

117.88. (GP: Recovery Audits) The State Fiscal Accountability Authority shall contract with one or more firms to conduct recovery audits of payments made by all state agencies to vendors for goods and services. The audits must be designed to detect, document, and recover overpayments and erroneous payments to the vendors and to recommend improved financial and operational practices and procedures. A state agency shall pay, from recovered monies received, the recovery audit firm responsible for obtaining for the agency a reimbursement or payment from a vendor a negotiated fee not to exceed twenty percent of the funds recovered by that firm.

Unless otherwise restricted by law, funds recovered, less the cost of recovery, shall be remitted to a special fund subject to appropriation by the General Assembly. Agencies may recover costs that are documented to be directly related to implementation of this provision.

Recovery audits apply only to payments made more than one hundred eighty days prior to the date the audit is initiated and shall
 cover at least three complete fiscal years.

3 All information provided under a contract must be treated as confidential by the recovery audit firm. A violation of this provision

shall result in the forfeiture by the firm of all compensation under the contract and to the same sanctions and penalties that would
 apply to that disclosure.

Each state agency shall participate in this recovery audit program and shall cooperate and provide the recovery audit firm with all
 information necessary for the audit in a timely manner. All vendors that provide goods or services to a state agency shall cooperate
 with the recovery audit firm in its audit.

9 A state agency shall expend or return to the federal government any federal money that is recovered through a recovery audit 10 conducted under this provision. Payments to the recovery audit firm from the federal share of recovered funds shall be solely from 11 the federal portion as allowed by the federal agency.

In addition to performing the recovery audits, the recovery audit firm may conduct an analysis of contracts and pricing structures, as determined and directed by the Executive Director of the State Fiscal Accountability Authority or her or his designee, to identify

and recommend future cost-savings and improved state agency financial operations going forward. A state agency shall pay the

recovery audit firm responsible for obtaining the agency actual cost-savings a fee as authorized by the contract with the recovery audit firm.

The recovery audit firm shall provide reports to the State Fiscal Accountability Authority detailing its findings, the causes for the overpayments and erroneous payments, future cost-savings opportunities and its recommendations for strengthening state operations and/or state contracts to prevent improper payments in the future.

For purposes of this proviso, the term "vendor" or "vendors" includes, but is not limited to, sellers, suppliers, service providers, other providers, contractors and third party administrators; the term "overpayments and erroneous payments" includes, but is not limited to, overpayments, duplicate payments, erroneous payments, and rebates, discounts and credits not received; and the term "state agency" or "state agencies" includes all state agencies, boards, commissions, institutions and institutions of higher education. The State Fiscal Accountability Authority shall provide copies, including electronic form copies, of final reports received from a

firm under contract to: the Governor; the Chairman of the Senate Finance Committee; the Chairman of the House Ways and Means Committee; and the state auditor's office. Not later than January first of each year, the board shall issue a report to the General Assembly summarizing the contents of all reports received under this provision during the prior fiscal year.

117.89. (GP: Funds Transfer to ETV) In the current fiscal year funds appropriated in Part IA to the Department of Administration Section 93 for Legislative and Public Affairs Coverage and Emergency Communications Backbone and to the Law Enforcement Training Council in Section 64 for State and Local Training of Law Enforcement, City and County municipal training services must be transferred to the Educational Television Commission (ETV) during July 2015 2016 for the continuation of services as provided in the prior fiscal year.

117.90. (GP: Opt Out of Federal Patient Protection and Affordable Care Act) If federal law permits, the State of South Carolina
 opts out of the following provisions in the federal Patient Protection and Affordable Care Act (Public Law 111-148):

(1) Subtitles A through C of Title I (and the amendments made by such subtitles), except for Sections 1253 and 1254;

117.91. (GP: Means Test) All agencies providing Healthcare Services are directed to identify standards and criteria for means
 testing on all programs provided, where allowed by Federal guidelines. Once a consistent criteria has been established within an
 agency, they shall implement their respective plans. Each agency shall report all criteria and fiscal data to the Chairman of the Senate
 Finance Committee and to the Chairman of the House Ways and Means Committee no later than January 1st, 2014.

9 **117.92.** (GP: Agency Reduction Management) The General Assembly encourages state agencies, in the event agencies are assessed a base reduction, to endeavor to realize savings through: (1) payroll management, including, but not limited to, furloughs, reductions in employee compensation, and instituting a hiring freeze; (2) eliminate administrative overhead cost that does not directly impact the agency's mission; and as a final option (3) reductions to programmatic funding.

13 **117.93.** (GP: WIA Service Advertising) For Fiscal Year 2014-15 2016-17, the Workforce Investment Boards may promote 14 outreach for their services via billboard, bus placard, newspapers, or radio in all workforce investment areas. This outreach may not 15 be limited to e-mail, online, or other internet-based outreach, publicity, or other promotions. Workforce investment boards must 16 adhere to all state procurement policies and procedures when utilizing outreach for the services provided by the Workforce 17 Investment A st

17 Investment Act.

(GP: WIA Training Marketability Evaluation) (A) For Fiscal Year 2014-15 2016-17, the Department of Employment 18 and Workforce shall submit a report that demonstrates how funds were expended in the prior fiscal year to provide marketable work 19 20 skills training. The report shall include, but not be limited to the total number of local training recipients, a description of the training area in which each recipient participated, and the number and percentage of participants in each training area that, upon completion 21 of training, have become employed in the field in which they were trained. 31 **117.96.** (GP: DOC & PPP Potential Consolidation Plan) From the funds appropriated to the Department of Corrections and the 32 Department of Probation, Parole and Pardon Services, the directors of the departments may collaborate and develop a plan to 33 consolidate the functions of the departments.

117.97. (GP: USC Greenville Medical School) It is the intent of the General Assembly that during Fiscal Year 2014-15 the
 current fiscal year, no general funds shall be appropriated for the new medical school at the University of South Carolina in
 Greenville. In addition, no state funds may be transferred from state earmarked or restricted funds held by the University of South

1 Carolina to the medical school except for grants, contributions, contractual payments, and tuition and required fees for students

Each entity and agency shall report on its share of the state's ongoing maintenance of effort as defined by the US 18 Department of Education under IDEA Part C. 19 **117.99.** (GP: Single Audit Schedule of Federal Expenditures) To ensure timely completion of the of the Statewide Single Audit. 20 state agencies which do not receive a separate audit of federal expenditures, must submit to the Office of the State Auditor a schedule 21 of federal program expenditures in a format prescribed by the Office of the State Auditor, no later than August fifteenth of each year. 22 23 117.100. (GP: Prohibits Local Government Fund Public Funded Lobbyists) All local governmental entities including, but not

limited to, counties, municipalities, and associations are prohibited from using taxpayer funds received from the Local Government
 Fund to compensate employees for lobbying activities engaged in on behalf of such governmental entity.

117.101. (GP: School Construction Development Impact Fee Assessment Prohibition) Governmental entities are prohibited from assessing South Carolina Development Impact Fees on the construction of new elementary, middle, or secondary schools. If a governmental entity violates this prohibition it shall have its Aid to Subdivisions Allocation reduced by the amount of the impact fee.

117.102. (GP: Sexually Violent Predator Treatment RFP) The Director of the Department of Mental Health and the Director of
 the Department of Corrections shall cooperate with the State Fiscal Accountability Authority, Division of Procurement Services
 which shall develop and cause to be issued a Request for Proposals (RFP) seeking long-term solutions for securely housing and

The RFP shall be issued on or before October 31, 2013. 3 The RFP shall be worded broadly to allow respondents to propose creative and cost-effective long term solutions for the operation 4 of this program in order to address the issues raised in Proviso 23.15 of the 2012-13 State Appropriations Act and the resulting 5 January 3, 2013, Report on the SVP Program issued by the Department of Mental Health and the Department of Corrections. 6 7 In addition to treatment services, respondents shall be allowed, but not required, to propose a single source solution with responsibility for all aspects of the program including but not limited to housing, security, food, clothing, health care, transport, and 8 treatment services. The RFP shall allow for, but not require, respondents to include in their responses the use of other private or 9 public partners (subcontractors) and/or the lease or use or purchase of state owned real property. 10 The selected contractor may be authorized to sponsor the issuance of tax exempt certificates of participation or other finance 11 solutions to fund the project and the state is authorized to enter into a lease/purchase agreement for the necessary replacement 12 facilities. 13 117.103. (GP: Prohibit Use of State Aircraft for Athletic Recruitment) Institutions of higher learning may use the state aircraft 14 operated by the Division of Aeronautics for the purpose of athletic recruiting, provided that they reimburse the Division of 15 Aeronautics for all flight hours on an at cost basis, using non-general funds. 16 To ensure availability of the aircraft for purposes of economic development, the Department of Commerce shall have first right of 17 refusal in the event of scheduling conflicts with athletic recruiting flights. 18 117.104. (GP: Recreational Activities) Two counties that receive an allocation from the Local Government Fund may enter into 19 20 a Memorandum of Understanding in order to provide recreational activities and projects that benefit the citizens of both counties. 21 117.105. (GP: Technology and Remediation) The funds appropriated to the Department of Administration for the Division of Information Security shall be used to develop and implement a statewide information security program. A portion of the nonrecurring 22 23 funds may be used for enterprise technology and remediation, and distributed to state agencies to address the State's most serious 24 information security vulnerabilities as determined by the Division of Information Security and the Division of Technology 25 Operations. (GP: Donation of Alcoholic Liquors) In the current fiscal year, a wholesaler may donate beer, wine, and alcoholic liquors to a nonprofit organization that has a license, including a temporary license, to serve the applicable beverage. This provision only 30 31 applies if the event hosted by the nonprofit organization creates an economic impact on State revenues. 117.107. (GP: Data Breach Notification) (A) An agency of this State owning or licensing computerized data or other data that 32

includes personal identifying information shall disclose any breach of the security of the system following discovery or notification

of the breach in the security of the data to any resident of this State whose personal identifying information was, or is reasonably

believed to have been, acquired by an unauthorized person. In determining whether information has been acquired, or is reasonably

3 (1) indications that the information is in the physical possession and control of an unauthorized person, such as a lost or 4 stolen computer or other device containing information;

A list of consumer reporting agencies shall be compiled by the Department of Consumer Affairs and furnished upon request to the agency required to make a notification under this section.

 to any one or more of the following data elements that relate to a resident of this State, when the data elements are neither encrypted

(G) An agency that knowingly and willfully violates this section is subject to an administrative fine up to one thousand dollars for each resident whose information was accessible by reason of the breach, the amount to be decided by the Department of Consumer Affairs.

(H) If the agency provides notice to more than one thousand persons at one time pursuant to this section, the agency shall notify, 32 without unreasonable delay, the Consumer Protection Division of the Department of Consumer Affairs and all consumer reporting 33 34 agencies that compile and maintain files on a nationwide basis, as defined in 15 USC Section 1681a(p), of the timing, distribution, and content of the notice. 35

117.108. (GP: State Ports Authority Property) The State Ports Authority shall transfer fifty acres of its real property on Daniel 1

2 Island to the Department of Parks, Recreation and Tourism, which shall ensure, in the manner it deems appropriate, that the property is used for public recreation activities. If the State Ports Authority has not completed the sale of its remaining real property on Daniel 3

4 Island and Thomas (St. Thomas) Island, except for the dredge disposal cells that are needed in connection with the construction of

5 the North Charleston terminal on the Charleston Naval Complex and for harbor deepening and for channel and berth maintenance,

6 by June 30, 2016 2017, the authority must transfer the property to the Department of Administration. The authority shall sell the

7 real property under terms and conditions it considers most advantageous to the authority and the State of South Carolina.

8 **117.109** (GP: Remittance of Court Fee and Fine Money) County and city treasurers are required to remit to the State Treasurer set percentages of revenues generated by assessments imposed by 14-1-206(A), 14-1-207(A), 14-1-208(A). This remittance is 9 required on a monthly basis by the 15th day of each month. 10

Should a county and/or city treasurer fail to make the required remittance, the SC Criminal Justice Academy shall cease providing 11 services to all law enforcement officers of all law enforcement agencies encompassed within the political subdivision if they have 12 failed to make remittance for two consecutive months in a fiscal year. (GP: Detailed Expenditure/Revenue Reports PCC/CID) The Prosecution Coordination Commission and the Commission 16 on Indigent Defense shall provide detailed expenditure reports and associated revenue streams for each individual circuit, revenue 17 streams shall include, but not be limited to, state funds, local funds, Federal funds, and also nongovernmental sources of funds, by 18

no later than September first, on the prior fiscal year, to the appropriate commission. The commissions shall than provide the 19

Chairman of the House Ways and Means Committee and Chairman of the Senate Finance Committee with a combined report by 20

21 September fifteenth of the current fiscal year.

117.111. (GP: South Carolina Welcome Centers) The Department of Parks, Recreation and Tourism and the Department of 22 23 Transportation shall maintain a Memorandum of Understanding (MOU) that provides that the Department of Parks, Recreation and 24 Tourism shall control operations of all South Carolina Welcome Centers. The MOU shall include replacement, renovation and 25 maintenance of the facilities, daily operations, and grounds maintenance and upkeep and shall clearly define responsibility for additional portions of Welcome Centers to include paving and sidewalks. 117.112. (GP: Continuation of Teen Pregnancy Prevention Project Accountability) Qualifying organizations applying for General 32 Funds provided as a special item in this act and titled Continuation of Teen Pregnancy Prevention must include in its application a 33

34 proposed annual budget and agreement to provide quarterly reports to the grantor state agency detailing the expenditure of funds and

the project's accomplishments which shall include: 35

26	117.113. (GP: Charleston & Dorchester County Sound Barriers) From the funds authorized to the Department of Transportation,
27	the department shall take the appropriate measures to allow the counties of Charleston and Dorchester to construct sound barriers in
28	the department's easements along Interstate 26 within the borders of Charleston County and along Dorchester Road within Dorchester
29	County, provided, no funds appropriated or authorized in Part IA to the Department of Transportation, any other section of this act,
30	any Federal Funds, unless otherwise agreed to by the local Metropolitan Planning Organization or Council or Governments for use
31	of a portion of their annual federal allocation, or any Other Funds, shall be used in the construction of the sound barriers, and only
32	local dollars shall be used in the construction of sound barriers. The sound barriers must meet the state and federal noise abatement
33	guidelines and must be constructed to meet any and all state and federal regulations. Consistent with the requirements of Section
34	57-25-190 (E) of the 1976 Code, or regulations adopted pursuant thereto, including construction by a local government in a state
35	right of way, the owner of a legally erected and maintained billboard shall have the option to relocate such billboard sign to another
36	location as close as practicable to the sign being relocated or adjust the height or angle of the billboard sign to a height or angle that

1 restores the visibility of the billboard sign to the same or comparable visibility as before construction of a sound barrier. Costs for

2 re-location or alteration of a billboard due to sound barrier installation by a local government in a state right of way shall be paid by 3 the local government. The provisions of Section 39-14-10 et seq. of the 1976 Code will apply regarding any compensation to be 4 paid by local governments for billboard signs which cannot be relocated or altered.

5 **117.114.** (GP: Information Technology and Information Security Plans) (A) By October 1, <u>2015</u> <u>2016</u>, all state agencies must 6 submit an information technology plan and an information security plan for Fiscal Year <u>2015-16</u> <u>2016-17</u> to the Department of 7 Administration. State agencies must submit updates to their plans if there are changes following initial submission. Changes that 8 would necessitate an updated plan include, but are not limited to, changes in response to technological advancements, changes in 9 legislation, regulation or compliance requirements, newly identified funding sources, or new issues relating to information 10 technology management or business requirements.

The information technology plans required by this section shall be in the form and level of detail required by the department 11 and shall include at least: (1) the information technology objectives of the state agency; (2) an inventory of the state agency's 12 information technology; (3) any performance measures used by the state agency for implementing its information technology 13 objectives; (4) how the state agency's development of information technology coordinates with other governmental entities; (5) the 14 state agency's budget plans for information technology for the coming fiscal year which must include: (a) all fixed, recurring 15 information technology costs, regardless of funding sources; (b) new information technology expenditures for services, hardware 16 upgrades/replacements and software purchases, regardless of funding sources; (c) new information technology projects, regardless 17 of funding sources; and (d) FTE counts, temporary personnel counts, and salary information and position descriptions for all 18 information technology personnel, regardless of funding sources; and (6) the state agency's need for appropriations for information 19 20 technology.

21 The information security plans required by this section shall be in the form and level of detail required by the division and shall 22 include at least: (1) the information security objectives of the state agency; (2) an inventory of the state agency's information security 23 technology; (3) a profile of the state agency's compliance with security policies established by the division; (4) a profile of the state 24 agency's sensitive data and a description of applicable state and federal privacy requirements; (5) a profile of risk management and 25 other measures taken by the state agency to protect its data from unauthorized access and disclosure; (6) the state agency's budget plans for information security for the coming fiscal year which must include: (a) all fixed, recurring information security technology 26 costs, regardless of funding sources; (b) new information security expenditures for services hardware upgrades/replacements and 27 28 software purchases, regardless of funding sources; (c) new information security projects, regardless of funding sources; and (d) FTE counts, temporary personnel counts, and salary information and position descriptions for all information security personnel, 29 30 regardless of funding sources; and (7) the state agency's need for appropriations for information security.

(B) The director of the Department of Administration should seek advice from private and public sector resources on the efficient
 use of information technology and best practices.

33 (C) The Judicial Department, Legislative Department, public institutions of higher learning, technical colleges, political
 34 subdivisions and quasi-governmental bodies are specifically exempt from the requirements as provided in this proviso.

35 117.115. (GP: SCOIS Transfer) For Fiscal Year 2015-16 2016-17, the South Carolina Occupational Information System, its 36 authority, <u>and</u> responsibilities, FTE's and funding shall <u>continue</u> to be transferred from the Department of Employment and

1 Workforce to the Department of Education. The Department of Administration and the Office of the Comptroller General shall

2 facilitate and coordinate this transfer.

3 **117.116.** (GP: PEBA Fiduciary Audit) For the current fiscal year, the provisions of Section 9-4-40 requiring the Inspector General

to employ a private audit firm to perform the fiduciary audit on the Public Employee Benefit Authority as required by Section 9-4 40 of the 1976 Code shall be suspended.

6 **117.117.** (GP: ABLE Savings Expense Fund) For the current fiscal year, the South Carolina ABLE Saving Expense Fund is 7 established in the Office of the State Treasurer to allow for tax-exempt savings accounts for disability-related expenses for individuals

31	117.145. (GP: DOT Structural Efficiencies Study) From the funds appropriated to and/or authorized for the Department of
32	Transportation, the Inspector General, in collaboration with the Secretary of Transportation, is directed to conduct a national search
33	to contract with a renowned firm that specializes in governmental structural efficiencies. The firm shall be tasked with studying the
34	internal structure of the Department of Transportation, and making recommendations on improvements that would cause the
35	department to operate more effectively and more cost-efficiently. The Department of Transportation and any entity contracting with
36	the department or the Office of Inspector General must fully cooperate with the firm in the discharge of its duties and responsibilities

(GP: Funds Exempt from Budget Reduction Calculations) The General Reserve Fund, funds designated in F310, Section 5 107, Capital Reserve Fund, funds designated in V040, Section 112, Debt service, funds designated in X220, Section 113, Aid to 6 Subdivisions - State Treasurer for the Local Government Fund, and funds designated in X500, Section 115, Tax Relief Trust Fund 7 shall be excluded from the calculation of any across-the-board base reduction mandated by the Department of Administration. 8 *Executive Budget Office or the General Assembly and shall not be subject to any such reduction.* 9 117.147. (GP: Gas Tax Posting) Of the funds appropriated to the Department of Transportation and the Department of 10 Agriculture, the departments must post on their website home pages in a prominent, easily viewed location, a link to documents 11 which indicate the current amount of federal and state gas tax which are charged to South Carolina consumers. 12 117.148. (GP: Statewide Voting System) Of the funds appropriated to the Department of Administration for a new Statewide 13 Voting System, funds shall be transferred to the State Election Commission at such time as the commission determines that a new 14 15 voting system with a verifiable paper trail is necessary. However if the State Election Commission determines that critical and necessary upgrades to the existing statewide voting system would insure future elections can be conducted in a reliable and secure 16 manner, these funds may be transferred to the commission and expended for that purpose. Prior to purchase of a new voting system, 17 Federal approval of new voting system standards must be obtained. Upon approval of the system requirements, the funds held by 18 the Department of Administration shall be transferred to the State Election Commission. 118.1. (SR: Year End Cutoff) Unless specifically authorized herein, the appropriations provided in Part IA of this act as ordinary 25 expenses of the State Government shall lapse on July 31, 2016 2017. State agencies are required to submit all current fiscal year 26 input documents and all electronic workflow for accounts payable transactions to the Office of Comptroller General by July 14, 2016 27 28 2017. Appropriations for Permanent Improvements, now outstanding or hereafter provided, shall lapse at the end of the second fiscal year in which such appropriations were provided, unless definite commitments shall have been made, with the approval of the State 29 Fiscal Accountability Authority and Joint Bond Review Committee, toward the accomplishment of the purposes for which the 30 31 appropriations were provided. Appropriations for other specific purposes aside from ordinary operating expenses, now outstanding or hereafter provided, shall lapse at the end of the second fiscal year in which such appropriations were provided, unless definite 32 commitments shall have been made, with the approval of the State Fiscal Accountability Authority, toward the accomplishment of 33 34 the purposes for which the appropriations were provided.

35 **118.2.** (SR: Titling of Real Property) It is the intent of the General Assembly to establish a comprehensive central property and 36 office facility management process to plan for the needs of state government agencies and to achieve maximum efficiency and

economy in the use of state owned or state leased real properties. The Department of Administration is directed to identify all state 1 2 owned properties whether titled in the name of the state or an agency or department, and all agencies and departments of state government are upon request to provide the department all documents related to the title and acquisition of the real properties that 3 4 are occupied or used by the agency or titled in the name of the agency. Except for any properties where the department determines 5 title should not be in the name of the State because the properties are subject to reverter clauses or other restraints on the property, 6 or where the department determines the state would be best served by not receiving title, and with the exception of properties, 7 highways and roadways owned by the Department of Transportation, title of any property held by or acquired by a state agency or 8 department shall be titled in the name of the state under the control of the Department of Administration. Titling in the name of the state shall not affect the operation or use of real property by an agency. 9 This provision applies to all state agencies and departments except: institutions of higher learning; the Public Service Authority; 10 the Ports Authority; the South Carolina Division of Public Railways; the MUSC Hospital Authority; the Myrtle Beach Air Force 11 Redevelopment Authority; the Department of Transportation; the Midlands Technical College Enterprise Campus Authority, the 12 Trident Technical College Enterprise Campus Authority; the Area Commission of Tri-County Technical College; and the Charleston 13 Naval Complex Redevelopment Authority. 14 15 This provision is comprehensive and supersedes any conflicting provisions concerning title and acquisition and disposition of state owned real property whether in permanent law, temporary law or by provision elsewhere in this act. 16 The Department of Administration is directed to provide to the Department of Education, funds equal to the amount realized from 17 the sale of the Greenville Halton Road Bus Shop property for school bus maintenance shop relocations, construction, and shop 18 19 equipment. 118.3. (SR: Contingency Reserve Fund) (A) There is created in the State Treasury a fund separate and distinct from the general 20 fund of the State, the Capital Reserve Fund, and all other funds entitled the Contingency Reserve Fund. All general fund revenues 21 accumulated in a fiscal year in excess of general appropriations and supplemental appropriations must be credited to this fund. 22 23 Revenues credited to this fund in a fiscal year may be appropriated by the General Assembly. Upon determination by the Comptroller General as to the amount to be deposited in the Contingency Reserve Fund, the Comptroller General shall notify the Board of 24 25 Economic Advisors and the board shall recognize that amount as surplus funds. Revenues in this fund may be appropriated only for 26 the purposes provided in subsection (B). 27 (B) (1) If the balance in the general reserve fund established pursuant to Section 36, Article III of the Constitution of this State and Section 11-11-310 of the 1976 Code is less than the required balance, there must be appropriated to it all amounts in the 28 Contingency Reserve Fund up to the total necessary to replenish the general reserve fund. This amount does not replace or supplant 29 the minimum replenishment amount otherwise required to be made to the general reserve fund. 30 31 (2) After the appropriation of amounts required pursuant to item (1) of this subsection, any remaining balance may be appropriated by the General Assembly as it deems appropriate. 32

118.4. (SR: Increased Enforced Collections Carry Forward) Unexpended funds appropriated pursuant to Proviso 90.16 in Part IB
 of Act 291 of 2010 may be carried forward from the prior fiscal year into the current fiscal year and shall be expended for the same
 purposes.

118.5. (SR: Health Care Maintenance of Effort Funding) The revenue collected from the fifty cent cigarette surcharge and 1 2 deposited into the South Carolina Medicaid Reserve Fund and shall be utilized by the Department of Health and Human Services for the Medicaid program. By this provision these funds are deemed to have been received and are available for appropriation. 3 4 Unexpended funds appropriated pursuant to this provision may be carried forward to succeeding fiscal years and expended for the 5 same purposes. 118.6. (SR: Prohibits Public Funded Lobbyists) All state agencies and institutions are prohibited from using general fund 6 7 appropriations to compensate employees who engage in lobbying on behalf of the state agency or institution. The State Ethics 8 Commission shall require state agencies and institutions that report lobbying activities to the commission to certify that the lobbying activities were not funded by general fund appropriations. 9 All state agencies and institutions are prohibited from entering into contracts using general fund appropriations to provide lobbying 10 services to the agency or institution. 11 12 **118.7.** (SR: Admissions Tax) For the current fiscal year, up to one hundred fourteen thousand dollars in admissions tax revenue collected annually from all events held at a NASCAR sanctioned motor speedway or racetrack that hosts at least one race each year 13 featuring the preeminent NASCAR cup series must be rebated to the motorsports entertainment complex facility in the current fiscal 14 year to keep a NASCAR race at the motorsports entertainment complex facility. In addition, any sports facility that hosts at least 15 one preeminent Women's Tennis Association-sanctioned tournament or any sports facility that operates as the home venue for a 16 professional soccer team that participates in the United Soccer Leagues, second division or higher, must be rebated to the facility 17

18 half of its admissions tax revenue for the fiscal year and used by that facility for marketing the events held at the facility.

19 **118.8.** (SR: Agency Deficit Notice) The Comptroller General or the Executive Budget Office shall (1) provide written notice to 20 each member of the General Assembly when it makes a report concerning an agency, department, or institution that is expending 21 authorized appropriations at a rate which predicts or projects a general fund deficit for the agency, department, or institution, and (2) 22 make monthly progress reports concerning an agency's, department's, or institution's plan to reduce or eliminate the deficit.

118.9. (SR: Tax Relief Reserve Fund) There is created the Tax Relief Reserve Fund, which shall be separate and distinct from the General Fund. Interest accrued by the fund must remain in the fund. Notwithstanding any other provision of law, on December 31, 2015 2016, the State Treasurer shall transfer funds identified in this act from the General Fund to the Tax Relief Reserve Fund. These funds may only be used to provide tax relief to businesses and individuals as provided by law. Funds within the Tax Relief Reserve Fund shall be retained and carried forward to be used for the same purpose.

28 **118.10.** (SR: Tax Deduction for Consumer Protection Services) (A) In addition to the deductions allowed in Section 12-6-1140 29 of the 1976 Code, there is allowed a deduction in computing South Carolina taxable income of an individual the actual costs, but not exceeding three hundred dollars for an individual taxpayer, and not exceeding one thousand dollars for a joint return or a return 30 31 claiming dependents, incurred by a taxpayer in the taxable year to purchase a monthly or annual contract or subscription for identity theft protection and identity theft resolution services. The deduction allowed by this item may not be claimed by an individual if the 32 individual deducted the same actual costs as a business expense or if the taxpayer is enrolled in the identity theft protection and 33 34 identity theft resolution services offered free of charge by the State of South Carolina. For purposes of this item, 'identity theft protection' means products and services designed to prevent an incident of identify fraud or identity theft or other protect the private 35 of a person' personal identifying information, as defined in Section 16-13-510(D), by precluding a third party from gaining 36

unauthorized acquisition of another's personal identifying information to obtain financial resources or other products, benefits or 1 2 services; and identity theft resolution services means products and services designed to assist persons whose personal identifying information, as defined by Section 16-13-510(D), was obtained by a third party, whereby minimizing the effects of the identity fraud 3 4 or identity theft incident and restoring the person's identity to pretheft status. (B) The deduction provided in (A) is only allowed for taxpayers that filed a return with the Department of Revenue for any taxable 5 vear after 1997 and before 2013, whether by paper or electronic transmission, or any person whose personally identifiable information 6 7 was contained on the return of another eligible person, including minor dependents. 8 (C) By March fifteenth of each year, the department shall issue a report to the Governor and the General Assembly detailing the number of taxpayers claiming the deduction allowed by this item in the most recent tax year for which there is an accurate figure, 9 and the total monetary value of the deductions claimed pursuant to this item in that same year. 10 (D) The department shall prescribe the necessary forms to claim the deduction allowed by this section. The department may 11 require the taxpayer to provide proof of the actual costs and the taxpayer's eligibility. 12 **118.11.** (SR: Tobacco Settlement) (A) To the extent funds are available from payments received on behalf of the State by the 13 Tobacco Settlement Revenue Management Authority from the Tobacco Master Settlement Agreement ("MSA") during Fiscal Year 14 15 2015-16 the current fiscal year, the State Treasurer is authorized and directed, after transferring funds sufficient to cover the operating expenses of the Authority, to transfer the remaining funds as follows: 16 (1) \$1,253,000 to the Attorney General's Office for Diligent Enforcement and Arbitration Litigation; \$450,000 to the State 17 Law Enforcement Division for Diligent Enforcement; and \$325,000 to the Department of Revenue for Diligent Enforcement, all to 18 enforce Chapter 47 of Title 11, the Tobacco Escrow Fund Act; and 19 20 (2) The remaining balance shall be transferred to the Department of Health and Human Services for the Medicaid program. (B) The requirements of Section 11-11-170 of the 1976 Code shall be suspended for Fiscal Year 2015-16 2016-17. 21 118.12. (SR: Nonrecurring Revenue) (A) The source of revenue appropriated in subsection (B) is nonrecurring revenue 22 23 generated from the following sources: 24 (1) \$19,740,576 from Fiscal Year 2013-14 Contingency Reserve Fund; (2) \$19,280,467 from Fiscal Year 2014-15 unobligated general fund revenue as certified by the Board of Economic 25 26 Advisors: 27 (3) \$27,802,168 from the Litigation Recovery Account; and 28 (4) \$49,500,000 from Fiscal Year 2015-16 non-recurring contribution from the Unclaimed Property Fund. 29 Any restrictions concerning specific utilization of these funds are lifted for the specified fiscal year. The above agency transfers 30 shall occur no later than thirty days after the close of the books on Fiscal Year 2014-15 and shall be available for use in Fiscal Year 31 2015-16. This revenue is deemed to have occurred and is available for use in Fiscal Year 2015-16 after September 1, 2015, following the 32 Comptroller General's close of the state's books on Fiscal Year 2014-15. 33 34 (B) The appropriations in this provision are listed in priority order. Item (1) must be funded first and each remaining item must be fully funded before any funds are allocated to the next item. Provided, however, that any individual item may be partially funded 35 in the order in which it appears to the extent that revenues are available. 36

12	institution for necessary repair and maintenance projects generally.
13	Matching funds exclude supplemental, capital reserve, lottery, or non-recurring state funds appropriated to an institution either
14	<u>in the current fiscal year or from a prior fiscal year for repair and maintenance or deferred maintenance projects.</u>
15	Prior to the utilization of these funds, institutions must certify to the Commission on Higher Education, in a manner it prescribes,
16	the extent to which they have met this requirement, including the sources of funds utilized to meet this requirement.
17	Not later than one hundred twenty days after the close of the fiscal year, the Commission on Higher Education shall report to the
18	Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee regarding the utilization
19	<u>of this provision.</u>
20	Funds not expended in the prior fiscal year may be carried forward into the current fiscal year and utilized for the same purpose,
21	subject to the matching requirement.
22	(D) There is established the 'South Carolina Farm Aid Fund' which shall be administered by the Department of Agriculture and
23	used to operate a grant program that provides financial assistance to farmers. This fund is separate and distinct from the general
24	fund of the State and all other funds.
25	To be eligible for a grant, the person must have:
26	(1) experienced a verifiable loss of agricultural commodities of at least forty percent as a result of the catastrophic flooding
27	of October 2015, for which:
28	(a) the Governor declared a state of emergency in the State; and
29	(b) the United States Secretary of Agriculture issued a Secretarial Disaster Declaration for the county in which the farm
30	is located;
31	(2) a farm number issued by the Farm Service Agency; and
32	(3) signed an affidavit, under penalty of perjury, certifying that each fact of the loss presented by the person is accurate.
33	The Department of Revenue shall assist the Department of Agriculture in the administration of the grant program by providing
34	auditing services, accounting services, and review and oversight of all financial aspects of the grant program. There is created the
35	Farm Aid Advisory Board to make recommendations to the Department of Agriculture regarding the duties of the department in
36	administering the grant program. The Commissioner of Agriculture, or his designee, shall serve ex officio, as chairman of the board.

1	Also, the Director of the Department of Revenue, or his designee, the Vice President for Public Service and Agriculture of Clemson
2	Public Service Activities, or his designee, and the Vice President for Land Grant Services of South Carolina State Public Service
3	Activities, or his designee, shall serve on the board. Finally, the following additional members shall be appointed to the board:
4	(1) the Commissioner of Agriculture shall appoint one member representing South Carolina Farm Bureau;
5	(2) the Commissioner of Agriculture shall appoint one member representing a farm credit association;
6	(3) the Director of the Department of Revenue shall appoint one member of the crop insurance industry; and
7	(4) the Director of the Department of Revenue shall appoint and one agricultural commodities producer.
8	No later than July 31, 2016, the board shall hold its initial meeting to recommend an application process by which a person with
9	a loss resulting from the flooding in October 2015, may apply for a grant. Upon adoption of an application process, the Department
10	of Agriculture shall provide the Chairman of the House Ways and Means Committee and the Chairman of the Senate Finance
11	Committee with a written copy of its application process within ten days after its adoption. A person shall apply not later than
12	forty-five days after the adoption of the application process. The Department of Agriculture must ensure every person interested in
13	applying for a grant has access to adequate resources to submit his application in a timely manner, and upon request, the department
14	must assist a person with the preparation of his application.
15	Each grant awarded by the Department of Agriculture may not exceed twenty percent of the person's verifiable loss of agricultural
16	commodities. However, a person, including any grant made to a related person, may not receive grants aggregating more than one
17	hundred thousand dollars. Also, a person, including any grant made to a related person, may not receive grants that when combined
18	with losses covered by insurance, exceed one hundred percent of the actual loss. If a grant is made to a related person, the amount
19	to be included in the limits set by this section must be the amount of the grant multiplied by the person's ownership interest in the
20	related person. However, a person who shares an ownership interest with another person or entity may not be refused a grant solely
21	because the other person or related person has otherwise received the maximum grant amount, but in this case, the person's grant
22	amount is limited by the person's ownership interest. If the total amount of grants allowed pursuant to this paragraph exceeds the
23	monies in the fund, then each person's grant must be reduced proportionately.
24	To determine loss, the department:
25	(1) must measure the person's cumulative total loss of all affected agricultural commodities for 2015 against the person's
26	expected production of all agricultural commodities affected by the flood in 2015;
27	(2) shall use the person's applicable actual production history yield, as determined by the Federal Crop Insurance
28	Corporation, to determine loss for insured agricultural commodities. In determining loss for uninsured agricultural commodities,
29	the department shall use the most recent year's county price and county yield, as applicable, as determined by the National
30	Agriculture Statistics Service, United States Department of Agriculture; and
31	(3) may require any documentation or proof it considers necessary to efficiently administer the grant program, including the
32	ownership structure of each entity and the social security numbers of each owner. Minimally, in order to verify loss, the Department
33	of Agriculture shall require the submission of dated, signed, and continuous records. These records may include, but are not limited
34	to, commercial receipts, settlement sheets, warehouse ledger sheets, pick records, load summaries, contemporaneous measurements,
35	truck scale tickets, contemporaneous diaries, appraisals, ledgers of income, income statements of deposit slips, cash register tape,
36	invoices for custom harvesting, u-pick records, and insurance documents.

1	Grant awards must be used for agricultural production expenses and losses due to the flood which demonstrate an intent to
2	continue the agricultural operation; however, awards may not be used to purchase new equipment. The Department of Agriculture
3	shall develop guidelines and procedures to ensure that funds are expended in the manner outlined in grant applications, and may
4	require any documentation it determines necessary to verify the appropriate use of grant awards including receipts.
5	If the Department of Agriculture determines that a person who received a grant provided inaccurate information, then the person
6	shall refund the entire amount of the grant. If the department determines that a person who received a grant used the funds for
7	ineligible expenses, then the person must refund the amount of the ineligible expenses. If the person does not refund the appropriate
8	amount, the Department of Revenue shall utilize the provisions of the Setoff Debt Collection Act to collect the money from the person.
9	If the department determines that a person knowingly provided false information to obtain a grant pursuant to this section or
10	knowingly used funds for ineligible expenses the person shall be subject to prosecution pursuant to Section 16-13-240.
11	Within forty-five days of the completion of the awarding of grants, but no later than June 30, 2017, the Farm Aid Advisory Board
12	is dissolved. Any funds remaining in the fund upon dissolution shall lapse to the general fund.
13	For purposes of this provision:
14	(1) 'Agricultural commodities' means wheat, cotton, flax, corn, dry beans, oats, barley, rye, tobacco, rice, peanuts, soybeans,
15	sugar beets, sugar cane, tomatoes, grain sorghum, sunflowers, raisins, oranges, sweet corn, dry peas, freezing and canning peas,
16	forage, apples, grapes, potatoes, timber and forests, nursery crops, citrus, and other fruits and vegetables, nuts, tame hay, native
17	grass, aquacultural species including, but not limited to, any species of finfish, mollusk, crustacean, or other aquatic invertebrate,
18	amphibian, reptile, or aquatic plant propagated or reared in a controlled or selected environment, excluding stored grain.
19	(2) 'Person' means any individual, trust, estate, partnership, receiver, association, company, limited liability company,
20	corporation, or other entity or group.
21	(3) 'Related person' means any person, joint venture, or entity that has a direct or indirect ownership interest of a person or
22	<u>legal entity.</u>
23	If the General Assembly enacts a grant program in the permanent laws of this state substantially similar to the program established
24	in this proviso, codified in the 1976 Code, then the provisions contained in the 1976 Code shall govern the operations of the program
25	and this proviso shall have no force and effect.
26	(E) The source of revenue appropriated in this subsection is unobligated Fiscal Year 2015-16 General Fund surplus revenues
27	collected above the amounts certified by the Board of Economic Advisors. The appropriations are listed in priority order. Item (1)
28	must be funded first and each remaining item must be fully funded before any funds are allocated to the next item. Provided, however,
29	that any individual item may be partially funded in the order in which it appears to the extent that revenues are available.
