OPERATION OF STATE GOVERNMENT

SECTION 1 - H630 - DEPARTMENT OF EDUCATION

7 **1.1.** (SDE: Appropriation Transfer Prohibition) The amounts appropriated herein for aid to subdivisions, allocations to school districts, or special line items shall not be transferred and must be expended in accordance with the intent of the appropriation, except 8 that the department may transfer funds that are deducted and retained from a school district's transportation allocation to reimburse 9 the department for the cost of unauthorized mileage. This transfer must be agreed upon by both the school district and the department. 10 Those funds may be transferred into the department's school bus transportation operating account. 11

1.2. (SDE: DHEC - Comprehensive Health Assessment) All school districts shall participate, to the fullest extent possible, in the 12 Medicaid program by seeking appropriate reimbursement for services and administration of health and social services. 13 Reimbursements to the school districts shall not be used to supplant funds currently being spent on health and social services. 14

15 1.3. (SDE: EFA Formula/Base Student Cost Inflation Factor) To the extent possible within available funds, it is the intent of the General Assembly to provide for one hundred percent of full implementation of the Education Finance Act to include an inflation 16 factor projected by the Revenue and Fiscal Affairs Office to match inflation wages of public school employees in the Southeast. The 17 base student cost for the current fiscal year has been determined to be \$2,425. For the current fiscal year, the total pupil count is 18 projected to be 721,401. The average per pupil funding is projected to be \$6,120 state, of which \$2,339 comes from the EFA, \$1,294 19 federal, and \$5,726 local. This is an average total funding level of \$13,140 excluding revenues of local bond issues. For the current 20 fiscal year the South Carolina Public Charter School District and any institution of higher education sponsoring a public charter 21 school shall receive and distribute state EFA funds to the charter school as determined by one hundred percent of the current year's 22

23 base student cost, as funded by the General Assembly multiplied by the weighted students pupils enrolled in the charter school, which 24

must be subject to adjustment for student attendance.

The Revenue and Fiscal Affairs Office, must post in a prominent place on their website for each school district projections, 25 including the per pupil state, federal and local revenues, excluding revenues of local bond issues, for the current fiscal year. Also, 26 as soon as practicable, upon determining the exact numbers regarding pupil count and funding, the Revenue and Fiscal Affairs Office, 27 shall also post on their website the one hundred thirty-five day average daily membership for each school district and per pupil state, 28 federal and local revenues, excluding revenues of local bond issues, based on the most recent audited financial statement as reported 29 annually pursuant to Section 59-17-100. The Department of Education and the Education Oversight Committee shall provide in a 30 prominent place on their internet websites a link to the information posted by the Revenue and Fiscal Affairs Office, including the 31 projected numbers and the exact numbers. 32

For the current fiscal year, the pupil classification weightings are as follows: 33

1.4. (SDE: EFA - Formula) The amount appropriated in Part IA, Section 1 for "Education Finance Act" shall be the maximum 3 paid under the provisions of Act 163 of 1977 (the South Carolina Education Finance Act of 1977) to the aggregate of all recipients. 4 5 The South Carolina Education Department shall develop formulas to determine the state and required local funding as stipulated in 6 the South Carolina Education Finance Act of 1977. Such formulas shall require the approval of the State Board of Education and 7 the State Fiscal Accountability Authority. After computing the EFA allocations for all districts, the department shall determine 8 whether any districts' minimum required local revenue exceeds the districts' total EFA Foundation Program. When such instance is found, the department shall adjust the index of taxpaying ability to reflect a local effort equal to the cost of the districts' EFA 9 Foundation Program. The districts' weighted pupil units are to be included in determination of the funds needed for implementation 10 11 of the Education Finance Act statewide. 12 In the event that the formulas as devised by the Department of Education and approved by the State Board of Education and the State Fiscal Accountability Authority should provide for distribution to the various school districts totaling more than the amount 13 appropriated for such purposes, subject to the provisions of this proviso, the Department of Education shall reduce each school district 14 15 entitlement by an equal amount per weighted pupil so as to bring the total disbursements into conformity with the total funds appropriated for this purpose. If a reduction is required in the state's contribution, the required local funding shall be reduced by the 16 proportionate share of local funds per weighted pupil unit. The Department of Education shall continually monitor the distribution 17 of funds under the provisions of the Education Finance Act and shall make periodic adjustments to disbursements to ensure the 18 aggregate of such disbursements do not exceed the appropriated funds. 19 Local districts shall not be mandated or required to inflate the base number in their respective salary schedules by any percentage 20 21 greater than the percentage by which the appropriated base student cost exceeds the appropriated base student cost of the prior fiscal 22 year. 23 **1.5.** (SDE: Employer Contributions/Allocations) It is the intent of the General Assembly that the appropriation contained herein for "Public School Employee Benefits" shall not be utilized to provide employer contributions for any portion of a school district 24 25 employee's salary that is federally funded. State funds allocated for school district employer contributions must be allocated by the formula and must be used first by each 26

district to cover the cost of fringe benefits for personnel required by the Defined Program, food service personnel and other personnel
 required by law. Once a district has expended all state allocated funds for fringe benefits, the district may utilize food service
 revenues to fund a proportionate share of fringe benefits costs for food service personnel.

The Department of Juvenile Justice and the Department of Corrections' school districts must be allocated funds under the fringe benefits program in accordance with criteria established for all school districts.

32 **1.6.** (SDE: Employer Contributions/Obligations) In order to finalize each school district's allocations of Employer Contributions

33 funds for retiree insurance from the prior fiscal year, the Department of Education is authorized to adjust a school district's allocation

in the current fiscal year accordingly to reflect actual payroll and payments to the Retirement System from the prior fiscal year. In

35 the event the Department of Education is notified that an educational subdivision has failed to remit proper payments to cover

1 Employee Fringe Benefit obligations, the Department of Education is directed to withhold the educational subdivision's state funds

2 until such obligations are met.

3 1.7. (SDE: Governor's School for Science & Math) Any unexpended balance on June thirtieth of the prior fiscal year of funds appropriated to or generated by the Governor's School for Science and Mathematics may be carried forward and expended in the current fiscal year pursuant to the direction of the board of trustees of the school.

6 **1.8.** (SDE: Educational Responsibility/Foster Care) The responsibility for providing a free and appropriate public education 7 program for all children including disabled students is vested in the public school district wherein a child of lawful school age resides in a foster home, group home, orphanage, or a state operated health care facility including a facility for treatment of mental illness 8 or chemical dependence and habilitation centers for persons with intellectual disabilities or persons with related conditions located 9 within the jurisdiction of the school district or alternative residences. The districts concerned may agree upon acceptable local cost 10 11 reimbursement. If no agreement is reached, districts providing education shall receive from the district where the child last resided 12 before placement in a facility an additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. If a child from out of state is residing 13 in a facility owned and/or operated by a for profit entity, the district providing educational services shall be reimbursed by the for 14 profit entity the local district's local support per weighted pupil above the statewide average base student cost multiplied by the 15 appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act. This also applies to John de la Howe 16 School who also has the authority to seek reimbursement in any situation that the school district has participation in the placement 17 of the student. John de la Howe School shall be reimbursed the local district's local support per weighted pupil above the statewide 18 average base student cost multiplied by the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance 19 Act. Participation will be evidenced by a written agreement from the IEP team or 504 team, written referral, or the school district 20 initiating the placement process. School districts providing the education shall notify the nonresident district in writing within 21 forty-five calendar days that a student from the nonresident district is receiving education services pursuant to the provisions of the 22 23 proviso. The notice shall also contain the student's name, date of birth, and disabling condition if available. If appropriate financial arrangements cannot be effected between institutions of the state, including independent school districts under the authority of the 24 25 Department of Disabilities and Special Needs, and school districts, institutions receiving educational appropriations shall pay the 26 local base student cost multiplied by the appropriate pupil weighting. Children residing in institutions of state agencies shall be educated with nondisabled children in the public school districts if appropriate to their educational needs. Such institutions shall 27 28 determine, on an individual basis, which children residing in the institution might be eligible to receive appropriate educational 29 services in a public school setting. Once these children are identified, the institution shall convene an IEP meeting with officials of 30 the public school district in which the institution is located. If it is determined by the committee that the least restrictive environment 31 in which to implement the child's IEP is a public school setting, then the school district in which the institution is located must provide the educational services. However, that school district may enter into contractual agreements with any other school district 32 having schools located within a forty-five mile radius of the institution. The cost for educating such children shall be allocated in 33 34 the following manner: the school district where the child last resided before being placed in an institution shall pay to the school 35 district providing the educational services an amount equivalent to the statewide average of the local base student cost multiplied by 36 the appropriate pupil weighting as set forth in Section 59-20-40 of the Education Finance Act; the school district providing the

1 educational services shall be able to count the child for all funding sources, both state and federal. The institution and school district,

through contractual agreements, will address the special education and related services to be provided to students. Should the school district wherein the institution is located determine that the child cannot be appropriately served in a public school setting, then the

institution may request a due process hearing pursuant to the procedures provided for in the Individuals with Disabilities Education
 Act.

The agreed upon acceptable local cost reimbursement or the additional amount equivalent to the statewide average of the local base student cost multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to out-of-district students, shall be paid within sixty days of billing, provided the billing district has provided a copy of the invoice to both the Superintendent and the finance office of the district being invoiced. Should the district not pay within sixty days, the billing district can seek relief from the Department of Education. The department shall withhold EFA funding equal to the billing from the district refusing to pay and submit the funding (equal to the invoice) to the billing school district.

12 The agency placing a child in any situation that requires changing school districts, must work with the schools to assure that all required school records, including confidential records, are transferred from the sending to the receiving school within three working 13 days. School records to be transferred should include grade transcripts, state birth certificate, certificate of immunization, social 14 security card, attendance records, discipline records, IEP's, psychological reports (or notation in the school records that a 15 psychological report on the child is available at the school district office) and any other records necessary for the appropriate 16 placement of the child in the new school. School districts must release all records upon presentation of a court order or appropriate 17 permission for confidential release. If evaluation or placement is pending, the receiving school district is responsible to secure 18 information and to complete the placement. The receiving school will maintain appropriate confidentiality of all records received 19 on a child. Upon discharge or release from the treatment facility, the agency placing the child in the receiving school must work 20

21 with the school district where the student will reside after treatment to assure continuity of the student's education.

1.9. (SDE: Instruction in Juvenile Detention Centers) It shall be the responsibility of the school district where a local juvenile detention center is located to provide adequate teaching staff and to ensure compliance with the educational requirements of this State. Students housed in local juvenile detention centers are to be included in the average daily membership count of students for that district and reimbursement by the Department of Education made accordingly.

1.10. (SDE: Revenue Authorization) The State Department of Education is hereby authorized to collect, expend, and carry 26 27 forward revenues in the following areas to offset the cost of providing such services: the sale of publications, manuals and forms, 28 the sale of Apple Tags, royalties, contributions, donations, foundation funds, special grants and contracts, brochures, photo copies, listings and labels, Directory of South Carolina Schools, student health record cards, items to be recycled, and high school diplomas 29 and certificates; the collection of out-of-state and in-state investigation fees, registration fees for non-SDE employees, recurring 30 31 facility inspection fees, teacher certification fees; the handling of audio-visual film; the provision of contract computer services to school districts and other state agencies, joint broadcast service to school districts, and education-related statistics through agreement 32 with the National Center for Education Statistics; the lease or sale of programs of television, audio or microcomputer software; the 33 34 lease or sale of virtual courses to other states; the collection of damage fees for instructional materials and the sale of unusable instructional materials; sale of fuel; use and repair of transportation equipment; fees for Medicaid reimbursable transportation; the 35

36 receipt of insurance and warranty payments on Department of Education equipment and the sale of used school buses and support

equipment. The Department of Education is authorized to collect revenue for deposit into the State General Fund for testing material purchases and test rescoring fees. The Department of Education is authorized to expend revenue collected for lost and damaged instructional materials and the sale of unusable instructional materials for the purpose of contracting for the purchase and maintenance of a statewide textbook inventory management system, provided that schools' newly-adopted instructional materials needs are met first.

1.11. (SDE: School District Bank Accounts) Each school district in this State, upon the approval of the district's governing
 body, may maintain its own bank account for the purpose of making disbursement of school district funds as necessary to conduct
 school district business and each county treasurer is hereby authorized to transfer such amount as needed, upon receipt of a written
 order certified by the district governing body or their designee. Such order shall contain a statement that such amount is for immediate
 disbursement for the payment of correct and legal obligation of the school district.

11 1.12. (SDE: School Lunch Program Aid) The amount appropriated herein for School Lunch Program Aid shall be divided among 12 the District and/or County Boards of Education of the State upon the basis of the number of schools participating in the School Lunch 13 Program in each district during the prior school year. The travel expenses of the District and/or County School Lunch Supervisor 14 shall be paid from this appropriation at the prevailing rate of mileage allowed by the State. These funds may be used as an aid in 15 improving the School Lunch Program. These funds may not be used to supplement the salaries of school lunch supervisors. In the 16 absence of a County Board of Education in multi-district counties, the funds will be divided among the school districts of the county 17 on the basis of the number of schools participating in the School Lunch Program in each district during the prior school year.

18 1.13. (SDE: Travel/Outside of Continental U.S.) School District allocations from General Funds, lottery, and EIA funds shall
 19 not be used for travel outside of the continental United States. The International Baccalaureate Program shall be exempt from this
 20 restriction.

1.14. (SDE: Year End Closeout) The State Department of Education is authorized to expend federal and earmarked funds (not including state or EIA funds) in the current fiscal year for expenditures incurred in the prior year; however, state funds appropriated in Part IA, Section 1, X, Aid to School Districts, for the Children's Case Resolution System or private placements for services provided to children with disabilities may be used for those expenditures in prior fiscal years. The department is also authorized to use appropriated funds to pay for textbooks shipped in the fourth quarter of the prior fiscal year.

1.15. (SDE: Transportation Collaboration) The Department of Education School Bus Maintenance Shops shall be permitted, on
 a cost reimbursable-plus basis, to deliver transportation maintenance and services to vehicles owned or operated by public agencies
 in South Carolina.

School buses operated by school districts, other governmental agencies or head start agencies for the purpose of transporting students for school or school related activities shall not be subject to state motor fuel taxes. Further, that school districts, other governmental agencies or head start agencies may purchase this fuel, on a cost reimbursable-plus basis, from the Department of Education School Bus Maintenance Shops.

33 **1.16.** (SDE: School Bus Insurance) The Department of Education shall maintain comprehensive and collision insurance or 34 self-insure state-owned buses. In no event shall the department charge local school districts for damages to the buses which are 35 commonly covered by insurance.

1.17. (SDE: Teacher Data Collection) Of the non-program funds appropriated to the Department of Education, it and the 1 2 Commission on Higher Education shall share data about the teaching profession in South Carolina. The data sharing should ensure (1) a systematic report on teacher supply and demand information and (2) data to determine classes being taught by public school 3 4 teachers out of field of their preparation. The data collection should include but not be limited to: classes/subjects taught, number 5 of students taught, percentage of teacher education graduates from South Carolina colleges/universities who go into teaching, 6 percentage of teacher education graduates who teach in public schools in South Carolina, percentage of new teachers who leave the 7 South Carolina teaching profession in the first three years of public school teaching due to unsuccessful evaluations, percentage of 8 new teachers who leave the profession in the first three years of public school teaching in South Carolina who have successful evaluations, turnover rate of teachers and certification areas with highest vacancies. All database items should be set up so that it 9 can be disaggregated by ethnicity, gender, geographic location, etc. 10

11 **1.18.** (SDE: School Bus Driver CDL) From funds provided in Part IA, Section 1, VII.B., local school districts shall request a 12 criminal record history from the South Carolina Law Enforcement Division for past conviction of any crime before the initial 13 employment of a school bus driver or school bus aide. The Department of Education and the school districts shall be treated as a 14 charitable organization for purposes of the fee charged for the criminal records search.

15 1.19. (SDE: School Bus Purchase) Any procurement of school buses with funds appropriated in this act or any other appropriation bill must meet specifications developed by the School Bus Specification Committee as established by the State 16 Superintendent of Education. The School Bus Specifications Committee shall allow for input from all school bus chassis and body 17 manufacturers. However, if it is safe, more economical, and in the public interest, the department may use the school bus 18 specifications of another state in the procurement of school buses. If the department uses the specifications of another state, the 19 department must submit a report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means 20 Committee detailing the methodology by which the alternative specifications were determined to be safe, more economical, and in 21 the public interest, when compared to the specifications set forth by the School Bus Specifications Committee. 22

1.20. (SDE: Buses, Parts, and/or Fuel) Funds appropriated for other operating in program VII.B. - Bus Shops and funds appropriated in VII.C. - Buses may be used to purchase buses, fuel, parts, or other school bus related items. All funds appropriated for bus fuel, parts/supplies, maintenance, and bus purchases may be carried forward from the prior fiscal year and expended in the current fiscal year to support bus transportation services.

1.21. (SDE: Mitford Transportation Costs) Transportation costs for the transporting of students from the Mitford area of Fairfield
 County to schools in the Great Falls area of Chester County is not the responsibility of and shall not be borne by the Chester County
 School District. These transportation costs shall continue to be the responsibility of the State Department of Education.

30 **1.22.** (SDE: Status Offenders/John de la Howe) The funds appropriated for the Status Offender Program shall be distributed to 31 John de la Howe School to expand residential programs to include court ordered status offenders. Components of such a program 32 shall include collaboration between the home school district and the residential school and treatment or related services to the families 33 of students in placement.

1.23. (SDE: Governor's School Leave Policy) The South Carolina Governor's School for the Arts and Humanities and the South
 Carolina Governor's School for Science and Mathematics are authorized to promulgate administrative policy governing annual and

sick leave relative to faculty and staff with the approval of their respective board of directors. This policy shall address their
 respective school calendars in order to comply with the instructional needs of students attending both special schools.

1.24. (SDE: School Board Meetings) Of the funds appropriated through the Department of Education for technology related expenses, school districts that have a website shall place a notice of a regularly scheduled school board meeting twenty-four hours in advance of such meeting. The notice shall include the date, time, and agenda for the board meeting. The school district shall place the minutes of the board meeting on their website within ten days of the next regularly scheduled board meeting.

1.25. (SDE: Proviso Allocations) In the event an official General Fund revenue shortfall is declared by the Board of Economic Advisors, the Department of Education may reduce any allocation in Section 1 specifically designated by proviso in accordance with the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office, except the additional EFA allocation to the South Carolina Public Charter School District. The reduction may not be greater than the total percentage of reduction of the Section 1 appropriation. Should the department hold back funds in excess of the total percentage reduction those funds must be allocated per the proviso. No allocation for teacher salaries shall be reduced as a result of this proviso.

1.26. (SDE: School Districts and Special Schools Flexibility) All school districts and special schools of this State may transfer 13 and expend funds among appropriated state general fund revenues, Education Improvement Act funds, and Education Lottery Act 14 funds, and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, to 15 ensure the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated 16 specifically for state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance 17 of effort requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for 18 Career and Technology Education, funds provided for technology, nor funds required for debt service or bonded indebtedness. All 19 school districts and special schools of this State may suspend professional staffing ratios and expenditure regulations and guidelines 20 at the sub-function and service area level, except for four-year old programs and programs serving students with disabilities who 21

22 have Individualized Education Programs.

In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per pupil expenditures must be utilized within the In\$ite categories of instruction, instructional support, and only transportation, food service, and safety within non-instruction pupil services. No portion of the seventy-five percent may be used for facilities, business services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional support, and transportation, food service, and safety within non-instruction pupil services for the current school year ending June thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures.

30 "In\$ite" means the financial analysis model for education programs utilized by the Department of Education.

School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and memberships, reducing transportation costs for extracurricular and academic competitions, restructuring administrative staffing, and

34 expanding virtual instruction.

35 School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year.

Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 1 2 allocation due to them for each categorical program. Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school 3 4 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken. 5 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of 6 7 the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education 8 and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting, and the certification must be conspicuously posted on the internet website maintained by the school district. 9 For the current fiscal year, Section 59-21-1030 is suspended. The foreign language program assessment, and the physical 10 education assessment must be suspended. School districts and the Department of Education are granted permission to purchase the 11 most economical type of bus fuel. 12 For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school 13 districts based on weighted pupil units. 14 15 School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made 16 available for public viewing and downloading. The register must include for each expenditure: 17 (i) the transaction amount: 18 (ii) the name of the payee; and 19 (iii) a statement providing a detailed description of the expenditure. 20 The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must 21 not include any information that can be used to identify an individual employee. The register must be accompanied by a complete 22 23 explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at 24 least once a month. 25 Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards 26 maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the 27 thirtieth day after the first date that any portion of the balance due as shown on the statement is paid. 28 The Comptroller General must establish and maintain a website to contain the information required by this section from a school 29 district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate 30 31 between the school districts and search for the information they are seeking. School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller 32 General in a manner and at a time determined by the Comptroller General to be included on the internet website. 33

34 The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 30, of the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of 35

Education to exercise its authority to grant waivers under Regulation 43-261. 36

1.27. (SDE: Medical Examination and Security Reimbursement/Expenditures) From funds authorized in Part IA, Section 1,
 VII.B. Other Operating Expenses, the Department of Education may directly pay, or reimburse employees, for the cost of a medical
 examination as required in Part 391, Subpart E of the Federal Motor Carrier Safety Regulations, for employees that are required to
 operate a state vehicle transporting hazardous materials and that are required to undergo a national security background check because
 of the required Hazmat endorsement to their CDL.

6 1.28. (SDE: Budget Reduction) In compensating for any reduction in funding or an operating deficit publically recognized by
 7 the School Board of Trustees, local districts must give priority to preserving classroom teachers and operations. Funding reductions
 8 should first be applied to administrative and non-classroom expenses before classroom expenses are affected.

9 1.29. (SDE: Governor's School for the Arts and Humanities Carry Forward) Any unexpended balance on June thirtieth of the 10 prior fiscal year of funds appropriated to or generated by the Governor's School for the Arts and Humanities may be carried forward 11 and expended in the current fiscal year pursuant to the discretion of the Board of Trustees of the School.

12 **1.30.** (SDE: Governor's Schools' Fees) The South Carolina Governor's School for the Arts and Humanities and the South 13 Carolina Governor's School for Science and Mathematics are authorized to charge, collect, expend, and carry forward student fees 14 as approved by their respective Board of Directors. The purpose and amount of any such fees will be to maintain program quality in 15 both academics and residential support. No student will be denied admittance or participation due to financial inability to pay. The 16 respective Board of Directors shall promulgate administrative policy governing the collection of all student fees. Both schools shall 17 conspicuously publish a fee schedule on their respective websites.

1.31. (SDE: School District Furlough) Should there be a midyear reduction in state funding to the districts, school districts may institute employee furlough programs for district-level and school-level professional staff. Before any of these employees may be furloughed, the chairman of the governing body of the school district must certify that all fund flexibility provided by the General Assembly has been utilized by the district and that the furlough is necessary to avoid a year-end deficit and a reduction in force. The certification must include a detailed report by the superintendent of the specific action taken by the district to avoid a year-end deficit. The certification and report must be in writing and delivered to the State Superintendent of Education and a copy must be forwarded to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

25 The local school district board of trustees may implement a furlough of personnel once certification to the State Superintendent 26 documents all funding flexibility has been exhausted and continued year-end deficits exist. Local school boards of trustees shall 27 have the authority to authorize furloughs of these employees in the manner in which it sees fit. However, instructional personnel 28 may be furloughed for up to five non-instructional days if not prohibited by an applicable employment contract with the district and provided district administrators are furloughed for twice the number of days. District administrators may only be furloughed on 29 non-instructional days and may not be furloughed for a period exceeding ten days. District administrators shall be defined by the 30 31 Department of Education using the Professional Certified Staff (PCS) System. For individuals not coded in PCS, the determination shall be made based upon whether the individual performs the functions outlined in position codes identified by the department as 32 administration. Educators who would have received a year's experience credit had a furlough not been implemented, shall not have 33 34 their experience credit negatively impacted because of a furlough implementation.

During any furlough, affected employees shall be entitled to participate in the same benefits as otherwise available to them except for receiving their salaries. As to those benefits that require employee and employee contributions, including, but not limited to,

contributions to the South Carolina Retirement System or the optional retirement program, the district will be responsible for making 1 2 both employer and employee contributions if coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the employee remains solely responsible for making those contributions. Placement of an employee on 3 4 furlough under this provision does not constitute a grievance or appeal under any employee grievance procedure. The district may 5 allocate the employee's reduction in pay over the balance of the fiscal year for payroll purposes regardless of the pay period within 6 which the furlough occurs. 7 Each local school district must prominently post on the district's internet website and make available for public viewing and 8 downloading the most recent version of the school district's policy manual and administrative rule manual. This proviso shall not abrogate the terms of any contract between any school district and its employees. 9 **1.32.** (SDE: School Lunch/Attendance Supervisors) For those counties in which an entity other than the school district 10 administers the school lunch supervisor and/or attendance supervisor programs, the school districts in that county shall transfer to 11 the entity the amount available in the previous fiscal year for administration of the school lunch supervisor and/or attendance 12 supervisor programs. Each district shall transfer a pro rata share of the total cost based upon the percentage of state EFA funds 13 distributed to the districts within the county. 14 15 1.33. (SDE: SCGSAH Certified Teacher Designation) Because of the unique nature of the South Carolina Governor's School for the Arts and Humanities, the Charleston School of the Arts, and the Greenville County Fine Arts Center, the schools are authorized 16 to employ at its discretion noncertified classroom teachers teaching in the literary, visual and performing arts subject areas who are 17 otherwise considered to be appropriately qualified in a ratio of up to one hundred percent of the entire teacher staff. 18 1.34. (SDE: No Discrimination Requirement) State funds must not be appropriated to a school that discriminates against or 19 participates with or is a member of an association with policies that discriminate or afford different treatment of students based on 20 race or national origin. 21 **1.35.** (SDE: Medicaid Cash Match Accounting) The department is granted authority to transfer funds between budget lines and 22 object codes to identify, reconcile, reimburse, and remit funds required for Medicaid cash match to the Department of Health and 23 24 Human Services. 25 **1.36.** (SDE: Student Report Card-GPA) For each high school student, school districts shall be required to print the student's 26 individual cumulative grade point average for grades nine through twelve on the student's report card. 1.37. (SDE: Lost & Damaged Instructional Materials Fees) Fees for lost and damaged instructional materials for the prior school 27 year are due no later than December first of the current school year when invoiced by the Department of Education. The department 28 29 may withhold instructional materials funding from schools that have not paid their fees by the payment deadline. 1.38. (SDE: Education Finance Act Reserve Fund) There is created in the State Treasury a fund separate and distinct from the 30 31 General Fund of the State and all other funds entitled the Education Finance Act Reserve Fund. All unexpended general funds appropriated to the Department of Education for the Education Finance Act in the current fiscal year shall be transferred to the 32 Education Finance Act Reserve Fund. In the event that the amount appropriated for the Education Finance Act is insufficient to fully 33 34 fund the base student cost as established by this act, revenues from the Education Finance Act Reserve Fund may be used to

35 supplement the funds appropriated. By June 30th of the current fiscal year, if the department determines that the funds are not needed

36 *to supplement the Education Finance Act, the department may utilize the funds for bus purchase.* The General Assembly may make

direct appropriations to this fund. All unexpended funds in the Education Finance Act Reserve Fund and any interest accrued by the
 fund must remain in the fund and may be carried forward into the current fiscal year.

1.39. (SDE: Prohibit Advertising on School Buses) The Department of Education and local school districts are prohibited from
 selling space for or the placement of advertisements on the outside or inside of state-owned school buses.

5 1.40. (SDE: Residential Treatment Facilities Student Enrollment and Funding) Each South Carolina resident of lawful school 6 age residing in licensed residential treatment facilities (RTFs) for children and adolescents identified on the State Oualified Providers 7 list and meets the requirements of Section 44-7-130 of the 1976 Code, (students) shall be entitled to receive educational services 8 from the school district in which the RTF is located (facility school district). The responsibility for providing appropriate educational programs and services for these students, both with and without disabilities, who are referred, authorized, or placed by the State is 9 vested in the facility school districts. For purposes of this proviso, an authorization must be pursuant to a physician's determination 10 of medical necessity. If clinically appropriate, the facility school district, the RTF, and the parent or guardian of a student referred 11 or placed in a RTF may consider the appropriateness of providing the student's education program virtually through enrollment in 12 either the facility district's virtual program, the South Carolina virtual school program provided through the Department of Education 13 (Virtual SC), or a virtual charter school authorized by the South Carolina Public Charter School District, or a virtual charter school 14 15 authorized by an approved institute of higher education. This decision should be made jointly with the best interest of the student and what is clinically indicated being considered. 16

A facility school district must provide the necessary educational programs and services directly to the student at the RTF's facility, 17 provided that the RTF facility provides and maintains comparable adequate space for the educational programs and services 18 consistent with all federal and state least restrictive environment requirements. Adequate space shall include appropriate electrical 19 support and Internet accessibility. Unless the parent or legal guardian of the student seeks to continue the student's enrollment in 20 the resident school district under a medical homebound instruction program and the district appropriate, then, under 21 these circumstances, the facility school district shall enroll the student and assume full legal and financial responsibility for the 22 23 educational services including enrolling the student, approving the student's entry into a medical homebound instructional program, 24 if appropriate, and receiving and expending funds, unless the resident school district undertakes to carry out its educational 25 responsibilities for the student directly. Alternatively, a facility school district may choose to provide the necessary educational 26 programs and services by contracting with the RTF provided that the RTF agrees to provide educational services to the student at the 27 RTF's facility. Under these circumstances, the facility school district must enroll the student and pay the RTF for the educational 28 services provided. If the facility school district determines the educational program being offered by the RTF does not meet the 29 educational standards outlines in the contract, the facility district shall be justified in terminating the contract.

The facility school districts are entitled to receive the base student cost multiplied by the Education Finance Act pupil weighting for Homebound pupils of 2.10, as set forth in Section 59-20-40 of the 1976 Code and any eligible categorical and federal funds. These funds may be retained by the facility school districts for the purpose of providing the educational programs and services directly to students referred or placed by the State or the facility school districts may use these funds to reimburse RTFs for the educational programs and services provided directly by the RTFs. A facility school district is entitled to reimbursement from a resident school district for the difference between (1) the reasonable costs expended for the educational services provided directly by the facility school district or the amount paid to the RTF and (2) the aggregate amount of federal and state funding received by

the facility school district for that student. However, the reimbursement rate may not exceed \$45 per student per day. Facility school 1 2 districts providing the educational services shall notify the resident district in writing within forty-five calendar days that a student from the resident district is receiving educational services pursuant to the provisions of the provision. Reimbursements shall be paid 3 4 within sixty days of billing, provided the facility district has provided a copy of the invoice to both the District Superintendent and 5 the finance office of the resident district being invoiced. Should the facility school district be unable to reach agreement with the 6 resident school district regarding reasonable costs differences, the facility school district shall notify the Department of Education's 7 Office of General Counsel. The Department of Education shall facilitate a resolution of the dispute between the facility school district and the resident school district within forty-five days of the notice of dispute. If the issue of reasonable cost differences 8 should remain unresolved, a facility school district shall have the right to file a complaint in a Circuit Court. Should a resident school 9 district fail to distribute the entitled funding to the facility school district by the one hundred thirty-five day count, the Department 10 of Education is authorized to withhold the equivalent amount of EFA funds and transfer those funds to the facility school district. 11 12 RTF facilities on the State Qualified Provider List not located within the boundaries of the state shall be reimbursed at a rate that may not exceed \$45 per student per day for education services and school districts shall be eligible to receive a base student cost 13 weighted funding of 2.10 provided that the student remains enrolled in the school district. Facilities providing the educational 14 services shall notify the resident district in writing within forty-five calendar days that a student from the resident district is receiving 15 educational services pursuant to the provisions of the proviso. Reimbursements shall be paid within sixty days of billing, provided 16 the qualified facility has provided a copy of the invoice to both the District Superintendent and the finance office of the resident 17 district being invoiced. Should the facility be unable to reach agreement with the resident school district regarding reasonable costs 18 differences, the provider shall notify the Department of Education's Office of General Counsel. The Department of Education shall 19 facilitate a resolution of the dispute between the facility and the resident school district within forty-five days of the notice of dispute. 20 If the issue of reasonable cost differences should remain unresolved, a facility shall have the right to file a complaint in a Circuit 21 Court. Additionally, gualified RTF providers' general education curriculum must be aligned to the South Carolina academic 22 23 standards in the core content areas. All students with disabilities who are eligible for special education and related services under 24 the Individuals with Disabilities Education Act (IDEA), as amended, and the State Board of Education (SBE) regulations, as 25 amended, shall receive special education and related services in the least restrictive environment by appropriately certified personnel. 26 Students in a qualified RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned through their 27 educational efforts. The resident school district and the RTF should develop a memorandum of understanding to outline the 28 responsibilities of the RTF in providing the educational services and responsibilities, if any, of the resident school district while the 29 student is housed in the RTF.

If a child from out of state is placed in a RTF by an out-of-state school district or agency, the child's home state remains responsible for the educational services. The facility school district may choose to provide the educational program to the child and, upon choosing to do so, shall contract with the appropriate entity for payment of educational serviced provided to the child. Out-of-state students provided educational services by a facility school district shall not be eligible for funding through the Education Finance Act.

If a child is placed in a RTF by the child's parent or guardian and is not referred, authorized, or placed by the State, the facility school district may choose to provide the educational program to the child, and upon doing so, must negotiate with the resident

school district for services through medical homebound procedures. A facility school district is responsible for compliance with all 1 2 child find requirements under Section 504 of the Rehabilitation Act of 1973 and Individuals with Disabilities Act of 2004 (IDEA). All students enrolled in the facility school districts shall have access to the facility school districts' general education curriculum, 3 4 which will be tied to the South Carolina academic standards in the core content areas. All students with disabilities who are eligible 5 for special education and related services under the Individuals with IDEA, as amended, and the State Board of Education (SBE) regulations, as amended, shall receive special education and related services in the least restrictive environment by appropriately 6 7 certified personnel. Students in an RTF will at all times be eligible to receive the educational credits (e.g., Carnegie Units) earned through their educational efforts. 8 With respect to students enrolled in the facility school districts, for accountability purposes, the assessment and accountability 9 measures for students residing in RTFs shall be attributed to a specific school only if the child physically attends the school. The 10 performance of students residing in a RTF who receive their educational program on site at the RTF must be reflected on a separate 11 line on the facility school district's report card and must not be included in the overall performance ratings of the facility school 12 district. The Department of Education shall examine the feasibility of issuing report cards for RTFs. For the current fiscal year, a 13 facility school district shall not have the district's state accreditation rating negatively impacted by deficiencies related to the delivery 14 of an educational program at a RTF. 15 RTFs shall notify the facility school district as soon as practical, and before admission to the RTF if practical, of a student's 16 admission to the RTF. RTFs, the facility school districts and the Department of Education shall use their best efforts to secure and/or 17

exchange information, including documents and records necessary to provide appropriate educational services and/or related services as necessary to assist the facility school district in determining the resident school district. The Department of Education, in collaboration with state placing agencies, RTFs, facility school districts, and resident school districts, shall implement a system to follow the release of students from a RTF and re-enrollment in public, private, or special schools to ensure these students, when appropriate, are not recorded as dropouts.

1.41. (SDE: Special Schools Flexibility) For the current fiscal year, the special schools are authorized to transfer funds among
 funding categories, including capital funds.

1.42. (SDE: High School Driver Education) For the current fiscal year, the requirement for high schools to provide a course in
 driver education is suspended however, high schools may continue to offer driver education courses if they choose to do so.

1.43. (SDE: Carry Forward Authorization) For the current fiscal year, the Department of Education is authorized to carry forward
 and expend any General Fund balances for school bus transportation.

1.44. (SDE: Administrative Costs Report Posting) School districts must report the amount of funds spent on administrative costs, as defined by In\$ight in the prior fiscal year and post the report on the districts website. School districts shall provide an electronic copy of this report to the Department of Education in conjunction with the financial audit report required by Section 59-17-100, of the 1976 Code. If a district fails to meet these requirements they must be notified in writing by the department that the district has sixty days to comply with the reporting requirement. If the district does not report within sixty days, the department is authorized to reduce the district's base student cost by one percent until such time as the requirement is met. Once in compliance, any funds withheld will be returned to the district.

1.45. (SDE: Governor's Schools Residency Requirement) Of the funds appropriated, the Governor's School for the Arts and the 1 2 Humanities and the Governor's School for Science and Mathematics are to ensure that a parent(s) or guardian(s) of a student attending either the Governor's School for the Arts and the Humanities or the Governor's School for Science and Mathematics must prove that 3 4 they are a legal resident of the state of South Carolina at the time of application and must remain so throughout time of attendance. 5 The Governor's School for the Arts and the Humanities and Governor's School for Science and Mathematics may not admit students whose parent(s) or guardian(s) are not legal residents of South Carolina. 6 7 1.46. (SDE: Holocaust Funds) Funds appropriated to the Department of Education for the SC Council on Holocaust shall not be used for any other purpose nor transferred to any other program. In addition, in the event the department is required to implement a 8

used for any other purpose nor transferred to any other program. In addition, in the event the department
 budget reduction, SC Council on Holocaust funds may not be reduced.

10 **1.47.** (SDE: Student Health and Fitness) Funds appropriated for Student Health and Fitness shall be allocated to school districts 11 to increase the number of physical education teachers to the extent possible and to provide licensed nurses for elementary public 12 schools. Twenty-seven <u>Twenty-one</u> percent of the funds shall be allocated to the districts based on average daily membership of 13 grades K-5 from the preceding year for physical education teachers. The remaining funds will be made available for school nurses 14 and shall be distributed to the school districts on a per school basis. Schools that provide instruction in grades K-5 are eligible to 15 apply for the school nurse funds.

16 **1.48.** (SDE: Impute Index Value) For the current fiscal year and for the purposes of calculating the index of taxpaying ability 17 the Department of Revenue shall impute an index value for owner-occupied residential property qualifying for the special four 18 percent assessment ratio by adding the second preceding taxable year total school district reimbursements for Tier 1, 2, and Tier 3(A) 19 and not to include the supplement distribution. The Department of Revenue shall not include sales ratio data in its calculation of the 20 index of taxpaying ability. The methodology for the calculations for the remaining classes of property shall remain as required 21 pursuant to the EFA and other applicable provisions of law.

1.49. (SDE: EFA State Share) A school district that does not recognize a State share of the EFA financial requirement shall be
 supplemented with an amount equal to seventy percent of the school district with the least State financial requirement.

24 **1.50.** (SDE: Health Education) (1) Each school district is required to ensure that all comprehensive health education, 25 reproductive health education, and family life education conducted within the district, whether by school district employees or a private entity, must utilize curriculum that complies with the provisions contained in Chapter 32, Title 59 and aligns to all standards 26 and regulations adopted by the South Carolina State Board of Education. Each district shall publish on its website the title and 27 28 publisher of all health education materials it has approved, adopted, and used in the classroom. If the department determines that a district is non-compliant with mandated health education upon review of the district's annual CHE Compliance Survey or if the 29 district fails to publish the title and publisher of materials on its website, then the Department of Education shall withhold one percent 30 31 of the district's funds allocated in Part IA, Section 1, X - Student Health and Fitness Act until the department determines the district is in compliance. 32

(2) Any person may complain in a signed, notarized writing to the chairman of the governing board of a school district that matter
 not in compliance with the requirements of Chapter 32, Title 59 is being taught in the district. Upon receiving a notarized complaint,
 the chairman of the governing board must ensure that the complaint is immediately investigated and, if the complaint is determined
 to be founded, that immediate action is taken to correct the violation. If corrective action is not taken within 60 days of such a

1 determination, or if no investigation is made within 60 days of the chairman's receipt of the notarized statement, then the complainant

2 may within 60 calendar days, give written notice to the department. The notice must include the original notarized complaint. If, 3 upon investigation, the department determines that the district has not taken appropriate immediate action to correct a violation, then

4 the Department of Education shall withhold one percent of the district's funds allocated in Part IA, Section 1, X - Student Health and

5 Fitness Act until the department determines the district is in compliance.

6 **1.51.** (SDE: Bus Lease/Purchase) The Department of Education is permitted to purchase or lease school buses in order to continue replacement of the state's school bus fleet.

8 **1.52.** (SDE: Lee County Bus Shop) From the funds appropriated in program VII.B. Bus Shops, in the current fiscal year, the 9 department must fund the Lee County School District Bus Shop and the Kershaw County School District Bus Shop at the same level 10 as they were funded in the previous fiscal year.

11 **1.53.** (SDE: School Enrollment Policy) For the current fiscal year, any school district with an open enrollment policy for all 12 schools or certain schools which had previously accepted certain students residing outside of the district to an academic magnet 13 school in the district must continue to accept these students and their siblings for enrollment at the academic magnet school under 14 the same terms and conditions these students were previously permitted to attend the school.

15 **1.54.** (SDE: District Funding Flexibility) For the current fiscal year, districts must utilize funding flexibility provided herein to 16 ensure that district approved safety precautions are in place at every school.

17 **1.55.** (SDE: Transportation Maintenance Facilities) For the current fiscal year, a school district wishing to include school bus
 maintenance in a contract with a private vendor may enter into an agreement with the Department of Education whereby the
 department releases the school district to include school bus maintenance in the private vendor contract.

1.56. (SDE: School District Activity Bus Advertisements) School Districts may sell commercial advertising space on the outside or inside of district owned activity buses. However, as defined and determined by the local school board, a school district may not sell such commercial advertising if the advertisement promotes a political candidate, ideology, or cause, a product that could be harmful to children, or a product that appeals to the prurient interest. Revenue generated from the sale of commercial advertising space shall be retained by the school district.

1.57. (SDE: School District Property) The requirements of Section 59-19-250 of the 1976 Code, as amended, which requires the consent of a governing board of a county in order for school trustees to sell or lease school property whenever they deem it expedient to do so are suspended for the current fiscal year.

1.58. (SDE: Full-Day 4K) Eligible students residing in a school district that met the poverty level for participation in the prior 28 29 school year are eligible to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and private providers shall be funded for instructional costs at a rate of \$4,422 \$4,510 per student enrolled. Eligible 30 31 students enrolling during the school year or withdrawing during the school year shall be funded on a pro rata basis determined by the length of their enrollment. Private providers transporting eligible children to and from school shall also be eligible for a 32 reimbursement of \$563 \$574 per eligible child transported. All providers who are reimbursed are required to retain records as 33 34 required by their fiscal agent. New providers participating for the first time in the current fiscal year and enrolling between one and six eligible children shall be eligible to receive up to \$1,000 per child in materials and equipment funding, with providers enrolling 35 seven or more such children eligible for funding not to exceed \$10,000. Providers receiving equipment funding are expected to 36

participate in the program and provide high-quality, center-based programs as defined herein for a minimum of three years. Failure 1 2 to participate for three years will require the provider to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of First Steps to School Readiness. Funding to providers is contingent upon receipt of data 3 4 as requested by the Department of Education and the Office of First Steps. The Department of Education shall only provide funding 5 for public school students whose complete records have been entered into PowerSchool and end of year adjustments shall be based 6 on the one hundred and thirty-five day student average daily membership. 7 Annually, the Department of Education is directed to audit the annual allocations to public providers to ensure that allocations are 8 accurate and aligned to the appropriate pro rata per student allocation, materials, and equipment funding. In the event the department, during the audit process determines that the annual allocations of the prior fiscal year are not accurate, the department must adjust 9 the allocations for the current fiscal year to account for the audit findings. The department must provide the results of the annual 10 audit findings to the General Assembly no later than December first. Likewise, in the event the Office of First Steps determines that 11 the annual allocations of the prior fiscal year to private providers are not accurate, the Office of First Steps must adjust the allocations 12 for the current fiscal year to account for the findings. 13 Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 14 the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 15 fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 16 public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 17 program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 18 Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of 19 Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day 20 four-year-old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and 21 maintenance of data on the state funded programs provided through private providers. The Education Oversight Committee shall 22 23 use this data and all other collected and maintained data necessary to conduct a research based review of the program's 24 implementation and assessment of student success in the early elementary grades. 25 **1.59.** (SDE: Summer Reading Camps) For the current fiscal year, funds appropriated for summer reading camps must be allocated as follows: (1) up to twenty percent to the Department of Education to provide bus transportation for students attending 26 the camps; (2) \$700,000 allocated to the department to provide grants to support community partnerships whereby community 27 organizations shall partner with local school districts to provide enrichment activities as part of after school programs or summer 28 reading camps that utilize volunteers, mentors or tutors to provide instructional support to struggling readers in elementary schools 29 that have a poverty index of forty percent or greater based on the poverty index utilized the prior fiscal year that was student eligibility 30

for the free or reduced price lunch program and Medicaid. All mentors and tutors that are a part of these after school programs or summer reading camps must have passed a SLED criminal background check. Participant to volunteer or teacher ratio must conform

to that of the school district in which the program is located; and (3) the remainder on a per pupil allocation to each school district

34 based on the number of students who substantially failed to demonstrate third-grade reading proficiency as indicated on the prior

year's state assessment as defined by Section 59-155-120 (10) of the 1976 Code. Summer reading camps must be at least six weeks

36 in duration with a minimum of four days of instruction per week and four hours of instruction per day, or the equivalent minimum

hours of instruction in the summer. School transportation shall be provided. The camps must be taught by compensated teachers 1 2 who have at least an add-on literacy endorsement or who have documented and demonstrated substantial success in helping students comprehend grade-level texts. The Department of Education shall assist districts that cannot find qualified teachers to work in the 3 4 summer camps. Districts may also choose to contract for the services of qualified instructors or collaborate with one or more districts 5 to provide a summer reading camp. Schools and school districts are encouraged to partner with county or school libraries, institutions 6 of higher learning, community organizations, faith-based institutions, businesses, pediatric and family practice medical personnel, 7 and other groups to provide volunteers, mentors, tutors, space, or other support to assist with the provision of the summer reading 8 camps. In the current school year, any student in third grade who substantially fails to demonstrate third-grade reading proficiency by the end of the school year must be offered the opportunity to attend a summer reading camp at no cost to the parent or guardian. 9 The purpose of the reading camp is to provide students who are significantly below third-grade reading proficiency with the 10 opportunity to receive quality, intensive instructional services and support. A district may also include in the summer reading camps 11 students who are not exhibiting reading proficiency at any grade and may charge fees for these students to attend the summer reading 12 camps based on a sliding scale pursuant to Section 59-19-90, except where a child is found to be reading below grade level in the 13 first, second or third grade. A parent or guardian of a student who does not substantially demonstrate proficiency in comprehending 14 texts appropriate for his grade level must make the final decision regarding the student's participation in the summer reading camp. 15 **1.60.** (SDE: Interscholastic Athletic Association Dues) A public school district supported by state funds shall not use any funds 16 or permit any school within the district to use any funds to join, affiliate with, pay dues or fees to, or in any way financially support 17 any interscholastic athletic association, body, or entity unless the constitution, rules, or policies of the association, body, or entity 18 19 contain the following:

(1) a range of sanctions that may be applied to a student, coach, team, or program and that takes into account factors such as
 the seriousness, frequency, and other relevant factors when there is a violation of the constitution, bylaws, rules, or other governing
 provisions of the association, body, or entity;

(2) (a) guarantees that private or charter schools are afforded the same rights and privileges that are enjoyed by all other
members of the association, body, or entity. A private or charter school may not be expelled from or have its membership
unreasonably withheld by the association, body, or entity or restricted in its ability to participate in interscholastic athletics including,
but not limited to, state playoffs or championships based solely on its status as a private school or charter school. The association,
body, or entity shall set reasonable standards for private or charter school admission. A private or charter school denied membership
must be provided, in writing within five business days, the reason or reasons for rejection of its application for membership;

(b) guarantees that a South Carolina home school athletic team that is a member of a home school athletic association may not be denied access to preseason and regular season interscholastic athletics including, but not limited to, jamborees and invitational tournaments, based solely on its status as a home school athletic team; other rules or policies of the association, body, or entity would apply;

(3) (a) an appeals process in which appeals of the association, body, or entity are made to a disinterested third-body appellate
 panel which consists of seven members who serve four year terms, with one person appointed by the delegation of each congressional
 district;

1 (b) a member of the panel serves until his successor is appointed and qualifies. A vacancy on the panel is filled in the 2 manner of the original appointment;

3 (c) members of the appellate panel do not concurrently serve as officers of the association, body, or entity and may not 4 have served as a member of the executive committee within the last three years. Principals and superintendents are able to appeal a 5 ruling of the association, body, or entity to the panel. The appellate panel also must provide the final ruling in any appeal brought 6 against a decision of the association, body, or entity;

7 (4) a procedure in place for emergency appeals to be held and decided upon in an expedited manner if the normal appellate 8 process would prohibit the participation of a student, team, program, or school in an athletic event, to include practices;

9 (5) provisions, implemented within one year after the effective date of this section, that require the composition of the executive 10 committee of the association, body, or entity be geographically representative of this State.

In the event an association, body, or entity fails to include one of the items listed in this proviso, public school districts and schools must end their affiliation with the association, body, or entity prior to the beginning of the upcoming school year and are prohibited from paying dues or fees to the association, body, or entity.

1.61. (SDE: Governor's Schools Informational Access to Students) For the current fiscal year, school districts must permit both 14 the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics to collaborate with 15 individual schools and their staff to share information with students and families about the educational opportunities offered at the 16 respective Governor's Schools, through avenues including school visits, informational presentations, and posters. By June thirtieth, 17 of the current fiscal year, the Governor's School for the Arts and Humanities and the Governor's School for Science and Mathematics 18 must report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee the 19 results of these Informational Access efforts. Further, the two Governor's Schools will work with districts, the Department of 20 Education and School Report Card administrators, to ensure that SAT scores of current Governor's Schools' students are included 21 22 in the School Report Card of those students' resident schools and districts.

1.62. (SDE: Reading/Literacy Coaches) (A) Funds appropriated for Reading/Literacy Coaches must be allocated to school districts by the Department of Education as follows: (1) for each *primary and* elementary school in which twenty percent or more of the students scored below "meets expectations" on the reading sub score of the English language arts test in the most recent year for which such data are available, the school district shall be eligible to receive the lesser of up to \$62,730. or the actual cost of salary and benefits for a full-time reading/literacy coach; and

(2) for each elementary school in which fewer than twenty percent of the students scored as referenced in (A)(1), the school
 district shall be eligible to receive the lesser of up to \$31,365 or fifty percent of the actual cost of salary and benefits for a full-time
 reading/literacy coach. A school district must provide local support for state funds provided under this paragraph. School districts
 may use existing local funds currently used for reading assistance as the local support.

(B) By accepting these funds, a school district warrants that they will not be used to supplant existing school district expenditures,
 except for districts that either are currently, or in the prior fiscal year, were paying for reading/literacy coaches with local funds. A
 district may, however, assign a reading/literacy coach to a primary school rather than to the elementary school to improve the early
 literacy skills of young children only utilize these funds to employ reading/literacy coaches that may serve in a primary, elementary.

1	or middle school or a combination of these schools depending on the area of highest need in the district. The school district must
2	align the placement of coaches to the district reading plan that is approved by the department.
3	(C) Funds appropriated for reading/literacy Coaches are intended to be used to provide <i>primary</i> , elementary, <i>and/or middle</i>
4	schools with reading/literacy coaches who shall serve according to the provisions in Chapter 155 of Title 59.
5	(D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve as
6	an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute they
7	must withhold that districts remaining balance of funds allocated pursuant to this proviso.
8	(E) The Department of Education must publish guidelines that define the minimum qualifications for a reading/literacy coach.
9	These guidelines must deem any licensed/certified teacher qualified if, at a minimum, he or she:
10	(1) holds a bachelor's degree or higher and an add-on endorsement for literacy coach or literacy specialist; or
11	(2) holds a bachelor's degree or higher and is actively pursuing the literacy coach or literacy specialist endorsement; or
12	(3) holds a master's degree or higher in reading or a closely-related field.
13	Within these guidelines, the Department of Education must assist districts in identifying a reading/literacy coach in the event that
14	the school is not successful in identifying and directly employing a qualified candidate. The provisions of subsection (A), including
15	the local support requirements, shall also apply to any allocations made pursuant to this paragraph.
16	(F) The Department of Education must develop procedures for monitoring the use of funds appropriated for reading/literacy
17	coaches to ensure they are applied to their intended uses and are not redirected for other purposes. The Department of Education
18	may receive up to \$100,000 of the funds appropriated for reading/literacy coaches in order to implement this program, provided that
19	this allocation does not exceed the department's actual costs.
20	(G) Prior to the close of the current fiscal year, any unspent or unallocated funds for reading/literacy coaches shall be used to fund
21	Summer Reading Camps.
22	(H) The Department of Education shall require:
23	(1) any school district receiving funding under subsection (A) to identify the name and qualifications of the supported
24	reading/literacy coach; as well as the school in which the coach is assigned; and
25	(2) any school district receiving funding under subsection (G) to account for the specific amounts and uses of such funds.
26	(I) With the data reported by the school districts, the department shall report by January fifteenth of the current fiscal year on the
27	hiring of and assignment of reading/literacy coaches by school. The department shall also report the amount of funds that will be
28	used for Summer Reading Camps.
29	(J) Funds appropriated for reading/literacy coaches shall be retained and carried forward to be used for the same purpose but
30	may not be flexed.
31	(K) For Fiscal Year 2017-18, if increased funding for reading/literacy coaches is not sufficient to provide additional
32	reading/literacy coaches at each elementary school then the funding must be targeted to the areas of greatest need based on the
33	number of students substantially failing to demonstrate reading proficiency as indicated on the prior year's state assessment the
34	current fiscal year, and if funds are available, the department may fund a coach at the full time rate if the district's reading scores
35	show that less than 20% of the students scored below "meets expectations" on the reading sub score of the English language arts

test in the most recent year for which such data are available, but for the past two year the district qualified for a full time coach 1

2 based on the assessment scores.

1.63. (SDE: Sports Participation) Any school receiving state funds shall be required to allow a military dependent student who 3 4 has transferred from their resident school district to another school district to participate in a sport that was not offered in the resident 5 school district. Should a school fail to comply with this provision, the Department of Education shall withhold one percent of their

6 total state allocation.

7 **1.64.** (SDE: Graduation Rates) For the current fiscal year, if a high school has a graduation rate below sixty percent, using 8 appropriated funds a local school district board of trustees must provide a report detailing a plan to increase the graduation rate in accordance with the provisions of the Education Accountability Act to the State Board of Education. 9

1.65. (SDE: South Carolina Community Block Grants for Education Pilot Program) There is created the South Carolina 10 Community Block Grants for Education Pilot Program. The purpose of this matching grants program is to encourage and sustain 11 partnerships between a community and its local public school district or school for the implementation of innovative, state-of-the-art 12 education initiatives and models to improve student learning. The initiatives and models funded by the grant must be well designed, 13 based on strong evidence of effectiveness, and have a history of improved student performance. 14

15 The General Assembly finds that the success offered by these initiatives and programs is assured best when vigorous community support is integral to their development and implementation. It is the intent of this proviso to encourage public school and district 16 communities and their entrepreneurial public educators to undertake state-of-the-art initiatives to improve student learning and to 17 share the results of these efforts with the state's public education community. 18

As used in this proviso: 19

(1) "Community" is defined as a group of parents, educators, and individuals from business, faith groups, elected officials, 20 nonprofit organizations and others who support the public school district or school in its efforts to provide an outstanding education 21 for each child. As applied to the schools impacted within a district or an individual school, "community" includes the school faculty 22 23 and the School Improvement Council as established in Section 59-20-60 of the 1976 Code;

24 (2) "Poverty" is defined as the percent of students eligible in the prior year for the free and reduced price lunch program and 25 or Medicaid: and

26 (3) "Achievement" is as established by the Education Oversight Committee for the report card ratings developed pursuant to 27 Section 59-18-900 of the 1976 Code.

28 The Executive Director of the Education Oversight Committee is directed to appoint an independent grants committee to develop the process for awarding the grants including the application procedure, selection process, and matching grant formula. The grants 29 committee will be comprised of seven members, three members selected from the education community and four members from the 30 business community. The chairman of the committee will be selected by the committee members at the first meeting of the grants 31 committee. The grants committee will review and select the recipients of the Community Block Grants for Education. 32

The criteria for awarding the grants must include, but are not limited to: 33

34 (1) the establishment and continuation of a robust community advisory committee to leverage funding, expertise, and other resources to assist the district or school throughout the implementation of the initiatives funded through the Block Grant Program; 35 36

(2) a demonstrated ability to meet the match throughout the granting period;

(3) a demonstrated ability to implement the initiative or model as set forth in the application; and

2 (4) an explanation of the manner in which the initiative supports the district's or school's strategic plan required by Section 3 59-18-1310 of the 1976 Code.

4 In addition, the district or school, with input from the community advisory committee, must include:

(1) a comprehensive plan to examine delivery implementation and measure impact of the model;

(2) a report on implementation problems and successes and impact of the innovation or model; and

(3) evidence of support for the project from the school district administration when an individual school applies for a grant.

8 The match required from a grant recipient is based on the poverty of the district or school. No matching amount will exceed more than seventy percent of the grant request or be less than ten percent of the request. The required match may be met by funds or by 9 in-kind donations, such as technology, to be further defined by the grants committee. Public school districts and schools that have 10 high poverty and low achievement will receive priority for grants when their applications are judged to meet the criteria established 11

for the grant program. 12

However, no grant may exceed \$250,000 annually unless the grants committee finds that exceptional circumstances warrant 13 exceeding this amount. 14

15 The Education Oversight Committee will review the grantee reports and examine the implementation of the initiatives and models to understand the delivery of services and any contextual factors. The Oversight Committee will then highlight the accomplishments 16 and common challenges of the initiatives and models funded by the Community Block Grant for Education Pilot Program to share

17

the lessons learned with the state's public education community. 18

For the current fiscal year, funds allocated to the Community Block Grant for Education Pilot Program must be used to provide or 19 expand high-quality early childhood programs for a targeted population of at-risk four-year-olds. High-quality is defined as meeting 20 the minimum program requirements of the Child Early Reading Development and Education Program and providing measurable 21 high-quality child-teacher interactions, curricula and instruction. Priority will be given to applications that involve public-private 22 23 partnerships between school districts, schools, Head Start, and private child care providers who collaborate to: (1) provide 24 high-quality programs to four-year-olds to maximize the return on investment; (2) assist in making the transition to kindergarten; (3) 25 improve the early literacy, social and emotional, and numeracy readiness of children; and (4) engage families in improving their 26 children's readiness.

27 1.66. (SDE: Board of Education Funds) For the current fiscal year, the Department of Education is authorized to carry forward funds appropriated in Part IA, Section 1, II. Board of Education. The State Board of Education is permitted to utilize these funds for 28 29 innovative educational opportunities and projects. The Board of Education shall develop guidelines and publish them on the board's website. 30

31 1.67. (SDE: Proceeds from Sale of Bus Shop & Boat) For the current fiscal year the Department of Education is authorized to retain any funds received from the sale of any bus shop and the sale of the state-owned boat and expend those funds for transportation 32 33 purposes.

34 1.68. (SDE: First Steps 4K Technology) During the current fiscal year, South Carolina Office of First Steps to School Readiness is authorized to expend up to \$75,000 from the four-year-old kindergarten carry forward funds to purchase electronic devices for the 35 administration of required school readiness assessments to children enrolled in the full-day 4K program in private centers in the 36

current fiscal year. The State Office of First Steps may purchase one device, which would be the property of the Office of First 1 2 Steps, for every ten centers serving children in the program. The regional coordinators who provide support to the centers shall coordinate the usage of the devices among the centers. First Steps shall provide a report documenting its technology and materials 3 4 expenditures to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee no later 5 than January 15, 2018 2019. 6 1.69. (SDE: Teacher Salary Schedule Structure) The Department of Education shall convene stakeholders to include: Palmetto 7 State Teachers Association, South Carolina School Business Officials, South Carolina Association of School Administrators, South Carolina School Boards Association, South Carolina Education Association, the Education Oversight Committee and CERRA to 8 examine and make recommendations regarding changes to the statewide minimum state teacher salary schedule to include extending 9 the steps on the state teacher salary schedule; an examination of the beginning teacher salary; and an examination of each district's 10 salary schedule structure. The department shall also include information from each of the districts who are, or were, the original trial 11 and plaintiff school districts in the Abbeville law suit regarding salary needs in those districts. Recommendations shall be provided 12 on the modification of the teacher salary schedule structure and the potential fiscal impact on implementing the modification 13 recommendations to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee 14 15 by October 1, 2017. **1.70.** (SDE: Teacher Certification Exemption) For the current fiscal year, a teacher certified at the secondary level may teach 16 such courses in grades seven through twelve without having the add on certification for middle-level education. Districts must report 17 to the Department of Education and the Center for Educator Recruitment Retention and Advancement on the teachers and courses 18 that utilize this exemption. 19 1.71. (SDE: Digital Instructional Materials) The Department of Education shall *continue to* create an instructional materials list 20 composed of those items (print and/or digital) that have received State Board of Education approval through the normal adoption 21 process. The department shall continue to work with the publishers of instructional materials to ensure that districts who wish to 22 23 receive both the digital version and have options for print/digital student materials to include class sets of textbooks may be awarded 24 that option print student editions, if needed. Funds appropriated for the purchase of textbooks and other instructional materials 25 (print/digital) may be used for reimbursing school districts to offset the costs of refurbishing science kits on the state-adopted 26 textbook instructional materials inventory, purchasing new kits or those adopted as supplemental from the central textbook depository, or a combination of refurbishment and purchase. The refurbishing cost of kits may not exceed the cost of the 27 state-adopted refurbishing kits plus a reasonable amount for shipping and handling. Costs for staff development, personnel costs, 28 equipment, or other costs associated with refurbishing kits on state inventory are not allowable costs. Funds provided for Instructional 29 Materials may be carried forward from the prior fiscal year into the current fiscal year to be expended for the same purposes by the 30 department, school districts, and special schools. These funds are not subject to flexibility. Digital Instructional Materials shall 31

- 32 include the digital equivalent of materials and devices.
- 33 *Utilizing the designated funds, the department shall determine a per pupil amount using the prior year's 135-Day Average Daily*
- 34 <u>Membership for unfunded state-adopted digital instructional materials and unvetted digital student materials</u>. These funds shall be
- 35 made available to all schools to allow one-year access to unfunded digital state-adopted student materials or one-year access to

1	unvetted digital student materials from publishers/vendors and are subject to the procedures outlined below. The use of the unvetted
2	digital student materials shall be the responsibility of the school district.
3	<u>Unfunded State Adopted Digital Student Materials: The department shall create a digital instructional materials list composed</u>
4	of those items which have received board approval through the normal adoption process but are unfunded. Districts shall use the
5	form available on the department's Instructional Materials website, to request an allocation for one-year digital access by denoting
6	the number of students, grade level, and subject for which the digital materials will be used.
7	Unvetted Materials: Publishers/vendors shall use the form available on the department's Instructional Materials website to
8	request to have digital student materials added to an unvetted list of instructional materials that have not been evaluated through
9	the instructional materials adoption process or approved by the board. Publishers/vendors are required to register and submit to
10	the department the one-year cost with product information, a completed brief, and correlations of the digital student materials to the
11	appropriate academic standards, career and technology education course standards, or other program areas which are not
12	addressed within the standards. Information in the brief shall include the intended course or subject area with the assigned
13	Instructional Activity Code, the readability level, documentation of compliance to ensure the digital instructional materials are
14	accessible to students with disabilities, and other specific descriptive information as required by the State Superintendent of
15	Education. Failure to provide completed brief and correlation will automatically exclude the digital materials from the unvetted
16	list. Previously reviewed instructional materials will be excluded from the list of unvetted digital materials. Should the
17	publisher/vendor submit the unvetted materials for review as part of a call for bids for instructional materials, the bid materials will
18	be removed from the unvetted listing.
19	A district shall use the form available on the department's Instructional Materials website to request an allocation for which the
20	unvetted digital materials will be used by denoting the number of students, grade level, and subject with the assigned Instructional
21	Activity Code. The department shall not be responsible for the use by schools of the unvetted digital materials including the content,
22	alignment to standards, lack of accessibility for students with disabilities, quality, or any other aspect of the digital materials. The
23	unvetted digital materials shall not be placed on state contract; therefore, the availability and cost of these materials will not be
24	<u>assured.</u>
25	Any funds appropriated for digital instructional materials which have not been encumbered by January 15, shall be used by the
26	department to purchase unfunded state adopted instructional materials.
27	1.72. (SDE: CDEPP Unexpended Funds) For Fiscal Year 2017-18 2018-19, the Office of First Steps to School Readiness is
28	permitted to retain the first \$1,000,000 of any unexpended CDEPP funds of the prior fiscal year and expend these funds to enhance
29	the quality of the full-day 4K program in private centers and provide professional development opportunities.
30	By August first, the Office of First Steps is directed to allocate any additional unexpended CDEPP funds from the prior fiscal year
31	and any CDEPP funds carried forward from prior fiscal years that were transferred to the restricted account for the following purpose:
32	Education Oversight Committee - \$1,000,000 for the South Carolina Community Block Grants for Education Pilot Program.
33	If carry forward funds are less than the amounts appropriated, funding for the items listed herein shall be reduced on a pro rata
34	basis.
35	If by August first, the Department of Education or the Office of First Steps determines there will be funds available, funds shall
36	be allocated on a per pupil basis for districts eligible for participation first, who have a documented waiting list, and funded an

extended program per this proviso in the prior school year, then to districts to increase the length of the program to a maximum of 1 2 eight and a half hours per day or two hundred and twenty days per year or to fund summer programs. By August 1, the Department of Education and the Office of First Steps must collect the documented waiting lists and determine a process to notify parents of 3 4 eligible students of available slots in all approved providers. If a district chooses to fund summer enrollment the program funding shall conform to the funding in this act for full year programs, however shall be reduced on a pro rata basis to conform with the 5 length of the program. A summer program shall be no more than eight and a half hours per day and shall be not more than ten weeks 6 in length. The per pupil allocation and classroom grant must conform with the appropriated amount contained in this Act and end 7 8 of year adjustments shall be based on the one hundred and thirty five day student average daily membership or later student average daily membership for districts choosing to extend the program past one hundred and eighty days. Funds may also be used to provide 9 professional development and quality evaluations of programs. 10 No later than April first, the Department of Education and the Office of First Steps must report to the Chairman of the Senate 11 Finance Committee and the Chairman of the House Ways and Means Committee on the expenditure of these funds to include the 12 following information: the amount of money used and specific steps and measures taken to enhance the quality of the 4K program 13 and the amount of money used for professional development as well as the types of professional development offered and the number 14 15 of participants. **1.73.** (SDE: Technology Technical Assistance) Of the funds appropriated for the K-12 Technology Initiative, the department is 16 authorized to withhold up to \$350,000 in order to provide technology technical assistance to school districts. 17 18 1.74. RESERVED 1.75. (SDE: Teacher Employment) Of the funds appropriated in the current fiscal year, a local school district superintendent or 19 his designee shall provide a teacher with notice of dismissal and an opportunity for a hearing before the local board or its designee. 20 Further, a local board may authorize a South Carolina licensed, practicing attorney to serve as hearing officer to conduct a hearing 21 on the matter and make a report of its recommendations to the board within forty-five days after receipt of notice of appeal. A 22 23 hearing officer may not be a member of the board or an employee of the district. If the board designates a hearing officer, the report 24 and recommendations of the hearing officer must be presented to the board in the form of a written order. In considering the report and recommendations, the board must have available to it the exhibits presented at the hearing and shall permit limited oral argument 25 26 on behalf of the district and the teacher, allowing each party thirty minutes to present its respective argument. The board shall uphold the decision of the hearing officer if the evidence shows good and just cause for dismissal. The board shall issue a decision affirming 27 28 or withdrawing the notice of suspension or dismissal within thirty days. The decision of the board may be appealed to the circuit 29 court. 30 **1.76.** (SDE: Technology Technical Assistance) Funds appropriated to the Department of Education for Technology Technical Assistance must be used to increase the capacity of districts who are or were the original trial and plaintiff school districts in the 31 Abbeville law suit. Funds shall be used by the department to assist school districts in procuring appropriate technology to include 32 devices and infrastructure in accordance with the recommendations made by the technology review team to begin to build capacity 33 34 to offer online testing and increased access. For the current fiscal year districts and individual public charter schools may request a 35 waiver from the State Board of Education from the requirement that all assessments be administered online.

1.77. (SDE-Highly Qualified Teachers) For the current fiscal year teacher certification requirements for highly qualified 1 2 educators aligned to No Child Left Behind shall be suspended. The department shall report to the General Assembly by February first on the updated Federal requirements under the Every Student Succeeds Act. 3 4 **1.78.** (SDE: Assistance Funding) For the current fiscal year, any funds appropriated to the Department of Education to assist 5 districts that are or were Plaintiffs in the Abbeville law suit and funding appropriated to the department to provide technical assistance to underperforming districts may not be transferred to any other program, are not subject to flexibility, and may be carried forward 6 7 and expended for the same purposes. 1.79. (SDE: Reporting and Procurement) Any state agency or school for which the department acts as the fiscal agent must 8 comply with any state and federal reporting requirements using agency procedures and shall follow all state procurement laws. 9 **1.80.** (SDE: Abbeville Equity Districts Comprehensive Report) Of the appropriations and provision of services that are provided 10 in the current fiscal year's budget for the Abbeville equity districts, the Department of Education must submit a comprehensive report 11 to the General Assembly by January 1, 2018 on the current allocation of funds to the Abbeville equity districts and the provision of 12 services to these districts. 13 1.81. (SDE: Computer Science Curriculum) Of the funds appropriated to the department for computer science, the department 14 shall develop grade appropriate computer science standards that include computational thinking and computer coding for grades 15 9-12. Experts and officials from higher education, business and industry must be included in the development of the standards. The 16 department shall support K-12 academic and computer science teachers in designing interdisciplinary units and instructional practices 17 that engage students in applying literacy, math, and computational thinking skills to solve problems. 18 1.82. (SDE: Military Child Care Centers) During the current fiscal year, South Carolina First Steps to School Readiness may 19 extend four-year-old kindergarten provider eligibility to military child care settings regulated by the United States Department of 20 Defense. State funds appropriated for use in military child care facilities must be used to expand service to CERDEP eligible children 21 22 residing in school districts approved for participation during the prior fiscal year and may not be used to supplant any existing federal 23 child care investment. 24 **1.83.** (SDE: First Steps 4K Underserved Communities) Using funds appropriated for the Child Early Reading and Development 25 Education Program, South Carolina First Steps shall develop a pilot program to expand four-year-old kindergarten enrollment within underserved communities eligible for participation during the most recent fiscal year. Newly created and/or newly approved private 26 providers proposing to expand service to ten or more CERDEP eligible children in communities enrolling less than 80% of eligible 27 28 students in a public, private, or Head Start setting during the prior fiscal year, may apply for up to \$30,000 in one-time supplemental, 29 needs-based incentives designed to address building renovations, documented as necessary to bring proposed classrooms into compliance with licensing regulations, materials and staffing costs, and/or other obstacles currently preventing their participation in 30 31 the First Steps 4K program. The First Steps Board of Trustees shall develop and approve an application process that incorporates formal review and fiscal safeguards designed to ensure grant funds are used solely to address documented barriers to program 32 participation. Providers receiving this one-time supplement are expected to participate in the program and provide high-quality, 33 34 center-based programs as defined herein for a minimum of three years. Failure to participate for three years will require the provider to return a portion of the supplemental allocation at a level determined by the Office of First Steps to School Readiness. First Steps 35

shall submit a report detailing its process, expenditures and expanded enrollment to the Chairman of the House Ways and Means 1 2 Committee and the Chairman of the Senate Finance Committee by March 15, 2018 2019. **1.84.** (SDE: School Leadership) Of the funds appropriated to and retained by the department for Professional Development, 3 4 \$400,000 shall be used to contract with a non-profit leadership development provider. The provider must specialize allocated to 5 South Carolina Foundation for Educational Leadership for Center for Executive Education Leadership (CEEL) which shall provide professional development that specializes in multiple assessments, executive coaching, and leadership development that provides the 6 7 skills necessary for a progressive career path in school leadership. 8 1.85. (SDE: Carry Forward) For Fiscal Year 2017-18, the Department of Education is directed to allocate \$30,000,000 from carry forward or unencumbered or unobligated cash balances for the School Districts Capital Improvement Plan as set forth in this 9 10 Act. **1.86.** (SDE: Poverty) Students eligible in the prior fiscal year to receive funding according to the Poverty weighting in the 11 Education Finance Act pursuant to proviso 1.3 in this Act, are eligible to receive those funds for Fiscal Year 2017-18 2018-19. 12 **1.87.** (SDE: School Bus Drivers) For the current fiscal year, a driver candidate must possess a valid driver's license that meets 13 the requirements in State and Federal law to operate commercial and non-commercial school bus type vehicles with no restrictions 14 other than vision correction to qualify for issuance. Driver candidates must complete all Department of Education classroom and 15 behind-the-wheel training requirements, including a medical examination and drug/alcohol testing, for initial certification as well as 16 all Department of Education required in-service training annually to qualify for continued certification. 17 1.88. (SDE: Committee on Educator Retention and Recruitment) From the funds appropriated to the department, the 18 Superintendent of Education shall initiate convening a study committee to address the issue of educator recruitment and retention to 19 include identification of the causes of teacher shortages and the state's educational system's future demand for teachers. The study 20 committee shall develop recommendations for the General Assembly to consider which include, but are not limited to, building 21 teacher recruitment: alternative certification: financial incentives: induction and mentorship: evaluation and feedback: and teacher 22 23 leadership. - (13) Superintendent from a medium School District appointed by the Governor; (14) Superintendent from a large School District appointed by the Governor; Of the three Superintendents appointed by the Governor, at least one Superintendent must come from a plaintiff or trial district in the Abbeville lawsuit: (15) Executive Director of CERRA; (16) Chairman of the Education Oversight Committee; (17) Two Deans of Colleges of Education appointed by the Governor; and (18) State Superintendent of Education who shall serve as Chairman of the Committee. Staff support shall be provided by the Department of Education, with assistance from the staffs of the Senate Education Committee and the House Education and Public Works Committee, upon request. Findings and recommendations shall be submitted to the General Assembly by December 31, 2017. **1.89.** (SDE: Big Brothers Big Sisters) Of the funds retained and carried forward by the Department of Education pursuant to proviso 117.23, the Department of Education is directed to transfer up to \$50,000 to Big Brothers Big Sisters of the Upstate and up to \$50,000 to Big Brothers Big Sisters - Carolina Youth Development Center to support educational activities. 1.90. (SDE: Hold Harmless) The Department of Education shall distribute the \$5,000,000 appropriated from Proviso 8.2 for the Education Foundation Supplement distributed to public school districts which would in the current fiscal year recognize a loss in State financial requirement of the foundation program by utilizing an Index of Taxpaying Ability which imputes the assessed value of owner occupied property compared to the State financial requirement of the same Index of Taxpaying Ability without an imputed value of owner-occupied homes. Funds in the Education Foundation Supplement must be distributed to the school districts receiving a loss, in an amount equal to the amount of the loss. (SDE: Save the Children) Of the funds retained and carried forward by the Department of Education pursuant to proviso 117.23, the Department of Education is directed to transfer up to \$200,000 to Save the Children. **1.92.** (SDE: Special Education Minutes Requirement) For the current fiscal year the required two-hundred fifty minutes of specialized instruction a student is required to receive in order to qualify for the special education weighting in the EFA is waived. A special education weighting may be applied for any public school child with an Individualized Education Program in effect, regardless of the number of minutes of instruction. 1.93. (SDE: Retired Educators Employment) For the current fiscal year school districts may notify retired educators of employment in writing on or before May 1. School districts employing retired educators pursuant to Section 9-1-1795 of the 1976 Code shall provide documentation of compliance with the earnings limitation exemptions to the department. The department shall verify the compliance and send the verification to the Public Employee Benefit Authority. **1.94.** (SDE: Education Rate Program) For purposes of the federal Educational Rate Program, a child attending a state-funded four-year-old kindergarten program must be considered an elementary school student. (SDE: Teacher Salaries Increase) For Fiscal Year 2018-19, the Department of Education is directed to increase the 1.95. statewide salary schedule by two percent. A local school district board of trustees must provide all certified teachers paid on the
- 36 teacher salary schedule a two percent salary increase. Districts are to provide this increase using the district salary schedule utilized

1	the prior fiscal year as its base. School districts shall utilize the additional funds made available from the Education Finance Act
2	appropriation to provide one percent of the required two percent increase.
3	For purposes of this provision, teachers shall be defined by the Department of Education using the Professional Certified Staff
4	(PCS) System.
5	1.96. (SDE: School District Residence Boundaries) For Fiscal Year 2018-19, and with funds appropriated to local school
6	districts, upon the reestablishment of a portion or entirety of a county boundary that impacts the school district boundary, persons
7	residing on the impacted property may continue to enroll their children who previously attended a school in the district until such
8	time as the child graduates from high school, as long as the child continuously resides at the same property until graduation. For
9	the purposes of this section, "children" includes those children who are residing with their legal guardians whose property is
10	impacted by a county boundary reestablishment in conflict with the immediate prior school district boundary. This proviso only

21	1.98. (SDE: Safe Schools Initiative) (A) For the current fiscal year, the Department of Education and the State Law Enforcement
22	Division must develop, within existing staff, a Crisis Intervention Team to coordinate, collect and compile Crisis Intervention &
23	School Safety Plans from each school district with their input. The report shall include recommendations for the General Assembly
24	to consider which may include, but are not limited to, physical building security, bullet proof and access controlled doors, RFID
25	chip in student identification cards, mental health services, school resource officers, and other school safety measures. Total costs
26	associated with each recommendation shall be included in the report. If additional funding is required to implement the

32	facilities projects. Eligible school facility projects shall include, but not necessarily be limited to items such as: (a) door locks, (b)
33	security cameras, (c) metal detectors, (d) lifesaving medical equipment and (e) equipment related to school resource officers,
34	excluding vehicles. For purposes of this provision, school facilities shall not include unimproved real property, centralized district

12	1.99. (SDE: School Holidays) For Fiscal Year 2018-19 local school districts must observe Martin Luther King, Jr. Day and
13	Memorial Day as legal holidays and schools and offices of the school districts must be closed on those dates. Districts may not
14	schedule make-up days on either day. Schools and school districts may utilize the funds realized from observing those holidays to
15	provide educational training related to the Martin Luther King Jr. Day and Memorial Day observance.
16	1.100. (SDE: School Safety Program) Funds appropriated for the School Safety Program shall be utilized by the department for
17	the purpose of hiring certified law enforcement officers to serve as a school resource officer for school districts that otherwise would
18	lack the adequate resources to hire their own school resource officers. In making determinations of eligibility the department shall
19	use the most recent index of taxpaying ability as the district's indicator of ability to pay, with districts of the lowest index of taxpaying
20	ability receiving priority consideration. Districts must apply for funding through the department and no districts shall receive an
21	award of more than four certified school resource officer positions. In making awards the department shall provide funding directly

27	1A.1. (SDE-EIA: Prohibition on Appropriation Transfers) The amounts appropriated herein for aid to subdivisions or allocations

1A.1. (SDE-EIA: Prohibition on Appropriation Transfers) The amounts appropriated herein for aid to subdivisions or allocations
 to school districts shall not be transferred or reduced and must be expended in accordance with the intent of the appropriation.
 However, transfers are authorized from allocations to school districts or special line items with projected year-end excess
 appropriations above requirements, to allocations to school districts or special line items with projected deficits in appropriations.

1A.2. (SDE-EIA: African-American History) Funds provided for the development of the African-American History curricula may be carried forward into the current fiscal year. Funds that are currently a salary line item will be reallocated for the development of instructional materials and programs and the implementation of professional learning opportunities that promote African American history and culture. For Fiscal Year 2017-18 <u>the current fiscal year</u>, not less than seventy percent of the funds carried forwarded must be expended for the development of additional instructional materials by nonprofit organizations, <u>school districts</u>, or <u>institutions</u>

36 *of higher education* selected through a grant process by the Department of Education.

1 1A.3. (SDE-EIA: Teacher Evaluations, Implementation/Education Oversight) The Department of Education is directed to oversee the evaluation of teachers at the School for the Deaf and the Blind, the John de la Howe School and the Department of Juvenile Justice under the ADEPT model.

4 1A.4. (SDE-EIA: Teacher Salaries/State Agencies) Each state agency which does not contain a school district but has 5 instructional personnel shall receive an appropriation as recommended by the Education Oversight Committee and funded by the General Assembly for teacher salaries based on the following formula: Each state agency shall receive such funds as are necessary 6 7 to adjust the pay of all instructional personnel to the appropriate salary provided by the salary schedules of the school district in 8 which the agency is located. Instructional personnel may include all positions which would be eligible for EIA supplements in a 9 public school district, and may at the discretion of the state agency, be defined to cover curriculum development specialists, educational testing psychologists, psychological and guidance counselors, and principals. The twelve-month agricultural teachers 10 located at Clemson University are to be included in this allocation of funds for base salary increases. The South Carolina Governor's 11 School for the Arts and Humanities and the South Carolina Governor's School for Science and Mathematics are authorized to increase 12 the salaries of instructional personnel by an amount equal to the percentage increase given by the School District in which they are 13 14 both located.

15 Teacher salary increases recommended by the Education Oversight Committee and funded in this Act shall be incorporated into 16 each agency's EIA appropriation contained in Section 1, VIII.E.

1A.5. (SDE-EIA: Work-Based Learning) Of the funds appropriated in Part IA, Section 1, VIII.A.1. for the Work-Based Learning 17 Program, \$75,000 shall be used by the State Department of Education to provide for regional professional development in contextual 18 methodology techniques and integration of curriculum, and professional development in career guidance for teachers and guidance 19 counselors and training mentors. Pilot-site delivery of contextual methodology training in mathematics will be supported by 20 technology and hands-on lab activities. In addition, \$500,000 shall be allocated for Regional Career Specialists. Each Regional 21 Career Specialist shall (1) be housed within the regional centers/WIA geographic areas, (2) provide career development activities 22 23 throughout all schools within the region, (3) be under the program supervision of the Office of Career and Technology Education, 24 State Department of Education, and (4) adhere to an accountability and evaluation plan created by the Office of Career and 25 Technology Education, State Department of Education. The Office of Career and Technology Education, State Department of 26 Education, shall provide a report, in February of the current fiscal year to the Senate Finance Committee and the House Ways and 27 Means Committee on accomplishments of the Career Counseling Specialists. Of the funds appropriated in the prior fiscal year, 28 unexpended funds may be carried forward to the current fiscal year and expended for the same purposes.

29 1A.6. (SDE-EIA: CHE/Teacher Recruitment) Of the funds appropriated in Part IA, Section 1, VIII.E. for the Teacher Recruitment Program, the South Carolina Commission on Higher Education shall distribute a total of ninety-two percent to the Center 30 31 for Educator Recruitment, Retention, and Advancement (CERRA-South Carolina) for a state teacher recruitment program, of which at least seventy-eight percent must be used for the Teaching Fellows Program specifically to provide scholarships for future teachers, 32 and of which twenty-two percent must be used for other aspects of the state teacher recruitment program, including the Teacher 33 34 Cadet Program and \$166,302 which must be used for specific programs to recruit minority teachers: and shall distribute eight percent to South Carolina State University to be used only for the operation of a minority teacher recruitment program and therefore shall 35 not be used for the operation of their established general education programs. Working with districts with an absolute rating of 36

At-Risk or Below Average, CERRA will provide shared initiatives to recruit and retain teachers to schools in these districts. CERRA 1 2 will report annually by October first to the Education Oversight Committee and the Department of Education on the success of the recruitment and retention efforts in these schools. The South Carolina Commission on Higher Education shall ensure that all funds 3 4 are used to promote teacher recruitment on a statewide basis, shall ensure the continued coordination of efforts among the three 5 teacher recruitment projects, shall review the use of funds and shall have prior program and budget approval. The South Carolina 6 State University program, in consultation with the Commission on Higher Education, shall extend beyond the geographic area it 7 currently serves. Annually, the Commission on Higher Education shall evaluate the effectiveness of each of the teacher recruitment 8 projects and shall report its findings and its program and budget recommendations to the House and Senate Education Committees, 9 the State Board of Education and the Education Oversight Committee by October first annually, in a format agreed upon by the Education Oversight Committee and the Department of Education. 10 With the funds appropriated CERRA shall also appoint and maintain the South Carolina Teacher Loan Advisory Committee. The 11 12 Committee shall be composed of one member representing each of the following: (1) Commission on Higher Education; (2) State Board of Education; (3) Education Oversight Committee; (4) Center for Educator Recruitment, Retention, and Advancement; (5) 13 South Carolina Student Loan Corporation; (6) South Carolina Association of Student Financial Aid Administrators; (7) a local school 14 district human resources officer; (8) a public higher education institution with an approved teacher education program; and (9) a 15 private higher education institution with an approved teacher education program. The members of the committee representing the 16 public and private higher education institutions shall rotate among those intuitions and shall serve a two-year term on the committee. 17 The committee must be staffed by CERRA, and shall meet at least twice annually. The committee's responsibilities are limited to: 18 (1) establishing goals for the Teacher Loan Program; (2) facilitating communication among the cooperating agencies; (3) advocating 19 for program participants; and (4) recommending policies and procedures necessary to promote and maintain the program. 20 **1A.7.** (SDE-EIA: Disbursements/Other Entities) Notwithstanding the provisions of Sections 2-7-66 and 11-3-50. South 21 Carolina Code of Laws, it is the intent of the General Assembly that funds appropriated in Part IA, Section 1, VIII.E. Other State 22 23 Agencies and Entities shall be disbursed on a quarterly basis by the Department of Revenue directly to the state agencies and entities referenced except for the Teacher Loan Program, Centers of Excellence, the Education Oversight Committee and School Technology, 24 25 which shall receive their full appropriation at the start of the fiscal year from available revenue. The Comptroller General's Office 26 is authorized to make necessary appropriation reductions in Part IA, Section 1, VIII.E. to prevent duplicate appropriations. If the 27 Education Improvement Act appropriations in the agency and entity respective sections of the General Appropriations Act at the start 28 of the fiscal year do not agree with the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities, the "other 29 funds" appropriations in the respective agency and entity sections of the General Appropriations Act will be adjusted by the

Comptroller General's Office to conform to the appropriations in Part IA, Section 1, VIII.E. Other State Agencies and Entities. Further, the Department of Revenue is directed to provide the full appropriation of the funding appropriated in Part IA, Section 1, VIII.C.2. Teacher Supplies to the Department of Education at the start of the fiscal year from available revenue. The Department of Revenue is also directed to provide the first quarter appropriation of the funding appropriated in Part IA, Section 1, VIII.G. Charter

34 School District to the Department of Education at the start of the fiscal year from available revenue.

1A.8. (SDE-EIA: Arts in Education) Funds appropriated in Part IA, Section 1, VIII.A.1. Arts Curricula shall be used to support innovative practices in arts education curriculum, instruction, and assessment in the visual and performing arts including dance,

music, theatre, and visual arts which incorporates strengths from the Arts in Education sites. They shall also be used to support the advancement of the implementation of the visual and performing arts academic standards. These funds shall be distributed to schools and school districts under a competitive grants program; however, up to thirty-three percent of the total amount of the grant fund shall be made available as "Aid to Other Agencies" to facilitate the funding of professional development arts institutes that have been approved by the State Department of Education for South Carolina arts teachers, appropriate classroom teachers, and administrators. Arts Curricular Grants funds may be retained and carried forward into the current fiscal year to be expended in accordance with the proposed award.

(SDE-EIA: Teacher Supplies) All certified and non-certified public school teachers identified in PCS, certified special school classroom teachers, certified media specialists, certified guidance counselors, and career specialists who are employed by a 9 school district, a charter school, or lead teachers employed in a publically funded full day 4K classroom approved by the South 10 Carolina First Steps to School Readiness, as of November thirtieth of the current fiscal year, based on the public decision of the 11 12 school board may receive reimbursement of two hundred seventy-five dollars each school year to offset expenses incurred by them for teaching supplies and materials. Funds shall be disbursed by the department to School districts by July fifteenth based on the last 13 reconciled Professional Certified Staff (PCS) listing from the previous year. With remaining funds for this program, any deviation 14 in the PCS and actual teacher count will be reconciled by December thirty-first or as soon as practicable thereafter. Based on the 15 public decision of the school district and no later than May fifteenth annually, the district shall notify all individuals entitled to receive 16 these funds the manner in which the funds will be dispersed. Funds may be disbursed to each teacher via check in a manner separate 17 and distinct from their payroll check on the first day teachers, by contract, are required to be in attendance at school for the current 18 contract year, or the funds may be disbursed to each teacher via direct deposit as long as the funds are handled in a manner to be 19 separate and distinct from their payroll check. This reimbursement shall not be considered by the state as taxable income. Special 20 schools include the Governor's School for Science and Math, the Governor's School for the Arts and Humanities, Wil Lou Grav 21 22 Opportunity School, John de la Howe School, School for the Deaf and the Blind, Felton Lab, Department of Juvenile Justice, and 23 Palmetto Unified School District. Funds distributed to school districts or allocated to schools must not supplant existing supply money paid to teachers from other sources. If a school district requires receipts for tax purposes the receipts may not be required 24 before December thirty-first. Districts that do not wish to require receipts may have teachers retain the receipts and certify for the 25 26 district they have received the allocation for purchase of teaching supplies and/or materials and that they have purchased or will purchase supplies and/or materials during the fiscal year for the amount of the allocation. Districts shall not have an audit exception 27 28 related to non-retention of receipts in any instances where a similar instrument is utilized. Any district requiring receipts must notify 29 any teacher from whom receipts have not been submitted between November twenty-fifth and December sixth that receipts must be submitted to the district. Districts may not add any additional requirement not listed herein related to this reimbursement. 30

Any classroom teacher, including a classroom teacher at a South Carolina private school, that is not eligible for the reimbursement allowed by this provision, may claim a refundable income tax credit on the teacher's 2017 2018 tax return, provided that the return or any amended return claiming the credit is filed prior to the end of the fiscal year. The credit is equal to two hundred seventy-five dollars, or the amount the teacher expends on teacher supplies and materials, whichever is less. If any expenditures eligible for a credit are made after December thirty-first, the teacher may include the expenditures on his initial return or may file an amended 2017 2018 return claiming the credit, so long as the return or amended return is filed in this fiscal year. The Department of Revenue

1 may require whatever proof it deems necessary to implement the credit provided by this part of this provision. Any person receiving 2 the reimbursement provided by this proviso is ineligible to take the income tax credit allowed by this proviso.

1A.10. (SDE-EIA: Teacher of the Year Awards) Of the funds provided herein for Teacher of the Year Awards, each district Teacher of the Year shall receive an award of \$1,000. In addition, the State Teacher of the Year shall receive an award of \$25,000, and each of the four Honor Roll Teachers of the Year will receive an award of \$10,000. To be eligible, districts must participate in the State Teacher of the Year Program sponsored by the State Department of Education. These awards shall not be subject to South Carolina income taxes.

1A.11. (SDE-EIA: EOC) The Education Oversight Committee may collect, retain and expend revenue from conference registration and fees; charges for materials supplied to local school districts or other entities not otherwise mandated to be provided by state law; and from other activities or functions sponsored by the committee including public awareness campaign activities. Any

11 unexpended revenue from these sources may be carried forward into the current fiscal year and expended for the same purposes.

12 **1A.12.** (SDE-EIA: Technical Assistance) In order to best meet the needs of underperforming schools, funds appropriated for technical assistance must be used to provide intensive support to schools and districts with an absolute rating of below average or 13 at-risk on the most recent annual school report card or with the lowest percentages of students meeting state standards on state 14 assessments on the most recent state assessments or with the lowest high school graduation rates. The department will create a 15 system of tiers of technical assistance for low-performing schools and districts that will receive technical assistance. The tiers will 16 be determined by factors that include, but are not limited to, length of time performance of the school or district has been at-risk/below 17 average, annual achievement ratings, annual growth ratings, school or district accreditation, and/or financial risk status. The tiers of 18 technical assistance may include a per student allocation, placement of a principal mentor, transformation coach, instructional leader, 19 replacement of the principal, reconstitution of a school, and declaration of a state of emergency. Low-performing schools and districts 20 shall be placed within the tiered technical assistance framework not later than December fifteenth. 21

Low-performing schools shall receive a diagnostic review through the department. In addition, newly identified low-performing schools and districts must be reviewed by an External Review Team in the year of designation, and every third year thereafter. These reports shall be made available on the Department of Education's website; any information pertaining to personnel matters or containing personally identifiable information shall be exempted. Based upon the recommendations in the review(s), low-performing schools and districts must develop and submit to the Department of Education an updated school renewal or district strategic plan outlining goals for improvements. The amended plans must address specific strategies designed to increase student achievement and must include measures to evaluate the success of implementation of the plan.

With the funds appropriated to the Department of Education, and any experts placed in the school or district for technical assistance 29 services, the department will assist low-performing schools and districts in designing and implementing the strategies and 30 31 measurement identified in the amended plans and in brokering for technical assistance personnel as stipulated in the plan. In addition, the department must monitor student academic achievement and progress on implementation and report their findings to the 32 Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means Committee, the Chairman of the Senate 33 34 Education Committee, the Chairman of the House Education and Public Works Committee, the local legislative delegation, and the Governor in the fall following the school or district designation as low-performing. If the school or school district does not provide 35 the evaluation information necessary to determine effective use, the principal of the school or the district superintendent may be 36

1 subject to receiving a public reprimand by the State Board of Education if it is determined that those individuals are responsible for

2 the failure to provide the required information.

Funds must be used by the department for implementation and delivery of technical assistance services. Using previous report card data and monitoring reports on the status of implementation of the school renewal plan, the department shall identify priority schools. Funds appropriated for technical assistance shall be used by the department to work with those schools identified as low-performing and to support priority schools under the tiered system. These funds shall not be transferred to any other funding category by the school district without prior approval of the State Superintendent of Education and funds are not subject to agency flexibility provisions.

Reconstitution means the redesign or reorganization of the school, which may include the declaration that all positions in the 9 school are considered vacant. Certified staff currently employed in priority schools must undergo an evaluation in the spring 10 following the school's identification as a priority school and must meet determined goals to be rehired and continue their employment 11 at that school. Educators who were employed at a school that is being reconstituted prior to July 2009, and to whom the employment 12 and dismissal laws apply will not lose their rights in the reconstitution. If they are not rehired or are not assigned to another school 13 in the school district they have the opportunity for a hearing. However, employment and dismissal laws shall not apply to educators 14 who are employed in the district and assigned to the priority schools July 1, 2009, in the event of a reconstitution of the school in 15 which the educator is employed. Those rights are only suspended in the event of a reconstitution of the entire school staff. 16 Additionally, the rights and requirements of the employment and dismissal laws do not apply to educators who on July 1, 2009, were 17 on an induction or annual contract, that subsequently were offered continuing contract status after the effective date of this proviso, 18 and are employed at a school that is subject to reconstitution under this proviso. 19

The reconstitution of a school could take place if the school has been identified as a priority school that has failed to improve satisfactorily. The decision to reconstitute a school shall be made by the State Superintendent of Education in consultation with the principal the school board of trustees, and the district superintendent. The decision to reconstitute a school shall be made by April first, at which time notice shall be given to all employees of the school. The department, in consultation with the district superintendent, shall develop a staffing plan and a budget for each reconstituted school.

The State Superintendent of Education may declare a state of emergency in a district if the accreditation status is probation or denied, if a majority of the schools fail to show improvement, if the district is classified as being in "high risk" status financially, or for financial mismanagement resulting in a deficit. The State Superintendent of Education may declare a state of emergency in a school if the accreditation status is probation or denied, or if the school fails to show improvement. Upon declaration of a state of emergency, the Superintendent may take over management of the school or district. Management of the school or district may include direct management, consolidation with another district, charter management, public/private management, or contracting with an educational management organization or another school district.

32 1A.13. (SDE-EIA: Proviso Allocations) In the event an official EIA revenue shortfall is declared by the Board of Economic 33 Advisors, the Department of Education may reduce any allocation in Section 1A specifically designated by proviso in accordance 34 with the lower Board of Economic Advisors revenue estimate as directed by the Executive Budget Office. No allocation for teacher 35 salaries shall be reduced as a result of this proviso.

1A.14. (SDE-EIA: School Districts and Special Schools Flexibility) All school districts and special schools of this State may 1 2 transfer and expend funds among appropriated state general fund revenues, Education Improvement Act funds, and Education Lottery Act funds, and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, 3 4 to ensure the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated 5 specifically for state level maintenance of effort requirements under IDEA, funds allocated specifically for state level maintenance 6 of effort requirement for federal program, funds provided for the Education and Economic Development Act, funds provided for 7 Career and Technology Education, funds provided for technology, nor funds required for debt service or bonded indebtedness. All school districts and special schools of this State may suspend professional staffing ratios and expenditure regulations and guidelines 8 at the sub-function and service area level, except for four-year old programs and programs serving students with disabilities who 9 have Individualized Education Programs. 10 In order for a school district to take advantage of the flexibility provisions, at least seventy-five percent of the school district's per 11 pupil expenditures must be utilized within the In\$ite categories of instruction, instructional support, and only transportation, food 12 service, and safety within non-instruction pupil services. No portion of the seventy-five percent may be used for facilities, business 13 services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall 14 report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional 15 support, and transportation, food service, and safety within non-instruction pupil services for the current school year ending June 16 thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures. 17 "In\$ite" means the financial analysis model for education programs utilized by the Department of Education. 18 School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low 19 enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and 20 21 memberships, reducing transportation costs for extracurricular and academic competitions, restructuring administrative staffing, and 22 expanding virtual instruction. 23 School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year. 24 Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil 25 allocation due to them for each categorical program. 26 Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school 27 district must certify where non-instructional or nonessential programs have been suspended and the specific flexibility actions taken. 28 The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of 29 the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education 30 31 and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting,

32 and the certification must be conspicuously posted on the internet website maintained by the school district.

For the current fiscal year, Section 59-21-1030 is suspended. The foreign language program assessment, and the physical education assessment must be suspended. School districts and the Department of Education are granted permission to purchase the most economical type of bus fuel.

For the current fiscal year, savings generated from the suspension of the assessments enumerated above must be allocated to school 1 districts based on weighted pupil units.

2

School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, 3 from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made 4 available for public viewing and downloading. The register must include for each expenditure: 5

(i) the transaction amount;

6

7

8

(ii) the name of the payee; and

(iii) a statement providing a detailed description of the expenditure.

The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must 9 not include any information that can be used to identify an individual employee. The register must be accompanied by a complete 10 explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at 11 least once a month. 12

Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards 13 maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each 14 statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the 15

thirtieth day after the first date that any portion of the balance due as shown on the statement is paid. 16

The Comptroller General must establish and maintain a website to contain the information required by this section from a school 17 district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate 18 between the school districts and search for the information they are seeking. 19

School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller 20 General in a manner and at a time determined by the Comptroller General to be included on the internet website. 21

The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 22 30, of the South Carolina Freedom of Information Act. Nothing in this proviso shall be interpreted as prohibiting the State Board of 23 24 Education to exercise its authority to grant waivers under Regulation 43-261.

25 **1A.15.** (SDE-EIA: Teacher Salary Supplement) The department is directed to carry forward prior year unobligated teacher salary supplement and related employer contribution funds into the current fiscal year to be used for the same purpose. Any unexpended 26 funds in teacher salary supplement may be used to fund shortfalls in the associated employer contribution funding in the current 27 28 fiscal year.

1A.16. (SDE-EIA: Dropout Prevention and High Schools That Work Programs) The Department of Education must report 29 annually by December first, to the Governor, the Chairman of the Senate Finance Committee, the Chairman of the House Ways and 30 Means Committee, the Chairman of the Senate Education Committee, and the Chairman of the House Education and Public Works 31 Committee on the effectiveness of dropout prevention programs funded by the Education and Economic Development Act and on 32

the High Schools that Work Programs' progress and effectiveness in providing a better prepared workforce and student success in 33

34 post-secondary education. The department, school districts, and special schools may carry forward unexpended funds from the prior

fiscal year into the current fiscal that were allocated for High Schools That Work. 35

1 **1A.17.** (SDE-EIA: Assessment) The department is authorized to carry forward into the current fiscal year, prior year state 2 assessment funds for the same purpose. Reimbursements shall resume in the current fiscal year for PSAT, pre-ACT or 10th grade 3 Aspire.

1A.18. (SDE-EIA: Report Card Information) The percentage each school district expended on classroom instruction as defined
 by the Department of Education's In\$ite classification for "Instruction" must be printed on the Annual School and District Report
 Card.

1A.19. (SDE-EIA: Core Curriculum Materials) The funds appropriated in Part IA, Section 1, VIII.A.3 for instructional materials for core curriculum shall be expended consistent with the requirements of Section 59-31-600 of the 1976 Code requiring the development of higher order thinking skills and critical thinking which should be integrated throughout the core curriculum instructional materials. Furthermore, the evaluation criteria used to select instructional materials with funds appropriated in Part IA, Section 1, VIII.A.3 shall include a weight of up to ten percent of the overall criteria to the development of higher order thinking skills and critical thinking skills

12 and critical thinking.

13 **1A.20.** (SDE-EIA: Certified Staff Technology Proficiency) To ensure the effective and efficient use of the funding provided by 14 the General Assembly in Part IA, Section 1 VIII.D. for school technology in the classroom and internet access, the State Department 15 of Education shall approve district technology plans that specifically address and incorporate certified staff technology competency 16 standards and local school districts must require certified staff to demonstrate proficiency in these standards as part of each certified

17 staff's Professional Development plan. District adopted technology proficiency standards and plans should be, at minimum, aligned

to the International Society for Technology in Education (ISTE) teacher standards. Evidence that districts are meeting the requirement is a prerequisite to expenditure of a district's technology funds.

1A.21. (SDE-EIA: Accountability Program Implementation) To support implementation of the accountability program, the Education Oversight Committee may carry forward unexpended Education Accountability Act funds authorized specifically for the administration of the Education Oversight Committee. For the current fiscal year the Education Oversight Committee may carry forward prior year EIA South Carolina Community Block Grants for Education Pilot Program funds not awarded by the grant committee. These funds must be used for an independent common evaluation of each awarded grant to ensure high quality programs that maximize a return on the state's investment.

1A.22. (SDE-EIA: 4K Targeting) EIA funds allocated for the provision of four-year-old kindergarten shall be utilized for the provision of services to age-eligible children qualifying for free or reduced-price lunch or Medicaid. Children with developmental delays documented through state approved screening assessments or children with medically documented disabilities who do not already qualify for special need services should also be considered for enrollment. In the event that more students seek to enroll than available space permits, districts shall prioritize students (at the time of acceptance) on the basis of family income expressed as a percentage of the federal poverty guidelines, with the lowest family incomes given the highest enrollment priority.

32 **1A.23.** (SDE-EIA: Reading) Of the funds appropriated for reading/literacy, the Department of Education, schools, and districts 33 shall ensure that resources are utilized to improve student achievement in reading/literacy. To focus on the importance of early 34 reading and writing skills and to ensure that all students acquire reading/literacy skills by the end of grade three, fifty percent of the 35 appropriation shall be directed toward acquisition of reading proficiency to include, but not be limited to, strategies in phonemic 36 awareness, phonics, fluency, vocabulary, and comprehension. Forty percent of the appropriation shall be directed toward classroom

1 instruction and intervention to focus on struggling readers and writers in grades four through eight. Ten percent of the appropriation

2 should be directed toward acceleration to provide additional opportunities for deepening and refinement of literacy skills.

3 Fifty percent of the funds shall be allocated to school districts based on the number of weighted pupil units in each school district

4 in proportion to the statewide weighted pupil units using the one hundred thirty-five day count of the prior school year. Fifty percent 5 of the funds shall be The funds allocated to the Department of Education for reading shall be used to provide districts with

6 research-based strategies and professional development and to work directly with schools and districts to assist with implementation

7 of research-based strategies. When providing professional development the department and school districts must use the most cost

8 effective method and when able utilize ETV to provide such services throughout the state. The department shall provide for an 9 evaluation to review first year implementation activities and to establish measurements for monitoring impact on student

10 achievement.

11 1A.24. (SDE-EIA: Students at Risk of School Failure) For the current fiscal year, EIA funds appropriated for students at academic 12 risk of school failure, must be allocated to school districts based upon two factors: (1) poverty as determined for the poverty add on weight in Proviso 1.3; and (2) the number of weighted pupil units identified in the prior fiscal year as in need of academic assistance. 13 At least eighty-five percent of the funds must be spent on instruction and instructional support for students at academic risk. 14 15 Instructional support may include family literacy and parenting programs to students at-risk for school failure and their families. Students at academic risk are defined as students who are not meeting grade level standards in English language arts/reading and 16 mathematics as evidenced by summative state assessments in grades three through eight or students who are not on track to meeting 17 or exceeding English language arts/reading or mathematics standards by the end of third grade. Public charter schools, the Palmetto 18 Unified School District, and the Department of Juvenile Justice must also receive a proportionate per pupil allocation based on the 19 20 number of students at academic risk of school failure served.

21 1A.25. (SDE-EIA: Professional Development) Of the funds appropriated for professional development, up to \$500,000 may be 22 expended for gifted and talented teacher endorsement and certification activities. Additionally, \$485,000 shall be allocated to the 23 Youth Learning Institute at Clemson University to implement two professional development programs in four middle schools in 24 school year 2018-19 to assist educators in teaching students how to become self-regulated and self-directed learners. The institute must provide to the department evidence of the impact of the program and information on how the model may be scaled statewide. 25 26 The balance of EIA funds appropriated for professional development must be allocated to districts based on the number of weighted pupil units in each school district in proportion to the statewide weighted pupil units using the one hundred thirty-five day count of 27 28 the prior school year. The funds must be expended on professional development for certificated instructional and instructional 29 leadership personnel in grades kindergarten through twelve across all content areas, including teaching in and through the arts and 30 using technology in classroom instruction. No more than twenty-five percent of the funds appropriated for professional development 31 may be retained by the Department of Education for the administration and provision of other professional development services which must be targeted to districts who are or were the original trial and plaintiff school districts in the Abbeville law suit to increase 32 the capacity of educators and leaders in those districts. The Department of Education must provide professional development on 33 34 assessing student mastery of the content standards through classroom, formative and end-of-year assessments. The Department of

35 Education also must post on the agency's website the South Carolina Professional Development Standards and provide training

1 through telecommunication methods to school leadership on the professional development standards. The department is authorized

2 to carry forward and expend professional development funds for the same purpose.

3 1A.26. (SDE-EIA: Assessments-Gifted & Talented, Advanced Placement, & International Baccalaureate Exams) Funds 4 appropriated and/or authorized for assessment shall be used for assessments to determine eligibility of students for gifted and talented 5 programs and for the cost of Advanced Placement and International Baccalaureate exams.

6 **1A.27.** (SDE-EIA: Adult Education) A minimum of thirty percent of the funds appropriated for adult education must be allocated 7 to school districts to serve adult education students between the ages of seventeen and twenty-one who are enrolled in programs leading to a state high school diploma, state high school equivalency diploma (GED), or career readiness certificate (WorkKeys). 8 The remaining funds will be allocated to districts based on a formula which includes factors such as target populations without a 9 high school credential, program enrollment the previous school year, number of students making an educational gain the previous 10 school year, and performance factors such as number of high school credentials and career readiness certificates awarded the previous 11 12 school year. Overall levels of state funding must meet the federal requirement of state maintenance of effort. Each school district must collect information from both the student and the school including why the student has enrolled in Adult Education and whether 13 or not the student is pursuing a GED or Diploma. The school district must then provide a quarterly report to the Department of 14 Education and must include the unique student identifier. The department, in turn, will provide summary information to the House 15 Ways and Means Committee, the House Education and Public Works Committee, the Senate Finance Committee and the Senate 16 Education Committee on the information. Up to a maximum of \$300,000, of funds may be used to establish an initiative by which 17 qualifying adult education students may qualify for a free high school equivalency test. The Department of Education shall establish 18 guidelines for the free high school equivalency testing initiative. 19

1A.28. (SDE-EIA: Clemson Agriculture Education Teachers) The funds appropriated in Part IA, Section VIII.E. for Clemson
 Agriculture Education Teachers must be transferred to Clemson University PSA to fund summer employment of agriculture teachers
 and to cover state-mandated salary increases on that portion of the agriculture teachers' salaries attributable to summer employment.
 If sufficient funds remain, Clemson University PSA may utilize such funds for a Regional Coordinator.

24 **1A.29.** (SDE-EIA: Full-Day 4K) Eligible students residing in a school district that met the poverty level for participation in the 25 prior school year are eligible to participate in the South Carolina Early Reading Development and Education Program in the current school year. Public and private providers shall be funded for instructional costs at a rate of \$4,422 \$4,510 per student enrolled. 26 27 Eligible students enrolling during the school year or withdrawing during the school year shall be funded on a pro rata basis determined 28 by the length of their enrollment. Private providers transporting eligible children to and from school shall also be eligible for a reimbursement of \$563 \$574 per eligible child transported. All providers who are reimbursed are required to retain records as 29 required by their fiscal agent. New providers participating for the first time in the current fiscal year and enrolling between one and 30 six eligible children shall be eligible to receive up to \$1,000 per child in materials and equipment funding, with providers enrolling 31 seven or more such children eligible for funding not to exceed \$10,000. Providers receiving equipment funding are expected to 32 participate in the program and provide high-quality, center-based programs as defined herein for a minimum of three years. Failure 33 34 to participate for three years will require the provider to return a portion of the equipment allocation at a level determined by the Department of Education and the Office of First Steps to School Readiness. Funding to providers is contingent upon receipt of data 35 as requested by the Department of Education and the Office of First Steps. The Department of Education shall only provide funding 36

for public school students whose complete records have been entered into PowerSchool and end of year adjustments shall be based 1

2 on the one hundred and thirty-five day student average daily membership.

Annually, the Department of Education is directed to audit the annual allocations to public providers to ensure that allocations are 3

4 accurate and aligned to the appropriate pro rata per student allocation, materials, and equipment funding. In the event the department, 5

during the audit process determines that the annual allocations of the prior fiscal year are not accurate, the department must adjust the allocations for the current fiscal year to account for the audit findings. The department must provide the results of the annual 6

7 audit findings to the General Assembly no later than December first. Likewise, in the event the Office of First Steps determines that

8 the annual allocations of the prior fiscal year to private providers are not accurate, the Office of First Steps must adjust the allocations

for the current fiscal year to account for the findings. 9

Of the funds appropriated, \$300,000 shall be allocated to the Education Oversight Committee to conduct an annual evaluation of 10

the South Carolina Child Development Education Pilot Program and to issue findings in a report to the General Assembly by January 11

fifteenth of each year. To aid in this evaluation, the Education Oversight Committee shall determine the data necessary and both 12

public and private providers are required to submit the necessary data as a condition of continued participation in and funding of the 13

program. This data shall include developmentally appropriate measures of student progress. Additionally, the Department of 14

Education shall issue a unique student identifier for each child receiving services from a private provider. The Department of 15 Education shall be responsible for the collection and maintenance of data on the public state funded full day and half-day 16 four-year-old kindergarten programs. The Office of First Steps to School Readiness shall be responsible for the collection and 17

maintenance of data on the state funded programs provided through private providers. The Education Oversight Committee shall 18 use this data and all other collected and maintained data necessary to conduct a research based review of the program's 19

implementation and assessment of student success in the early elementary grades. 20

1A.30. (SDE-EIA: Aid to Districts) Funds appropriated in Part IA, Section 1, VIII.A.1. Aid to Districts shall be dispersed at least 21 quarterly to school districts based on the number of weighted pupil units. Of the funds appropriated for Aid to Districts, the 22

23 department is authorized to withhold up to \$350,000 in order to provide technology technical assistance to school districts. For the

current fiscal year, the remaining funds shall be allocated to districts based on the number of weighted pupil units with no district 24

25 receiving less funds than the district received in the prior fiscal year as a result of consolidating the following EIA line items into the

Aid to Districts line item: Aid to Districts-Technology; Reading; and Professional Development. 26

1A.31. (SDE-EIA: Centers of Excellence) Of the funds appropriated for Centers of Excellence, \$350,000 must be allocated to the 27 28 Francis Marion University Center of Excellence to Prepare Teachers of Children of Poverty to expand statewide training for 29 individuals who teach children of poverty through weekend college, nontraditional or alternative learning opportunities.

1A.32. (SDE-EIA: IDEA Maintenance of Effort) Prior to the dispersal of funds appropriated in Section VIII.A.1. Aid to Districts 30 31 according to Proviso 1A.30 for the current fiscal year, in the event that there is a reduction in state funds or there are changes in the Education Finance Act/Base Student Cost formula that would reduce support for children with disabilities, the Department of 32 Education is authorized to utilize funds appropriated in Section VIII.A.1. Aid to Districts to ensure maintenance of state financial 33

34 support for the IDEA. The department shall distribute these funds using the current fiscal year one hundred thirty-five day Average

Daily Membership or as directed by the United States Department of Education. Funds provided for these purposes may not be 35

transferred to any other purpose and therefore are not subject to flexibility. For continued compliance with the federal maintenance 36

of state financial support requirements of the IDEA, funding for children with disabilities must, to the extent practicable, be held 1 2 harmless to budget cuts or reductions to the extent those funds are required to meet federal maintenance of state financial support requirements under the IDEA. In the event cuts to funds that are needed to maintain fiscal effort are necessary, when administering 3 4 such cuts, the department must not reduce funding to support children with disabilities who qualify for services under the IDEA in a 5 manner that is disproportionate to the level of overall reduction to state programs in general. By December first, the department 6 must submit an estimate of the IDEA maintenance of state financial support requirement to the General Assembly and the Governor. 7 For the current fiscal year, the department may carry forward IDEA Maintenance of Effort funds from the prior fiscal year and 8 expend them in the same manner.

1A.33. (SDE-EIA: Career Cluster Industry Partnerships) From the funds appropriated to the Department of Education, \$800,000 9 must be provided as direct grants to the private sector statewide trade association or educational foundation providing nationally 10 certified programs in career and technology education representing the automotive, construction, engineering, healthcare, mechanical 11 12 contracting/construction, and hospitality tourism career clusters. Organizations applying for a grant must do so by July thirty-first and the Department of Education must award a minimum of one grant of at least \$150,000 in at least four of these specified career 13 clusters to be used exclusively for career and technology education. The recipient industry organization must conduct end-of-course 14 exams graded by a national industry organization and must include in their grant request how the money will be spent in direct 15 support of students to further industry-specific career technology education; a description and history of their program nationally and 16 within South Carolina; estimates of future employment growth in their industry; and the national scope of their program. By August 17 first of the following year, the organization must submit to the department a report detailing how the grant increased 18 industry/employer awareness; the number of increased schools using the industry-based curriculum and partnered with the industry 19 organization; the increased number of students in the program; and an overview and analysis of the organization's statewide student 20 competition. The grant must be used for career awareness programs for that industry cluster; statewide student competitions leading 21 to national competitions; teacher development and training; post-secondary scholarships in industry-specific degree programs; 22 23 student recruitment into that career cluster programs; programs to educate middle and high school Career or Guidance Counselors 24 about the industry; service to disadvantaged youth; and administering business/employer awareness and partnerships which help lead 25 to experience-based, career-oriented experiences including internships, apprenticeships, mentoring, co-op education and service 26 learning. The Office of Career and Technology Education of the department will develop goals with each career cluster on the number of new schools using the industry-based curriculum and partnered with that career cluster organization. These funds may 27 28 not be used to supplant or replace, in whole or in part, other existing resources/assets sourced outside the present grant being used to 29 provide the same services or programs. Organizations may carry-over grants for up to three years when a large project is identified in the grant application to be used at a future date; otherwise excess funds must be returned to the state. Organizations awarded must 30 31 submit a semi-annual programmatic and financial report on the last day of December in addition to the final report due August first that has been audited by a third party accounting firm. 32

1A.34. (SDE-EIA: Partnerships/Other Agencies & Entities) For the current fiscal year, agencies and other entities receiving funds appropriated in Part IA, Section 1, VIII. <u>E</u> will continue to report annually to the Education Oversight Committee (EOC). Any entity receiving funds that must flow through a state agency will receive those funds through the EOC, *unless requested in writing*

by the entity to match federal or other funds. The EOC will make funding recommendations to the Governor and General Assembly
 as part of the agency's annual budget request.

1A.35. (SDE-EIA: ETV Teacher Training/Support) Of the funds appropriated in Part IA, Section 1, VIII.E. South Carolina
 Educational Television must provide training and technical support on the educational resources available to teachers and school
 districts.

6 1A.36. (SDE-EIA: Teacher Salaries/SE Average) The projected Southeastern average teacher salary shall be the average of the average teachers' salaries of the southeastern states as projected by the Revenue and Fiscal Affairs Office. For the current school year the Southeastern average teacher salary is projected to be \$51,966 \$51,152. The General Assembly remains desirous of raising the average teacher salary in South Caroling through incremental increases over the part for wars so as to make such equivalent to

9 the average teacher salary in South Carolina through incremental increases over the next few years so as to make such equivalent to 10 the national average teacher salary.

11 The statewide minimum teacher salary schedule used in Fiscal Year 2016-17 will continue to be used in Fiscal Year $\frac{2017-18}{2018-12}$ 12 <u>19</u>.

Additionally, for the current fiscal year, a local school district board of trustees must increase the salary compensation for all eligible certified teachers employed by the district by no less than one year of experience credit using the district salary schedule

15 utilized the prior fiscal year as the basis for providing the step. Application of this provision must be applied uniformly for all eligible 16 certified teachers.

Funds appropriated in Part IA, Section 1, VIII.C.2. for Teacher Salaries must be used to increase salaries of those teachers eligible pursuant to Section 59-20-50(4)(b), to include classroom teachers, librarians, guidance counselors, psychologists, social workers, occupational and physical therapists, school nurses, orientation/mobility instructors, and audiologists in the school districts of the

20 state.

For purposes of this provision teachers shall be defined by the Department of Education using the Professional Certified Staff (PCS) System.

1A.37. (SDE-EIA: PowerSchool Dropout Recovery Data) With the funds appropriated to the Department of Education for PowerSchool and data collection, the department will begin in the current fiscal year to collect data from schools and school districts on the number of students who had previously dropped out of school and who reenrolled in a public school or adult education to pursue a high school diploma. The Education Oversight Committee working with the Department of Education will determine how to calculate a dropout recovery rate that will be reflected on the annual school and district report cards.

1A.38. (SDE-EIA: Assisting, Developing and Evaluating Professional Teaching -ADEPT) With funds appropriated in the current fiscal year, the Department of Education, school districts, the Department of Juvenile Justice and special schools of the state may continue implementation of the ADEPT program. Governing boards of public institutions of higher education may provide by policy or regulation for a tuition waiver for the tuition for one three-hour course at that institution for those public school teachers who serve as supervisors for full-time students completing education degree requirements. Unexpended funds appropriated for this purpose may be carried forward from the prior fiscal year into the current fiscal year and expended for the same purposes.

1A.39. (SDE-EIA: Educational Partnerships) The funds provided to the Center for Educational Partnerships at the College of Education at the University of South Carolina will be used to create a consortium of educational initiatives and services to schools and communities. These initiatives will include, but are not limited to, professional development in writing, geography and other

content areas; training; research; advocacy; and practical consultancy. The Center will establish collaborative educational enterprises 1 2 with schools, school districts, parents, communities, and businesses while fulfilling the responsibilities of the School Improvement Council Assistance. The Center will focus on connecting the educational needs and goals of communities to improve efficiency and 3 4 effectiveness. 5 1A.40. (SDE-EIA: STEM Centers SC) All EIA-funded entities that provide professional development and science programming 6 to teachers and students should be included in the state's science, technology, engineering and mathematics education strategic plan. 7 **1A.41.** (SDE-EIA: EOC Partnerships for Innovation) Of the funds appropriated or carried forward from the prior fiscal year, the 8 Education Oversight Committee is directed to participate in public-private partnerships to promote innovative ways to transform the assessment of public education in South Carolina that support increased student achievement in reading and college and career 9 readiness. The Education Oversight Committee may provide financial support to districts and to public-private partnerships for 10

planning and support to implement, sustain and evaluate the innovation and to develop a matrix and measurements of student 11 academic success based on evidence-based models. These funds may also be used to support the innovative delivery of science, 12 technology, and genetic education and exposure to career opportunities in science, including mobile science laboratory programs, to 13 students enrolled in the Abbeville equity school districts and students in high poverty schools. These funds may also focus on 14 15 creating public-private literacy partnerships utilizing a 2:1 matching funds provision when the initiative employs research-based methods, has demonstrated success in increasing reading proficiency of struggling readers, and works directly with high poverty 16 schools and districts. The committee will work to expand the engagement of stakeholders including state agencies and boards like 17 the Educational Television Commission, businesses, and higher education institutions. The committee shall annually report to the 18 General Assembly on the measurement results. 19

The Education Oversight Committee and the Department of Education shall recommend to the Senate Finance Committee and to the House Ways and Means Committee a plan to develop and implement a strategic grants process for reviewing, awarding, and monitoring innovative education strategies in schools and districts. The plan would identify the process and priority areas for funding that address the educational needs of the state. The plan must be submitted by January 15, <u>2018</u> <u>2019</u>.

24 1A.42. (SDE-EIA: Aid to Districts Draw Down) For the current fiscal year, in order to draw down funds appropriated in Part IA, 25 Section 1, VIII.A.1, Aid to Districts, school districts, Palmetto Unified District and the Department of Juvenile Justice must work with local law enforcement agencies, and when necessary, state law enforcement agencies in order to ensure that the district has an 26 updated school safety plan in place. The safety plan must include safety directives in the classroom, a safe student and staff exit 27 28 strategy and necessary safety staff. Notice of completion of the updated plan must be submitted to the Department of Education no 29 later than September first, of the current fiscal year. The department must report to the Chairman of the House Ways and Means Committee, the Chairman of the House Education and Public Works Committee, the Chairman of the Senate Finance Committee 30 31 and the Chairman of the Senate Education Committee by September thirtieth, of the current fiscal year, on any districts that failed to submit an updated plan. 32

1A.43. (SDE-EIA: Education and Economic Development Act Carry Forward) Funds provided for the Education and Economic
 Development Act may be carried forward into the current fiscal year to be expended for the same purposes by the department, school
 districts, and special schools.

1	1A.44. (SDE-EIA: EEDA Regional Education Centers) Funds appropriated from the EEDA for Regional Education Centers must
2	not be less than \$108,500.
3	1A.45. (SDE-EIA: Teach for America SC) Because Teach For America SC receives EIA funds in the current fiscal year, school
4	districts that partner with Teach For America SC are required to provide to Teach For America SC by September first annually,
5	information on the prior year's academic achievement of students who were directly taught by Teach For America corps members.
6	The information must be in a format that protects the identity of individual students and must include state assessment data as
7	appropriate.
8	1A.46. (SDE-EIA: EOC-South Carolina Autism Society) Of the funds appropriated in Section 1A, VIII.E. Partnerships, Education
9	Oversight Committee (A85), \$500,000 must be transferred in quarterly installments from the Education Oversight Committee to the
10	South Carolina Autism Society for the Autism Parent-School Partnership Program. Beginning October 10, 2015, the South Carolina
11	Autism Society shall provide a quarterly accounting report to the Chairman of the Senate Finance Committee, the Chairman of the
12	House Ways and Means Committee and the Education Oversight Committee.
13	1A.47. (SDE-EIA: CHE/CERRA) The Center for Educator Recruitment, Retention and Advancement (CERRA) must complete
14	periodic evaluations of the institutions currently hosting a Teaching Fellows (TF) program and ensure that the TF programs at the
15	current host institutions continue to meet the requirements for a TF program as set forth by the CERRA Board of Directors. Further,
16	CERRA will continue implementing a long-range plan for approving additional TF programs at other public, four-year institutions
17	who wish to be considered to host a TF program, provided the proposed programs meet the requirements set forth by the CERRA
18	Board of Directors. CERRA will publish TF program criteria and requirements prominently on its website. Any institution who
19	applies but is not selected to host a TF program will be informed in writing of the basis for the selection decision and be offered
20	technical support if the institution elects to reapply. Any institution that applies but is not selected to host a TF program may appeal
21	to the Commission on Higher Education.
22	1A.48. (SDE-EIA: Surplus) For Fiscal Year 2017-18 2018-19, EIA cash funds from the prior fiscal year and EIA funds not
23	otherwise appropriated or authorized must be carried forward and expended on the following items in the order listed:
24	1. Computer Science Task Force - \$400,000;
25	2. 1. EOC-Partnerships - \$6,281,500 \$4,559,000; and
26	3. <u>2.</u> Industry Certification - \$3,000,000;.
27	4. SDE-School Districts Capital Improvement Plan - \$55,828,859;
28	5. SDE-Technical Assistance - \$1,308,500; and
29	6. SDE-K-12 Funding Gap - \$450,000.
30	The Department of Education shall disburse the funds for the K-12 Funding Gap proportionately to school districts that, in the

- 1A.49. (SDE-EIA: Public Charter Pupil Counts) With funds appropriated to <u>charter schools sponsored by either</u> the South
 Carolina Public Charter School District <u>or a registered Institution of Higher Education</u>, the <u>district sponsor</u> must require each charter

school to submit a student attendance report for the 5th, 45th, 90th and 135th days. Reporting requirements shall include both Average 1 2 Daily Membership and Weighted Pupil Unit membership. The South Carolina Public Charter School District or a registered Institution of Higher Education shall then provide the data for each charter school to the Department of Education. Quarterly, the 3 4 department will submit the information to the House Ways and Means Committee, the House Education and Public Works 5 Committee, the Senate Finance Committee and the Senate Education Committee. 6 The South Carolina Public Charter School District or a registered Institution of Higher Education must also require each virtual 7 charter school to collect the following information: (1) the reason or reasons why each student enrolled in the virtual charter school 8 district from both the parent(s) and the referring school district; and (2) the reason or reasons why a student withdrew from the virtual charter school district. This data must be provided to the Department of Education guarterly and must include the unique student 9 identifier. (SDE-EIA: South Carolina Public Charter School District Funding) The funds appropriated in Part IA, Section 13 VIII.GH. - South Carolina Public Charter School District Statewide Sponsor must be allocated in the following manner to students 14 at charter schools within the South Carolina Public Charter School District or within a registered Institution of Higher Education: 15 Pupils enrolled in virtual charter schools sponsored by the South Carolina Public Charter School District or a registered Institution 16 of Higher Education shall receive \$1,900 per weighted pupil and pupils enrolled in brick and mortar charter schools sponsored by 17 the South Carolina Public Charter School District or a registered Institution of Higher Education shall receive \$3,600 per weighted 18 pupil. Any unexpended funds, not to exceed ten percent of the prior year appropriation, must be carried forward from the prior fiscal 19 year and expended for the same purpose. Any unexpended funds exceeding ten percent of the prior year appropriation must be 20 transferred to the Charter School Facility Revolving Loan Program established in Section 59-40-175. For Fiscal Year 2017-18 2018-21 19, the timelines set forth for ruling on charter school applications are extended for sixty calendar days for all applications submitted 22 23 to the South Carolina Public Charter School District if the district determines that an applicant should be permitted to amend its 24 application to meet the requirements of Section 59-40-60 and Section 59-40-70, of the 1976 Code, based on an applicant's proposal to address an existing achievement gap utilizing an evidence-based educational program in an underserved geographical area of the 25 state including, but not limited to, charter schools proposed to be located in any school district that is a plaintiff in the Abbeville law 26 27 suit. The South Carolina Public Charter School District shall report to the Senate Finance Committee and the House Ways and 28 Means Committee on the outcomes of this extended time for a hearing at the end of the application cycle. 29 1A.51. (SDE-EIA: Low Achieving Schools) Of the funds appropriated to the Education Oversight Committee for Partnerships for Innovation, \$500,000 must be allocated to support up to three low-achieving schools in designing and planning for 30 implementation innovative, research-based strategies focused on recruiting and retaining highly effective teachers and on increasing 31 32 time-on-task through the amount of time, the quality of instruction and the engagement of students. The committee will assist the schools in determining the evidence that will be collected to measure the effectiveness of the initiative and in identifying resources 33 34 to support the initiative and in collaborating with TransformSC. 1A.52. (SDE-EIA: TransformSC) Of the funds appropriated to the Education Oversight Committee for Partnerships for 35

36 Innovation, at least \$400,000 shall be allocated to the TransformSC public-private project.

1A.53. (SDE-EIA: CDEPP Student Information and Reporting) For the current fiscal year, the Department of Education and the 1 2 Office of First Steps to School Readiness must acquire unique student identifiers or SUNS numbers for each student enrolled in the CDEPP program no later than the 45th day and must provide a report of such to the House Ways and Means Committee, the House 3 Education Committee, the Senate Finance Committee, the Senate Education Committee and the Education Oversight Committee by 4 5 November first. The Department of Education and the Office of First Steps to School Readiness must provide any information 6 required by the Education Oversight Committee for the annual CDEPP report no later than November thirtieth. 7 1A.54. (SDE-EIA: Charter School Funding-Chartered by Institution of Higher Education) Pupils enrolled in a brick and mortar 8 charter school authorized by an approved institution of higher education located in this state shall receive \$3,600 per weighted pupil and pupils enrolled in a virtual charter school authorized by an approved institution of higher education located in this state shall 9 receive \$1,900 per weighted pupil from the funds appropriated in Part IA, Section VIII.G. - South Carolina Public Charter 10 School - Institution of Higher Education. Any unexpended funds, not to exceed ten percent of the prior year appropriation, must be 11 carried forward from the prior fiscal year and expended for the same purpose. Any unexpended funds exceeding ten percent of the 12 prior year appropriation must be transferred to the Charter School Facility Revolving Loan Program established in Section 59-40-175, 13 of the 1976 Code. 14 1A.55. (SDE-EIA: Rural Teacher Recruiting Incentive) (A) There is created a program within the South Carolina Center for 15 Educator Recruitment, Retention, and Advancement (CERRA) to recruit and retain classroom educators in rural and underserved 16 districts experiencing excessive turnover of classroom teachers on an annual basis. 17 (B) During the current fiscal year CERRA shall publish eligibility requirements and applications for individual educators, school 18 districts, and institutions of higher education not inconsistent with existing licensure requirements for each, but also including: 19 (1) Eligible districts identified by CERRA as experiencing greater than eleven ten percent average annual teacher turnover, 20 as reported on the districts' five most recent district report cards issued by the South Carolina Department of Education, may make 21 application to participate in the program. 22 23 (2) Individuals eligible for incentives shall be willing to provide instructional services in an eligible district in exchange for 24 participation in an incentive detailed in item (C) of this section, pursuant to the obligations and restrictions stated for each. 25 (3) Institutions of higher education eligible to receive education funding as a component of recruiting incentives created pursuant to item (C) of this section shall not be excluded from participation in Teaching Fellows Program. 26 (4) Any incentives requiring individuals to relocate into an eligible district to provide instructional services shall not be 27 28 made available to individuals providing instructional services in other eligible districts. 29 (C) Pursuant to item (A), CERRA shall develop a set of incentives including, but not limited to, salary supplements, education subsidies, loan forgiveness, professional development, and mentorship to be provided to classroom educators that offer instructional 30 31 services in eligible districts and shall provide incentive options for eligible individuals at all stages of their careers, including high-school and college or university students interested in entering the teaching profession and including individuals entering the 32 field through an alternative certification pathway to include, but not limited to, PACE, ABCTE, Teach for American and CATE 33

35 At a minimum, the incentives shall include:

(D) In addition to eligibility and application requirements, CERRA shall develop a process for recovering an amount equal to the incentives given to individual participants who fail to comply with the obligations associated with a relevant incentive in which they participate including, but not limited to, failure to complete a prescribed course of study, failure to obtain a relevant certification or licensure upon completion of a course of study, or failure to provide instructional services in an eligible district for a prescribed period of time.

19 (E) CERRA shall report by July thirty-first of the current fiscal year to the Governor, President pro Tempore of the Senate, and 20 Speaker of the House on the incentives developed pursuant to item (C) of this section and make recommendations for attracting and 21 retaining high quality teachers in rural and underserved districts. The report shall contain at a minimum eligibility requirements and 22 application processes for districts and individuals, descriptions of and proposed budgets for each incentive program and an analysis 23 of the number and demographics of individuals potentially eligible for each.

29 1A.57. (SDE-EIA: Reading/Literacy Coaches) (A) Funds appropriated for Reading/Literacy Coaches must be allocated to school districts by the Department of Education as follows: (1) for each *primary and* elementary school in which twenty percent or more

31 of the students scored below "meets expectations" on the reading sub score of the English language arts test in the most recent year

32 for which such data are available, the school district shall be eligible to receive the lesser of up to \$62,730. or the actual cost of salary 33 and benefits for a full-time reading/literacy coach; and

34 (2) for each elementary school in which fewer than twenty percent of the students scored as referenced in (A)(1), the school
 35 district shall be eligible to receive the lesser of up to \$31,365 or fifty percent of the actual cost of salary and benefits for a full-time

reading/literacy coach. A school district must provide local support for state funds provided under this paragraph. School districts 1 2 may use existing local funds currently used for reading assistance as the local support. (B) By accepting these funds, a school district warrants that they will not be used to supplant existing school district expenditures, 3 4 except for districts that either are currently, or in the prior fiscal year, were paying for reading/literacy coaches with local funds. A district may, however, assign a reading/literacy coach to a primary school rather than to the elementary school to improve the early 5 6 literacy skills of young children only utilize these funds to employ reading/literacy coaches that may serve in a primary, elementary, or middle school or a combination of these schools depending on the area of highest need in the district. The school district must 7 align the placement of coaches to the district reading plan that is approved by the department. 8 (C) Funds appropriated for reading/literacy Coaches are intended to be used to provide primary, elementary, and/or middle 9 schools with reading/literacy coaches who shall serve according to the provisions in Chapter 155 of Title 59. 10 (D) Schools and districts accepting funding to support a coaching position agree that the reading/literacy coach must not serve as 11 an administrator. If the department finds that school districts are using these funds for administrative costs as defined in statute they 12 must withhold that districts remaining balance of funds allocated pursuant to this proviso. 13 (E) The Department of Education must publish guidelines that define the minimum qualifications for a reading/literacy coach. 14 15 These guidelines must deem any licensed/certified teacher qualified if, at a minimum, he or she: (1) holds a bachelor's degree or higher and an add-on endorsement for literacy coach or literacy specialist; or 16 (2) holds a bachelor's degree or higher and is actively pursuing the literacy coach or literacy specialist endorsement; or 17 (3) holds a master's degree or higher in reading or a closely-related field. 18 Within these guidelines, the Department of Education must assist districts in identifying a reading/literacy coach in the event that 19 the school is not successful in identifying and directly employing a qualified candidate. The provisions of subsection (A), including 20 the local support requirements, shall also apply to any allocations made pursuant to this paragraph. 21 (F) The Department of Education must develop procedures for monitoring the use of funds appropriated for reading/literacy 22 23 coaches to ensure they are applied to their intended uses and are not redirected for other purposes. The Department of Education 24 may receive up to \$100,000 of the funds appropriated for reading/literacy coaches in order to implement this program, provided that 25 this allocation does not exceed the department's actual costs. (G) Prior to the close of the current fiscal year, any unspent or unallocated funds for reading/literacy coaches shall be used to fund 26 Summer Reading Camps. 27 28 (H) The Department of Education shall require: 29 (1) any school district receiving funding under subsection (A) to identify the name and qualifications of the supported reading/literacy coach; as well as the school in which the coach is assigned; and 30 (2) any school district receiving funding under subsection (G) to account for the specific amounts and uses of such funds. 31 (I) With the data reported by the school districts, the department shall report by January fifteenth of the current fiscal year on the 32 hiring of and assignment of reading/literacy coaches by school. The department shall also report the amount of funds that will be 33 34 used for Summer Reading Camps. (J) Funds appropriated for reading/literacy coaches shall be retained and carried forward to be used for the same purpose but 35 may not be flexed. 36

(K) For Fiscal Year 2017-18, if increased funding for reading/literacy coaches is not sufficient to provide additional 1 2 reading/literacy coaches at each elementary school then the funding must be targeted to the areas of greatest need based on the number of students substantially failing to demonstrate reading proficiency as indicated on the prior year's state assessment the 3 4 current fiscal year, and if funds are available, the department may fund a coach at the full time rate if the district's reading scores show that less than 20% of the students scored below "meets expectations" on the reading sub score of the English language arts 5 test in the most recent year for which such data are available, but for the past two year the district qualified for a full time coach 6 7 based on the assessment scores. 8 1A.58. (SDE-EIA: Digital Instructional Materials) The Department of Education shall *continue to* create an instructional materials list composed of those items (print and/or digital) that have received State Board of Education approval through the normal adoption 9 process. The department shall continue to work with the publishers of instructional materials to ensure that districts who wish to 10 receive both the digital version and have options for print/digital student materials to include class sets of textbooks may be awarded 11 that option print student editions, if needed. Funds appropriated for the purchase of textbooks and other instructional materials 12 (print/digital) may be used for reimbursing school districts to offset the costs of refurbishing science kits on the state-adopted 13 textbook instructional materials inventory, purchasing new kits or those adopted as supplemental from the central textbook 14 depository, or a combination of refurbishment and purchase. The refurbishing cost of kits may not exceed the cost of the 15 state-adopted refurbishing kits plus a reasonable amount for shipping and handling. Costs for staff development, personnel costs, 16 equipment, or other costs associated with refurbishing kits on state inventory are not allowable costs. Funds provided for Instructional 17 Materials may be carried forward from the prior fiscal year into the current fiscal year to be expended for the same purposes by the 18 department, school districts, and special schools. These funds are not subject to flexibility. Digital Instructional Materials shall 19 include the digital equivalent of materials and devices. 20 21 Utilizing the designated funds, the department shall determine a per pupil amount using the prior year's 135-Day Average Daily Membership for unfunded state-adopted digital instructional materials and unvetted digital student materials. These funds shall be 22 made available to all schools to allow one-year access to unfunded digital state-adopted student materials or one-year access to 23 unvetted digital student materials from publishers/vendors and are subject to the procedures outlined below. The use of the unvetted 24 digital student materials shall be the responsibility of the school district. 25 26 Unfunded State Adopted Digital Student Materials: The department shall create a digital instructional materials list composed of those items which have received board approval through the normal adoption process but are unfunded. Districts shall use the 27 form available on the department's Instructional Materials website, to request an allocation for one-year digital access by denoting 28 29 the number of students, grade level, and subject for which the digital materials will be used. Unvetted Materials: Publishers/vendors shall use the form available on the department's Instructional Materials website to 30 request to have digital student materials added to an unvetted list of instructional materials that have not been evaluated through 31 the instructional materials adoption process or approved by the board. Publishers/vendors are required to register and submit to 32 the department the one-year cost with product information, a completed brief, and correlations of the digital student materials to the 33 34 appropriate academic standards, career and technology education course standards, or other program areas which are not addressed within the standards. Information in the brief shall include the intended course or subject area with the assigned 35 Instructional Activity Code, the readability level, documentation of compliance to ensure the digital instructional materials are 36

accessible to students with disabilities, and other specific descriptive information as required by the State Superintendent of 1 2 Education. Failure to provide completed brief and correlation will automatically exclude the digital materials from the unvetted Previously reviewed instructional materials will be excluded from the list of unvetted digital materials. Should the 3 list. publisher/vendor submit the unvetted materials for review as part of a call for bids for instructional materials, the bid materials will 4 be removed from the unvetted listing. 5 A district shall use the form available on the department's Instructional Materials website to request an allocation for which the 6 unvetted digital materials will be used by denoting the number of students, grade level, and subject with the assigned Instructional 7 Activity Code. The department shall not be responsible for the use by schools of the unvetted digital materials including the content, 8 alignment to standards, lack of accessibility for students with disabilities, quality, or any other aspect of the digital materials. The 9 unvetted digital materials shall not be placed on state contract; therefore, the availability and cost of these materials will not be 10 11 assured. 12 Any funds appropriated for digital instructional materials which have not been encumbered by January 15, shall be used by the department to purchase unfunded state adopted instructional materials. 13 1A.59. (SDE-EIA: 4K Early Literacy Competencies Assessments) Of the funds carried forward from the full-day 4K program 14 15 from the previous fiscal year, the Department of Education is authorized to expend up to \$800,000 on assessments and professional development to analyze the early literacy competencies of children in publicly funded prekindergarten. If these funds are not 16 available, funds appropriated and/or authorized for assessment shall be used to administer the prekindergarten assessments. The 17 department shall manage the administration of assessments that analyze the early literacy and language development of children in 18 publicly funded prekindergarten as done in the prior fiscal year. Each school district and private provider participating in a publicly 19 funded prekindergarten program will administer one of the formative assessments selected by the department to each child eligible 20 for and enrolled in a publicly funded prekindergarten program during the first forty-five days of the school year and during the last 21 forty-five days of the school year. Accommodations that do not invalidate the results of these assessments must be provided in the 22 23 manner set forth by the student's Individualized Education Program or 504 Accommodations Plan and for students who are Limited 24 English Proficient according to their LEP Plan. The department will provide the assessment data to the Education Oversight 25 Committee. The results of the assessment and the developmental intervention strategies recommended or services needed to address the child's identified needs must also be provided, in writing, to the parent or guardian. The assessment may not be used to deny a 26 27 student to admission to prekindergarten. Furthermore, up to \$2,000,000 of the funds appropriated for half-day programs for four-year-olds and funds carried forward from 28 assessment must be expended by the Department of Education to administer the Kindergarten Readiness Assessment (KRA) to each 29 child entering kindergarten in the public schools. The assessment of kindergarten students must be administered at a minimum of 30 once during the first forty-five days of the school year with the results collected by the department. The results of the assessments 31 and the developmental intervention strategies recommended or services needed to address each child's identified needs must also be 32 provided, in writing, to the parent or guardian. The assessment may not be used to deny a student admission to kindergarten. 33 34 Accommodations that do not invalidate the results of these assessments must be provided in the manner set forth by the student's Individualized Education Program, or 504 Accommodations Plan, or LEP Plan. Districts are given the option of designating up to 35 two days of the one hundred eighty day school calendar to administer the assessment to kindergarten students. The department will 36

also provide the results of the assessment of kindergarten students to the Education Oversight Committee. With available funds, the 1 2 department will also provide or secure training for appropriate educators in how to administer the assessment. For all students assessed with the Kindergarten Readiness Assessment (KRA), the Department of Education is required to collect 3 4 data from schools and school districts on the prior early learning experience of each student. The data would include whether the 5 kindergartener had attended in the prior school year a Head Start program, a South Carolina Early Reading Development and Education Program in a public school or a private center, a half-day 4K program in a public school, a full-day 4K program in a public 6 7 school, a child care center (registered faith-based, registered family home, group home, or exempt provider) or informal child care. 1A.60. RESERVED 8 1A.61. (SDE-EIA: CDEPP Unexpended Funds) For Fiscal Year 2017-18 2018-19, the Office of First Steps to School Readiness 9 is permitted to retain the first \$1,000,000 of any unexpended CDEPP funds of the prior fiscal year and expend these funds to enhance 10 the quality of the full-day 4K program in private centers and provide professional development opportunities. 11 By August first, the Office of First Steps is directed to allocate any additional unexpended CDEPP funds from the prior fiscal year 12 and any CDEPP funds carried forward from prior fiscal years that were transferred to the restricted account for the following purpose: 13 Education Oversight Committee - \$1,000,000 for the South Carolina Community Block Grants for Education Pilot Program. 14 15 If carry forward funds are less than the amounts appropriated, funding for the items listed herein shall be reduced on a pro rata 16 basis. If by August first, the Department of Education or the Office of First Steps determines there will be funds available, funds shall 17 be allocated on a per pupil basis for districts eligible for participation first, who have a documented waiting list, and funded an 18 extended program per this proviso in the prior school year, then to districts to increase the length of the program to a maximum of 19 eight and a half hours per day or two hundred and twenty days per year or to fund summer programs. By August 1, the Department 20 of Education and the Office of First Steps must collect the documented waiting lists and determine a process to notify parents of 21 eligible students of available slots in all approved providers. If a district chooses to fund summer enrollment the program funding 22 shall conform to the funding in this act for full year programs, however shall be reduced on a pro rata basis to conform with the 23 24 length of the program. A summer program shall be no more than eight and a half hours per day and shall be not more than ten weeks 25 in length. The per pupil allocation and classroom grant must conform with the appropriated amount contained in this Act and end of year adjustments shall be based on the one hundred and thirty five day student average daily membership or later student average 26 daily membership for districts choosing to extend the program past one hundred and eighty days. Funds may also be used to provide 27 28 professional development and quality evaluations of programs. No later than April first, the Department of Education and the Office of First Steps must report to the Chairman of the Senate 29 Finance Committee and the Chairman of the House Ways and Means Committee on the expenditure of these funds to include the 30 following information: the amount of money used and specific steps and measures taken to enhance the quality of the 4K program 31 and the amount of money used for professional development as well as the types of professional development offered and the number 32 33 of participants. 34 1A.62. (SDE-EIA: College and Career Readiness) Funds appropriated to the Department of Education for District College and Career Readiness Assistance must first be used to increase the capacity of districts that are or were the original trial and plaintiff 35 school districts in the Abbeville law suit. Funds shall be used by the department to provide assistance to districts using appropriately 36

experienced educators with demonstrated effectiveness in instructional leadership. Support shall include professional development, 1

2 standards and learning support, instructional support, data analysis and leadership development resources to ensure that educators

are equipped with the tools to provide students with high quality, personalized learning that supports the Profile of the South Carolina 3

4 Graduate. The department shall report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and

5 Means Committee on how these funds were expended.

6 **1A.63.** (SDE-EIA: Industry Certifications/Credentials) Of the funds appropriated for Industry Certifications/Credentials, 7 \$3,000,000 must be allocated to school districts based upon the number of national industry exams administered in the prior school 8 year with each district receiving a base amount of \$10,000. The department will identify the national industry exams that will be funded based upon the job availability in the state. School districts may carry forward funds from the prior fiscal year into the current 9 fiscal year and expend the funds for the cost of national industry exams. The department shall work with the Department of 10 Commerce, the Department of Employment and Workforce, state and local chambers of commerce and economic development 11 12 offices and the Tech Board to ensure that students are aware of the industry required credentials for current job availability in the state organized by region. Any additional funds appropriated must be allocated to school districts based upon the number of national 13 industry exams/credentials earned in the prior school year, and districts must expend these funds to pay for the cost of industry exams 14 15

or to support students in preparing for the exams in the current fiscal year.

1A.64. (SDE-EIA: Career and Technology Education) Funds appropriated for Career and Technology Education will be 16 distributed to school districts and multi-district career centers based on the prior year actual student enrollment for career and 17 technology education courses, with no district or multi-district career center receiving less than \$50,000. Funds may be expended 18 for the purchase of career and technical equipment, the up fitting of facilities and the purchase of consumables, regional career 19 specialists, and such evidence-based initiatives like High Schools that Work and Project Lead the Way. Each district must include 20 in the district plan submitted to the Office of Career and Technology Education information on other career and technical equipment 21 available. The district must include, at a minimum, equipment located at the career center and at the technical college, information 22 23 on the alignment of equipment to current industry jobs and needs in the state as recommended by career and technical program 24 advisory committees. District plans must include charter schools within the school district offering at least one career and technical 25 education completer program. School districts and career centers may carry forward unexpended funds to be used for the same intended purposes to up fit career and technical facilities and replace career and technical program consumables. In addition, 26 \$125,000 of the funds appropriated shall be allocated to the Palmetto Partners for Science and Technology for robotics competition, 27 28 curriculum, and support.

29 1A.65. (SDE-EIA: Digital Learning) Of the funds appropriated to the Education Oversight Committee for Partnerships for Innovation, \$1,300,000 \$1,900,000 must be authorized for schools or school districts that have poverty indices of eighty percent or 30 31 greater based on the poverty index utilized the prior fiscal year that was student eligibility for the free or reduced price lunch program and Medicaid, or are a trial or plaintiff district in the Abbeville equity lawsuit. In these districts, the EOC will pilot a program that 32 provides school districts with digital learning tools, digital resources, the curriculum foundry, technical support, and professional 33 34 development.

1A.66. (SDE-EIA: South Carolina IT Academy) Of the funds appropriated for the South Carolina IT Academy, the Department 35 of Education shall procure an IT Academy for public schools statewide in the coming school year. The IT Academy must offer 36

1 certification opportunities for educators to receive Teacher Certification Exams and for students to receive certifications in an office

2 suite of products in the middle grades and programming credentials in high school. The procurement shall include official curriculum. e-learning. E-books. exams. software and lesson plans. 3 4 1A.67. (SDE-EIA: Family Connection South Carolina) Funds appropriated in Part IA, Section 1, VIII.E, Partnerships, for Family 5 Connection South Carolina (H63), shall be transferred in quarterly installments from the Department of Education to Family Connection South Carolina. Funds shall be used to provide support to families of children with disabilities. Support shall include, 6 7 home visits, transition assistance, education assistance, parent support and parent training. The department shall establish guidelines 8 through which Family Connection South Carolina shall provide planning documents to the department not later than July fifteenth of the current fiscal year, and quarterly reporting of expenditures thereafter; and a performance report submitted annually. 9 1A.68. (SDE-EIA: Low Achieving Schools) Of the funds appropriated to the Education Oversight Committee for Partnerships 10 for Innovation, \$500,000 \$409,000 shall be allocated to parent support initiatives and afterschool programs in historically 11 underachieving communities. 12 1A.69. (SDE-EIA: EOC Military-Connected Children) Of the funds allocated for Partnerships for Innovation, the Education 13 Oversight Committee is directed to expend \$300,000 to initiate in at least two school districts with high military density, a pilot 14 15 program that will provide training, services, resources and research to teachers, counselors, mental health professionals, school nurses, service providers and military parents. The objective of the pilot is to increase the level of educational quality and support 16 for military-connected children. The training and services must be provided by a non-profit entity that is an NBCC-Approved 17 Continuing Education Provider and is an authorized provider by the international Association for Continuing Education and Training 18 (IACET). Pursuant to its responsibilities under Act 289 of 2014, the Education Oversight Committee will report on the expenditure 19 of these funds and post-training evaluations in its annual report on the educational performance of military connected children. 20 21 1A.70. (SDE-EIA: STEM Labs) Of the funds allocated for Partnerships for Innovation, the Education Oversight Committee is directed to expend \$300,000 for customized STEM labs. The Education Oversight Committee shall work with the Department of 22 23 Education, Office of Standards and Learning to solicit interested middle schools from the Abbeville trial and plaintiff districts to participate in implementing a STEM based curriculum. The pilot sites will receive a customized 6th - 8th grade STEM curriculum 24 25 designed to address the needs of local industry. The curriculum provided will be aligned to state standards and certified by ACT WorkKeys and will include hands on, problem based student labs. The curriculum will also be certified by ACT WorkKeys. 26 Teachers in the pilot sites will receive ongoing, year-long professional development on cross curricular STEM implementation that 27 28 will be aligned to state standards as well and the district strategic plan. 1A.71. (SDE-EIA: Assistance Funding) For the current fiscal year, any funds appropriated to the Department of Education to 29 assist districts that are or were Plaintiffs in the Abbeville law suit and funding appropriated to the department to provide technical 30 assistance to underperforming districts may not be transferred to any other program, are not subject to flexibility, and may be carried 31 forward and expended for the same purposes. 32

1A.72. (SDE-EIA: National Board Certification Incentive) Public school classroom teachers, to include teachers employed at the special schools or classroom teachers who work with classroom teachers, to include teachers employed at the special schools who are certified by the State Board of Education and who have been certified by the National Board for Professional Teaching Standards or completed the application process prior to July 1, 2010 shall be paid a \$7,500 salary supplement beginning July first in the year

following the year of achieving certification, beginning with 2009 applicants. The special schools include the Governors School for 1 2 Science and Math, Governors School for the Arts and Humanities, Wil Lou Gray Opportunity School, John de la Howe School, School for the Deaf and the Blind, Department of Juvenile Justice and Palmetto Unified School District 1. The \$7,500 salary 3 4 supplement shall be added to the annual pay of the teacher for the length of the national certificate. However, the \$7,500 supplement 5 shall be adjusted on a pro rata basis for the teachers FTE and paid to the teacher in accordance with the districts payroll procedure. In addition, teachers who have applied prior to July 1, 2010 and are certified by the National Board for Professional Teaching 6 7 Standards shall enter a recertification cycle for their South Carolina certificate consistent with the recertification cycle for national 8 board certification. National board certified teachers who have been certified by the National Board for Professional Teaching Standards or completed the application process prior to July 1, 2010 moving to this State who hold a valid standard certificate from 9 their sending state are exempted from initial certification requirements and are eligible for a professional teaching certificate and 10 continuing contract status. Their recertification cycle will be consistent with national board certification. 11 For the current fiscal year the salary supplement will be \$5,000 for public school classroom teachers, to include teachers employed 12 at the special schools or classroom teachers who work with classroom teachers, to include teachers employed at the special schools 13 who are certified by the State Board of Education and who complete the application process on or after July 1, 2010, beginning in 14 the year of achieving certification and applies uniformly to all teachers covered under Section 59-26-85(A)(2) of the 1976 Code. 15 The special schools include the Governors School for Science and Math, Governors School for the Arts and Humanities, Wil Lou 16 Gray Opportunity School, John de la Howe School, School for the Deaf and the Blind, Department of Juvenile Justice and Palmetto 17 Unified School District 1. The \$5,000 salary supplement shall be added to the annual pay of the teacher, not to exceed the lesser of, 18 the length of one national certificate cycle. However, the \$5,000 supplement shall be adjusted on a pro rata basis for the teachers 19 FTE and paid to the teacher in accordance with the districts payroll procedure. 20 Fiscal Year 2017-18 shall be the final year for eligible teachers to submit the initial application and fee for NBPTS and be eligible 21 22 to receive the state supplement upon achieving certification. Teachers eligible to receive the state supplement upon achieving 23 certification must have submitted the initial application and fee for NBPTS in Fiscal Year 2017-18. The department is authorized to

24 <u>carry forward funds and only expend them for the same purpose.</u> Appropriations in excess of applicable expenditures shall be 25 distributed to school districts based on the EFA formula.

1A.73. (SDE-EIA: Revolving Student Loan Program Transfer) The State Treasurer shall transfer \$16,000,000 from the EIA
 Revolving Student Loan Program, Fund 41L1, to the Department of Education. The department shall utilize these funds for the
 School Districts Capital Improvement Plan as set forth in this act.

1A.74. (SDE-EIA: Abbeville Equity School Districts Capital Improvement Plan) The funds appropriated for the Abbeville Equity 29 School Districts Capital Improvement Plan in Part IA, Section 1, VIII, I, Abbeville Equity School Districts Capital Improvements 30 31 and by provisos 1.85, 1A.48, 1A.73, and 1A.77 shall be allocated by the Department of Education to eligible school districts for the purpose of funding school facility upgrades. Eligible school districts include any school district that is a plaintiff in the Abbeville 32 law suit or districts with a poverty index of eighty percent or higher. For the purpose of this provision, "school facility" means only 33 34 facilities necessary for instructional and related supporting purposes including, but not limited to, classrooms, libraries, media centers, laboratories, cafeterias, physical education spaces, related interior and exterior facilities, and the conduit, wiring, and powering of 35 hardware installations for classroom computers or for area network systems. Eligible school facility projects shall include: (a) health 36

and safety upgrades; (b) technology upgrades inside school facilities; (c) upgrades associated with career and technology education 1 2 programs; and (d) deferred maintenance needs as described in the district's capital improvement plan. For purposes of this provision, school facilities shall not include unimproved real property, centralized district administration facilities, or other facilities, including 3 4 those normally identified with interscholastic sports activities. The department shall develop and maintain an application process for school districts to request funding for qualified school 5 projects and establish policies, procedures, and priorities for the making of grants pursuant to this provision. At least twice a year 6 7 and upon receipt of applications pursuant to the application process adopted by the department, the department shall prioritize the 8 eligible projects with the greatest need and shall submit a list of recommended grant awards to the State Board of Education. Grants shall be awarded upon an affirmative vote of the State Board. 9 The financial assistance provided to school districts pursuant to this provision must be used for the eligible school facility project. 10 The department is responsible for establishing policies and procedures to ensure that funds are expended in a manner consistent with 11 this provision. 12 Following the close of the fiscal year, the department shall submit an annual report of its Abbeville Equity School Districts Capital 13 Improvement Plan activities for the preceding year to the Governor, the Chairman of the Senate Finance Committee, the Chairman 14 of the House Ways and Means Committee, the Chairman of the Senate Education Committee, and the Chairman of the House 15 Education and Public Works Committee. 16 1A.75. Funds distributed to a school district may only be used for the following purposes: (1) To improve external connections to schools, with a goal of reaching at least 100 kilobits per second, per student in each school by 2017; (2) To improve internal connections within schools, with a goal of reaching at least 1 megabit per second, per student in each school by 2017; or (3) To develop or expand one-to-one computing initiatives. A school district that has achieved each of the above goals may submit a plan to the K-12 Technology Committee for permission to expend its allocation on other technology-related uses; such permission shall not be unreasonably withheld and the K-12 Technology Committee must permit districts to appeal any process should a district not receive approval and must provide technical assistance to districts in developing plans should the district request such. The annual 8 verification and audit shall be funded from the funds appropriated to or authorized for the Commission on Higher Education and the commission shall not assess a fee or charge institutions of higher learning for performing this function. In addition, the Commission 9 on Higher Education shall provide a report to the Executive Budget Office, the Chairman of the Senate Finance Committee, and the 10 Chairman of the House Ways and Means Committee by October first each year summarizing, by institution, how lottery funds were 11 expended in the prior fiscal year, issues and concerns as well as institution responses to those issues and concerns discovered as a 12 result of the commission's verification and/or audit activity during the prior fiscal year, if any. 13

(SDB: Mobility Instructor Service Fee) The School for the Deaf and the Blind is authorized to charge a fee for the services 16 of a mobility instructor to provide service on a contractual basis to various school districts in the state, and such revenue shall be 17 retained and carried forward into the current fiscal year and expended by the School for the purpose of covering expenses in the 18 Blind School. 19 6.5. (SDB: Cafeteria Revenues) All revenues generated from cafeteria operations may be retained and expended by the institution 20 for the purpose of covering actual expenses in cafeteria operations. 21 6.6. 6.15. (SDB: Early Childhood Center) The School for the Deaf and the Blind shall be authorized to redirect and transfer the \$500,000 appropriated for the Thackston Hall Roof Replacement in Act 91 of 2015 by proviso 118.14(B)(5)(a) to the Early Childhood Center Construction project.

(ETV: Grants/Contributions Carry Forward) The Educational Television Commission shall be permitted to carry forward 7 any funds derived from grant awards or designated contributions and any state funds necessary to match such funds, provided that 8 these funds be expended for the programs which they were originally designated. 8.2. (ETV: Spectrum Auction) The Educational Television Commission shall be authorized to receive and retain up to 9 \$35,000,000 of the proceeds from the Federal Communication Commission TV Auction and place them in a segregated, restricted 10 account. These proceeds shall be used to fund capital needs, including broadcast industry standards changes, existing equipment 11 repair, maintenance and replacement needs, and operational costs. Any proceeds received above \$35,000,000 must be placed into a 12 segregated account and transferred to the Department of Education to be used as follows: \$5,000,000 for the Education Foundation 13 Supplement and any remaining proceeds for school bus purchases. Unexpended funds shall be carried forward from the prior fiscal 14 year into the current fiscal year and used for the same purpose. No later than June thirtieth of the current fiscal year, ETV must 15 report to the Chairman of the House Ways and Means Committee and the Chairman of the Senate Finance Committee the amount of 16 money expended from the fund and the balance of the fund. 17 8.3. (ETV: Antenna and Tower Placement) All leases for antenna and tower operations within institutions of higher learning 18 campuses must conform to master plans for such property, as determined solely by the institution of higher learning. 19 8.4. (ETV: Wireless Communications Tower) The Educational Television Commission is directed to coordinate tower and 20 antenna operations within South Carolina state government. The commission shall (1) approve all leases regarding antenna placement 21 on state-owned towers and buildings, (2) coordinate all new tower construction on state-owned property, (3) promote and market 22 23 excess capacity on the State's wireless communications infrastructure, (4) generate revenue by leasing, licensing, or selling excess 24 capacity on the State's wireless communications infrastructure, and (5) construct new communications assets on appropriate 25 state-owned property for the purpose of generating revenue pursuant to this proviso. The commission shall retain and expend such funds for agency operations. The commission shall be authorized to carry forward unexpended funds from the prior fiscal year into 26 the current fiscal year. The commission shall annually report to the Chairmen of the Senate Finance and House Ways and Means 27 Committees by October first of each year all revenue collected and disbursed. 28 29

30 SECTION 11 - H030 - COMMISSION ON HIGHER EDUCATION

11.1. (CHE: Contract for Services Program Fees) The amounts appropriated in this section for "Southern Regional Education Board Contract Programs" and "Southern Regional Education Board Dues" are to be used by the commission to pay to the Southern Regional Education Board the required contract fees for South Carolina students enrolled under the Contract for Services program of the Southern Regional Education Board, in specific degree programs in specified institutions and the Southern Regional Education

1 Board membership dues. The funds appropriated may not be reduced to cover any budget reductions or be transferred for other 2 purposes.

11.2. (CHE: African-American Loan Program) Of the funds appropriated to the Commission on Higher Education for the African-American Loan Program, 73.7 percent shall be distributed to South Carolina State University and 26.3 percent shall be distributed to Benedict College, and must be used for a loan program with the major focus of attracting African-American males to the teaching profession. The Commission of Higher Education shall act as the monitoring and reporting agency for the African-American Loan Program. Of the funds allocated according to this proviso, no more than ten percent shall be used for administrative purposes.

9 **11.3.** (CHE: GEAR-UP) Funds appropriated for GEAR-UP shall be used for state grants programs to reach disadvantaged middle school students to improve their preparation for college. Eligible South Carolina public schools and public institutions of higher education shall cooperate with the Commission on Higher Education in the provision of services under the Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR-UP) grant.

13 **11.4.** (CHE: EPSCoR Committee Representation) With the intent that the four-year teaching institutions receive a portion of 14 EPSCoR funding, the State EPSCoR Committee shall have an executive committee consisting of one representative from each of the 15 research institutions and one representative from the four-year teaching university sector.

- 16 **11.5.** (CHE: SREB Funds Exempt From Budget Cut) In the calculation of any across the board cut mandated by the Executive 17 Budget Office or General Assembly, the amount which the Commission on Higher Education is appropriated for Southern Regional 18 Education Board (SREB) Professional Scholarship Programs and Fees, Dues and Assessments shall be excluded from the 19 Commission on Higher Education's base budget. Funds appropriated for SREB programs may be carried forward into the current 20 fiscal year and expended for the same purpose by the Commission on Higher Education.
- 11.6. (CHE: Performance Improvement Pool Allocation) Of the funds appropriated to the Commission on Higher Education under Section II. Other Agencies & Entities: Special Items: Performance Funding, eighty percent will be allocated to the EPSCoR program under the Commission on Higher Education to improve South Carolina's research capabilities and twenty percent will be allocated to support the management education programs of the School of Business at South Carolina State University.

11.7. (CHE: Troop-to-Teachers) Members of the Armed Forces either active-duty, retired, or separated who are admitted to and enrolled in the South Carolina Troop-to-Teachers Alternative Route to Certification program are entitled to pay in-state rates at participating state institutions for requisite program work.

28 **11.8.** (CHE: Need-Based Grants for Foster Youth) For the current academic year, youth in the custody of the Department of Social Services and attending a higher education institution in South Carolina are eligible for additional need-based grants funding 29 of up to \$2,000 above the \$2,500 maximum. Foster youth must apply for these funds no later than May first, of the preceding year. 30 31 All other grants, both state and federal, for which these foster youth are eligible must be applied first to the cost of attendance prior to using the additional need-based grant funding. If the cost of attendance for a foster youth is met with other grants and scholarships, 32 then no additional need-based grant may be used. The Department of Social Services, in cooperation with the Commission on Higher 33 Education will track the numbers of recipients of this additional need-based grant to determine its effectiveness in encouraging more 34 foster youth to pursue a secondary education. No more than \$100,000 may be expended from currently appropriated need-based 35

36 grants funding for this additional assistance.

11.9. (CHE: Tuition Age) For the current fiscal year, the age limitation for those children of certain war veterans who may be 1 2 admitted to any state-supported college, university, or post high school technical education institution free of tuition is suspended for eligible children that successfully appeal the Division of Veterans Affairs on the grounds of a serious extenuating health condition. 3 4 11.10. (CHE: LIFE and Palmetto Fellows Enhancement Stipends) In the current fiscal year before fall awards are made, to 5 continue eligibility for LIFE and Palmetto Fellows Enhancement Stipends, students shall certify and the institutions shall verify that the student is meeting all requirements as stipulated by the policies established by the institution and the academic department to be 6 7 enrolled as a declared major in an eligible program and is making academic progress toward completion of the student's declared 8 eligible major. These determinations are subject to the verification and audit of the Commission on Higher Education. Institutions shall return funds determined to have been awarded to ineligible students. 9 11.11. (CHE: SmartState) The Commission on Higher Education is prohibited from expending any source of funds on the 10 11 marketing of the SmartState Program. 11.12. (CHE: College Transition Need-Based Grants) Of the currently appropriated need-based grants funding, no more than 12 \$350,000 shall be used to provide need-based grants to South Carolina resident students enrolled at a public institution of higher 13 education in an established college transition program that serves students with intellectual disabilities. The Commission on Higher 14 Education shall allocate the available funds to eligible institutions on the basis of student need and enrollment in the established 15 college transition programs. All other grants and gift aid for which these students are eligible must be applied first to the cost of 16 attendance prior to using the need-based grant funding. If the cost of attendance for an eligible student is met with all other grants 17 and gift aid, the need-based grant shall not be used. The participating institutions, in cooperation with the Commission on Higher 18 Education, shall track the number of grant recipients and other information determined necessary to evaluate the effectiveness of 19 these grants in assisting students with intellectual disabilities in college transition programs. 20 11.13. (CHE: Scholarship Awards) A student may receive a Palmetto Fellows or LIFE scholarship award during the summer, in 21 addition to fall and spring semesters of an academic year, provided continued eligibility requirements are met as of the end of the 22 23 spring semester. Students must enroll full-time, which for purposes of the summer award will require enrollment in at least twelve 24 hours over the course of the summer. The summer is defined as the period between the end of the spring term and prior to the 25 opening of the fall term. The total summer award per student may not exceed half of the allowable academic year award up to the 26 cost of attendance and must be reimbursed if less than twelve hours for academic credit are not attempted by the student during summer sessions. If awarded in the summer, a student's total award during his or her enrollment may not exceed the amount that 27

would otherwise be provided under current semester limits applied for the scholarship awards. The Commission on Higher Education

30 **11.14.** (CHE: Other Funded FTE Revenue) When institutions of higher learning request additional other funded full-time 31 equivalent positions, the Executive Budget Office shall inform the Commission on Higher Education of its decision regarding the 32 request and whether or not sufficient revenues exist to fund the salary and fringe benefits for the positions.

33 11.15. (CHE: Abatements) By November first of each year, state supported institutions of higher learning must submit to the 34 Commission on Higher Education the total number of out-of-state undergraduate students during the prior fiscal year that received

35 abatement of rates pursuant to Section 59-112-70 of the 1976 Code as well as the total dollar amount of the abatements received.

36 The report must include the geo-origin of the student, class of the student, comprehensive listing of all financial awards received by

the student, number of semesters the student has received the abated rate, as well as the athletic status of the student. The report 1 2 must also include the calculation method used to determine the abatement amount awarded to students as well as the number of students that received educational fee waivers pursuant to Section 59-101-620. (CHE: Longitudinal Data Reports) By December first each year, the Commission on Higher Education is directed to provide a report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee on 13 tuition and required fee trends submitted to the commission by the state's public colleges and universities. The baseline of the report 14 15 must be the most recent fall semester compared to the previous five fall semesters. (CHE: SmartState Review Board Study) Of the funds appropriated to the Commission on Higher Education, on or before 21 December 31, 2017, the Research Centers of Excellence Review Board shall submit to the President Pro Tempore of the Senate, the 22 23 Speaker of the House of Representatives, the Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means Committee, and the Governor, written recommendations regarding a plan to sunset the SmartState Board and how best to 24 25 transition some of its responsibilities to an appropriate entity of state government for any continuing administrative program 26 management, including a minimum budget necessary for administration, as well as for oversight and/or accountability responsibilities related to awards made on or before August 1, 2017, that may remain after the SmartState Board sunsets. 27 28 **11.20.** RESERVED 29 11.21. (CHE: Prohibition of Discriminatory Practices) (A) In the current fiscal year and from the funds appropriated to the Commission on Higher Education, the commission shall print and distribute to all South Carolina public colleges and universities 30 the definition of anti-Semitism. 31 32 (B) For purposes of this proviso, the term "definition of anti-Semitism" includes: (1) a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations 33 34 of anti-Semitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions 35 and religious facilities: calling for, aiding, or justifying the killing or harming of Jews; 36

The Director of DHEC's Office of Primary Care; the Director or his designee of the 26 Department of Health and Human Services; and the Executive Director of the South Carolina Dental Association shall serve as ex 27 28 officio members without vote. This board shall serve without compensation. 29 23.2. (MUSC: Rural Access Plan) The MUSC Hospital Authority, in conjunction with the Department of Health and Human Services, shall study how to partner with existing rural hospitals to ensure that these regions maintain access to medical care. 30

31 23.3. (MUSC: Procurement Efficiency Study) The Medical University of South Carolina (MUSC), the Medical University 32 Hospital Authority (MUHA), and Procurement Services of the State Fiscal Accountability Authority are directed to work together to 33 study and make recommendations regarding the opportunity, if any, to create efficiencies, cost savings, and/or economies of scale 34 by combining some or all of any similar operations and/or procurements of the MUSC and MUHA. Findings and recommendations

34 by combining some of an of any similar operations and/of procurements of the WebSC and WebTA. Findings and recommendations 35 must be submitted to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee

25.1. (TEC: Training of New & Expanding Industry) (A) Notwithstanding the amounts appropriated in this section for readySC

6 (B) In the event projected expenditures are above the appropriation, the appropriation in this section for readySC may be 7 appropriately adjusted, if and only if, the Executive Budget Office determines that the projected expenditures are directly related to:

8 (1) an existing technology training program where the demand for the program exceeds the program's capacity and the 9 additional funds are to be utilized to meet the demand; or

(2) a new program is necessary to provide direct training for new or expanding business or industry.

11 (C) The adjustment may occur only upon approval by the Executive Budget Office. Upon the Executive Budget Office's approval 12 of the adjustment, the Director of the Executive Budget Office must certify, in writing, that the adjustment is directly related to either 13 subsection (B)(1) or (B)(2). The Director must immediately provide a copy of the written certification, including the amount of the 14 adjustment, to the President Pro Tempore of the Senate, the Speaker of the House of Representatives, the Chairman of the Senate 15 Finance Committee, and the Chairman of the House Ways and Means Committee.

(AH: Use of Proceeds) The proceeds of facilities rentals, gift shop operations, training sessions, sales of publications, reproductions of documents, repair of documents, research fees, handling charges, and the proceeds of sales of National Register of Historic Places certificates and plaques by the Archives Department shall be deposited in a special account in the State Treasury, and may be used by this department to cover the cost of facility operations and maintenance, gift shop inventory, additional training sessions, publication, reproduction expenses, repair expenses, and National Register of Historic Places certificates and plaques, and selected Historic Preservation Grants.

9 **26.2.** (AH: Disposal of Materials) For the current fiscal year, the Department of Archives and History, upon prior approval of 10 the commission, may sell from its collections certain record and non-record materials, which are not eligible for public auction, in a 11 manner most advantageous to the department.

13 SECTION 27 - H870 - STATE LIBRARY

14

15 **27.1.** (LIB: Aid to Counties Libraries Allotment) The amount appropriated in this section for "Aid to County Libraries" shall be 16 allotted to each county on a per capita basis according to the official United States Census For 2010, as aid to the County Library. No 17 county shall be allocated less than \$75,000 under this provision. To receive this aid, local library support shall not be less than the 18 amount actually expended for library operations from local sources in the second preceding year.

19 **27.2.** (LIB: Information Service Fees) The State Library may charge a fee for costs associated with information delivery and 20 retain such funds to offset the costs of maintaining, promoting and improving information delivery services.

21 **27.3.** (LIB: Continuing Education Fees) The State Library may charge a fee for costs associated with continuing education and 22 retain such funds to offset the costs of providing continuing education opportunities.

23 27.4. (LIB: Books and Materials Disposal) The State Library may sell or otherwise dispose of books and other library materials
 24 that are deemed by the State Library as no longer of value to the State of South

Carolina and the State Library's collection. Funds received from the sale of books and materials shall be retained and expended to purchase new materials for the collection. Unexpended funds may be carried forward from the prior fiscal year into the current fiscal year and be used for the same purpose.

27.5. (LIB: SCLENDS) The State Library may accept money for the South Carolina Library Evergreen Network Delivery 29 System (SCLENDS), a consortium providing patrons access to more library materials. The consortium shall allow South Carolina 30 libraries the ability to share resources and provide a forum for sharing expertise in technical areas such as systems administration 31 and cataloging. Funds received by the State Library for SCLENDS shall be placed in a special account and shall only be utilized to 32 pay for items related to SCLENDS. Unexpended funds may be carried forward from the prior fiscal year into the current fiscal year 33 and be used for the same purpose.

27.6. (LIB: Donations) The State Library may accept donation funds to be used for administration, operation, and programs
 from any donor source. Unexpended funds shall be carried forward from the prior fiscal year into the current fiscal year.

27.7. (LIB: Sale of Promotional Items) The State Library shall be allowed to sell promotional items with the South Carolina
 State Library brand and logo for the purpose of generating funds for the State Library. Unexpended funds shall be carried forward
 from the prior fiscal year into the current fiscal year.

4 27.8. (LIB: Consortium Purchasing) The State Library shall be authorized to accept funds to be used for consortium purchasing 5 between libraries (public, academic, special) that serve South Carolina residents. Funds received by the State Library for consortium 6 purchasing agreements shall be placed in a designated account and shall only be used to pay for items related to specific consortium 7 purchasing agreements. These funds may be retained, expended, and carried forward from the prior fiscal year into the current fiscal 8 year and used for the same purpose.

12 **28.1.** (ARTS: Professional Artists Contract) Where practicable, all professional artists employed by the Arts Commission in the 13 fields of music, theater, dance, literature, musical arts, craft, media arts and environmental arts shall be hired on a contractual basis 14 as independent contractors. Where such a contractual arrangement is not feasible employees in these fields may be unclassified, 15 however, the approval of their salaries shall be in accord with the provisions of Section 8-11-35 of the 1976 Code.

16 **28.2.** (ARTS: Special Revolving Account) Any income derived from Arts Commission sponsored arts events or by gift, 17 contributions, or bequest now in possession of the Arts Commission including any federal or other funds balance remaining at the 18 end of the prior fiscal year, shall be retained by the commission and placed in a special revolving account for the commission to use 19 solely for the purpose of supporting the programs provided herein. Any such funds shall be subject to the review procedures as set 20 forth in Act 651 of 1978.

21 28.3. (ARTS: Partial Indirect Cost Waiver) The commission is allowed to apply a fifteen percent indirect cost rate for continuing 22 federal grants for which they must compete. The commission shall apply the full approved negotiated rate to the Basic State Grant 23 and any new grants received by the commission.

24 **28.4.** (ARTS: Grants) The Arts Commission must expend seventy percent of appropriated state funds on grants to support the 25 statewide improvement of learning and enrichment opportunities for children and communities through educational and cultural 26 programs with proven research based strategies.

27 **28.5.** (ARTS: Distribution to Subdivisions) No later than December first of the current fiscal year, the Arts Commission must 28 report to the Chairman of the House Ways and Means Committee and the Chairman of the Senate Finance Committee the amount of 29 aid/allocations distributed to subdivisions during the most recently completed fiscal year, detailed by specific subdivisions.

SECTION 29 - H950 - STATE MUSEUM COMMISSION

29.1. (MUSM: Removal From Collections) The commission may remove accessioned objects from its museum collections by gift to another public or nonprofit institution, by trade with another public or nonprofit institution, by public sale, by transfer to the commission's education, exhibit, or study collections or to its operating property inventory; or as a last resort, by intentional destruction on the condition that the objects so removed meet with one or more of the following criteria: (1) they fall outside the

scope of the South Carolina Museum Commission's collections as defined in the Collection Policy; (2) they are unsuitable for 1 2 exhibition or research; (3) they are inferior duplicates of other objects in the collection; or (4) they are forgeries or were acquired on the basis of false information; funds from the sale of such objects will be placed in a special revolving account for the commission 3 4 to use solely for the purpose of purchasing objects for the collections of the State Museum. 5 **29.2.** (MUSM: Museum Store) The Museum Commission shall establish and administer a museum store in the State Museum. 6 This store may produce, acquire, and sell merchandise relating to historical, scientific, and cultural sources. All profits received from 7 the sale of such merchandise shall be retained by the Museum Commission in a restricted fund to be carried forward into the following 8 fiscal year. These funds may be used for store operations, publications, acquisitions, educational programs, exhibit production and general operating expenses provided that the expenditures for such expenses are approved by the General Assembly in the annual 9 10 Appropriation Act. **29.3.** (MUSM: Retention of Revenue) The Museum Commission may retain revenue received from admissions, program fees, 11 facility rentals, professional services, donations, food service, exhibits and exhibit components, and other miscellaneous operating 12 income generated by or for the museum and may expend such revenue for general operating expenses provided that such expenditures 13 are approved by the General Assembly in the annual Appropriation Act. Any unexpended revenue from these sources may be carried 14 15 forward into the current fiscal year to be expended for the same purposes. 29.4. (MUSM: School Tour Fee Prohibition) The commission may not charge admission fees to groups of children from South 16 Carolina who have made reservations that are touring the museum as part of a school function. 17 29.5. (MUSM: Dining Area Rent) Of the space currently vacant in the Columbia Mills Building, space large enough for the 18 museum to have dining space for school-aged children shall be provided to the State Museum at no cost. 19 **29.6.** (MUSM: Remittance to General Services) The State Museum is directed to remit not less than \$1,800,000 to the 20 Department of Administration as compensation for expenses associated with the premises it leases in the Columbia Mills Building.

Department of Administration as compensation for expenses associated with the premises it leases in the Columbia Mills Building. In the event the General Assembly or the Executive Budget Office implements a mid-year across-the-board budget reduction, the rent that the State Museum remits to the Department of Administration shall be reduced by the same percentage as the assessed budget reduction.

30.1. (CRR: Southern Maritime Collection) The Confederate Relic Room and Military Museum Commission, on behalf of the Hunley Commission is authorized to expend funds appropriated for such purpose to pay the outstanding note entered into to finance the purchase of the Southern Maritime Collection and the Hunley Commission will assume custody and management of the Collection for the State. The commission is authorized to use up to \$500,000 of the funds transferred for implementation of this proviso. The balance of the funds transferred may be used by the commission for costs associated with other Museum operations. The General Assembly will provide for funds in future fiscal years to cover the costs of the financing of the Southern Maritime Collection

34 Collection.

SECTION 32 - H730 - DEPARTMENT OF VOCATIONAL REHABILITATION

3 32.1. (VR: Production Contracts Revenue) All revenues derived from production contracts earned by people with disabilities receiving job readiness training at the agency's Work Training Centers may be retained by the State Agency of Vocational Rehabilitation and used in the facilities for Client Wages and any other production costs; and further, any excess funds derived from these production contracts may be used for other operating expenses and/or permanent improvements of these facilities.

32.2. (VR: Reallotment Funds) To maximize utilization of federal funding and prevent the loss of such funding to other states
 in the Basic Service Program, the State Agency of Vocational Rehabilitation be allowed to budget reallotment and other funds
 received in excess of original projections in following State fiscal years.

32.3. (VR: User/Service Fees) Any revenues generated from user fees or service fees charged to the general public or other parties ineligible for the department's services may be retained to offset costs associated with the related activities so as to not affect the level of service for regular agency clients.

32.4. (VR: Meal Ticket Revenue) All revenues generated from sale of meal tickets may be retained by the agency and expended
 for supplies to operate the agency's food service programs or cafeteria.

32.5. (VR: Basic Services Program - Educational Scholarships) For those persons with disabilities who are eligible for and are receiving services under an approved plan of the South Carolina Vocational Rehabilitation Department (consistent with the 1973 Rehabilitation Act, as amended) tuition costs at state supported institutions (four year, technical, or trade schools) will not increase beyond the 1998 tuition rate, will be provided, or will be waived by the respective institution after the utilization of any other federal or state student aid for which the student is eligible. Persons eligible for this tuition reduction or sponsorship must meet all academic requirements of the particular institution and be eligible for State need-based scholarships as defined in Chapter 142, Title 59, Code of Laws of South Carolina, 1976.

32.6. (VR: Deferred Maintenance, Capital Projects, Ordinary Repair and Maintenance) The Department of Vocational
 Rehabilitation is authorized to establish an interest bearing fund with the State Treasurer to deposit funds appropriated for deferred
 maintenance and other one-time funds from any source. After receiving any required approvals, the department is authorized to
 expend these funds for the purpose of deferred maintenance, capital projects, and ordinary repair and maintenance. These funds

26 *may be carried forward from the prior fiscal year into the current fiscal year to be used for the same purpose.*

27 <u>32.7. (VR: Licensing Requirements for Disability Examiners)</u> For the current fiscal year, the licensing requirements for 28 physicians employed by Disability Determination Services for evaluation of medical evidence for disability benefits claims shall be

29 waived, provided that physicians do not perform examinations or have any contact with claimants, and only perform Disability

30 Determination Services in order to allow the agency to expedite determinations for services provided through funding appropriated

- 31 *and authorized in this act.*

33 SECTION 33 - J020 - DEPARTMENT OF HEALTH AND HUMAN SERVICES

34

35 **33.1.** (DHHS: Recoupment/Restricted Fund) The Department of Health and Human Services shall recoup all refunds and 36 identified program overpayments and all such overpayments shall be recouped in accordance with established collection policy.

1 Further, the Department of Health and Human Services is authorized to maintain a restricted fund, on deposit with the State Treasurer,

2 to be used to pay for liabilities and improvements related to enhancing accountability for future audits. The restricted fund will

derive from prior year program refunds. The restricted fund shall not exceed one percent of the total appropriation authorization for
 the current year. Amounts in excess of one percent will be remitted to the general fund.

33.2. (DHHS: Long Term Care Facility Reimbursement Rate) The department, in calculating a reimbursement rate for long term care facility providers, shall obtain for each contract period an inflation factor, developed by the Revenue and Fiscal Affairs Office. Data obtained from Medicaid cost reporting records applicable to long term care providers will be supplied to the Revenue and Fiscal Affairs Office. A composite index, developed by the Revenue and Fiscal Affairs Office will be used to reflect the respective costs of the components of the Medicaid program expenditures in computing the maximum inflation factor to be used in long term care contractual arrangements involving reimbursement of providers. The Revenue and Fiscal Affairs Office shall update the composite

11 index so as to have the index available for each contract renewal.

12 The department may apply the inflation factor in calculating the reimbursement rate for the new contract period from zero percent 13 up to the inflation factor developed by the Revenue and Fiscal Affairs Office.

14 33.3. (DHHS: Medical Assistance Audit Program Remittance) The Department of Health and Human Services shall remit to 15 the State Auditor's Office an amount representing fifty percent (allowable Federal Financial Participation) of the cost of the Medical 16 Assistance Audit Program as established in the State Auditor's Office of the State Fiscal Accountability Authority, Section 105. 17 Such amount shall also include appropriated salary adjustments and employer contributions allocable to the Medical Assistance 18 Audit Program. Such remittance to the State Auditor's Office shall be made monthly and based on invoices as provided by the State 19 Auditor's Office of the State Fiscal Accountability Authority.

33.4. (DHHS: Third Party Liability Collection) The Department of Health and Human Services is allowed to fund the net costs
 of any Third Party Liability and Drug Rebate collection efforts from the monies collected in that effort.

33.5. (DHHS: Medicaid State Plan) Where the Medicaid State Plan has been altered to cover services that previously were provided by one hundred percent state funds, or that have been requested to be added by other state agencies, the department can bill other agencies for the state share of services provided through Medicaid. In order to comply with Federal regulations regarding allowable sources of matching funds, state agencies are authorized to make appropriation transfers to the Department of Health and Human Services to be used as the state share when certified public expenditures are not allowed for those state agency Medicaid services. The department will keep a record of all services affected and submit periodic reports to the Senate Finance and House Ways and Means Committees.

29 33.6. (DHHS: Medically Indigent Assistance Fund) The department is authorized to expend disproportionate share funds to all 30 eligible hospitals with the condition that all audit exceptions through the receipt and expenditures of these funds are the liability of 31 the hospital receiving the funds.

32 33.7. (DHHS: Registration Fees) The department is authorized to receive and expend registration fees for educational, training,
 33 and certification programs.

34 33.8. (DHHS: Fraud and Abuse Collections) The Department of Health and Human Services may offset the administrative costs
 35 associated with controlling fraud and abuse.

33.9. (DHHS: Medicaid Eligibility Transfer) The South Carolina Department of Health and Human Services (DHHS) is hereby
 authorized to determine the eligibility of applicants for the South Carolina Medicaid Program in accordance with the State Plan
 Under Title XIX of The Social Security Act Medical Assistance Program. The governing authority of each county shall provide
 office space and facility service for this function as they do for DSS functions under Section 43-3-65.
 With funds available to the department and by November first, the Director of the Department of Health and Human Services shall

6 provide the governing authority and the legislative delegation of each county with information on the condition of space furnished for this purpose and shall specifically identify any known deficiencies with respect to the accessibility requirements of the Americans with Disabilities Act (ADA). By May first, the governing authority of any county with an identified ADA-related deficiency shall report to its legislative delegation and the Director of the Department of Health and Human Services on its progress in correcting

10 such deficiency.

33.10. (DHHS: Franchise Fees Suspension) Franchise fees imposed on nursing home beds and enacted by the General Assembly
 during the 2002 session are suspended.

13 33.11. (DHHS: Program Integrity Efforts) The Department of Health and Human Services is instructed to expand its program 14 integrity efforts by utilizing resources both within and external to the agency including, but not limited to, the ability to contract with 15 other entities for the purpose of maximizing the department's ability to detect and eliminate provider fraud.

16 33.12. (DHHS: Post Payment Review) The department is directed to perform post payment reviews as permitted under Medicaid 17 regulations to ensure compliance with the Hyde Amendment provisions as it relates to the performance of medically necessary 18 services under the Medicaid program. The results of such reviews shall be available to the General Assembly upon request in a 19 format that meets the requirements of the Health Insurance Accountability and Portability Act (HIPAA) and Medicaid confidentiality 20 regulations.

33.13. (DHHS: Long Term Care Facility Reimbursement Rates) The department shall direct staff to complete and submit its 21 Medicaid State Plan Amendment for long term care facility reimbursement rates to the Director of the Department of Health and 22 23 Human Services by August first of each year. The director shall review the plan and submit to the Federal Government on or before August fifteenth of each year provided the State Appropriations Act has been enacted by that date. All additional requests for 24 information from CMS concerning the plan shall be promptly submitted to CMS by the Department of Health and Human Services. 25 26 **33.14.** (DHHS: Nursing Services to High Risk/High Tech Children) The Department of Health and Human Services shall continue a separate classification and compensation plan for Registered Nurses (RN) and Licensed Practical Nurses (LPN) who provide 27 28 services to Medically Fragile Children, who are Ventilator dependent, Respirator dependent, Intubated, and Parenteral feeding or 29 any combination of the above. The classification plan shall recognize the skill level that these nurses caring for these Medically Fragile Children must have over and above normal home-care or school-based nurses. 30

31 33.15. (DHHS: CHIP Enrollment and Recertification) The Department of Health and Human Services shall enroll and recertify 32 eligible children to the Children's Health Insurance Program (CHIP) and must use available state agency program data including, 33 but not limited to, that housed in the Revenue and Fiscal Affairs Office, to include the Department of Social Services' Supplemental 34 Nutritional Assistance Program (SNAP) and the department may use the poverty-related information from the Department of 35 Education. Use of this data and cooperative efforts between state agencies reduces the cost of outreach and maintenance of eligibility 36 for CHIP.

33.16. (DHHS: Carry Forward) The Department of Health and Human Services is authorized to carry forward and expend any 1 2 General Fund balance and any cash balances from the prior fiscal year into the current fiscal year for any earmarked or restricted trust and agency, or special revenue account or subfund. The department shall submit a comprehensive reporting of all cash balances 3 4 brought forward from the prior fiscal year. The report shall, at a minimum, for each account or subfund include the following: the 5 statutory authority that allows the funds to be carried forward, the maximum authorized amount that can be carried forward, the 6 general purpose or need for the carry forward, the specific source(s) of funding or revenue that generated the carry forward, and a 7 detailed description of any pending obligations against the carry forward. The report must be submitted to the President Pro Tempore of the Senate, Chairman of the Senate Finance Committee, Speaker of the House of Representatives, and Chairman of the House 8 Ways and Means Committee, within fifteen days after the Comptroller General closes the fiscal year. 9 **33.17.** (DHHS: Medicaid Provider Fraud) The department shall expand and increase its effort to identify, report, and combat 10 Medicaid provider fraud. The department shall publish on its' agency homepage by April first, of the current fiscal year, the results 11 of these efforts, the funds recovered, and information pertaining to prosecutions of such cases, including pleas agreements entered 12 13 into. 33.18. (DHHS: GAPS) The requirements of Article 5, Chapter 6, Title 44 shall be suspended for the current state fiscal year. 14

15 33.19. (DHHS: Contract Authority) The Department of Health and Human Services is authorized to contract with community-based not-for-profit organizations for local projects that further the objectives of department programs. The department shall develop policies and procedures and may promulgate regulations to assure compliance with state and federal requirements associated with the funds used for the contracts and to assure fairness and accountability in the award and administration of these contracts. The department may require a match from contract recipients. The department shall report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committees on the contracts administered.

33.20. (DHHS: Medicaid Accountability and Quality Improvement Initiative) From the funds appropriated and authorized to the
 Department of Health and Human Services, the department is authorized to implement the following accountability and quality
 improvement initiatives:

(A) Healthy Outcomes Initiative - The Department of Health and Human Services may tie Disproportionate Share Hospital
 (DSH) payments to participation in the Healthy Outcomes Initiative and may expand the program as DSH funding is available.

(B) To improve community health, the department may explore various health outreach, education, patient wellness and incentive programs. The department may pilot health interventions targeting diabetes, smoking cessation, weight management, heart disease, and other health conditions. These programs may be expanded as their potential to improve health and lower costs are identified by the department.

30 (C) Rural Hospital DSH Payment - Medicaid-designated rural hospitals in South Carolina may be eligible to receive up to one 31 hundred percent of costs associated with uncompensated care as part of the DSH program. Funds shall be allocated from the existing 32 DSH program. To be eligible, rural hospitals must participate in reporting and quality guidelines published by the department and 33 outlined in the Healthy Outcomes Initiative. In addition to the requirements placed upon them by the department, rural hospitals 34 must actively participate with the department and any other stakeholder identified by the department, in efforts to design an alternative 35 health care delivery system in these regions.

(D) Primary Care Safety Net - The department shall implement a methodology to reimburse safety net providers participating 1 2 in a hospital Healthy Outcomes Initiative program to provide primary care, behavioral health services, and pharmacy services for chronically ill individuals that do not have access to affordable insurance. Qualifying safety net providers are approved, licensed, 3 4 and duly organized Federally Qualified Health Centers (FQHCs and other entities receiving funding under Section 330 of the Public 5 Health Services Act), Rural Health Clinics (RHCs), local alcohol and drug abuse authorities established by Act 301 of 1973, Free Clinics, other clinics serving the uninsured, and Welvista. The department shall formulate a methodology and allocate \$3,600,000 6 7 for innovative care strategies for qualifying safety net providers. The department shall formulate a separate methodology and allocate 8 \$5,000,000 of funding to FQHCs, at least \$1,500,000 of funding for Free Clinics, and \$1,500,000 of funding for local alcohol and drug abuse authorities created under Act 301 of 1973 and up to \$4,000,000 for capital improvements to the Act 301 facilities through 9 consultation with the Department of Alcohol and Other Drug Abuse Services, to ensure funds are provided on a needs based 10 approach. The department may continue to develop and implement a process for obtaining encounter-level data that may be used to 11 assess the cost and impact of services provided through this proviso. Any newly established Community Health Center/FQHC shall 12 receive an amount equivalent to the average disbursement made to all centers/FQHCs. 13 (E) The department shall allocate funds to be used for obesity education for patients, reimbursement payments for providers, 14

(E) The department shall allocate funds to be used for obesity education for patients, reimbursement payments for providers,
 and continuing education for all providers through partnerships with the Department.

16 (F) To be eligible for funds in this proviso, providers must provide the department with patient, service and financial data to 17 assist in the operation and ongoing evaluation of both the initiatives resulting from this proviso, and other price, quality, transparency 18 and DSH accountability efforts currently underway or initiated by the department. The Revenue and Fiscal Affairs Office shall 19 provide the department with any information required by the department in order to implement this proviso in accordance with state 20 law and regulations.

(G) The department may pilot a behavioral health intervention program for wrap-around care to vulnerable mental health patients who frequent the emergency room in hotspots and underserved areas within the state. The pilot program must provide reports detailing progress on the target population and health outcomes achieved. These programs may be expanded as their potential to improve health and lower costs are identified by the department.

(H) The department shall provide funding not to exceed \$1,500,000 to establish a pilot program to expand medication assisted
 treatment (MAT) services for prescription opioid dependency and addiction, including such medical and behavioral health services
 necessary to support MAT interventions. The department shall consider evidence based interventions, recommendations made in
 the December 2014 State Plan to Prevent and Treat Prescription Drug Abuse, and scalability in the design of the pilot program. In
 consultation with the Department of Alcohol and Drug Abuse Services and the MUSC Hospital Authority, the department may
 contract with such providers that are necessary to ensure impact in a geographical area of critical need.

 $(I \underline{H})$ The department shall publish quarterly reports on the agency's website regarding the department's progress in meeting the goals established by this provision.

33.21. (DHHS: Medicaid Healthcare Initiatives Outcomes) Prior to February fifteenth of the current fiscal year, the Director of
 the Department of Health and Human Services shall make a presentation to the House Ways and Means Healthcare Budget
 Subcommittee on the outcomes of Medicaid healthcare initiatives enacted during the current fiscal year to improve the well-being of
 persons enrolled in the Medicaid program and receiving services from Medicaid providers.

33.22. (DHHS: Rural Health Initiative) From the funds appropriated to the Department of Health and Human Services for the Rural Health Initiative *in the current fiscal year*, the department shall partner with the following state agencies, institutions, and other key stakeholders to implement these components of a Rural Health Initiative to better meet the needs of medically underserved communities throughout the state. The department may leverage any and all available federal funds to implement this initiative. Recurring and non-recurring funding for the Rural Health Initiative may be carried forward by the department and expended for the same purpose.

(A) The Department of Health and Human Services shall incentivize the development of primary care access in rural and
 underserved areas, leverage Medicaid spending on Graduate Medical Education (GME) by implementing methodologies that support
 recommendations contained in the January 2014 report of the South Carolina GME Advisory Group, and continue to leverage the
 use of teaching hospitals to ensure rural physician coverage in counties with a demonstrated lack of adequate access and coverage
 through the following provisions:

(1) Rural and Underserved Area Provider Capacity - the department shall partner with the University of South Carolina
 School of Medicine to develop a statewide Rural Health Initiative to identify strategies for significantly improving health care access,
 supporting physicians, and reducing health inequities in rural communities. In addition, the department shall also contract with the
 MUSC Hospital Authority in the amount of \$1,000,000, and the USC School of Medicine in the amount of \$2,000,000 to further
 develop statewide teaching partnerships.

(2) Rural Healthcare Coverage and Education - The USC School of Medicine, in consultation with the South Carolina 17 Office of Rural Health, shall continue to operate a Center of Excellence to support and develop rural medical education and delivery 18 infrastructure with a statewide focus, through clinical practice, training, and research, as well as collaboration with other state 19 agencies and institutions. The center's activities must be centered on efforts to improve access to care and expand healthcare provider 20 capacity in rural communities. The department shall authorize at least \$1,000,000 to support center staffing as well as the programs 21 and collaborations delivering rural health research, the ICARED program, workforce development scholarships and recruitment, 22 23 rural fellowships, health education development, and/or rural practice support and education. Funding released by the department 24 pursuant to this section must not be used by the recipient(s) to supplant existing resources already used for the same or comparable 25 purposes. No later than February first of the current fiscal year, the USC School of Medicine shall report to the Chairman of the House Ways and Means Committee, the Chairman of the Senate Finance Committee, and the Director of the Department of Health 26 and Human Services on the specific uses of funds budgeted and/or expended pursuant to this provision. 27

(3) Rural Medicine Workforce Development - The department, in consultation with the Medical Education Advisory 28 Committee (MEAC), shall support the development of additional residency and/or fellowship slots or programs in rural medicine, 29 family medicine, and any other appropriate primary care specialties that have been identified by the department as not being 30 adequately served by existing Graduate Medical Education programs. The department shall ensure that each in-state member of the 31 Association of American Medical Colleges is afforded the opportunity to participate in MEAC. New training sites and/or residency 32 positions are subject to approval as specified by the Accreditation Council for Graduate Medical Education (ACGME). The 33 34 department may also accept proposals and award grants for programs designed to expose resident physicians to rural practice and enhance the opportunity to recruit these residents for long-term practice in these rural and/or underserved communities. Up to 35 \$500,000 of the recurring funds appropriated to the department for the Rural Health Initiative may be used for this purpose. 36

(4) Statewide Health Innovations - At least \$2,000,000 must be expended by the department to contract with the USC
 School of Medicine and at least \$1,000,000 to the MUSC Hospital Authority to develop and continue innovative healthcare delivery
 and training opportunities through collaborative community engagement via ICARED and other innovative programs that provide
 clinical services, mental and behavioral health services, children's health, OB/GYN services, and/or chronic disease coverage gaps.
 In consultation with the Office of Rural Health, the department must ensure collaborative efforts with the greatest potential for impact
 are prioritized.

7 (B) The department shall continue to investigate the potential use of DSH and/or any other allowable and appropriate source 8 of funds in order to improve access to emergency medical services in one or more communities identified by the department in which 9 such access has been degraded due to a hospital's closure during the past five years.

10 (1) In the current fiscal year, the department is authorized to establish a DSH pool, or carry forward DSH capacity from 11 a previous period as federally permissible, for this purpose and/or if deemed necessary to implement transformation plans for which 12 conforming applications were filed with the department pursuant to this or a previous hospital transformation or rural health initiative 13 proviso, but for which additional negotiations or development were required.  Analysis and Planning shall provide the department with any information required by the department in order to implement this

(DHHS: BabyNet Compliance) With the funds available to the department, the Department of Health and Human Services shall report to the Governor, the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and Means Committee no later than December 31, 2017 2018 on the status of the department's efforts to bring the BabyNet program into compliance with federal requirements. This report must specifically address areas in which the BabyNet program has received low performance scores and include any relevant correspondence from the U.S. Department of Education. The report must explain the department's plan for bringing BabyNet into compliance, including specific steps and the associated timeline.

35 **33.25.** (DHHS: Family Planning Waiver) With funds appropriated and authorized to the Department of Health and Human 36 Services for Fiscal Year 2018-2019, the department shall prepare and submit to the Centers for Medicare and Medicaid Services

34.15. (DHEC: Health Licensing Fee) Funds resulting from an increase in the Health Licensing Fee Schedule shall be retained 6 7 by the department to fund increased responsibilities of the health licensing programs. Failure to submit a license renewal application

8 or fee to the department by the license expiration date shall result in a late fee of \$75 or twenty-five percent of the licensing fee

Further 31 administration cost funded with other funds used in the indirect cost calculation may, based on their percentage, be retained by the 32 agency to support the remaining administrative costs of the agency. 33

34.29. (DHEC: Beach Renourishment and Monitoring and Coastal Access Improvement) If state funds are made available or carried forward from any general revenue, capital, surplus or bond funding appropriated to the department for beach renourishment and maintenance, the department shall be able to expend not more than \$100,000 of these funds annually to support annual beach profile monitoring. Additional funds made available or carried forward for beach renourishment projects that are certified by the department as excess may be spent for beach renourishment and departmental activities that advance the policy goals contained in the State Beachfront Management Plan, R.30-21.

34 34.30. (DHEC: South Carolina State Trauma Care Fund) Of the funds appropriated to the South Carolina State Trauma Care
 Fund, \$2,268,885 shall be utilized for increasing the reimbursement rates for trauma hospitals, for trauma specialists' professional
 fees, for increasing the capability of EMS trauma care providers from counties with a high rate of traumatic injury deaths to care for

The department, in conjunction with the Department of Health and Human Services, is authorized to establish a fund for the purpose of developing an emergency supply, stockpile, and distribution system of appropriate antiviral, antibiotic, and vaccine medicines and medical supplies. In the event the United States Department of Health and Human Services makes available medicines or vaccines for purchase by states via federal contract or federally subsidized contract or other mechanism, the department, with Executive Budget Office approval, may access appropriated or earmarked funds as necessary to purchase an emergency supply of these medicines for the State of South Carolina.

34.32. (DHEC: Pharmacist Services) For the current fiscal year, provisions requiring that all department facilities distributing or 20 dispensing prescription drugs be permitted by the Board of Pharmacy and that each pharmacy have a pharmacist-in-charge are 21 suspended. Each Department of Health and Environmental Control Public Health Region shall be required to have a permit to 22 23 distribute or dispense prescription drugs. A department pharmacist may serve as the pharmacist-in-charge without being physically present in the pharmacy. The department is authorized to designate one pharmacist-in-charge to serve more than one department 24 facility. Only pharmacists, nurses, or physicians are allowed to dispense and provide prescription drugs/products/vaccines for 25 26 conditions or diseases that the department treats, monitors, or investigates. In the event of a public health emergency or upon 27 activation of the strategic national stockpile, other medications may be dispensed as necessary.

34.33. (DHEC: Coastal Zone Appellate Panel) The Coastal Zone Appellate Panel as delineated in Section 48-39-40 of the 1976
 Code under the Department of Health and Environmental Control shall be suspended for the current fiscal year.

30 34.34. (DHEC: Rural Hospital Grants) Rural Hospital Grants funds shall be allocated to public hospitals in very rural or rural areas whose largest town is less than 25,000 and whose licensed bed capacity does not exceed two hundred beds. Hospitals qualifying for the grants shall utilize such funds for any of the following purposes: (a) the development of preventive health programs, medical homes, and primary care diversion from emergency departments; (b) expanded health services, including physician recruitment and retention; (c) to improve hospital facilities; (d) activities involving electronic medical records or claims processing systems; (e) to enhance disease prevention activities in diabetes, heart disease, etc; and (f) activities to ensure compliance with State or Federal regulations.

The department shall notify providers of the 6 7 suspension within thirty days of its effective date. 34.37. (DHEC: Fetal Pain Awareness) (A) The department must utilize at least one hundred dollars to prepare printed materials 8 concerning information that unborn children at twenty weeks gestation and beyond are fully capable of feeling pain and the right of 9 a woman seeking an abortion to ask for and receive anesthesia to alleviate or eliminate pain to the fetus during an abortion procedure. 10 The materials must be provided to each abortion provider in the State and must be placed in a conspicuous place in each examination 11 room at the doctor's office. The materials must contain only the following information: 12 "Fetal Pain Awareness 13 An unborn child who is twenty weeks old or more is fully capable of experiencing pain. Anesthesia provided to a woman for an 14 15 abortion typically offers little pain prevention for the unborn child. If you choose to end your pregnancy, you have a right to have anesthesia or analgesic administered to alleviate the pain to your unborn child during the abortion." 16 (B) The materials must be easily comprehendible and must be printed in a typeface large and bold enough to be clearly legible. 17 34.38. (DHEC: SCHIDS) From funds appropriated for Chronic Disease Prevention, the department shall establish a South 18 Carolina Health Integrated Data Services (SCHIDS) program to disseminate data about prevalence, treatment and cost of disease 19 from the South Carolina Health and Human Services Data Warehouse and in particular the Medicaid System. The purpose of the 20 program is to educate communities statewide about improving health and wellness through lifestyle changes. 21 22 The Revenue and Fiscal Affairs Office shall provide data needed by the SCHIDS program to fulfill its mission, and all state 23 agencies and public universities involved in educating South Carolinians through public programs for the purpose of improving health and wellness shall communicate with the program in order to improve collaboration and coordination and the possible use of 24 25 SCHIDS to assist in the evaluation of program outcomes. 26 Medicaid staff shall coordinate with the SCHIDS program staff to target Prevention Partnership Grant awards to those communities demonstrating a prevalence of chronic disease and/or lack of access to care. 27 34.39. (DHEC: Abstinence Education Contract) For the current fiscal year, funds made available to the State of South Carolina 28 under the provisions of Title V, Section 510, may only be awarded to other entities through a competitive bidding process. 29 **34.40.** (DHEC: Immunizations) The department is authorized to utilize the funds appropriated for immunizations to hire 30 31 temporary personnel to address periods of high demand for immunizations at local health departments. 34.41. (DHEC: Residential Treatment Facilities Swing Beds) For Fiscal Year 2017-18 in coordination with the South Carolina 32 Health Plan and to improve access for acute psychiatric beds as patient populations demand, Residential Treatment Facilities (RTF) 33 34 may swing up to eighteen beds per qualifying facility to accommodate patients with a diagnosis of an acute psychiatric disorder. In order to qualify to utilize swing beds a facility must meet the following criteria: the facility must currently have both licensed acute 35 psychiatric and residential treatment facility beds, the RTF beds must meet the same licensure requirements as the existing licensed 36

As part of the 14 investigation and control of the outbreak, the department will alert the appropriate healthcare providers and community members 15 using the most effective means available. 16 (C) Upon being informed of or having reason to suspect a case of tuberculosis that is capable of transmitting tubercle bacilli at a 17 school or child care center involving a student, teacher, employee, volunteer, or an individual working at the school or child care 18 center for an employer providing services to the school or child care center, the department immediately shall notify: 19 20 (1) if the case is at a school, the principal, and the Superintendent of the school district if the school is a public school; and 21 (2) if the case is at a child care center, the director of the child care center; and (D) When informing the principal of a school or the director of a child care center about a known or suspected case of tuberculosis 22 23 that is capable of transmitting tubercle bacilli as provided for in subsection (C), the department shall provide: 24 (1) an update addressing the: 25 (a) status of the investigation, including the steps the department is taking to identify the source and extent of the 26 exposure and the risks of additional exposure; and (b) steps the school or child care center must take to assist the department in controlling the spread of the tuberculosis 27 28 infection; and 29 (2) information and other resources to distribute to parents and guardians that discuss how to assist the department in 30 identifying and managing the tuberculosis infection. 34.43. (DHEC: Abstinence-Until-Marriage Emerging Programs) (A) From the funds appropriated to DHEC in this act as a 31 Special Item and titled "Abstinence-Until Marriage Emerging Programs" the department shall award a twelve month grant for 32 abstinence-until-marriage emerging programs. This funding shall be awarded by the department only to nonprofit 501(c)(3) agencies 33 34 meeting all the A-H Title V, Section 510 definitions of Abstinence Education. 35 (B) Contracts must be awarded utilizing a competitive approach in accordance with the South Carolina Procurement Code. (C) Applicants must provide a budget and budget narrative to the department that explains how the funds will be used. 36

(DHEC: Abstinence Until Marriage Evidence-Based Programs Funding) From the monies appropriated for the 11 Continuation of Teen Pregnancy Prevention, contracts must be awarded to separate private, nonprofit 501(c)(3) entities to provide 12 Abstinence Until Marriage teen pregnancy prevention programs and services within the State that meet all of the A-H Title V, Section 13 510 definitions of Abstinence Education. Contracts must be awarded utilizing a competitive approach in accordance with the South 14 Carolina Procurement Code. Proposed programs/curricula must be certified by the National Abstinence Education Association 15 (NAEA) as meeting and being in compliance with all of the Title V, Section 510 A-H requirement for abstinence-until-marriage 16 education programs. Applicants must provide a budget for the proposed project for which the application is being made. Monies 17 will be paid over a twelve month basis for services rendered. Unexpended funds shall be carried forward for the purpose of fulfilling 18 the department's contractual agreement. The programs implemented by the entity awarded a contract pursuant to this proviso may 19 not violate any portion of the South Carolina Comprehensive Health Education Act when implemented in a school setting. An entity 20 that violates any portion of the South Carolina Comprehensive Health Education Act must reimburse the State for all funds disbursed. 21 22 **34.45.** (DHEC: Wave Dissipation Device) From funds appropriated to the department for the Coastal Resource Improvement 23 program, the department shall permit a Wave Dissipation Device pilot program to be initiated. 24 The deployment of a qualified wave dissipation device seaward of the setback line or baseline pursuant to a study conducted by 25 the Citadel or a research university is not construction and meets the permitting exception contained in Section 48-39-130(D)(2). 26 Prior to deploying or expanding a qualified wave dissipation device, a person proposing to deploy or expand the device must pay the department a fee of ten cents per linear foot of the proposed deployment or expansion. The department may order the removal of all 27 or any portion of a qualified wave dissipation device that the department determines causes material harm to the flora, fauna, physical 28 or aesthetic resources of the area under Section 48-39-130(D)(2) of the 1976 Code. 29 A 'qualified wave dissipation device' is a device that: 30 31 (1) is placed mostly parallel to the shoreline;

(DHEC: Birth Center Inspections) With the funds appropriated and authorized to the Department of Health and 6 Environmental Control for this fiscal year, the department shall ensure that all licensed birth centers must register an on-call 7 agreement and any transfer policies with the Department of Health and Environmental Control. (DHEC: Abortion Clinic Certification) Prior to January 31, 2017, a facility other than a hospital that is licensed and 21 certified by the department to perform abortions must file a report with the department that provides the number of physicians that 22 23 performed an abortion at the facility between July 1, 2016 and December 31, 2016, who did not have admitting privileges at a local 24 certified hospital and staff privileges to replace on-staff physicians at the certified hospital and the percentage of these physician in 25 relation to the overall number of physicians who performed abortions at the facility. The report must include a summation of any 26 abortion that resulted in an outcome which required a level of aftercare that exceeds what is customarily provided by physicians in 27 such cases in accordance with accepted medical practice and indicate whether or not the abortion was performed by a physician with 28 admitting privileges at a local certified hospital and staff privileges to replace on-staff physicians at the certified hospital. Any summation of any abortion must not divulge any information that is privileged or required to be maintained as confidential by any 29 provision of law. An applicable facility must remit a twenty-five dollar filing fee to the department for the report required by this 30 31 provision.

34.48. (DHEC: Data Center Migration) Of the funds appropriated to the Department of Health and Environmental Control for Data Center Migration, the department must utilize the Department of Administration, Division of Technology Operations for shared services, including but not limited to, mainframe services, application hosting, servers, managed servers, storage, network services and disaster recovery services. Unexpended funds appropriated for the data center migration may be carried forward from the prior fiscal year and used for the same purpose

Unexpended funds may be carried forward into the current fiscal year to be expended for the same purpose. 18 34.52. (DHEC: Lake Conestee Dam and Reservoir) Of the funds appropriated and authorized to the Department of Health and 19 Environmental Control, the department shall appropriate up to \$185,000 to the Conestee Foundation, the owner of the Lake Conestee 20 Dam, to conduct an expert dam engineering study. The objective of this study shall be to examine alternatives for the rehabilitation 21 and/or replacement of the present Lake Conestee Dam. The study shall include all inspection, survey, engineering analysis, risk 22

calculations, sampling and environmental testing activities, and hydrologic modeling necessary to evaluate all viable alternatives, and related construction and long term care costs and other related requirements necessary to compare the alternatives in accordance with appropriate state and federal agency requirements, and customary dam engineering requirements. The study shall identify a

with appropriate state and federal agency requirements, and customary dam engineering requirements. The study shall identify a
 Final Recommended Alternative appropriate for final design and construction.

The contractor conducting the study on behalf of the Conestee Foundation shall be selected in a manner similar to state procurement standards. The panel selecting the contractor shall be made up of one representative of the Conestee Foundation, one representative from the Department of Health and Environmental Control, one representative appointed by the Greenville County Legislative Delegation, one representative appointed by the Greenwood County Legislative Delegation, and one representative appointed by the Laurens County Legislative Delegation. (DMH: Crisis Intervention Training) Of the funds appropriated to the department, \$170,500 shall be utilized for the 13 National Alliance on Mental Illness (NAMI) SC for Crisis Intervention Training (CIT). 14 35.5. (DMH: Uncompensated Patient Medical Care) There is created an Uncompensated Patient Care Fund to be used by the

15 35.5. (DMH: Uncompensated Patient Medical Care) There is created an Uncompensated Patient Care Fund to be used by the 16 department for medical costs incurred for patients. These funds may be carried forward from the prior fiscal year into the current 17 fiscal year to be used for the same purpose.

18 35.6. (DMH: Meals in Emergency Operations) The cost of meals may be provided to state employees who are required to work

The department is also authorized to retain and deposit into the fund proceeds from the sale of excess real property owned by, under the control of, or assigned to the department. After receiving any required approvals, the department is authorized to expend these funds for the purpose of deferred maintenance, capital projects, and ordinary repair and maintenance. These funds may be carried forward from the prior fiscal year into the current fiscal year to be used for the same purpose.

35.8. (DMH: Lease Payments to SFAA for SVP Program) In the current fiscal year, funds appropriated and authorized to the
 Department of Mental Health for Lease Payments to the State Fiscal Accountability Authority for the Sexually Violent Predator
 Program are exempt from any across-the-board base reductions.

The department shall follow all the policies 3 4 and procedures of the Department of Administration or State Fiscal Accountability Authority and the Joint Bond Review Committee. 5 **36.3.** (DDSN: Prenatal Diagnosis) Revenues not to exceed \$126,000 from client fees, credited to the debt service fund and not 6 required to meet the department's debt service requirement, may be expended only in the current fiscal year to promote expanded 7 prenatal diagnosis of intellectual and/or other related disabilities by the Greenwood Genetic Center. 8 **36.4.** (DDSN: Medicaid-Funded Contract Settlements) The department is authorized to carry forward and retain settlements 9 under Medicaid-funded contracts. **36.5.** (DDSN: Departmental Generated Revenue) The department is authorized to continue to expend departmental generated 10 revenues that are authorized in the budget. 11 36.6. (DDSN: Transfer of Capital/Property) The department may transfer capital to include property and buildings to local DSN 12 providers with State Fiscal Accountability Authority approval. 13 **36.7.** (DDSN: Unlicensed Medication Providers) The provision of selected prescribed medications may be performed by 14 designated unlicensed persons in community-based programs sponsored, licensed or certified by the South Carolina Department of 15 Disabilities and Special Needs, provided the unlicensed persons have documented successful completion of medication training and 16 competency evaluation. Licensed nurses, licensed pharmacists and licensed medical doctors may train and supervise designated 17 unlicensed persons to provide medications and, after reviewing competency evaluations, may approve designated unlicensed persons 18 for the provision of medications. The provision of medications by designated unlicensed persons is limited to oral, sublingual, 19 buccal, topical, inhalation and transdermal medications; ear drops, eye drops, nasal sprays, injections of regularly scheduled insulin 20 and injections of prescribed anaphylactic treatments. The provision of medications by designated unlicensed persons does not include 21 22 rectal and vaginal medications, sliding scale insulin or other injectable medications. A written or electronic record regarding each medication provided, including time and amount administered, is required as part of the provision of medication. Provision of 23 24 medication does not include judgment, evaluation or assessment by the designated unlicensed persons. The designated unlicensed 25 persons and the nurses, pharmacists and medical doctors that train, approve, and supervise these staff shall be protected against tort 26 liability provided their actions are within the scope of their job duties and the established medical protocol. The Department of Disabilities and Special Needs shall establish curriculum and standards for training and oversight. 27 This provision shall not apply to a facility licensed as an intermediate care facility for individuals with intellectual and/or related 28 29 disability. **36.8.** (DDSN: Pervasive Developmental Disorder) The Department of Disabilities and Special Needs, as the agency authorized 30 to treat autistic disorder, is designated for a Medicaid project to treat children who have been diagnosed by eight years of age with a 31 pervasive developmental disorder. The project must target the youngest ages feasible for treatment effectiveness, treatment for each 32 individual child shall not exceed three years without a special exception as defined in the waiver, and reimbursement for each 33 34 individual participant may not exceed \$50,000 per year. The Department of Disabilities and Special Needs and the Department of Health and Human Services will determine the areas of the State with the greatest need and availability of providers. Children 35

36 participating in the project will be selected based upon an application system developed in compliance with the Medicaid waiver.

SECTION 36 - J160 - DEPARTMENT OF DISABILITIES AND SPECIAL NEEDS

Treatment will be provided as authorized and prescribed by the department according to the degree of the developmental disability. 1 2 In authorizing and prescribing treatment the department may award grants or negotiate and contract with public or private entities to implement intervention programs, which must comply with Medicaid reimbursement methodologies, for children who have been 3 4 diagnosed with a pervasive developmental disorder. "Pervasive developmental disorder" means a neurological condition, including 5 autistic disorder and Asperger's syndrome, as defined in the most recent edition of the Diagnostic and Statistical Manual of Mental 6 Disorders of the American Psychiatric Association. The department shall report semi-annually to the General Assembly and the 7 Governor on the developmental progress of the children participating in the project and the fiscal status of the project, to include 8 expenditure data and appropriation balances. This provision does not establish or authorize creation of an entitlement program or benefit. 9 The Department of Disabilities and Special Needs and the Department of Health and Human Services shall develop a plan to 10 transition children in the Pervasive Developmental Disorder Program (PDD) to Medicaid State Plan services in a manner that 11 minimizes any break in service. Private insurance benefits which include Autism Spectrum Disorder services shall be sought prior 12 to the expenditure of Medicaid or State funds for these services. For children not Medicaid eligible, the Department of Disabilities 13 and Special Needs shall develop a sliding fee scale based on a means test for determining payment by a family for PDD services. 14 15 As children transition from the waiver to the Medicaid State Plan, the Department of Disabilities and Special Needs shall permanently transfer, on a quarterly basis, all uncommitted Medicaid matching funds to the Department of Health and Human 16 Services to be used for Applied Behavioral Analysis lead and line therapist services to ensure access to care. The Department of 17

Disabilities and Special Needs shall provide a report to the House Ways and Means Committee and the Senate Finance Committee within thirty days after the close of the fiscal year on the amount of funds transferred to the Department of Health and Human Services.

36.9. (DDSN: Child Daycare Centers) Of the funds appropriated to the department, the department shall provide reimbursement for services provided to department eligible children at daycare centers previously under contract prior to December 31, 2008. The reimbursement shall not be less than eighty percent of the amount reimbursed in the previous fiscal year. By September fifteenth, the department must transfer \$100,000 to the Anderson County Disabilities Board for the provision of these services.

36.10. (DDSN: Debt Service Account) The department shall utilize the uncommitted dollars in their debt service account, account
 E164660, for operations and services that are not funded in the appropriations bill. By August first, the department must report to
 the Governor, the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and Means Committee on the
 remaining balance in this account and on the amounts and purposes for which the account was used in the prior fiscal year.

36.11. (DDSN: Traumatic Brain Injury) Funds appropriated to the agency for Traumatic Brain Injury/Spinal Cord Injury Post-Acute Rehabilitation shall be used for that purpose only. In the event the department receives a general fund reduction in the current fiscal year, any reductions to the post-acute rehabilitation funding shall not exceed reductions in proportion to the agency as a whole.

33 36.12. (DDSN: Medicaid Direct Billing) The department shall facilitate Medicaid direct billing for all providers, including local 34 disabilities and special needs boards, who choose to initiate the direct billing process regardless of the receipt of capital grant funds 35 from the department for the specific facility involved. All entities receiving capital grant funds must use the funds as originally 36 specified in the award. If the purpose or use of a facility constructed or purchased with departmental grant funds is altered without

the department's approval, the entity must repay the department the amount of the funds awarded. The use of direct billing shall not 1 2 be construed as a change in the purpose or use of a facility. **36.13.** (DDSN: Carry Forward Authorization) For the current fiscal year, the department is authorized to carry forward any 3 4 balance of General Funds appropriated for the reduction of the department's waiting lists in the prior fiscal year and must utilize 5 these funds for the same purpose in the current fiscal year. Within thirty days after the close of the fiscal year, the department shall report the balance carried forward to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and 6 7 Means Committee. 8 **36.14.** (DDSN: Service Providers Expenditure Requirement) For the current fiscal year, in order to accommodate service provider infrastructure needs resulting from the reductions in the department's waiting lists, service providers including local disabilities and 9 special needs boards are authorized to carry forward from the prior fiscal year unexpended funds based on a ninety percent 10 expenditure requirement for capitated services. Service providers shall not withhold services in order to generate funds to be carried 11 forward. The expenditure requirement shall not affect the department's three month reserve limitation policy. If the department's 12 Medicaid allowable costs, in the aggregate, do not meet the level of certified public expenditures (CPEs) reported to the Department 13 of Health and Human Services, the department is allowed to recoup funds necessary to remain in compliance with federal Medicaid 14 15 CPE rules. **36.15.** (DDSN: Beaufort DSN Facility) For Fiscal Year 2017-18 2018-19, the Department of Disabilities and Special Needs is 16 authorized to retain the full amount of proceeds from the sale of the local Disabilities and Special Needs Board of Beaufort County 17 property. The funds retained from this sale must be used by the department to purchase a new property for the local Disabilities and 18 Special Needs Board in Beaufort County that more appropriately meets the needs of the individuals served. Unexpended funds may 19 be carried forward into the current fiscal year and used for the same purpose. The department must provide a status report to the 20 Beaufort County Legislative Delegation by June 30, 2018 2019, detailing the retention of any sale proceeds and/or the expenditures 21 of those funds. 22 23 24 SECTION 37 - J200 - DEPARTMENT OF ALCOHOL AND OTHER DRUG ABUSE SERVICES 25 26 **37.1.** (DAODAS: Training & Conference Revenue) The department may charge fees for training events and conferences. The revenues from such events shall be retained by the department to increase education and professional development initiatives. 27 **37.2.** (DAODAS: Gambling Addiction Services) In that gambling is a serious problem in South Carolina, the department through 28 its local county commissions may provide, from funds appropriated to the 29 department, information, education, and referral services to persons experiencing gambling addictions. 30 37.3. (DAODAS: Medicaid Match Transfer) At the beginning of the fiscal year, the Department of Alcohol and Other Drug 31 Abuse Services will transfer \$1,915,902 to the Department of Health and Human Services to meet federal Medicaid Match 32 participation requirements for the delivery of alcohol and other drug abuse services to the Medicaid beneficiary population. 33 34 37.4. (DAODAS: Carry Forward Unexpended Funds) The Department of Alcohol and Other Drug Abuse Services is authorized 35 to carry forward from the prior fiscal year into the current fiscal year unexpended funds in excess of ten percent of the agency's

SECTION 38 - L040 - DEPARTMENT OF SOCIAL SERVICES

38.1. (DSS: Fee Retention) The Department of Social Services shall recoup all refunds and identified program overpayments and all such overpayments shall be recouped in accordance with established collection policy. Funds of \$800,000 collected under the Child Support Enforcement Program (Title IV-D) which are state funds shall be remitted to the State Treasurer and credited to the General Fund of the State. All state funds above \$800,000 shall be retained by the department to fund Self-Sufficiency and Family Preservation and Support initiatives.

38.2. (DSS: Recovered State Funds) The department shall withhold a portion of the State Funds recovered, under the Title IV-D 11 Program, for credit to the general fund in order to allow full participation in the federal "set off" program offered through the Internal 12 Revenue Service, the withholding of unemployment insurance benefits through the Department of Employment and Workforce and 13 reimbursement for expenditures related to blood testing. Such funds may not be expended for any other purpose. The Department 14 of Social Services shall be allowed to utilize the State share of Federally required fees, collected from non-TANF clients, in the 15 administration of the Child Support Enforcement Program. Such funds may not be expended for any other purpose. However, this 16 shall not include Child Support Enforcement Program incentives paid to the program from federal funds to encourage and reward 17 cost effective performance. Such incentives are to be reinvested in the program to increase collections of support at the state and 18 county levels in a manner consistent with federal laws and regulations governing such incentive payments. The department shall not 19 use clerk of court incentive funds to replace agency operating funds. Such funds shall be remitted to the appropriate state 20 governmental entity to further child support collection efforts. 21

38.3. (DSS: Burial Expenses) The expenditure of funds allocated for burials of foster children and adults in the custody of the
 Department of Social Services shall not exceed one thousand five hundred dollars per burial.

38.4. (DSS: Battered Spouse Funds) Appropriations included in Subprogram II.J. entitled Battered Spouse shall be allocated through contractual agreement to providers of this service. These appropriations may also be used for public awareness and contracted services for victims of this social problem including the abused and children accompanying the abused. Such funds may not be expended for any other purpose nor be reduced by any amount greater than that stipulated by the Executive Budget Office or the General Assembly for the agency as a whole.

38.5. (DSS: Court Examiner Service Exemption) In order to prevent the loss of federal funds to the State, employees of the
 Department of Social Services whose salaries are paid in full or in part from federal funds will be exempt from serving as court
 examiners.

38.6. (DSS: TANF Advance Funds) The Department of Social Services is authorized to advance sufficient funds during each fiscal year from the Temporary Assistance for Needy Families Assistance Payments general fund appropriations to the Temporary Assistance for Needy Families Assistance Payments federal account only for the purpose of allowing a sufficient cash flow in the federal account. The advance must be refunded no later than April of the same fiscal year. Upon the advance of funds as provided herein, the Comptroller General is authorized to process the July voucher for the funding of benefit checks.

SECTION 38 - L040 - DEPARTMENT OF SOCIAL SERVICES

38.7. (DSS: Fee Schedule) The Department of Social Services shall be allowed to charge fees and accept donations, grants, and bequests for social services provided under their direct responsibility on the basis of a fee schedule. The fees collected shall be utilized by the Department of Social Services to further develop and administer these program efforts. The below fee schedule is established for the current fiscal year.

38.8. (DSS: Food Stamp Fraud) The state portion of funds recouped from the collection of recipient claims in the TANF and Food Stamp programs shall be retained by the department. A portion of these funds shall be distributed to local county offices for emergency and program operations.

38.9. (DSS: TANF - Immunizations Certificates) The department shall require all TANF applicants and/or recipients to provide proof of age appropriate immunizations for children. If such immunizations have not been administered, the department shall assist in referring applicants to appropriate county health departments to obtain the immunizations.

38.10. (DSS: County Directors' Pay) With respect to the amounts allocated to the Department of Social Services for Employee Pay Increase in this act, the Department of Social Services is authorized to allot funds for pay increases to individual county directors and regional directors in classified positions without uniformity. Pay increases for DSS county directors and regional directors shall be administered in accordance with the guidelines established by the Department of Administration for Executive Compensation System and other nonacademic unclassified employees. Any employees subject to the provisions of this paragraph shall not be eligible for any other compensation increases provided in this act.

38.11. (DSS: Use of Funds Authorization) Department investigative units shall be authorized to receive and expend funds 13 awarded to these units as a result of a donation, contribution, prize, grant, and/or court order. These funds shall be retained by the 14 department on behalf of the investigative units and deposited in a separate, special account and shall be carried forward from year to 15 year and withdrawn and expended as needed to fulfill the purposes and conditions of the donation, contribution, prize, grant, and/or 16 court order, if specified, and if not specified, as may be directed by the Director of the Department of Social Services. These accounts 17 shall not be used to supplant operating funds in the current or future budgets. The agency shall report to the Senate Finance 18 Committee and Ways and Means Committee by January thirtieth of the current fiscal year on the amount of funds received and how 19 20 expended. **38.12.** (DSS: Use of Funds Authorization) Unless specifically directed by the General Assembly, when DSS is directed to provide 21

 funds to a not-for-profit or 501(c)(3) organization, that organization must use the funds to serve persons who are eligible for services
 in one or more DSS programs.

38.13. (DSS: Grant Authority) The Department of Social Services is authorized to make grants to community-based not-for-profit organizations for local projects that further the objectives of DSS programs. The department shall develop policies and procedures and may promulgate regulations to assure compliance with state and federal requirements associated with the funds used for the grants and to assure fairness and accountability in the award and administration of these grants. The department shall require a match from all grant recipients.

38.14. (DSS: Family Foster Care Payments) The Department of Social Services shall furnish as Family Foster Care payments for
 individual foster children under their sponsorship and under kinship care:

- 31 ages 0 5 \$404 per month
- 32 ages 6 12 \$469 per month
- 33 ages 13 + \$535 per month

34 These specified amounts are for the basic needs of the foster children to include kinship care assistance. Basic needs within this

35 proviso are identified as food (at home and away), clothing, housing, transportation, education and other costs as defined in the U.S.

36 Department of Agriculture study of "Annual Cost of Raising a Child to Age Eighteen". Further, each agency shall identify and

1 justify, as another line item, all material and/or services, in excess of those basic needs listed above, which were a direct result of a

2 professional agency evaluation of clientele need. Legitimate medical care in excess of Medicaid reimbursement or such care not 3 recognized by Medicaid may be considered as special needs if approved by the sponsoring/responsible agency and shall be 4 reimbursed by the sponsoring agency in the same manner of reimbursing other special needs of foster children.

5 **38.15.** (DSS: Penalty Assessment) The Department of Social Services may impose monetary penalties against a person, facility, 6 or other entity for violation of statutes or regulations pertaining to programs, other than foster home licensing, that the department 7 regulates. Penalties collected must be remitted to the State Treasurer for deposit into the State General Fund. The department shall 8 promulgate regulations for each program in which penalties may be imposed. The regulations must include guidance on the decision to assess a penalty, the effect of failure to pay a penalty in a timely manner, and a schedule of penalty ranges that takes into account 9 severity and frequency of violations. These regulations must provide for notice of the penalty and the right to a contested case 10 hearing before a designee of or panel appointed by the director of the department. Judicial review of the final agency decision 11 concerning a penalty must be in accordance with statutes or regulations that apply to judicial review of final revocation and denial 12 decisions in that particular program. The department, in accordance with regulations promulgated pursuant to this provision, shall 13 have discretion in determining the appropriateness of assessing a monetary penalty against a person or facility and the amount of the 14 penalty. The authority to assess monetary penalties shall be in addition to other statutory provisions authorizing the department to 15 seek injunctive relief or to deny, revoke, suspend, or otherwise restrict or limit a license or other types of operating or practice 16 registrations, approvals, or certificates. 17

38.16. (DSS: Child Support Enforcement Automated System Carry Forward) The department shall be authorized to retain and carry forward any unexpended funds appropriated for the Child Support Enforcement automated system and related penalties.

38.17. (DSS: Child Support Enforcement System) From the funds appropriated in Part IA, Section 38 (II.F.), the Department of Social Services shall prepare a detailed report on the status of the Child Support Enforcement System. The report shall include, but not be limited to, actions currently being undertaken to become compliant with federal government requirements; the cost required to meet minimum federal guidelines; total funds spent so far on the system; the amount of fines assessed by the federal government associated with noncompliance; how much has been spent to satisfy actions taken by the state judicial system; and how much has been spent related to actions taken by any other entity which may have altered the amount required for meeting minimum federal guidelines. The report shall be submitted to the General Assembly by August thirty-first of the current fiscal year.

38.18. (DSS: Child Care Voucher) State funds allocated to the Department of Social Services and used for child care vouchers
 must be used to enroll eligible recipients within provider settings exceeding the state's minimum child care licensing standards. The
 department may waive this requirement on a case by case basis.

30 38.19. (DSS: Meals in Emergency Operations) The cost of meals may be provided to state employees who are not permitted to 31 leave their stations and are required to work during actual emergencies, emergency situation exercises, and when the Governor 32 declares a state of emergency.

38.20. (DSS: Day Care Facilities Supervision Ratios) For the current fiscal year, staff-child ratios contained in Regulations
 114-504(B), 114-504(C), 114-524(B), and 114-524(C) shall remain at the June 24, 2008 levels.

38.21. (DSS: Foster Care Goals) To comply with the requirements of 42 U.S.C. Section 671(a)(14) and 45 C.F.R. Section 1356.21(n), it shall be the goal of the state that the maximum number of Title IV-E funded children who will remain in foster care

for more than twenty-four months will not exceed a total of 2,617 during the fiscal year. The Department of Social Services shall 1 2 develop appropriate plans for timely permanency and use appropriate data benchmarks and targets that will achieve this goal. **38.22.** (DSS: Comprehensive Teen Pregnancy Prevention Funding) (A) From the monies appropriated for the Continuation of 3 4 Teen Pregnancy Prevention, the department must award the dollars allocated to a nonprofit 501(c)(3) entity to provide abstinence 5 first, age appropriate comprehensive approach to health and sexuality education with a goal of preventing adolescent pregnancy 6 throughout South Carolina. 7 (B) Contracts must be awarded utilizing a competitive approach in accordance with the South Carolina Procurement Code. 8 (C) The monies appropriated must be paid over a twelve month basis for services rendered. Unexpended funds shall be carried forward for the purpose of fulfilling the department's contractual agreement. 9 (D) The programs implemented by the entity awarded a contract pursuant to this proviso may not violate any portion of the South 10 Carolina Comprehensive Health Education Act when implemented in a school setting. An entity that violates any portion of the 11 South Carolina Comprehensive Health Education Act must reimburse the State for all funds disbursed. 12 38.23. (DSS: SNAP Coupons) The Department of Social Services shall continue the "Healthy Bucks" program established to 13 provide coupons that allow Supplemental Nutrition Assistance Program (SNAP) recipients to obtain additional fresh fruits and 14 vegetables when purchasing fresh produce at grocery stores or farmers markets with SNAP benefits through their EBT cards. Each 15 coupon shall allow the beneficiary to double the amount of produce purchased, up to ten dollars per month. The agency shall utilize 16 all funds received in the prior and current fiscal years from the U.S. Department of Agriculture as a bonus for reducing the error rate 17 in processing SNAP applications to fund the program. The agency shall work to identify and utilize funds as matching dollars for 18 the continued success of the "Healthy Bucks" program and shall report semi-annually to the General Assembly on the status of the 19 program. The report shall include, at a minimum, the number of recipients, counties served, and cumulative expenditure data for the 20 21 program. 22 **38.24.** (DSS: Internal Child Fatality Review Committees) For Fiscal Year 2017-18, the Director of the Department of Social Services shall create and fund Internal Child Fatality Review Committees (internal committees) pursuant to the authority granted in 23 Sections 43-1-60(3), 43-1-80, and 63-7-910(E) of the 1976 Code to allow for the rapid and expeditious review of reported child 24 25 fatalities that are reported to the Department of Social Services on suspicion of abandonment, child abuse, neglect or harm as defined 26 in Section 63-7-20. This review process will enable the department to respond to the safety needs of any surviving siblings and will lead to improvement in the department's efforts to prevent child fatalities caused by abandonment, child abuse, neglect or harm. 27 28 Each internal committee shall be composed of a board-certified child abuse pediatrician, an agent from the State Law Enforcement Division, a local law enforcement officer, a representative from the local coroner's office, and representatives from the Department 29 of Social Services. The internal committee may invite other service provider organizations as deemed necessary. The department 30 31 is authorized to provide reasonable compensation for board-certified child abuse pediatricians serving on an internal committee.

Internal committees shall have access to information and records maintained by a provider of medical care regarding a child whose

33 death is being reviewed by the internal committee, including information on prenatal care; all information and records maintained

34 by any state, county, or local government agency, including, but not limited to, birth certificates, law enforcement investigation data,

35 county coroner or medical examiner investigation data, parole and probation information and records, and information and records

36 of health agencies that provided services to the child or family. The meetings, information obtained by, reports prepared by, and

statements made before the internal committees are confidential and protected from disclosure pursuant to the Freedom of 1 2 Information Act, criminal and civil proceedings, and subpoenas as set forth in Sections 63-7-940 and 63-7-1990. **38.25.** (DSS: Tuition Reimbursement/Student Loan Repayment) The Department of Social Services is allowed to spend state, 3 federal, and other sources of revenue to provide tuition reimbursement and/or student loan repayment to aid in retaining caseworkers 4 5 and critical needs department jobs based on objective guidelines established by the State Director of the Department of Social 6 Services. 7 The department may also provide paid educational leave for any employees in an FTE position to attend class while enrolled in 8 programs that are related to the agency's mission. All such leave is at the agency head's discretion. The department may enter into an agreement with staff employed in critical need departments to repay them for their outstanding 9 student loans and/or reimburse tuition expenses. The employee must be employed in a critical needs area, which would be identified 10 at the agency head's discretion, be in a covered FTE, and not have any disciplinary actions. Participants in this program must agree 11 to remain at the department for a period of five years. The department may pay these employees up to \$7,500 each year over a 12 five-year period in accordance with a program developed by the department. Payments will be made directly to the employee at the 13 end of each year of employment. Payments cannot exceed the balance of the student loan or the cost of tuition. 14 15 38.26. (DSS: Federally Certified Child Support Enforcement System Project) In order to expedite the completion and certification of the Automated Child Support Enforcement System required by the Social Security Act (42 U.S.C. Section 654a), the Department 16 of Social Services is authorized to adopt, to the fullest extent possible, the system and operating procedures of the Delaware Transfer 17 System. To the extent the Transfer System operating processes deviate from, or are incompatible with, current South Carolina 18 practice, the department is authorized to determine the most effective and efficient practice to comply with federal requirements. 19 The department shall work with Clerks of Court to identify and prepare for the changes involved in the implementation of the Transfer 20 System which may impact their current operating practices with regards to performance of required child support functions. Pursuant 21 to the Social Security Act and S.C. Code Section 63-17-610, Clerks of Court shall utilize the federally certifiable child support system 22 23 and the state disbursement unit developed by the department to perform required child support functions. 24 **38.27.** (DSS: Wilderness Therapeutic Camps) The Department of Social Services shall make and promulgate such rules and 25 regulations relating to licensing standards and other matters as may be necessary to carry out the purposes of Title 63, Chapter 11, 26 Article 1 of the 1976 Code as applied to Wilderness Therapeutic Camps. For this purpose, a "Wilderness Therapeutic Camp" is a therapeutic camp organization or facility with an outdoor or wilderness focus that is engaged in receiving children for care and 27 28 maintenance, either part or full time, but shall not include any summer camp, day camp, or after school program, and shall also not include any other outdoor education or youth development program or facility where participants usually attend for less than 15 days, 29 and does not include any licensed residential group care organization, child caring institution or group home or facility that meets 30 the facility requirements of S.C. Code of Regulations Section 114-590. 31

32 **38.28.** (DSS: Group Home Transition) For the current fiscal year, the Department of Social Services shall provide financial and 33 administrative support and flexibility to Group Homes in order to best enable any necessary transition of services or the development 34 of new service models for children and young adults. Group Homes with young adults between the ages of 18 to 23 years residing 35 in approved and supervised independent living programs shall not be required to provide 24 hours per day face to face supervision

1	for the resident. Regulatory and contractual requirements must not be different for supervision and staff ratios when a young adult
2	aged 18 to 23 is a resident in an approved and supervised independent living program.

11	any service that conflicts with, or provide any service under circumstances that conflict with, a sincerely-held religious belief or

13	38.30. (DSS: Foster Care Child Placements) With funds appropriated and authorized to the Department of Social Services for
14	Fiscal Year 2018-19, the department shall ensure that the following provisions are implemented related to child placements. The

16	(A) If a child in foster care has been placed within the same foster home for at least 9 consecutive months and if the foster

44.1. (AGRI: Market Bulletin) The Market Bulletin shall be mailed only to those persons who request it in writing and a record of each request shall be maintained by the department. Provided further, that the Department of Agriculture is authorized to charge a yearly subscription fee to each person requesting the bulletin and may charge for classified advertisements printed in the bulletin. The funds collected pursuant to this provision shall be retained by the department to defray the costs of publication and related incidental expenses.

44.2. (AGRI: Fruit/Vegetable Inspectors Subsistence) A daily subsistence allowance of up to \$30.00 may be allowed for temporarily employed fruits and vegetables inspectors from funds generated by fruits and vegetables inspection fees and budgeted under other funds in Program IV. Marketing Services, D. Inspection Services, in lieu of reimbursements for meals and lodging expense.

44.3. (AGRI: Warehouse Receipts Guaranty Fund) The Department of Agriculture may retain and expend fifty thousand dollars
 from the Warehouse Receipts Guaranty Fund established by Section 39-22-150 of the 1976 Code as is necessary for the department
 to administer the funding of the program.

44.4. (AGRI: Weights & Measures Registration) All servicepersons required to be registered with the Department of Agriculture pursuant to the provisions of Section 39-9-65 of the 1976 Code shall pay to the department a registration fee of \$25.00. Revenues generated by this provision shall be for use by the Department of Agriculture to offset expenses incurred in administering this registration program.

44.5. (AGRI: Sale of Property Revenue) The department may retain revenues associated with the sale of the property titled to or utilized by the department, except for the State Farmers Market property, and must expend these funds on capital improvements approved by the Joint Bond Review Committee and the State Fiscal Accountability Authority. The department must continue to occupy any property until replacement capital improvements are completed.

1 **44.6.** (AGRI: Export Certification) The Department of Agriculture is allowed to charge up to \$250 for each export certification 2 of agricultural products and to retain revenues to offset expenses incurred in performing certifications.

44.7. (AGRI: Feed Label Registration) The Department of Agriculture is authorized to require the annual registration of feed labels by manufacturers and to charge a fee of \$15.00 for such registrations. Revenues generated by these fees shall be retained and used by the department to offset expenses incurred in operating the Feed Inspection Program.

44.8. (AGRI: Commodity Boards) In the current fiscal year, the provisions of the Consolidated Procurement Code related to a

45.1. (CU-PSA: Phytosanitary Certificates) Revenues collected from the issuance of phytosanitary certificates shall be retained
 by the Division of Regulatory and Public Service for the purpose of carrying out phytosanitary inspections.

(CU-PSA: Witness Fee) The Public Service Activities of Clemson University are hereby authorized to charge a witness 15 fee of \$100.00 per hour up to \$400.00 per day for each employee testifying as an expert witness in civil matters which do not involve 16 the State as a party in interest. This fee shall be charged in addition to any court prescribed payment due as compensation or 17 reimbursement for judicial appearances and deposited into a designated revenue account.

45.3. (CU-PSA: Nursery/Nursery Dealer Registration Fee) The Division of Regulatory and Public Service Programs is
 authorized to retain up to \$92,000 of revenue collected from the issuance of Nursery/Nursery Dealer Fees for the purpose of carrying
 out nursery/nursery dealer inspections. Revenue collected from this fee above \$92,000 shall be deposited into the general fund.

45.4. (CU-PSA: Retention of Fees) All revenues collected from the regulatory programs of agrichemical, plant industry and
 crop protection including: fertilizer, lime, and soil amendments registration fees; pesticide licensing fees; seed certification fees; and
 fertilizer tax/inspection fees must be retained by Clemson University PSA regulatory programs.

45.5. (CU-PSA: Pesticide Registration) All revenues collected from pesticide registration fees and revenue collected from
 structural pest control businesses for business licensing must be retained by Clemson University PSA Regulatory and Public Service
 Programs to support general regulatory, enforcement, and education programs and to carry out provisions of the South Carolina
 Pesticide Control Act and regulations related to it.

45.6. (CU-PSA: Lime Inspection Fee) The Public Service Activities of Clemson University are hereby authorized to charge an
 inspection fee of \$0.50 per ton on Agricultural Liming Materials sold or distributed in this state. Clemson University-PSA may
 retain, expend, and carry forward these funds to maintain its programs.

45.7. (CU-PSA: Livestock-Poultry Health Programs) For the current fiscal year Clemson University Public Service Activities shall maintain operation of the state Meat Inspection Program. All revenues and recoveries from USDA Food Safety Inspection Services and from USDA Animal and Plant Health Inspection Services for Clemson University PSA's Livestock-Poultry Health Programs and its departments shall be retained by Clemson University-PSA's Livestock-Poultry Health Program for purposes of carrying out the operation of its programs.

SECTION 45 - P200 - CLEMSON UNIVERSITY - PSA

45.8. (CU-PSA: Boll Weevil Eradication) For the current fiscal year Clemson University Public Services Activities shall maintain operation of the Boll Weevil Eradication Program. In the calculation of any across-the-board budget reduction mandated by the Executive Budget Office or the General Assembly, the amount appropriated for the Boll Weevil Eradication Program shall be excluded from Clemson PSA's base budget. In the event of such a reduction Clemson PSA may reduce the amount of funds appropriated for this program by an amount not to exceed the percentage associated with the mandated reduction.

6 45.9. (CU-PSA: Landplaster Inspection Fee) For the purpose of regulating its use as applied to land for crop production, 7 landplaster (gypsum), shall be defined as a product consisting chiefly of calcium sulfate with two combined water (CaSO₄ 2H₂O) 8 and is incapable of neutralizing soil acidity. It shall contain not less than seventy percent CaSO₄ 2H₂O. All registrants of landplaster 9 who sell or distribute in this state that previously were required to pay an inspection fee of \$1.50 per ton shall now pay to Clemson 10 University Regulatory Services an inspection fee of fifty cents for each ton sold. Clemson University-PSA may retain, expend, and 11 carry forward these funds from the prior fiscal year into the current fiscal year to maintain its programs.

(DNR: Publications Revenue) For the current fiscal year all revenue generated from the sale of the "South Carolina Wildlife" magazine, its by-products and other publications, shall be retained by the department and used to support the production 17 of same in order for the magazine to be self-sustaining. In addition, the department is authorized to sell advertising in the magazine 18 and to increase the magazine's subscription rate, if necessary, to be self-sustaining. No general funds may be used for the operation 19 and support of the "South Carolina Wildlife" magazine.

47.2. (DNR: Casual Sales Tax Collection) The Department of Natural Resources shall continue to collect the casual sales tax as
 contained in the contractual agreement between the Department of Revenue and the Department of Natural Resources and the State
 Treasurer is authorized to reimburse the department on a quarterly basis for the actual cost of collecting the casual sales tax and such
 reimbursement shall be paid from revenues generated by the casual sales tax.

47.3. (DNR: Proportionate Funding) Each of South Carolina's forty-six soil and water conservation districts shall receive a proportionate share of funding set aside for Aid to Conservation Districts at \$15,000 per district for general assistance to the district's program. Available funding above \$15,000 for each district will be apportioned by the Department of Natural Resources based upon local needs and priorities as determined by the board. During the fiscal year, the districts' funding may only be reduced in an amount not to exceed the percentage of each agency budget reduction. No district shall receive any funds under this provision unless the county or counties wherein the district is located shall have appropriated no less than three hundred dollars to the district from county funds for the same purposes.

47.4. (DNR: Carry Forward - Contract for Goods & Services) If any funds accumulated by the Department of Natural Resources
 Geology Program, under contract for the provision of goods and services not covered by the department's appropriated funds, are
 not expended during the preceding fiscal years, such funds may be carried forward and expended for the costs associated with the

(INDEF: Defense of Indigents Formula) The amount appropriated in this act for "Defense of Indigents" shall be apportioned among counties in accord with Section 17-3-330 of the 1976 Code, but on a per capita basis and based upon the most current official decennial census of the United States; provided that no county shall receive funding in an amount less than the amount apportioned to it as of July 1, 2005. The level of contribution of each county as of July 1, 2001, must be maintained. No county shall be permitted to contribute less money than the amount the county contributed in the prior fiscal year. Within the amount of money established for indigent defense services, the State shall set aside \$3,000,000 (Death Penalty Trial Fund) annually for use of the defense in capital cases pursuant to Section 16-3-26 of the 1976 Code, for juveniles facing the possibility of a sentence of life without parole, and for the expenses of the operation of the Commission on Indigent Defense to include salaries and operations

expenses of the Death Penalty Trial Division. The State also shall set aside \$2,500,000 annually to pay fees and expenses of private 1 2 counsel appointed in noncapital cases pursuant to Section 17-3-50 (Conflict Fund). Of the funds generated from the fees imposed under Sections 14-1-206(C)(4), 14-1-207(C)(6) and 14-1-208(C)(6) and the application fee provided in Section 17-3-30(B), on a 3 4 monthly basis, fifty percent must be deposited into the Death Penalty Trial Fund, fifteen percent must be deposited into the Conflict 5 Fund, and the remaining funds each month must be apportioned among the counties' public defender offices pursuant to Section 6 17-3-330. At the end of each fiscal year any leftover funds shall carryover to the next fiscal year. All applications for the payment of fees and expenses in capital cases shall be applied for from the Death Penalty Trial Fund which shall be administered by the 7 Commission on Indigent Defense. All applications for the payment of fees and expenses of private counsel or expenses of public 8 defenders pursuant to Section 17-3-50 shall be applied for from the Conflict Fund administered by the Commission on Indigent 9 Defense. Reimbursement in excess of the hourly rate and limit set forth in Section 17-3-50 is authorized only if the court certifies, 10 in a written order with specific findings of fact, prior to the fees being incurred, that reimbursement in excess of the rates or limit is 11 necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is 12 appropriate because the services to be provided are reasonable and necessary. If prior approval by written order of the court is not 13 obtained, no additional fees shall be paid under any circumstances. 14 15 Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant 16 and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed 17 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the 18 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the 19 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. 1 other support functions currently provided from their resources. On June thirtieth of each year, the Commission on Indigent Defense

2 shall review all outstanding obligations in this fund. Any unspent and unobligated money shall be used to pay outstanding vouchers

3 in the Death Penalty Trial Fund or the Conflict Fund, provided the designated fund has become exhausted during the year.

61.4. (INDEF: SC Appellate Court Rule 608 Appointments) The funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for Civil Court Appointments including Termination of Parental Rights, Abuse and Neglect, Probate Court Commitments, Sexually Violent Predator Act, and Post-Conviction Relief (PCR) and Criminal Conflict appointments to reimburse court appointed private attorneys and for other expenditures as specified in this provision. SC Appellate Court Rule 608 Appointments funds may not be transferred or used for any other purpose.

A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for "Termination of Parental 9 Rights" cases and "Abuse and Neglect" cases to reimburse private attorneys who are appointed by the Family Court to represent 10 guardians ad litem, children, or parents under the provisions of S.C. Code Sections 20-7-110 et seq., 20-7-1570 et seq., 20-7-1695 11 (A)(2) et seq., 20-7-7205 et seq., and 20-7-8705 (4)(a) et seq.; for "Probate Court Commitment" cases to reimburse private attorneys 12 who are appointed by the Probate Court to represent indigent persons; and for "Sexually Violent Predator" cases to reimburse private 13 attorneys who are appointed by the Circuit Court pursuant to Sections 44-48-10, et seq., to represent indigent persons. When private 14 counsel is appointed pursuant to these provisions, counsel shall be reimbursed a reasonable fee to be determined on the basis of fifty 15 dollars per hour or reimbursement may also be made on the basis of a set (flat) fee. The method of payment and the amount of the 16 set fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed two thousand dollars for any case 17 under which such private attorney is appointed. 18 A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for noncapital Post 19

A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for noncapital Post Conviction Relief Cases. Any attorney appointed shall be compensated at a rate not to exceed forty dollars per hour for time expended aut of court on d ciuty dollars non hour for time compensated in court, or on the hosis of a set (flot) for. The method of normal and

out of court and sixty dollars per hour for time expended in court, or on the basis of a set (flat) fee. The method of payment and amount of set (flat) fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed one thousand dollars in any single case.

A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" shall be used for noncapital criminal cases pursuant to Section 17-3-50 (Conflict Fund). Any attorney appointed shall be compensated at a rate not to exceed forty dollars per hour for time expended out of court and sixty dollars per hour for time expended in court, or on the basis of a set (flat) fee. The method of payment and amount of set (flat) fee will be determined by the Commission on Indigent Defense. Attorney fees shall not exceed three thousand five hundred dollars in any single felony case or one thousand dollars in any single misdemeanor case.

Reimbursement in excess of the hourly rate and limit set forth herein is authorized only if the court certifies, in a written order with specific findings of fact, prior to the fees being incurred, that reimbursement in excess of the rates or limit is necessary to provide reimbursement adequate to ensure effective assistance of counsel and reimbursement in excess of the limit is appropriate because the services to be provided are reasonable and necessary. If prior approval by written order of the court is not obtained, no additional fees shall be paid under any circumstances.

Upon a finding in ex parte proceedings that investigative, expert, or other services are reasonable and necessary for the representation of the defendant, the court shall authorize the defendant's attorney to obtain such services on behalf of the defendant and shall authorize the payment, from funds available to the Commission on Indigent Defense, of fees and expenses not to exceed

1 five hundred dollars as the court considers appropriate. Payment in excess of the five hundred dollar limit is authorized only if the

2 court certifies, in a written order with specific findings of fact, prior to the expense being incurred, that payment in excess of the

3 limit is appropriate because the services to be provided are reasonable and necessary to provide adequate defense. Payments shall

4 be made from funds appropriated for this purpose from the Commission of Indigent Defense. If prior approval by written order of

5 the court is not obtained, no additional expenses shall be paid under any circumstances.

6 Indigent defense vouchers authorized in this provision must be reviewed and paid pursuant to procedures and policies established

by the Commission on Indigent Defense. The commission shall provide a copy of the established procedures and policies to the

8 Senate Finance Committee and the House Ways and Means Committee.

9 A portion of the funds appropriated under "SC Appellate Court Rule 608 Appointments" may be used by the Commission on 10 Indigent Defense to retain, on a contractual basis, the services of attorneys qualified to handle civil and criminal court appointments,

11 to be reimbursed in accordance with applicable provisos and statutes.

12 61.5. (INDEF: Carry Forward) To offset budget reductions, the Commission on Indigent Defense may carry forward and utilize 13 any unencumbered balances available in the Appellate Conflict Fund and the SC Appellate Court Rule 608 Appointment Fund at the 14 end of the prior fiscal year.

61.6. (INDEF: Public Defender Fee) Every person placed on probation on or after July 1, 2003, who was represented by a public defender or appointed counsel, shall be assessed a fee of five hundred dollars. The revenue generated from this fee must be collected by the clerk of court and sent on a monthly basis to the Commission on Indigent Defense. However, if a defendant fails to pay this fee, this failure alone is not sufficient basis for incarceration for a probation violation. This assessment shall be collected and paid over before any other fees.

61.7. (INDEF: Defense of Indigents Civil Action Application Fee) (A) A person requesting appointment of counsel in any termination of parental rights (TPR), abuse and neglect, or any other civil court action in this state shall execute an affidavit that the person is financially unable to employ counsel and that affidavit shall set forth all of the person's assets. This affidavit must be completed before counsel may be appointed. If it appears that the person has some assets but they are insufficient to employ private counsel, the court, in its discretion, may order the person to pay these assets or a portion thereof to the Commission on Indigent Defense.

26 (B) A forty dollar application fee for appointed counsel services must be collected from every person who executes an affidavit that they are financially unable to employ counsel. The person may apply to the court, the clerk of court, or other appropriate official 27 for a waiver or reduction in the application fee. If it is determined that the person is unable to pay the application fee, the fee may 28 be waived or reduced, provided that if the fee is waived or reduced, the clerk or appropriate official shall report the amount waived 29 or reduced to the trial judge and the trial judge shall order the remainder of the fee paid by a time payment method or such method 30 as the trial judge deems appropriate. The clerk of court or other appropriate official shall collect the application fee imposed by this 31 section and remit the proceeds to the Commission on Indigent Defense on a monthly basis. The monies shall be 33 34 administered by the Commission on Indigent Defense. The clerk of court or other appropriate official shall maintain a record of all persons applying for representation and the disposition of the application and shall provide this information to the Commission on 35 Indigent Defense on a monthly basis as well as reporting the amount of funds collected or waived. 36

(C) In matters in which a juvenile is brought before a court, the parents or legal guardian of such juvenile shall execute the above 1 2 affidavit based upon their financial status and shall be responsible for paying any fee. In matters concerning juveniles, the parents or legal guardians of said juvenile, shall be advised in writing of this requirement at the earliest stage of the proceedings against said 3 4 iuvenile. 5 (D) Nothing contained above shall restrict or hinder a court from appointing counsel in any emergency proceedings or where 6 existing statutes do not provide sufficient time for an individual to complete the application process. 7 (E) The appointment of counsel, as herein before provided, creates a claim against the assets and estate of the person who is provided counsel or the parents or legal guardians of a juvenile in an amount equal to the costs of representation as determined by a 8 voucher submitted by the appointed counsel and approved by the court, less that amount that the person pays to the appointed counsel. 9 (F) Such claim shall be filed in the office of the clerk of court in the county where the person is assigned counsel, but the filing 10 of a claim shall not constitute a lien against real or personal property of the person unless, in the discretion of the court, part or all of 11 such claim is reduced to judgment by appropriate order of the court, after serving the person with at least thirty days' notice that 12 judgment will be entered. When a claim is reduced to judgment, it shall have the same effect as judgments, except as modified by 13 this provision. 14 15 61.8. (INDEF: Exemption for Pass Through Funding) The funds distributed by the Commission on Indigent Defense to the Legal Services Corporation in accordance with Section 14-1-204 of the 1976 Code shall not be considered part of the commission's 16 budget for purposes of calculating budget reductions. 17 61.9. (INDEF: Reporting Requirement) Circuit Public Defenders shall provide, in a manner and form as the agency head 18 requires, information and data concerning caseloads, dispositions, and other information as required by the agency head or General 19 Assembly. The agency shall withhold payments and transfers to Circuit Public Defenders who are not in compliance with the agency 20 reporting requirements. 21 61.10. (INDEF: Donation Carry Forward) The Commission on Indigent Defense may accept donations for the publication of 22 23 "The South Carolina Juvenile Collateral Consequences Checklist." All revenue derived from donations received at the Commission on Indigent Defense shall be retained, carried forward and expended according to agreement reached between the donor, or donors, 24 25 and the Commission on Indigent Defense. 26 61.11. (INDEF: Capital Case Contract Attorneys) Funds appropriated from the Death Penalty Trial Fund may be used by the commission to retain, on a contractual basis, the service of attorneys qualified to provide representation in capital proceedings to 27 28 include: capital trials, post-conviction relief actions, re-sentencing, appeals or any other capital litigation proceeding. The commission shall establish all policies, procedures and contract provisions as it deems appropriate for the implementation of 29 the system, including but not limited to the selection and compensation of contract awardees. 30 31 61.12. (INDEF: Optional Courts and Indigent Representation) If a municipality has or elects to have an optional municipal court

32 system, it must provide adequate funds for representation of indigents. No public defender shall be appointed in any such court 33 unless the municipality and the office of the circuit public defender have reached an agreement for indigent representation and no

34 funds allocated to the commission shall be used to provide compensation for appointed counsel in municipal courts.

SECTION 62 - D100 - STATE LAW ENFORCEMENT DIVISION

62.1. (SLED: Special Account Carry Forward) Funds awarded to the State Law Enforcement Division by either court order or from donations or contributions shall be deposited in a special account with the State Treasurer, and shall be carried forward from year to year, and withdrawn from the Treasurer as needed to fulfill the purposes and conditions of the said order, donations or contributions, if specified, and if not specified, as may be directed by the Chief of the State Law Enforcement Division. Funds expended from the special account must be annually reported by October first to the Senate Finance Committee and the Ways and Means Committee.

62.2. (SLED: Computer/Communications Center Carry Forward) Revenue generated from the operation of the division's
 criminal justice computer/communications center and not expended during the prior fiscal year may be carried forward and expended
 for the same purpose during the current fiscal year.

62.3. (SLED: Agents Operations Carry Forward) Any unexpended balance on June thirtieth, of the prior fiscal year, in Part IA,
 subsection 62 of the section "Agents Operations" may be carried forward and expended for the same purpose in the current fiscal
 year.

62.4. (SLED: Match for Federal Grants Carry Forward) State appropriations to SLED that are required to provide match for
 federal grant programs in the prior fiscal year may be carried forward into the current fiscal year and expended for the same purpose
 as originally appropriated.

62.5. (SLED: Clothing Allowance) The State Law Enforcement Division is hereby authorized to provide agents and criminalists
 with an annual clothing allowance (on a pro rata basis) not to exceed \$600 per agent/criminalist for required clothing used in the line
 of duty.

62.6. (SLED: Witness Fee) The State Law Enforcement Division is hereby authorized to charge a witness fee of \$130.00 per hour up to \$1,000 per day for each employee testifying in civil matters which do not involve the State as a part in interest. This fee shall be charged in addition to any court prescribed payment due as compensation or reimbursement for judicial appearances and deposited into a designated revenue account.

62.7. (SLED: Commissioned Officers' Physicals) The department is authorized to pay for the cost of physical examinations for department personnel who are required to receive such physical examinations prior to receiving a law enforcement commission.

62.8. (SLED: Meals in Emergency Operations) The State Law Enforcement Division may provide meals to employees of SLED
 who are not permitted to leave assigned duty stations and are required to work during deployment, emergency simulation exercises
 and when the Governor declares a state of emergency.

62.9. (SLED: Hazardous Materials Security Detail) The State Law Enforcement Division (SLED) is authorized to be reimbursed
 for security related law enforcement services provided to entities authorized to transport sensitive materials within the borders of
 South Carolina. SLED shall determine all costs associated with security details and is authorized to coordinate the collection,

retention, and distribution to any assisting agency. SLED and each assisting agency shall expend any funds associated with minimizing risks related to the transportation of these hazardous materials for the implementation of homeland security initiatives.

35 **62.10.** (SLED: Sex Offender Registry Fee) Each Sheriff is authorized to charge and collect an annual amount of one hundred

36 fifty dollars from each sex offender required to register by law. If such sex offender has been declared indigent by the Sheriff of the

1 county in which the offender must register and provides proof of the declaration at the time of registration, the fee will automatically

2 be waived. If an offender is not declared indigent and fails to pay the fee, he is officially declared unregistered. This fee shall be

and the remaining fifty dollars remitted by the Sheriffs to SLED on a quarterly basis. These funds must be used to support the

6 **62.11.** (SLED: Private Detective Fees Criminal History Checks) The State Law Enforcement Division is authorized to charge 7 private detective companies, individual private detectives, private security companies, armed security guards, and proprietary 8 security companies a fee of twenty-five dollars to process state criminal history checks and fifty dollars for federal fingerprint based 9 criminal history checks. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement 10 Division.

62.12. (SLED: CWP Instructors Certification) The State Law Enforcement Division is authorized to charge one hundred dollars for the issuance of a Certified Concealable Weapons Permit Instructor certificate, and one hundred dollars every three years for each renewal. These funds shall be collected, retained, expended and carried forward by the State Law Enforcement Division.

62.13. (SLED: Expungement Requests) The State Law Enforcement Division is authorized to collect a twenty-five dollar expungement fee for each request to expunge criminal records. These funds shall be used to offset the operational and research expenses associated with processing these expungement requests. SLED is authorized to collect, retain, expend, and carry forward these funds. Persons found not guilty by a court of competent jurisdiction or where charges have been dismissed or nolle prossed

18 shall be excluded from the fee requirement.

62.14. (SLED: Retention of Funds Reimbursed by State or Federal Agencies) The State Law Enforcement Division is authorized to
 collect, expend, retain, and carry forward all funds received from other state or federal agencies in the current fiscal year as
 reimbursement of expenditures incurred in the current or prior fiscal year.

62.15. (SLED: Monies Associated with Illegal Gaming Devices) The State Law Enforcement Division is authorized to retain,
 expend, and carry forward all monies associated with illegal gaming devices seized by the division, once orders of destruction and
 awarding of these monies have been received from a court of competent jurisdiction.

62.16. (SLED: Private Detective/Security Fee) The license and registration fees set by the State Law Enforcement Division for
 private detective businesses, private security businesses, including employees of these businesses, and companies which provide
 private security on their own premises must not exceed those fees set by regulation as of January 1, 2011, unless otherwise approved
 by the General Assembly. From the funds collected from these fees, the State Law Enforcement Division must transfer \$480,000 to
 the Department of Public Safety which shall be used for the purpose of providing security in the Capitol Complex area.

62.17. (SLED: Criminal Record Search Fees) The State Law Enforcement Division is authorized to charge and collect a fee of eight dollars for a criminal record search for local park and recreation volunteers through a commission, municipality, county, or the South Carolina Department of Parks, Recreation, and Tourism. Any organization that is authorized to receive the reduced fee must not charge the volunteer, member, or employee more than the eight dollars or any additional fee that is not required by the State Law Enforcement Division. All criminal record searches conducted under this provision must be for a volunteer, memtor,

35 member or employee performing in an official capacity of the organization and must not be resold.

SECTION 62 - D100 - STATE LAW ENFORCEMENT DIVISION

62.18. (SLED: Compensatory Payment) In the event a State of Emergency is declared by the Governor, exempt employees of the 1 2 State Law Enforcement Division may be paid for actual hours worked in lieu of accruing compensatory time, at the discretion of the Chief, and providing funds are available. 3 4 62.19. (SLED: Meth Lab Clean Up Carry Forward) Any unexpended balance on June thirtieth of the prior fiscal year, in the special line "Meth Lab Clean Up" may be carried forward and expended for agency law enforcement operations in the current fiscal 5 6 vear. 7 62.20. (SLED: CWP Renewal and Replacement) A concealed weapons permit may not be suspended by a state official, agent, or 8 employee supported by state funds if the permit holder has initiated a renewal or replacement application and the processing and issuance of a renewal or replacement permit is delayed for administrative reasons. A concealed weapons permit remains valid during 9 the pendency of the renewal or replacement process so long as the application for replacement renewal is submitted prior to the 10 expiration of the permit. 11 12 62.21. (SLED: Drug Lab Electronic Mandatory Reporting System) Of the funds appropriated for Meth Lab Clean Up, the State Law Enforcement Division is authorized to expend such funds for the development and implementation of a statewide electronic 13 mandatory reporting system for municipal, county and state governmental entities to report information, as directed by the State Law 14 15 Enforcement Division, pertaining to the discovery or seizure of methamphetamine laboratories and dumpsites. 62.22. (SLED: Mandatory Meth Lab Reporting) If a municipal, county, or state governmental entity locates, finds, or seizes a 16 methamphetamine laboratory or dumpsite within the State, the governmental entity shall report the incident within three business 17 days to the State Law Enforcement Division. 18 The State Law Enforcement Division shall determine the reporting mechanism and is authorized to request, receive, catalogue, 19 classify, and maintain all information it determines necessary pertaining to the laboratory or dumpsite including, but not limited to, 20 the location, the type of manufacturing method used, and suspect information. The State Law Enforcement Division shall maintain 21 information related to these governmental reports on its website, which must be made available to the public, and is authorized to 22 23 use funds appropriated for Meth Lab Clean Up towards the prudent maintenance of information reported. 24 A governmental entity that fails to report information to the State Law Enforcement Division pursuant to this proviso is ineligible 25 to receive public safety grants that are funded through the South Carolina Public Safety Coordinating Council pursuant to Section 26 23-6-520(2) of the 1976 Code. 27 62.23. (SLED: First Responder PTSD Treatment) From the funds provided for First Responder PTSD Treatment, the State Law 28 Enforcement Division shall distribute fifty percent to the South Carolina Law Enforcement Assistance Program to reimburse law 29 enforcement officers who incur mental injury as a result of a critical incident during the scope of employment for actual out-of-pocket expenses not covered through worker's compensation claims and/or other insurance and can also be utilized to provide services 30 31 through the South Carolina Law Enforcement Assistance Program. The State Law Enforcement Division shall distribute fifty percent to the South Carolina State Firefighters Association for the South Carolina Firefighter Assistance Support Team to reimburse 32 firefighters and emergency medical technicians who incur mental injury as a result of a critical incident during the scope of 33 34 employment for actual out-of-pocket expenses not covered through worker's compensation claims and/or other insurance and can also be utilized to provide services through the South Carolina Firefighter Assistance Support Team. The State Law Enforcement 35

36 Division shall promulgate any administrative regulations necessary to carry out the provisions of this section.

SECTION 63 - K050 - DEPARTMENT OF PUBLIC SAFETY

63.1. (DPS: Special Events Traffic Control) The highway patrol must not charge any fee associated with special events for maintaining traffic control and ensuring safety on South Carolina public roads and highways unless approved by the General Assembly. Nothing shall prohibit the Treasury of the State from accepting voluntary payment of fees from private or public entities to defray the actual expenses incurred for services provided by the Department of Public Safety.

63.2. (DPS: Retention of Private Detective Fees) The Department of Public Safety is hereby authorized to receive, expend, retain, and carry forward all funds transmitted from SLED related to fees charged and collected by SLED from license and registration fees for private detective businesses, private security businesses, including employees of these businesses, and companies which provide private security on their own premises. The funds transferred are to be used in the Bureau of Protective Services Program to provide security for state agencies and the Capitol Complex.

63.3. (DPS: Motor Carrier Advisory Committee) From the funds appropriated and/or authorized to the Department of Public Safety and the Department of Motor Vehicles, the departments are directed to jointly establish a Motor Carrier Advisory Committee to solicit input from the Trucking Industry and other interested parties in developing policies and procedures for the regulation of this industry. The members of the advisory committee shall serve without compensation.

63.4. (DPS: Sale of Real Property) At such time as any portion of the Laurens Road property in Greenville is declared to be 16 surplus by the agency or agencies which occupy said portion, and after receiving approval from the Department of Administration 17 or State Fiscal Accountability Authority, for the sale of the property, the Department of Public Safety, the Department of 18 Transportation, and the Department of Motor Vehicles are authorized to receive, retain, expend, and carry forward funds derived 19 from the sale of the real property in which each agency holds an interest or title. No portion of the property may be declared as 20 surplus by one agency if another agency is occupying said property. The Department of Public Safety is directed to use these funds 21 22 to defray the operating expenses of the Highway Patrol and the Department of Transportation and the Department of Motor Vehicles 23 are directed to use their portion of these funds for department operating expenses. 24

63.5. (DPS: CMV Driver Rest Areas) A joint working group is to be established between the Department of Transportation, Department of Public Safety, State Transport Police and the South Carolina Trucking Association to review and evaluate where critical rest areas may be made available for commercial motor vehicle drivers to park and obtain their federally mandated required rest.

63.6. (DPS: SC Law Enforcement Officers Hall of Fame Scholarships) The Department of Public Safety is hereby authorized to accept donations from the public in order to provide scholarships to the children of law enforcement officers killed in the line of duty. The South Carolina Law Enforcement Officers Hall of Fame Advisory Committee is authorized to set the criteria for awarding such scholarships. All revenue received for this purpose shall be used to provide scholarships and shall be retained, carried forward, and expended for the same purpose.

63.7. (DPS: Body Cameras) The Department of Public Safety is authorized to retain and carry forward unexpended funds
 associated with body cameras from the prior fiscal year into the current fiscal year and expend those funds for the same purpose.

63.8. (DPS: Overtime Pay) For Fiscal Year 2017-18 the current fiscal year, the department is authorized and required to pay
 current non-exempt law enforcement officers by October first for any compensatory time earned and not used in the prior fiscal year.

SECTION 63 - K050 - DEPARTMENT OF PUBLIC SAFETY

The funds for this compensation must be provided from available personal services and/or employer contributions funds carried 1 2 forward from the prior fiscal year. If the amount of carried forward funds is not sufficient to pay all the non-exempt law enforcement officers accrued compensatory time, the agency shall pay the officers on a percentage distribution based on the hours owed per officer 3 4 up to the total amount that the agency has carried forward. 5 6 SECTION 64 -N200 - LAW ENFORCEMENT TRAINING COUNCIL 7 8 64.1. (LETC: CJA-Federal, Other Flow Through Funds) In order to complete projects begun in a prior fiscal year, the Law Enforcement Training Council, Criminal Justice Academy is authorized to expend federal and earmarked funds in the current fiscal 9 vear for expenditures incurred in the prior fiscal year. 10 64.2. (LETC: CJA-Retention of Emergency Expenditure Refunds) The Law Enforcement Training Council, Criminal Justice 11 Academy is authorized to collect, expend, retain, and carry forward all funds received from other state or federal agencies in the 12 current fiscal year as reimbursement of expenditures incurred in the current or prior fiscal year when personnel and equipment are 13 mobilized and expenses incurred due to an emergency. 14 15 64.3. (LETC: CJA-Unexpended FY 2017-18 General Funds) The Law Enforcement Training Council, Criminal Justice Academy, is authorized to carry forward unexpended general funds from the prior fiscal year into the current fiscal year to complete 16 Village Dorm restroom repairs and technology upgrades for the training program. 17 18 19 **SECTION 65 - N040 - DEPARTMENT OF CORRECTIONS** 20 21 **65.1.** (CORR: Canteen Operations) Revenue derived wholly from the canteen operations within the Department of Corrections on behalf of the inmate population, may be retained and expended by the department for the continuation of the operation of said 22 23 canteens and the welfare of the inmate population or, at the discretion of the Director, used to supplement costs of operations. The canteen operation is to be treated as an enterprise fund within the Department of Corrections and is not to be subsidized by state 24 25 appropriated funds. **65.2.** (CORR: E.H. Cooper Trust Fund) Any unclaimed funds remaining in any inmate account, after appropriate and necessary 26 steps are taken to determine and contact a rightful owner of such funds, shall be deposited into the Inmate Welfare Fund. 27 65.3. (CORR: Instructional Salaries) The certified instructional personnel of the Department of Corrections shall receive a 28 percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel 29 throughout the State. 30 31 65.4. (CORR: Funding Through State Criminal Assistance Program) All funds received by the State from the United States Department of Justice, State Criminal Alien Assistance Program, for care and custody of illegal aliens housed in the state correctional 32 facilities shall be retained by the South Carolina Department of Corrections to offset incurred expenses. 33 34 65.5. (CORR: Remedial Education Funding) A criminal offender committed to the custody of the Department of Corrections, who has been evaluated to function at less than an eighth grade educational level, or less than the equivalent of an eighth grade 35 educational level, may be required by department officials to enroll and actively participate in academic education programs. Funds 36

appropriated to the Department of Corrections for educational programs shall be prioritized to assure such remedial services are
 provided.

65.6. (CORR: Tire Retreading Program Restriction) The tire retreading program at the Lieber Correctional Institution shall be
 limited to the marketing and sale of retreads to state governmental entities.

65.7. (CORR: Social Security Administration Funding) All funds received by the South Carolina Department of Corrections from the Social Security Administration under Section 1611 (e)(1)(I) of the Social Security Act, which provides payment for information regarding incarcerated Social Security Insurance recipients, shall be retained by the South Carolina Department of Corrections and credited to a fund entitled "Special Social Security" for the care and custody of inmates housed in the state correctional facilities.

10 **65.8.** (CORR: Medical Expenses) The Department of Corrections shall be authorized to charge inmates a nominal fee for any 11 medical treatment or consultation provided at the request of or initiated by the inmate. A nominal co-pay shall be charged for 12 prescribed medications. Inmates shall not be charged for psychological or mental health visits.

65.9. (CORR: Prison Industry Funds) The Director of the Department of Corrections, at his discretion, is hereby authorized to utilize prison industry funds for projects or services benefiting the general welfare of the inmate population or to supplement costs of operations. These funds may be carried forward from the prior fiscal year into the current fiscal year to be used for the same purpose.

65.10. (CORR: Reimbursement for Expenditures) The Department of Corrections may retain for general operating purposes any
 reimbursement of funds for expenses incurred in a prior fiscal year.

65.11. (CORR: Sale of Real Property) Funds generated from the sale of real property owned by the Department of Corrections
 shall be retained by the department to offset renovation and maintenance capital expenditures.

65.12. (CORR: Funds From Vehicle Cleaning) Monies generated by inmates engaged in the cleaning and waxing of private
 vehicles, or any other adult work activity center, shall be placed in a special account and utilized for the welfare of the inmate
 population.

65.13. (CORR: Release of Inmates) The Director of the Department of Corrections and other persons having charge of prisoners who are required to serve a period of six months or more, may release all such prisoners, including prisoners to whom Section 24-13-150(A) of the 1976 Code applies, on the first day of the month in which their sentences expire, and if the first day of the month falls on a Saturday, Sunday, or a legal holiday, such prisoners may be released on the last weekday prior to the first of the month which is not a holiday.

65.14. (CORR: Western Union Funding) All funds received by the South Carolina Department of Corrections from the Western
 Union Quick Collect Revenue Sharing Program or similar private sector entities, which provides payment for processing electronic
 transfers into the E.H. Cooper Trust Fund, shall be retained by the South Carolina Department of Corrections and credited to a fund

32 entitled "Inmate Welfare Fund" to be expended for the benefit of the inmate population.

65.15. (CORR: Monitoring Fees) The Department of Corrections is authorized to charge an inmate who participates in community
 programs a reasonable fee for the cost of supplying electronic and telephonic monitoring. The fees charged may not exceed the
 actual cost of the monitoring.

65.16. (CORR: Inmate Insurance Policies) The Department of Corrections may collect and record private health insurance 1 2 information from incarcerated individuals. The department may file against any private insurance policy covering an inmate to recoup any health care expenditures covered by the policy. Health care will be provided in accordance with law and standards 3 4 regardless of whether or not an inmate is covered by insurance. 65.17. (CORR: Work Release Transportation Fee) The South Carolina Department of Corrections is authorized to charge a \$4.00 5 6 per day transportation fee to participants in the work release program only when such transportation is provided by the department. 7 Monies collected shall be credited to the South Carolina Department of Corrections, and utilized solely to fund transportation of 8 work release participants and vehicle replacement for the work release program. 65.18. (CORR: Special Assignment Pay Level 2 & 3 Facilities) Funds appropriated for special assignment pay at the Department 9 of Corrections are for the purpose of addressing vacancies and turnover of staff by providing a pay differential for certain employees 10 assigned to institutions with a Level II or Level III security designation. The funds are to be used for special assignment pay only 11 and may not be transferred to any other program. If the employee leaves one of the qualifying job classes or leaves a Level II or 12 Level III institution for a non-Level II or non-Level III facility, they shall no longer be eligible for this special assignment pay. Only 13 employees in full-time equivalent positions are eligible for this special assignment pay. 14 15 The special assignment pay is not a part of the employee's base salary and is as determined by the Director of the Department of Corrections at Level II and Level III institutions: 16 17 (1) Cadets: (2) Correctional Officers, including Class Code JD-30 (Officer I and II positions); 18 (3) Corporals I and II; 19 (4) Sergeants and Lieutenants; 20 (5) Captains and Majors; 21 22 (6) Nursing Staff;

- (7) Food Services Staff; and 23 24
 - (8) Warden.

25 65.19. (CORR: Quota Elimination) Pursuant to Section 24-3-60 of the 1976 Code, upon notification by the county, the 26 Department of Corrections shall accept newly sentenced inmates from each local jail and detention center.

For sentenced inmates who the county is willing to transport, the department may limit the acceptance at the Kirkland Correctional 27

Institution to the hours of 8:00 a.m. to 1:00 p.m., Monday through Friday, excluding holidays, and at the Perry and Lieber Correctional 28

Institutions to the hours of 8:00 a.m. to 10:30 a.m., Monday through Friday, excluding holidays. 29

By mutual agreement between the Department of Corrections and a local jail or detention center, the department may establish an 30 31 alternate admissions schedule for receiving inmates at the Reception and Evaluation Center.

At the time of transfer of the inmate to the department, the county shall provide the sentencing order, and if available copies of 32

medical screening records, booking reports, and other documents to assist the department in its intake processing. Counties that have 33

34 not completed medical screenings at the time of transfer shall not be required to do so.

In the event there are inadequate beds within the Reception and Evaluation Center, the Department of Corrections may create a 35 "jail" within the Kirkland Correctional Institution using one or more of the available 192-bed housing units to accept newly sentenced 36

1 state inmates who are awaiting R & E processing. The department may operate such "jail," to the extent feasible, in accordance with

2 standards applicable to the local jails.

3 The department shall use the funds appropriated in this act for "Quota Elimination" to accomplish this initiative and to open a

4 96-bed unit at the MacDougall Correctional Institution and the 192-bed housing units at Kirkland Correctional Institution. The funds

5 may not be transferred to any other program or used for any other purpose.

6 65.20. (CORR: Public/Private Partnerships for Construction) Funds appropriated in Act 407 of 2006, item 23, shall be used to
 7 construct as many multi-purpose buildings at Department of Corrections institutions as possible. For such facilities at Lieber,
 8 McCormick, Leath, Perry, or Allendale Correctional Institution, at least \$150,000 in matching funds and/or construction materials
 9 or services must be donated before construction of the facility may begin. At other Department of Corrections locations, the Director
 10 may require that donated funds and/or materials or services equal one-half of the cost of construction, including design and

11 engineering costs.

65.21. (CORR: Inmate Barbering Program) Inmate barbers in the Inmate Barbering Program at the Department of Corrections,
 shall not be subject to the licensing requirement of Section 40-7-30 of the 1976 Code.

65.22. (CORR: Executed Inmate Autopsy) For the current fiscal year, the autopsy requirements of Section 17-7-10 of the 1976
 Code are suspended when an inmate is executed by the Department of Corrections pursuant to a valid order of the Supreme Court of
 South Carolina.

65.23. (CORR: Recoupment of Expenses Associated with Inmate Cremation) If the Department of Corrections incurs expenses
 for cremating and disposing of an unclaimed deceased inmate, the department may recoup all associated costs of cremation, including
 transportation, through the deceased inmate's E.H. Cooper account, providing funds are available.

65.24. (CORR: Credited Jail Time; DNA Sample Collection) Inmates committed to the Department of Corrections for sentences 20 greater than ninety days, but who have credit for jail time in excess of their sentence to incarceration are not required to be transported 21 to the Reception and Evaluation Center of the Department of Corrections. Cities and counties housing inmates who have credit for 22 23 jail time in excess of their sentence may, through written agreement with the Department of Corrections, transfer required 24 commitment records to the department electronically or by other means. The Department of Corrections must establish reasonable 25 documentation requirements to facilitate the implementation of this cost savings measure. Employees of the Department of 26 Probation, Parole and Pardon Services assigned to the court or employees of the Department of Corrections, as applicable, shall obtain DNA samples from the offenders who are required to submit DNA samples. This provision does not exempt the above 27 28 referenced inmates from the \$250 DNA fee as required by Section 23-3-670 of the 1976 Code. The \$250 fee shall be collected in the same manner as other fines and fees and submitted to the State Treasurer for remittance to SLED. 29

30 65.25. (CORR: Cell Phone Interdiction) The Director of the Department of Corrections is granted the right to add a surcharge to 31 all inmate pay phone calls to offset the cost of equipment and operations of cell phone interdiction measures. The surcharge will be 32 added to the cost per call, collected by chosen telephone vendor and paid to the department on a monthly basis. The department is 33 authorized to retain the funds to pay, either directly or through the State lease program, for equipment required to enact cell phone 34 interdiction or retrieval <u>or for critical security needs</u>. When the equipment has been paid in full, the surcharge amount will be 35 for the department of the surcharge amount will be

35 reviewed and adjusted to cover the cost of ongoing operational expenses of the interdiction equipment. Any unexpended balance

may be carried forward from the prior fiscal year into the current fiscal year and be used for the same purpose <u>or for critical security</u>
 <u>needs</u>.

65.26. (CORR: Correctional Institution Maintenance and Construction) For maintenance and construction activities funded in the current fiscal year, the Department of Corrections may utilize inmate labor to perform any portion of the work on its own grounds and facilities. The provisions of Section 40-11-360(A)(9) of the 1976 Code shall apply to any such project, including new construction.

65.27. (CORR: Meals in Emergency Operations) The Department of Corrections may provide meals to public employees who
 are not permitted to leave their stations and are required to work during actual emergencies, emergency simulation exercises, or when
 the Governor declares a state of emergency.

65.28. (CORR: Prohibition on Funding Certain Surgery) (A) The Department of Corrections is prohibited from using state funds or state resources to provide a prisoner in the state prison system sexual reassignment surgery; however, if a person is taking hormonal therapy at the time the person is committed to the Department of Corrections, the department shall continue to provide this therapy to the person as long as medically necessary for the health of the person.

14 (B) As used in this provision:

15 (1) 'Hormonal therapy' means the use of hormones to stimulate the development or alteration of a person's sexual 16 characteristics in order to alter the person's physical appearance so that the person appears more like the opposite gender;

17 (2) 'Sexual reassignment surgery' means a surgical procedure to alter a person's physical appearance so that the person 18 appears more like the opposite gender.

19 **65.29.** (CORR: CBD Pilot Program) Of the funds appropriated or authorized to the Department of Corrections, the department 20 shall initiate a study committee with MUSC, DHHS, and DMH to explore the use of cannabidiol oil, also known as CBD oil, in a 21 therapeutic manner for eligible incarcerated individuals. The committee shall review applicable laws to include 45 CFR 46, related

to research authorized for use on prisoners and the federal protections created for prisoners as subjects of biomedical and behavioral

research and develop criteria, eligibility, guidelines, policy recommendations, and an overview of the necessary federal approvals

24 and boards required for the administration of a pilot program. Upon completion of the study, a report must be submitted to the

25 Chairman of the House Ways and Means Committee and the Chairman of the Senate Finance Committee that details the process

26 and procedures involved, potential outcomes and cost savings, and feasibility of establishing a pilot program to allow use of CBD

27 oil in a therapeutic manner for eligible incarcerated individuals.

65.30. (CORR: Video Bond Conferencing) In the current fiscal year, and from the funds appropriated to the Department of
 Corrections, the video conferencing bond system shall be used for all bond hearings for inmates incarcerated at Lieber Correctional
 Institution and charged with criminal offenses in Dorchester County.

66.1. (DPPP: Sale of Equipment) All revenue generated by the Department of Probation, Parole and Pardon Services from the
 sale of various equipment in excess of \$575, less the cost of disposition incurred by the Department of Administration, may be
 retained and carried forward into the current fiscal year and expended for the purpose of purchasing like items.

66.2. (DPPP: Interstate Compact Application Fee) The department may charge offenders an application fee set by the department, not to exceed the department's actual costs, to offenders applying for transfers out of or into the state under the Interstate Compact Act. The application fee shall be retained by the department to offset the cost of the Interstate Compact Act. All unexpended funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.3. (DPPP: GED Learn and Earn Program) From the funds appropriated in Part IA, the department may enter into agreements with statewide colleges, technical colleges, and school districts for the purpose of providing GED and GED Prep education to offenders. Offenders of the department enrolled in the program must repay the department the cost of the course and materials within six months of obtaining their GED.

66.4. (DPPP: Sex Offender Monitoring Carry Forward) The Department of Probation, Parole and Pardon Services is authorized
 to carry forward any unexpended funds in the Sex Offender Monitoring program. These funds must be used for the sex offender

If it is determined that the offender is indigent, this fee must be waived. The fee shall be retained by the department to offset the cost of drug testing. All unexpended funds at year-end may be retained and carried forward by the department to be expended for the same purpose.

66.6. (DPPP: Public Service Employment Set-Up Fee) In addition to any other fee, the department may charge an adult offender

67.2. (DJJ: Interstate Compact Revenue) The revenue returned to the Interstate Compact Program shall be retained and carried
 forward into the current fiscal year by the agency and expended for the operation of the program.

67.3. (DJJ: Children's Projects Revenue) Funds generated from the projects undertaken by children under the supervision of the
 Department of Juvenile Justice may be retained by the department and utilized for the benefit of those children. Such funds may be
 carried forward into the following fiscal year.

67.4. (DJJ: Instructional Salaries) The certified instructional personnel of the Department of Juvenile Justice shall receive a
 percentage increase in their annual salary for the current fiscal year equal to the percentage allocated to the instructional personnel
 throughout the State.

SECTION 67 - N120 - DEPARTMENT OF JUVENILE JUSTICE

67.5. (DJJ: Reimbursements for Expenditures) The Department of Juvenile Justice may retain for general operating purposes 1 2 any reimbursement of funds for expenses incurred in a prior fiscal year. 67.6. (DJJ: Juvenile Arbitration/Community Advocacy Program) The amount appropriated and authorized in this section for the 3 4 Juvenile Arbitration Program shall be retained and expended by the Department of Juvenile Justice for the purpose of providing juvenile arbitration services through the sixteen Judicial Circuit Solicitors' offices in the state and used to fund necessary 5 6 administrative and personnel costs for the programs. The Department of Juvenile Justice shall contract with Solicitors to administer the Juvenile Arbitration Program and disburse up 7 to \$60,000 per Judicial Circuit based on services rendered. The amount payable to Solicitors may vary based on consistent adherence 8 to established statewide program guidelines to assess program performance. 9 The \$250,000 appropriated for the Community Advocacy Program in the first Judicial Circuit, will be used to fund necessary 10 administrative and personnel costs for this status offender diversion program. The Department of Juvenile Justice shall monitor and 11 provide support to this program. 12 All unexpended funds may be retained and carried forward from the prior fiscal year to be used for the same purposes. 13 67.7. (DJJ: Sale of Real Property) After receiving approval from the Department of Administration or State Fiscal Accountability 14 Authority, for the sale of property, the department is authorized to retain revenues associated with the sale of department-owned real 15 property and may expend these funds on capital improvements reviewed by the Joint Bond Review Committee and approved by the 16 State Fiscal Accountability Authority. 17 67.8. (DJJ: Sale of Timber) The Department of Juvenile Justice is hereby authorized to sell mature trees and other timber suitable 18 for commercial purposes from lands owned by the department. Prior to such sales, the director shall consult with the State Forester 19 to determine economic and environmental feasibility and to obtain approval for such sales. Funds derived from timber sales shall be 20 retained and utilized for family support services after setting aside a reasonable amount, as determined by the State Forester, for 21 22 reforestation of the lands from which the trees and timber are sold. 23 **67.9.** (DJJ: Drug Free Workplace) The critical mission of the Department of Juvenile Justice requires a safe and drug free work environment. In order to accomplish this, the department may conduct and pay for the cost of pre-employment drug testing and 24 25 random employee drug testing. The department is authorized to expend funds in order to provide or procure these services. 26 67.10. (DJJ: Definition of Juveniles) The Department of Juvenile Justice is authorized to place juveniles in marine and wilderness programs or other community residence programs operated by nongovernmental entities. Juveniles receiving services in these 27 community residence programs must either be referred to such a program by the Family Court as a condition of probation, released 28 to such a program by the Board of Juvenile Parole, or voluntarily agree to be assigned and released to such a program by the 29 Department of Juvenile Justice. 30 31 67.11. (DJJ: Adult Education - GED) Juveniles committed to the Department of Juvenile Justice who have been enrolled in, but not yet completed, a GED educational program while at the department, at the discretion of the local school district, upon release 32 from the department shall be allowed to enroll in either the juvenile's local school district's regular education program, in their 33 34 appropriate grade placement, or allowed to enroll in that district's or county's adult education program. If enrolled in an adult education program, the juvenile's eligibility for taking the GED shall be based upon the regulations promulgated by the Department 35

36 of Education for youth who are confined in, or under the custody of, the Department of Juvenile Justice.

SECTION 67 - N120 - DEPARTMENT OF JUVENILE JUSTICE

67.12. (DJJ: Local District Effort) Upon commitment or confinement to a Department of Juvenile Justice facility, the school 1 2 district in which that child resides shall pay an amount equivalent to the statewide average of the local base student cost (thirty percent), multiplied by the appropriate pupil weighting set forth in Section 59-20-40, for instructional services provided to 3 4 out-of-district students to the Department of Juvenile Justice for the time period in which the child is committed or confined to a 5 department facility. EFA funding for school districts is provided for a one hundred eighty day school year. The billing provided by the department shall be calculated by dividing the 6 7 local base student cost by two hundred twenty-five days to determine the daily rate. The department shall notify the school district 8 in writing within forty-five calendar days that a student from the nonresident district is receiving education services pursuant to this provision. The notice shall also contain the student's name, date of birth, disabling condition if available, and dates of service. 9 The invoice shall be paid within sixty days of billing, provided the department has provided a copy of the invoice to both the 10 superintendent and the finance office of the school district being invoiced. Should the school district fail to pay the invoice within 11 sixty days, the department can seek relief from the Department of Education. The Department of Education shall withhold EFA 12 funding equal to the billing from the district refusing to pay and submit the funding (equal to the invoice) to the department. If 13 adequate funding is not received, the department shall have the flexibility to use funds from other programmatic areas to maintain 14 15 an appropriate level of service. 67.13. (DJJ: Early Release Authorization) In order to avoid unconstitutional levels of overcrowding and other unconstitutional 16 conditions from occurring in facilities operated by the department and in residential programs operated for the department, the 17 number of children housed in residential placements (either committed to the custody of the Department of Juvenile Justice or who 18 are under the department's supervision) shall not exceed the number of beds available to the department to house them. Should 19 appropriation reductions necessitate that the department close any additional facility, program, or housing unit it operates, or to be 20 unable to fund any additional residential program operated for its benefit, the department is authorized and empowered to release 21 from its residential placements sufficient numbers of children committed to its custody or supervision for a status offense, a 22 23 misdemeanor offense, other than Assault and Battery of a High and Aggravated Nature and Assault with Intent to Kill, or for violation 24 of probation/contempt of a status offense or a misdemeanor offense, other than Assault and Battery of a High and Aggravated Nature 25 and Assault with Intent to Kill, so that the number of children in its custody or under its supervision and placed in these residential 26 placements does not exceed the number of housing units/beds available to properly house those children. No child adjudicated delinquent for a violent crime as defined in Section 16-1-60 of the 1976 Code, a felony offense as defined in Section 16-1-90 of the 27 28 1976 Code, or a sexual offense shall be released pursuant to this proviso.

The positions designated as (Interim) shall denote a temporary employee and the salary is for a period of six months to be paid at that rate only while the General Assembly is in session. The positions designated as (Interim) shall denote a temporary employee and the salary is for a period of six months to be paid at that rate while the General Assembly is not in session. The positions designated (PTT) shall denote part-time temporary employees on a twelve-months basis. The positions designated (PPT) shall denote permanent part-time employees retained for full-time work for a period of months or the duration of the legislative session.

(LEG: Legislative Employee BPI/Merit) Legislative employees designated (P) or (PPT) shall receive base pay and average 16 merit pay in the same manner as such pay is granted to classified state employees, but for purposes of this paragraph, the term 17 "legislative employees" does not include employees of the House of Representatives. (DOA: Developmental Disabilities Council) Of the funds appropriated to the Department of Administration, Office of Executive Policy and Programs, \$50,000 must be used as state match for the Developmental Disabilities Council federal grant. These funds shall be excluded from the Department of Administration's base budget calculation of any across-the-board agency base reductions mandated by the Executive Budget Office or General Assembly.

93.2. (DOA: CCRS Evaluations & Placements) The amount appropriated in this section under Special Items Children's Case 10 Resolution System for Private Placement of Handicapped School-Age Children must be used for expenses incurred in the evaluation 11 of children referred to the CCRS to facilitate appropriate placement and to pay up to forty percent when placement is made in-state 12 and up to thirty percent when placement must be made out-of-state of the excess cost of private placement over and above 13 one-per-pupil share of state and local funds generated by the Education Finance Act, and the one-per-pupil share of applicable federal 14 funds; provided it has been established that all other possible public placements are exhausted or inappropriate. "Dolly" Cooper Veterans Cemetery Carry Forward) The Department of Administration, Office of Executive 19 Policy and Programs, Veterans' Affairs Program may carry forward unexpended funds appropriated and/or authorized for the M.J. 20 "Dolly" Cooper Veterans Cemetery from the prior fiscal year and shall use such funds for the same purpose. In addition, any 21 unexpended funds in the Veterans' Affairs Program, including Special Line Items, shall be carried forward from the prior fiscal year 22 23 into the current fiscal year and used for operation of the M.J. If it is determined that sufficient net proceeds are not to be derived from the sale of its property on Key Road to cover the 23 cost of all renovations of the Telecommunications Center, the property on Key Road shall not be sold. Any proposed sale hereunder 24 shall, prior to said sale, be submitted to the Department of Administration for approval as being in compliance with the requirements 25 of this subsection. 26 The Department of Corrections shall be authorized to retain the net proceeds from the sale of the residence provided for the Commissioner of the Department of Corrections and use such proceeds for deferred maintenance needs at the Department of 27 28 Corrections. 95.5. (LTG: Home and Community-Based Services) State funds appropriated for Home and Community-Based Services shall 1 2 be used to fund those services that most directly meet the goal of allowing seniors to live safely and independently at home. Allowable services as defined in the Lieutenant Governor's State Plan include: group dining, home delivered meals, transportation 3 4 to group dining sites, transportation for essential trips, personal care (formerly Home Care Level I), homemaker (formerly Home 5 Care Level II), Home Chore, Home Modification, Legal Assistance, and Assessments. Area Agencies on Aging (AAAs) may expend 6 no more than ten percent for administrative services and one-quarter of one percent shall be retained by the Lieutenant Governor's 7 Office on Aging to provide monitoring and oversight of the program. However, up to three percent of the annual state appropriation for Home and Community-Based Services may be retained at the Lieutenant Governor's Office on Aging to be allocated by the 8 Lieutenant Governor's Office on Aging to the affected regions in cases of an emergency and/or natural disaster recognized by the 9 Governor. If these funds are not utilized in the fiscal year allocated, they are to be treated as carry forward funds and reallocated to 10 the AAAs. 96.3. (SS: Charitable Funds Act Misrepresentation Violations) The Secretary of State shall refer to the Attorney General for investigation under Section 33-56-145 of the Solicitation of Charitable Funds Act any person who is alleged to have violated the misrepresentation provisions of Section 33-56-120 of the Act, and who has been fined \$10,000 or more for those violations.

SECTION 97 - E120 - OFFICE OF COMPTROLLER GENERAL

10 97.1. (CG: Signature Authorization) The Comptroller General is hereby authorized to designate certain employees to approve, 11 in his stead, disbursement documents authorizing payment, and the State Treasurer is hereby authorized to accept such approved 12 disbursement documents when notified by the Comptroller General. This provision shall in no way relieve the Comptroller General 13 of responsibility.

97.2. (CG: GAAP Implementation & Refinement) It is the intent of the General Assembly that the State of South Carolina issue 14 financial statements in conformance with Generally Accepted Accounting Principles (GAAP). To this end, the Comptroller General 15 is directed, as the State Accounting Officer, to maintain an Enterprise Information System for State Government (SCEIS) that will 16 result in proper authorization and control of agency expenditures, including payroll transactions, and in the preparation and issuance 17 of the official financial reports for the State of South Carolina. Under the oversight of the General Assembly, the Comptroller 18 General is given full power and authority to issue accounting policy directives to state agencies in order to comply with GAAP. The 19 Comptroller General is also given full authority to conduct surveys, acquire consulting services, and implement new procedures 20 required to implement fully changes required by GAAP. 21

97.3. (CG: Payroll Deduction Processing Fee) There shall be a fee for processing payroll deductions, not to exceed twenty-five cents, for insurance plans, credit unions, deferred compensation plans, benefit providers, and professional associations per deduction per pay day. This fee shall not be applied to charitable deductions. Vendors and other third parties receiving payroll deductions shall bear the entire cost of this fee, at no cost to state employees. The revenues generated from these fees and those provided for child support deductions in accordance with Section 63-17-1460(C), South Carolina Code of Laws, 1976, as amended, may be used to support the operations of the Office of Comptroller General and any unexpended balance may be carried forward from the prior fiscal year to the current fiscal year and utilized for the same purposes.

97.4. (CG: Unemployment Compensation Fund Administration) The lesser of two percent or \$200,000 of the fund balance of
 the Unemployment Compensation Fund shall be paid out annually to the Office of Comptroller General to be used by that agency to
 recover the costs of administering the fund. The Unemployment Compensation Fund is provided for in Section 41-31-820, South
 Carolina Code of Laws, 1976, as amended. Any unexpended balance may be carried forward from the prior fiscal year to the current
 fiscal year and used for the same purposes.

97.5. (CG: Purchasing Card Rebate Program) The Office of Comptroller General is authorized to retain the first \$100,000 of
 rebate associated with the Purchasing Card Program and \$200,000 of agency incentive rebates.

SECTION 97 - E120 - OFFICE OF COMPTROLLER GENERAL

The funds retained may be used to support the operations of the Office of Comptroller General and any unexpended balance may 2 be carried forward from the prior fiscal year into the current fiscal year and be utilized for the same purposes.

SECTION 98 - E160 - OFFICE OF STATE TREASURER

98.1. (TREAS: Nat'l. Forest Fund - Local Govt. Compliance) In order to conform to federal requirements local governments 6 7 receiving distributions of National Forest Fund revenues are required to report annually to the State Treasurer indicating compliance 8 with authorized purposes.

98.2. (TREAS: STARS Approval) Decisions relating to the Statewide Accounting and Reporting System (STARS) and the 9 South Carolina Enterprise Information System (SCEIS) which involve the State Treasurer's Banking Operations and other functions 10 of the State Treasurer's Office shall require the approval of the State Treasurer. 11

98.3. (TREAS: Investments) The State Treasurer may pool funds from accounts for investment purposes and may invest all 12 monies in the same types of investments as set forth in Section 11-9-660. 13

98.4. (TREAS: Management Fees) The State Treasurer is authorized to charge a fee for the operating and management costs 14 associated with the Local Government Investment Pool, the Deferred Compensation Program, the Tuition Prepayment Program, and 15 the College Investment Program and is further authorized to retain and expend the fees to provide these services. The fees assessed 16

may not exceed the cost of the provision of such services. 17

98.5. (TREAS: Investment Management Fees) Unless otherwise prohibited by law, the State Treasurer may charge a fee for the 18 operating and management costs associated with the investment management and support operations of various state funds and 19 programs, and further, may retain and expend the fees to provide these services. The fees assessed may not exceed the actual cost 20 of the provision of these services or the earnings on these investments. 21

22 98.6. (TREAS: Debt Management Cost Allocation) Unless otherwise prohibited by law, the State Treasurer may charge actual 23 costs associated with the administration and management of the indebtedness of the State, its agencies and institutions, and further, may retain and expend any amounts so allocated to provide these services. Costs associated with the original issuance of bonds and 24 25 other indebtedness must be assessed on an hourly basis, must be taken from the costs of issuance of any bond issue or other indebtedness, and must not exceed the actual cost of providing these services. Ongoing costs of administration and maintenance 26 27 must be assessed against expenses of debt service, and must not exceed the actual costs of providing these services.

28 98.7. (TREAS: Withheld Accommodations Tax Revenues) Before noncompliant expenditures and penalties withheld pursuant to Sections 6-4-35(B)(1)(a) and (b) are reallocated, the Tourism Expenditure Review Committee must certify to the Office of State 29 Treasurer that the time period for an appeal of the committee's action to the Administrative Law Court has expired or that the action 30 31 of the committee has been upheld or overturned by the Administrative Law Court. Noncompliant expenditures and penalties withheld must be reallocated annually after August first. Allocations withheld must be reallocated proportionately based on the most recent 32 completed fiscal year's total statewide collections of the accommodations tax revenue according to the Office of State Treasurer 33 34 records. Each annual reallocation of withheld funds to non-offending counties and municipalities must be calculated separately then 35 combined if necessary. Each reallocation to a county or municipality calculated less than a dollar must be transferred to the General 36 Fund of the State.

98.8. (TREAS: Tuition Prepayment Program) The South Carolina Tuition Prepayment Program shall not accept any new enrollment in the current fiscal year. The annual increase in tuition for the purposes of the Tuition Prepayment Program, for an institution cannot exceed seven percent per year from the 2006-07 level. To the extent that actual tuition for an institution exceeds an annual growth of seven percent per year since Fiscal Year 2006-07, colleges and universities must grant a waiver of the difference to the designated beneficiary and shall not pass along this difference to any student.

98.9. (TREAS: Penalties for Non-reporting) If a municipality fails to submit the audited financial statements required under
 Section 14-1-208 of the 1976 Code to the State Treasurer within thirteen months of the end of their fiscal year, the State Treasurer
 must withhold all state payments to that municipality until the required audited financial statement is received.

9 If the State Treasurer receives an audit report from either a county or municipality that contains a significant finding related to 10 court fine reports or remittances to the Office of State Treasurer, the requirements of Proviso 117.51 shall be followed if an amount 11 due is specified, otherwise the State Treasurer shall withhold twenty-five percent of all state payments to the county or municipality 12 until the estimated deficiency has been satisfied.

13 If a county or municipality is more than ninety days delinquent in remitting a monthly court fines report, the State Treasurer shall 14 withhold twenty-five percent of state funding for that county or municipality until all monthly reports are current.

After ninety days, any funds held by the Office of State Treasurer will be made available to the State Auditor to conduct an audit of the entity for the purpose of determining an amount due to the Office of State Treasurer, if any.

98.10. (TREAS: Signature Authorization) The State Treasurer is hereby authorized to designate certain employees to sign
 payments for the current fiscal year in accordance with Section 11-5-140 of the 1976 Code to meet the ordinary expenses of the
 State. This provision shall in no way relieve the State Treasurer of responsibility.

98.11. (TREAS: Unclaimed Property) The State Treasurer may not expend funds to retain a third party, private sector auditor, or auditing firms to fulfill his duties pursuant to the South Carolina Uniform Unclaimed Property Act on a contingency basis or any basis other than an hourly basis, with the exception that the State Treasurer may join other state(s) in multi-state contingent fee auditors' examinations, not to include companies whose parent company is headquartered or incorporated in South Carolina, when there is a reason to believe that those companies being audited are holding funds belonging to South Carolina citizens. The Office of State Treasurer shall retain \$200,000 from the Unclaimed Property Program for the sole purpose of employing internal compliance auditors to enforce the Unclaimed Property Act.

98.12. (TREAS: Municipality Accommodations Tax Withholdings) If the State Treasurer is withholding accommodations tax 27 28 revenue distributions to a municipality due to an expenditure the Tourism Expenditure Review Committee determined to be in 29 noncompliance, then the municipality may refund an amount equivalent to the amount determined to be in noncompliance to the municipality's accommodations tax fund from the municipality's general fund. If the municipality certifies to the Tourism 30 Expenditure Review Committee that the amount has been refunded, the State Treasurer shall refund the withheld funds to the 31 municipality's general fund. The expenditure of funds refunded to the municipality's accommodations tax fund and any subsequent 32 expenditures are subject to review by the Tourism Expenditure Review Committee. Prior to notification to the State Treasurer of 33 34 noncompliance by a municipality, the Tourism Expenditure Review Committee must notify the municipality if an expenditure is found to be in noncompliance. If the committee informs the municipality of an expenditure determined to be in noncompliance and 35

(ADJ: Educational Seminar Revenue) All revenue earned from educational seminars shall be retained by the agency to be 1 2 used for the printing of materials and other expenses related to conducting the seminars. The balance of funds shall be reported annually to the General Assembly. 3 4 100.8. (ADJ: Retention of Lease Property Revenue) The Adjutant General is authorized to lease all real property under the control 5 of SCMD. All revenue generated by the lease program may be retained for SCMD armory operations and maintenance as authorized 6 by the Adjutant General or Deputy Adjutant General. 7 100.9. (ADJ: Billeting and Dining Facility Operations) All revenues collected by the Billeting and Dining Facility operations at 8 the R.L. McCrady Training Center shall be retained and expended in their its budgeted operations. Expenditures from these funds shall be determined by the Billeting Committee for Billeting operations and the Deputy Adjutant General for state operations for the 9 **Dining Facility operation**. 10 **100.10.** (ADJ: EMD Compensatory Payment) In the event a State of Emergency is declared by the Governor, exempt employees 11 of the Emergency Management Division may be paid for actual hours worked in lieu of accruing compensatory time, at the discretion 12 of the Agency Director, and providing funds are available. 13 100.11. (ADJ: Civil Air Patrol) The funds appropriated in this section for the Civil Air Patrol shall be expended by the Civil Air 14 Patrol so as to discharge the state's obligations in conjunction with the Civil Air Patrol as outlined in the SARDA Plan, the South 15 Carolina Operational Radiological Emergency Response Plan, and to assist county and local authorities and other state agencies as 16 permitted by the regulations governing the Civil Air Patrol. All expenditures for equipment and services shall be in accordance with 17 state fiscal policies. 18 100.12. (ADJ: Parking Lot Revenues-Columbia Armory, Buildings and Grounds) The Adjutant General may control and 19 contractually lease the Columbia Armory, and its buildings and grounds parking facilities during events at the University of South 20 Carolina's Williams-Brice Stadium. Funds derived wholly from the rental of the Columbia Armory, and its buildings and grounds 21 22 parking facilities may be retained by the Adjutant General's Office and used for the Funeral Caisson and for SCMD operations, 23 including matching federal funds and armory maintenance and operations. These funds may not be used for any other purpose. 24 **100.13.** (ADJ: Emergency Commodities) The Emergency Management Division shall be allowed to rotate and replace water, 25 Meals Ready to Eat (MREs), and other essential emergency commodities housed in the state's Logistic Center through the provision of said commodities to neighboring states, counties, municipalities and other state agencies, and shall be allowed to accept 26 compensation for said commodities not to exceed replacement costs. (ADJ: State Guard Activation) In the event of activation of the State Guard of the South Carolina National Guard to 19 State Active Duty, the Office of the Adjutant General is authorized to compensate State Guard personnel at a rate of \$150 per day 20 and to also compensate such personnel for meal per diem as authorized by National Guard and State policy. 21 100.19. (ADJ: Disasters Expenditure Status Report) The Emergency Management Division of the Office of the Adjutant General 22 23 shall prepare a quarterly report on the status of the expenditure of the funds appropriated in the current fiscal year or in a previous fiscal year for FEMA Match for the 2015 Flooding, for Hurricane Matthew, and for the Pinnacle Mountain Fire. The quarterly report 24 25 must include, but is not limited to, expenditure by category of work by state/local and by county and shall be submitted to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee beginning September 30, 26 27 2017 2018. 100.20. (ADJ: 2017 Hurricane Irma and 2014 Ice Storm FEMA Match) The Office of Adjutant General, Emergency 30 Management Division shall be authorized to utilize existing fund balances to provide the non-federal cost share to state and local 31 government entities for work that is eligible under the Federal Emergency Management Agency Public Assistance Program for 32 Hurricane Irma. legal costs and costs for upgrading the Statewide Voter Registration System. Any balance in the Sale of Lists Account on June

101.5. (ELECT: Budget Reduction Exemption) Funds appropriated for recurring and nonrecurring general and primary election expenses are exempted from mandated across the board reductions. In addition, in the calculation of any across the board agency base reductions mandated by the Executive Budget Office or the General Assembly, the amount of funds appropriated for recurring

6 and nonrecurring primary and general election expenses shall be excluded from the agency's base budget.

101.6. (ELECT: Primary and General Election Carry Forward) Filing fees received from candidates filing to run in statewide or special primary elections may be retained and expended by the State Election Commission to pay for the conduct of primary elections. Any balance in the filing fee accounts on June thirtieth, of the prior fiscal year may be carried forward and expended for the same purposes during the current fiscal year. In addition, any balance in the Primary and General Election Accounts on June thirtieth, of the prior fiscal year may be carried forward and expended for the same purposes during the current fiscal year. In addition, the aforementioned funds may also be utilized to conduct the Presidential Preference Primary elections.

13 **101.7.** (ELECT: Training & Certification Program) All members and staff of County Boards of Voter Registration and Elections 14 will receive a common curriculum to include core courses on the duties and responsibilities of county boards of voter registration 15 and elections and electives to promote quality service and professional development. The State Election Commission shall make 16 these courses available in various locations, including but not be limited to, the upstate, coastal, and midlands areas of the state. Up 17 to \$35,000 of revenue generated by charging a fee to attend these courses may be retained and expended by the South Carolina 18 Election Commission to help cover the cost of providing the training. Any balance in the training and certification account on June 19 thirtieth, of the prior fiscal year may be carried forward and expended for the same purpose during the current fiscal year.

Unexpended funds shall be carried forward from the 6 prior fiscal year and shall be utilized for special primaries, runoffs, and elections. (ELECT: Use of Election Funds) Funds appropriated to the Election Commission for the purpose of conducting elections shall not be used for any other purpose unless specifically authorized in this act. However, up to \$200,000 may be transferred to 9 other operating accounts from General Election accounts upon approval from the Executive Budget Office, which shall then notify 10 the Chairman of the Senate Finance Committee, the Chairman of the House Ways and Means Committee, and the Governor of such 11 transfer of funds. 12 101.12. (ELECT: Statewide Voting System Reserve Fund) Of the funds appropriated for the New Statewide Voting System, there 13 is created within the State Election Commission the Statewide Voting System Reserve Fund. (RFAO: Election File Merge) In order to assist the County Registration and Election Commissions to ensure that registered voters are assigned to proper election districts, the Revenue and Fiscal Affairs Office, in conjunction with the South Carolina Election 32 Commission, shall merge the voter registration file with the office's Geocoded Address List and the district boundaries of the 33 34 Congress, South Carolina Senate, South Carolina House of Representatives, county councils, and such other districts as the office possesses official district boundary records in electronic format. The merged systems will allow the Revenue and Fiscal Affairs 35

The purpose of the Warehouse is to ensure that the operation 13 of health and human services agencies may be enhanced by coordination and integration of client information. Client data is defined 14 as person-level data that is created, received, and/or maintained by state agencies and other entities required to report client 15 information to the Revenue and Fiscal Affairs Office under this provision. 5 These agencies and departments shall collect and provide client data in formats and schedules to be specified by the Revenue and 6 Fiscal Affairs Office (Office). The Office shall establish a Memorandum of Agreement with each agency, department or division. 7 These Memorandums of Agreement shall specify, but are not limited to, the confidentiality of client information, the conditions for 8 the release of data that may identify agencies, departments, divisions, programs and services, or clients, any restrictions on the release of data so as to be compliant with state and federal statutes and regulations on confidentiality of data, conditions under which the 9 data may be used for research purposes, and any security measures to be taken to insure the confidentiality of client information. 10 To ensure accountability and the coordinated, efficient delivery of health and human services, the Office shall implement, in 11

consultation with state health and human services agencies and other entities as deemed necessary by the Office, an integrated data 12 system that includes client data from all participating agencies. 13

In order to provide for inclusion of other entities into the South Carolina Health and Human Services Data Warehouse and other 14 research and analytic-oriented applications that will assist the state in the efficient and effective provision of services, the Office shall 15 have the authority to enter into agreements or transactions with any federal, state or municipal agency or other public institution or 16 with any private individual, partnership, firm, corporation, association or other entity to provide statistical, research and information 17 dissemination services including, but not limited to, program and outcomes evaluation, program monitoring/surveillance, projects to 18 determine the feasibility of data collection and/or analyses, information dissemination and research. The confidentiality of data 19 collected under these initiatives shall comply with applicable state and federal laws governing the privacy of data. The Office shall 20 have the power to promulgate regulations, policies and procedures, in consultation with the participating agencies, for the 21 22 development, protection and operation of the Data Warehouse, other research and analytic-oriented applications, and their underlying 23 processes.

24 The Office shall develop internet-accessible secure analytic query tools (such as analytic cubes) using integrated client data from 25 the Warehouse. All agencies shall cooperate with the Office in the development of these analytic tools. It is the intent of this provision 26 that the analytic tools developed under this provision shall be made available to members of the South Carolina General Assembly and their research staff members, state agencies, and researchers. (RFAO: E911 PSAPs) The Revenue and Fiscal Affairs Office, utilizing the funds appropriated and or authorized herein 5 for the E911 program, must ensure that any new plans or proposed amendments to existing plans maintain comprehensive coverage 6 for the full Public Safety Answering Points area as well as improve cost effectiveness. No new plans or amendments may be 7 considered by Revenue and Fiscal Affairs that do not include the written agreement of all jurisdictions affected by the new plan or 8 proposed change as well as provide cost savings on the state and local level. Local Public Safety Answering Points are encouraged to cooperate to find ways to continue to improve cost effectiveness and efficiencies for all affected entities. 9 102.5. (RFAO: Revenue for Goods and Services) The respective sections of the Revenue and Fiscal Affairs Office are authorized 10 to provide and receive from other governmental entities, including other divisions, state and local agencies and departments, and the 11

private sector, goods and services, as will in its opinion promote efficient and economical operations. The sections may charge and pay the entities for the goods and services, the revenue from which shall be deposited in the state treasury in a special account and expended only for the costs of providing the goods and services, and such funds may be retained and be expended for the same

15 purposes.

16 **102.6.** (RFAO: 911 Advisory Committee) For the current fiscal year, the Executive Director of the Revenue and Fiscal Affairs

17 Office shall appoint an individual with technical or operational knowledge of E-911 systems to the South Carolina 911 Advisory

18 Committee, which formerly had an appointment of a director of a division of the State Budget and Control Board, ex officio. In

19 addition to the members designated to serve on the advisory committee, the Executive Director of the Revenue and Fiscal Affairs

20 Office may appoint a designee to serve on the advisory committee on his behalf.

102.7. (RFAO: NG9-1-1 Strategic Plan) The Revenue and Fiscal Affairs Office shall be authorized to use up to \$150,000 of the funds from the 58.2 percent compliance cost portion of the wireless 9-1-1 fund for costs associated with the further planning, development, and implementation of the comprehensive statewide NG9-1-1 system as outlined in the South Carolina NG9-1-1 strategic plan. Associated costs include, but are not limited to, the hiring of consultants, technical experts, or other professionals for assistance in defining, developing, or implementing the operating model and standards, system or technical requirements, or other elements of the system as outlined in the strategic plan.

104.1. (SFAA: Procurement of Art Objects) Before any governmental body, with the exception of the South Carolina Museum Commission, the Confederate Relic Room and Military Museum Commission, and the South Carolina Hunley Commission as defined under the South Carolina Consolidated Procurement Code, procures any art objects such as paintings, antiques, sculptures, or similar objects above \$1,000, the head of the Purchasing Agency shall prepare a written determination specifying the need for such objects and benefits to the State. The South Carolina Arts Commission shall review such determination for approval prior to any acquisition.

SECTION 104 - E550 - STATE FISCAL ACCOUNTABILITY AUTHORITY

104.2. (SFAA: Lawsuit Funding) The Executive Director shall pay from the Insurance Reserve Fund the defense costs of the 1 2 State, which are incurred in the current fiscal year, in the Abbeville school funding litigation and the prisoner mental health care litigation. The appropriate official from the House of Representatives and the Senate must certify to the Executive Director on a 3 4 monthly basis the costs incurred in defense of this litigation. Upon receipt of the certification, the Executive Director shall pay the 5 provider of these services the amount certified. 104.3. (SFAA: Public Procurement Unit) For purposes of participation in the Minnesota Multi State Contracting Alliance for 6 7 Pharmacy (MMCAP), a private, nonprofit corporation that provides only free medical care may be allowed to participate as a local 8 public procurement unit in the MMCAP cooperative purchase. The participation of nonprofit corporations in the program is contingent upon approval of the Minnesota Multi-State Contracting Alliance for Pharmacy. Participating nonprofit corporations 9 must comply with all applicable federal laws or regulations for participation in the MMCAP cooperative purchase. The state shall 10

11 not be liable for any action or inaction of such a nonprofit corporation.

12 **104.4.** (SFAA: Insurance Coverage for Aging Entity Authorized) The State Fiscal Accountability Authority, through the 13 Insurance Reserve Fund, for Fiscal Year 2017-18 2018-19, is also authorized to offer insurance coverage to an aging entity and its 14 employees serving clients countywide which previously obtained its tort liability insurance coverage through the board. The 15 Insurance Reserve Fund and the State of South Carolina shall not be liable to any person or entity, including an insured, for any 16 insufficiencies of coverage provided hereunder.

17 **104.5.** (SFAA: IRF Report) The State Fiscal Accountability Authority shall prepare a report on prior fiscal year utilization of the 18 Insurance Reserve Fund to include for each transaction the amount, the recipient of the funds, the date of the transfer or payment, 19 and the action or reason that necessitated the transfer. The report shall be submitted to the President Pro Tempore of the Senate, the 20 Chairman of the Senate Finance Committee, the Speaker of the House of Representatives, and the Chairman of the House Ways and 21 Means Committee by October fifteenth, of the current fiscal year.

104.6. (SFAA: Second Injury Fund Closure Plan) The State Fiscal Accountability Authority is authorized and empowered to take all necessary actions to administer the closure plan for the Second Injury Fund, as adopted pursuant to Section 42-7-320(A) of the 1976 Code, as amended, and to use the separate and distinct trust and administrative accounts established for this purpose.

104.7. (SFAA: IT Planning Transfer) The State Fiscal Accountability Authority shall transfer \$400,000 from revenue generated
 from contract administration fees on information technology contracts to the Department of Administration to support the state's
 information technology planning program.

104.8. (SFAA: Attorneys) For the current fiscal year, during the transition of the Insurance Reserve Fund from the Budget and Control Board to the State Fiscal Accountability Authority, the Insurance Reserve Fund shall continue to approve the attorneys-at-law retained to defend those it insures. In addition, the authority of the former Budget and Control Board under Section 1-7-170(A) is devolved upon the State Fiscal Accountability Authority.

104.9. (SFAA: Compensation - Agency Head Salary) In the event of an agency head or technical college president vacancy, the governing board of the agency or the Governor, or the appointing authority of a technical college president, must have the prior favorable recommendation of the Agency Head Salary Commission to set, discuss, offer, or pay a salary for the agency head or technical college president at a rate that exceeds the minimum of the range established by the Agency Head Salary Commission. No agency head or technical college president shall be paid a salary higher than that recommended by the commission. Boards and

commissions, or the Governor if he is the appointing authority, of newly created agencies or technical colleges shall not offer or pay 1 2 a salary to a prospective agency head until a salary range has been established and the salary approved by the Agency Head Salary Commission. The funding of the salaries of any agency head or technical college president should come from resources within the 3 4 agency. The State Fiscal Accountability Authority shall contract every four years for a study of agency head and technical college 5 president compensation. The cost of the study must be shared by the participating agencies. The staff of the State Fiscal Accountability Authority shall serve as the support staff to the Agency Head Salary Commission. Limited only by the maximum of 6 7 the respective salary range, the General Assembly authorizes the respective appointing authority for an agency head or technical 8 college president to provide salary increases for an agency head or technical college president not to exceed that recommended by the Agency Head Salary Commission. No agency head or technical college president shall be paid less than the minimum 9 of the pay range nor receive an increase that would have the effect of raising the salary above the maximum of the pay range. 10 **104.10.** (SFAA: Continuation of Authority) The respective divisions of the State Fiscal Accountability Authority are authorized 11 to provide to and receive from other governmental entities, including other divisions and state and local agencies and departments, 12 goods and services, as will in its opinion promote efficient and economical operations. The divisions may charge and pay the entities 13 for the goods and services, the revenue from which shall be deposited in the state treasury in a special account and expended only 14 15 for the costs of providing the goods and services, and such funds may be retained and expended for the same purposes. 16 17 SECTION 105 - F270 - SFAA, STATE AUDITOR'S OFFICE 18

- 19 105.1. (SFAA-AUD: Annual Audit of Federal Programs) Each state agency receiving federal funds subject to the audit 20 requirements of the Single Audit Act Amendments of 1996 and OMB Circular A-133, Audits of States, Local Governments and 21 Nonprofit Organizations <u>Title 2 U.S. Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost</u> 22 <u>Principles, and Audit Requirements for Federal Awards (Uniform Guidance)</u> shall remit to the State Auditor an amount representing 23 an equitable portion of the expense of contracting with a nationally recognized CPA firm to conduct a portion of the audit of the 24 State's federal financial assistance. 25 Each state agency's equitable portion of the expense will be determined by a schedule developed by the State Auditor. Such 26 State agency's equitable portion of the expense will be determined by a schedule developed by the State Auditor. (PEBA: Adoption Assistance Program) The Employee Adoption Assistance Program is established to provide grants to 29

108.2. (PEBA: Adoption Assistance Program) The Employee Adoption Assistance Program is established to provide grants to eligible employees to assist them with the direct costs of adoption. The program shall be an employee benefit through the Public Employee Benefit Authority (PEBA) and shall be funded from the appropriation for the State Health Plan as provided in this act. (PEBA: Inactive SCRS Account Transfer) A current employee or teacher who is an active participant in the State Optional 33 34 Retirement Program but who has an inactive account in the South Carolina Retirement Program due to previous service in that

35 system, shall be allowed to transfer previous contributions to the employee's or teacher's active State Optional Retirement Program

36 account.

(PEBA: Removal of Notarization Requirement for Retirement Systems) The provisions in Sections 9-1-1650, 9-9-70(A), 19 9-9-100(2), 9-11-110(1), 9-11-170(5) and 9-11-170(6) of the 1976 Code requiring a written beneficiary designation to be "duly 20 acknowledged" are hereby suspended for Fiscal Year 2018-19. The requirement that a PEBA form or other writing signed by a 21 member be "notarized" pursuant to Section 9-9-70(B) is hereby suspended for Fiscal Year 2018-19. 22 108.15. (PEBA: Suspension of Fiduciary Audit) The provision of Section 9-4-40 of the 1976 Code requiring the performance 23 and completion of a fiduciary audit of the Public Employee Benefit Authority by January 15, 2019, is hereby suspended for Fiscal 24 Year 2018-19. 25 26 108.16. (PEBA: Return to Covered Employment) In the current fiscal year, notwithstanding any other provision of law, from the funds appropriated, PEBA shall allow a member who retired from either the South Carolina Retirement System or the Police 27 Officers Retirement System on or before December 31, 2017, to return to employment covered by these systems and not be subject 28 29 to the earnings limitations as provided by law. 30 31 **SECTION 109 - R440 - DEPARTMENT OF REVENUE** 32 33 109.1. (DOR: Subpoenaed Employee Expense Reimbursement) If any employee of the Department of Revenue is subpoenaed to 34 testify during litigation not involving the Department of Revenue, the party subpoenaing the employee(s) to testify shall reimburse the State for expenses incurred by the employee(s) requested to testify. Expenses shall include but are not limited to the cost of 35

36 materials and the average daily salary of the employee or employees.

109.2. (DOR: Court Order Funds Carry Forward) Funds awarded to the Department of Revenue by court order shall be retained 1 2 in a special account and shall be carried forward from year to year, and expended as needed to accomplish the purposes and conditions of said order if specified, and if not specified, as may be directed by the Director of the Department of Revenue. 3 4 109.3. 24	standardized tests, or both, at progressive grade levels to determine student progress;
25	(e) has school facilities that are subject to applicable federal, state, and local laws;

27	of Christian Schools, the South Carolina Independent Schools Association, or Palmetto Association of Independent Schools; and
28	(g) provides a specially designed program or learning resource center to provide needed accommodations based on the
29	needs of exceptional needs students or provides onsite educational services or supports to meet the needs of exceptional needs
30	students, or is a school specifically existing to meet the needs of only exceptional needs students with documented disabilities.
31	(2) "Exceptional needs child" means a child:
32	(a) who has been evaluated in accordance with this state's evaluation criteria, as set forth in S.C. Code Ann. Regs.
33	43-243.1, and determined eligible as a child with a disability who needs special education and related services, in accordance with
34	the requirements of Section 300.8 of the Individuals with Disabilities Education Act; or
35	(b) who has been diagnosed within the last three years by a licensed speech-language pathologist, psychiatrist, or
36	medical, mental health, psychoeducational, or other comparable licensed health care provider as having a neurodevelopmental

disorder, a substantial sensory or physical impairment such as deaf, blind, or orthopedic disability, or some other disability or acute 1 2 or chronic condition that significantly impedes the student's ability to learn and succeed in school without specialized instructional and associated supports and services tailored to the child's unique needs. 3

4 (3) "Independent school" means a school, other than a public school, at which the compulsory attendance requirements of 5 Section 59-65-10 may be met and that does not discriminate based on the grounds of race, color, religion, or national origin. 6

(4) "Parent" means the natural or adoptive parent or legal guardian of a child.

7 (5) "Oualifying student" means a student who is an exceptional needs child, a South Carolina resident, and who is eligible to be enrolled in a South Carolina secondary or elementary public school at the kindergarten or later year level for the applicable 8 9 school year.

(6) "Resident public school district" means the public school district in which a student resides, or in the case of dependents 10 of active military personnel, the public school district which the student may attend. 11

- (7) "Transportation" means transportation to and from school only.

(8) "Tuition" means the total amount of money charged for the cost of a qualifying student to attend an independent school 13 including, but not limited to, fees for attending the school, textbook fees, and school-related transportation. 14 15

(9) "Department" means the Department of Revenue.

(B) (1) There is created the Educational Credit for Exceptional Needs Children Fund that is separate and distinct from the State 16 general fund. The fund shall be organized by the department as a public charity as defined by the Internal Revenue Code under 17 sections 509(a)(1) through 509(a)(4) and consist solely of contributions made to the fund. The fund may not receive an appropriation 18 of public funds. The fund shall receive and hold all contributions intended for it as well as all earnings until disbursed as provided 19 in this chapter. Monies received in the fund shall be used to provide scholarships to exceptional needs children attending eligible 20 21 schools.

22 (2) The amounts on deposit in the fund do not constitute public funds nor are the deposits property of the State. Amounts 23 on deposit in the fund must not be commingled with public funds and the State shall have no claim to or interest in the amounts on 24 deposit. Agreements or contracts entered into by or on behalf of the fund do not constitute a debt or obligation of the State.

25 (3) The public charity shall be governed by five directors, two appointed by the Chairman of the House Ways and Means 26 Committee, one of which is based upon the recommendation of the South Carolina Association of Christian Schools and one which is based upon the recommendation of the Diocese of Charleston, two appointed by the Chairman of the Senate Finance Committee 27 based upon the recommendations of the South Carolina Independent Schools Association and one appointed by the Governor based 28 upon the recommendation of the Palmetto Association of Independent Schools. The directors of the public charity, along with the 29 Director of the Department of Revenue, shall designate an executive director of the public charity. 30

31 (4) In concert with the public charity directors, the Department of Revenue shall administer the public charity, including, but not limited to, the keeping of records, the management of accounts, and disbursement of the grants awarded pursuant to this 32 proviso. The public charity may expend up to two percent of the fund for administration and related costs. Neither the department 33 34 or the public charity may expend public funds to administer the program.

Information contained in or produced from a tax return, document, or magnetically or electronically stored data utilized by the 35 Department of Revenue or the public charity in the exercise of its duties as provided in this proviso shall remain confidential and is 36

exempt from disclosure pursuant to the Freedom of Information Act. Personally identifiable information, as described in the Family 1 2 Educational Rights and Privacy Act and individual health records, or the medical or wellness needs of children applying for or receiving grants shall remain confidential and are not subject to disclosure pursuant to the Freedom of Information Act. 3 4 (5) By June thirtieth of the current fiscal year, the Department of Revenue must report to the Chairman of the Senate Finance 5 Committee, the Chairman of the House Ways and Means Committee and the Governor: 6 (a) the number and total amount of grants issued to eligible schools in the fiscal year; 7 (b) for each grant issued to an eligible school in the fiscal year, the identity of the school and the amount of the grant; 8 (c) an itemization and detailed explanation of any fees or other revenues obtained from or on behalf of any eligible 9 schools; (d) a copy of a compilation, review, or audit of the fund's financial statements, conducted by a certified public 10 accounting firm and; 11 12 (e) the criteria and eligibility requirements for scholarship awards. (C) (1) Grants may be awarded in an amount not exceeding eleven thousand dollars or the total annual cost of tuition, whichever 13 is less, to a qualifying student at an eligible school. Tuition charged to qualifying students by eligible schools receiving grants may 14 15 not exceed tuition charged to non-participating students. (2) Before awarding any grant, the public charity must receive written documentation from the qualifying student's parent 16 or guardian documenting that the qualifying student is an exceptional needs child. Upon approving the application, the public charity 17 must issue a check to the eligible school in the name of the qualifying student within either thirty days upon approval of the application 18 or thirty days of the start of the school's semester. 19 20 (3) In the event that the qualifying student leaves or withdraws from the school for any reason before the end of the semester or school year and does not reenroll within thirty days, then the eligible school must return a prorated amount of the grant to the 21 22 public charity based on the number of days the qualifying student was enrolled in the school during the semester or school year 23 within sixty days of the qualifying student's departure. 24 (4) The public charity may not award grants solely for the benefit of one school. 25 (5) The department or the public charity may not release any personally identifiable information pertaining to students or donors or use information collected about donors, students, or schools for financial gain. 26 (6) The public charity shall develop a process to prioritize the awarding of grants to eligible incumbent grant recipients at 27 28 eligible schools. 29 (D) (1) (a) Tax credits authorized by subsection (H)(1) and subsection (I) of this proviso annually may not exceed cumulatively 30 a total of eleven twelve million dollars for contributions to the Educational Credit for Exceptional Needs Children Fund. (b) Tax credits authorized pursuant to subsection (H)(2) of this proviso annually may not exceed cumulatively a total 31 of two million dollars for tuition payments made on behalf of qualifying students. 32 (c) If the department determines that the total of the credits claimed by all taxpayers exceeds either limit amount as 33 34 contained in items (a) or (b), it shall allow credits only up to those amounts on a first come, first served basis. (2) (a) The department shall establish an application process to determine the amount of credit available to be claimed. 35 The receipt of the application by the department shall determine priority for the credit. Subject to the provisions of subitem (e), 36

contributions must be made annually on or before June thirtieth, in order to claim the credit. The credit must be claimed on the return 1 2 for the tax year that the contribution is made.

(b) A taxpayer may not claim more than sixty percent of his total tax liability for the year in contribution toward the 3 4 tax credit authorized by subsection (H)(1) or subsection (I). This credit is not refundable.

5 (c) If a taxpayer deducts the amount of the contribution on his federal return and claims the credit allowed by subsection 6 (H)(1) or subsection (I), then he must add back the amount of the deduction for purposes of South Carolina income taxes.

7 (d) The department shall prescribe the form and manner of proof required to obtain the credit authorized by subsection 8 (H)(1) or subsection (I). The department shall also develop a method of informing taxpayers if the credit limit is met at any time 9 during the fiscal year.

(e) A taxpayer only may claim a credit pursuant to subsection (H)(1) and subsection (I) for contributions made during 10 11 the fiscal year.

(GP: State Institutions - Revenues & Income) (A) The University of South Carolina, Clemson University, the Medical 8 University of South Carolina (including the Medical University Hospital), The Citadel, Winthrop University, South Carolina State University, Francis Marion University, University of Charleston, Lander University, Coastal Carolina University, and the Wil Lou 9 Gray Opportunity School shall remit all revenues and income, collected at the respective institutions, to the State Treasurer according 10 to the terms of Section 117.1 of this act, but all such revenues or income so collected, except fees received as regular term tuition, 11 matriculation, and registration, shall be carried in a special continuing account by the State Treasurer, to the credit of the respective 12 institutions, and may be requisitioned by said institutions, in the manner prescribed in Section 11-3-185 of the 1976 Code, and 13 expended to fulfill the purpose for which such fees or income were levied, but no part of such income shall be used for permanent 14 improvements without the express written approval of the State Fiscal Accountability Authority and the Joint Legislative Capital 15 Bond Review Committee; and it is further required that no such fee or income shall be charged in excess of the amount that is 16 necessary to supply the service, or fulfill the purpose for which such fee or income was charged. Notwithstanding other provisions 17 of this act, funds at state institutions of higher learning derived wholly from athletic or other student contests, from the activities of 18 student organizations, and from the operations of canteens and bookstores, and from approved Private Practice plans at institutions 19 and affiliated agencies may be retained at the institution and expended by the respective institutions only in accord with policies 20 established by the institution's Board of Trustees. Such funds shall be audited annually by the State but the provisions of this act 21 concerning unclassified personnel compensation, travel, equipment purchases and other purchasing regulations shall not apply to the 22 23 use of these funds. 24 (B) Notwithstanding other provisions of this Act, for purposes of budgetary expenditure authorization, The Citadel, Clemson University (Education & General), University of Charleston, Coastal Carolina University, Francis Marion University, Lander 25

26 University, South Carolina State University, University of South Carolina and all branch campuses, Winthrop University, Medical

27 University of South Carolina, and State Board for Technical and Comprehensive Education Technical Colleges shall be authorized

to retain, expend, and carry forward any revenue received by the institutions which is designated as other funds. Nothing in this

29 provision alters an institution's current reporting requirements.

30 117.9. (GP: Transfers of Appropriations) Agencies and institutions shall be authorized to transfer appropriations within programs 31 and within the agency with notification to the Executive Budget Office and Comptroller General. No such transfer may exceed 32 twenty percent of the program budget. Upon request, details of such transfers may be provided to members of the General Assembly 33 on an agency by agency basis. Transfers of appropriations from personal service accounts to other operating accounts or from other 34 operating accounts to personal service accounts may be restricted to any established standard level set by the State Fiscal 35 Accountability Authority upon formal approval by a majority of the members of the State Fiscal Accountability Authority.

1 **117.10.** (GP: Federal Funds - DHEC, DSS, DHHS - Disallowances) Amounts appropriated to the Department of Health and 2 Environmental Control, Department of Social Services and Department of Health and Human Services may be expended to cover 3 program operations of prior fiscal years where adjustment of such prior years are necessary under federal regulations or audit 4 exceptions. All disallowances or notices of disallowances by any federal agency of any costs claimed by these agencies shall be 5 submitted to the State Auditor, the Senate Finance Committee and the House Ways and Means Committee, within five days of receipt 6 of such actions.

117.11. (GP: Fixed Student Fees) During the current fiscal year, student fees at the state institutions of higher learning shall be
 fixed by the respective Boards of Trustees as follows:

9 (1) Fees applicable to student housing, dining halls, student health service, parking facility, laundries and all other personal 10 subsistence expenses shall be sufficient to fully cover the total direct operating and capital expenses of providing such facilities and 11 services over their expected useful life except those operating or capital expenses related to the removal of asbestos.

(2) Student activity fees may be fixed at such rates as the respective Boards shall deem reasonable and necessary.

13 **117.12.** (GP: Tech Educ. Colleges Student Activity Fees) Notwithstanding any other provisions of this act, funds at technical 14 education colleges derived wholly from the activities of student organizations and from the operations of canteens and bookstores 15 may be retained by the college and expended only in accord with policies established by the respective college's area commission 16 and approved by the State Board for Technical and Comprehensive Education.

17 **117.13.** (GP: Discrimination Policy) It is the policy of the State of South Carolina to recruit, hire, train, and promote employees 18 without discrimination because of race, color, sex, national origin, age, religion or physical disability. This policy is to apply to all 19 levels and phases of personnel within state government, including but not limited to recruiting, hiring, compensation, benefits, 20 promotions, transfers, layoffs, recalls from layoffs, and educational, social, or recreational programs. It is the policy of the State to 21 take affirmative action to remove the disparate effects of past discrimination, if any, because of race, color, sex, national origin, age, 22 religion or physical disability.

Each state agency shall submit to the State Human Affairs Commission employment and filled vacancy data by race and sex by October thirty-first, of each year.

25 In accordance with Section 1-13-110 of the 1976 Code, as amended, the Human Affairs Commission shall submit a report on the 26 status of state agencies' Affirmative Action Plans and Programs to the General Assembly by February first each year. This report shall contain the total number of persons employed in each job group, by race and sex, at the end of the preceding reporting period, 27 a breakdown by race and sex of those hired or promoted from within the agency during the reporting period, and an indication of 28 whether affirmative action goals were achieved. For each job group referenced in the Human Affairs report, where the hiring of 29 personnel does not reflect the percentage goals established in the agency's affirmative action plan for the year in question, the state 30 agency shall submit a detailed explanation to the Human Affairs Commission by February fifteenth, explaining why goals were not 31 achieved. 32

33 The Human Affairs Commission shall review the explanations and notify the Department of Administration of any agency not in 34 satisfactory compliance with meeting its stated goals.

The Department of Administration shall notify any agency not in compliance that their request for additional appropriations for the current appropriation cycle, may not be processed until such time as the Department of Administration, after consultation with

the Human Affairs Commission, is satisfied that the agency is making a good faith effort to comply with its affirmative action plan, 1 2 and that the compliance must be accomplished within a reasonable length of time to be determined by the mission and circumstances of the agency. This requirement shall not affect additional appropriation requests for public assistance payments or aid to entities. 3 4 This section does not apply to those agencies that have been exempted from the reporting requirements of the Human Affairs 5 Commission. 6 **117.14.** (GP: FTE Management) In order to provide the necessary control over the number of employees, the Executive Budget 7 Office is hereby directed to maintain close supervision over the number of state employees, and to require specifically the following: (1) That no state agency exceed the total authorized number of full-time equivalent positions and those funded from state 8 sources as provided in each section of this act except by majority vote of the State Fiscal Accountability Authority. 9 (2) That the Executive Budget Office shall maintain and make, as necessary, periodic adjustments thereto, an official record 10 of the total number of authorized full-time equivalent positions by agency for state and total funding sources. 11 (a) That within thirty days of the passage of the Appropriation Act or by August first, whichever comes later, each agency 12 of the State must have established on the Executive Budget Office records all positions authorized in the Act. Each agency may, 13 upon notification to the Executive Budget Office, change the funding source of state FTE positions established on the Executive 14 15 Budget Office records as necessary to expend federal and other sources of personal service funds to conserve or stay within the state appropriated personal service funds. No agency shall change funding sources that will cause the agency to exceed the authorized 16 number of state or total full-time equivalent positions. Each agency may transfer FTEs between programs as needed to accomplish 17 the agency mission. 18 (b) That by September thirtieth, the office shall prepare a FTE analysis, by agency, which shows the number of authorized, 19 filled, and vacant positions by source of funds for the current and two previously completed fiscal years. The office shall provide a 20 21 copy of each agency's FTE analysis to the Senate Finance and House Ways and Means Committees. 22 (3) That full-time equivalent (FTE) positions shall be determined under the following guidelines: 23 (a) The annual work hours for each FTE shall be the agency's full-time standard annual work hours. 24 (b) The state FTE shall be derived by multiplying the state percentage of budgeted funds for each position by the FTE for 25 that position. 26 (c) All institutions of higher education shall use a value of 0.75 FTE for each position determined to be full-time faculty with a duration of nine months. 27 28 The FTE method of accounting shall be utilized for all authorized positions. 29 (4) That the number of positions authorized in this act shall be reduced in the following circumstances: (a) Upon request by an agency. 30 (b) When anticipated federal funds are not made available. 31 (c) When the Executive Budget Office, through study or analysis, becomes aware of any unjustifiable excess of positions 32 33 in any state agency. 34 (5) That the number of positions authorized in this act shall be increased for the sole purpose of classifying Temporary,

35 Time-Limited and Temporary Grant positions created prior to July 1, 2017, that merit such classification as FTEs because the agency

36 has determined that the duties will continue indefinitely. The new FTEs created through this process and filled by existing non-FTE

staff shall be exempt from the posting process. Additionally, affected Temporary Grant and Time-Limited employees shall transfer any unused annual and sick leave to their FTE positions.
The Division of State Human Resources, in consultation with the Executive Budget Office, shall formulate guidelines for the administration of this item. The request by the agency must include a justification for changing the position, justification of an insufficient vacancy pool, identification of sufficient funds with current appropriations, identification of source of funds to be utilized, and assurance that the FTEs are not being used to create new jobs. The guidelines shall also include a process for submitting requests

7 including a deadline for submission of requests.

8 The Department of Administration shall review the request and approve, deny, or modify it as appropriate. The department shall 9 further ensure that the FTE Constitutional limits are observed. This item in no way requires agencies to submit requests, and does 10 not guarantee any employment status to staff. A report on FTE issuance through this item shall be submitted to the Chairman of the

Senate Finance Committee and the Chairman of the House Ways and Means Committee no later than January sixth of the current fiscal year.

(6 5) That no new permanent positions in state government shall be funded by appropriations in acts supplemental to this act but
 temporary positions may be so funded.

15 (7 <u>6</u>)That the provisions of this section shall not apply to personnel exempt from the State Classification and Compensation
 Plan under item I of Section 8-11-260 of the 1976 Code.

The Governor, in making his appropriation recommendations to the Ways and Means Committee, must provide that the level of personal service appropriation recommended for each agency is at least ninety-seven percent of the funds required to meet one hundred percent of the funds needed for the full-time equivalents positions recommended by the Governor (exclusive of new positions).

21 **117.15.** (GP: Allowance for Residences & Compensation Restrictions) That salaries paid to officers and employees of the State, including its several boards, commissions, and institutions shall be in full for all services rendered, and no perquisites of office or of 22 23 employment shall be allowed in addition thereto, but such perquisites, commodities, services or other benefits shall be charged for 24 at the prevailing local value and without the purpose or effect of increasing the compensation of said officer or employee. The charge 25 for these items may be payroll deducted at the discretion of the Comptroller General or the chief financial officer at each agency maintaining its own payroll system. This shall not apply to the Governor's Mansion, nor to guards at any of the state's penal 26 institutions and nurses and attendants at the Department of Disabilities and Special Needs, and registered nurses providing clinical 27 care at the MUSC Medical Center, nor to the Superintendent and staff of John de la Howe School, nor to the cottage parents and staff 28 of Wil Lou Gray Opportunity School, nor to full-time or part-time staff who work after regular working hours in the SLED 29 Communications Center or Maintenance Area, nor to adult staff at the Governor's School for Science and Mathematics and the 30 31 Governor's School for Arts and Humanities who are required to stay on campus by the institution because of job requirements or program participation. Any state institution of higher learning may provide complimentary membership privileges to employees 32 who work at their wellness centers. The presidents of those state institutions of higher learning authorized to provide on-campus 33 34 residential facilities for students may be permitted to occupy residences on the grounds of such institutions without charge. Any state institution of higher learning may provide a housing allowance to the president in lieu of a residential facility, the amount 35

to be approved by the State Fiscal Accountability Authority.

That the following may be permitted to occupy residences owned by the respective departments without charge: the Farm Director, 1 2 Farm Managers, and Specialists employed at the Wateree River Correctional Institution; the South Carolina State Commission of Forestry fire tower operators, forestry aides, and caretaker at central headquarters; the Department of Natural Resources' Game 3 4 Management Personnel, Fish Hatchery Personnel, and Fort Johnson Superintendent; the Department of Parks, Recreation and 5 Tourism field personnel in the State Parks Division; Director of Wil Lou Gray Opportunity School; President of the School for the 6 Deaf and the Blind; houseparents for the Commission for the Blind; South Carolina Department of Health and Environmental Control 7 personnel at the State Park Health Facility and Camp Burnt Gin; Residence Life Coordinators at Lander University; Residence Life 8 Directors, temporary and transition employees, student interns, and emergency personnel at Winthrop University; Farm Superintendent at Winthrop University; Residence Hall Directors at the College of Charleston; the Department of Disabilities and 9 Special Needs' physicians and other professionals at Whitten Center, Clemson University Off-Campus Agricultural Staff and 10 Housing Area Coordinators; and TriCounty Technical College's Bridge to Clemson Resident and Area Directors; and housing 11 12 maintenance night supervisors, residence life directors, temporary and transition employees, and emergency medical personnel occupying residences owned by the University of South Carolina. Except in the case of elected officials, the fair market rental value 13 of any residence furnished to a state employee shall be reported by the state agency furnishing the residence to the Agency Head 14 15 Salary Commission, and the Department of Administration by October first of each fiscal year. All salaries paid by departments and institutions shall be in accord with a uniform classification and compensation plan, approved 16 by the Department of Administration, applicable to all personnel of the State Government whose compensation is not specifically 17 fixed in this act. Such plan shall include all employees regardless of the source of funds from which payment for personal service is 18 drawn. The Department of Administration is authorized to approve temporary salary adjustments for classified and unclassified 19 employees who perform temporary duties which are limited by time and/or funds. When approved, a temporary salary adjustment 20 shall not be added to an employee's base salary and shall end when the duties are completed and/or the funds expire. Academic 21 22 personnel of the institutions of higher learning and other individual or group of positions that cannot practically be covered by the 23 plan may be excluded therefrom but their compensations as approved by the Department of Administration shall, nevertheless, be 24 subject to review by the State Fiscal Accountability Authority. Salary appropriations for employees fixed in this act shall be in full 25 for all services rendered, and no supplements from other sources shall be permitted or approved by the State Fiscal Accountability 26 Authority. With the exception of travel and subsistence, legislative study committees shall not compensate any person who is otherwise employed as a full-time state employee. Salaries of the heads of all agencies of the State Government shall be specifically 27 28 fixed in this act and no salary shall be paid any agency head whose salary is not so fixed. As long as there is no impact on appropriated

funds, state agencies and institutions shall be allowed to spend public funds and/or other funds for designated employee award programs which shall have written criteria approved by the agency governing board or commission. For purposes of this section, monetary awards, if any, shall not be considered a part of an employee's base salary, a salary supplement, or a perquisite of employment. The names of all employees receiving monetary awards and the amounts received shall be reported annually to the Department of Administration.

In the case of lodging furnished by certain higher education institutions to employees, the prevailing local rate does not apply if the institution meets the exceptions for inadequate rent described in the current Internal Revenue Code Section 119(d)(2). To meet the exception, rental rates must equal the lesser of five percent of the appraised value of the qualified campus lodging, or the average

1 of the rentals paid by individuals (other than employees or students of the educational institution) during the calendar year for lodging

2 provided by the educational institution which is comparable to the qualified campus lodging provided to the employee, over the rent

paid by the employee for the qualified campus lodging during the calendar year. The appraised value shall be determined as of the

4 close of the calendar year in which the taxable year begins, or, in the case of a rental period not greater than one year, at any time5 during the calendar year in which the period begins.

6 **117.16.** (GP: Universities & Colleges - Allowance for Presidents) Presidents of the University of South Carolina, Clemson 7 University, the Medical University of South Carolina, The Citadel, Winthrop University, South Carolina State University, Francis 8 Marion University, University of Charleston, Coastal Carolina University and Lander University must not be paid a fixed allowance 9 for personal expenses incurred in connection with the performance of their official duties. Reimbursements may be made to the 9 presidents from funds available to their respective institutions for any personal expenses incurred provided that all requests for 9 reimbursement are supported by properly documented vouchers processed through the normal accounting procedures of the 9 institutions.

117.17. (GP: Replacement of Personal Property) The Department of Juvenile Justice, Department of Corrections, Department 13 of Probation, Parole and Pardon Services, Department of Mental Health, Department of Disabilities and Special Needs, Continuum 14 of Care, Department of Social Services and School for the Deaf and the Blind may replace the personal property of an employee 15 which has been damaged or destroyed by a client while in custody of the agency. The replacement of personal property may be 16 made only if the loss has resulted from actions by the employee deemed to be appropriate and in the line of duty by the agency head 17 and if the damaged or destroyed item is found by the agency head to be reasonable in value, and necessary for the employee to carry 18 out the functions and duties of his employment. Replacement of damaged or destroyed items shall not exceed \$250 per item, per 19 incident. Each agency must have guidelines to insure the reasonableness of the replacement payments. 20

117.18. (GP: Business Expense Reimbursement) Agency heads and deputy commissioners or deputy directors designated by agency heads may receive reimbursements for business expenses incurred while performing their official duties, provided that receipts are presented when seeking reimbursement and justification is submitted to document the time, place, and purpose of the expense as well as the names of the individuals involved. The Department of Administration shall promulgate regulations governing these expenses.

117.19. (GP: Per Diem) The per diem allowance of all boards, commissions and committees shall be at the rate of \$35 per day.
 No full-time officer or employee of the State shall draw any per diem allowance for service on such boards, commissions or committees.

117.20. (GP: Travel - Subsistence Expenses & Mileage) Travel and subsistence expenses, whether paid from state appropriated,
 federal, local or other funds, shall be allowed in accordance with the following provisions:

(A) Unless otherwise provided in paragraphs B through H of this section, all employees of the State of South Carolina or any agency thereof including employees and members of the governing bodies of each technical college while traveling on the business of the State shall, upon presentation of a paid receipt, be allowed reimbursement for actual expenses incurred for lodging, not to exceed the current maximum lodging rates, excluding taxes, established by the U.S. General Services Administration. The lodging reimbursement for employees of a school district must also conform to these rates when that employee's travel reimbursement is paid by state funds that are transferred to the school district. Agencies may contract with lodging facilities to pay on behalf of an

employee. Failure to maintain proper control of direct payments for lodging may result in the revocation of the agency's authority 1 2 by the Comptroller General or the State Auditor. The employee shall also be reimbursed for the actual expenses incurred in the obtaining of meals except that such costs shall not exceed \$25 per day within the State of South Carolina. For travel outside of South 3 4 Carolina the maximum daily reimbursement for meals shall not exceed \$32. Agencies may contract with food or dining facilities to 5 pay for meals on behalf of employees in accordance with rules and regulations established by the Office of Comptroller General. It 6 shall be the responsibility of the agency head to monitor the charges for lodging which might be claimed by his employees in order 7 to determine that such charges are following maximum lodging rates as established by the U.S. General Services Administration. Any exceptions must have the written approval of the agency head, taking into consideration location, purpose of travel or other 8 extenuating circumstances. The provisions of this item shall not apply to Section 42-3-40 of the 1976 Code, and when pertaining to 9 institutions of higher learning, for travel paid with funds other than General Funds. 10 (B) That employees of the State, when traveling outside the United States, Canada, and Puerto Rico upon promotional business 11 for the State of South Carolina shall be entitled to actual expenses for both food and lodging. 12 (C) The Governor, Lieutenant Governor, Secretary of State, Comptroller General, Attorney General, State Treasurer, Adjutant 13 General, Superintendent of Education and the Commissioner of Agriculture shall be reimbursed actual expenses for subsistence. 14 15 (D) Non-legislative members of committees appointed pursuant to Acts and Resolutions of the General Assembly whose membership consists solely of members of the General Assembly or members of the General Assembly and other personnel who are 16 not employees of the State of South Carolina shall be allowed subsistence expenses of \$35 per day while traveling on official business, 17 unless otherwise designated by law. Members of such committees may opt to receive actual expenses incurred for lodging and actual 18 expenses incurred in the obtaining of meals in lieu of the allowable subsistence expense. 19 (E) Members of the state boards, commissions, or committees whose duties are not full-time and who are paid on a per diem 20 basis, shall be allowed reimbursement for actual expenses incurred at the rates provided in paragraph A and I of this section while 21 away from their places of residence on official business of the State. One person accompanying a handicapped member of a state 22 23 board, commission, or committee on official business of the State shall be allowed the same reimbursement for actual expenses 24 incurred at the rates provided in paragraph A through I of this section. 25 (F) No subsistence reimbursement shall be allowed to a Justice of the Supreme Court or Judge of the Court of Appeals while 26 traveling in the county of his official residence. When traveling on official business of said court within fifty miles outside the county of his official residence, a Supreme Court Justice and a Judge of the Court of Appeals shall be allowed subsistence expenses in the 27 amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. When traveling on 28 official business of said court fifty or more miles outside the county of his official residence, each Justice and Judge of the Court of 29 Appeals shall be allowed subsistence expenses in the amount as provided in this act for members of the General Assembly plus such 30 31 mileage allowance for travel as is provided for other employees of the State. The Chief Justice, or such other person as the Chief Justice designates, while attending the Conference of Chief Justices and one member of the Supreme Court while attending the 32 National Convention of Appellate Court Judges, and three Circuit Judges while attending the National Convention of State Trial 33 34 Judges shall be allowed actual subsistence and travel expenses.

Upon approval of the Chief Justice, Supreme Court Justices, Judges of the Court of Appeals, Circuit Judges, and Family Court Judges shall be reimbursed for actual expenses incurred for all other official business requiring out-of-state expenses at the rate provided in paragraph A of this section.

4 (G) No subsistence reimbursements are allowed to a Circuit Judge, a Family Court Judge, or an Administrative Law Judge while 5 holding court within the county in which he resides. While holding court or on other official business outside the county, within 6 fifty miles of his residence, a Circuit Court Judge, Family Court Judge, or an Administrative Law Judge is entitled to a subsistence 7 allowance in the amount of \$35 per day plus such mileage allowance for travel as is provided for other employees of the State. While 8 holding court or on other official business at a location fifty miles or more from his residence, a Circuit Court, Family Court or 9 Administrative Law Judge is entitled to a subsistence allowance in the amount as provided in this act for members of the General 10 Assembly plus such mileage allowance for travel as is provided for other employees of the State.

(H) Any retired Justice, Circuit Court Judge or Family Court Judge or Master-in-Equity appointed by the Supreme Court to serve
 as a Special Circuit Judge, Family Court Judge, Appeals Court Judge, or Acting Associate Justice shall serve without pay but shall
 receive the same allowance for subsistence, expenses, and mileage as provided in Part I for Circuit Court Judges.

(I) No expense shall be allowed an employee either at his place of residence or at the official headquarters of the agency by 14 which he is employed except as provided in paragraph E, of this section. When an employee is assigned to work a particular territory 15 or district, and such territory or district and his official headquarters are in different localities or sections of the State, expenses may 16 be allowed for the necessary travel to his official headquarters. The members of the Workers' Compensation Commission may be 17 reimbursed at the regular mileage rate of one round trip each week from their respective homes to Columbia. No subsistence 18 reimbursement shall be allowed to a member of the Workers' Compensation Commission while traveling in the county of his official 19 residence. When traveling on official business of the commission outside the county of his official residence, a member of the 20 Workers' Compensation Commission shall be allowed subsistence expenses in the amount of \$35 per day. When traveling on official 21 22 business of the commission fifty or more miles outside the county of his official residence, each member shall be allowed a 23 subsistence allowance in the amount as provided in this act for members of the General Assembly. When out-of-state, members of 24 the Workers' Compensation Commission and the members of the Appellate Panel of the Department of Employment and Workforce 25 may claim the established amount of per diem, as stated in the General Appropriation Act, or actual expenses as deemed reasonable 26 by the Comptroller General. The members of the Appellate Panel of the Department of Employment and Workforce may be 27 reimbursed at the regular mileage rate when the member is on official business fifty miles or more outside of Columbia. The members 28 of the Appellate Panel of the Department of Employment and Workforce shall be allowed subsistence allowance in the amount as 29 provided in this act for members of the General Assembly when the member is on official business fifty miles or more outside of 30 Columbia.

(J) When an employee of the State shall use his or her personal automobile in traveling on necessary official business, a charge to equal the standard business mileage rate as established by the Internal Revenue Service will be allowed for the use of such automobile and the employee shall bear the expense of supplies and upkeep thereof. The standard business mileage rate used in this calculation shall be the current rate established by the Internal Revenue Service. Whenever state provided motor pool vehicles are reasonably available and their use is practical and an employee of the State shall request for his own benefit to use his or her personal vehicle in traveling on necessary official business, a charge of four cents per mile less than the standard business mileage rate as

established by the Internal Revenue Service will be allocated for the use of such vehicle and the employee shall bear the expense of 1 2 supplies and upkeep thereof. The standard business mileage rate used in this calculation shall be the current rate established by the Internal Revenue Service. When such travel is by a state-owned automobile, the State shall bear the expense of supplies and upkeep 3 4 thereof but no mileage will be allowed. Agencies and employees are directed to use state fueling facilities to the maximum extent 5 possible, when such use is cost beneficial to the State. When using commercial fueling facilities, operators of State-owned vehicles are directed to use self-service pumps. In traveling on the business of the State, employees are required to use the most economical 6 7 mode of transportation, due consideration being given to urgency, schedules and like factors. Mileage between an employee's home and his/her place of employment is not subject to reimbursement. However, when an 8 employee leaves on a business trip directly from his/her home, and does not go by the employee's headquarters, the employee shall 9 be eligible for reimbursement for actual mileage beginning at his/her residence. 10 (K) That a state agency may advance travel and subsistence expense monies to employees of that agency for the financing of 11 ordinary and necessary travel required in the conducting of the business of the agency. The Office of Comptroller General is directed 12 to develop and publish rules and regulations pertaining to the advancing of travel expenses and no state agency shall make such 13 advances except under the rules and regulations as published. All advances for travel and subsistence monies shall be repaid to the 14 15 agency within thirty days after the end of the trip or by July fifteenth, whichever comes first. (L) That the state institutions of higher learning are authorized to reimburse reasonable relocation expenses for new employees 16 when such reimbursements are considered by the agency head to be essential to successful recruitment of professionally competent 17 18 staff members. (M) The Office of Comptroller General is authorized to promulgate and publish rules and regulations governing travel and 19 20 subsistence payments. 21 (N) No state funds may be used to purchase first class airline tickets. 117.21. (GP: Organizations Receiving State Appropriations Report) Each organization receiving a contribution in this act shall 22 23 render to the state agency making the contribution by November first of the fiscal year in which funds are received, an accounting 24 of how the state funds will be spent, goals to be accomplished, proposed measures to evaluate success in implementing and meeting 25 the goals, a copy of the adopted budget for the current year, and also a copy of the organization's most recent operating financial statement. The funds appropriated in this act for contributions shall not be expended until the required financial statements are filed 26 with the appropriate state agency. No funds in this act shall be disbursed to organizations or purposes which practice discrimination 27 28 against persons by virtue of race, creed, color or national origin. The State Auditor shall review and audit, if necessary, the financial 29 structure and activities of each organization receiving contributions in this act and make a report to the General Assembly of such review and/or audit, when requested to do so by the State Fiscal Accountability Authority. From the funds an organization receives 30 from a state agency, for accountability purposes, by June thirtieth organizations receiving contributions in this act shall submit a 31

32 report to the state agency making the contribution that includes an accounting of how the funds were spent and the outcome measures

33 used to determine the success of the stated goals. State agencies receiving such data from organizations shall forward the 34 information to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee.

117.22. (GP: State-Owned Aircraft - Flight Logs) Each agency having in its custody one or more aircraft shall maintain a

36 continuing log on all flights, which in order to promote accountability and transparency shall be open for public inspection and shall

also be posted online. Any and all aircraft owned or operated by agencies of the State Government shall be used only for official 1 2 business. The Division of Aeronautics and other agencies owning and operating aircraft may furnish transportation to the Governor, Constitutional Officers, members of the General Assembly, members of state boards, commissions, and agencies and their invitees 3 4 for official business only; no member of the General Assembly, no member of a state board, commission, or committee, and no state 5 official shall use any state-owned or operated aircraft unless the member or official files within twenty-four hours after the completion 6 of the flight with the agency that provided the flight a sworn statement certifying and describing the official nature of his trip; and 7 no member of the General Assembly, no member of a state board, commission or committee, and no state official shall be furnished 8 air transportation by a state agency unless such agency prepares and maintains in its files a sworn statement from the highest ranking official of the agency or its designee certifying that the member's or state official's trip was in conjunction with the official business 9 of the agency. Official business shall not include routine transportation to and from meetings of the General Assembly or committee 10 meetings for which mileage is authorized. Official business also does not include attending a press conference, bill signing, or 11 political function. 12 All logs shall be signed by the parties using the flight and the signatures shall be maintained as part of the permanent record of 13 any agency. All passengers shall be listed on the flight log by their legal name; passengers flying with an appropriate official of 14 SLED or the Department of Commerce whose confidentiality must, in the opinion of SLED or the department, be protected shall be 15 listed in writing on the flight log as "Confidential Passenger SLED or the Department of Commerce (strike one)" and the appropriate 16 official of SLED or the department shall certify to the agency operating the aircraft the necessity for such confidentiality. The 17 Division of Aeronautics shall post its flight logs on its website within one working day of completion of trips. 18 Violation of the above provisions of this section is prima facie evidence of a violation of Section 8-13-700(A) of the 1976 Code 19 and shall subject a violating member of the General Assembly to the ethics procedure of his appropriate house and shall subject a 20 violating member of a state board, commission or committee, or a state official to the applicable ethics procedure relating to them as 21 22 provided by law. The above provisions do not apply to state-owned or operated aircraft when used by the Medical University of 23 South Carolina, nor to aircraft of the athletic department or the educational foundations of any state-supported institution of higher 24 education, nor to law enforcement officers when flying on state-owned aircraft in pursuit of fugitives, missing persons, or felons or 25 for investigation of gang, drug, or other violent crimes. 26 Aircraft owned by agencies of state government shall not be leased to individuals for their personal use. 117.23. (GP: Carry Forward) Each agency is authorized to carry forward unspent general fund appropriations from the prior 27

fiscal year into the current fiscal year. Agencies shall not withhold services in order to carry forward general funds.

This provision shall be suspended if necessary to avoid a fiscal year-end general fund deficit. For purposes of this proviso, the amount of the general fund deficit shall be determined after first applying the Capital Reserve Fund provisions in Section 11-11-320(D) of the 1976 Code, and before any transfers from the General Reserve. The amount of general funds needed to avoid a year-end deficit shall be reduced proportionately from each agency's carry forward amount.

Agencies which have separate general fund carry forward authority must exclude the amount carried forward by such separate authority from their base for purposes of calculating the ten percent carry forward authorized herein. Any funds that are carried forward as a result of this provision are not considered part of the base of appropriations for any succeeding years.

117.24. (GP: TEFRA-Tax Equity and Fiscal Responsibility Act) It is the intent of the General Assembly that the State Medicaid 1 2 Plan be amended to provide benefits for disabled children as allowed by the Tax Equity and Fiscal Responsibility Act (TEFRA) option. State agencies, including but not limited to, the Department of Social Services - the Continuum of Care, the Department of 3 4 Health and Environmental Control, the Department of Mental Health, the Department of Disabilities and Special Needs, and the 5 Department of Health and Human Services shall collectively review and identify existing state appropriations within their respective 6 budgets that can be used as state match to serve these children. Such funds shall be used effective January 1, 1995 to implement 7 TEFRA option benefits. Agencies providing services under the provisions of this paragraph must not spend less in the current fiscal 8 year than expended in the previous fiscal year.

9 117.25. (GP: Prison Industries) All agencies funded in this act, when procuring goods and services, shall first consider
 10 contracting for services or purchasing goods and services through the Department of Corrections' Prison Industries Program. The
 11 Department of Corrections shall furnish, upon request, to all agencies a catalogue of goods and services provided by Prison Industries.
 12 The department is hereby directed to develop and market a catalogue of Prison Industries products for nationwide circulation.

117.26. (GP: Travel Report) Annually on November first, the Comptroller General shall issue a report on travel expenditures 13 for the prior fiscal year which shall be distributed to the Senate Finance Committee, the House Ways and Means Committee, and the 14 Statehouse Press Room. The Comptroller General may use up to \$500 of general fund appropriations for the purpose of providing 15 copies to the media or the public upon request. The report must contain a listing for every agency receiving an appropriation in the 16 annual General Appropriations Act. The listing must show at a minimum the top ten percent of employees for whom travel expenses 17 and registration fees were paid within each agency, not to exceed twenty-five employees per agency. Agencies should include 18 position titles for each of the top twenty-five travelers for each agency. Expenditures must include state, federal and other sources 19 of funds. Expenditures for in-state and out-of-state registration fees (fees to attend conferences, teleconferences, workshops, or 20 seminars for training on a per person basis) must be shown as a separate subtotal within the grand total for the individual employees 21 and the agency as a whole. The list for each agency must be in rank order with the largest expenditure first and the name of the 22 23 employee must be shown with each amount. Agencies should include a brief summary of the type of travel the agency incurs. The Comptroller General may provide additional information as deemed appropriate. The Comptroller General shall provide no 24 25 exceptions to this report in that the information contained is not considered confidential or restricted for economic development 26 purposes. However, further disclosure of detailed information shall be restricted as provided for by law.

117.27. (GP: School Technology Initiative) From the funds appropriated/authorized for the K-12 technology initiative, the Department of Education, in consultation with the Department of Administration, the State Library, the Educational Television Commission, and a representative from the Education Oversight Committee, shall administer the K-12 technology initiative funds. These funds are intended to provide technology, encourage effective use of technology in K-12 public schools throughout the state, conduct cost/benefit analyses of the various technologies, and should, to the maximum extent possible, involve public-private sector collaborative efforts. Funds may also be used to establish pilot projects for new technologies with selected school districts as part of the evaluation process. K-12 technology initiative funds shall be retained and carried forward to be used for the same purpose.

34 **117.28.** (GP: State-Operated Day Care Facilities Fees) Any state agency receiving funding in this act and any higher education 35 institution, including four-year institutions, two-year institutions, and technical colleges, that operates an early childhood 36 development center or day care facility shall charge, at a minimum, fees that are comparable to those charged by private day care

1 facilities in the local community. The institution or agency shall not restrict enrollment in the center solely to the children of faculty,

2 staff, and students of the institution; nor shall fees be set at a lower level for faculty, staff, or students of the institution or agency.

117.29. (GP: Base Budget Analysis) Agencies' annual accountability reports for the prior fiscal year, as required in Section 3 1-1-810, must be accessible to the Governor, Senate Finance Committee, House Ways and Means Committee, and to the public on 4 5 or before September fifteenth, for the purpose of a zero-base budget analysis and in order to ensure that the Agency Head Salary 6 Commission has the accountability reports for use in a timely manner. Accountability Report guidelines shall require agencies to 7 identify key program area descriptions and expenditures and link these to key financial and performance results measures. The 8 Executive Budget Office is directed to develop a process for training agency leaders on the annual agency accountability report and its use in financial, organizational, and accountability improvement. Until performance-based funding is fully implemented and 9 reported annually, the state supported colleges, universities and technical schools shall report in accordance with Section 59-101-350. 10 **117.30.** (GP: Collection on Dishonored Payments) In lieu of any other provision of law, any state agency may collect a service 11 charge as provided in Section 34-11-70 to cover the costs associated with the processing and collection of dishonored instruments or 12 electronic payments where any amount is not paid by the drawee due to insufficient funds on deposit with the bank or the person 13 upon which it was drawn when presented, or the instrument has an incorrect or insufficient signature on it. Such funds shall be 14 retained and expended by the agency in accordance with this purpose and any unused amount shall carry forward to the following 15 16 fiscal year.

17 **117.31.** (GP: State DNA Database) Funds collected by the South Carolina Department of Corrections, the Department of 18 Probation, Parole and Pardon, and Department of Juvenile Justice to process DNA samples must be remitted to the State Law 19 Enforcement Division to offset the expenses incurred to operate the State DNA Database program. SLED may retain, expend, and 20 carry forward these funds. Any carry forward funds resulting from the DNA Database program must be used solely to operate the 21 DNA Database program.

117.32. (GP: Voluntary Separation Incentive Program) State agencies may implement, in consultation with the Department of 22 23 Administration, a program to realign resources to include provisions for a separation incentive payment for employees which may 24 include the employer portion of health and dental benefits not to exceed one year. Employees participating in such program shall 25 not be eligible to participate in the Teacher and Employee Retention Incentive (TERI) program. Employees participating in such program shall be considered to have voluntarily quit their employment without good cause and be subject to the provisions of Section 26 41-35-120(1) of the South Carolina Employment Security Law. Any program developed under this provision will involve voluntary 27 28 participation from employees and will be funded within existing appropriations. The program must be approved by the agency head and the Director of the Human Resources Division based on ability to demonstrate recurring cost savings for realignment and/or 29 permanent downsizing. State agencies shall report the prior year's results to the Department of Administration by August fifteenth, 30 of the current fiscal year. The Department of Administration, upon request, shall report to the Senate Finance Committee and the 31 House Ways and Means Committee on these results. 32

33 **117.33.** (GP: Alternative Commitment to Truancy) As part of its plan for an alternative school, a school district receiving funds 34 from the Department of Education for an alternative school shall identify available alternatives to commitment for children whose 35 truancy is approaching the level of being referred to family court. When proceeding under S.C. Code Section 59-65-50 to bring an

36 individual case before the family court, the school district must present this plan as well as the district's efforts with respect to the

individual child to the court. Each school district's plan under this proviso shall include possible assignment to alternative school
 for a non-attending child before petitioning the court.

117.34. (GP: Debt Collection Reports) Each state agency shall provide to the Chairmen of the Senate Finance and House of Representatives Ways and Means Committees and the Inspector General a report detailing the amount of its outstanding debt and all methods it has used to collect that debt. This report is due by the last day of February for the previous calendar year. For purposes of this provision, outstanding debt means a sum remaining due and owed to a state agency by a nongovernmental entity for more than sixty calendar days.

8 **117.35.** (GP: State-Funded Libraries - Web Filters) (A) A library receiving state funds, directly, indirectly, by grant, or 9 otherwise, other than a library at an institution of higher learning, that has computers available for use by the public or students, or 10 both, must equip these computers with software incorporating web-filtering technology designed to eliminate or reduce the ability 11 of the computer to access sites displaying pornographic pictures or text. However, up to ten percent, and at least one, of the library's

12 computers must be unfiltered. Each library's governing officials shall determine the physical location of any unfiltered computer(s).

13 The library also must have a written policy providing sanctions against a person who instructs or demonstrates to another person 14 how to bypass this web-filtering technology.

15 (B) State funds intended for a library not in compliance with subsection (A) must be reduced by fifty percent. Funds resulting 16 from this reduction must be distributed among other libraries that are in compliance with subsection (A).

17 117.36. (GP: Tobacco Settlement Funds Carry Forward) State agencies are hereby authorized to retain and carry forward any
 unexpended Tobacco Settlement Agreement funds from the prior fiscal year into the current fiscal year and to expend such funds for
 the same purpose.

117.37. (GP: Use Tax Exemption) For the current fiscal year there is exempt from the use tax imposed pursuant to Chapter 36, Title 12 of the 1976 Code the sales price of tangible personal property purchased for use in private primary and secondary schools, including kindergartens and early childhood education programs, which are exempt from income taxes pursuant to Section 501(c)(3) of the Internal Revenue Code. For the purposes of this item, the Internal Revenue Code means Internal Revenue Code as described in Section 12-6-40 of the 1976 Code. This exemption applies for sales occurring after 1995. No refund is due any taxpayer of use tax paid on sales exempted by this paragraph.

117.38. (GP: Personal Property Tax Relief Fund) If the Personal Property Tax Exemption Sales Tax is imposed in a county and a sales tax rate of two percent of gross proceeds of sales is insufficient to offset the property tax not collected, sufficient amounts must be credited to the Trust Fund for Tax Relief established pursuant to Section 11-11-150 of the 1976 Code to provide the reimbursement to offset such a shortfall in the manner provided in Section 4-10-540(A) of the 1976 Code.

117.39. (GP: COG Annual Report) Each Council of Government shall submit a report to the Senate Finance Committee and the
 House Ways and Means Committee by December first each year describing how the funds which they received from the State in the
 prior fiscal year were expended.

117.40. (GP: Department of Administration, OEPP, Veterans Affairs) Of the funds appropriated for the Department of Administration, Office of Executive Policy and Programs, Division of Veterans Affairs, the Director of the Division shall appoint an additional claims representative within the Division of Veterans Affairs, who, in addition to being charged with the duty of assisting all ex-servicemen, regardless of the wars in which their service may have been rendered, in filing, presenting, and prosecuting to

final determination all claims which they have for money compensation, hospitalization, training, and insurance benefits under the 1 2 terms of federal legislation, shall also specialize in the specific needs and diseases associated with veterans of the Vietnam era. The person appointed as a claims representative under this section must be versed in federal legislation relating to these matters and the 3 rules, regulations, and practice of the Veterans Administration as created by Congress and his appointment must be approved by the 4 5 Governor. 6 Subject to the direction of the director, and in addition to other duties prescribed in this section, the claims representative appointed 7 pursuant to this section may represent the Division of Veterans Affairs on the South Carolina Agent Orange Advisory Council and 8 on the Hepatitis C Coalition established by the South Carolina Department of Health and Environmental Control, assist the Division of Veterans Affairs in carrying out its duties in connection with the Agent Orange Information and Assistance program, represent 9 the director in connection with functions relating to Vietnam veterans, and perform other duties as may be assigned by the director. 10 **117.41.** (GP: South Carolina Recycling Initiative) To protect the public health and safety, protect and preserve the environment 11 of this State, and to recover resources which have the potential for usefulness in the most environmentally safe, economically feasible 12 and cost effective manner, state agencies shall purchase recycled steel unless the item cannot be acquired competitively at a 13 reasonable price. 14 117.42. (GP: Life and Palmetto Fellows Scholarships Waiver Exemption) Any provision in permanent law or in Part IB, 15 Section 117 of this act, except that which is specified for LIFE and Palmetto Fellows Scholarships, that would require general fund 16 appropriations other than what is specified in Part IA of this act is waived for the current fiscal year. 17 117.43. (GP: Sole Source Procurements) The State Fiscal Accountability Authority shall evaluate and determine whether the 18 written determinations, explanations, and basis for sole source procurements, pursuant to South Carolina Code Section 11-35-1560, 19 and emergency procurements, pursuant to South Carolina Code Section 11-35-1570, are legitimate and valid reasons for awarding 20 noncompetitive contracts. 21 22 117.44. (GP: DMV Data) The Department of Motor Vehicles shall provide access, in compliance with all state and federal 23 privacy protection statues, to the following data and reports without charge to the South Carolina Department of Transportation: 24 (1) all collision data and collision reports; (2) registration information used for toll enforcement; and 25 26 (3) driver records of employees or prospective employees. 117.45. (GP: Parking Fees) State agencies shall not impose additional parking fees or increases in current fees for state 27 employees during the current fiscal year. This provision does not apply to any college or university. 28 117.46. (GP: Facility Rental Fee) The Governor's School for the Arts and Humanities, Governor's School for Science and 29 Mathematics, Wil Lou Gray Opportunity School, and John de la Howe School are authorized to charge, collect, expend and carry 30 forward fees charged for facility and equipment rental and registration. 31 117.47. (GP: Insurance Claims) Any insurance reimbursement to an agency may be used to offset expenses related to the claim. 32 These funds may be retained, expended, and carried forward. 33 117.48. (GP: Organizational Charts) All agencies, departments and institutions of state government shall furnish to the Human 34 Resources Division (1) a current personnel organizational chart annually no later than September first of the current fiscal year, or 35 upon the request of the division and (2) notification of any change to the agency's organizational structure which impacts an 36

1 employee's grievance rights within thirty days of such change. The organizational chart shall be in a form prescribed by the Human

2 Resources Division showing all authorized positions, class title, class code, position number and indications as to whether such 3 positions are filled or vacant. In addition, the organizational chart shall clearly identify those employees who are exempt from the

4 State Employee Grievance Procedure Act.

5 **117.49.** (GP: Agencies Affected by Restructuring) Upon restructuring of state agencies by the General Assembly the Department 6 of Administration is directed to work with affected State agencies in order to phase-in operations of restructured organizations during 7 the current fiscal year. Restructured organizations should be operating entirely under the revised structure no later than December 8 thirty-first, of the current fiscal year, unless otherwise directed by law. The department is further directed to work with the affected agencies in order to identify and facilitate the transfer of any portion of their operations, including transfer of funds during the current 9 fiscal year, which is affected by the restructured organization adopted by the General Assembly, but which has not already been 10 accomplished herein. Until sufficient changes can be made to the State's accounting system and the appointment of appropriate 11 12 agency heads, the Comptroller General and the State Treasurer shall allow those agencies affected by restructuring to continue processing documents within the account structure existing on June thirtieth, of the prior fiscal year. Restructured agencies shall 13 make all the necessary accounting adjustments to complete the transition to the new account structure as soon as possible, but no 14 later than December thirty-first, of the current fiscal year, unless otherwise directed by law. The Executive Budget Office is directed 15 to prepare the subsequent detail budget to conform Part IA and corresponding provisos in this act to any restructuring changes that 16 are ratified. 17

18 117.50. (GP: Agency Administrative Support Collaboration) It is the intent of the General Assembly that state agencies continue
 to actively pursue cost savings measures through collaborative efforts and where feasible may combine administrative support
 functions with other agencies in order to maximize efficiency and effectiveness.

117.51. (GP: Assessment Audit / Crime Victim Funds) If the State Auditor finds that any county treasurer, municipal treasurer, 21 county clerk of court, magistrate, or municipal court has not properly allocated revenue generated from court fines, fines, and 22 23 assessments to the crime victim funds or has not properly expended crime victim funds, pursuant to Sections 14-1-206(B) and (D), 14-1-207(B) and (D), 14-1-208(B) and (D), and 14-1-211(B) of the 1976 Code, the State Auditor shall notify the State Office of 24 Victim Assistance Department of Crime Victim Compensation. The State Office of Victim Assistance Department of Crime Victim 25 *Compensation* is authorized to conduct an audit which shall include both a programmatic review and financial audit of any entity or 26 nonprofit organization receiving victim assistance funding based on the referrals from the State Auditor or complaints of a specific 27 28 nature received by the State Office of Victim Assistance Department of Crime Victim Compensation to ensure that crime victim funds are expended in accordance with the law. Guidelines for the expenditure of these funds shall be developed by the Victim 29 Services Coordinating Council. The Victim Services Coordinating Council shall develop these guidelines to ensure any expenditure 30 which meets the parameters of Article 15, Chapter 3, Title 16 is an allowable expenditure. Any local entity or nonprofit organization 31 that receives funding from revenue generated from crime victim funds is required to submit their budget for the expenditure of these 32 funds to the State Office of Victim Assistance Department of Crime Victim Compensation within thirty days of the budget's approval 33 34 by the governing body of the entity or nonprofit organization. Failure to comply with this provision shall cause the State Office of Victim Assistance Department of Crime Victim Compensation to initiate a programmatic review and a financial audit of the entity's 35 or nonprofit organization's expenditures of victim assistance funds. Additionally, the Office of Victim Assistance Department of 36

Crime Victim Compensation will place the name of the noncompliant entity or nonprofit organization on their website where it shall 1 2 remain until such time as they are in compliance with the terms of this proviso. Any entity or nonprofit organization receiving victim assistance funding must cooperate and provide expenditure/program data requested by the State Office of Victim Assistance 3 4 Department of Crime Victim Compensation. If the State Office of Victim Assistance Department of Crime Victim Compensation 5 finds an error, the entity or nonprofit organization has ninety days to rectify the error. An error constitutes an entity or nonprofit 6 organization spending victim assistance funding on unauthorized items as determined by the State Office of Victim Assistance 7 Department of Crime Victim Compensation. If the entity or nonprofit organization fails to cooperate with the programmatic review and financial audit or to rectify the error within ninety days, the State Office of Victim Assistance Department of Crime Victim 8 Compensation shall assess and collect a penalty in the amount of the unauthorized expenditure plus \$1,500 against the entity or 9 nonprofit organization for improper expenditures. This penalty plus \$1,500 must be paid within thirty days of the notification 10 by the State Office of Victim Assistance Department of Crime Victim Compensation to the entity or nonprofit organization that 11 they are in noncompliance with the provisions of this proviso. All penalties received by the State Office of Victim Assistance 12 Department of Crime Victim Compensation shall be credited to the General Fund of the State. If the penalty is not received by the 13 State Office of Victim Assistance Department of Crime Victim Compensation within thirty days of the notification, the political 14 subdivision will deduct the amount of the penalty from the entity or nonprofit organization's subsequent fiscal year appropriation. 15 **117.52.** (GP: H.L. Hunley Museum Location) The General Assembly approves the City of North Charleston as the permanent 16 site of the H.L. Hunley Museum. This approval is contingent upon the negotiation and execution of necessary contracts between the 17 State of South Carolina and the City of North Charleston. The Hunley Commission is directed to expend funds from its account to 18 negotiate and execute contracts on behalf of the State of South Carolina. 19 117.53. (GP: Secure Juvenile Confinement) The Attorney General shall review the interpretation of the current policies of the 20 Department of Public Safety and the Department of Corrections regarding secure juvenile confinement that the departments indicate 21 may jeopardize federal grant funds. The departments may not implement any changes to the current policies regarding secure juvenile 22 23 confinement until the Attorney General considers the departments' interpretation of the federal Juvenile Justice and Delinquency Prevention Act in regard to the secure holding of juveniles for more than six hours in adult detention facilities that also serve as 24 25 forty-eight-hour juvenile holdover facilities. The Attorney General will determine if the departments' interpretation is fair and equitable and how the local governments and the Department of Juvenile Justice would be impacted, to include any financial 26 27 considerations. 28 117.54. (GP: ISCEDC Funding Transfer) The departments of Mental Health, Disabilities and Special Needs, and Juvenile Justice 29 are directed to transfer a total of \$1,199,456 in funds to the Department of Social Services for the support of the Interagency System for Caring for Emotionally Disturbed Children. Funding transfers shall be in the following amounts: Department of Mental 30 31 Health - \$595,000, Department of Disabilities and Special Needs - \$379,456, and Department of Juvenile Justice - \$225,000. The transfer of funds shall be accomplished by September thirtieth of the current fiscal year. 32

33 117.55. (GP: Employee Bonuses) State agencies and institutions are allowed to spend state, federal, and other sources of revenue 34 to provide selected employees lump sum bonuses, not to exceed three thousand dollars per year, based on objective guidelines 35 established by the Department of Administration. Payment of these bonuses is not a part of the employee's base salary and is not 36 earnable compensation for purposes of employee and employer contributions to respective retirement systems. Employees earning

1 \$100,000 or more shall not be eligible to receive bonuses under this provision. The employing agency must report this information

2 on or before August thirty-first of each year and must include the total amount and source of the bonus received by the employee

during the preceding fiscal year (July first through June thirtieth). The Human Resources Division of the Department of
 Administration shall formulate policies and procedures to ensure compliance with the reporting provisions of this proviso. Copies

5 of the reports shall be made available to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and

6 Means Committee, upon request.

117.56. (GP: FEMA Flexibility) Any appropriation designated as the state share for a federally declared disaster may be carried forward and used for the same purpose by the Emergency Management Division of the Adjutant General's Office in the event of additional federally declared disasters. Unallocated funds from established state accounts may be used as the state share in any federally declared disaster. These funds may also be used during a Governor's state of emergency to augment existing state appropriations of the South Carolina Emergency Management Division (SCEMD). When these funds are used during a Governor's state of emergency, the allocation of those funds following the event will be determined by the Governor based on the recommendation of the Adjutant General and the Director of the South Carolina Emergency Management Division.

In the event there is a federally declared disaster and state match funds are unavailable, the State Fiscal Accountability Authority may borrow from any internal account or accounts necessary to maximize federal matching funds through the Emergency Management Division. Any such borrowing must be reported to the General Assembly within five days. Funds borrowed from accounts shall be replenished by the General Assembly as soon as practicable.

18 **117.57.** (GP: Respiratory Syncytial Virus Prescription Sales and Use Tax Exemption) The effective date of the exemption from 19 sales and use tax of prescription medicines used to prevent respiratory syncytial virus shall be January 1, 1999. No refund of sales 20 and use taxes may be claimed as a result of this provision.

117.58. (GP: Year-End Financial Statements - Penalties) Agencies, institutions, and other reporting entities required to submit 21 annual audited financial statements for inclusion in the State's Comprehensive Annual Financial Report must submit final audited 22 23 financial statements to the Comptroller General not later than October first for those with fiscal year-end June thirtieth. The South Carolina Retirement Systems, Insurance Benefits, and Other Post-Employment Benefits Trust Funds administered by the South 24 25 Carolina Public Employee Benefit Authority must submit their final audited financial statements no later than October fifteenth. For 26 institutions and reporting entities with fiscal year-ends other than June thirtieth, final audited financial statements must be submitted 27 to the Comptroller General within 120 days of that fiscal year-end. The Comptroller General shall provide a written report of each 28 agency, institution, or other reporting entity not in compliance with this provision to the State Fiscal Accountability Authority by 29 November thirtieth.

30 **117.59.** (GP: Purchase Card Incentive Rebates) In addition to the Purchase Card Rebate deposited in the general fund, any 31 incentive rebate premium received by an agency from the Purchase Card Program may be retained and used by the agency to support 32 its operations.

117.60. (GP: Sex Offender Monitoring and Supervision) The funds appropriated to the Department of Probation, Parole and
 Pardon Services in Part IA, Section 66, Program II.A.2. for the Sex Offender Monitoring Program and to the Department of Juvenile
 Justice in Part IA, Section 67, Program III.A. Special Item: Sex Offender Monitoring are to be used and expended only for GPS

36 monitoring programs of the departments. In cases of limited funds, monitoring of "Jessie's Law" offenders shall take precedence

over all other GPS programs of the departments. Funds appropriated for this program may not be used for any other purpose or 1 2 transferred to any other program. Unexpended funds appropriated for Sex Offender Monitoring may be carried forward and used for the same purpose. The departments are directed to submit a report to the General Assembly by January fifteenth each year 3 4 accounting for the expenditure of the funds including any carry-forward funding; the total costs and per-day costs for equipment, 5 supervision, and monitoring; the total number of staff assigned to the activity and the average agent caseloads; the amount of funds collected from sex offenders for both intensive supervision and electronic monitoring; and the anticipated fiscal needs for the 6 7 upcoming fiscal year. The report shall also include, but not be limited to, data regarding the number of offenders sentenced to 8 electronic monitoring, including the number sentenced for life; the number of alert notifications received, investigated, and prosecuted; and the number of offenders returned to prison as a result of electronic monitoring violations. 9 **117.61.** (GP: Viscosupplementation Therapies Sales and Use Tax Exemption) For the current fiscal year only, sales and use 10

11 taxes on viscosupplementation therapies shall be suspended. No refund or forgiveness of tax may be claimed as a result of this provision.

13 117.62. (GP: CID & PCC Agency Head Salaries) All hiring salaries and salary increases for the agency heads of the Commission
 on Indigent Defense and the Prosecution Coordination Commission shall be subject to all provisions related to agency heads covered
 by the Agency Head Salary Commission.

16 **117.63.** (GP: Prosecutors and Defenders Public Service Incentive Program) The Office of Attorney General, the Prosecution 17 Coordination Commission, and the Commission on Indigent Defense, in consultation with the South Carolina Student Loan 18 Corporation and the Commission on Higher Education, shall develop and implement a Prosecutors and Defenders Public Service 19 Incentive Program for attorneys employed by the Office of Attorney General, the Prosecution Coordination Commission, the 20 Commission on Indigent Defense, a Circuit Solicitor's Office or a county Public Defender's Office.

After more than three years of continuous service as a full-time attorney with any of these entities, qualifying attorneys may be reimbursed up to \$1,000 for payments made in the prior calendar year on outstanding law school loans. Reimbursements for law school loan payments may be increased by up to \$1,000 for each additional year of continuous service; however, such reimbursements shall not exceed \$5,000 in any year. The amount of law school loan payment reimbursement in any calendar year shall not exceed the amount of principal and interest paid on the loan in the prior calendar year. Reimbursements under the program may continue until all outstanding law school loans are satisfied; however, such reimbursements shall not exceed \$40,000 per qualifying attorney.

27 Reimbursements shall be adjusted if necessary so as not to exceed appropriations for the program.

The Prosecutors and Defenders Public Service Incentive Program must be administered by the South Carolina Student Loan Corporation, which shall pay for the cost of administration within the funds appropriated.

The Office of Attorney General, the Prosecution Coordination Commission, and the Commission on Indigent Defense shall each compile a report that includes, but is not limited to, the number of applicants and the impact of the program on attracting and retaining

32 attorneys. The Student Loan Corporation shall compile a report that includes, but is not limited to, the cost of administering the

33 program as well as the amount of reimbursements per agency or entity. Such reports shall be submitted to the Senate Finance

34 Committee and the House Ways and Means Committee by September first each fiscal year.

Unexpended program funds from the prior fiscal year may be carried forward into the current fiscal year to be used for the same purpose.

117.64. (GP: Attorney Dues) Agencies and offices of the State of South Carolina that employ attorneys are authorized, if they 1 2 so decide, to use other appropriated funds, including General Fund carry forward funds, to pay the costs of mandatory dues owed to the South Carolina Bar Association. 3 4 **117.65.** (GP: Healthcare Critical Employee Recruitment and Retention) The Department of Corrections. Department of 5 Disabilities and Special Needs, Department of Health and Environmental Control, Department of Health and Human Services, 6 Department of Juvenile Justice, Department of Mental Health, Department of Vocational Rehabilitation, and Wil Lou Grav 7 Opportunity School State agencies are allowed to spend state, federal, and other sources of revenue to provide lump sum bonuses 8 to aid in recruiting and retaining healthcare workers in critical needs healthcare jobs based on objective guidelines established by the Department of Administration which provide services that directly impact the health, safety, and welfare of the public. The employee 9 bonus amount shall be approved by the State Human Resources Director based on State Human Resources guidelines, and shall not 10 exceed \$10,000 per year. Payment of these bonuses is not a part of the employee's base salary and is not earnable compensation for 11 purposes of employee and employer contributions to respective retirement systems. These bonuses shall, however, be considered 12 earnings for determining if an employee who has returned to work after retirement is subject to the earning limitation imposed in 13 *either Section 9-1-1790(A)(1) or Section 9-11-(4)(a)(i).* 14 These agencies may also provide paid educational leave for any employees employee in an a FTE position deemed critical by the 15 Department of Administration to attend class while enrolled in healthcare degree programs that are related to the agency's mission. 16 All such leave is at the agency head's discretion. 17 These agencies may enter into an agreement with Psychiatrists, Psychologists, and Nurses individuals employed in those critical 18 needs positions to repay them for their outstanding student loans associated with completion of a healthcare relevant degree. The 19 employee must be employed in a critical needs area, which would be identified at the agency head's discretion. Critical needs areas 20 could include rural areas, areas with high turnover, or where the agency has experienced recruiting difficulties. Agencies may pay 21 these employees up to twenty percent or \$7,500, whichever is less, of their outstanding student loan each year over a five-year period. 22 23 Payments will be made directly to the employee at the end of each year of employment. The agency will be responsible for verifying 24 the principle principal balance of the employee's student loan prior to issuing payments. 25 Employees of these agencies working on a practicum or required clinical experience towards completion of a healthcare degree may be allowed to complete these requirements at their state agency or another state agency at the discretion of the agency head. 26 This field placement at another state agency may be considered work time for participating employees. 27 These agencies Agencies are also authorized to allow tuition reimbursement from a maximum of ten credit hours per semester; 28 29 allow probationary employees to participate in tuition programs; and provide tuition prepayment instead of tuition reimbursement for employees willing to pursue a degree in a healthcare program. An agency may pay up to fifty percent of an employee's tuition 30 through tuition prepayment. The remaining tuition could be reimbursed to the employee after successful completion of the class. 31 The Department of Administration shall approve of the designation of critical needs positions applicable to this provision using 32 guidelines that include, but are not limited to: 1) the difficulty recruiting for the positions as reflected by data such as the vacancy 33 rate maintained, the average time to fill, the lack of sufficient qualified applicants, and other objective factors; 2) the difficulty 34 35 retaining employees in the positions as shown by turnover data; 3) justification by the state agency that the position is critical to the

core mission of the agency and directly impacts the health, safety and welfare of the public; and 4) assurances from the state agency 1 2 that there are sufficient existing funds available to pay for items under this provision. Healthcare employees in approved critical needs positions working on a practicum or required clinical experience towards 3 completion of a healthcare degree may be allowed to complete these requirements at their state agency or another state agency at 4 the discretion of the agency head. This field placement at another state agency may be considered work time for participating 5 6 employees. 7 State agencies must report to the Department of Administration by August 31st of each year any expenditure under this provision. The Department of Administration shall compile a report of the responses and submit them to the Chairman of the Senate Finance 8 Committee and the Chairman of the House Ways and Means Committee by October 1st of each year. 9 117.66. (GP: Governor's Budget Certification) The annual Executive Budget proposed by the Governor must be certified by the 10 Director of the Revenue and Fiscal Affairs Office or his designee in the same manner as the House Ways and Means and Senate 11 Finance Committee versions of the budget bill are certified. 12 117.67. (GP: Sexually Violent Predator Program) After the Department of Mental Health obtains all necessary project approvals, 13 the Department of Corrections may utilize inmate labor to perform any portion of the construction of an addition to the Edisto Unit 14 15 at the Broad River Correctional Institution, which houses the Department of Mental Health's Sexually Violent Predator Treatment Program, such addition to be used for additional treatment space and staff offices. For purposes of this project, the Department of 16 Corrections may exceed the \$350,000 limit on projects for which it may use inmate labor. 17 **117.68.** (GP: Voluntary Furlough) Agency heads may institute a voluntary employee furlough program of not more than ninety 18 days per fiscal year. During this voluntary furlough, the state employees shall be entitled to participate in the same state benefits as 19 otherwise available to them except for receiving their salaries. As to those benefits which require employer and employee 20 contributions, the state agencies, institutions and departments will be responsible for making both employee and employee 21 contributions if coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the 22 23 employee remains solely responsible for making those contributions. In the event an agency's reduction is due solely to the General 24 Assembly transferring or deleting a program, this provision does not apply. 117.69. (GP: Governor's Security Detail) The State Law Enforcement Division, the Department of Public Safety, and the 25 Department of Natural Resources shall provide a security detail to the Governor in a manner agreed to by the State Law Enforcement 26 Division, the Department of Public Safety, the Department of Natural Resources, and the Office of Governor. Reimbursement to the 27 28 State Law Enforcement Division, the Department of Public Safety, and the Department of Natural Resources to offset the cost of the security detail for the Governor shall be made in an amount agreed to by the State Law Enforcement Division, the Department of 29 Public Safety, the Department of Natural Resources, and the Office of Governor from funds appropriated to the Office of Governor 30 31 for this purpose. Law enforcement officers assigned to security detail for the Governor shall only perform services related to security and shall not provide any unrelated service during the assignment. 32 **117.70.** (GP: Reduction in Force Antidiscrimination) In the event of a reduction in force implemented by a state agency or 33 34 institution, the state agency or institution must comply with Title VII of the Civil Rights Act of 1964 or any other applicable federal

35 or state antidiscrimination laws.

117.71. (GP: Reduction in Force/Agency Head Furlough) In the event a reduction in force is implemented by a state agency or 1 2 institution of higher learning, the agency head shall be required to take five days furlough in the current fiscal year. If more than one reduction in force plan is implemented in a fiscal year, the mandatory agency head furlough is only required for the initial plan. The 3 4 agency head will retain all responsibilities and authority during the furlough. All monies saved from this furlough may be retained by that agency and expended at the discretion of the agency head. During this furlough, the agency head shall be entitled to participate 5 6 in the same state benefits as otherwise available to them except for receiving their salaries. As to those benefits which require 7 employer and employee contributions, the state agency will be responsible for making both employer and employee contributions if 8 coverage would otherwise be interrupted; and as to those benefits which require only employee contributions, the agency head remains solely responsible for making those contributions. 9 Placement of an agency head on furlough under this provision does not constitute a grievance or appeal under the State Employee 10 Grievance Procedure Act. In the event the reduction for the state agency or institution of higher learning is due solely to the General 11 Assembly transferring or deleting a program, this provision does not apply. Agencies may allocate the agency head's reduction in 12 pay over the balance of the fiscal year for payroll purposes regardless of the pay period within which the furlough occurs. The 13 Department of Administration shall promulgate guidelines and policies, as necessary, to implement the provisions of this proviso. 14 State agencies shall report information regarding furloughs to the Department of Administration. 15 For purposes of this provision, agency head includes the president of a technical college as defined by Section 59-103-5 of the 16 1976 Code. 17 The agency head of the State Board for Technical and Comprehensive Education shall not be required to take this mandatory 18 furlough based solely on the implementation of a reduction in force plan by a technical college. 19 An agency head shall not be required to take this mandatory furlough based solely on reductions in force implemented as a result 20 of federal budget cuts or reorganization to accomplish organizational efficiencies. 21 117.72. (GP: Printed Report Requirements) (A) For Fiscal Year 2017-18 2018-19, state supported institutions of higher learning 22 23 shall not be required to submit printed reports mandated by Sections 2-47-40, 2-47-50, and 59-103-110 of the 1976 Code, and shall 24 instead only submit the documents electronically. 25 Submission of the plans or reports required by Sections 59-101-350, 59-103-30, 59-103-45(4), and 59-103-160(D) shall be waived for the current fiscal year, except institutions of higher learning must continue to report student pass rates on professional 26 27 examinations, and data elements otherwise required for the Commission on Higher Education Management Information System. 28 The commission, in consultation with institutions, shall take further action to reduce data reporting burdens as possible. (B) For Fiscal Year 2017-18 2018-19, the Department of Agriculture shall not be required to submit printed reports mandated by 29 Section 46-49-10 of the 1976 Code. The department shall provide these reports electronically and shall use any monetary savings 30 31 for K5-12 agricultural education programs. (C) For Fiscal Year 2017-18 2018-19, the Department of Health and Human Services shall not be required to provide printed 32

copies of the Medicaid Annual Report required pursuant to Section 44-6-80 of the 1976 Code and shall instead only submit the documents electronically.

35 (D) For Fiscal Year 2017-18 2018-19, the Department of Transportation shall not be required to submit printed reports or 36 publications mandated by Sections 1-11-58, 2-47-55, and 58-17-1450 of the 1976 Code.

The Department of Transportation may combine their Annual Report and Mass Transit Report into their Annual Accountability
 Report.

117.73. (GP: IMD Operations) The Department of Health and Human Services shall produce an annual report on 3 Medicaid-funded out-of-home placements and associated expenditures which shall be provided to the Chairman of the Senate 4 5 Finance Committee, Chairman of the House Ways and Means Committee, and the Governor no later than November first each year. 6 **117.74.** (GP: Fines and Fees Report) In order to promote accountability and transparency, each state agency must provide and 7 release to the public via the agency's website, a report of all aggregate amounts of fines and fees that were charged and collected by 8 that state agency in the prior fiscal year. The report shall include, but not be limited to: (1) the code section, regulation, or proviso that authorized the fines and fees to be charged, collected, or received; (2) the amount of the fine or fee; (3) the amount received by 9 source; (4) the purpose for which the funds were expended by the agency; (5) the amount of funds transferred to the general fund, if 10 applicable, and the authority by which the transfer took place; and (6) the amount of funds transferred to another entity, if applicable, 11 and the authority by which the transfer took place, as well as the name of the entity to which the funds were transferred. The report 12 must be posted online by September first. Additionally, the report must be delivered to the Chairman of the Senate Finance 13 Committee and the Chairman of the House Ways and Means Committee by September first. Funds appropriated to and/or authorized 14 15 for use by each state agency shall be used to accomplish this directive. **117.75.** (GP: Mandatory Furlough) In a fiscal year in which the general funds appropriated for a state agency are less than the 16 general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 17 implements a midyear across-the-board budget reduction, and agency heads institute a mandatory employee furlough program, in 18 determining which employees must participate in the program, agency heads should give consideration to furloughs for contract 19

employees, post-TERI employees, and TERI employees before other employees. During this mandatory furlough, the state 20 employees shall be entitled to participate in the same state benefits as otherwise available to them except for receiving their salaries. 21 22 As to those benefits which require employer and employee contributions, the state agencies, institutions, and departments will be 23 responsible for making both employer and employee contributions if coverage would otherwise be interrupted; and as to those 24 benefits which require only employee contributions, the employee remains solely responsible for making those contributions. In the 25 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 26 **117.76.** (GP: Reduction In Force) In a fiscal year in which the general funds appropriated for a state agency are less than the general funds appropriated for that agency in the prior fiscal year, or whenever the General Assembly or the Executive Budget Office 27 implements a midyear across-the-board budget reduction, and agency heads must make reductions in force, agency heads should 28 give consideration to reductions of contract employees, post-TERI employees, and TERI employees before other employees. In the 29 event an agency's reduction is due solely to the General Assembly transferring or deleting a program, this provision does not apply. 30 31 117.77. (GP: Cost Savings When Filling Vacancies Created by Retirements) During the current fiscal year, whenever classified FTEs become vacant because of employee retirements, it is the intent of the General Assembly that state agencies should realize 32 personnel costs savings of at least twenty-five percent in the aggregate when managing these vacant positions. Prior to filling a 33 34 classified FTE which has become vacant because of a retirement, an agency must review and determine the appropriate salary for

35 the position as well as determine whether the agency can manage without filling the position or by delay in filling the position. Prior

to filling the vacant FTE, agencies must follow all laws and regulations concerning posting and competitive solicitation and consideration of applicants. No agency shall enter into any agreement with any employee that violates the terms of this proviso.

117.78. (GP: Information Technology for Health Care) From the funds appropriated and awarded to the South Carolina 3 4 Department of Health and Human Services for the Health Information Technology for Economic and Clinical Health Act of 2009, 5 the department shall advance the use of health information technology and health information exchange to improve quality and 6 efficiency of health care and to decrease the costs of health care. In order to facilitate the gualification of Medicare and/or Medicaid 7 eligible providers and hospitals for incentive payments for meaningful health information technology (HIT) use, a health care 8 organization participating in the South Carolina Health Information Exchange (SCHIEx) or a Regional Health Information Organization (RHIO) or a hospital system health information exchange (HIE) that participates in SCHIEx may release patient records 9 and medical information, including the results of any laboratory or other tests ordered or requested by an authorized health care 10 provider within the scope of his or her license or practice act, to another health information organization that requests the information 11 12 via a HIE for treatment purposes with or without express written consent or authorization from the patient. A health information organization that receives or views this information from a patient's electronic health record or incorporates this information into the 13 health information organization's electronic medical record for the patient in providing treatment is considered an authorized person 14 for purposes of 42 C.F.R. 493.2 and the Clinical Laboratory Improvement Amendments. 15

117.79. (GP: Broadband Spectrum Lease) The General Assembly must approve any exercise of the Middle Band Segment 16 Channel recapture provisions contained in the Educational Broadband Service Spectrum Lease Agreements if the exercise of the 17 recapture provisions would result in a decrease in payments received by the State. The Educational Television Commission assumes 18 management and administration of the lease and receives lease payments directly. The Educational Television Commission shall 19 retain and expend funds received pursuant to the lease for agency operations. The commission shall be authorized to carry forward 20 unexpended funds from the prior fiscal year into the current fiscal year. In the event of a default by the current lease holder, the 21 Educational Television Commission is authorized to use contingent funds up until such time as a new lease can be negotiated by the 22 23 State and the Educational Television Commission.

117.80. (GP: Reduction in Compensation) For the current fiscal year, no state agency or political subdivision of this state may decrease the compensation of an employee, including dismissal, suspension, or demotion, solely because the employee gave sworn testimony regarding alleged wrongdoing to a standing committee, subcommittee of a standing committee, or study committee of the Senate or the House of Representatives. This proviso shall apply regardless of when the alleged wrongdoing occurred.

117.81. (GP: Deficit Monitoring) It is the responsibility of each state agency, department, and institution to operate within the limits of its authorized appropriations. All agencies, departments, and institutions are to budget, allocate and manage its authorized appropriations in a way to avoid an operating deficit for the fiscal year.

If at the end of each quarterly deficit monitoring review by the Executive Budget Office, it is determined by either the Executive Budget Office or a state agency, department, or institution that the likelihood of a deficit for the current fiscal year exists, the state agency shall notify the General Assembly within fifteen days of this determination and shall further request the Executive Budget

34 Office to work with it to develop a plan to avoid the deficit. Within fifteen days of the deficit avoidance plan being completed, the

54 Office to work with it to develop a plan to avoid the deficit. Within fifteen days of the deficit avoidance plan being completed, the

35 Executive Budget Office shall either request the General Assembly to recognize the deficit if it determines the deficit avoidance plan

will not be sufficient to avoid a deficit or notify the General Assembly of how the deficit will be avoided based on the deficit
 avoidance plan if the Executive Budget Office determines the plan will be sufficient to avoid a deficit.

Upon notification from the Executive Budget Office that an agency will run a deficit and requesting that it be recognized, the General Assembly, by joint resolution, may make a finding that the cause of, or likelihood of, a deficit is unavoidable due to factors which are outside the control of the state agency, department, or institution, and recognize the deficit. Any legislation to recognize a deficit must be in a separate joint resolution enacted for the sole purpose of recognizing the deficit of a particular state agency.

7 department, or institution. A deficit may only be recognized by an affirmative vote of each branch of the General Assembly.

8 If the General Assembly recognizes the deficit, then the actual deficit at the close of the fiscal year must be reduced as necessary 9 from surplus revenues or surplus funds available at the close of the fiscal year in which the deficit occurs and from funds available 10 in the General Reserve Fund and the Capital Reserve Fund, as required by the Constitution of this State.

Once a deficit has been recognized by the General Assembly, the state agency, department, or institution shall limit travel and conference attendance to that which is deemed essential by the director of the agency, department, or institution. In addition, the General Assembly, when recognizing a deficit may direct that any pay increases and purchases of equipment and vehicles must be approved by the Executive Budget Office.

15 117.82. (GP: Commuting Costs) State government employees who use a permanently assigned agency or state-owned vehicle to commute from their permanently assigned work location to and from the employee's home must reimburse the agency in which 16 they are employed for commuting use in accordance with IRS regulations based on guidance from the Office of Comptroller General 17 which must use the Cents per mile Rule, unless they are exempted from such reimbursement by applicable IRS regulations. These 18 permanently assigned vehicles must be clearly marked as a state or agency vehicle through the use of permanent state-government 19 license plates and either state or agency seal decals unless the vehicle is used primarily in undercover operations. This requirement 20 does not apply to a vehicle used by an employee for the purpose of a special travel assignment, for active certified law enforcement 21 officers authorized to carry firearms, execute warrants, and make arrests, for Constitutional Officers, or for Department of 22 Transportation employees on call for emergency maintenance. 23

24 **117.83.** (GP: Bank Account Transparency and Accountability) Each state agency, except state institutions of higher learning, 25 which has composite reservoir bank accounts or any other accounts containing public funds which are not included in the Comptroller 26 General's South Carolina Enterprise Information System shall prepare a report for each account disclosing every transaction of the account in the prior fiscal year. The report shall be submitted to the State Fiscal Accountability Authority by October first of each 27 28 fiscal year. The report shall include the name(s) and title(s) of each person authorized to sign checks or make withdrawals from each account, the name and title of each person responsible for reconciling each account, the beginning and year-end balance of funds in 29 each account, and data related to both deposits and expenditures of each account. The report shall include, but not be limited to, the 30 31 date, amount, and source of each deposit transaction and the date, name of the payee, the transaction amount, and a description of the goods or services purchased for each expenditure transaction. To facilitate review, the State Fiscal Accountability Authority 32 shall prescribe a common format for the report which agencies must use. In order to promote accountability and transparency, a link 33 34 to the report shall be posted on the Comptroller General's website as well as the agency's homepage.

When the State Auditor conducts or contracts for an audit of a state agency, accounts of the agency subject to this proviso must be included as part of the review.

If an agency determines that the release of the information required in this provision would be detrimental to the state or the 1 2 agency, the agency may petition the State Fiscal Accountability Authority to grant the agency an exemption from the reporting requirements for the detrimental portion. The meeting to determine whether an exemption should be granted shall be closed. 3 4 However, the exemption may only be granted upon a majority vote of the State Fiscal Accountability Authority in a public meeting. 5 **117.84.** (GP: Websites) All agencies, departments, and institutions of state government shall be responsible for providing on its 6 Internet website a link to the Internet website of any agency, other than the individual agency, department, or institution, that posts 7 on its Internet website that agency, department, or institution's monthly state procurement card statements or monthly reports 8 containing all or substantially all the same information contained in the monthly state procurement card statements. The link must be to the specific webpage or section on the website of the agency where the state procurement card information for the state agency, 9 department, or institution can be found. The information posted may not contain the state procurement card number. Any 10 information that is expressly prohibited from public disclosure by federal or state law or regulation must be redacted from any posting 11 12 required by this section.

13 **117.85.** (GP: Regulations) For the current fiscal year, if a state agency proposes a regulation that levies or increases a fee, fine, or that otherwise generates revenues, the title to the Joint Resolution which proposes the regulation must indicate that a fee, fine, or revenue source is being proposed.

117.86. (GP: Joint Children's Committee) For the current fiscal year, the Department of Revenue is directed to reduce the rate 16 of interest paid on eligible refunds by one percentage point. Of the revenue resulting from this reduction, \$300,000 shall be 17 transferred to the Senate for the Joint Citizens and Legislative Committee on Children to provide the report, research, and other 18 operating expenses as directed in Section 63-1-50 of the 1976 Code. Funds transferred to the University of South Carolina for the 19 Joint Citizens and Legislative Committee on Children shall be maintained in a separate and distinct account. A detailed report of all 20 expenditures shall be made to the Executive Budget Office within thirty days of the close each fiscal quarter, and the Executive 21 Budget Office shall distribute this information to the Chairman of the Senate Finance Committee and the Chairman of the House 22 23 Ways and Means Committee. The remaining revenue resulting from this reduction shall be transferred to the Department of Juvenile Justice to be used for mentoring or alternatives to incarceration programs. Unexpended funds authorized by this provision may be 24 25 retained and carried forward by the Senate or the Department of Juvenile Justice, respectively, and used for the same purposes. The 26 rate of reduction authorized in this provision shall be in addition to the reduction authorized in Proviso 93.7.

27 117.87. (GP: Civil Conspiracy Defense Costs) For the current fiscal year, for any claim that has not reached a judgment, if a 28 state or local government employee or former state or local government employee ("government employee") is personally sued for civil conspiracy based in part upon a personnel or employment action or decision regarding an employee, the court must, prior to 29 trial, make a final determination whether the action or decision giving rise to the suit was made by the government employee within 30 31 the scope of their official duty. If the court finds that the government employee was acting outside the scope of the employee's official duties, the government shall not thereafter expend any funds to pay or defend the claim. If the court finds the government 32 employee was acting within the scope of their official duties, the employee is immune from suit, liability, and damages with respect 33 34 to the civil conspiracy claim. The government may only expend funds to defend the claim if the determination is that the employee was acting within the scope of their official duties. Nothing in this proviso prevents an insurance provider from defending and 35 paying, respectively, any claims that the provider has contractually agreed to defend and pay. 36

117.88. (GP: Recovery Audits) The State Fiscal Accountability Authority shall contract with one or more firms to conduct 1 2 recovery audits of payments made by all state agencies to vendors for goods and services. The audits must be designed to detect, document, and recover overpayments and erroneous payments to the vendors and to recommend improved financial and operational 3 4 practices and procedures. A state agency shall pay, from recovered monies received, the recovery audit firm responsible for obtaining 5 for the agency a reimbursement or payment from a vendor a negotiated fee not to exceed twenty percent of the funds recovered by 6 that firm. 7 Unless otherwise restricted by law, funds recovered, less the cost of recovery, shall be remitted to a special fund subject to appropriation by the General Assembly. Agencies may recover costs that are documented to be directly related to implementation 8 9 of this provision. Recovery audits apply only to payments made more than one hundred eighty days prior to the date the audit is initiated and shall 10 cover at least three complete fiscal years. 11 All information provided under a contract must be treated as confidential by the recovery audit firm. A violation of this provision 12 shall result in the forfeiture by the firm of all compensation under the contract and to the same sanctions and penalties that would 13 apply to that disclosure. 14 15 Each state agency shall participate in this recovery audit program and shall cooperate and provide the recovery audit firm with all information necessary for the audit in a timely manner. All vendors that provide goods or services to a state agency shall cooperate 16 with the recovery audit firm in its audit. 17 A state agency shall expend or return to the federal government any federal money that is recovered through a recovery audit 18 conducted under this provision. Payments to the recovery audit firm from the federal share of recovered funds shall be solely from 19 the federal portion as allowed by the federal agency. 20 In addition to performing the recovery audits, the recovery audit firm may conduct an analysis of contracts and pricing structures, 21 as determined and directed by the Executive Director of the State Fiscal Accountability Authority or her or his designee, to identify 22 23 and recommend future cost-savings and improved state agency financial operations going forward. A state agency shall pay the 24 recovery audit firm responsible for obtaining the agency actual cost-savings a fee as authorized by the contract with the recovery 25 audit firm. 26 The recovery audit firm shall provide reports to the State Fiscal Accountability Authority detailing its findings, the causes for the overpayments and erroneous payments, future cost-savings opportunities and its recommendations for strengthening state operations 27 and/or state contracts to prevent improper payments in the future. 28 For purposes of this proviso, the term "vendor" or "vendors" includes, but is not limited to, sellers, suppliers, service providers, 29 other providers, contractors and third party administrators; the term "overpayments and erroneous payments" includes, but is not 30 limited to, overpayments, duplicate payments, erroneous payments, and rebates, discounts and credits not received; and the term 31 "state agency" or "state agencies" includes all state agencies, boards, commissions, institutions and institutions of higher education. 32 The State Fiscal Accountability Authority shall provide copies, including electronic form copies, of final reports received from a 33 34 firm under contract to: the Governor; the Chairman of the Senate Finance Committee; the Chairman of the House Ways and Means Committee; and the state auditor's office. Not later than January first of each year, the board shall issue a report to the General 35 Assembly summarizing the contents of all reports received under this provision during the prior fiscal year. 36

117.89. (GP: Funds Transfer to ETV) In the current fiscal year funds appropriated in Part IA to the Department of Administration 1 2 Section 93 for Legislative and Public Affairs Coverage and Emergency Communications Backbone and to the Law Enforcement Training Council in Section 64 for State and Local Training of Law Enforcement, City and County municipal training services must 3 4 be transferred to the Educational Television Commission (ETV) during July 2017 of the current fiscal year for the continuation of 5 services as provided in the prior fiscal year. **117.90.** (GP: Means Test) All agencies providing Healthcare Services are directed to identify standards and criteria for means 6 7 testing on all programs provided, where allowed by Federal guidelines. Once a consistent criteria has been established within an agency, they shall implement their respective plans. Each agency shall report all criteria and fiscal data to the Chairman of the Senate 8 Finance Committee and to the Chairman of the House Ways and Means Committee no later than January first. 9 117.91. (GP: Agency Reduction Management) The General Assembly encourages state agencies, in the event agencies are 10 assessed a base reduction, to endeavor to realize savings through: (1) payroll management, including, but not limited to, furloughs, 11 reductions in employee compensation, and instituting a hiring freeze; (2) eliminate administrative overhead cost that does not directly 12 impact the agency's mission; and as a final option (3) reductions to programmatic funding. 13 117.92. (GP: WIA Service Advertising) For Fiscal Year 2017-18, the Workforce Investment Boards may promote outreach for 14 their services via billboard, bus placard, newspapers, or radio in all workforce investment areas. This outreach may not be limited 15 to e-mail, online, or other internet-based outreach, publicity, or other promotions. Workforce investment boards must adhere to all 16 state procurement policies and procedures when utilizing outreach for the services provided by the Workforce Investment Act. 17 117.93. (GP: WIA Training Marketability Evaluation) (A) For Fiscal Year 2017-18, the Department of Employment and 18 Workforce shall submit a report that demonstrates how funds were expended in the prior fiscal year to provide marketable work 19 skills training. The report shall include, but not be limited to the total number of local training recipients, a description of the training 20 area in which each recipient participated, and the number and percentage of participants in each training area that, upon completion 21 of training, have become employed in the field in which they were trained. The report shall be submitted to the Chairman of the 22 23 Senate Finance Committee, the Chairman of the Senate Labor, Commerce and Industry Committee, the Chairman of the House Ways 24 and Means Committee, and the Chairman of the House Labor, Commerce and Industry Committee on or before November sixteenth. 25 (B) Also, the report must specifically describe any restructuring or realignment of agency functions, and any changes in staffing levels or service. The report must detail information on employees terminated, hired, re-hired, reassigned, or reclassified by program 26 area and location. Further, the report must describe efforts made by the agency to reassign or retrain employees who were terminated 27 28 for positions for which the department hired new employees. 29 117.94. (GP: Victims Assistance Transfer) The Department of Corrections shall transfer \$20,500 each month to the Department of Public Safety Office of Attorney General for distribution through the State Victims Assistance Program. 30 117.95. (GP: DOC & PPP Potential Consolidation Plan) From the funds appropriated to the Department of Corrections and the 31 Department of Probation, Parole and Pardon Services, the directors of the departments may collaborate and develop a plan to 32 33 consolidate the functions of the departments. 34 117.96. (GP: USC Greenville Medical School) It is the intent of the General Assembly that during the current fiscal year, no

35 general funds shall be appropriated for the new medical school at the University of South Carolina in Greenville. In addition, no 36 state funds may be transferred from state earmarked or restricted funds held by the University of South Carolina to the medical school

except for grants, contributions, contractual payments, and tuition and required fees for students attending the new medical school at 1

2 the University of South Carolina in Greenville that are specifically designated for the medical school at the University of South Carolina in Greenville. 3

4 117.97. (GP: BabyNet Quarterly Reports) First Steps to School Readiness, the The School for the Deaf and Blind, the 5 Department of Disabilities and Special Needs, the Department of Health and Human Services, the Department of Mental Health and 6 the Department of Social Services shall each provide on a common template developed by the agencies, a quarterly report to the 7 Chairman of the House Ways and Means Committee and the Chairman of Senate Finance outlining all programs provided by them 8 for BabyNet; all federal funds received and expended on BabyNet and all state funds expended on BabyNet. Each entity and agency shall report on its share of the state's ongoing maintenance of effort as defined by the US Department of Education under IDEA Part 9 10 C.

117.98. (GP: Single Audit Schedule of Federal Expenditures) To ensure timely completion of the of the Statewide Single Audit, 11 state agencies which do not receive a separate audit of federal expenditures, must submit to the Office of the State Auditor a schedule 12 of federal program expenditures in a format prescribed by the Office of the State Auditor, no later than August fifteenth of each year. 13 117.99. (GP: Prohibits Local Government Fund Public Funded Lobbyists) All local governmental entities including, but not 14 limited to, counties, municipalities, and associations are prohibited from using taxpayer funds received from the Local Government 15

Fund to compensate employees for lobbying activities engaged in on behalf of such governmental entity. 16

117.100. (GP: School Construction Development Impact Fee Assessment Prohibition) Governmental entities are prohibited from 17 assessing South Carolina Development Impact Fees on the construction of new elementary, middle, or secondary schools. If a 18 governmental entity violates this prohibition it shall have its Aid to Subdivisions Allocation reduced by the amount of the impact 19 20 fee.

21 117.101. (GP: Prohibit Use of State Aircraft for Athletic Recruitment) Institutions of higher learning may use the state aircraft operated by the Division of Aeronautics for the purpose of athletic recruiting, provided that they reimburse the Division of 22 23 Aeronautics for all flight hours on an at cost basis, using non-general funds.

24 To ensure availability of the aircraft for purposes of economic development, the Department of Commerce shall have first right of 25 refusal in the event of scheduling conflicts with athletic recruiting flights.

117.102. (GP: Recreational Activities) Two counties that receive an allocation from the Local Government Fund may enter into 26 a Memorandum of Understanding in order to provide recreational activities and projects that benefit the citizens of both counties. 27

117.103. (GP: Technology and Remediation) The funds appropriated to the Department of Administration for the Division of 28 Information Security shall be used to develop and implement a statewide information security program. A portion of the nonrecurring 29 funds may be used for enterprise technology and remediation, and distributed to state agencies to address the State's most serious 30 31 information security vulnerabilities as determined by the Division of Information Security and the Division of Technology Operations. Funds appropriated for Enterprise Technology and Remediation shall be excluded from the Department of 32 Administration's base budget calculation of any across-the-board agency base reduction mandated by the Executive Budget Office 33 34 or the General Assembly. Unexpended Enterprise Technology and Remediation funds may be carried forward from the prior fiscal

year and used for the same purpose. 35

1 **117.104.** (GP: Donation of Alcoholic Liquors) In the current fiscal year, a wholesaler may donate beer, wine, and alcoholic liquors 2 to a nonprofit organization that has a license, including a temporary license, to serve the applicable beverage. This provision only 3 applies if the event hosted by the nonprofit organization creates an economic impact on State revenues.

117.105. (GP: Data Breach Notification) (A) An agency of this State owning or licensing computerized data or other data that includes personal identifying information shall disclose any breach of the security of the system following discovery or notification of the breach in the security of the data to any resident of this State whose personal identifying information was, or is reasonably believed to have been, acquired by an unauthorized person. In determining whether information has been acquired, or is reasonably believed to have been acquired, by an unauthorized person or a person without valid authorization, the agency may consider the following factors, among others:

10 (1) indications that the information is in the physical possession and control of an unauthorized person, such as a lost or 11 stolen computer or other device containing information;

12

(2) indications that the information has been viewed, downloaded, or copied; or

(3) indications that the information was used by an unauthorized person, such as fraudulent accounts opened or instances
 of reported identity theft.

(B) An agency maintaining computerized data or other data that includes personal identifying information that the agency does
 not own shall notify the owner or licensee of the information of a breach of the security of the data immediately following discovery,
 if the personal identifying information was, or is reasonably believed to have been, acquired by an unauthorized person.

18 (C) The disclosure requirements of subsections (A) and (B) must be made in the most expedient time possible and without 19 unreasonable delay; however, the notification required by this section may be delayed if a law enforcement agency determines that 20 the notification impedes a criminal investigation and must be made after the law enforcement agency determines that it no longer 21 compromises the investigation. A delay in notification shall not exceed seventy-two hours after discovery, unless the agency requests 22 and the attorney general grants, in writing, additional delays of up to seventy-two hours each upon a determination that such 23 notification impedes a criminal investigation.

24 (D) For purposes of this section:

(1) "Agency" means any agency, department, board, commission, committee, or institution of higher learning of the State
 or a political subdivision of it.

(2) "Breach of the security of the system" means unauthorized access to and acquisition of computerized data that was not rendered unusable through encryption, redaction, or other methods that compromise the security, confidentiality, or integrity of personal identifying information maintained by the agency, when illegal use of the information has occurred or is reasonably likely to occur or use of the information creates a material risk of harm to the consumer. Good faith acquisition of personal identifying information by an employee or agent of the agency for the purposes of the agency is not a breach of the security of the system if the personal identifying information is not used or subject to further unauthorized disclosure.

(3) "Consumer reporting agency" means any person which, for monetary fees, dues, or on a cooperative nonprofit basis,
 regularly engages in whole or in part in the practice of assembling or evaluating consumer credit information or other information
 on consumers for the purpose of furnishing consumer reports to third parties, and which uses any means or facility of interstate

 commerce for the purpose of preparing or furnishing consumer reports. A list of consumer reporting agencies shall be compiled by the Department of Consumer Affairs and furnished upon request to the agency required to make a notification under this section. (4) "Personal identifying information" means the first name or first initial and last name in combination with and linked
to any one or more of the following data elements that relate to a resident of this State, when the data elements are neither encrypted
nor redacted or when the data elements are encrypted with an encryption key and the encryption key that has also been acquired:
(a) social security number;
(b) driver's license number or state identification card number issued instead of a driver's license;
(c) financial account number, or credit card or debit card number in combination with any required security code, access code, or password that would permit access to a resident's financial account; or
(d) other numbers or information which may be used to access a person's financial accounts or numbers or
information issued by a governmental or regulatory entity that uniquely will identify an individual.
The term does not include information that is lawfully obtained from publicly available information, or from federal, state, or local
government records lawfully made available to the general public.
(E) The notice required by this section may be provided by:
(1) written notice;
(2) electronic notice, if the agency's primary method of communication with the individual is by electronic means, the
person to whom notice is required has expressly consented to receiving said notice in electronic form, or is consistent with the
provisions regarding electronic records and signatures set forth in Section 7001 of Title 15 USC and Chapter 6, Title 26 of the 1976
Code;
(3) telephonic notice; or
(4) substitute notice, if the agency demonstrates that the cost of providing notice exceeds two hundred fifty thousand
dollars or that the affected class of subject persons to be notified exceeds five hundred thousand or the agency has insufficient contact
information. Substitute notice consists of:
(a) e-mail notice when the agency has an e-mail address for the subject persons;
(b) conspicuous posting of the notice on the agency's website page, if the agency maintains one; or
(c) notification to major statewide media.
Regardless of the method by which notice is provided, such notice shall include contact information for the agency making the
notification and a description of the categories of information that were, or are reasonably believed to have been, acquired by a person
without valid authorization, including specification of which of the elements of personal information and private information were,
or are reasonably believed to have been, so acquired.
(F) A resident of this State who is injured by a violation of this section, in addition to and cumulative of all other rights and
remedies available at law, may:
(1) institute a civil action to recover damages;
(2) seek an injunction to enforce compliance; and

(3) recover attorney's fees and court costs, if successful.

(G) An agency that knowingly and willfully violates this section is subject to an administrative fine up to one thousand dollars 1 2 for each resident whose information was accessible by reason of the breach, the amount to be decided by the Department of Consumer 3 Affairs.

4 (H) If the agency provides notice to more than one thousand persons at one time pursuant to this section, the agency shall notify, 5 without unreasonable delay, the Consumer Protection Division of the Department of Consumer Affairs and all consumer reporting agencies that compile and maintain files on a nationwide basis, as defined in 15 USC Section 1681a(p), of the timing, distribution, 6 7 and content of the notice.

8 **117.106.** (GP: State Ports Authority Property) If the State Ports Authority has not completed the sale of its real property on Daniel Island and Thomas (St. Thomas) Island, except for the dredge disposal cells that are needed in connection with the construction of 9 the North Charleston terminal on the Charleston Naval Complex and for harbor deepening and for channel and berth maintenance, 10

by June 30, 2018 2019, the authority must transfer the property to the Department of Administration. The authority shall sell the 11

real property under terms and conditions it considers most advantageous to the authority and the State of South Carolina. 12

117.107 (GP: Remittance of Court Fee and Fine Money) County and city treasurers are required to remit to the State Treasurer 13 set percentages of revenues generated by assessments imposed by 14-1-206(A), 14-1-207(A), 14-1-208(A). This remittance is 14 required on a monthly basis by the 15th day of each month. 15

Should a county and/or city treasurer fail to make the required remittance, the SC Criminal Justice Academy shall cease providing 16 services to all law enforcement officers of all law enforcement agencies encompassed within the political subdivision if they have 17 failed to make remittance for two consecutive months in a fiscal year. The finance director shall certify by July first, under oath, that 18 the county and/or city has remitted all funds or the SC Criminal Justice Academy shall withhold services until such time as remittance 19

20 is made.

117.108. (GP: Detailed Expenditure/Revenue Reports PCC/CID) The Prosecution Coordination Commission and the Commission 21 on Indigent Defense shall provide detailed expenditure reports and associated revenue streams for each individual circuit, revenue 22 23 streams shall include, but not be limited to, state funds, local funds, Federal funds, and also nongovernmental sources of funds, by 24 no later than September first, on the prior fiscal year, to the appropriate commission. The commissions shall than provide the 25 Chairman of the House Ways and Means Committee and Chairman of the Senate Finance Committee with a combined report by September fifteenth of the current fiscal year. 26

117.109. (GP: South Carolina Welcome Centers) The Department of Parks, Recreation and Tourism and the Department of 27 28 Transportation shall maintain a Memorandum of Understanding (MOU) that provides that the Department of Parks, Recreation and Tourism shall control operations of all South Carolina Welcome Centers. The MOU shall include replacement, renovation and 29 maintenance of the facilities, daily operations, and grounds maintenance and upkeep and shall clearly define responsibility for 30 31 additional portions of Welcome Centers to include paving and sidewalks. The Department of Transportation shall transfer to the Department of Parks, Recreation and Tourism the amount of \$3,563,560 less any state funds appropriated by the General Assembly 32 for the same purpose. The Department of Parks, Recreation and Tourism assumes responsibility for this amount and the timing of 33 34 the transfer of these funds shall be defined as part of the MOU. The funds transferred to the Department of Parks, Recreation and Tourism shall be placed in a separate and distinct fund and these funds shall be carried forward from the prior fiscal year into the 35

current fiscal year and be expended for the same purposes. 36

117.110. (GP: Continuation of Teen Pregnancy Prevention Project Accountability) Qualifying organizations applying for General 1 2 Funds provided as a special item in this act and titled Continuation of Teen Pregnancy Prevention must include in its application a proposed annual budget and agreement to provide quarterly reports to the grantor state agency detailing the expenditure of funds and 3 4 the project's accomplishments which shall include: 5 (1) Financial: 6 (a) Personnel costs, including employer contributions, by position for each of the following areas: administration, 7 training, and education, as well as for other positions as identified; 8 (b) Operational costs identified in the application; (c) One-time costs over \$500 for such items as supplies; 9 Administration costs may not exceed ten percent of the total project budget. For purposes of this provision, "Administration" 10 is defined as expenses other than educational. 11 (2) Description of program and curriculum to be used; 12 (3) Description of training; 13 (4) Schedule and brief description of project activities for each quarter; 14 (5) Participation reports on the following: 15 (a) Number of persons who participated; 16 (b) Total number of hours provided; 17 (c) Number of train the trainer events: 18 (d) Other data regarding the activities of the project; 19 (6) Description of the project evaluation to be used; 20 21 (7) Copy of latest completed independent financial audit and agency's response to any audit exceptions; (8) Qualifications of project personnel; 22 (9) Best Practices to be used; and 23 24 (10) Evidence Based Curriculum. An organization awarded a grant must provide these quarterly reports to the grantor state agency within fifteen days of the end of 25 26 each quarter. Grantees failing to submit reports with thirty days of the end of each quarter shall have their grant terminated. Unexpended funds for Continuation of Teen Pregnancy Prevention projects under the Department of Social Services or under the 27 Department of Health and Environmental Control shall be carried forward for the purpose of fulfilling the department's contractual 28 29 agreement. 117.111. (GP: Charleston & Dorchester County Sound Barriers) From the funds authorized to the Department of Transportation, 30 the department shall take the appropriate measures to allow the counties of Charleston and Dorchester to construct sound barriers in 31 the department's easements along Interstate 26 within the borders of Charleston County and along Dorchester Road within Dorchester 32 County, provided, no funds appropriated or authorized in Part IA to the Department of Transportation, any other section of this act, 33 34 any Federal Funds, unless otherwise agreed to by the local Metropolitan Planning Organization or Council or Governments for use of a portion of their annual federal allocation, or any Other Funds, shall be used in the construction of the sound barriers, and only 35 local dollars shall be used in the construction of sound barriers. The sound barriers must meet the state and federal noise abatement 36

guidelines and must be constructed to meet any and all state and federal regulations. Consistent with the requirements of Section 1 2 57-25-190 (E) of the 1976 Code, or regulations adopted pursuant thereto, including construction by a local government in a state right of way, the owner of a legally erected and maintained billboard shall have the option to relocate such billboard sign to another 3 4 location as close as practicable to the sign being relocated or adjust the height or angle of the billboard sign to a height or angle that 5 restores the visibility of the billboard sign to the same or comparable visibility as before construction of a sound barrier. Costs for 6 re-location or alteration of a billboard due to sound barrier installation by a local government in a state right of way shall be paid by 7 the local government. The provisions of Section 39-14-10 et seq. of the 1976 Code will apply regarding any compensation to be 8 paid by local governments for billboard signs which cannot be relocated or altered.

25 The information security plans required by this section shall be in the form and level of detail required by the division and shall 26 include at least: (1) the information security objectives of the state agency; (2) an inventory of the state agency's information security technology; (3) a profile of the state agency's compliance with security policies established by the division; (4) a profile of the state 27 agency's sensitive data and a description of applicable state and federal privacy requirements; (5) a profile of risk management and 28 other measures taken by the state agency to protect its data from unauthorized access and disclosure; (6) the state agency's budget 29 plans for information security for the coming fiscal year which must include: (a) all fixed, recurring information security technology 30 costs, regardless of funding sources; (b) new information security expenditures for services hardware upgrades/replacements and 31 software purchases, regardless of funding sources; (c) new information security projects, regardless of funding sources; and (d) FTE 32 counts, temporary personnel counts, and salary information and position descriptions for all information security personnel, 33 34 regardless of funding sources; and (7) the state agency's need for appropriations for information security.

(B) The director of the Department of Administration should seek advice from private and public sector resources on the efficient

Funds appropriated in Part IA, F300, Section 106, Statewide Employee Benefits may be carried forward from the prior fiscal year into the current fiscal year.

117.115. (GP: Child Fatality Review) The agencies specified shall implement the following recommendations contained in the
 Legislative Audit Council's October 2014 report "A Review of Child Welfare Services at the Department of Social Services":

5 (1) Annually, the Department of Social Services and the State Child Fatality Advisory Committee shall jointly report statistics 6 on child deaths from maltreatment and the number of those with prior Department of Social Services involvement;

30 **117.118.** (GP: Family Planning Funds) (A) Notwithstanding any other law, federal family planning funds and state family planning funds shall be awarded to eligible individuals, organizations, or entities applying to be family planning contractors in the following order of descending priority:

(1) public entities that provide family planning services, including state, county, and local community health clinics and
 federally qualified health centers;

(2) nonpublic entities that provide comprehensive primary and preventive health services, as described in 42 U.S.C.

The report shall provide a detailed explanation of how it was 8 determined that there were an insufficient number of eligible individuals, organizations, or entities in items (A)(1) and (A)(2) to 9 prevent a significant reduction in family planning services in each region of the State where (A)(3) contractors are located.

10 **117.119.** (GP: Statewide Strategic Information Technology Plan Implementation) To ensure the uniform implementation of the 11 Statewide Strategic Information Technology Plan developed pursuant to the Restructuring Act of 2014 and designed to improve the 12 State's ability to provide reliable, secure, cost-efficient, and innovative information technology services and infrastructure, state 13 agencies are directed as follows:

 that fit into the overall Statewide Strategic Information Technology Plan.

(5) With the consultation and approval of the Division of Technology Operations, agencies must create an information
 technology plan for purchases that exceed \$50,000 to ensure compliance with the Statewide Strategic Information Technology Plan
 and the standards defined by the division.

(6) Agencies shall develop a three-year strategic plan for information technology, updated annually, for the Division of
 Technology Operations, that shall be approved by the Chief Information Officer, that sets forth: (a) operational and project priorities;

 concerns with the agency's information technology.

(GP: County Transportation Committee Road Program Supplement) Unexpended funds appropriated pursuant to this 6 provision may be carried forward and expended for the same purposes. 7 117.121. (GP: Sentencing Reform Oversight Committee Reauthorization) There is established for the current fiscal year the South 8 Carolina Sentencing Reform Oversight Committee. (GP: Equestrian Center Therapy Program) The Department of Vocational Rehabilitation shall transfer \$500,000 to Lander University for the Lander Equestrian Center. These funds shall be used for the operation of the Equestrian Center and to 24 25 create a Herd 2 Human pilot program to provide equine assisted psychotherapy geared towards military members as a method of treating post-traumatic stress disorder (PTSD) and other similar disorders. Except as provided herein, this shall not be construed to allow an APRN to perform services beyond the 18 scope of what is authorized by Title 40, Chapter 33 and Title 40, Chapter 47. 19 (D C) The MUSC Hospital Authority shall publish a summary report to the Governor and the General Assembly indicating the 20 21 overall progress of the state's telemedicine transformation by April 1, 2018 2019. 117.132. (GP: Adult Protective Services Coordination Teams) In order to best coordinate services for the South Carolina 22 23 vulnerable adult population, the Adult Protective Services Program at the Department of Social Services shall develop county level 24 multi-agency interdisciplinary Adult Protective Services Coordination Teams. - 4 117.133. (GP: Distribution Facility) The State Ports Authority shall be considered a distribution facility for the purpose of sales 5 tax exemptions associated with the purchase of equipment and construction materials.
- 6 117.134. (GP: Catastrophic Weather Event) (A) Any improvements made to real property or personal property used as a residence,
- 7 such as a mobile home or manufactured housing unit, damaged during the catastrophic weather event in October 2015 or Hurricane
- 8 Matthew of 2016, after the event and before June 30, 2018 2019, is not considered an improvement and does not require a re-appraisal.
- This provision only applies if as a result of the catastrophic weather event, the improvements made to the property were funded by 9

(GP: SDE State Transportation Operations) For the current fiscal year, Section 1-11-330 of the 1976 Code is suspended. 3 The Department of Administration shall evaluate all state transportation operations at the Department of Education to determine 4 5 safety improvement, efficiency, and cost saving measures that may be realized by the department. The Department of Education is directed to coordinate with the Department of Administration to participate in the State Fuel Card Program, the Lease Fleet program 6 7 for light-duty vehicles, the Commercial Vendor Repair Program, and the State Maintenance Facility Repair program. The 8 Department of Administration shall submit findings and recommendations to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by March 1, 2019. 9 117.142. (GP: Opioid Abuse Prevention and Treatment Plan) From the funds appropriated and authorized to the Department of 10 Alcohol and Other Drug Abuse Services and the Department of Health and Human Services in the current fiscal year, the agencies 11 shall establish a coalition of state agencies, providers and other related entities to combat the opioid epidemic in a collaborative 12 manner and ensure that appropriate services and treatments are made available statewide. This initiative should include efforts to 13 coordinate funding for the provision of treatment with an assessment of current programs and funding levels, to enhance available 14 15 prevention, treatment and recovery services: expand provider capacity; and enable workforce development for substance use disorder services. General Funds appropriated to any state agency for Opioid Abuse Prevention and Treatment may be carried 16 forward and expended for the same purpose. 17 (A) The Department of Alcohol and Other Drug Abuse Services, the State Law Enforcement Division, and the Department of 18 Health and Human Services shall establish an advisory board with representation from both agencies, to provide both oversight and 19 administrative direction to the coalition. 16	117.145. (GP: SCEIS Data Entry Compliance) The Department of Administration shall develop and issue written SCEIS data
17	entry standards and guidelines for agency compliance. To ensure uniform compliance with these standards and guidelines, state
18	agencies shall comply with all SCEIS data entry rules, standards, plans, policies, directives, and guidelines established by the
19	Department of Administration.

17	117.152. (GP: Legal Funding Transactions) With the funds appropriated and authorized to the Department of Consumer Affairs
18	for the current fiscal year, the department shall suspend and cease any investigations, enforcement procedures, or actions as a result
19	of the Administrative Interpretation 3.104,106-1403 issued by the department and dated November 14, 2014. The department shall
20	not make any such administrative determinations for legal funding transactions without the clear expression of intent from the
21	General Assembly regarding the applicability of this administrative interpretation.
22	117.153. (GP: State Contracts) Of the funds appropriated or authorized to the State Fiscal Accountability Authority, the authority
23	shall develop guidelines regarding covered contracts exceeding \$50,000 that state agencies enter into which incentivizes contractors
24	to pay their employees promptly. For purposes of this proviso, a "covered contract" is any contract that involves the physical
25	performance of manual labor within South Carolina, if the contracting agency reasonably anticipates that the total cost of the manual
26	labor will exceed seventy percent of the total cost of all labor. These guidelines shall provide that an agency may consider a
27	prospective contractor's record of promptly paying its employees both (a) when making a determination of the contractor's
28	responsibility to perform, or (b) when deciding whether to exercise a contractual right to extend, renew, or otherwise lengthen an
29	existing contract. The guidelines may, but are not required to, include model terms and conditions that allow the State to deem a
30	contractor's persistent failure to timely pay its employees as a material breach of contract.
31	117.154. (GP: School Resource Officer Critical Needs) Any Class 1 law enforcement officer who retired under the Police Officers
32	Retirement System on or before December 31, 2017, may return to employment with a public school district as a critical needs School
33	Resource Officer without affecting the monthly retirement allowance that they are receiving from the Police Officers Retirement
34	System. The Law Enforcement Training Council must develop guidelines and curriculum for these officers to be recertified and must
35	not require recertification through basic training for those that have been inactive for a year or more.

1	117.155. (GP: South Carolina Industry, Workforce and Education Data Warehouse) Of the funds appropriated to the Revenue
2	and Fiscal Affairs Office, there is hereby established within the Revenue and Fiscal Affairs Office (RFA), the South Carolina Industry,
3	Workforce and Education Data Warehouse. The purpose of the warehouse is to create a fully functional longitudinal data system to
4	link industry, workforce and education data through enhanced coordination and integration of courseware, certifications and
5	individual data to meet the objectives of and in accordance with the requirements of the Coordinating Council for Workforce
6	Development (CCWD). All state agencies participating in the warehouse shall utilize it and its associated software applications as
7	tools to effectively organize, manage, and analyze educational, workforce and other data as necessary for workforce program
8	evaluation, improvement of individual outcome measures, and the coordination and continuity of the workforce delivery system.
9	The CCWD shall establish the Workforce and Education Data Oversight Committee (WEDOC) to be comprised of the following
10	<u>members:</u>
11	(1) The Secretary of the Department of Commerce or his designee;
12	(2) The State Superintendent of Education or his designee;
13	(3) The president of the State Board for Technical and Comprehensive Education or his designee;
14	(4) The Executive Director of the Department of Employment and Workforce or his designee;
15	(5) The Executive Director of the Commission on Higher Education or his designee;
16	(6) The president or provost of a public college or university who shall be selected by the Council of Presidents of the public
17	<u>universities;</u>
18	(7) The president or provost of a senior independent college or university who shall be selected by the presidents of such
19	<u>universities:</u>
20	(8) The president of a technical college who shall be appointed by the Chairman of the State Board for Technical and
21	Comprehensive Education; and
22	(9) A person appointed by the Superintendent of Education who has particularized expertise regarding Chapter 59, Title 59,
23	the South Carolina Education and Economic Development Act.
24	The WEDOC shall support the mission of the CCWD as defined in Section 13-1-2030 of the 1976 Code by providing
25	recommendations to RFA regarding the governance of the South Carolina Industry, Workforce and Education Data Warehouse. The
26	committee must meet at least quarterly with the chair of the CCWD or his designee serving ex officio as chair. With the agreement
27	of the WEDOC, RFA may charge reasonable applicable fees for the establishment and operation of the South Carolina Industry,
28	Workforce and Education Data Warehouse.
29	RFA shall develop and implement procedures, with the approval of the WEDOC, for sharing information and coordinating efforts
30	among stakeholders to prepare the state's current and emerging workforce to meet the needs of the state's economy. Information
31	submitted to the South Carolina Industry, Workforce and Education Data Warehouse may include but is not limited to: courseware,
32	certifications and individual information, individual data and non-individual data from industry, workforce and education state
33	agencies. For the purpose of this provision, individual data is defined as person-level data that is created, received, and/or
34	maintained by state agencies and other entities required to report individual information to RFA.
35	
	The following agencies shall report to RFA as necessary, and in accordance with all state and federal law and regulation,

1	(1) the Department of Commerce;
2	(2) the Department of Education;
3	(3) the Department of Employment and Workforce;
4	(4) the State Technical College System;
5	(5) the South Carolina First Steps to School Readiness;
6	(6) the Commission on Higher Education; and
7	(7) other entities as deemed necessary by mutual agreement of the WEDOC, CCWD and RFA.
8	These agencies shall collect and provide individual data in formats and schedules specified as agreed to by RFA, the WEDOC
9	and the agency. RFA shall establish a Memorandum of Agreement with each agency or entity. These Memorandums of Agreement
10	shall specify, but are not limited to, the confidentiality of individual information, the conditions for the release of data that may
11	identify agencies, departments, divisions, programs and services, or individuals, any restrictions on the release of data so as to be
12	compliant with state and federal statutes and regulations on confidentiality of data, conditions under which the data may be used for
13	research purposes, and any security measures to be taken to insure the confidentiality of individual information.
14	RFA shall implement, with the approval of the WEDOC, an integrated data system that includes individual and other data from
15	all participating agencies to ensure accountability and the coordinated, efficient delivery of education and workforce services to
16	meet the demands of industry. In order to provide for inclusion of other entities into the South Carolina Industry, Workforce and
17	Education Data Warehouse and other research and analytic-oriented applications that will assist the state in the efficient and
18	effective provision of services, RFA may enter into agreements or transactions with any federal, state or municipal agency or other
19	public institution or with any private individual, partnership, firm, corporation, association or other entity to provide statistical,
20	research and information dissemination services including, but not limited to, program and outcomes evaluation, program
21	monitoring/surveillance, projects to determine the feasibility of data collection and/or analyses, information dissemination and
22	research. Information from the South Carolina Industry, Workforce and Education Data Warehouse shall not be disclosed or
23	released to any third party or non-government entity without the prior written consent of the WEDOC and the agency providing the
24	data, unless that information is already in the public domain, and the confidentiality of data collected under these initiatives shall
25	comply with applicable state and federal laws governing the privacy of data. RFA shall release no individual level data or data that
26	could be used to identify an individual. RFA may promulgate regulations, policies and procedures, in consultation with the
27	participating agencies, for the development, protection and operation of the data warehouse, other research and analytic-oriented
28	applications, and their underlying processes.
29	<u>RFA shall develop, with the approval of the WEDOC, internet-accessible secure analytic query tools using integrated individual</u>
30	data from the warehouse. All agencies shall cooperate with RFA in the development of these analytic tools. Analytic tools developed
31	under this provision shall be made available to members of the South Carolina General Assembly and their staffs, state agencies,
32	and researchers. RFA shall, in consultation with the participating agencies, promulgate regulations addressing access to, use and
33	release of information generated through use of the query tools.
34	117.156. (GP: Workforce Pathways Grant Fund) Of the funds appropriated to the State Board for Technical and Comprehensive
35	Education (SBTCE) for the Workforce Pathways Program, there is created a Pathways Grant Fund, which shall be administered by
36	the SBTCE.

1	(A) The purpose of the fund is to award grants to eligible technical colleges in order to provide and support the infrastructure
2	necessary to offer Pathways programs. Grants awarded to technical colleges must be used only for Pathways-specific expenses, to
3	include program administration, career and technical equipment, facilities, instructional materials, transportation, and tuition
4	grants. The SBTCE or board-appointed committee, in consultation with the Department of Education, shall develop and maintain
5	eligibility criteria for these competitive grants.
6	(B) Funds available through these competitive grants are awarded to technical colleges that demonstrate the strongest ability to
7	meet grant criteria. Funds may not be awarded to all colleges in a given year.
8	(C) Funds must be used to establish new pathways or enhance existing pathways that confer the necessary skills and training to
9	prepare students for careers in high-demand fields. Funds shall only support career and technical education programs and courses
10	in industry sectors with critical workforce needs.
11	(D) To qualify for Pathways grant funding as established pursuant to this provision, the technical college and school or school
12	district must enter into Memorandums of Understanding that meet the grant requirements.
13	(E) The SBTCE or board-appointed committee, in consultation with the Department of Education, is responsible for determining
14	if a pathway meets the established criteria and may promulgate regulations further enumerating the specifics of these criteria and
15	the evaluation process.
16	(F) The SBTCE shall prepare an annual report on the Pathways program and grant awards by September first of each year. The
17	report must be submitted to the Coordinating Council for Workforce Development for inclusion in its annual report to the Governor,
18	the Chairman of the Senate Finance Committee, and the Chairman of the House Ways and Means Committee. The report must
19	include, at minimum, an update of progress toward full statewide implementation of the Pathways program, and upon
20	implementation, an analysis of program accountability measures and key performance indicators.
21	(G) As used in this provision:
22	(1) 'Industry sectors with critical workforce needs' means the industry sectors as outlined by the Coordinating Council
23	for Workforce Development and their business and industry partners.
24	(2) 'Pathways' means a partnership between a secondary education provider, a technical college, and a business or

26	(a) secondary and postsecondary education elements;
27	(b) coherent and rigorous content aligned with challenging academic standards and relevant career and technical
28	content in a coordinated, non-duplicative progression of courses that align secondary education with postsecondary education to

30	(c) opportunity for secondary education students to participate in dual or concurrent enrollment programs or other
31	ways to acquire postsecondary education credits at no cost to the student; and
32	(d) student attainment of an industry-recognized credential, or a postsecondary certificate, diploma, or associate
33	degree, with multiple entrance and exit points.
34	<u>117.157. (GP: Net Energy Metering) (A) The General Assembly finds:</u>
35	(1) the General Assembly passed Act 236 of 2014 to promote the establishment of a reliable, efficient, and diversified
36	portfolio of distributed energy resources for the State; and

1	(2) Act 236 of 2014 successfully resulted in the rapid development and expansion of the solar power marketplace in this
2	<i>State; and</i>
3	(3) it is necessary to preserve the important role of the emerging solar industry as it becomes sustainable, without subsidies,
4	in our diversifying energy market; and
5	(4) the Public Service Commission approved in Order 2015-194 a settlement agreement that provides for a 1:1 kilowatt
6	hour ("kWh") crediting rate ("1:1 Rate") whereby each kWh of electricity produced by a customer-generator is credited at the full
7	<u>retail rate.</u>
8	(B) In the current fiscal year and from the funds appropriated and/or authorized to the Public Service Commission, for purposes
9	of Chapter 40, Title 58 of the 1976 Code, an electrical utility shall make net energy metering available to customer-generators on a
10	first-come, first-served basis, according to the rights accorded customer-generators by Commission Order 2015-194 until the total
11	nameplate generating capacity of net energy metering systems equals four percent of the previous five-year average of the electrical
12	utility's South Carolina retail peak demand. No electrical utility must be required to approve an application for interconnection
13	from net energy metering customer-generators if the total rated generating capacity of all applications for interconnection from net
14	energy metering customer-generators already approved to date by the electrical utility equals or exceeds four percent of the previous
15	five-year average of the electrical utility's South Carolina retail peak demand.
16	(C) (1) From the funds appropriated and/or authorized to the Public Service Commission, there is created the "Renewable
17	Energy Development Joint Study Committee" to support the development of renewable energy resources and production facilities to
18	generate electricity. The study committee specifically shall investigate, examine, and develop appropriate recommendations
19	<u>addressing:</u>
20	(a) ratemaking methodologies, cost allocations, and rate designs for all retail electric customers in South Carolina;
21	(b) strategies for ensuring the fairest allocation of system costs and benefits related to renewable energy resources and
22	Act 236 of 2014 between consumers, including consumers who either do or do not utilize distributed energy resources;
23	(c) strategies to build upon the successful deployment of renewable energy generating capacity through the South
24	Carolina Distributed Resource Act and to continue enabling market-driven, private investment in distributed energy resources across
25	the State by reducing regulatory and administrative burdens to customer installation and utilization of onsite distributed energy
26	<u>resources;</u>
27	(d) the current status of the progress and implementation of Act 236 of 2014 and strategies to enhance the act's progress
28	and success; and
29	(e) job retention and growth in the renewable energy industry.
30	(2) The study committee must be composed of the following members:
31	(a) one member of the House of Representatives appointed by the Speaker of the House of Representatives;
32	(b) one member of the House of Representatives appointed by the majority leader of the House of Representatives;
33	(c) one member of the House of Representatives appointed by the minority leader of the House of Representatives;
34	(d) one member of the Senate appointed by the President Pro Tempore of the Senate;
35	(e) one member of the Senate appointed by the majority leader of the Senate;
36	(f) one member of the Senate appointed by the minority leader of the Senate; and

1	(g) one member representing each of the following organizations to be appointed by the Governor:

32	The study committee must be co-chaired by the appointee of the President Pro Tempore of the Senate and the appointee of the

7	Public Service Commission, for purposes of Chapter 40, Title 58 of the 1976 Code, customers of a utility who are not customer-
8	generators are not required to subsidize the costs of customer-generators.
9	117.159. (GP: Immigration Compliance) A resident of a political subdivision in this State, the Attorney General, or both, may
10	bring a civil action in the circuit court in which the resident and political subdivision are located to enjoin:
11	(1) an enactment by the political subdivision of any ordinance or policy that intentionally limits or prohibits a law enforcement
12	officer, local official, or local government employee from seeking to enforce a state law with regard to immigration;
13	(2) an enactment by the political subdivision of any ordinance or policy that intentionally limits or prohibits a law enforcement
14	officer, local official, or local government employee from communicating to appropriate federal or state officials regarding the
15	immigration status of a person within this State; or

9	118.1. (SR: Year End Cutoff) Unless specifically authorized herein, the appropriations provided in Part IA of this act as ordinary
10	expenses of the State Government shall lapse on July 31, 2018 2019. State agencies are required to submit all current fiscal year
11	input documents and all electronic workflow for accounts payable transactions to the Office of Comptroller General by July 13, 2018
12	July 12, 2019. Appropriations for Permanent Improvements, now outstanding or hereafter provided, shall lapse at the end of the
13	second fiscal year in which such appropriations were provided, unless definite commitments shall have been made, with the approval
14	of the State Fiscal Accountability Authority and Joint Bond Review Committee, toward the accomplishment of the purposes for
15	which the appropriations were provided. Appropriations for other specific purposes aside from ordinary operating expenses, now
16	outstanding or hereafter provided, shall lapse at the end of the second fiscal year in which such appropriations were provided, unless
17	definite commitments shall have been made, with the approval of the State Fiscal Accountability Authority, toward the
18	accomplishment of the purposes for which the appropriations were provided.
19	118.2. (SR: Titling of Real Property) It is the intent of the General Assembly to establish a comprehensive central property and
20	office facility management process to plan for the needs of state government agencies and to achieve maximum efficiency and
21	economy in the use of state owned or state leased real properties. The Department of Administration is directed to identify all state
22	owned properties whether titled in the name of the state or an agency or department, and all agencies and departments of state
23	government are upon request to provide the department all documents related to the title and acquisition of the real properties that
24	are occupied or used by the agency or titled in the name of the agency. Except for any properties where the department determines
25	title should not be in the name of the State because the properties are subject to reverter clauses or other restraints on the property,
26	or where the department determines the state would be best served by not receiving title, and with the exception of properties,
27	highways and roadways owned by the Department of Transportation, title of any property held by or acquired by a state agency or
28	department shall be titled in the name of the state under the control of the Department of Administration. Titling in the name of the
29	state shall not affect the operation or use of real property by an agency.
30	This provision applies to all state agencies and departments except: institutions of higher learning; the Public Service Authority;
31	the Ports Authority; the South Carolina Division of Public Railways; the MUSC Hospital Authority; the Myrtle Beach Air Force
32	Redevelopment Authority; the Department of Transportation; the Midlands Technical College Enterprise Campus Authority, the
33	Trident Technical College Enterprise Campus Authority; the Area Commission of Tri-County Technical College; and the Charleston
34	Naval Complex Redevelopment Authority.

This provision is comprehensive and supersedes any conflicting provisions concerning title and acquisition and disposition of state owned real property whether in permanent law, temporary law or by provision elsewhere in this act.

1 The Department of Administration is directed to provide to the Department of Education, funds equal to the amount realized from 2 the sale of the Greenville Halton Road Bus Shop property for school bus maintenance shop relocations, construction, and shop 3 equipment.

4 118.3. (SR: Contingency Reserve Fund) (A) There is created in the State Treasury a fund separate and distinct from the general 5 fund of the State, the Capital Reserve Fund, and all other funds entitled the Contingency Reserve Fund. All general fund revenues 6 accumulated in a fiscal year in excess of general appropriations and supplemental appropriations must be credited to this fund. Revenues credited to this fund in a fiscal year may be appropriated by the General Assembly. Upon determination by the Comptroller 7 8 General as to the amount to be deposited in the Contingency Reserve Fund, the Comptroller General shall notify the Board of Economic Advisors and the board shall recognize that amount as surplus funds. Contingency Reserve Fund up to the total necessary to replenish the general reserve fund. This amount does not replace or supplant the minimum replenishment amount otherwise required to be made to the general reserve fund.

15 (2) After the appropriation of amounts required pursuant to item (1) of this subsection, any remaining balance may be 16 appropriated by the General Assembly as it deems appropriate.

17 **118.4.** (SR: Increased Enforced Collections Carry Forward) Unexpended funds appropriated pursuant to Proviso 90.16 in Part IB 18 of Act 291 of 2010 may be carried forward from the prior fiscal year into the current fiscal year and shall be expended for the same 19 purposes.

118.5. (SR: Health Care Maintenance of Effort Funding) The revenue collected from the fifty cent cigarette surcharge and deposited into the South Carolina Medicaid Reserve Fund and established by Act 170 of 2010 and any other funds deposited into the funds shall be utilized deemed appropriated for use by the Department of Health and Human Services for the Medicaid program. By this provision these funds are deemed to have been received and are available for appropriation. Unexpended funds appropriated

24 pursuant to this provision may be carried forward to succeeding fiscal years and expended for the same purposes.

118.6. (SR: Prohibits Public Funded Lobbyists) All state agencies and institutions are prohibited from using general fund appropriations to compensate employees who engage in lobbying on behalf of the state agency or institution. The State Ethics Commission shall require state agencies and institutions that report lobbying activities to the commission to certify that the lobbying activities were not funded by general fund appropriations.

All state agencies and institutions are prohibited from entering into contracts using general fund appropriations to provide lobbying services to the agency or institution.

31 **118.7.** (SR: Admissions Tax) For the current fiscal year, up to one hundred fourteen thousand dollars in admissions tax revenue

32 collected annually from all events held at a NASCAR sanctioned motor speedway or racetrack that hosts at least one race each year 33 featuring the preeminent NASCAR cup series must be rebated to the motorsports entertainment complex facility in the current fiscal

year to keep a NASCAR race at the motorsports entertainment complex facility. In addition, any sports facility that hosts at least

35 one preeminent Women's Tennis Association-sanctioned tournament or any sports facility that operates as the home venue for a

professional soccer team that participates in the United Soccer Leagues, second division or higher, must be rebated to the facility
 half of its admissions tax revenue for the fiscal year and used by that facility for marketing the events held at the facility.

118.8. (SR: Agency Deficit Notice) The Comptroller General or the Executive Budget Office shall (1) provide written notice to each member of the General Assembly when it makes a report concerning an agency, department, or institution that is expending authorized appropriations at a rate which predicts or projects a general fund deficit for the agency, department, or institution, and (2) make monthly progress reports concerning an agency's, department's, or institution's plan to reduce or eliminate the deficit.

118.9. (SR: Tax Relief Reserve Fund) There is created the Tax Relief Reserve Fund, which shall be separate and distinct from the General Fund. Interest accrued by the fund must remain in the fund. (C) By March fifteenth of each year, the department shall issue a report to the Governor and the General Assembly detailing the
