This bill allows certain special purpose districts to own, acquire, sell, and otherwise interact with property for the purposes of their duties. To determine the impact, we surveyed all counties and the 181 districts registered with the Secretary of State with email contact information. Florence County has indicated that this bill does not change operations for one of the special purpose districts within county boundaries, as it was founded after the 1973 date stipulated in law. The fourteen special purpose districts that have responded to our request have broadly stated that this bill should have no fiscal impact. These no impact responses come from both special purpose districts that would be eligible under the bill's definition of special purpose district expecting no change in operations or other impact, and special purpose districts that would not fit under the bills definition as they were founded after the 1973 date or fit under other designations such as special taxing districts created by county ordinances.
